**DESCRIPTION**

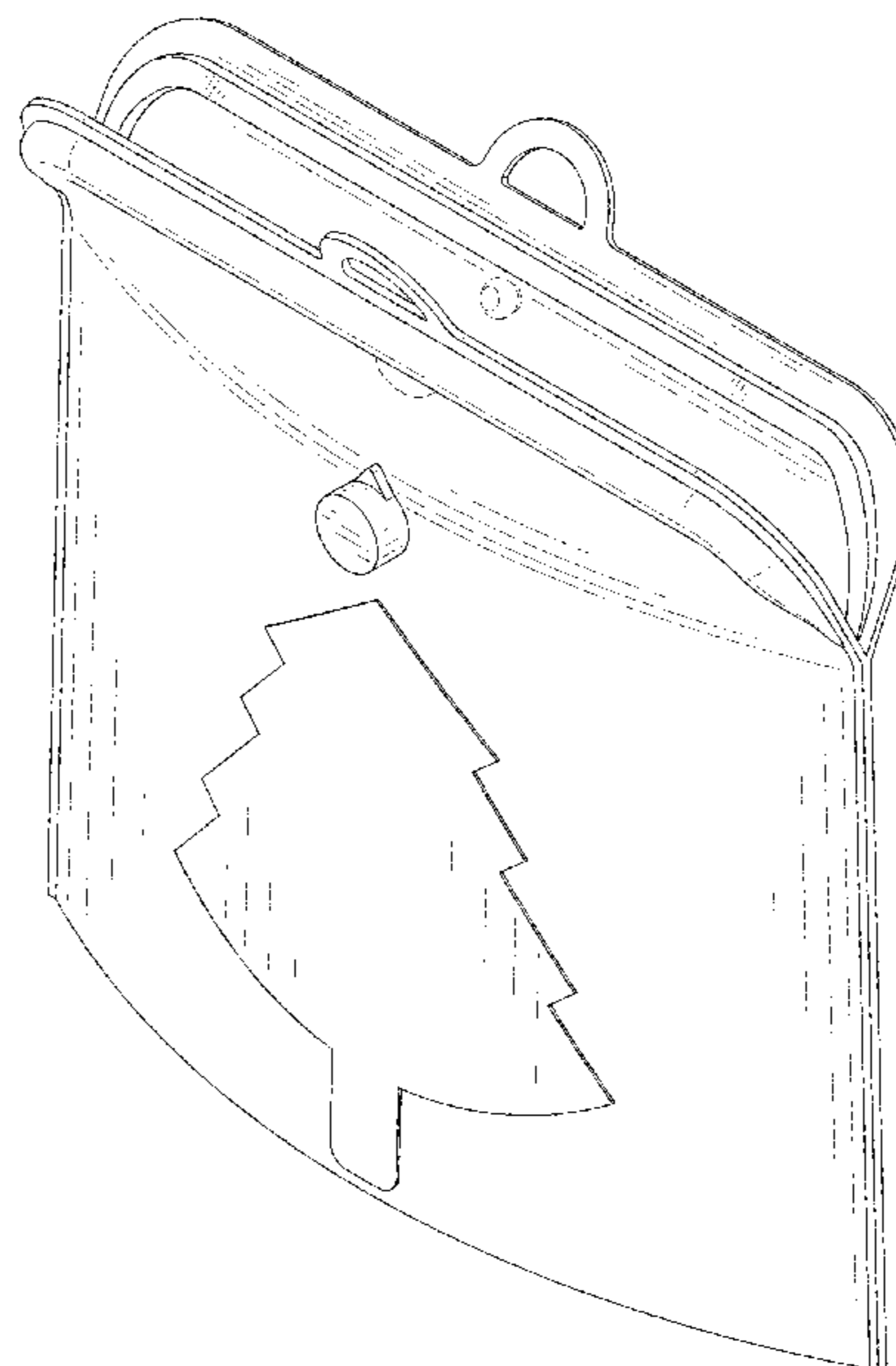
FIG. 1 is a perspective view of a silicone food storage bag showing my new design;

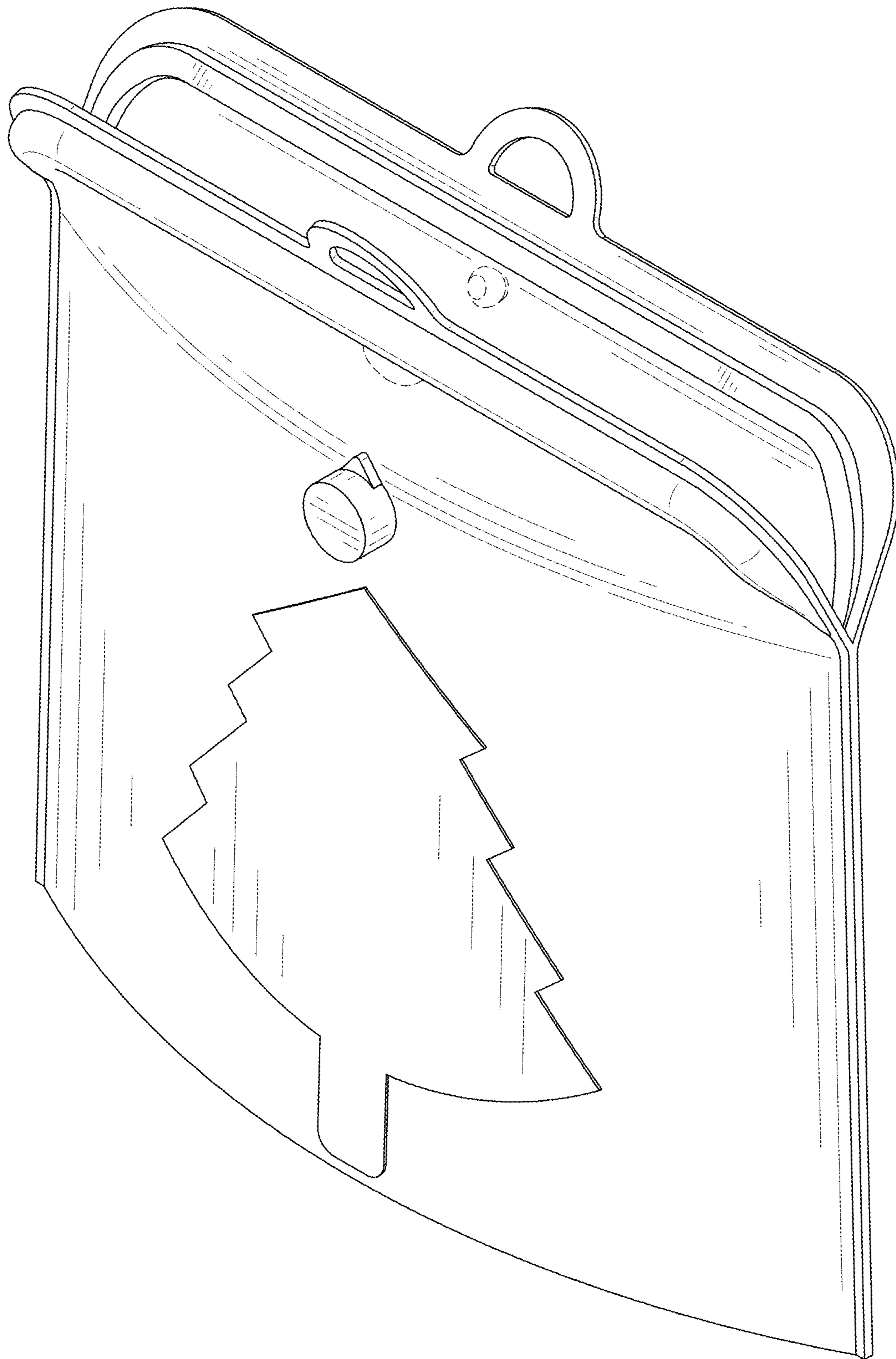

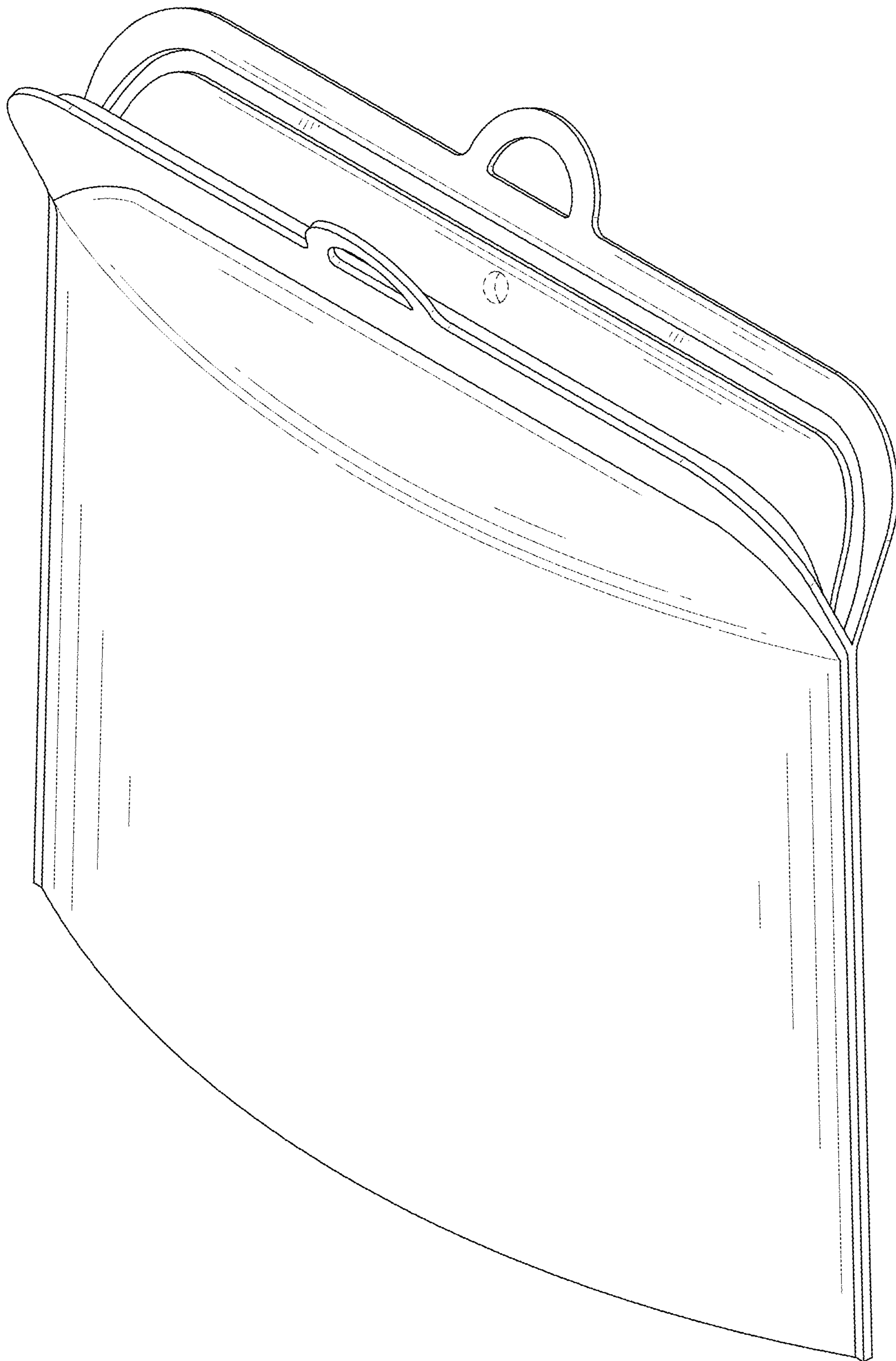

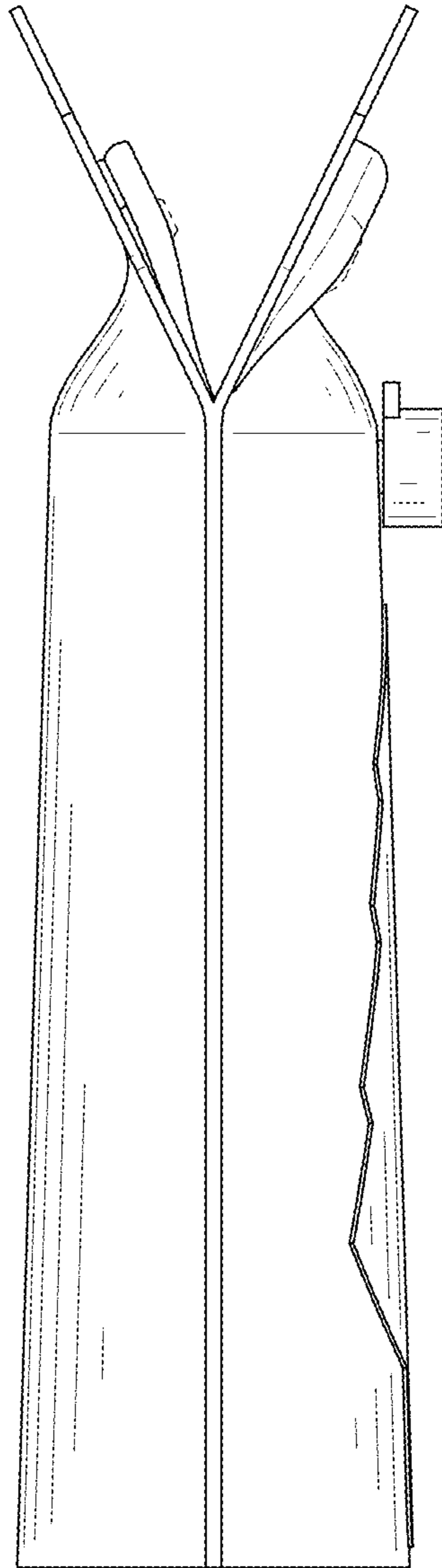

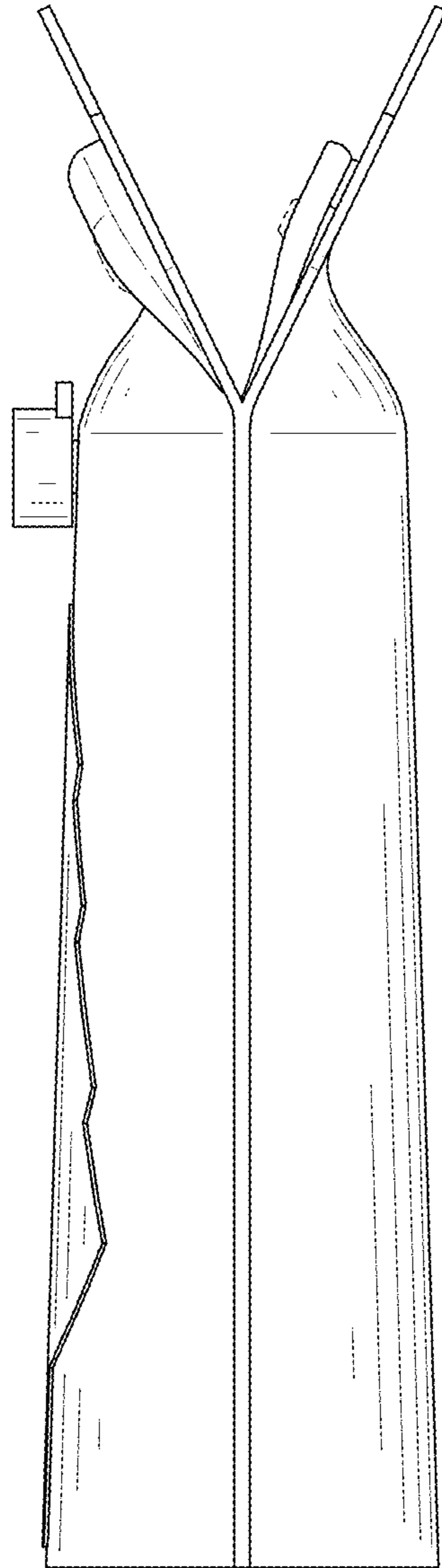

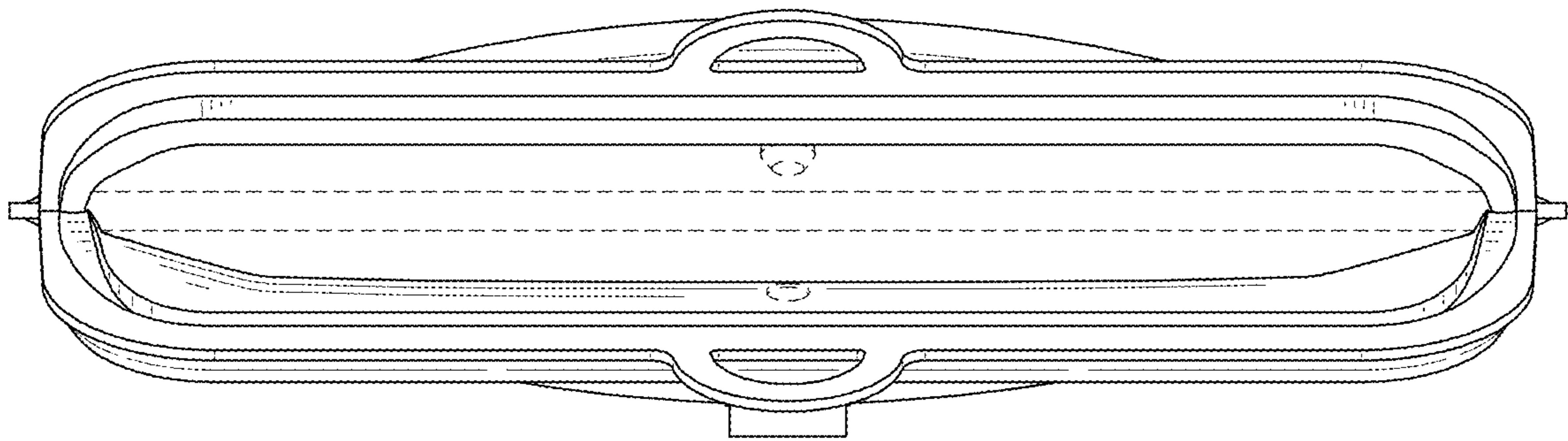

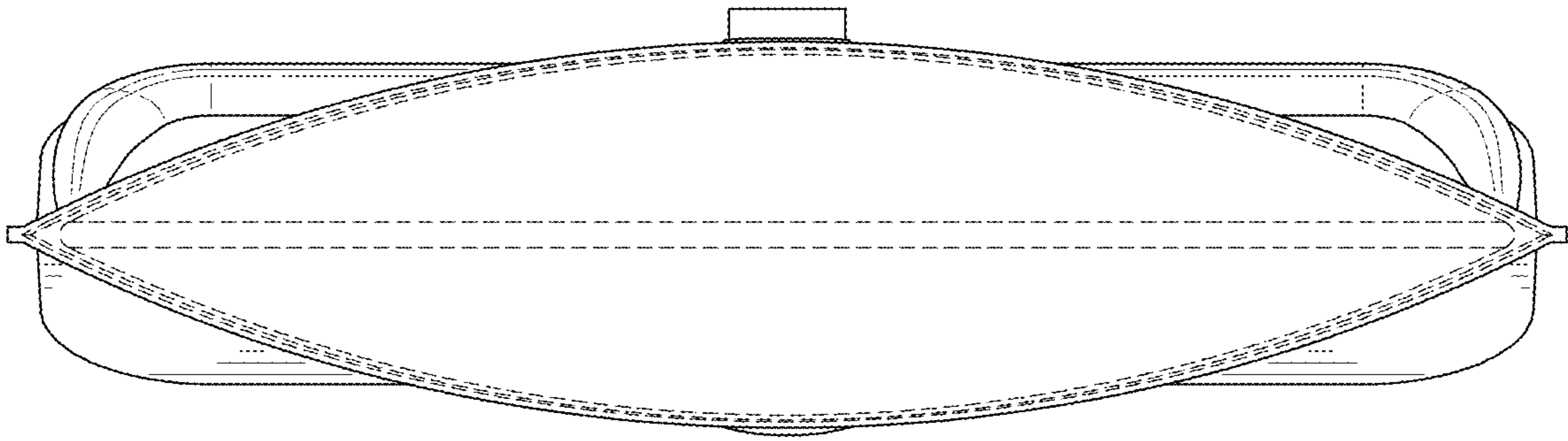
