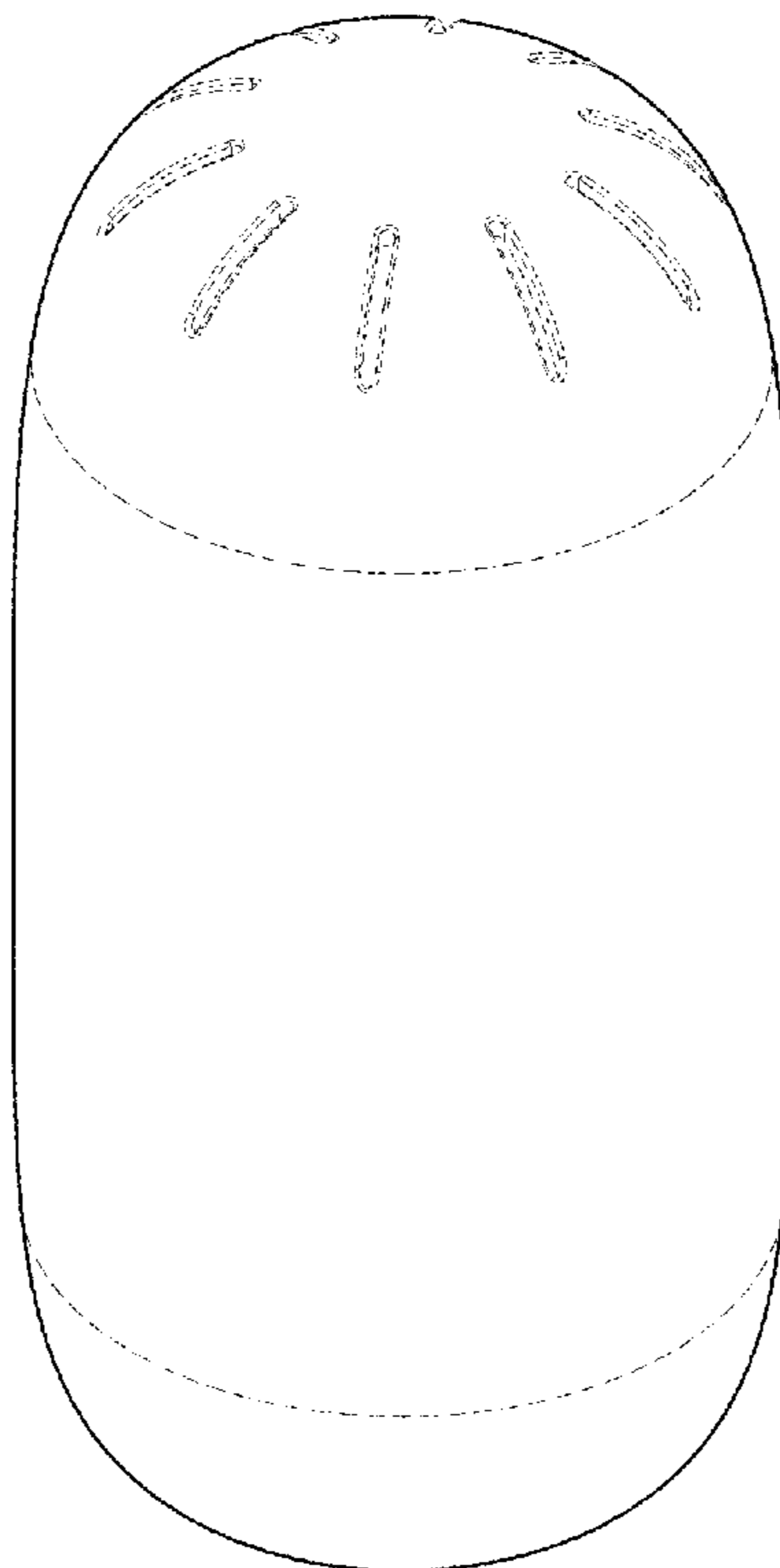
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a cooler, according to one embodiment of our new design;
 FIG. 2 is a top view thereof;

 FIG. 4 is a front view thereof; and
 FIG. 5 is a rear view thereof.

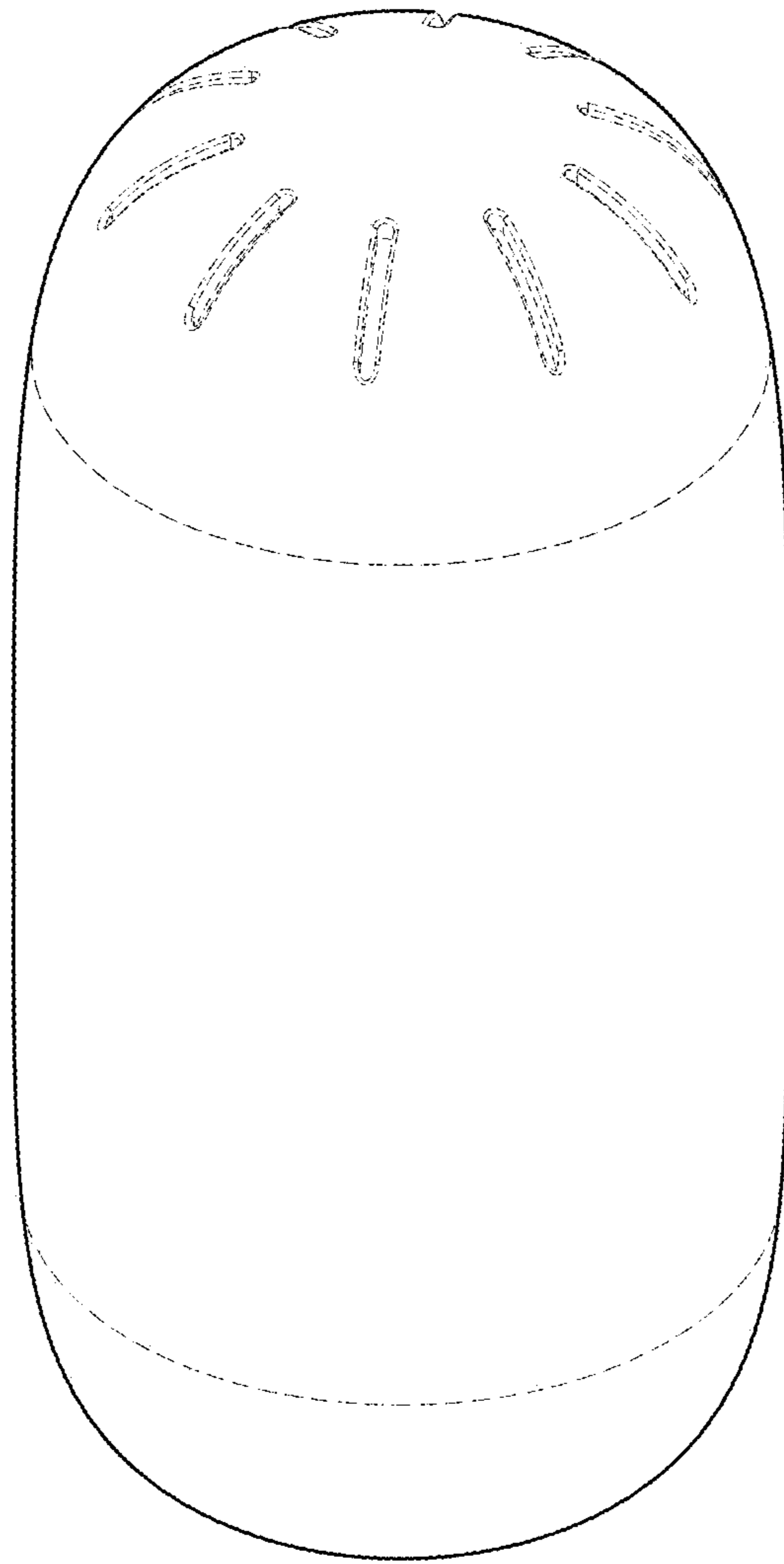

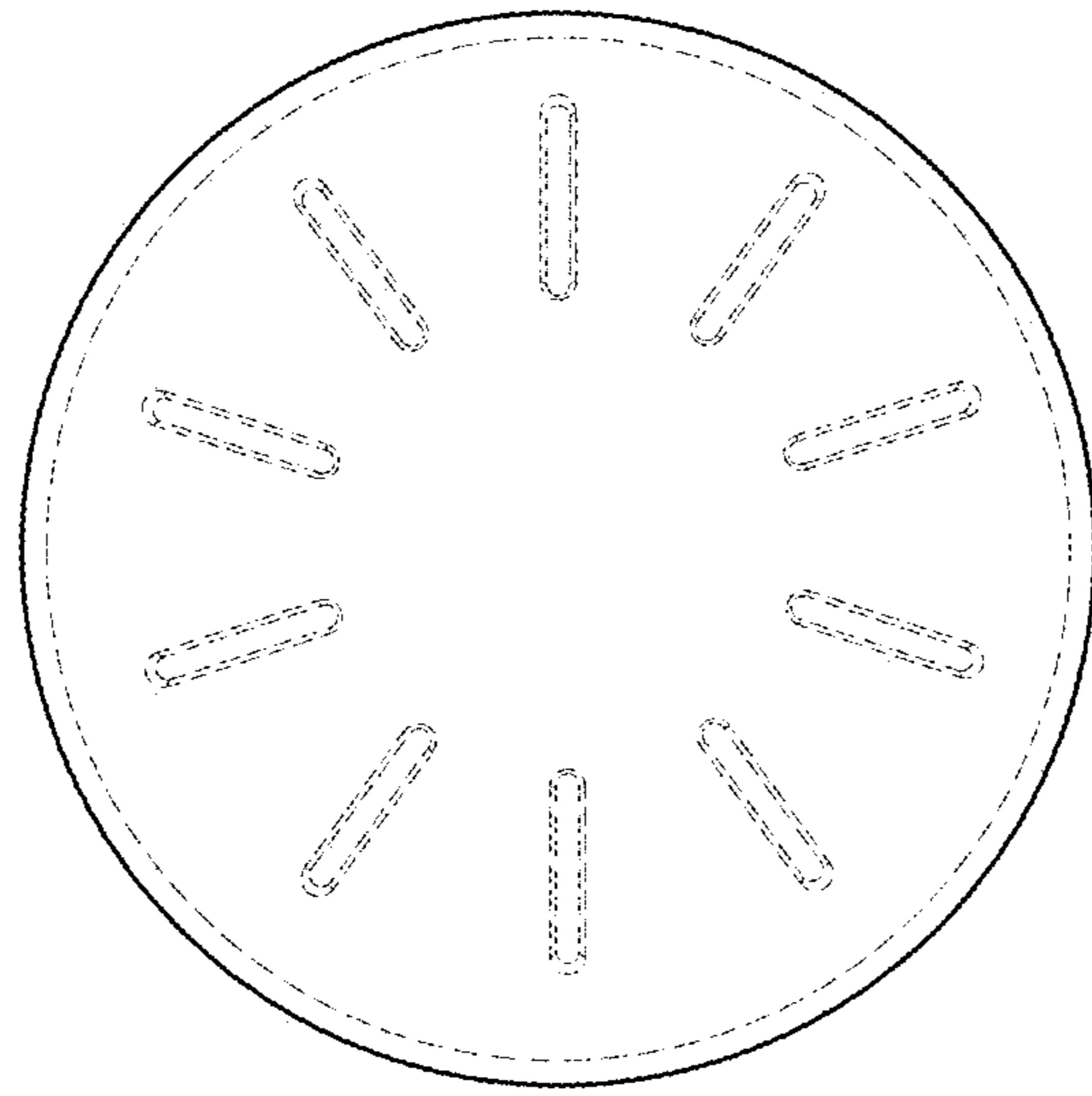

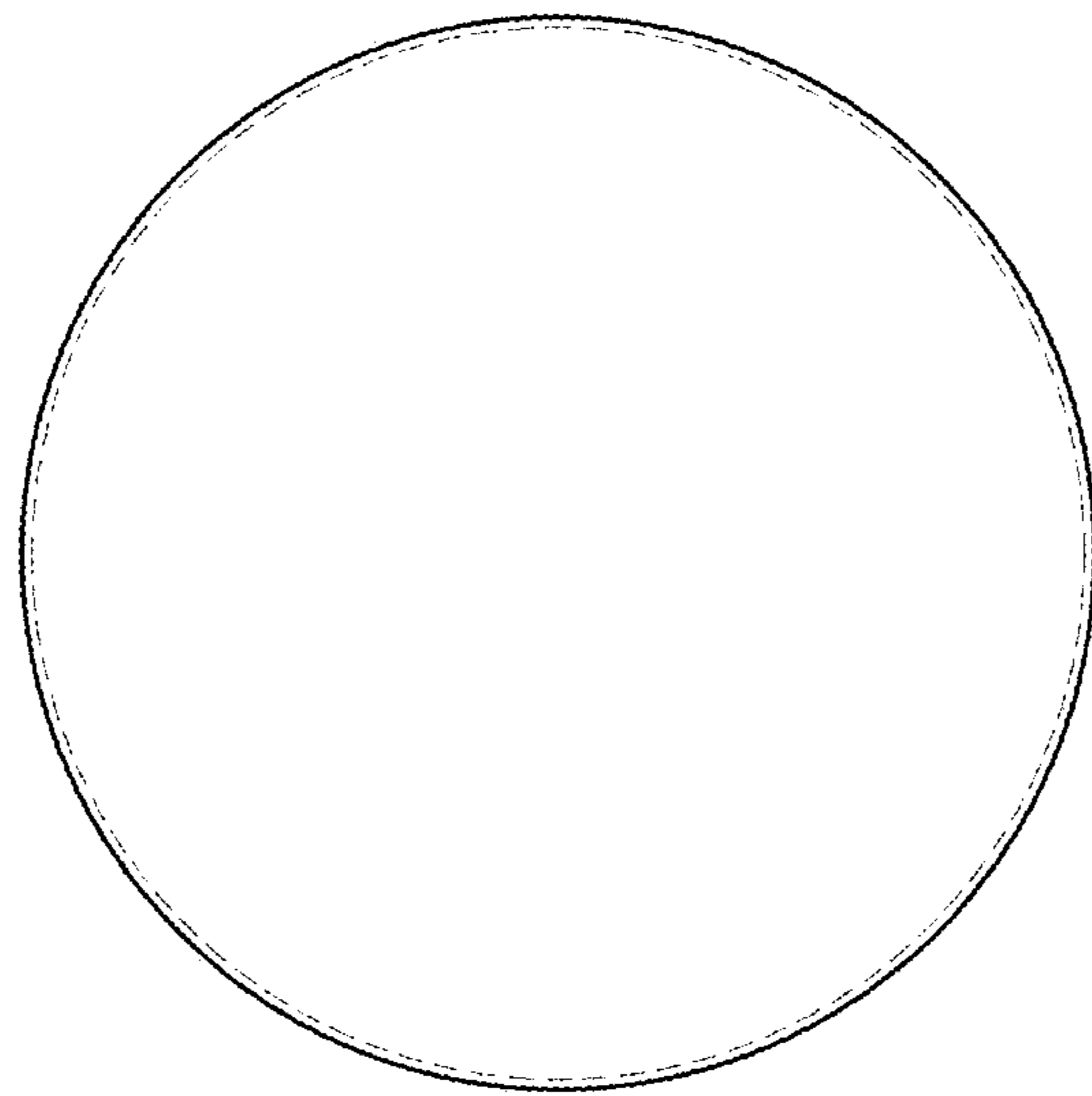

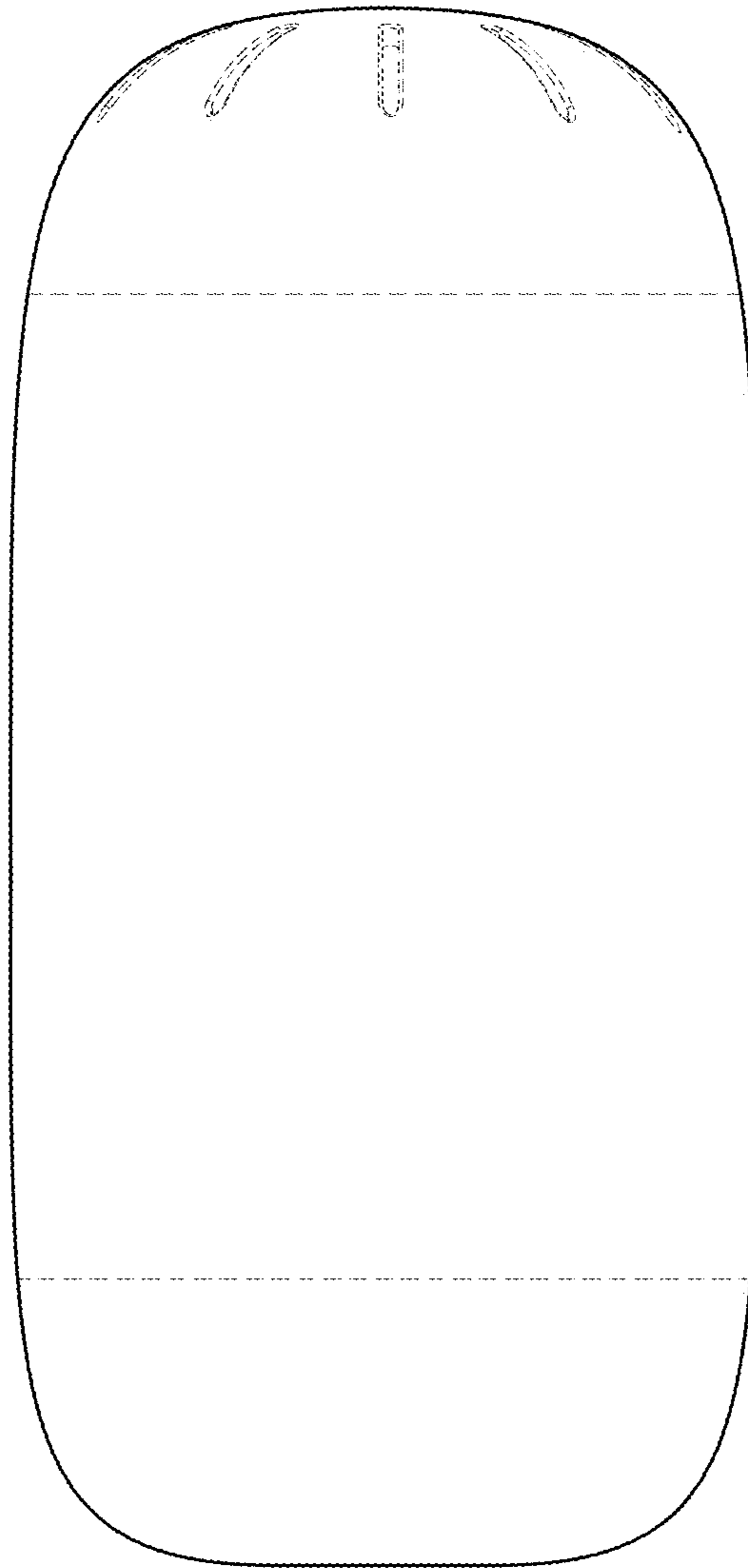

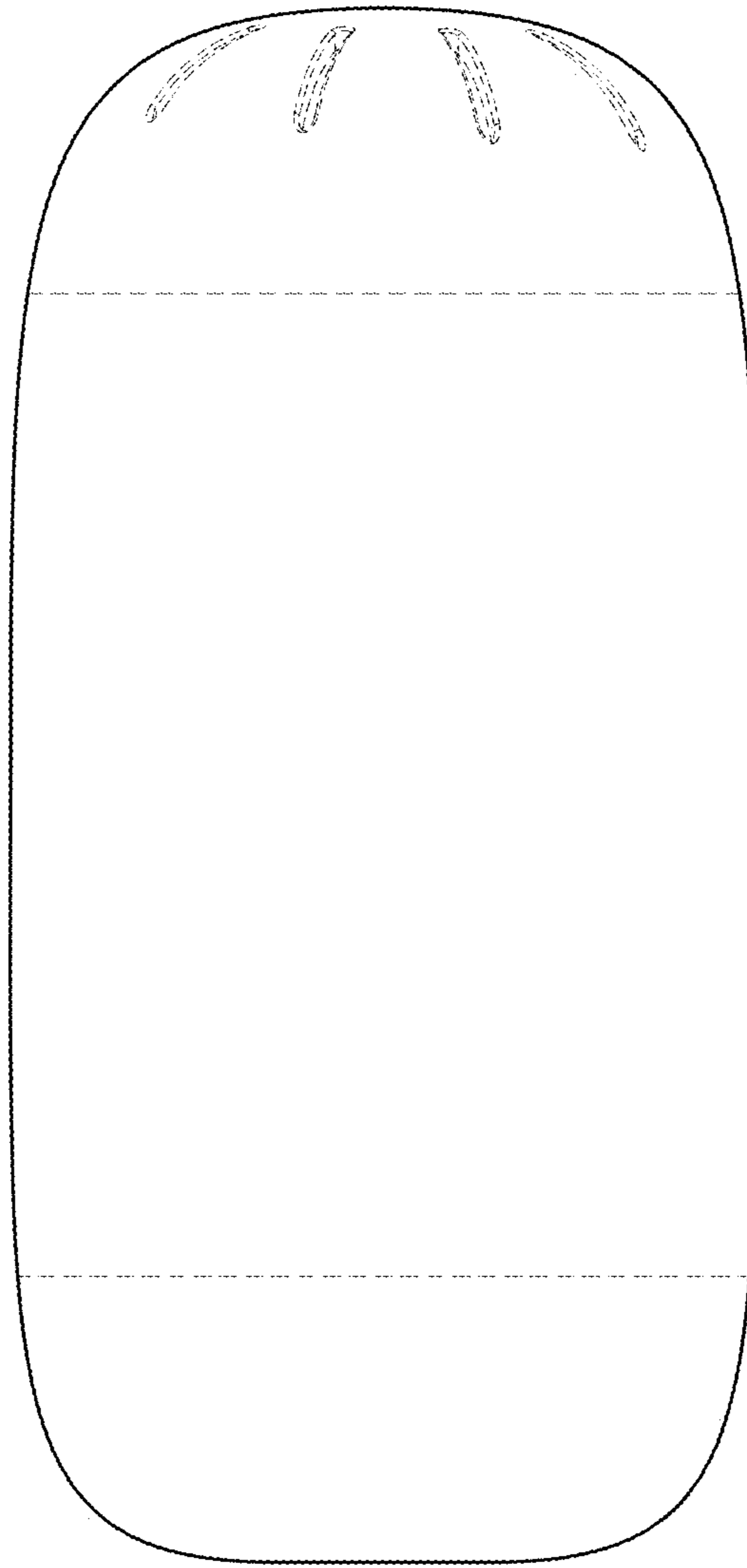

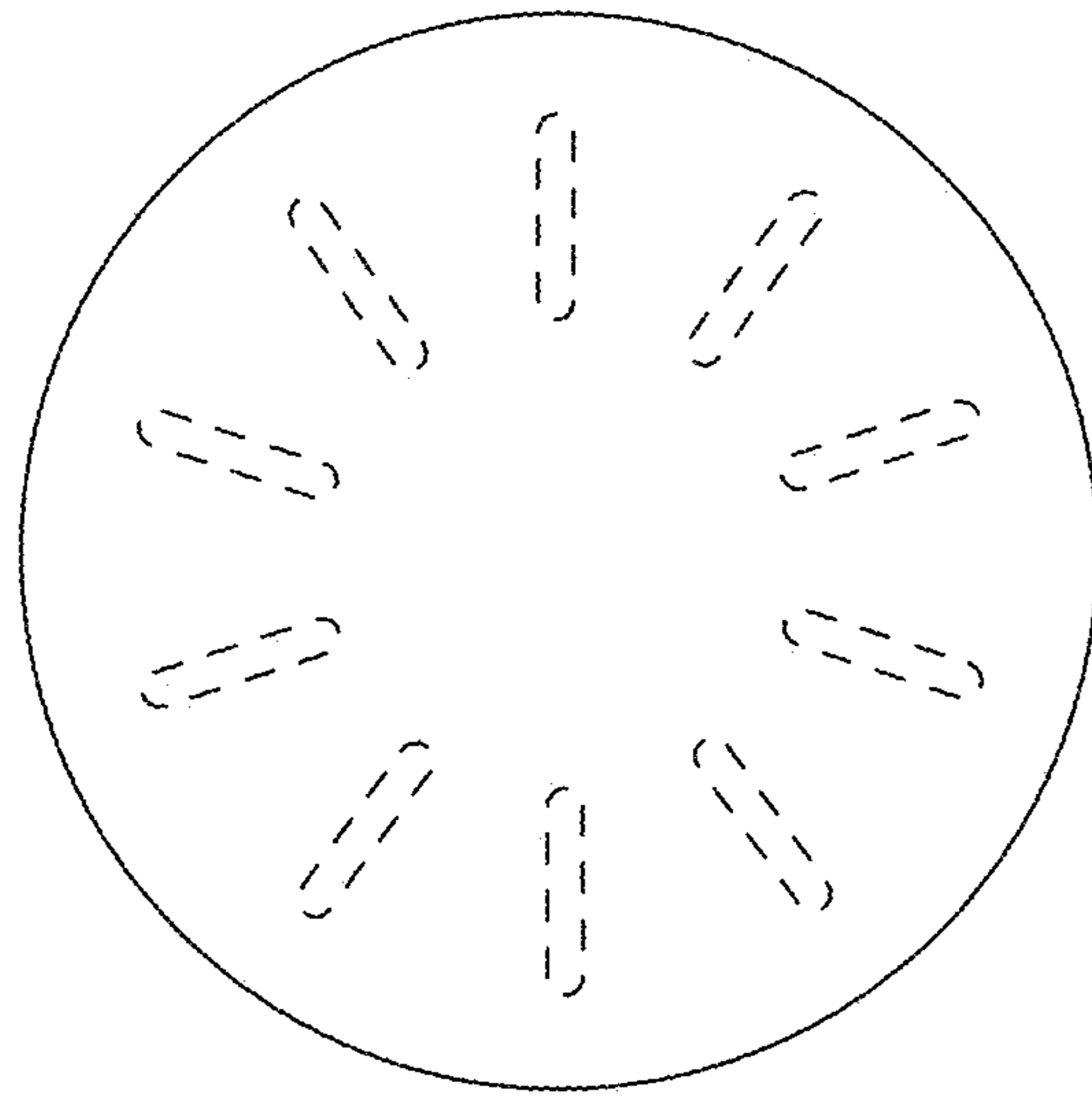

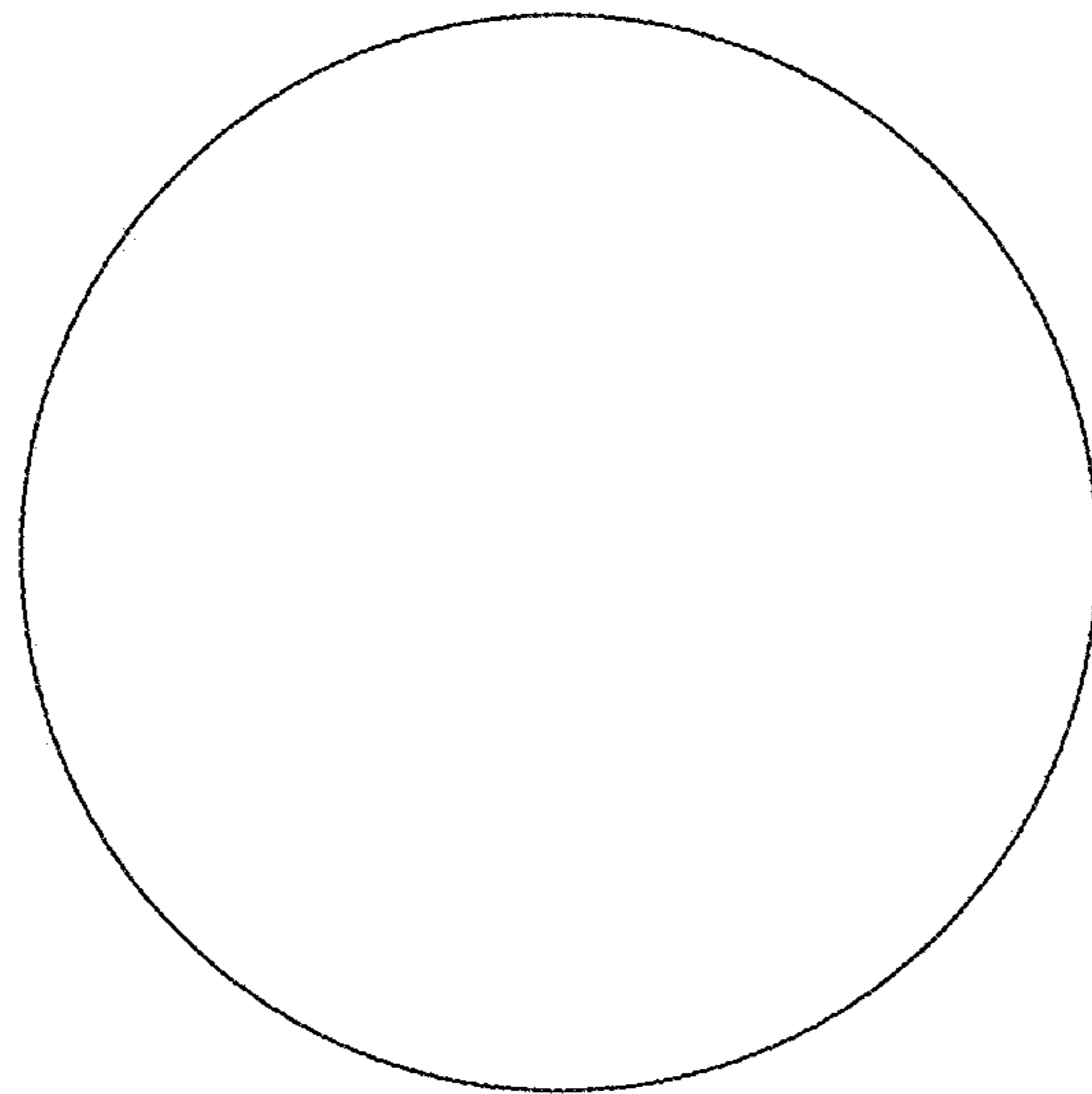

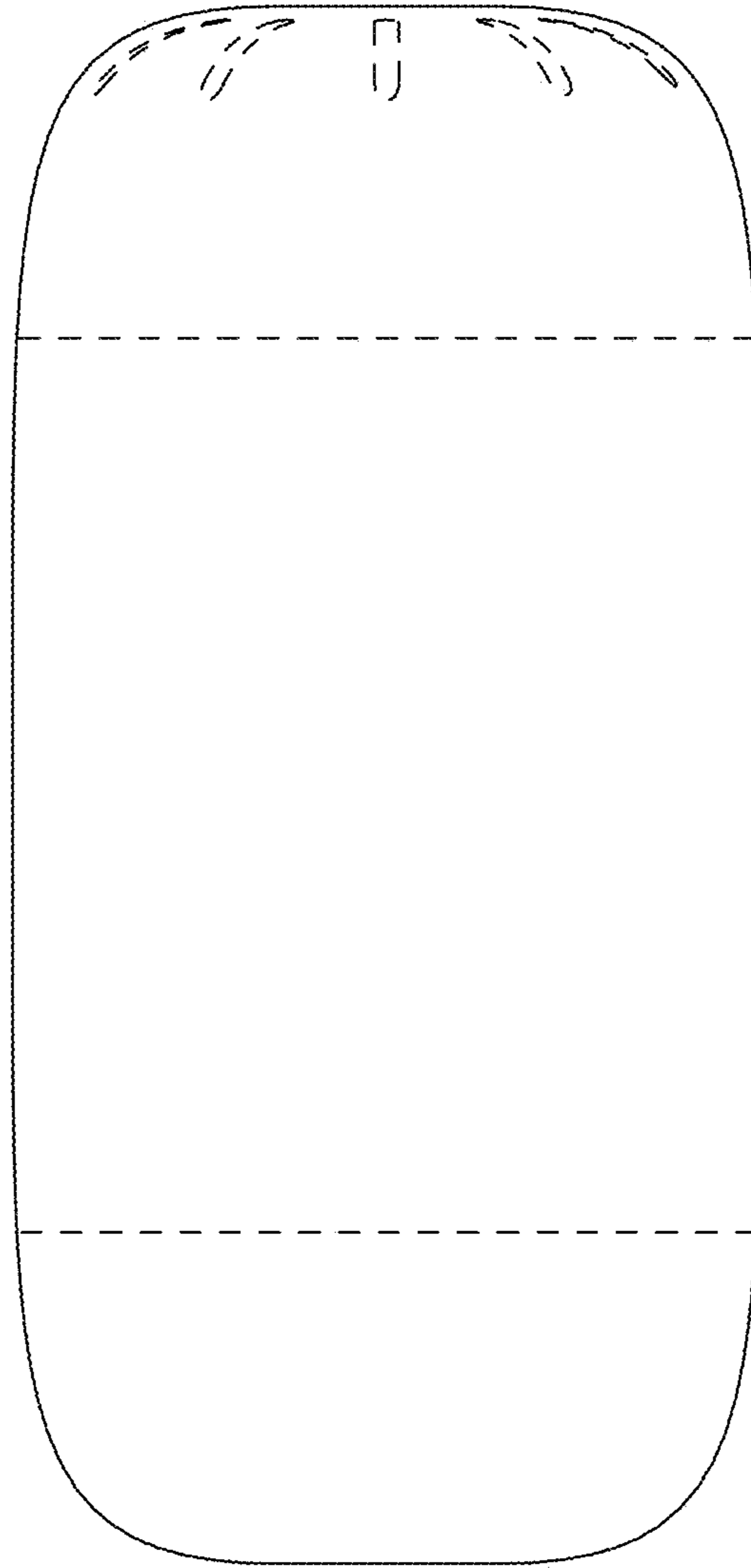
