(57) **CLAIM**

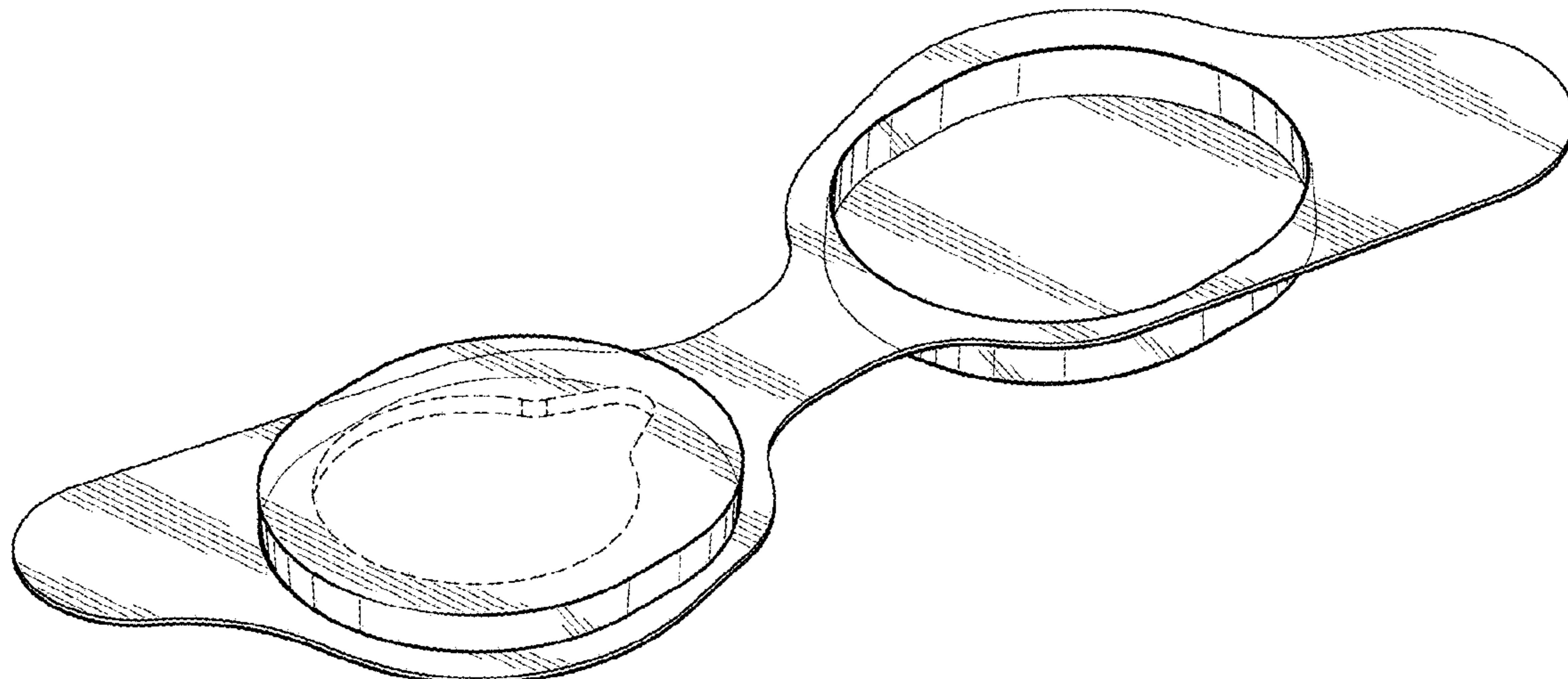
The ornamental design for a clamshell-type package for a sensing pad, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a clamshell-type package for a sensing pad according to the present invention, in an open position.

FIG. 2 is a top view of the package shown in FIG. 1.
FIG. 3 is a bottom view thereof.
FIG. 4 is a front side view thereof.
FIG. 5 is a rear side view thereof.
FIG. 6 is a left side view thereof.
FIG. 7 is a right side view thereof.
FIG. 8 is a cross-sectional taken on line 8-8 of FIG. 2.
FIG. 9 is a front perspective view of the clamshell-type package shown in FIGS. 1-8, in a closed position.
FIG. 10 is a top view of the package shown in FIG. 9.
FIG. 11 is a bottom view thereof.
FIG. 12 is a front side view thereof.
FIG. 13 is a rear side view thereof.
FIG. 14 is a left side view thereof.
FIG. 15 is a right side view thereof.
FIG. 16 is a cross-sectional taken on line 16-16 of FIG. 10.
FIG. 17 is a front perspective view of clamshell-type package for a sensing pad according to an alternative embodiment of the present invention, in an open position.
FIG. 18 is a front perspective view of the package shown in FIG. 17, in a closed position
FIG. 19 is a top view of the package shown in FIGS. 17 and 18, in an open position.
FIG. 20 is a cross-sectional view taken on line 21-21 of FIG. 19.
FIG. 21 is cross-sectional view similar to FIG. 20, but with the package in a closed position.
FIG. 22 is a front perspective view of a clamshell-type package for a sensing pad, according to another alternative embodiment of the present invention, in an open position.
FIG. 23 is a front perspective view of the package shown in FIG. 22, in a closed position
FIG. 24 is a top view of the package shown in FIG. 22.
FIG. 25 is a cross-sectional taken on line 25-25 of FIG. 24; and,
FIG. 26 is cross-sectional view similar to FIG. 25, but with the package in a closed position.
The broken line showing in the drawings is included for the purpose of illustrating portions of the clamshell-type package for a sensing pad and forms no part of the claimed design.

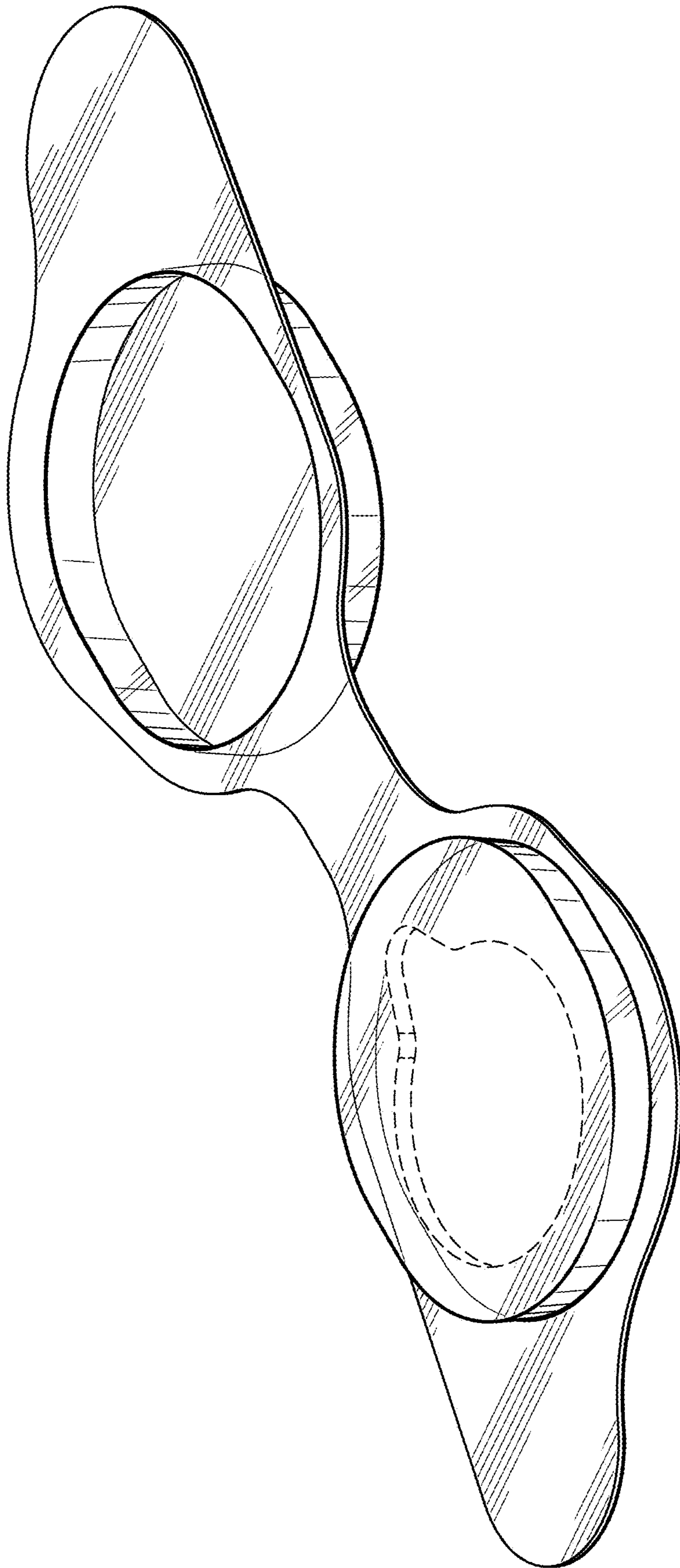

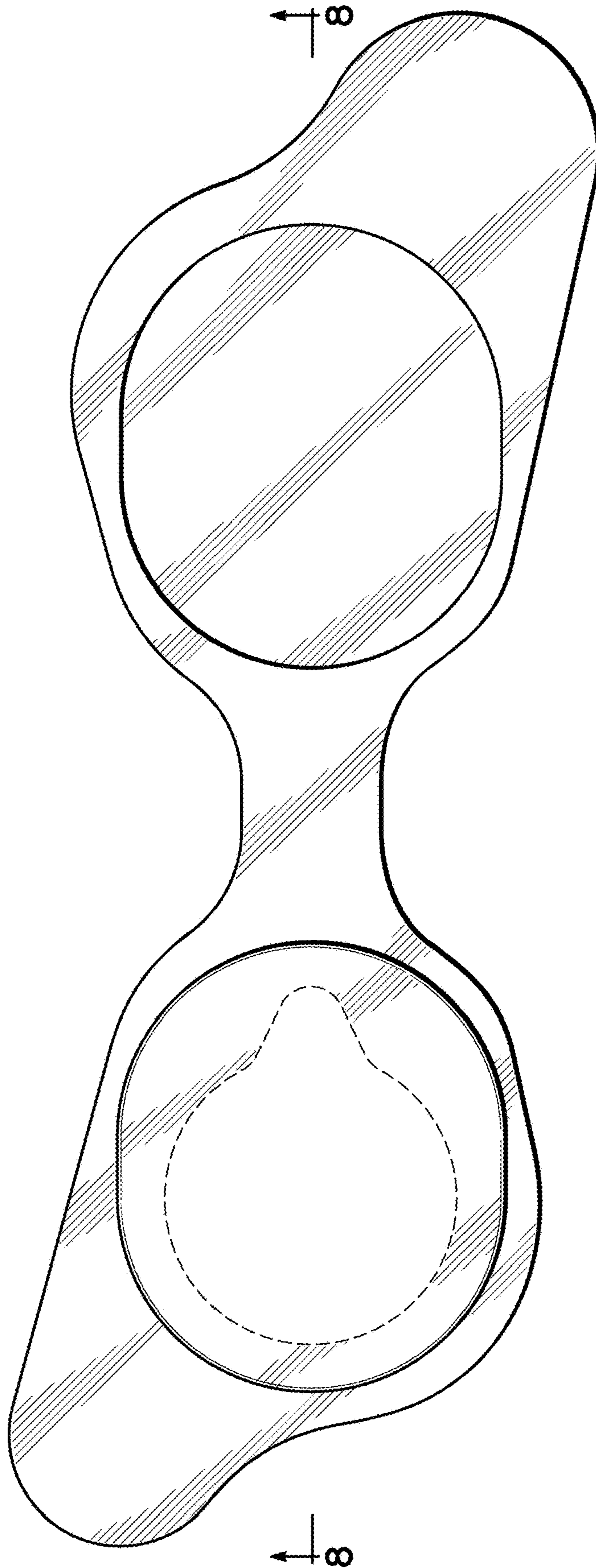

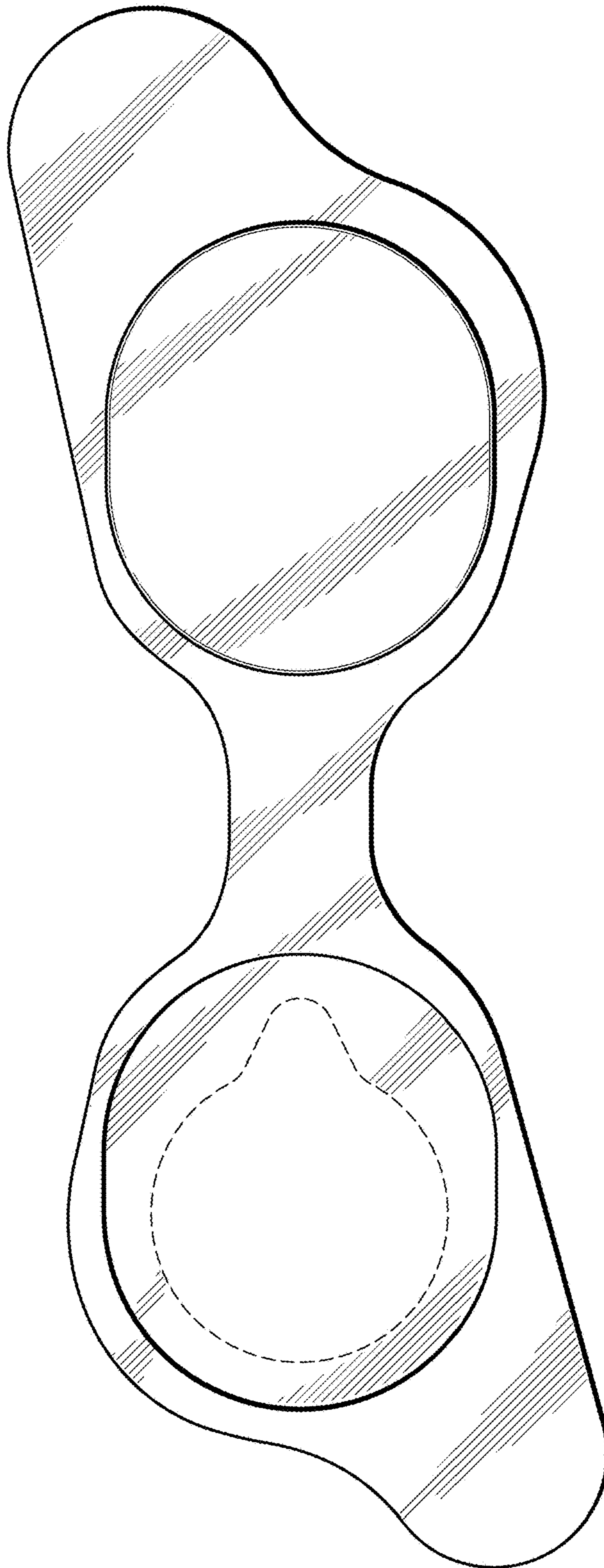

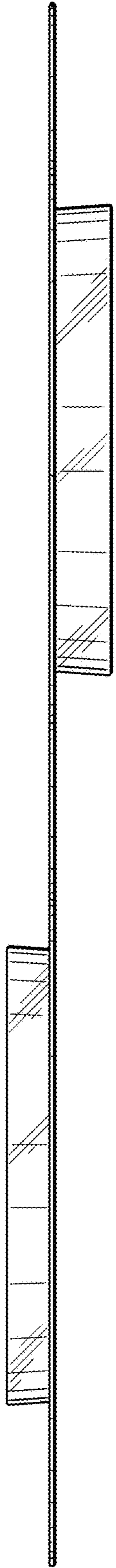

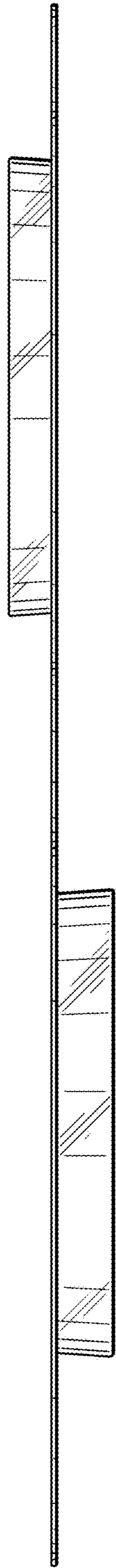

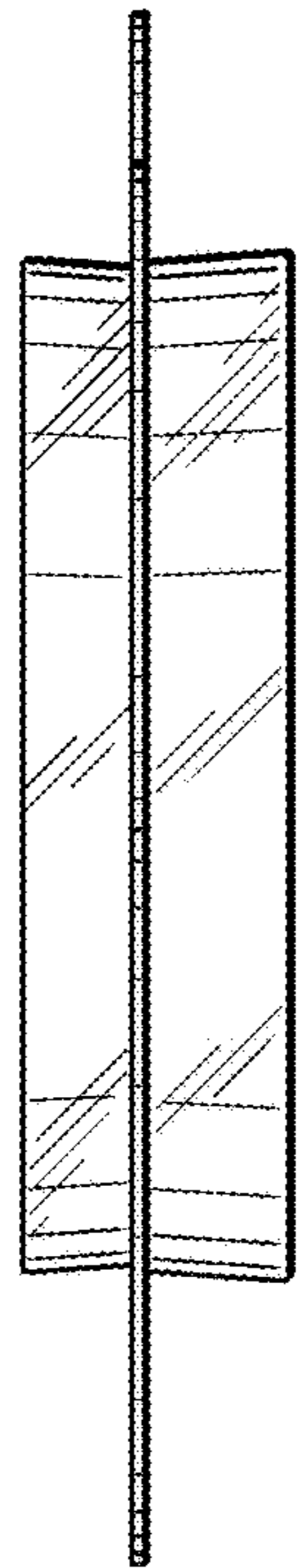

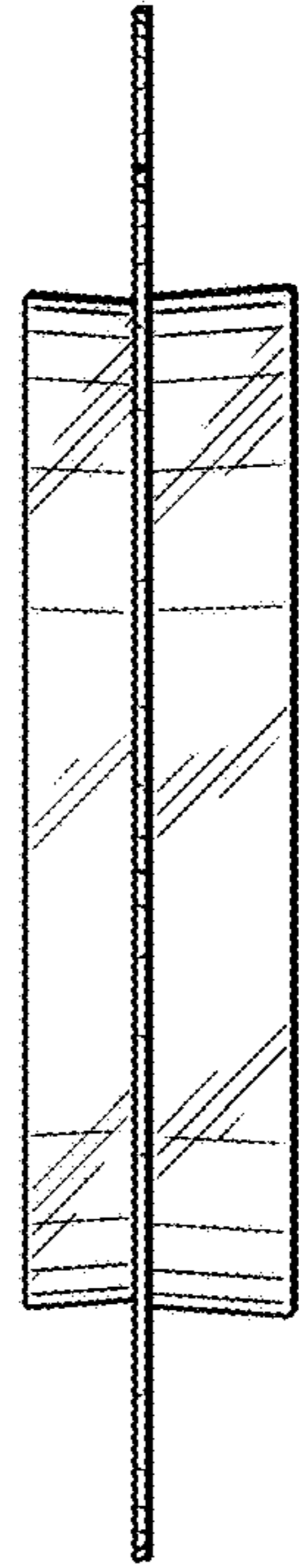

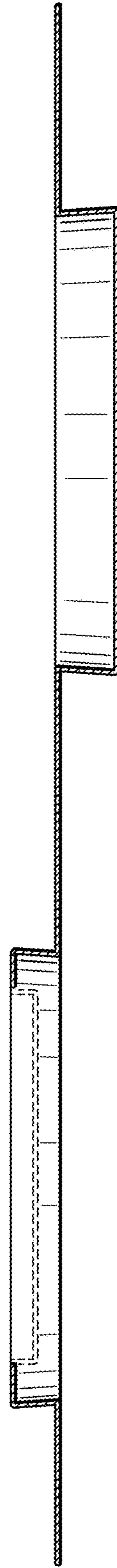

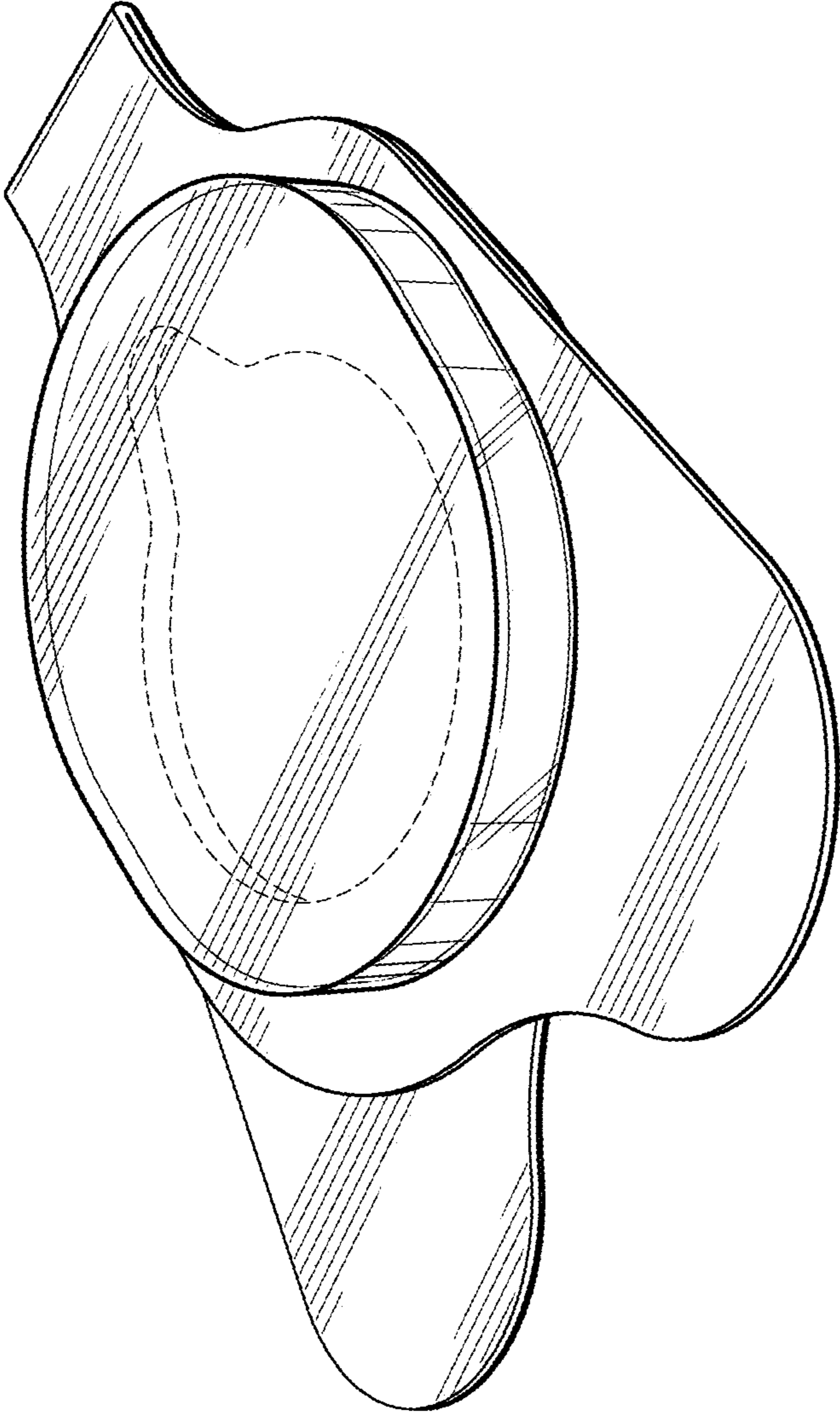

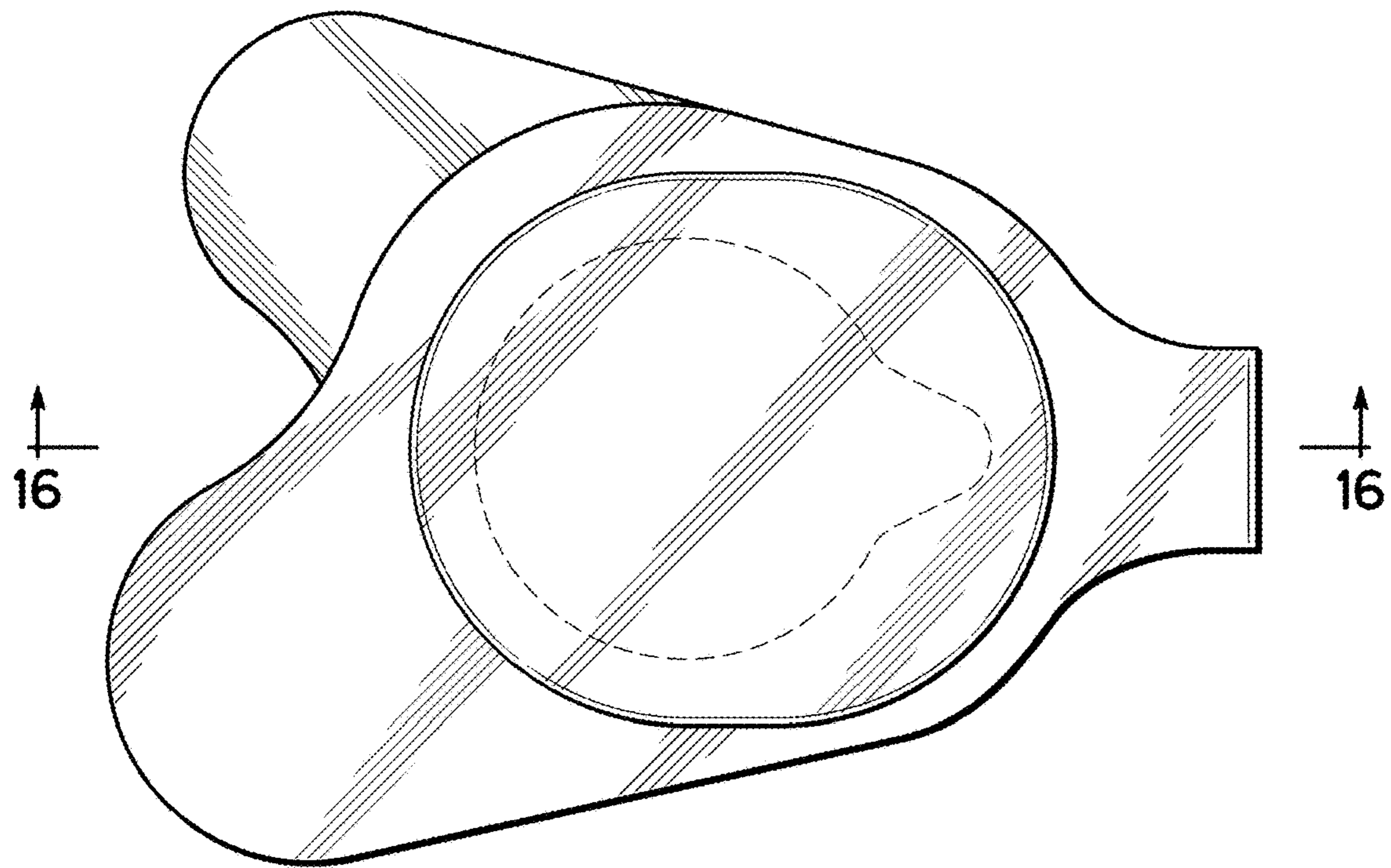

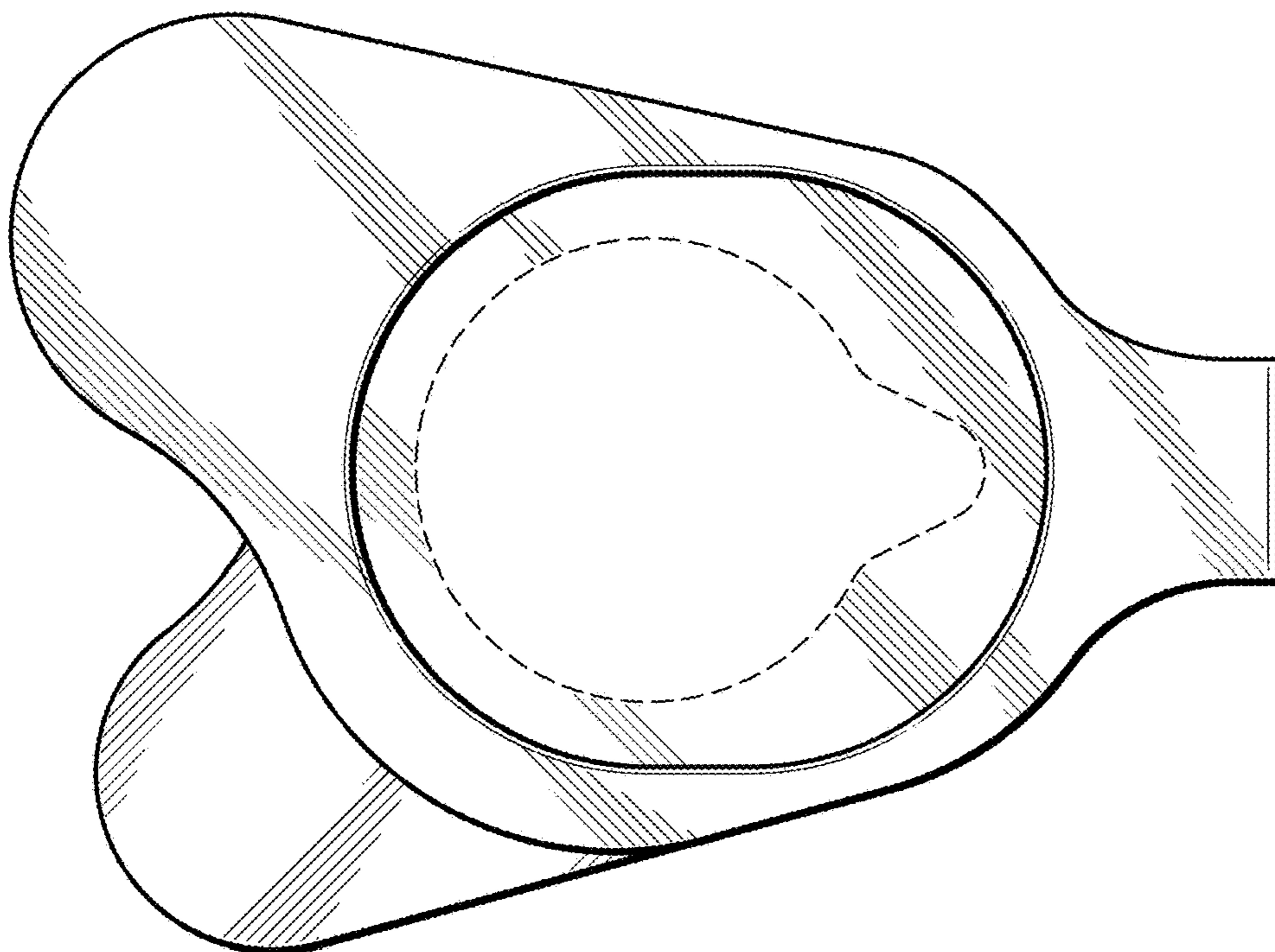

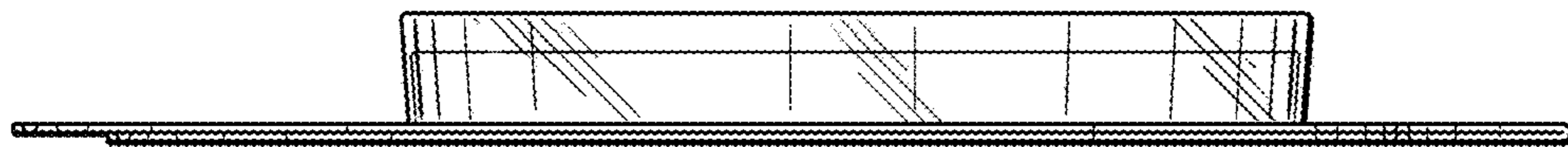

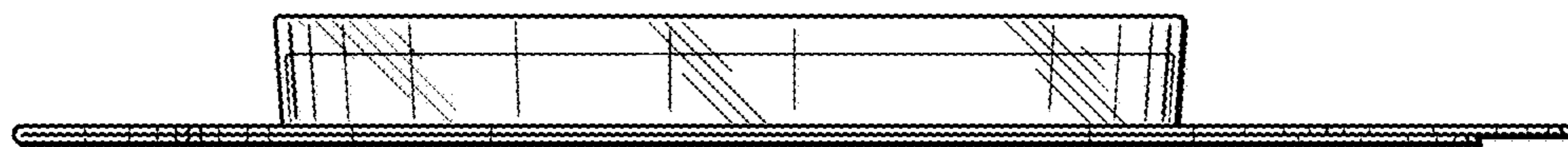

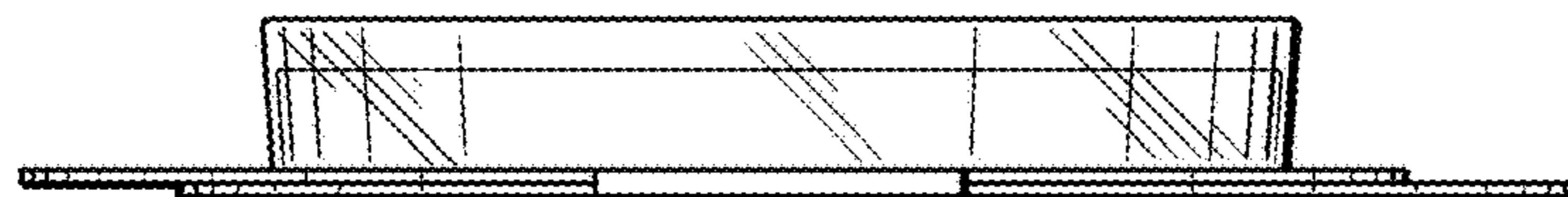

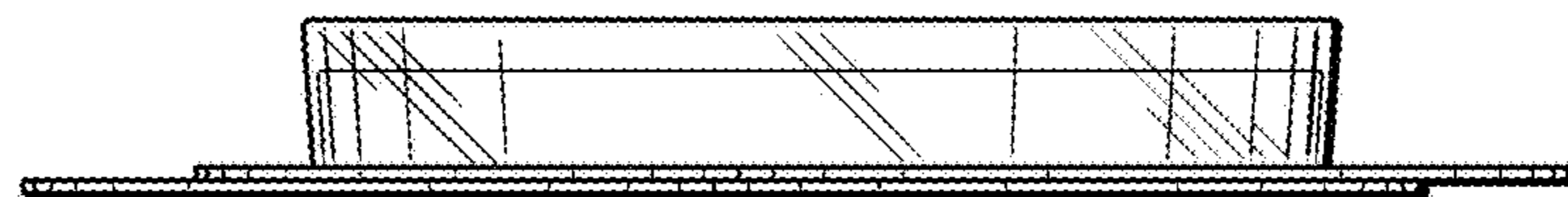

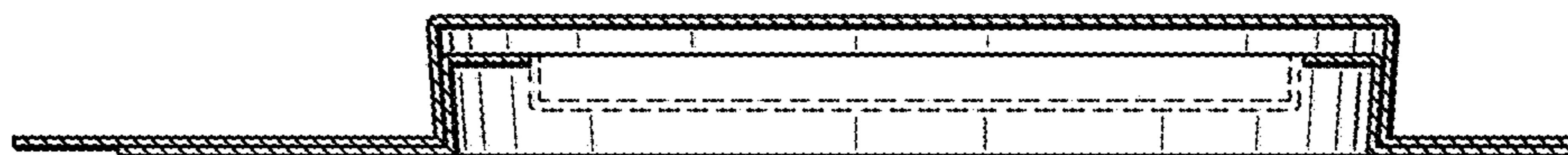

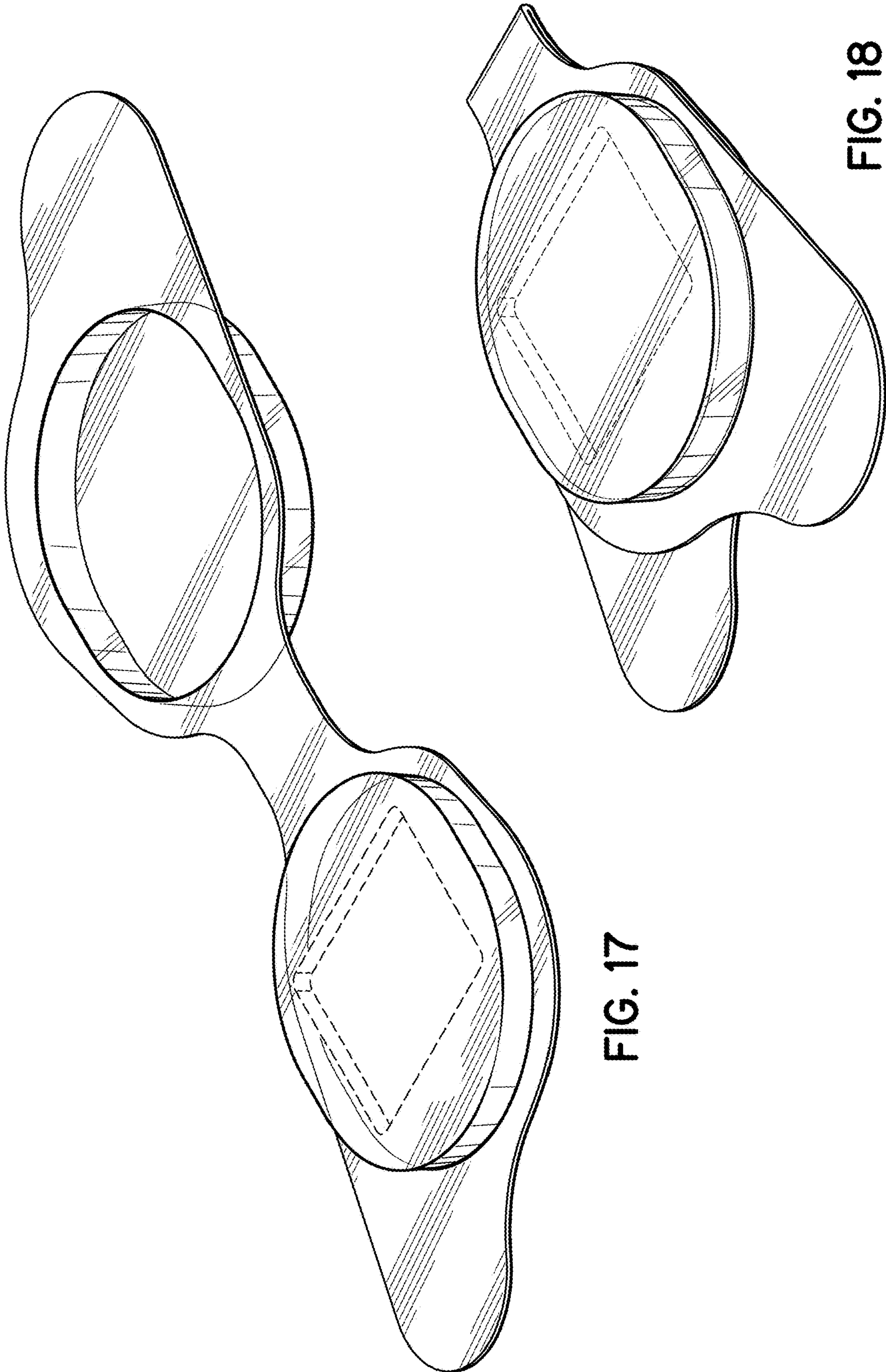

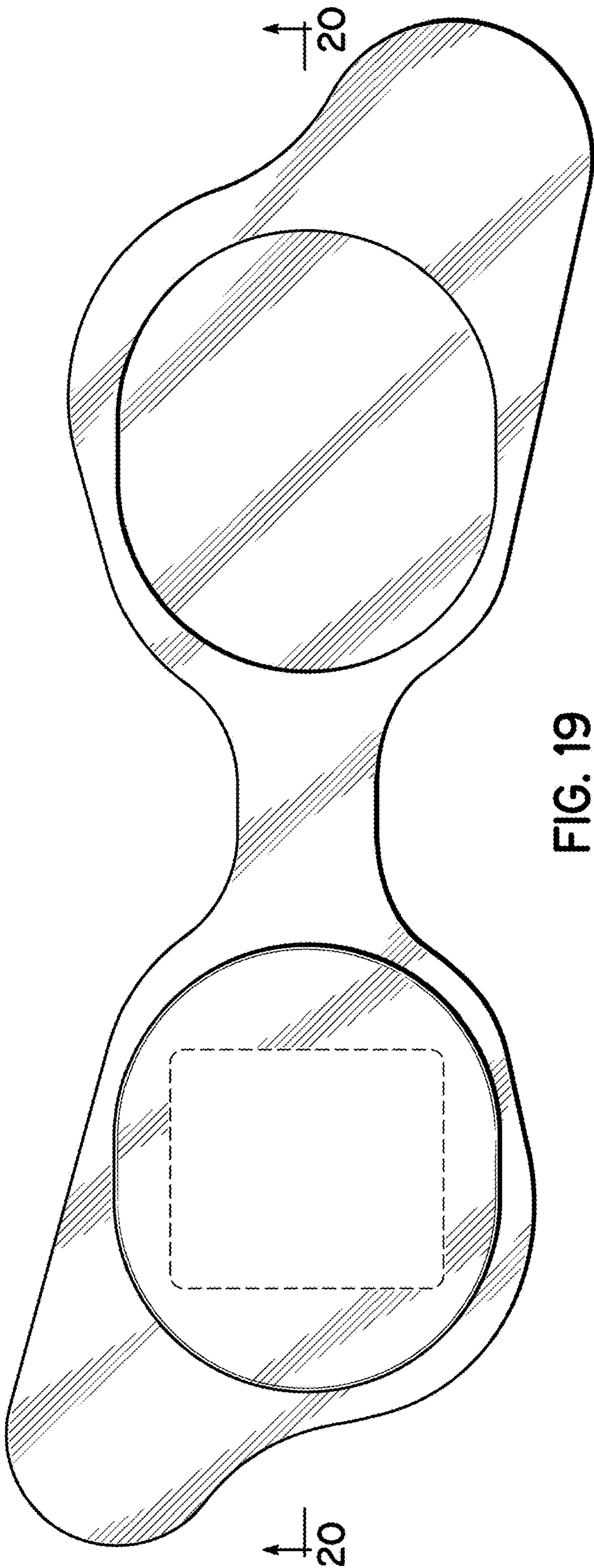

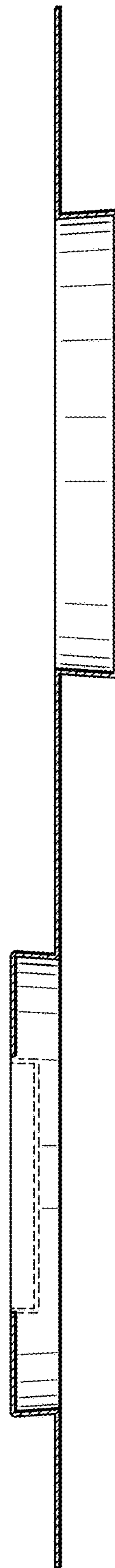

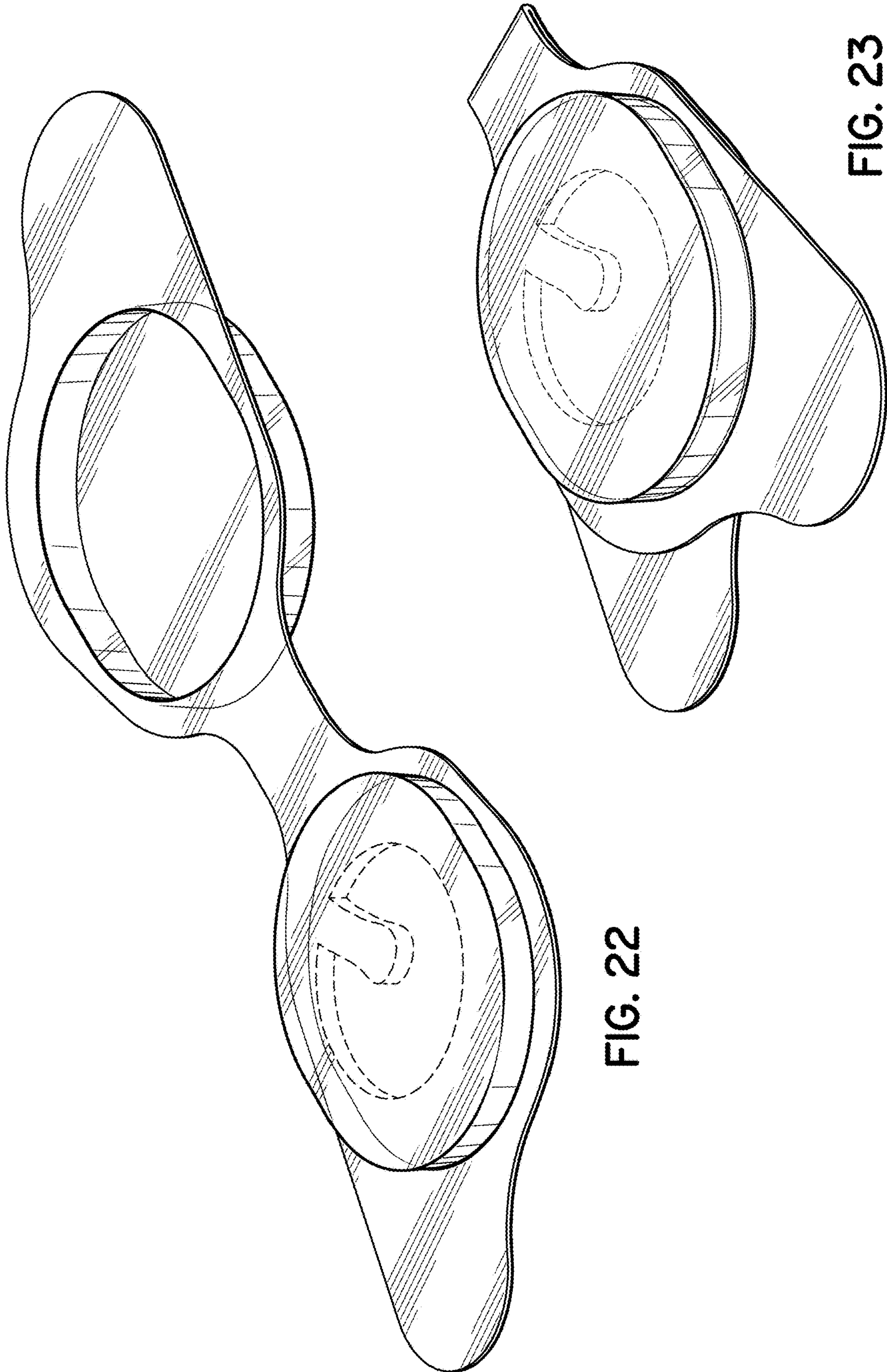
