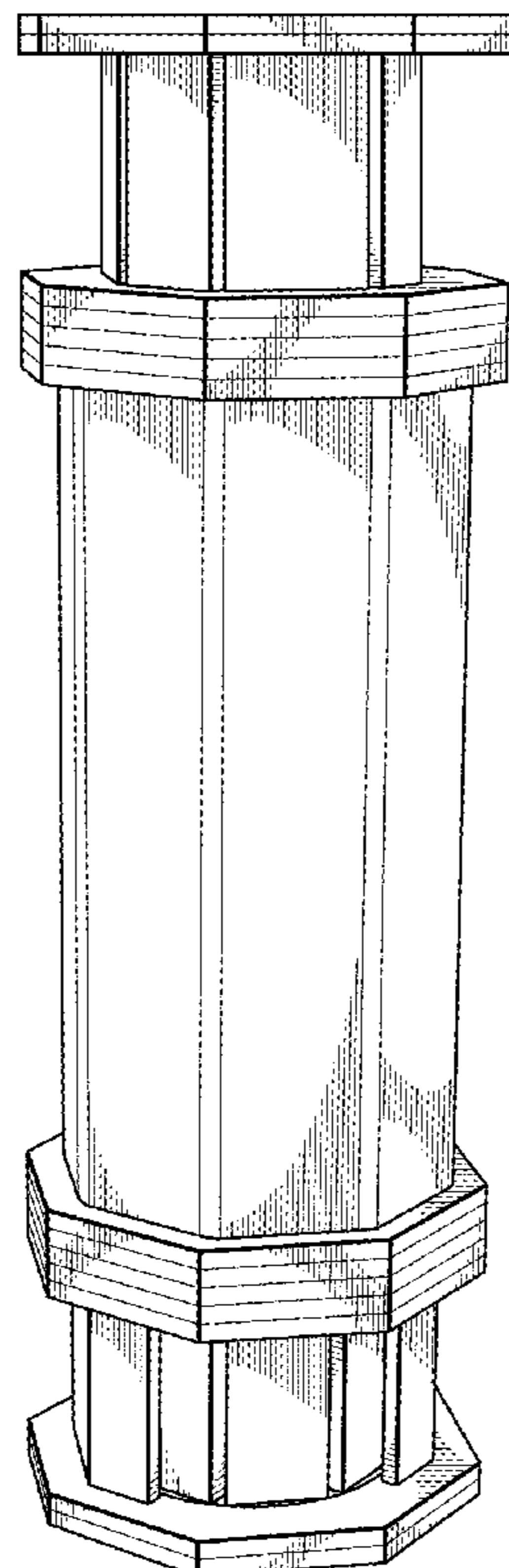

FIG. 1 is a front view of the tube with leather wrapped rigid slats, the rear view being a mirror image thereof.
FIG. 2 is a left side view, the right side being a mirror image thereof; and,
FIG. 3 is a top view, the bottom view being a mirror imaged thereof.
Our tube with leather wrapped rigid slats is characterized by rigid slats around which leather is affixed to form a tubular structure.

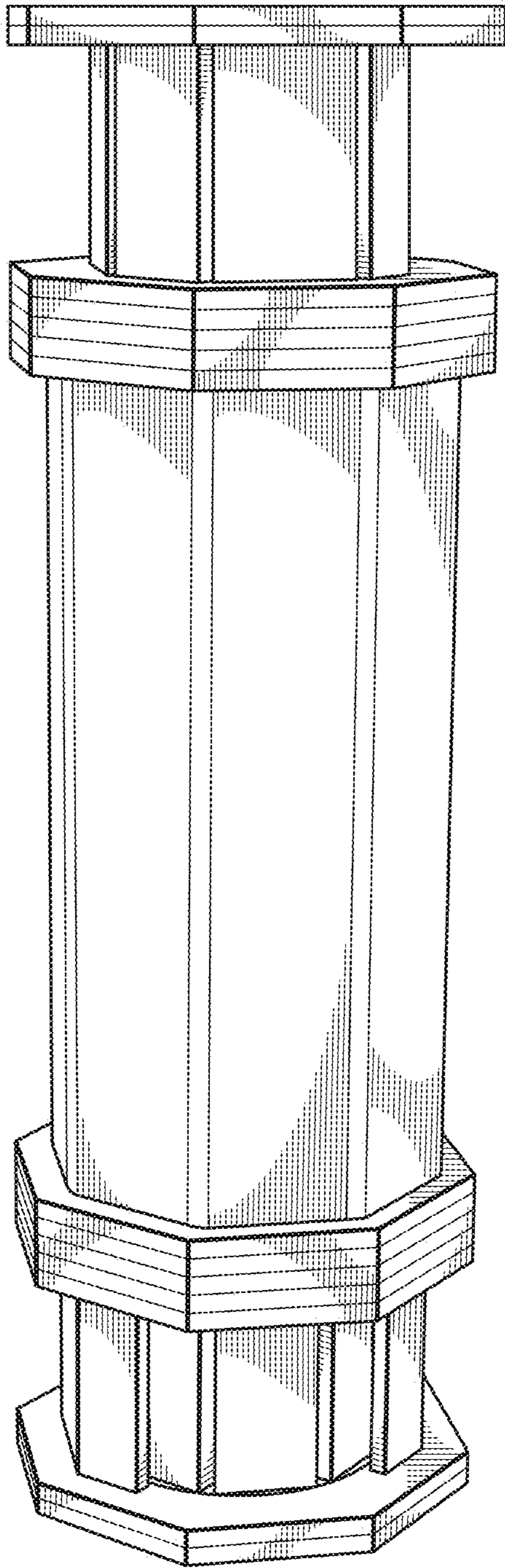

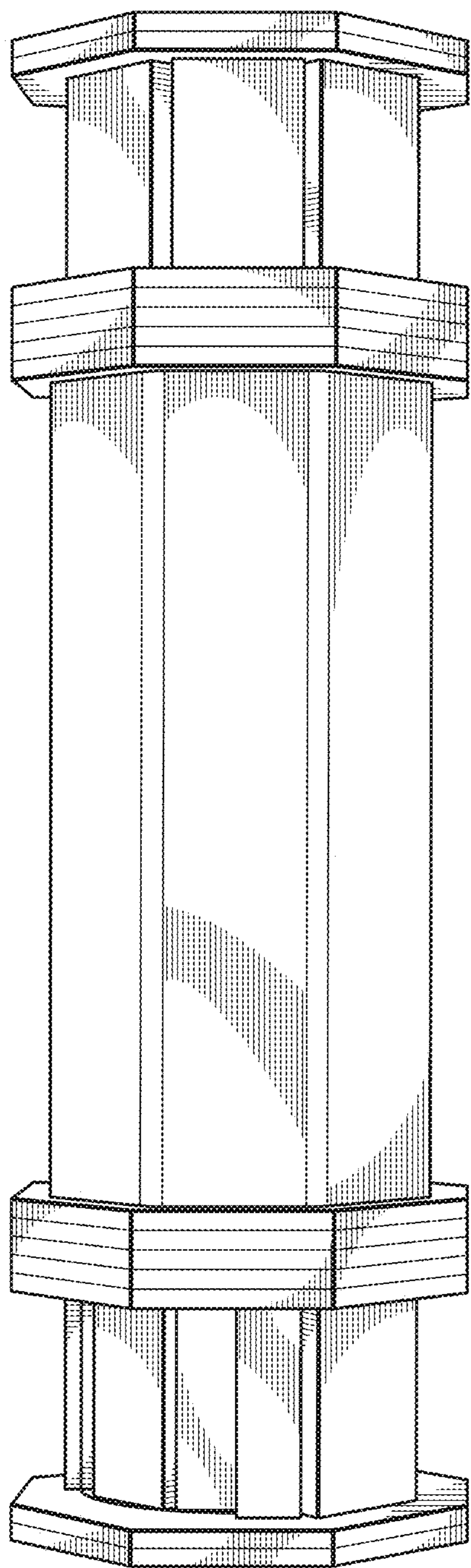

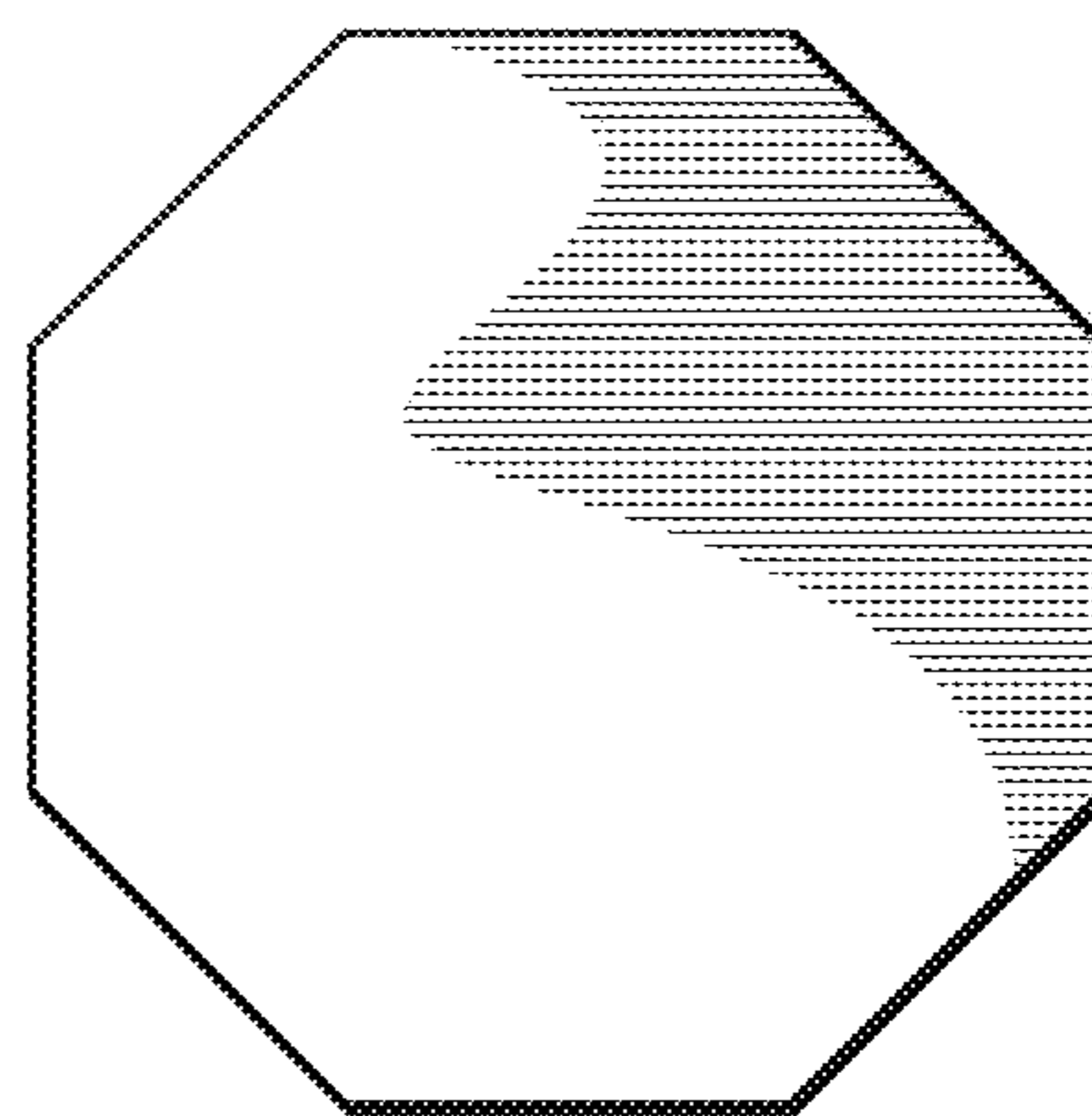
