FIG. 1 is a perspective view of a precious stone, showing my new design.

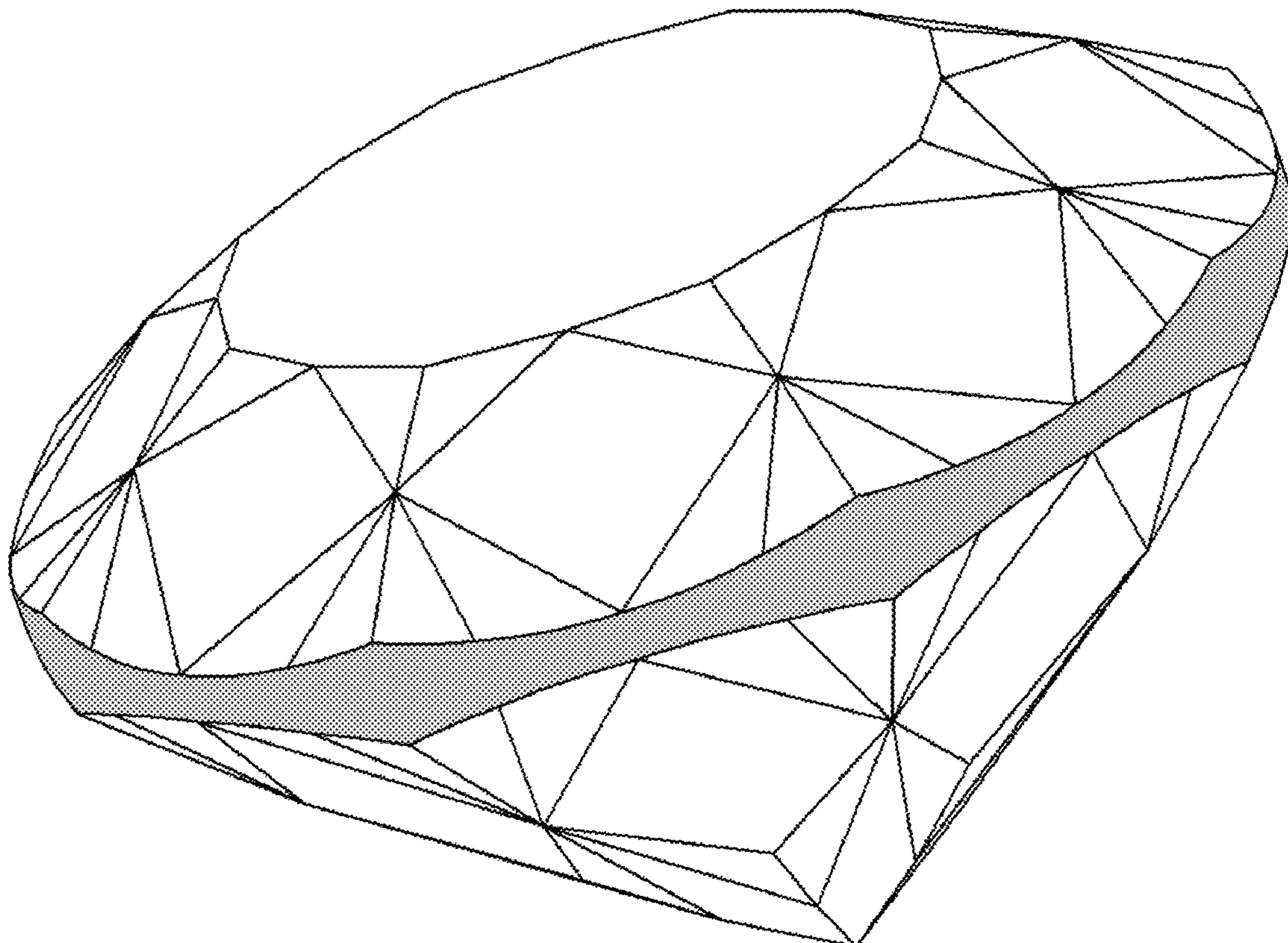
FIG. 2 is another perspective view of the precious stone of FIG. 1.

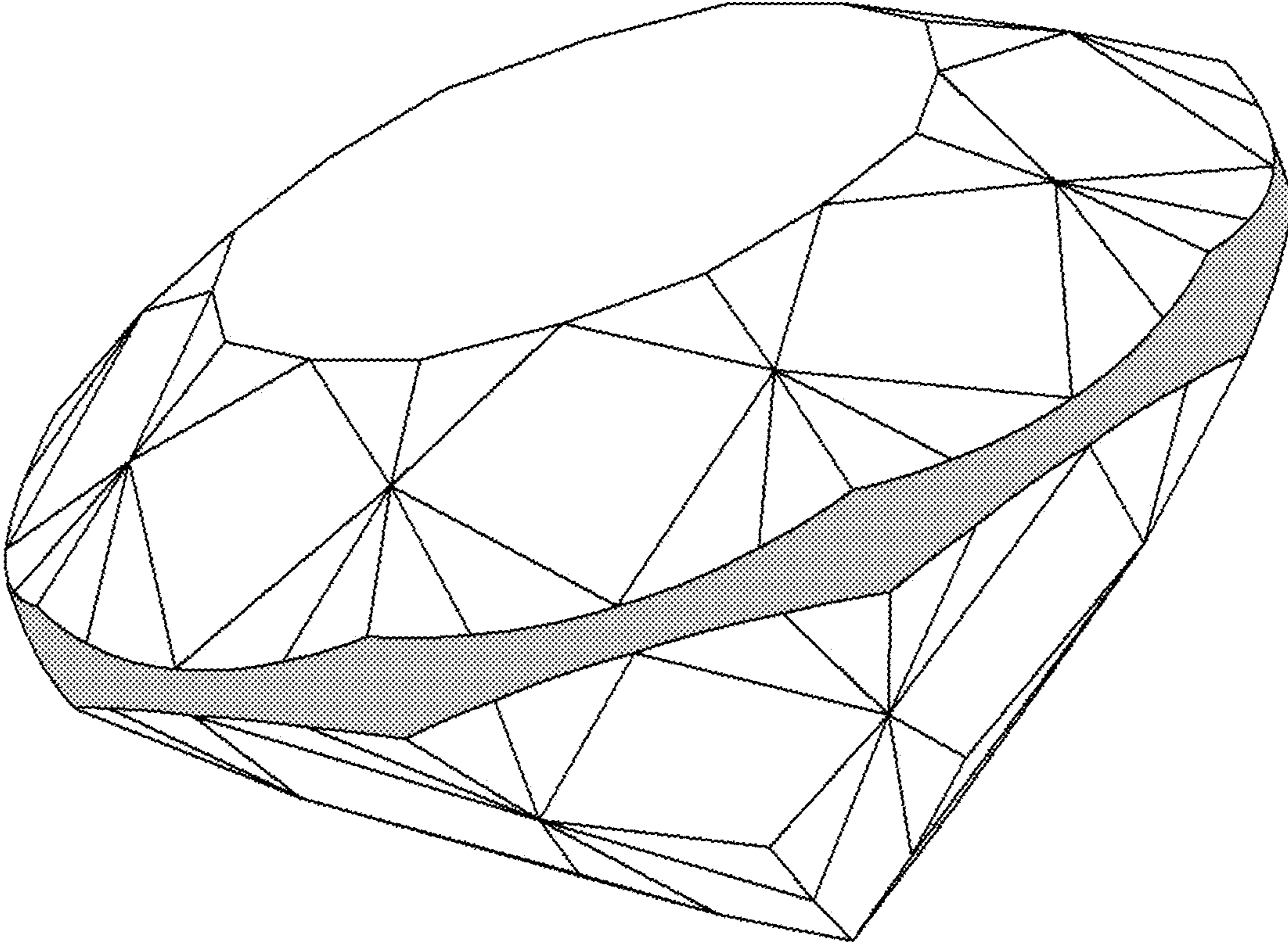

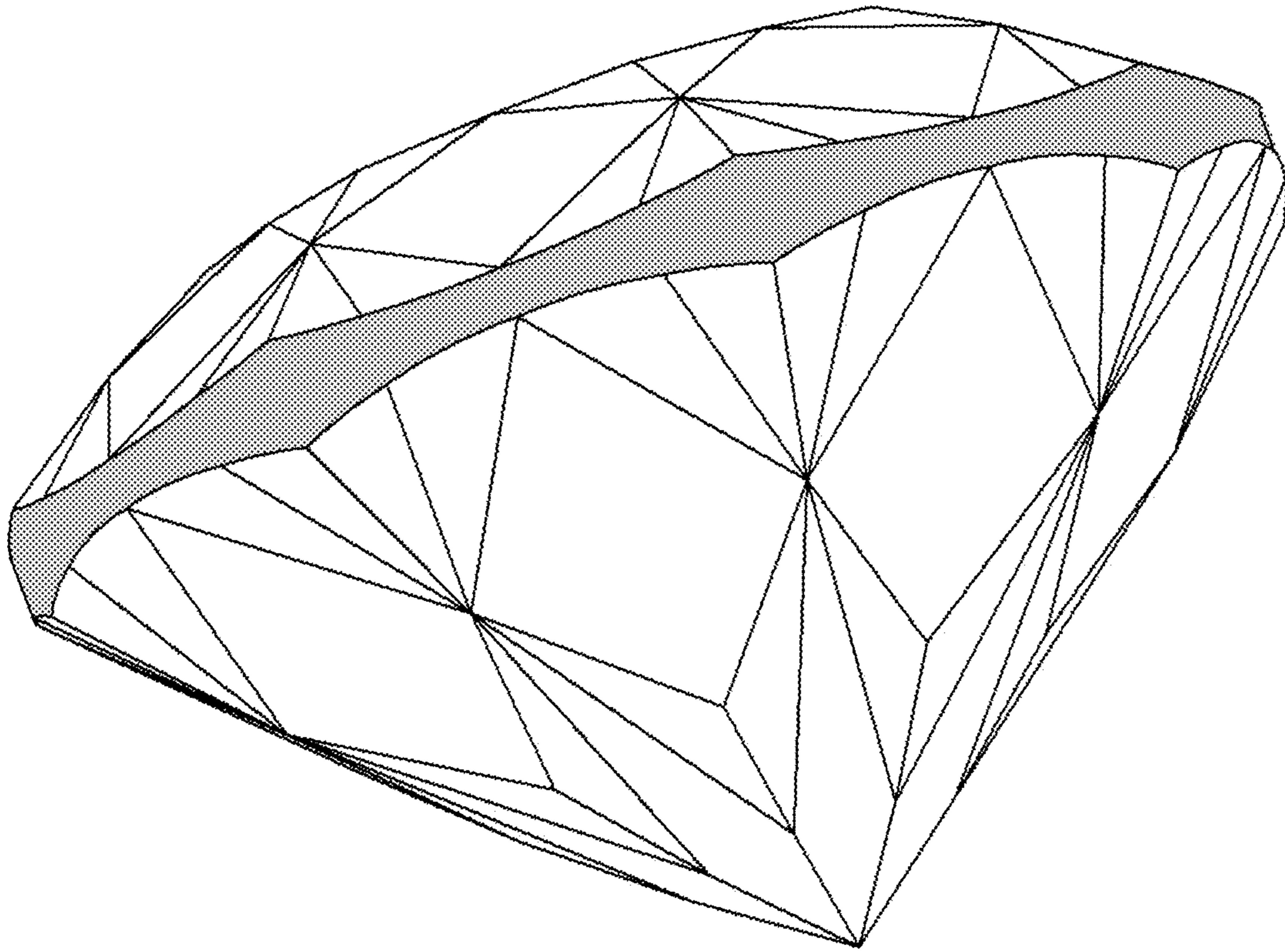

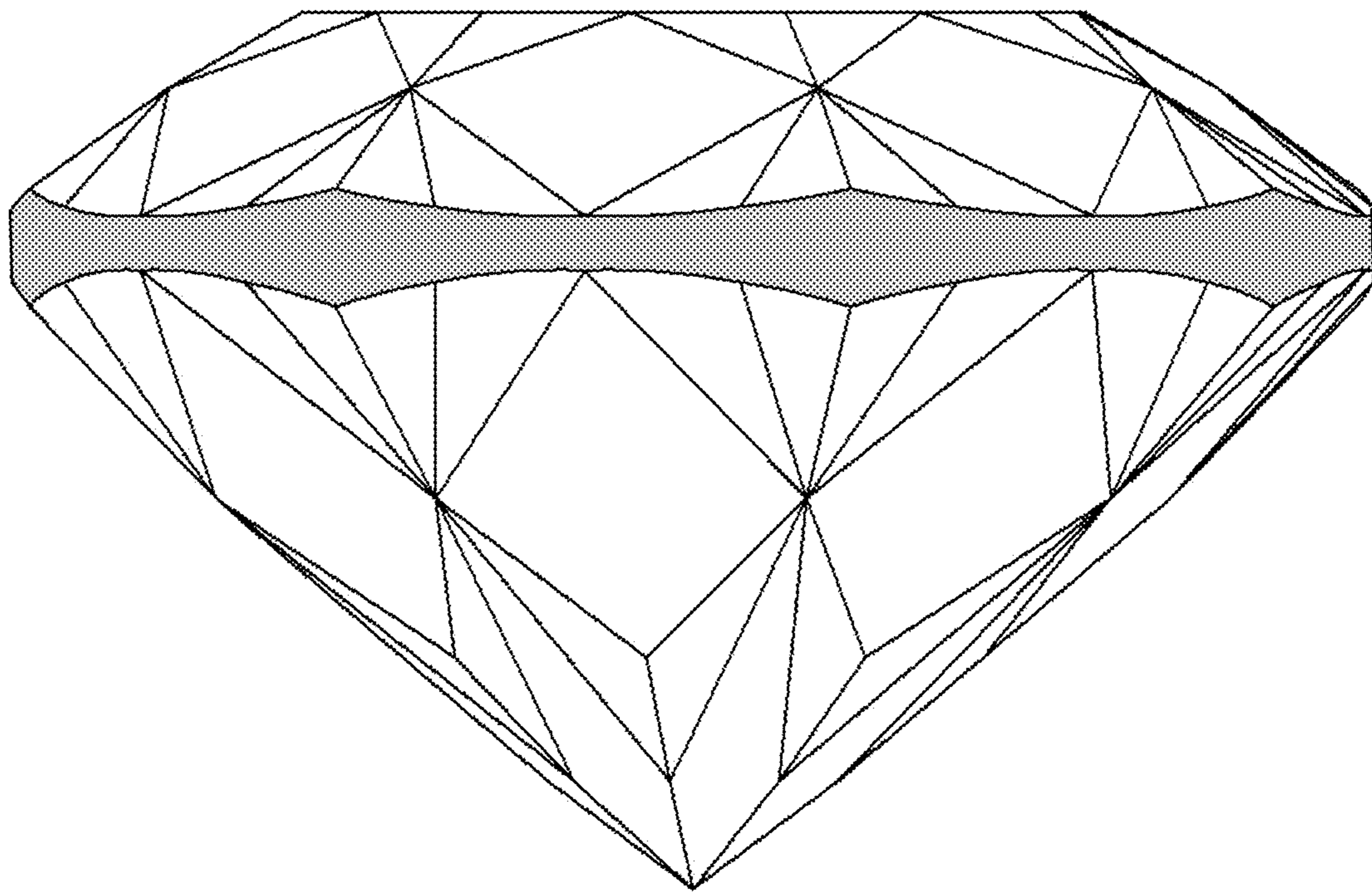

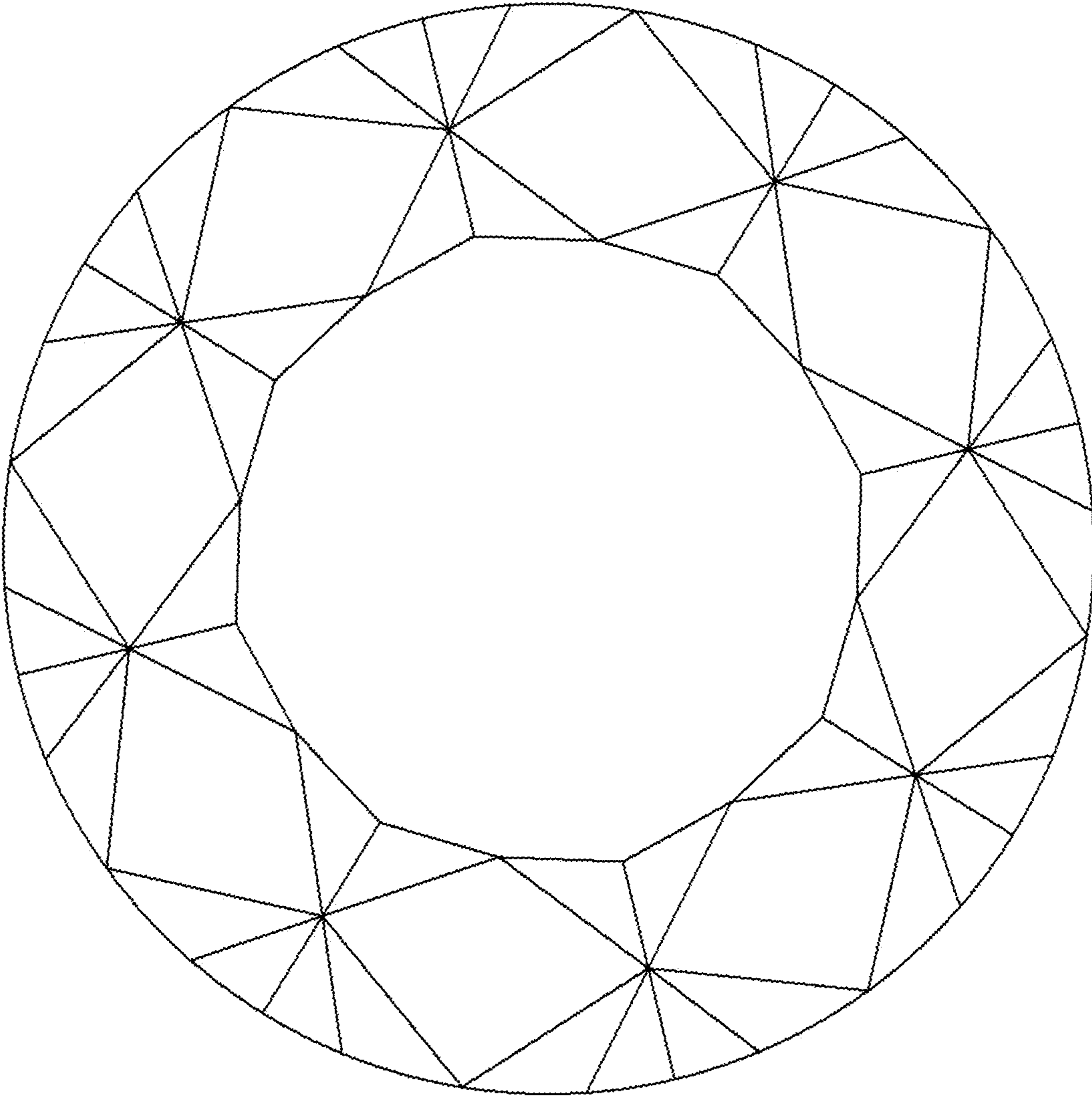

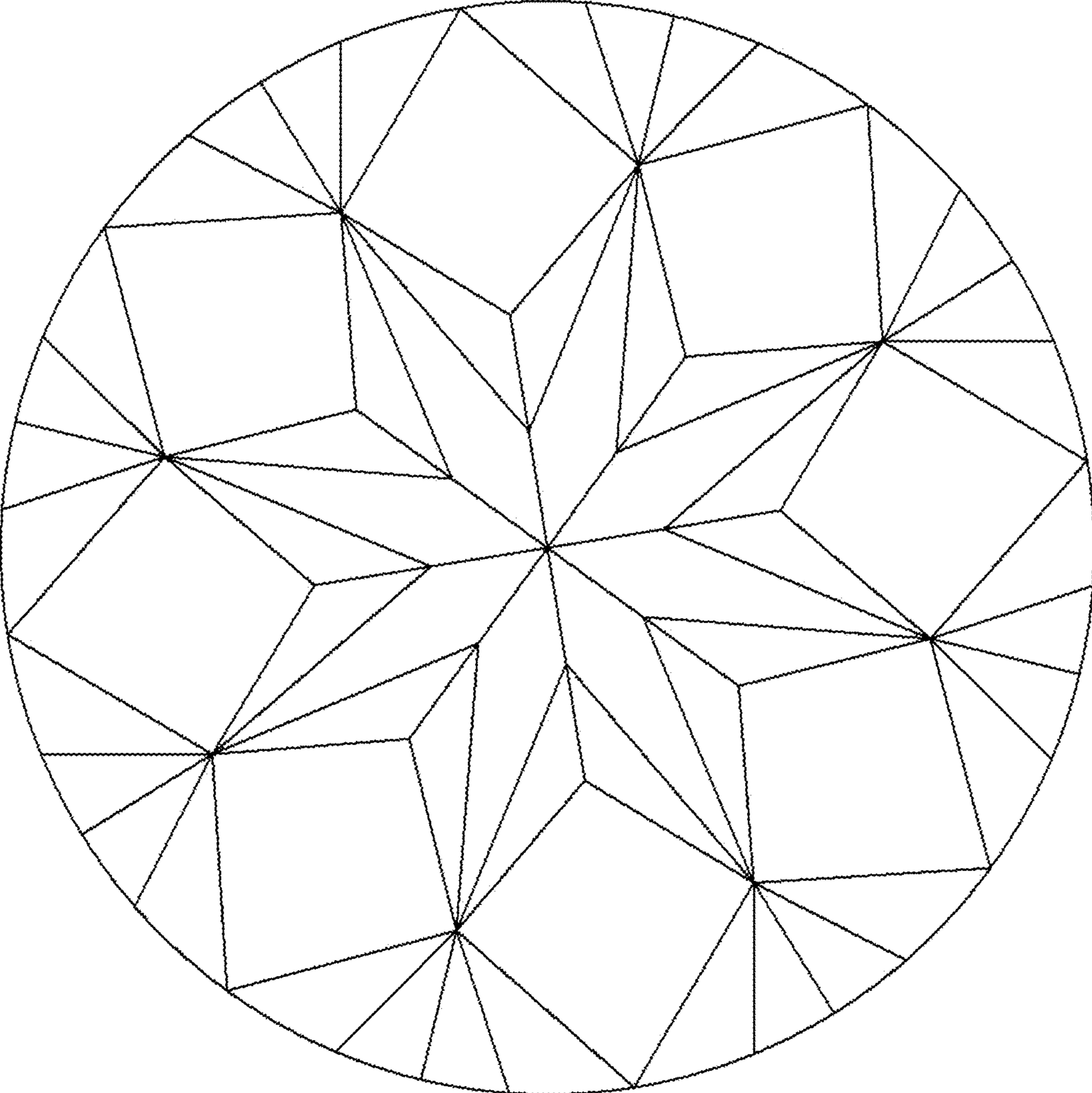
