The ornamental design for a front bumper for a vehicle, as
shown and described.

DESCRIPTION
FIG. 1 is a top, front and left side perspective view of a front
bumper for a vehicle showing our new design;

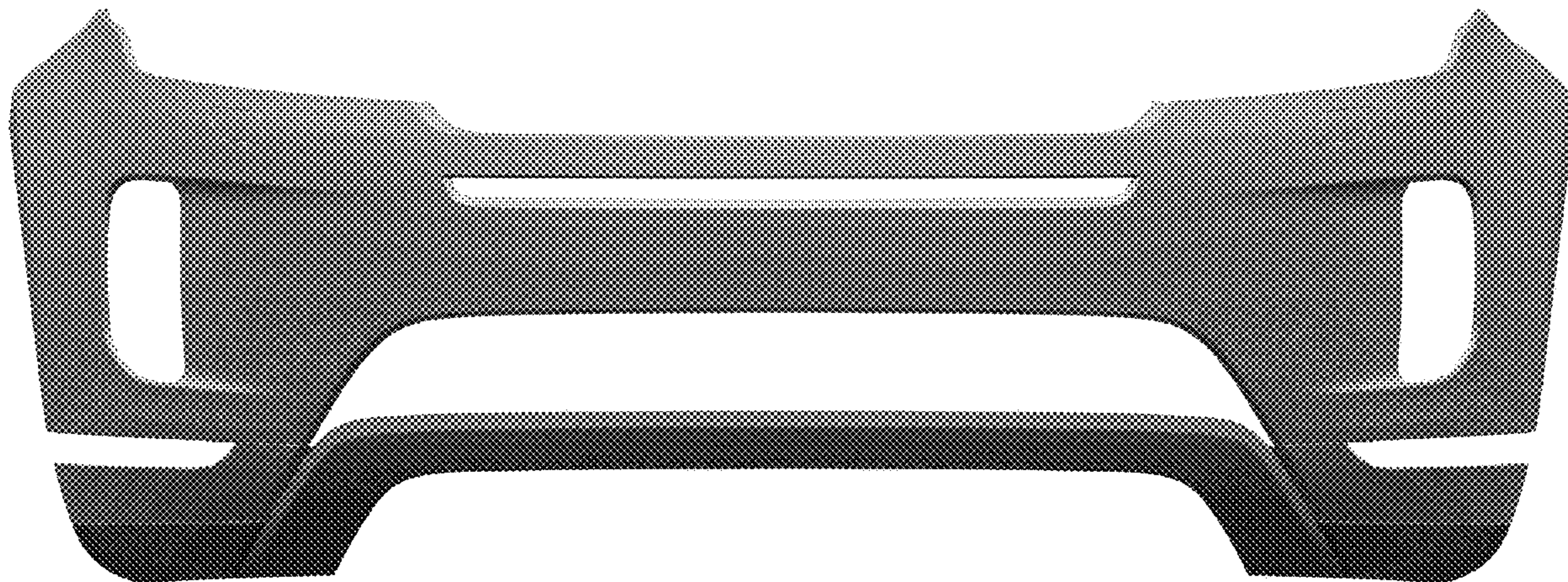

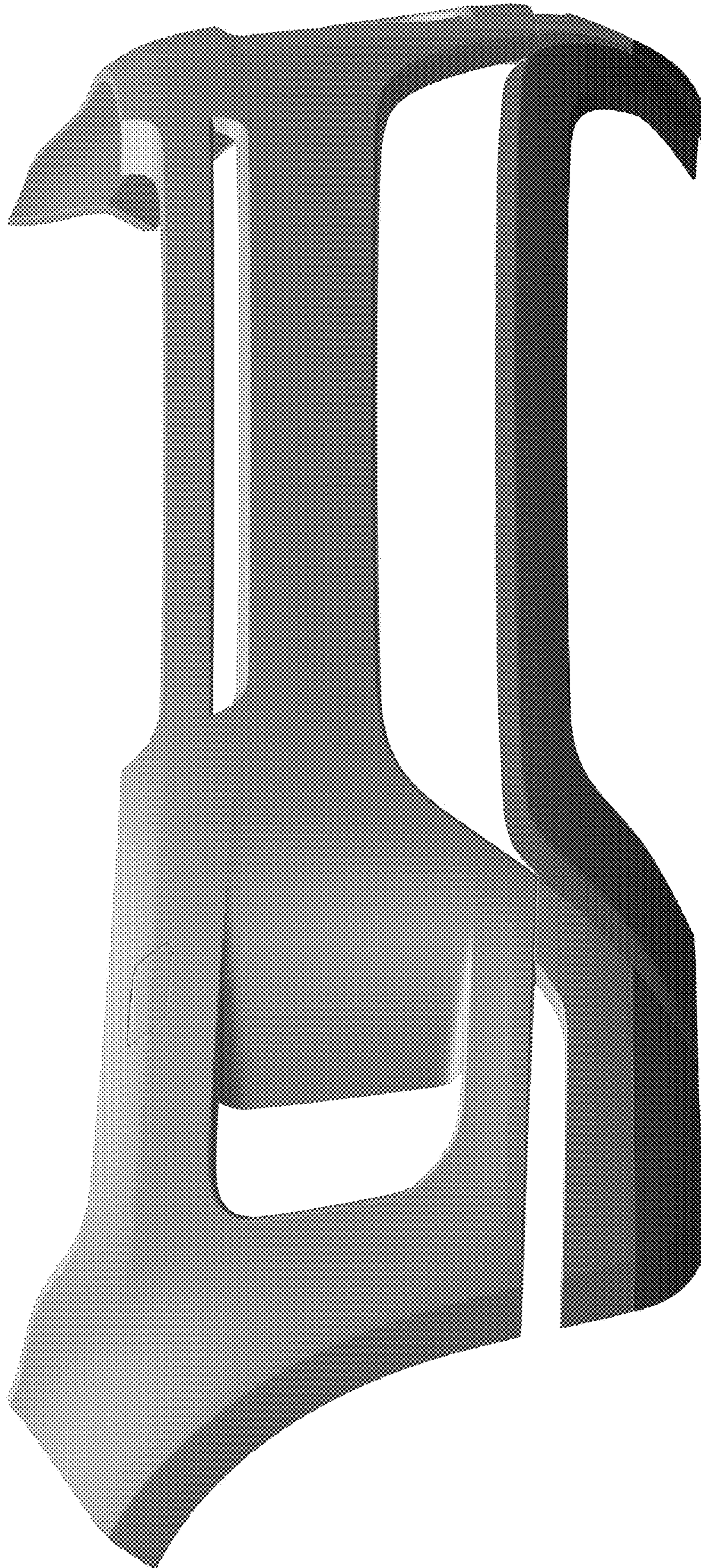

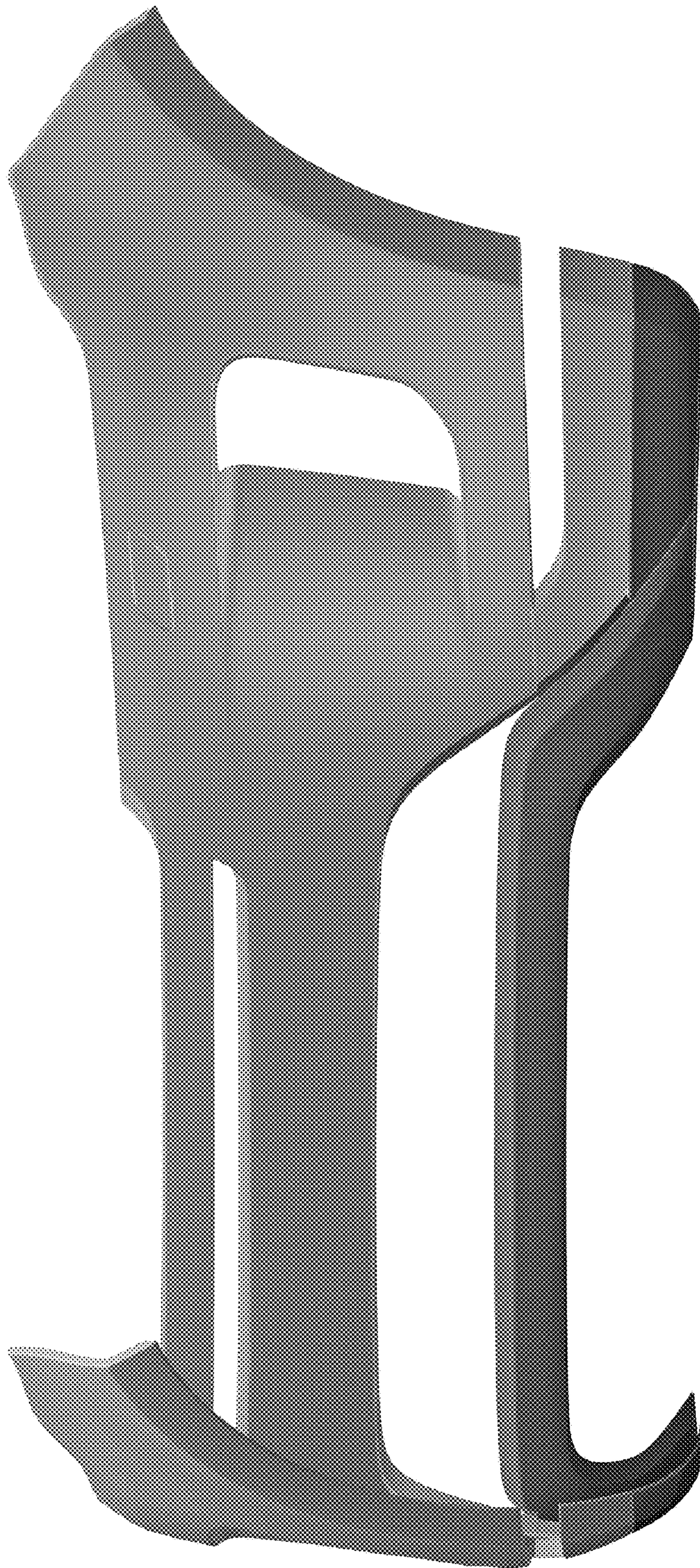

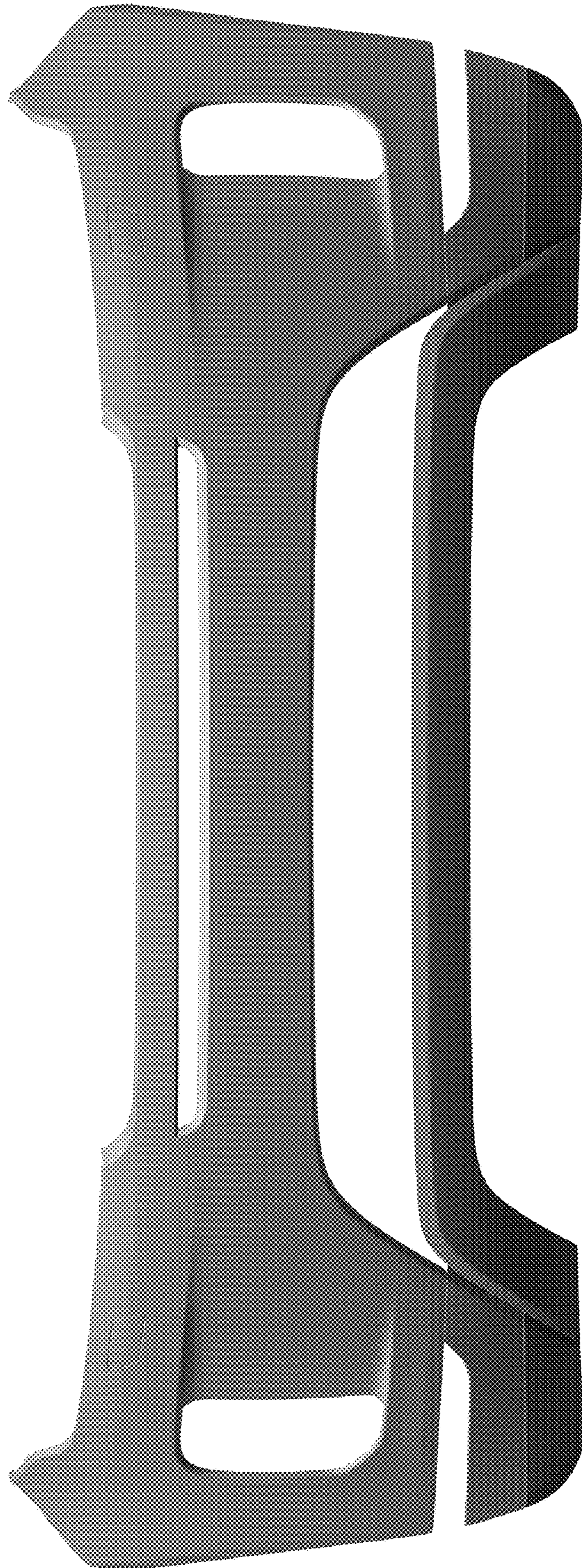

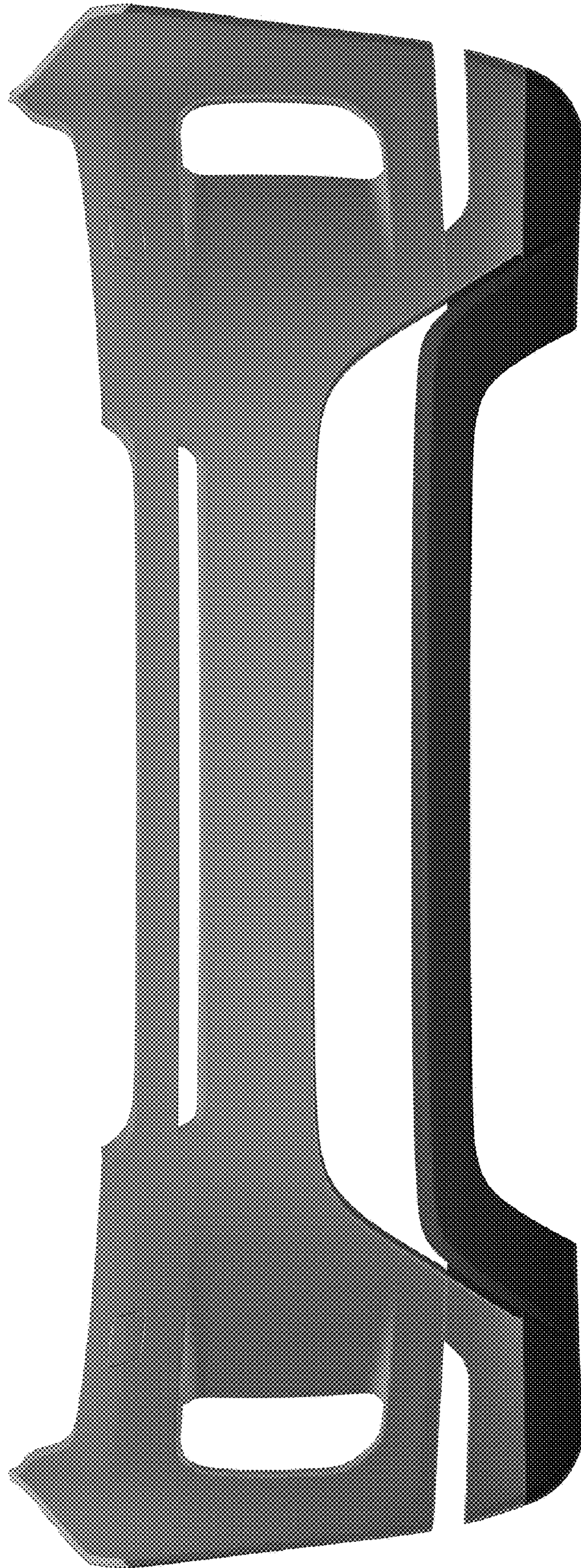

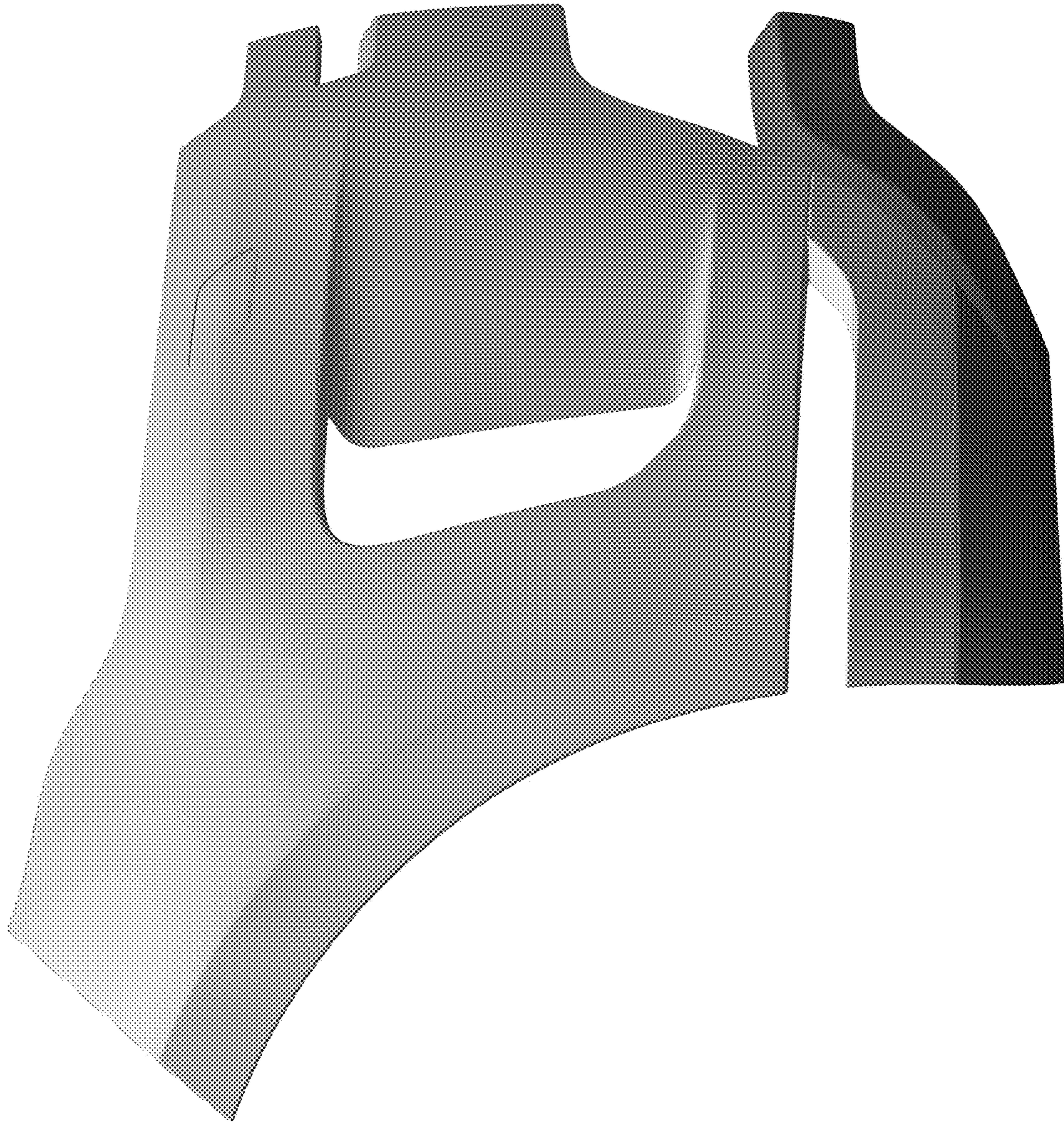

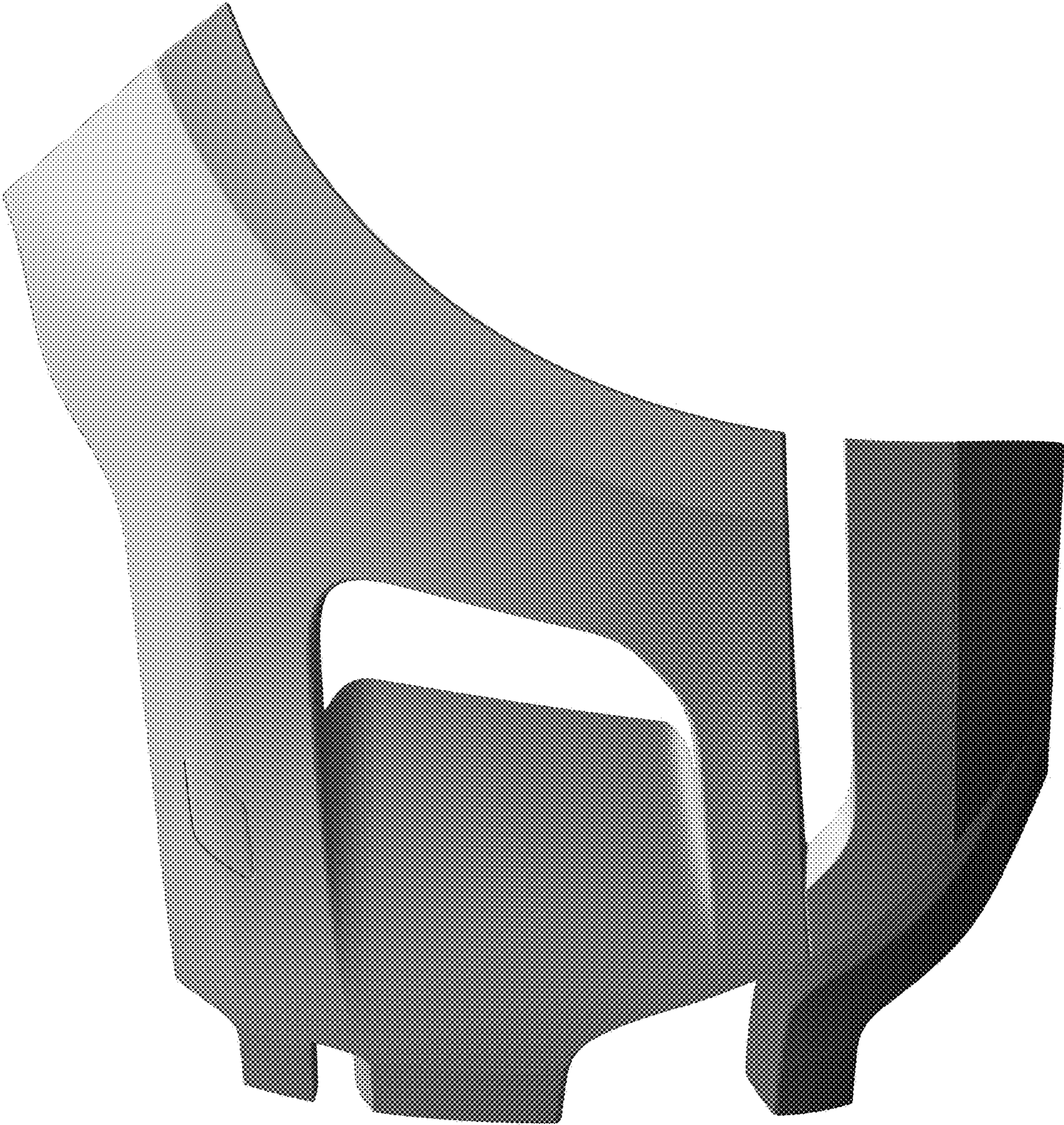

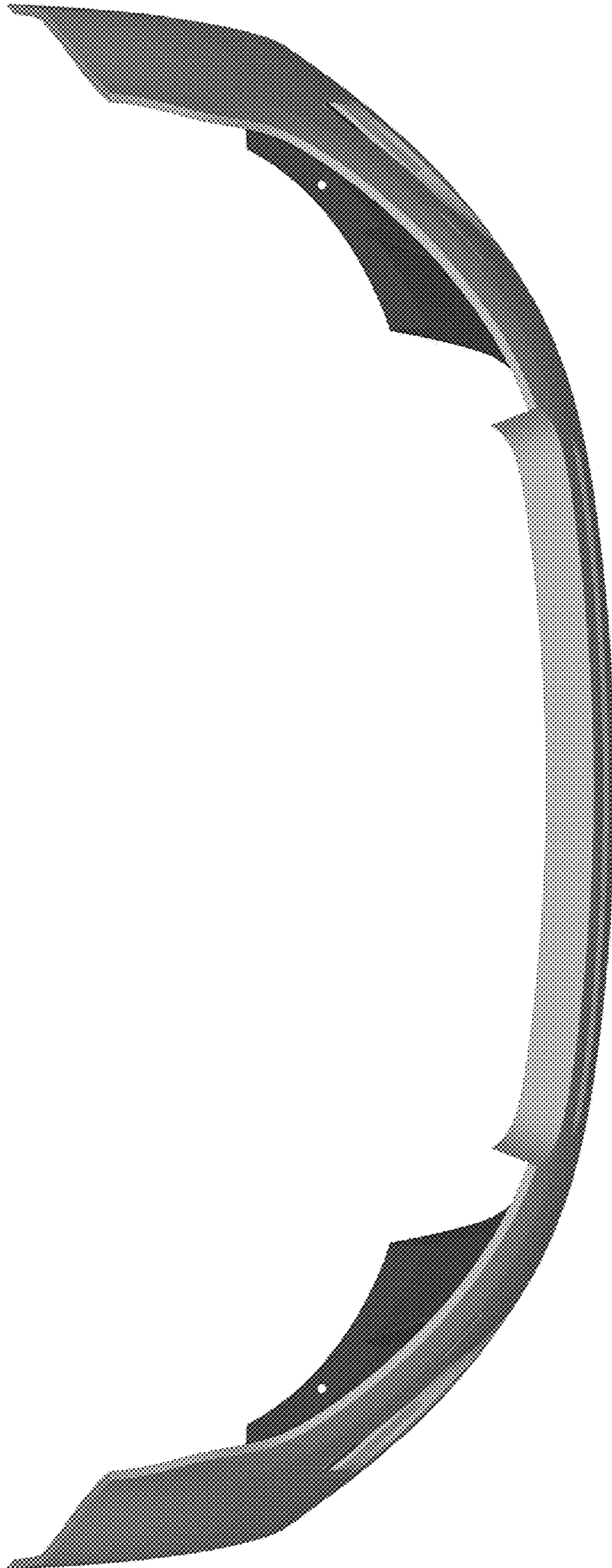

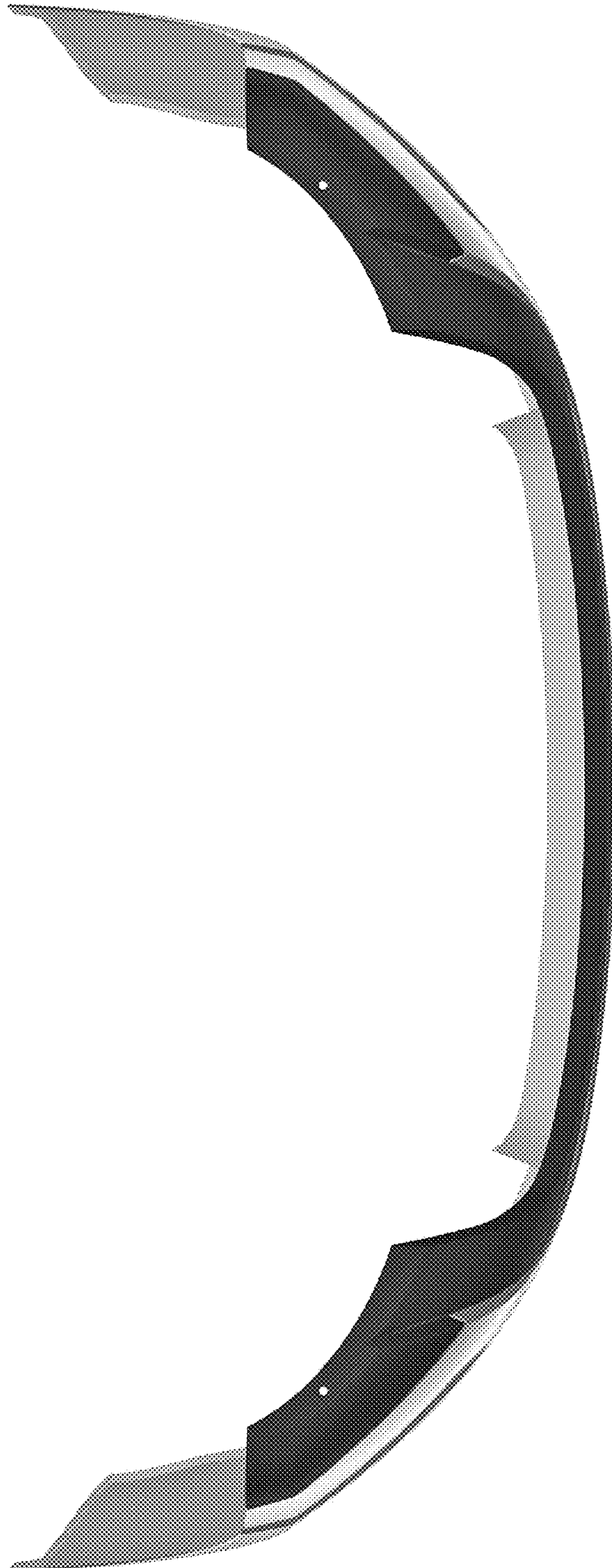

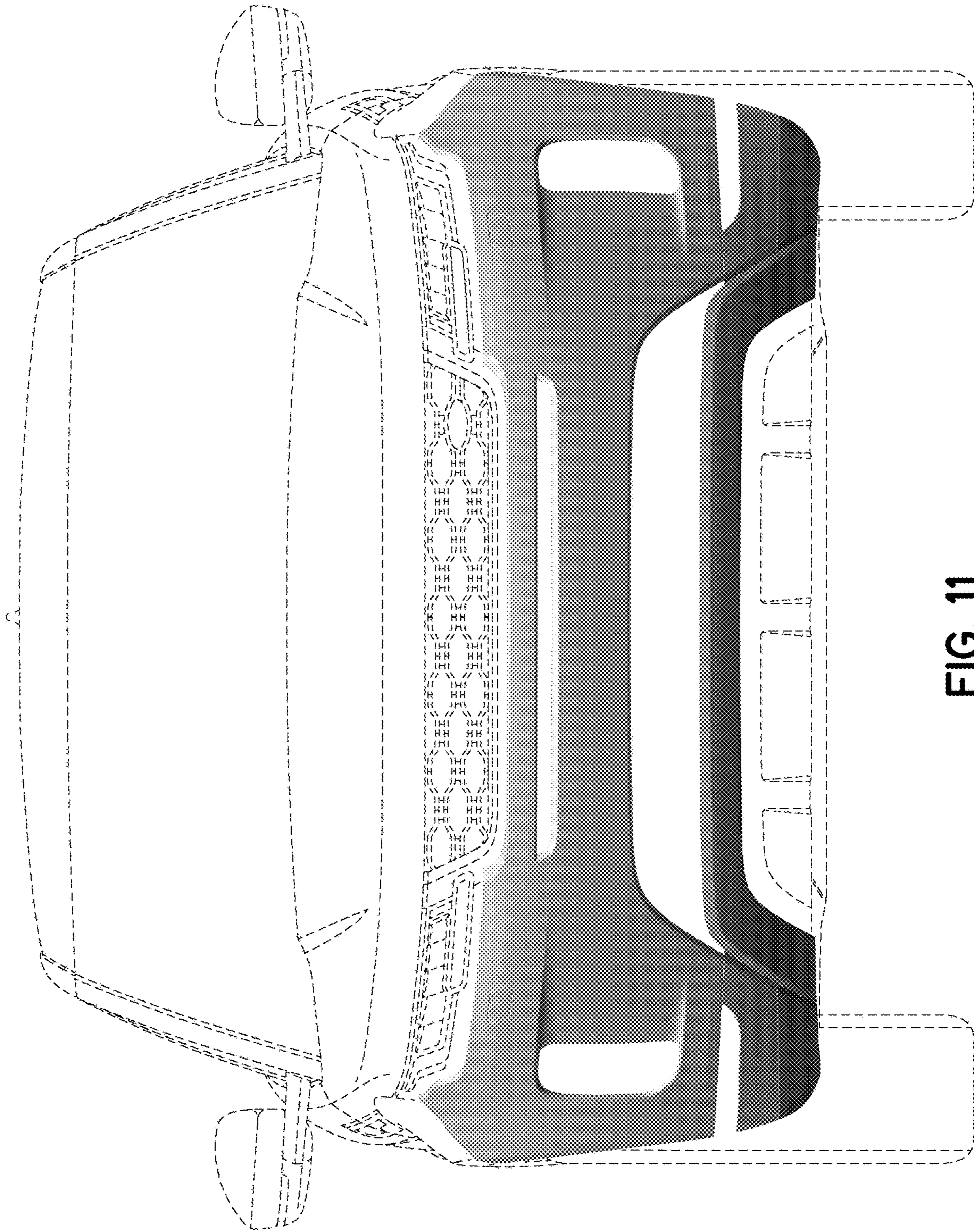
