The ornamental design for a wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a wheel for a vehicle according to the present invention.

FIG. 2 is a front right perspective view of the wheel shown in FIG. 1.

FIG. 3 is a front view thereof.

FIG. 4 is a left side view thereof, the right side view being a mirror image thereof.

FIG. 5 is a rear view thereof.

FIG. 6 is a rear right perspective view thereof; and,

FIG. 7 is a rear left perspective view thereof.

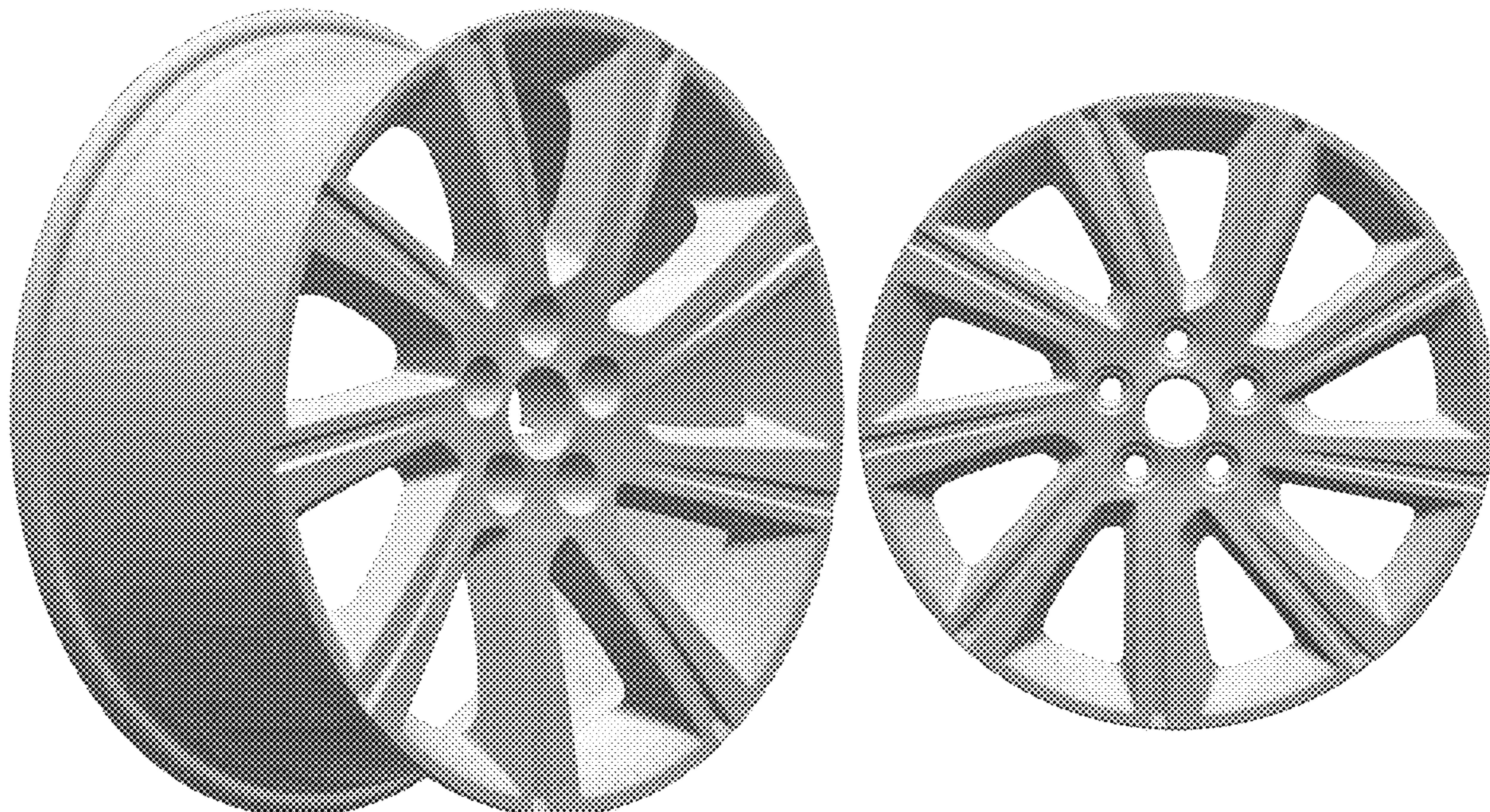

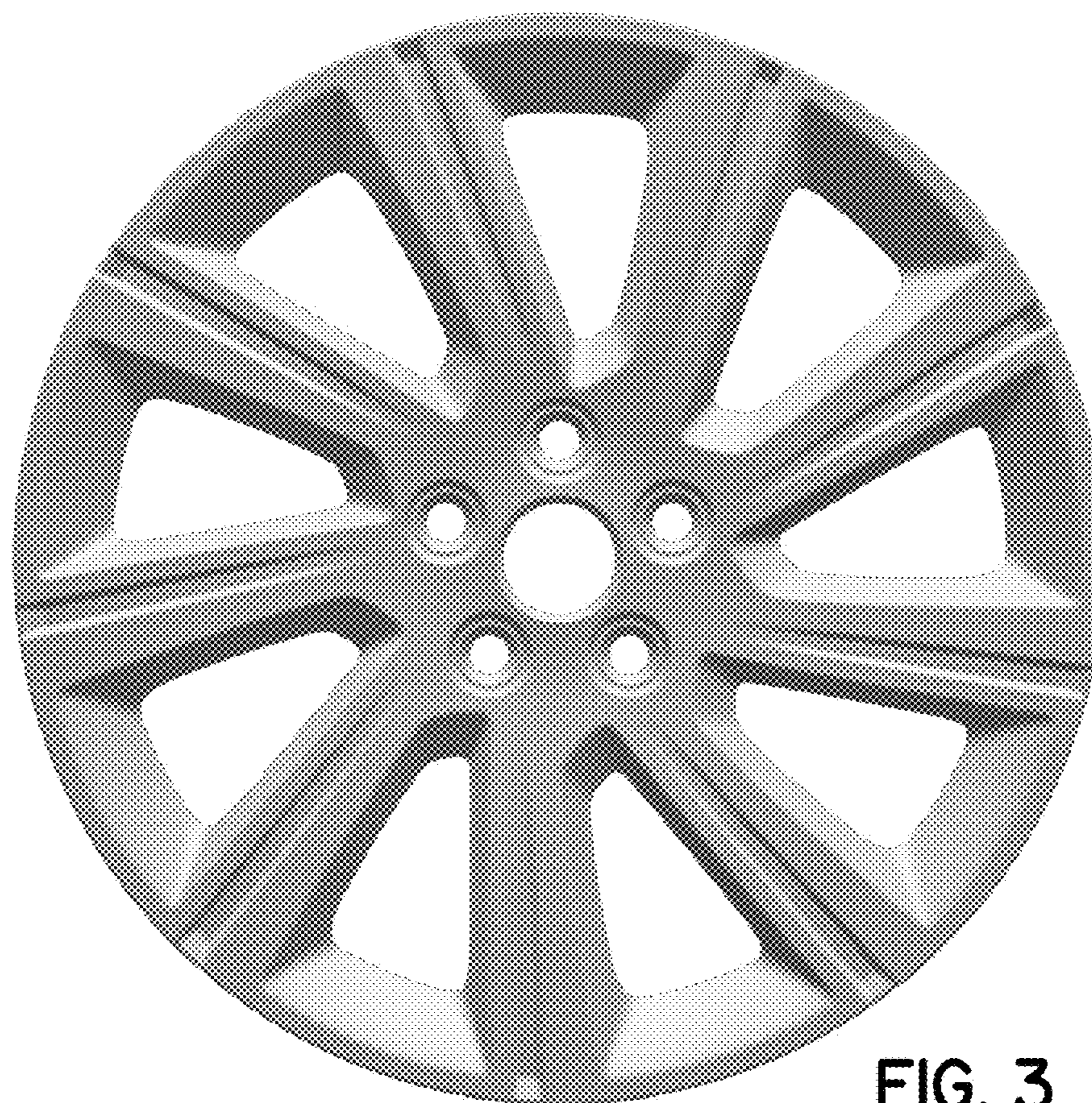

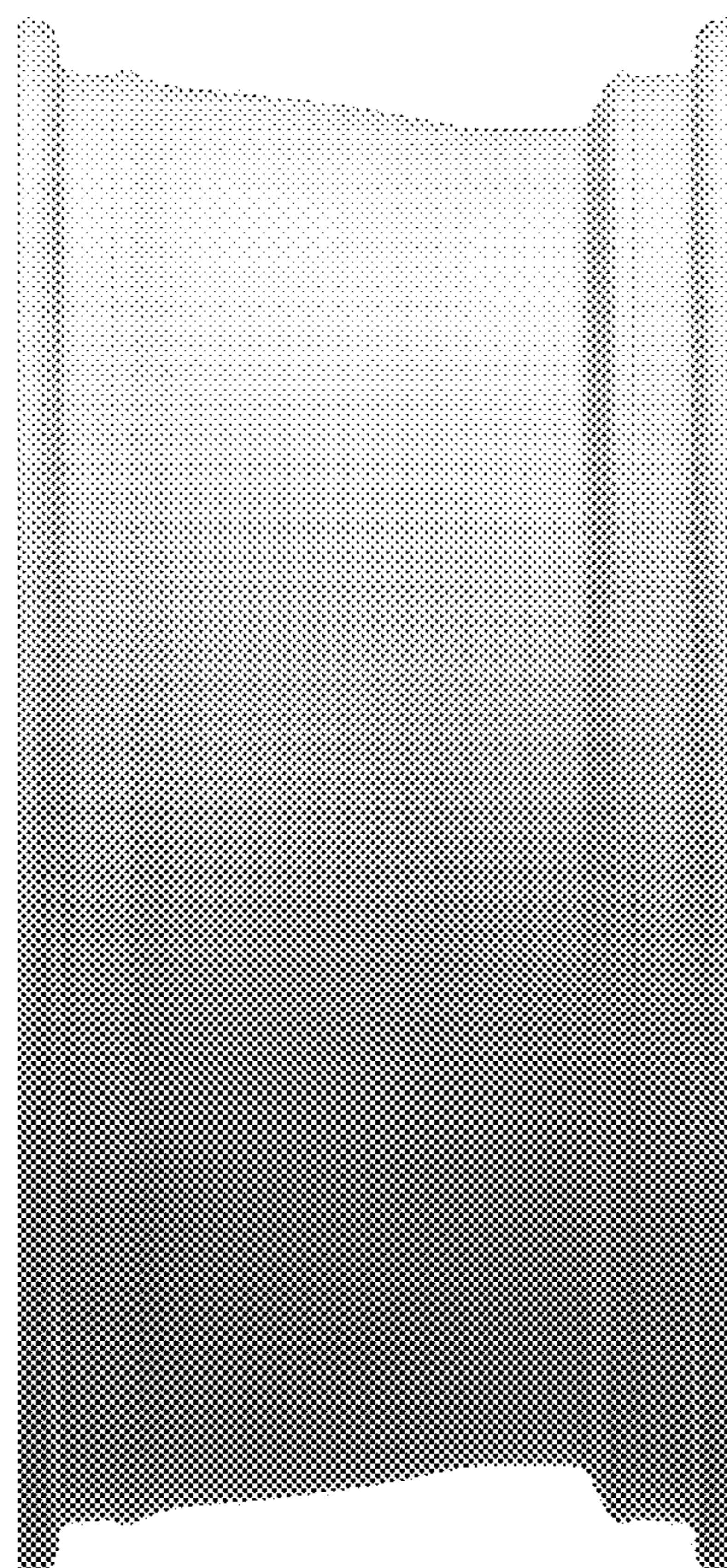

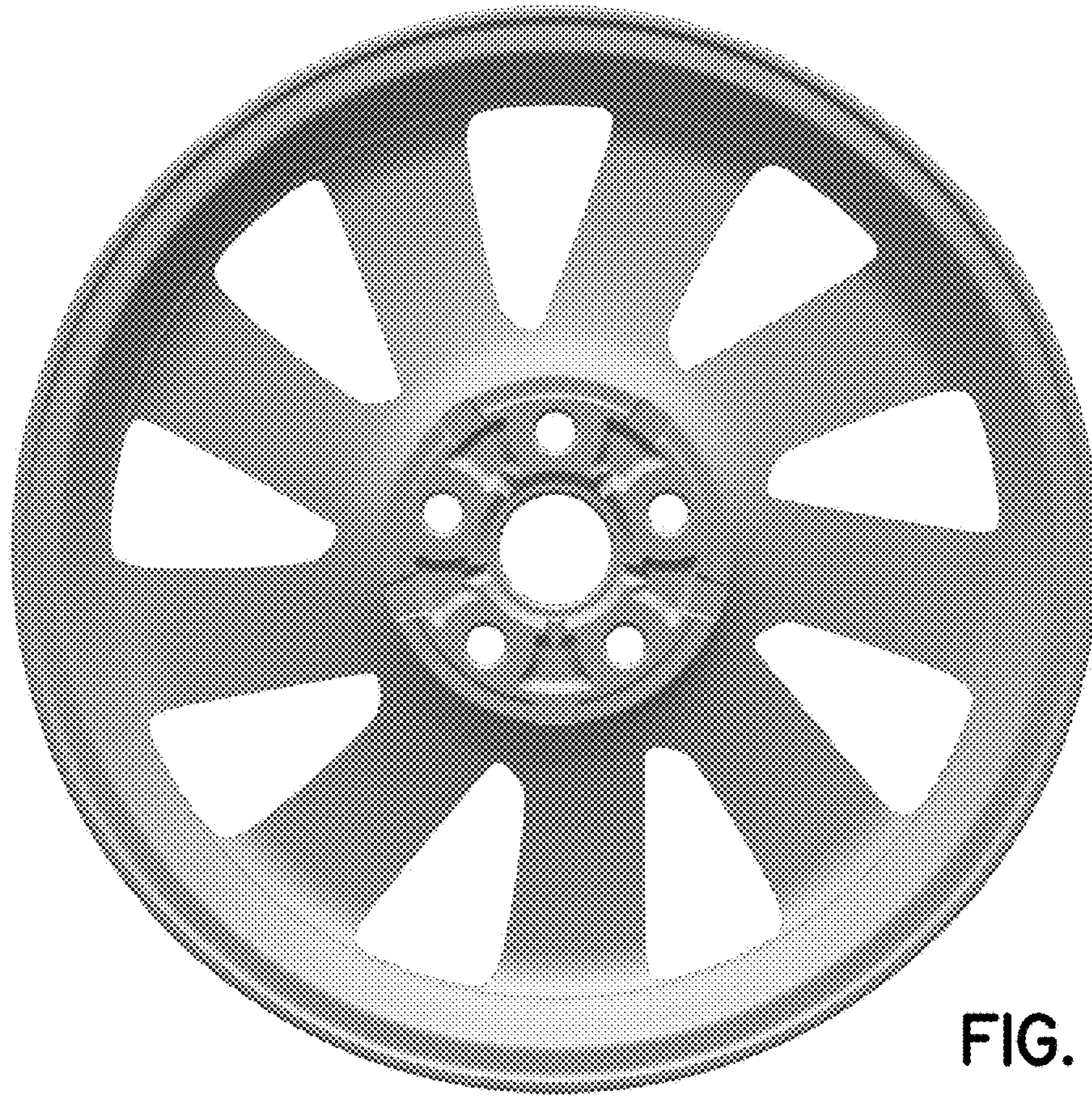
