DESCRIPTION

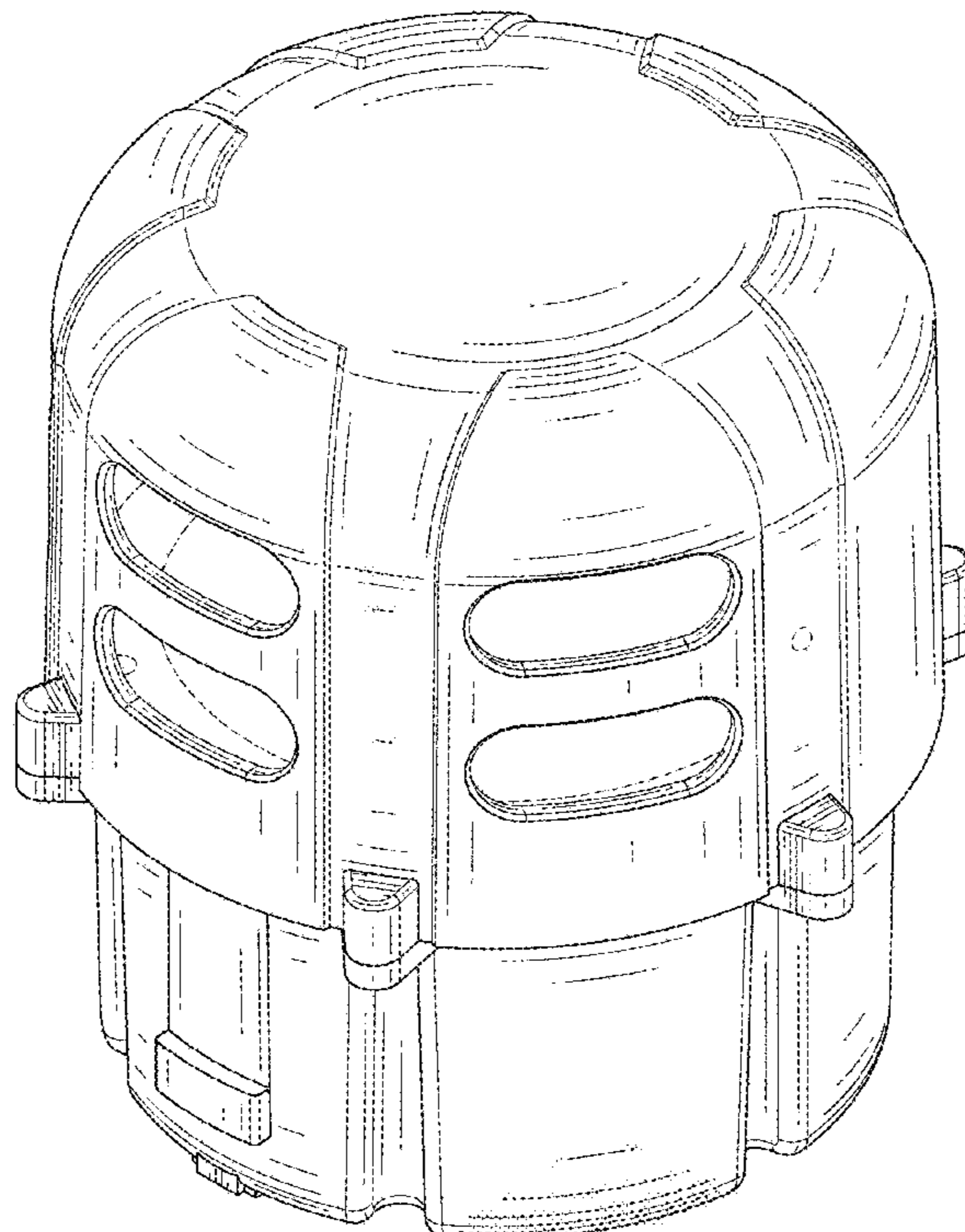
FIG. 1 is a front perspective view of a speaker showing my new design;

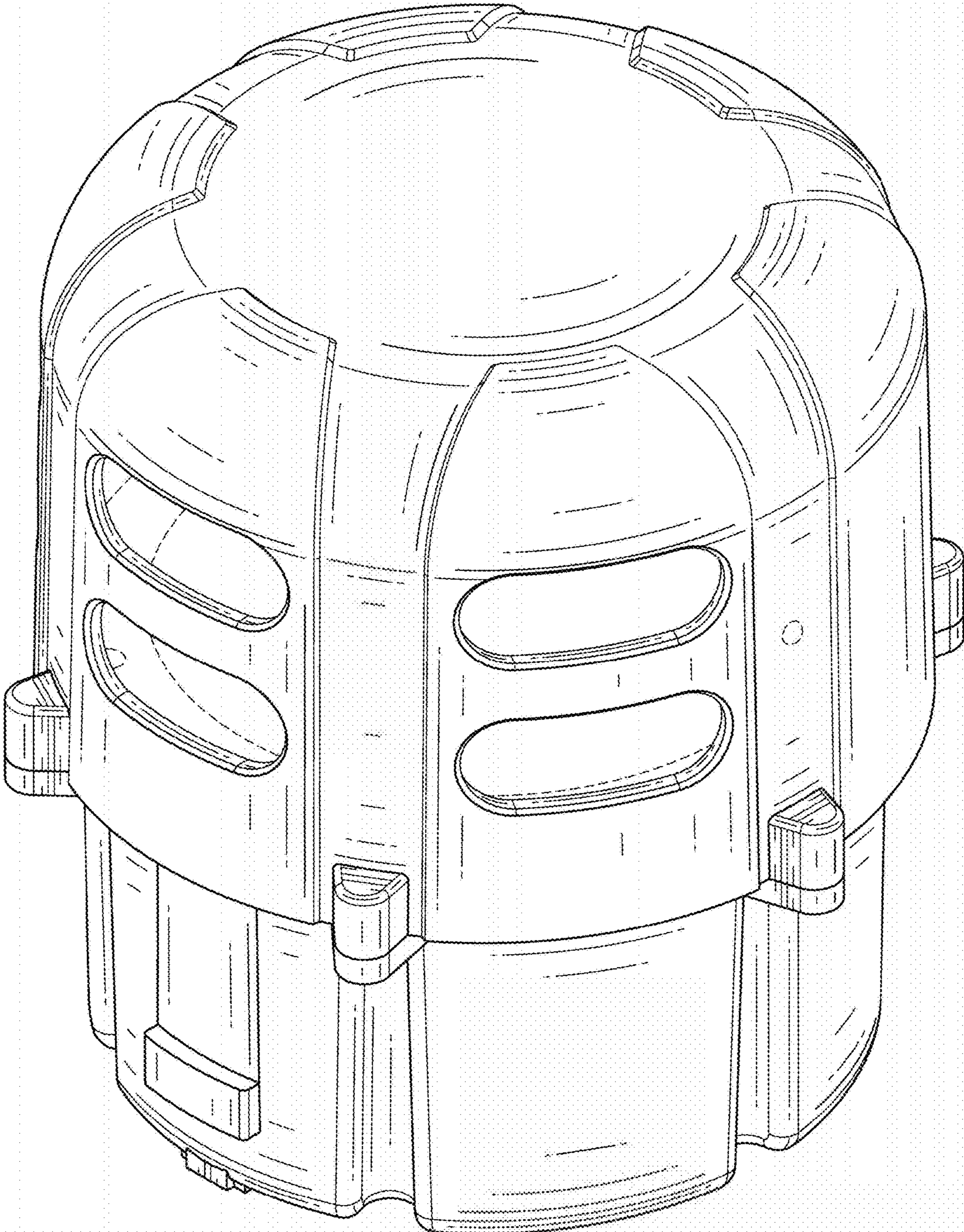

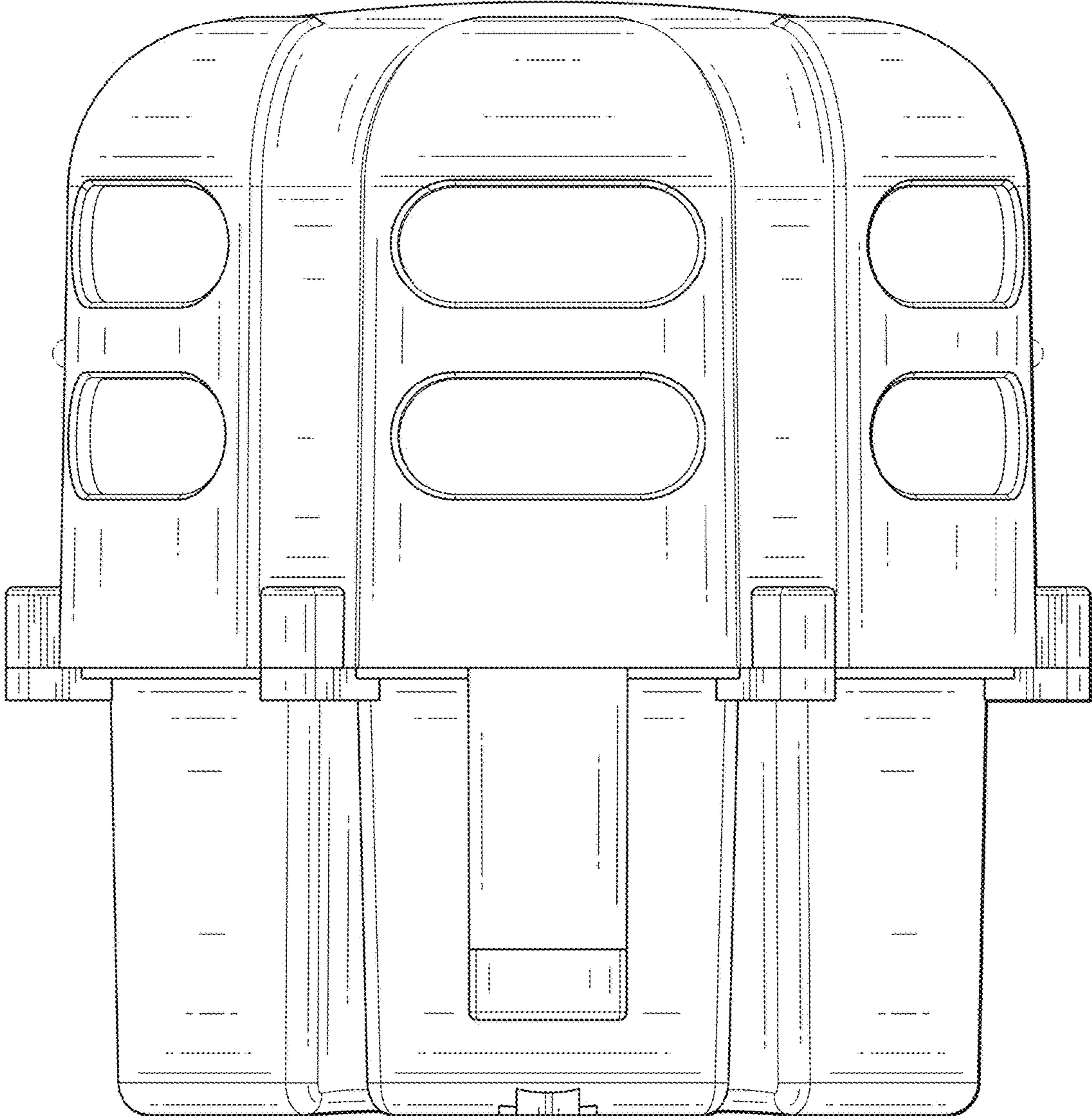

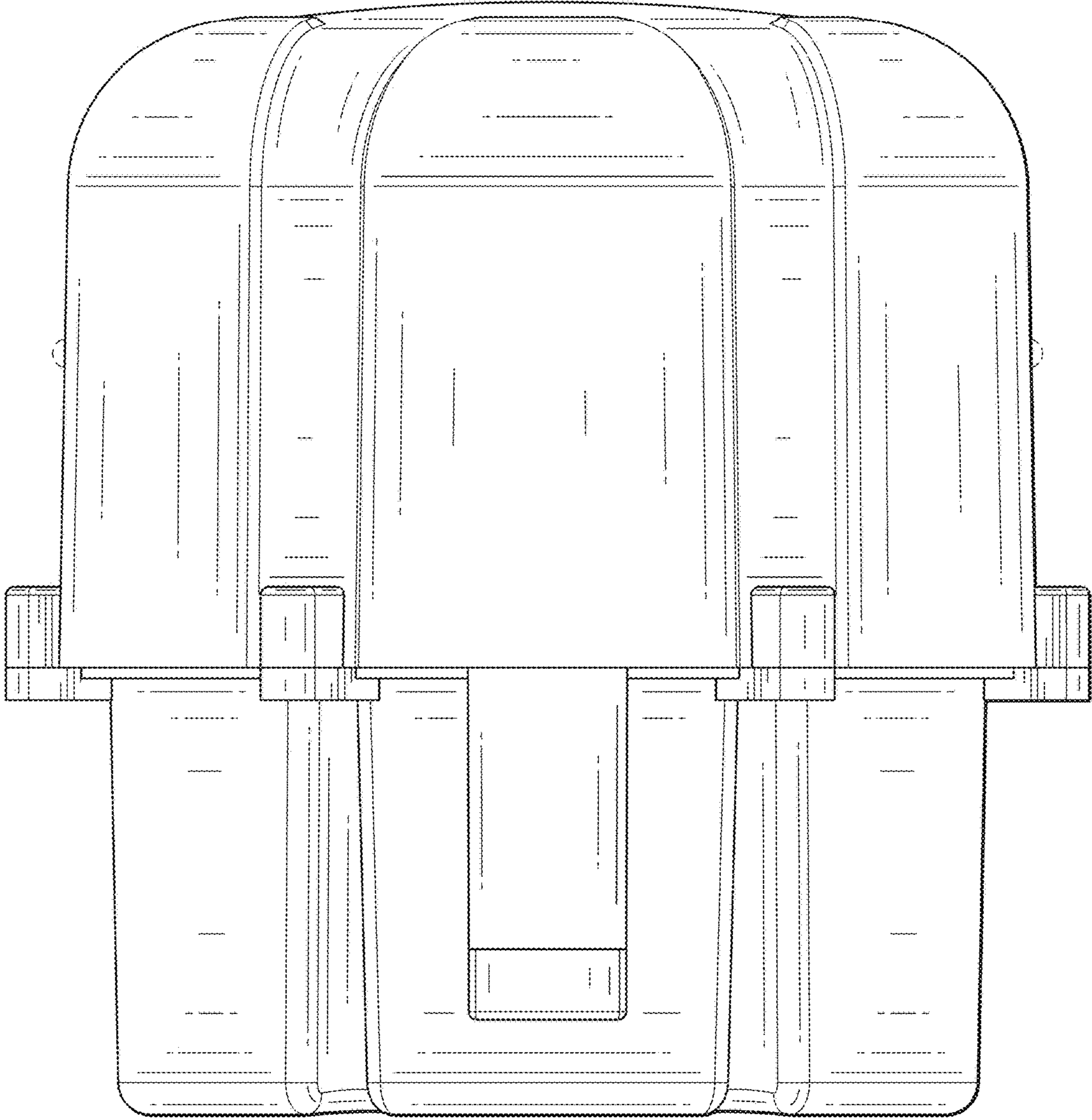

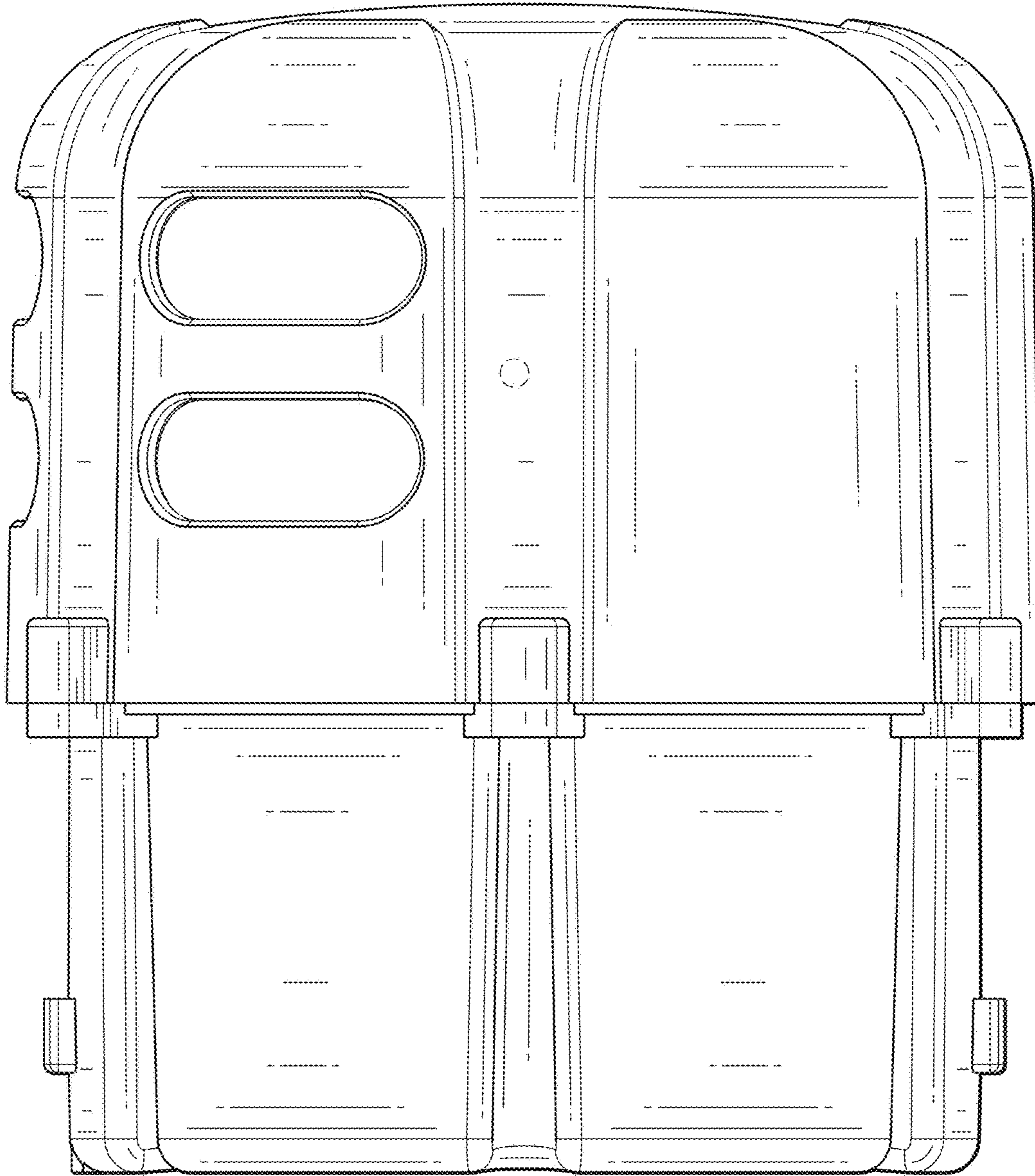

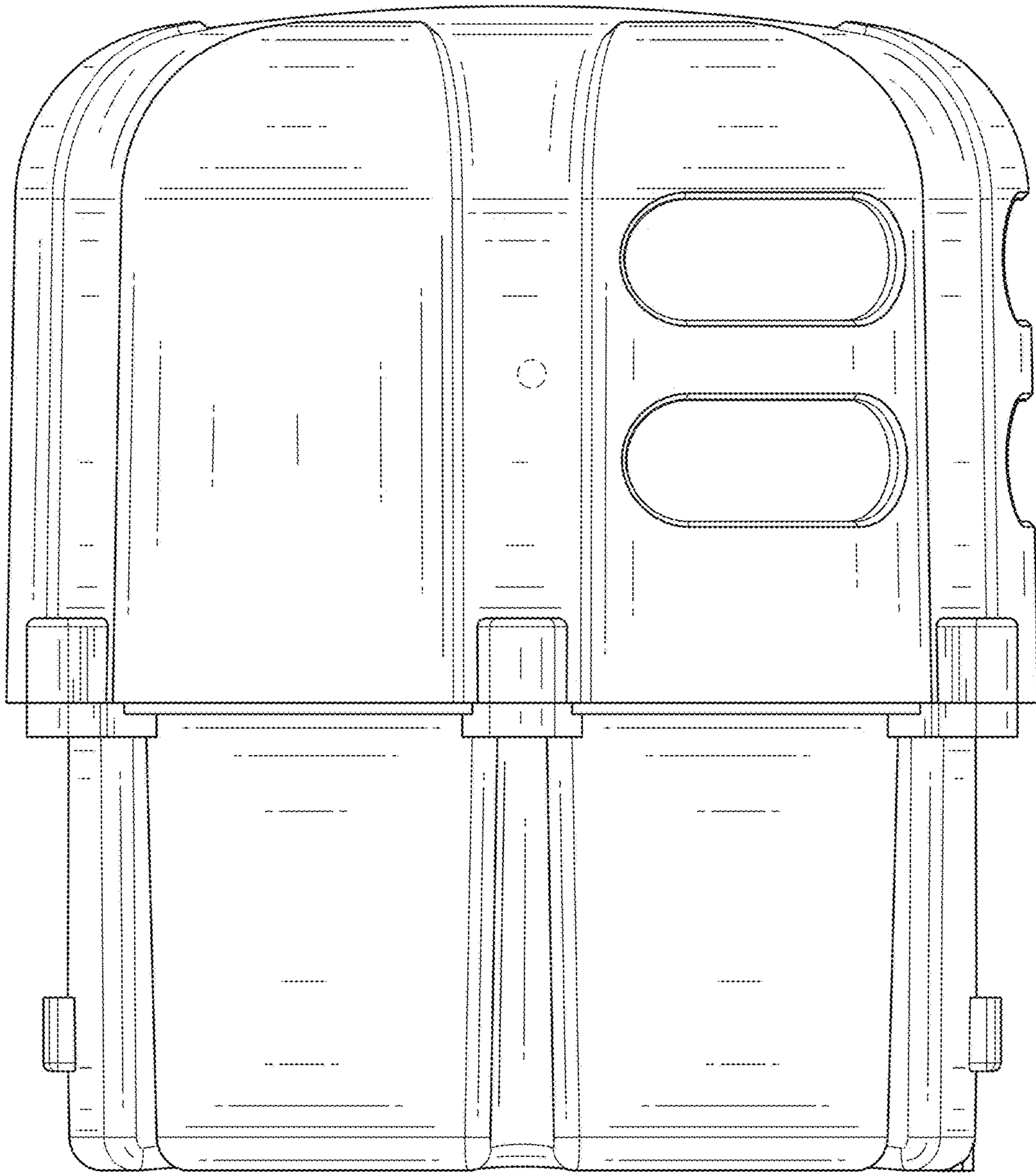

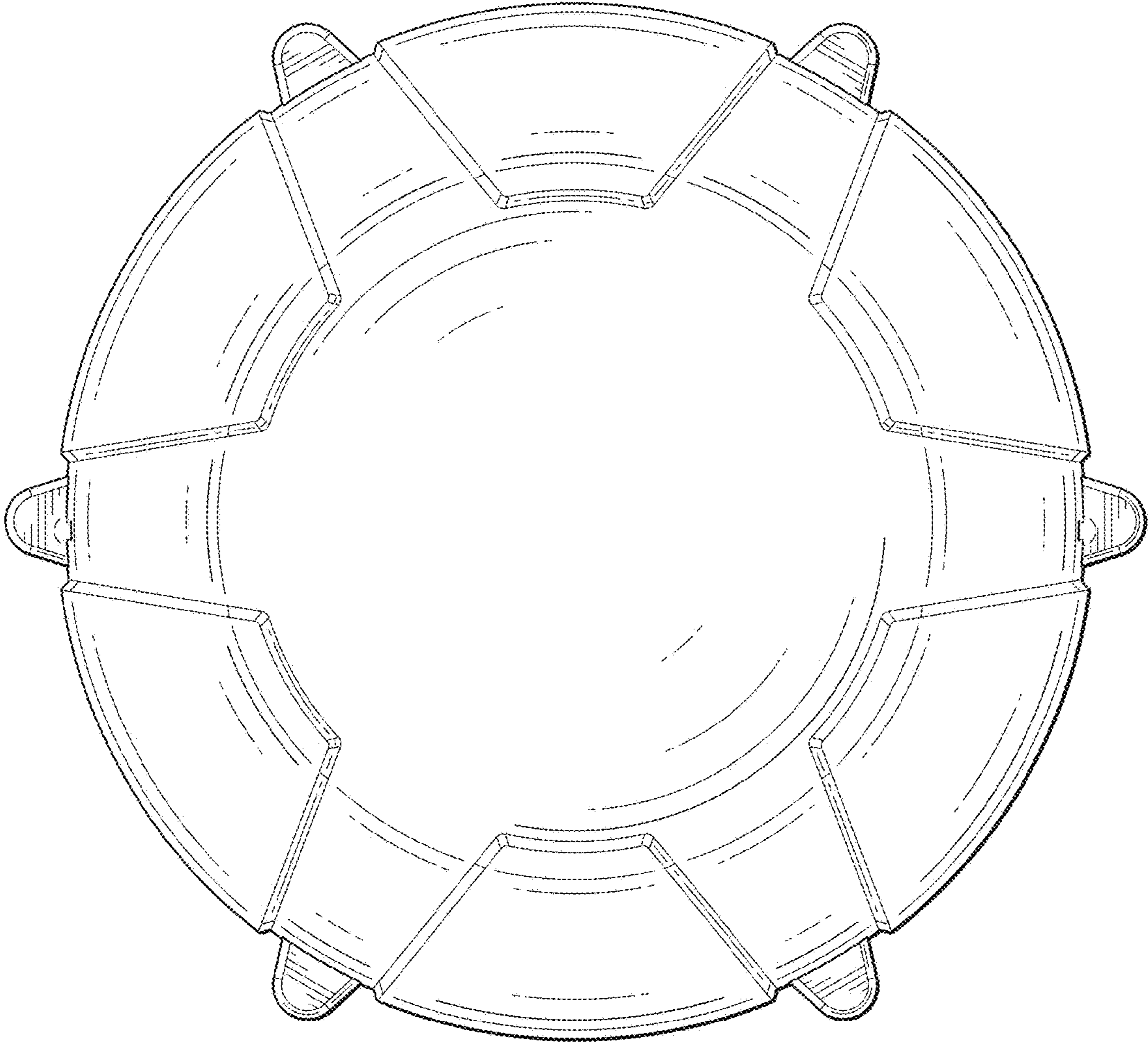

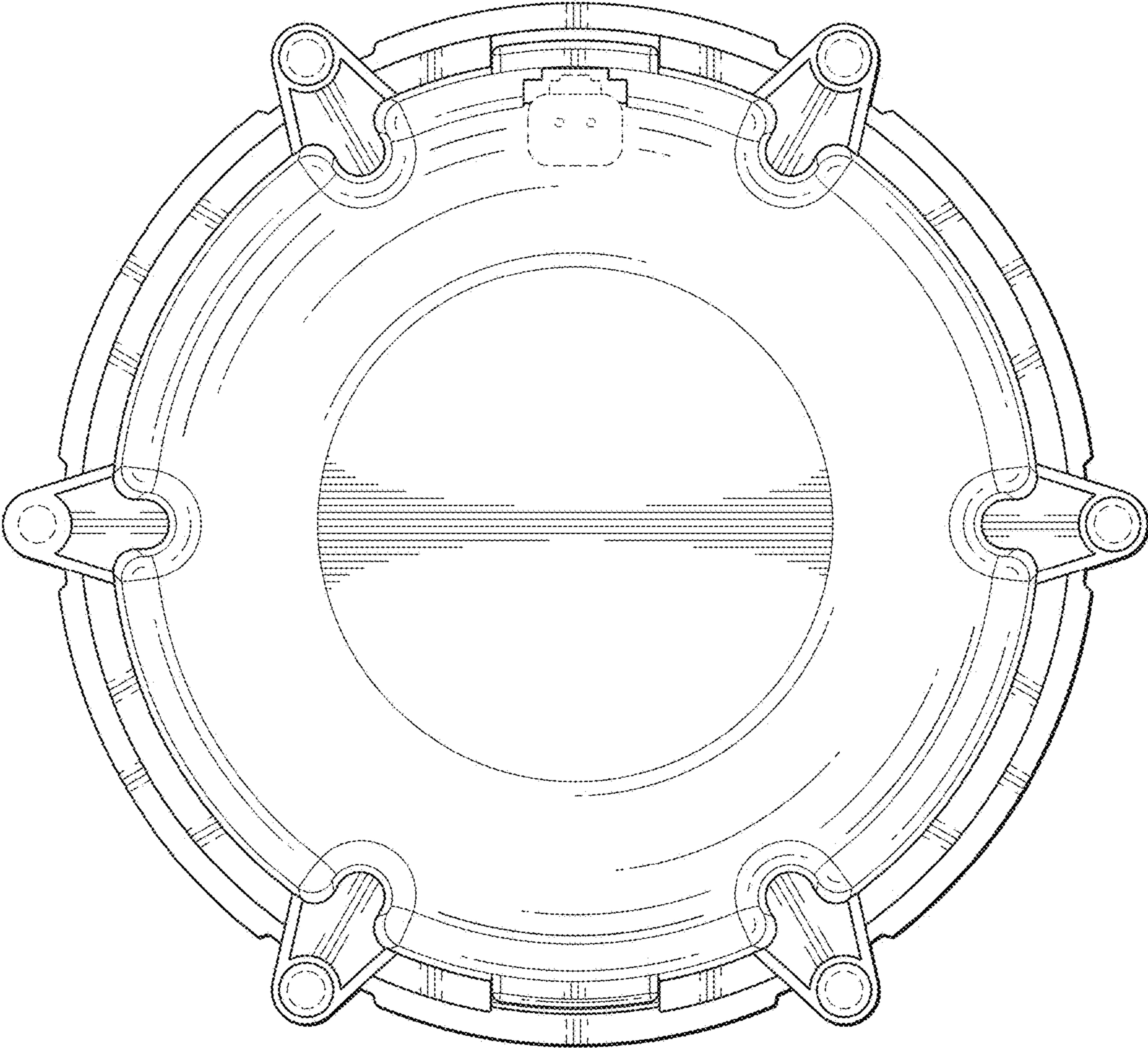

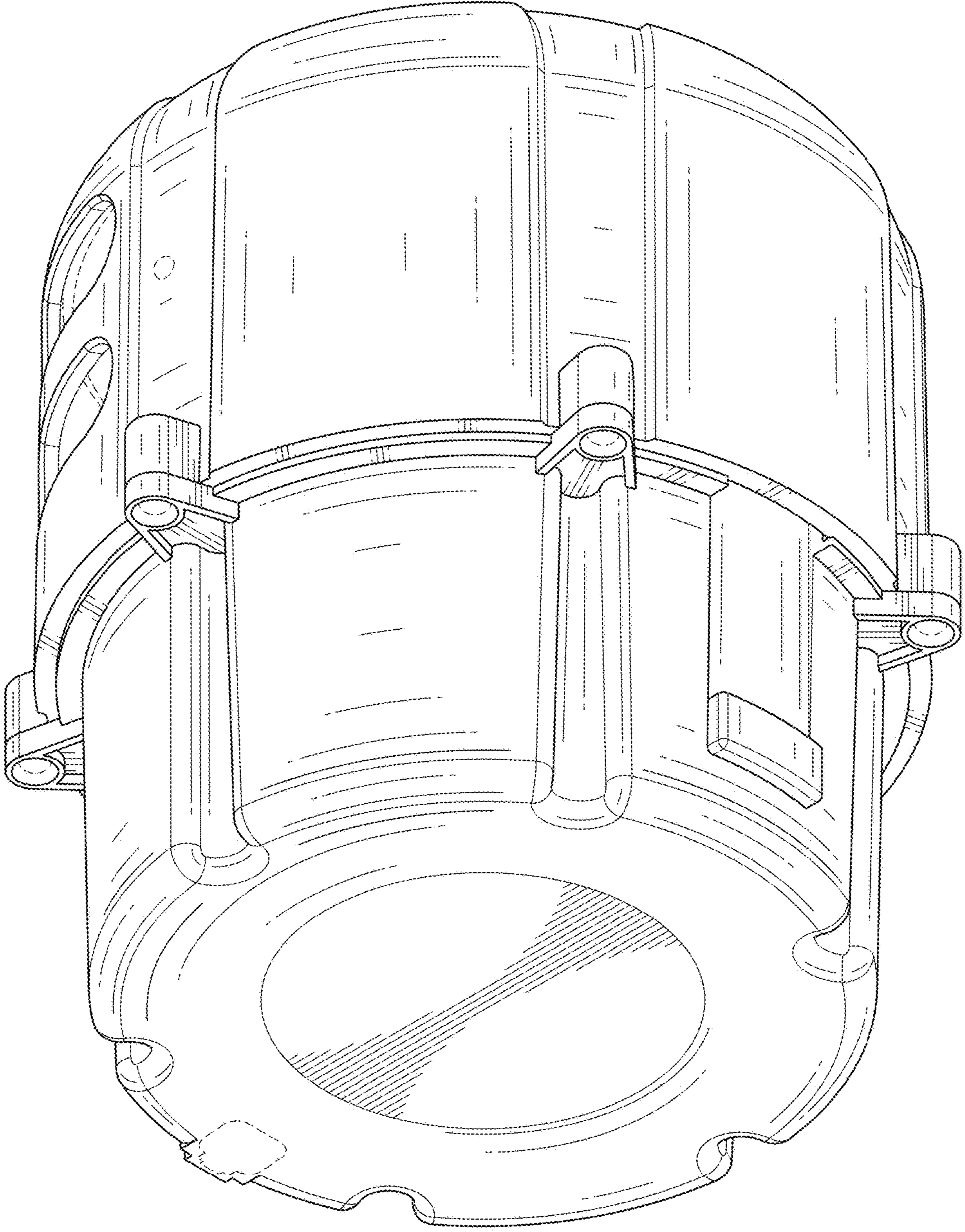
