(57) **CLAIM**

The ornamental design for a mobile telephone case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a mobile telephone case showing my new design with the visor portion of the case in a retracted position;

FIG. 2 is a perspective back view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a back elevation view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a right side elevation view thereof.

FIG. 11 is a bottom plan view thereof;

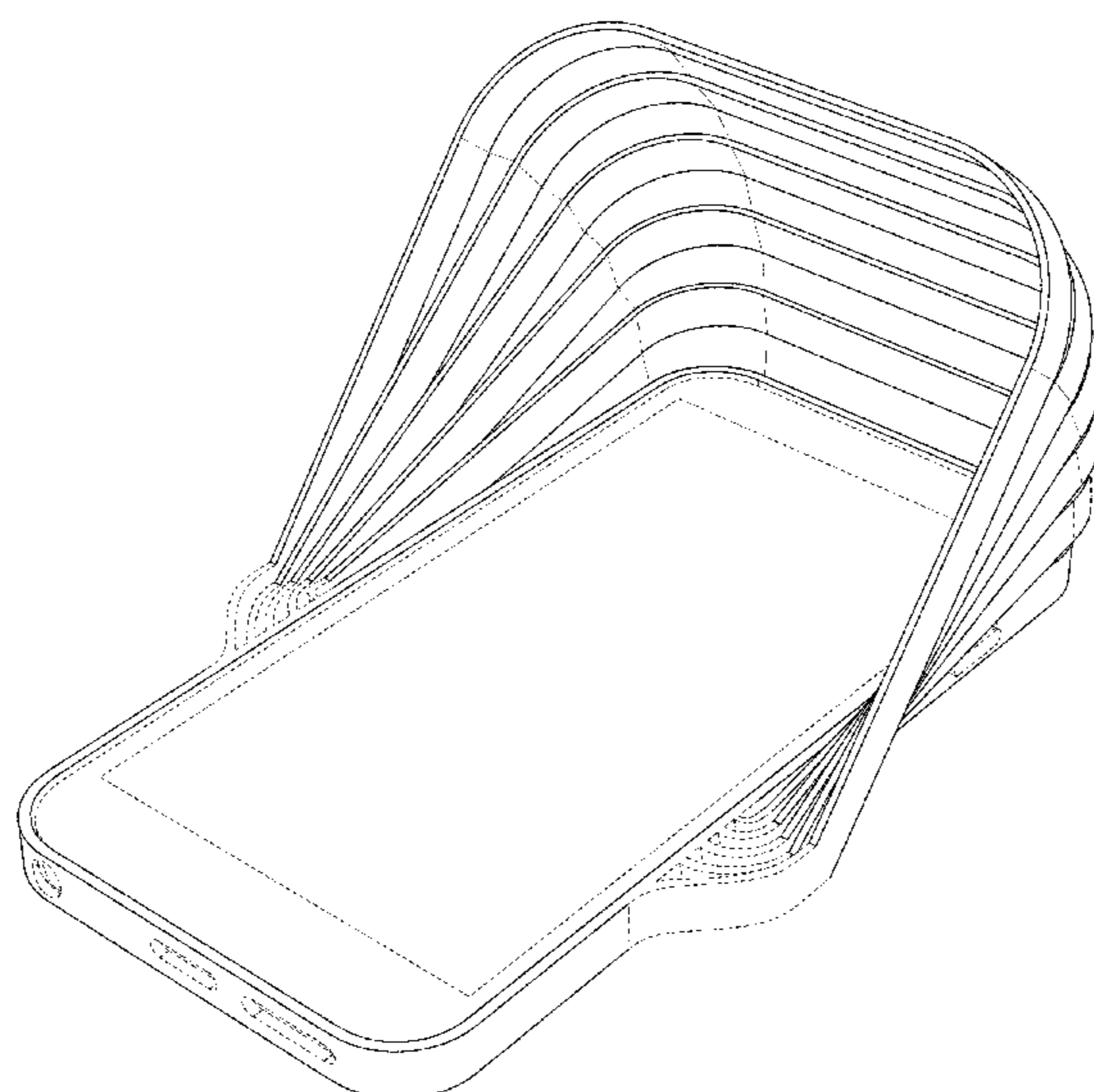
FIG. 12 is a back elevation view thereof;

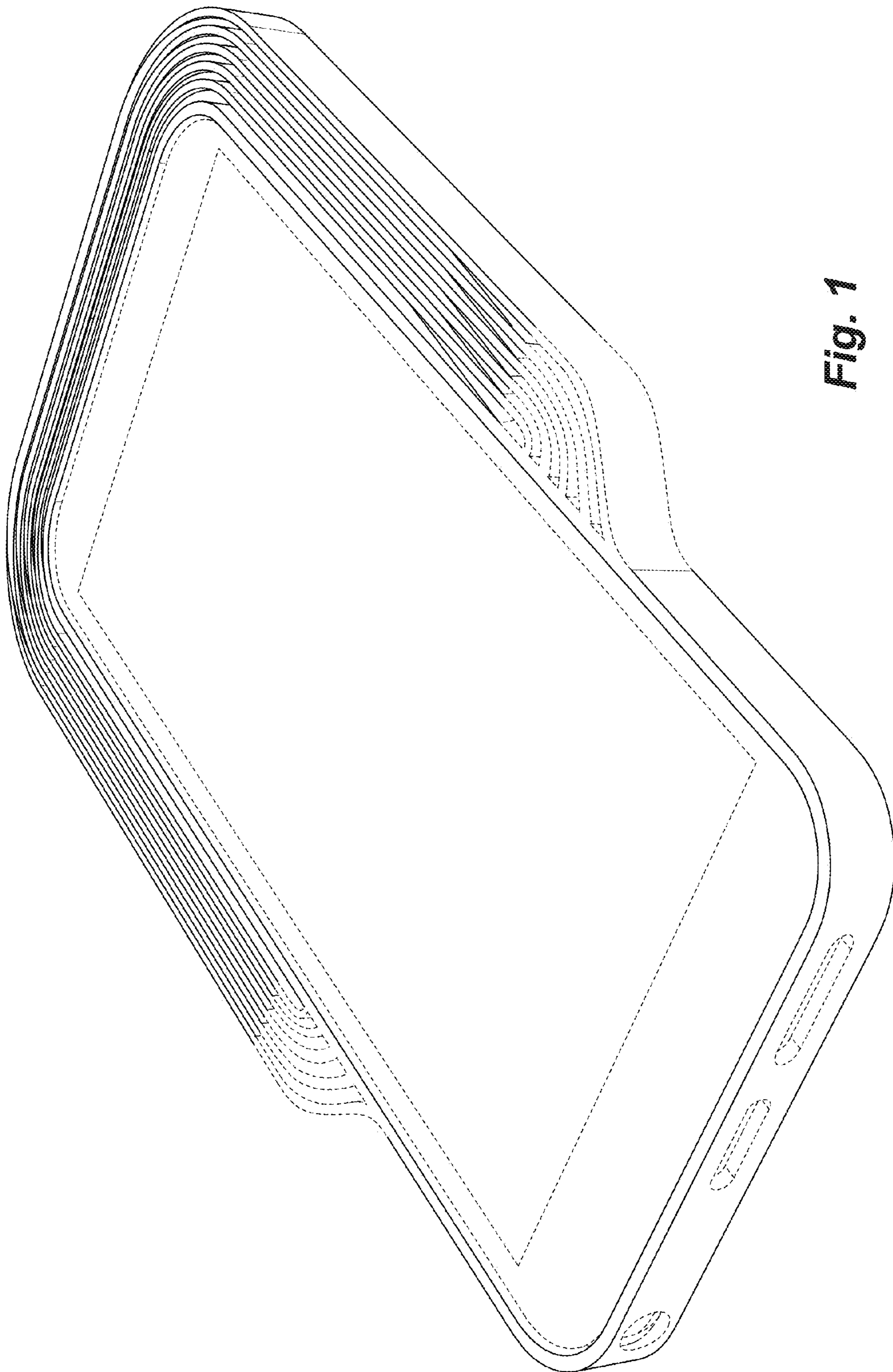

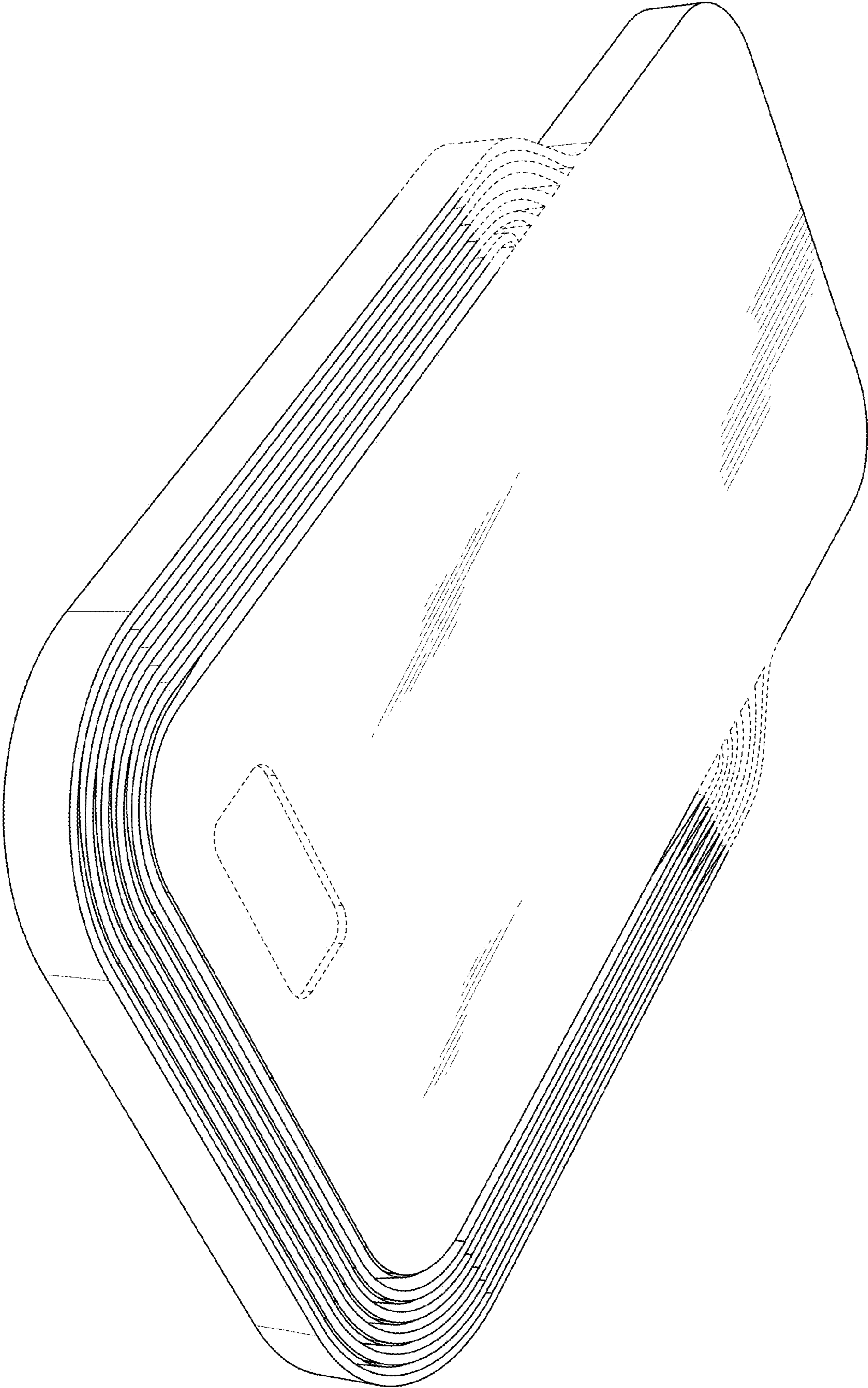

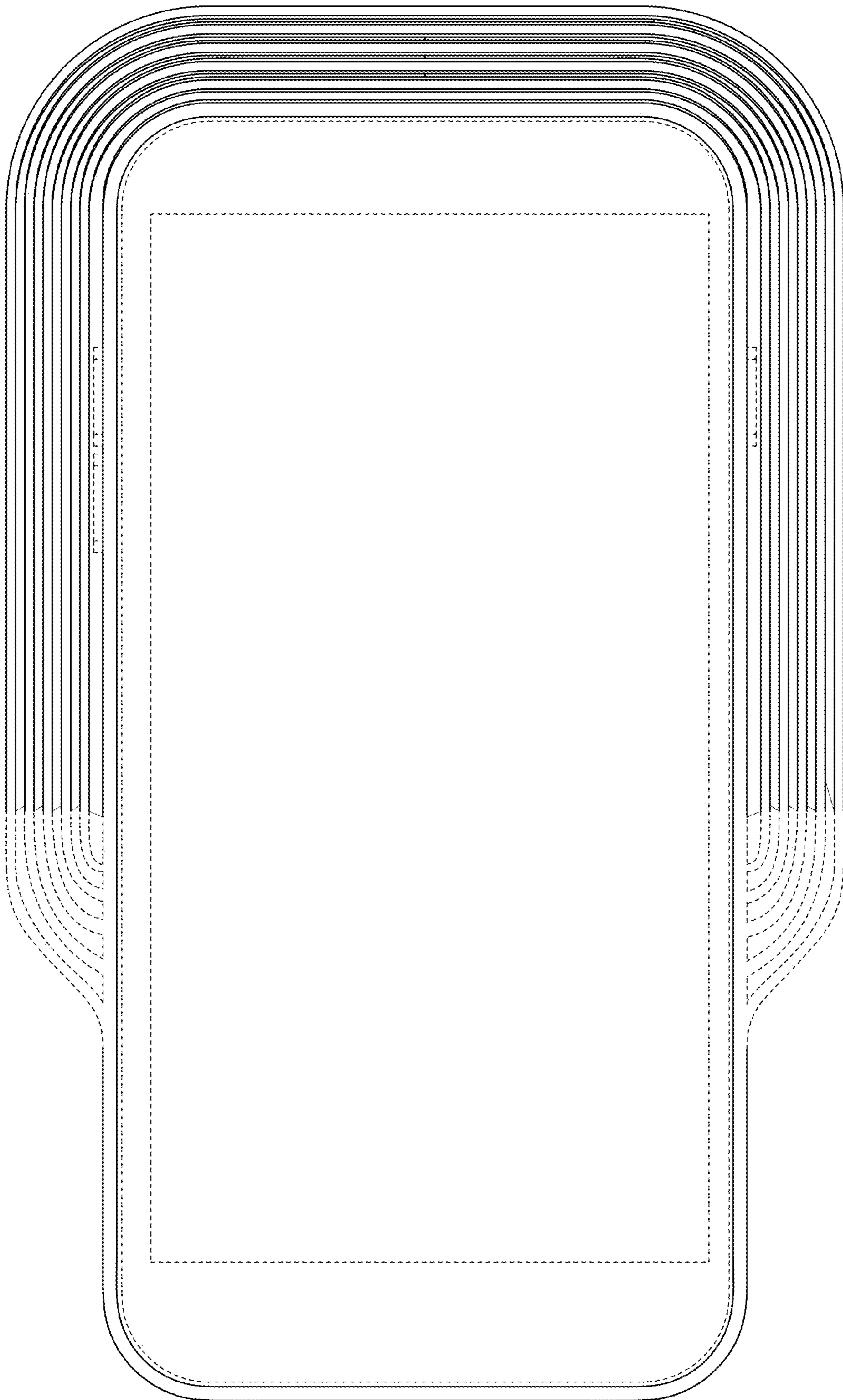

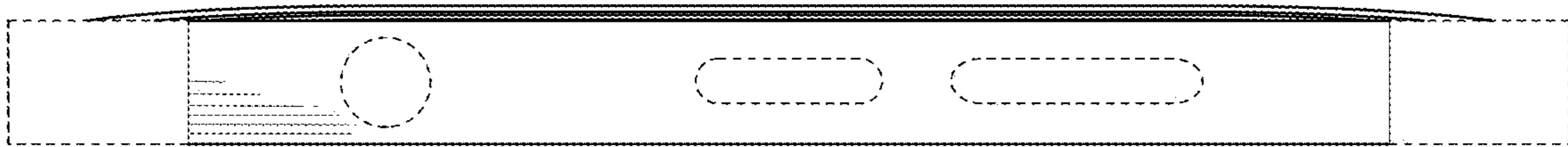

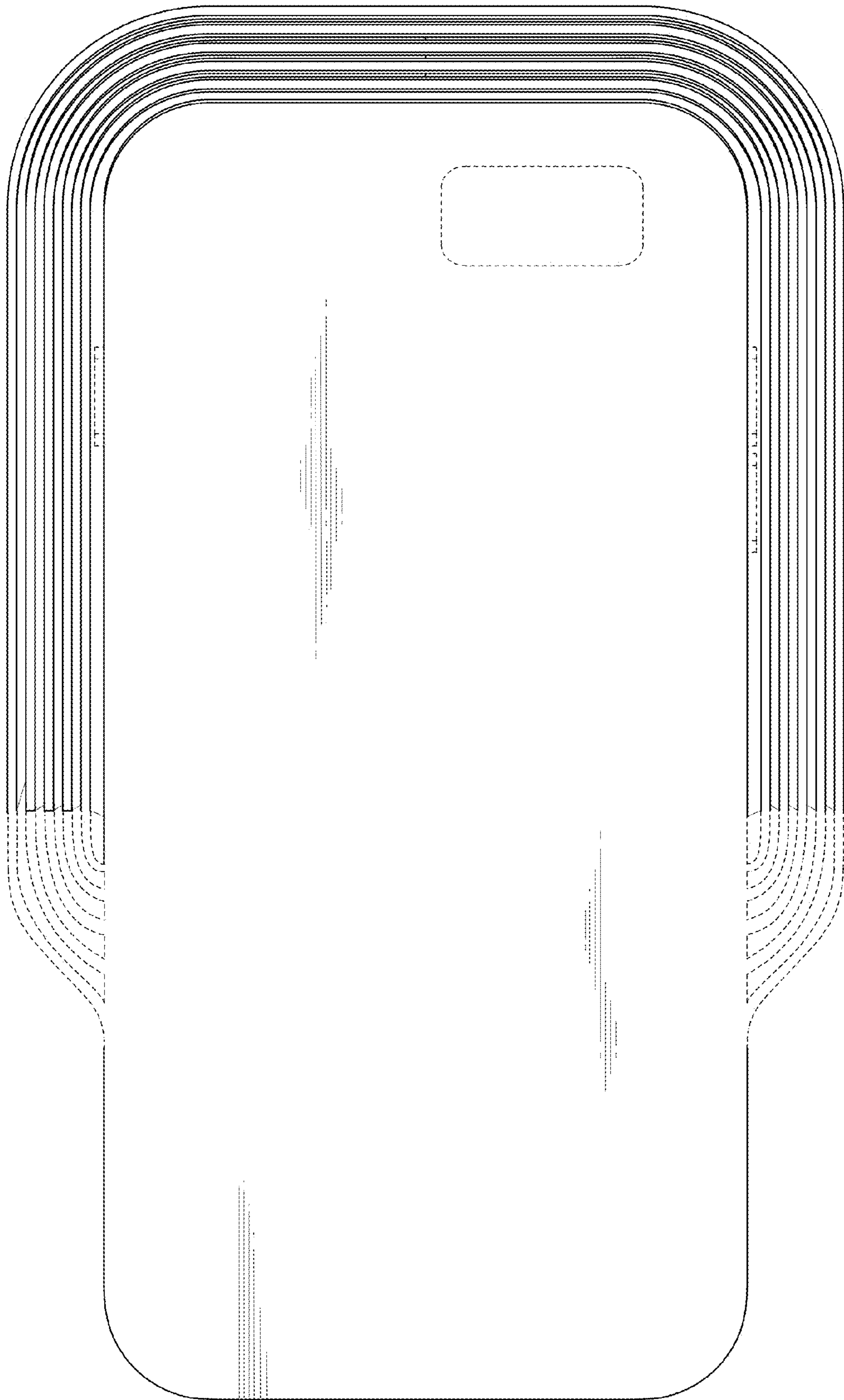

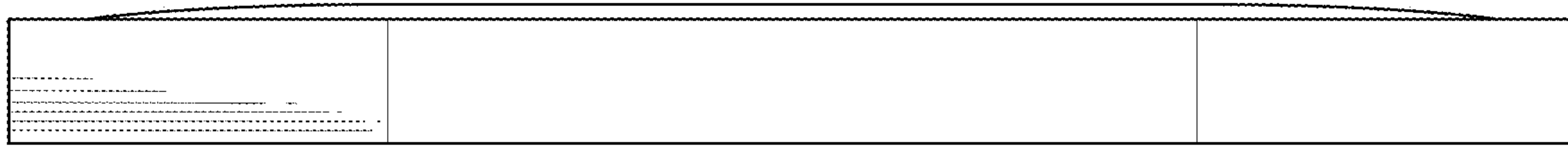

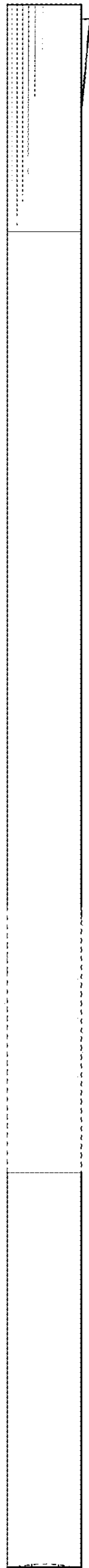
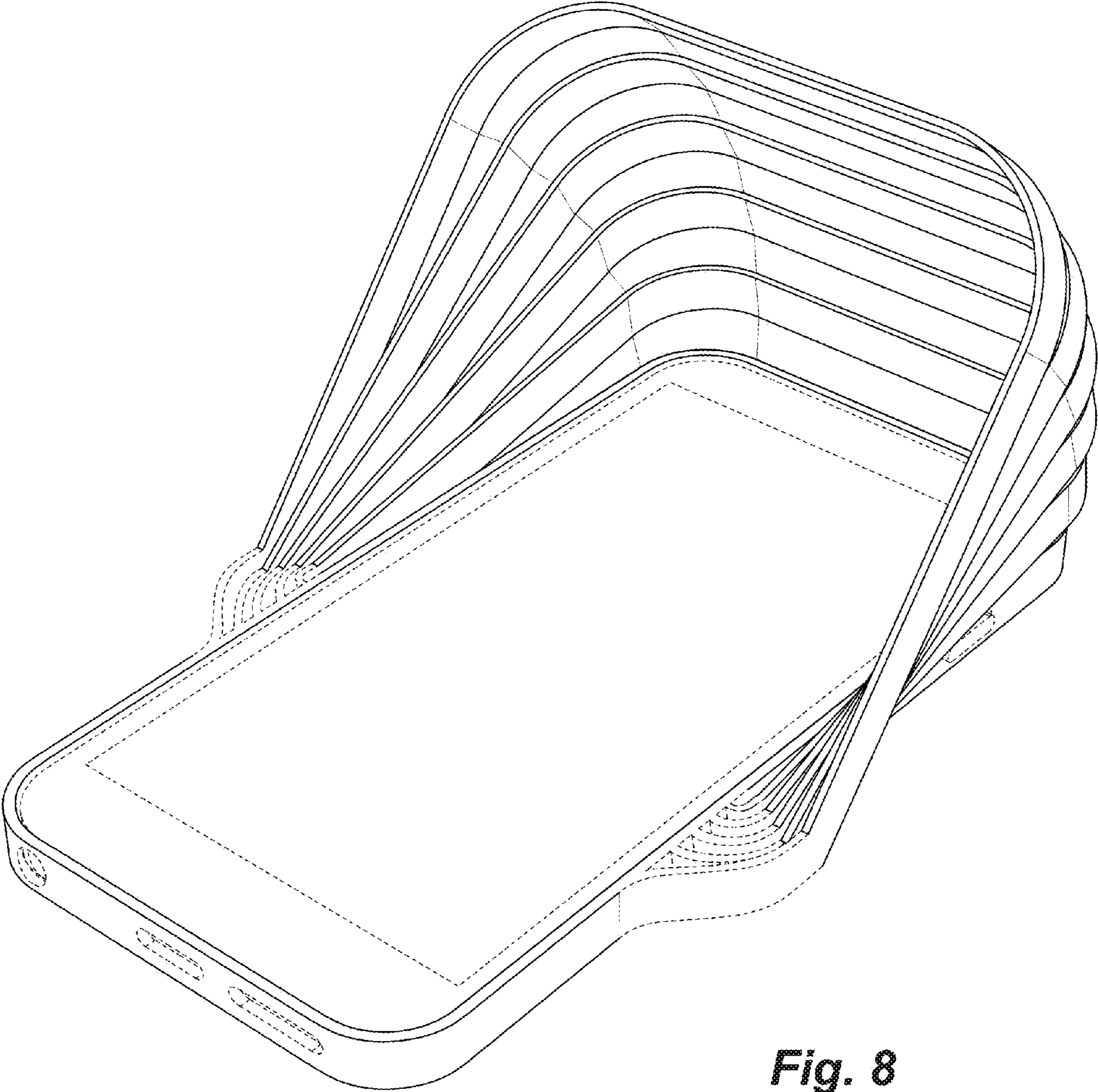

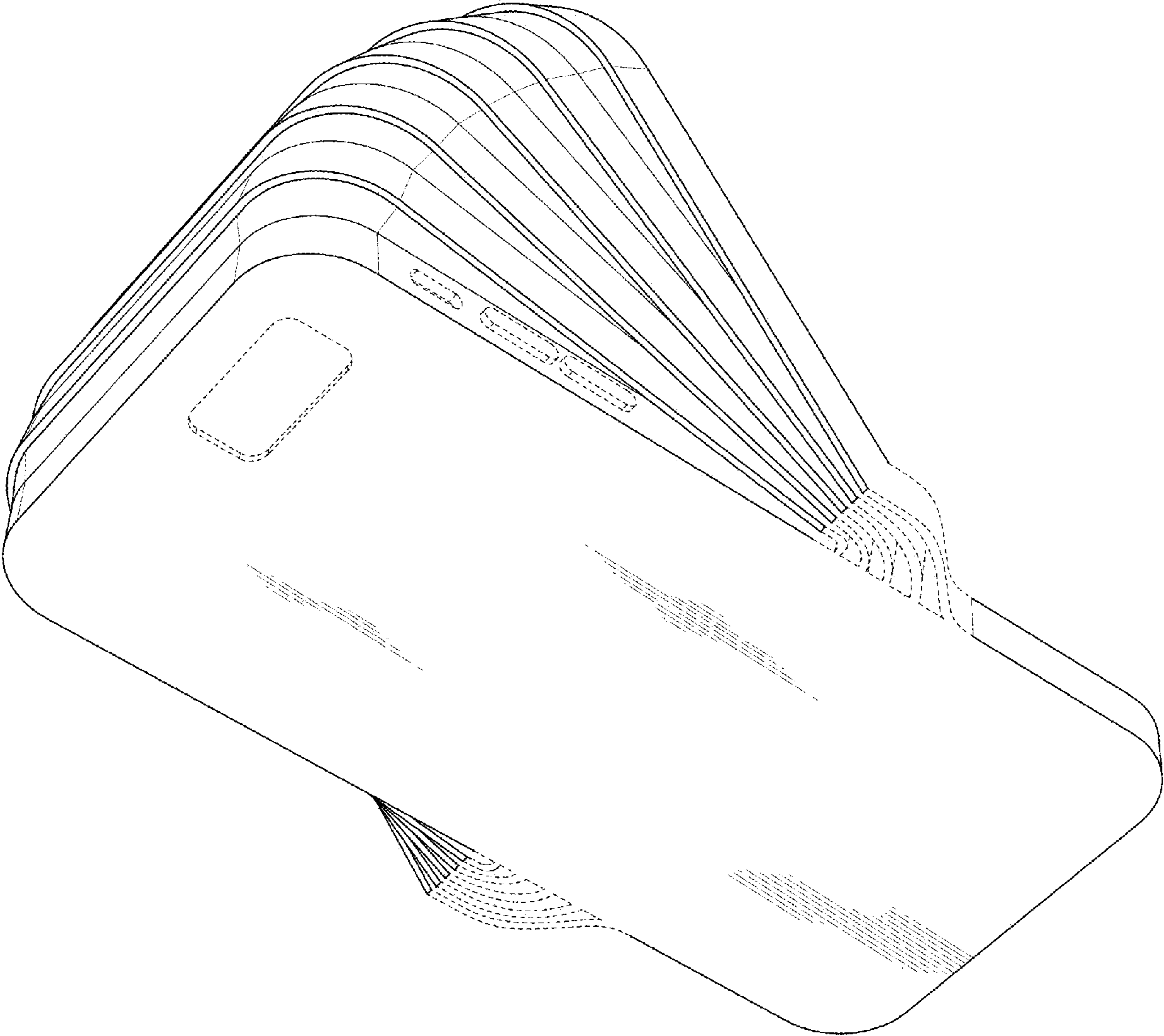

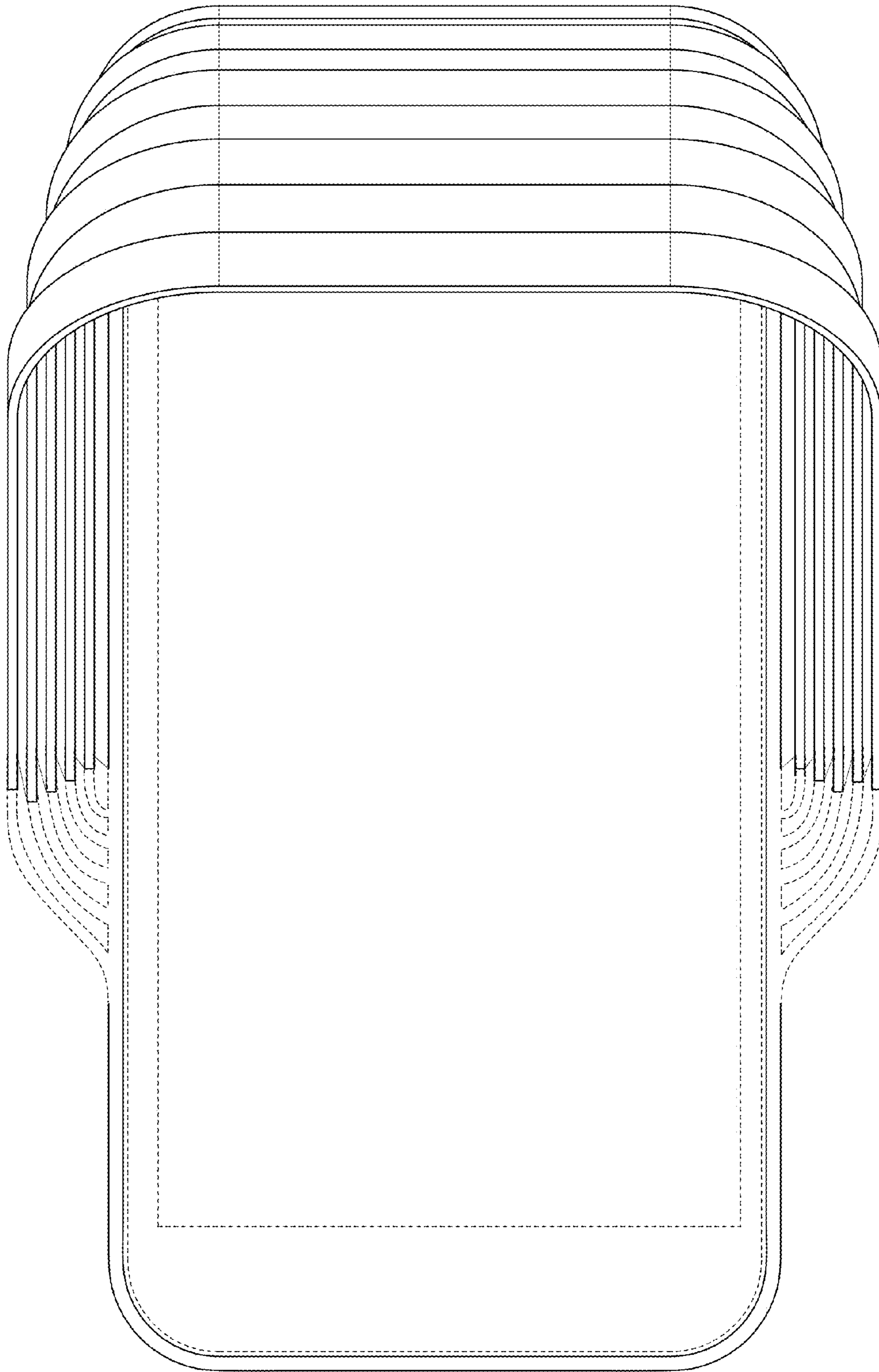

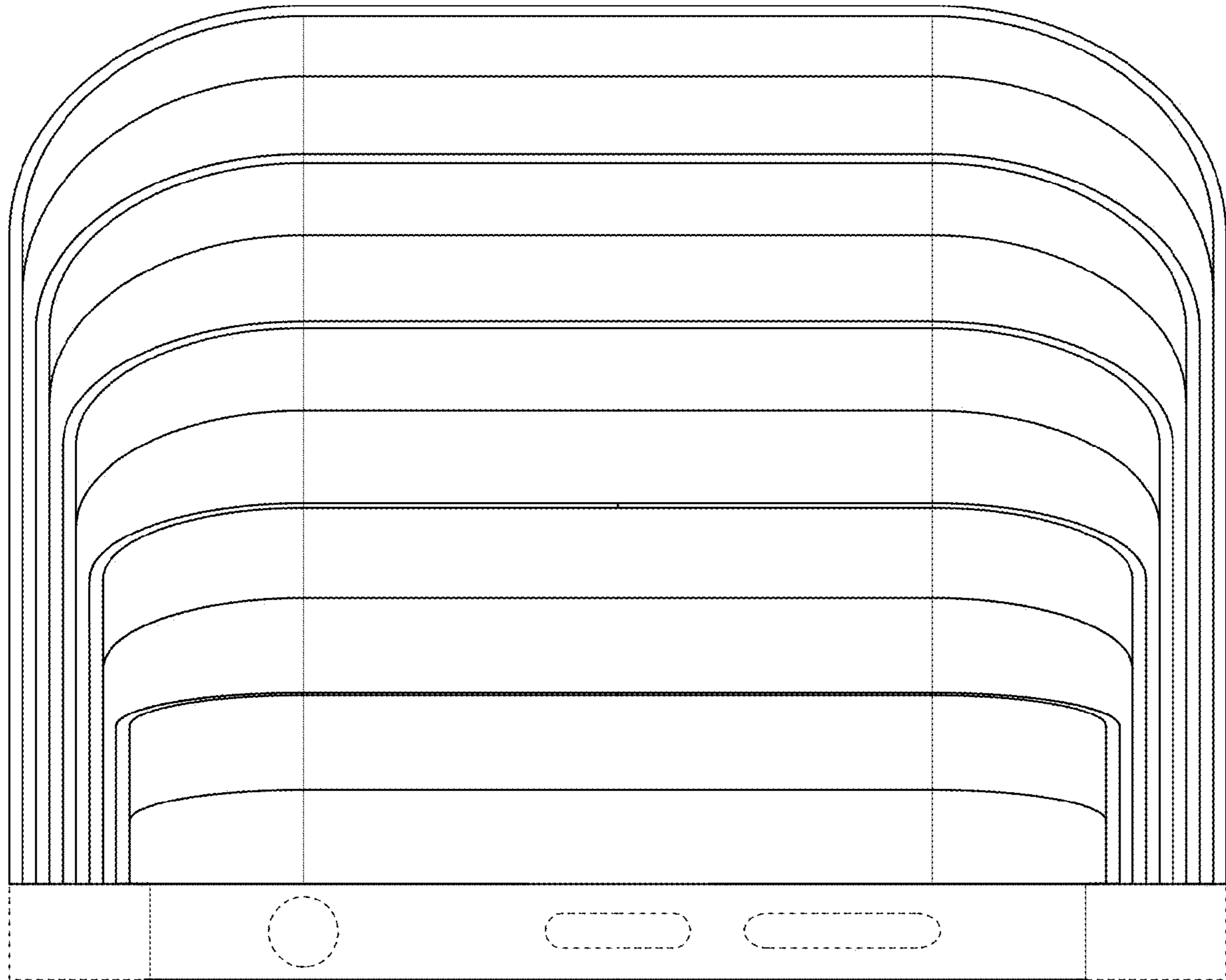

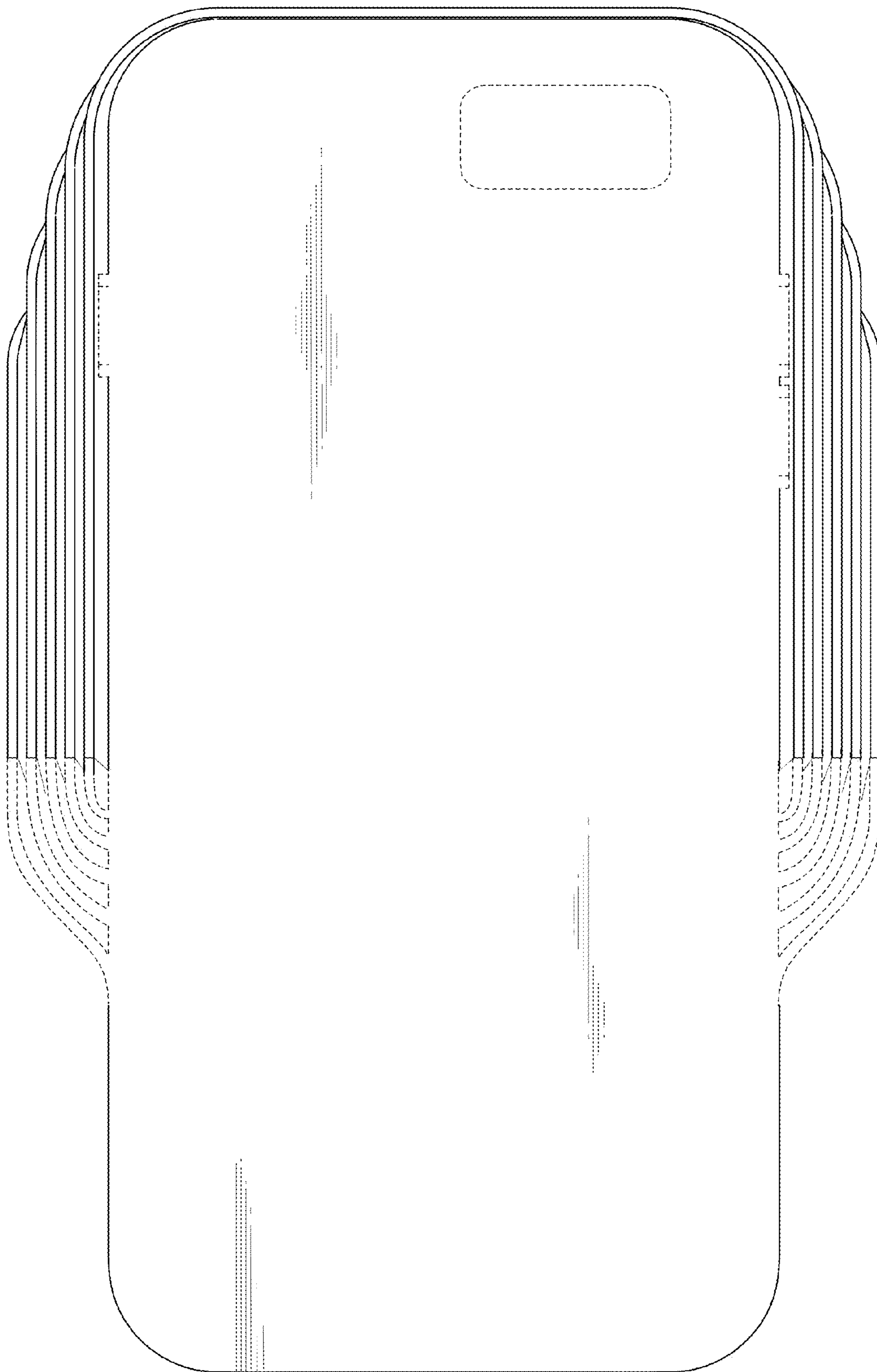

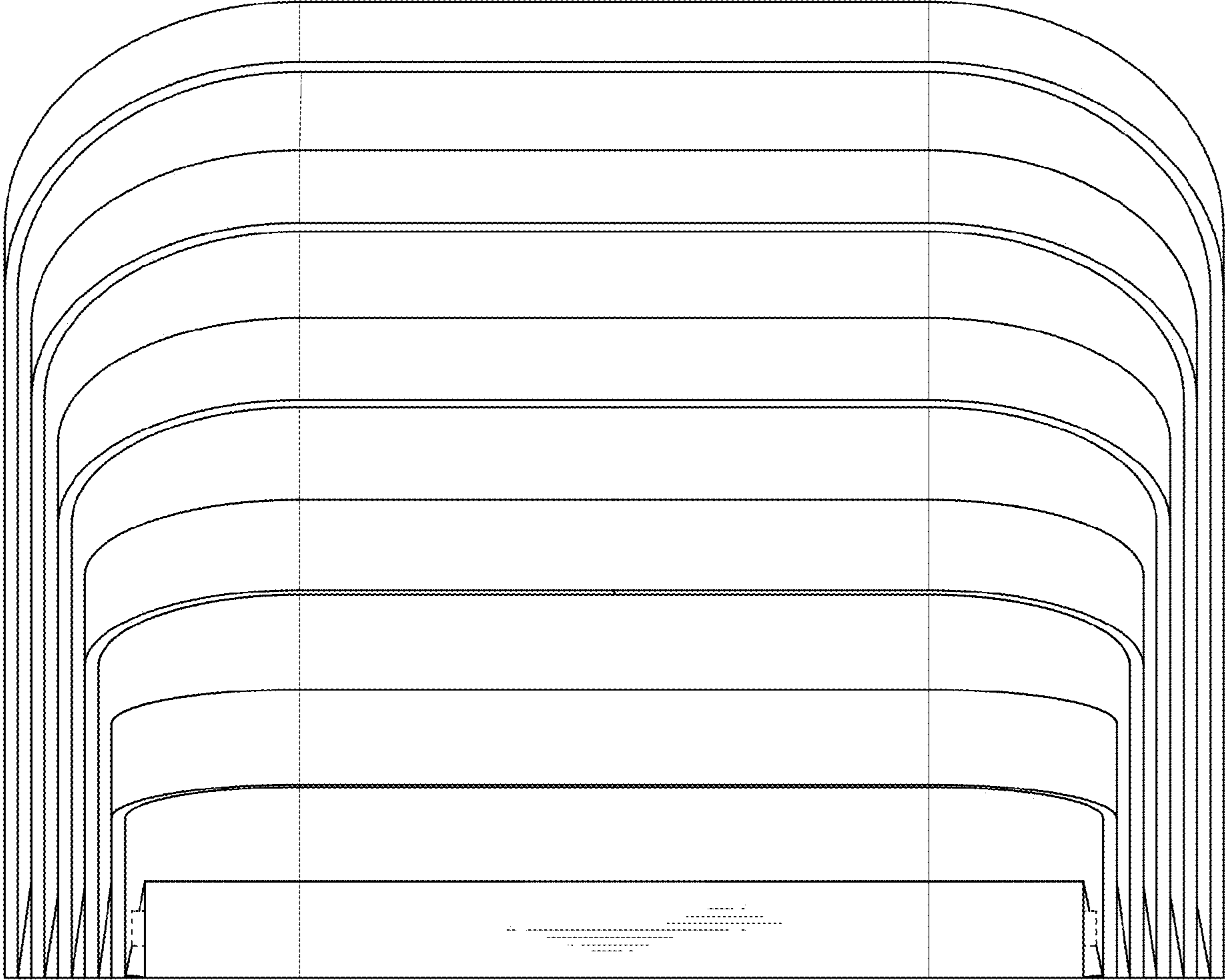

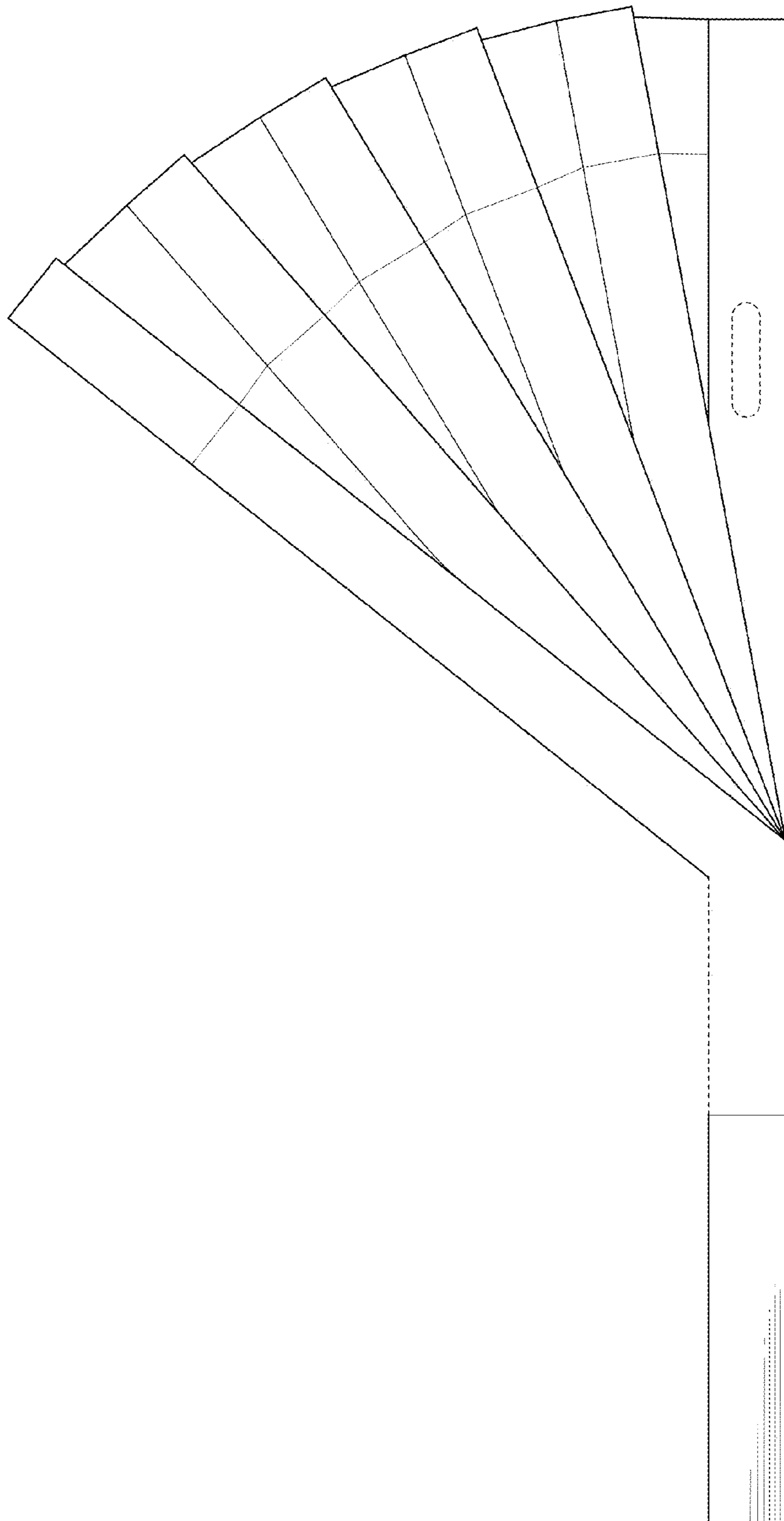
