(57) **CLAIM**

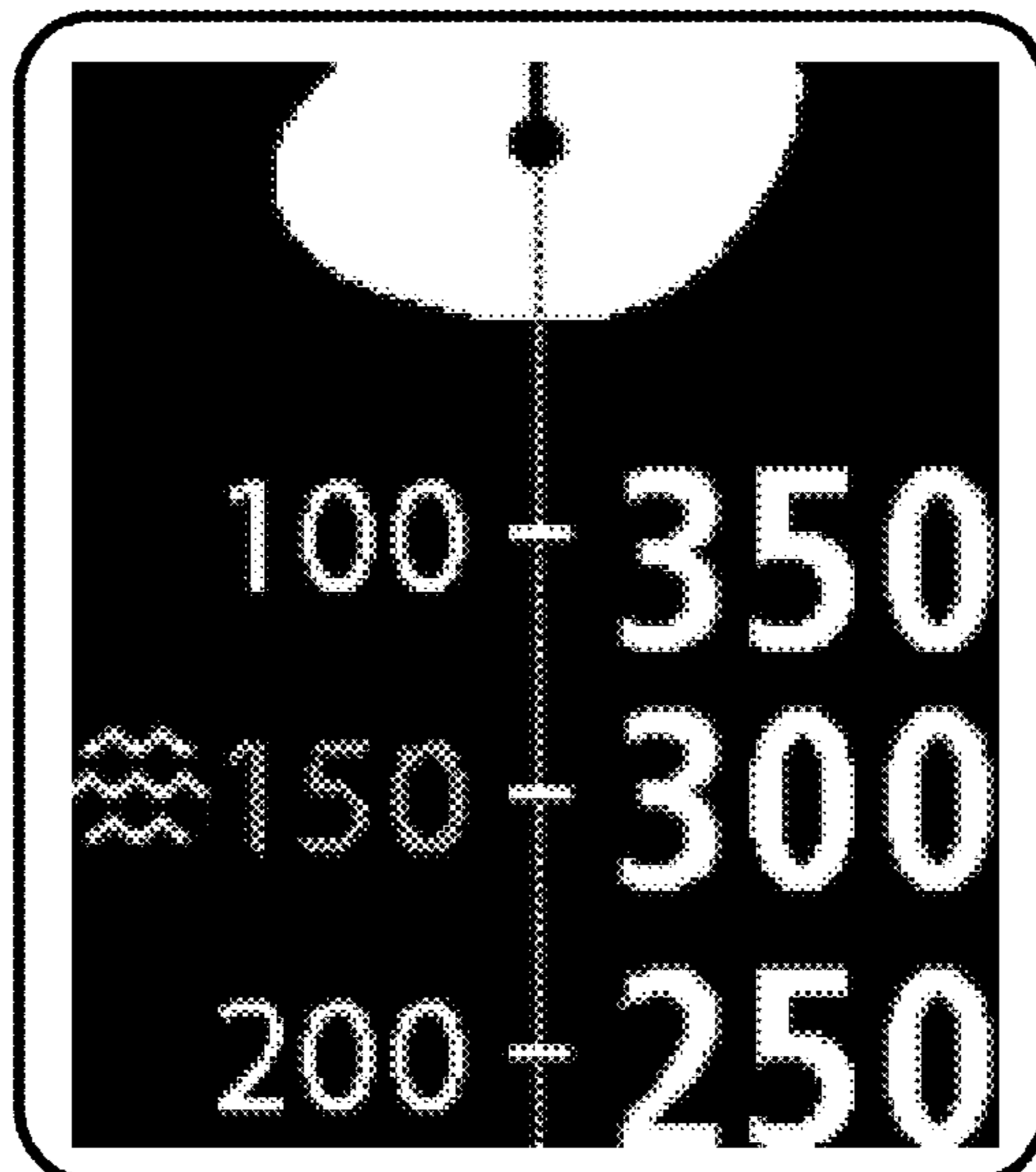
The ornamental design for a display panel of an electronic
golf device with a computer generated icon, as shown and
described.

DESCRIPTION

The design comprises a computer generated icon on a
display panel, such as a liquid crystal display panel, of an
electronic device; the device arranged to provide informa-
tion to a user (or golfer) in respect of a hole of a golf course
currently being played.

The drawing FIGURE shows a display panel of an electronic
