(57) **CLAIM**

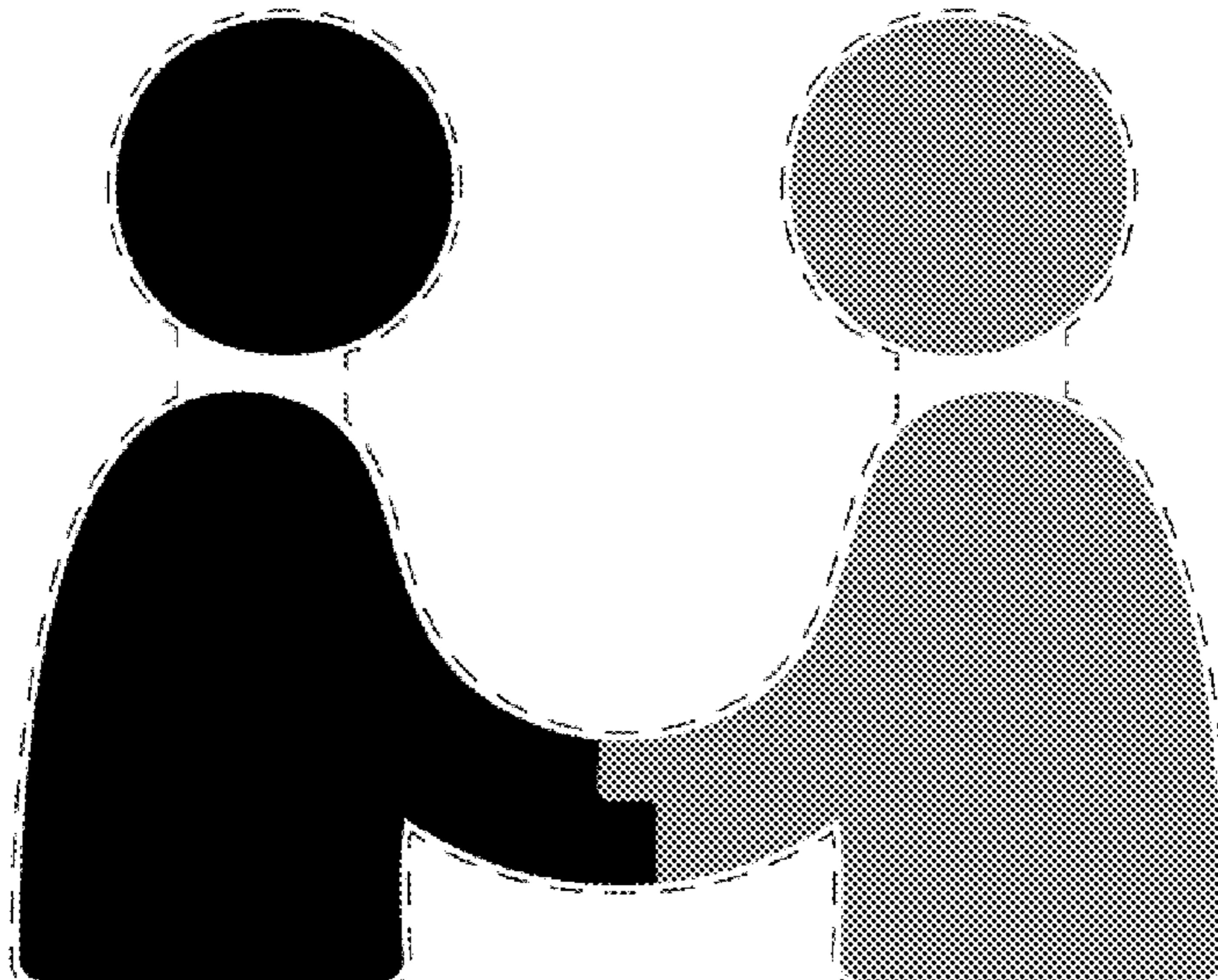
The ornamental design for an electronic device with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an electronic device having a display screen with graphical user interface applied to the display screen showing the claimed design; FIG. 2 is another embodiment thereof; and, FIG. 3 is a front view of another electronic device having a display screen showing the graphical user interface of FIG. 1 applied to the display screen. The graphical user interface design of FIG. 2 may be similarly applied thereto.

The dashed broken lines in the figures show an electronic device having a display screen, or another electronic device having a display screen, and form no part of the claimed design. The dot-dash broken lines in FIG. 3 show a boundary of the graphical user interface that forms no part of the claimed design.

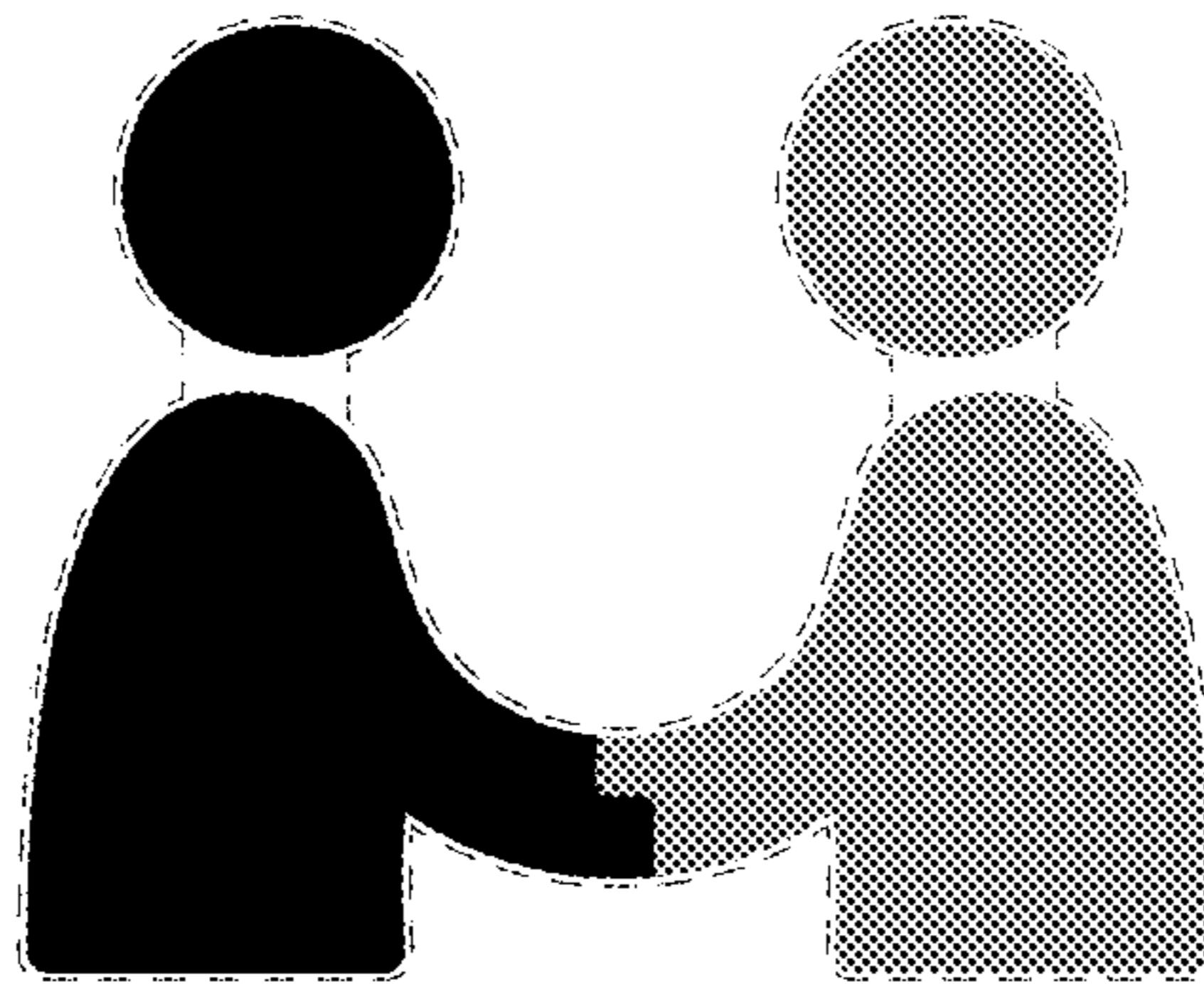

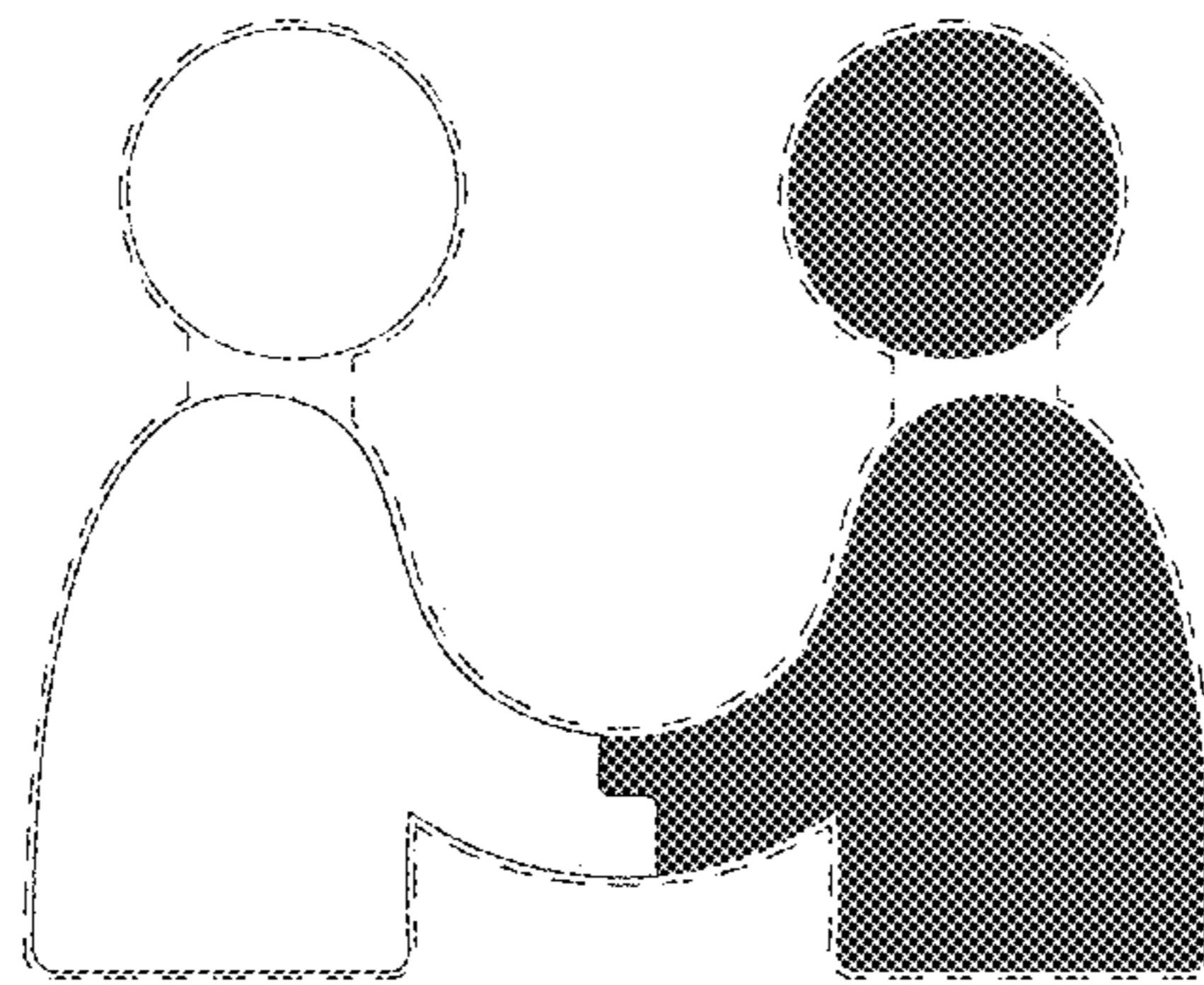

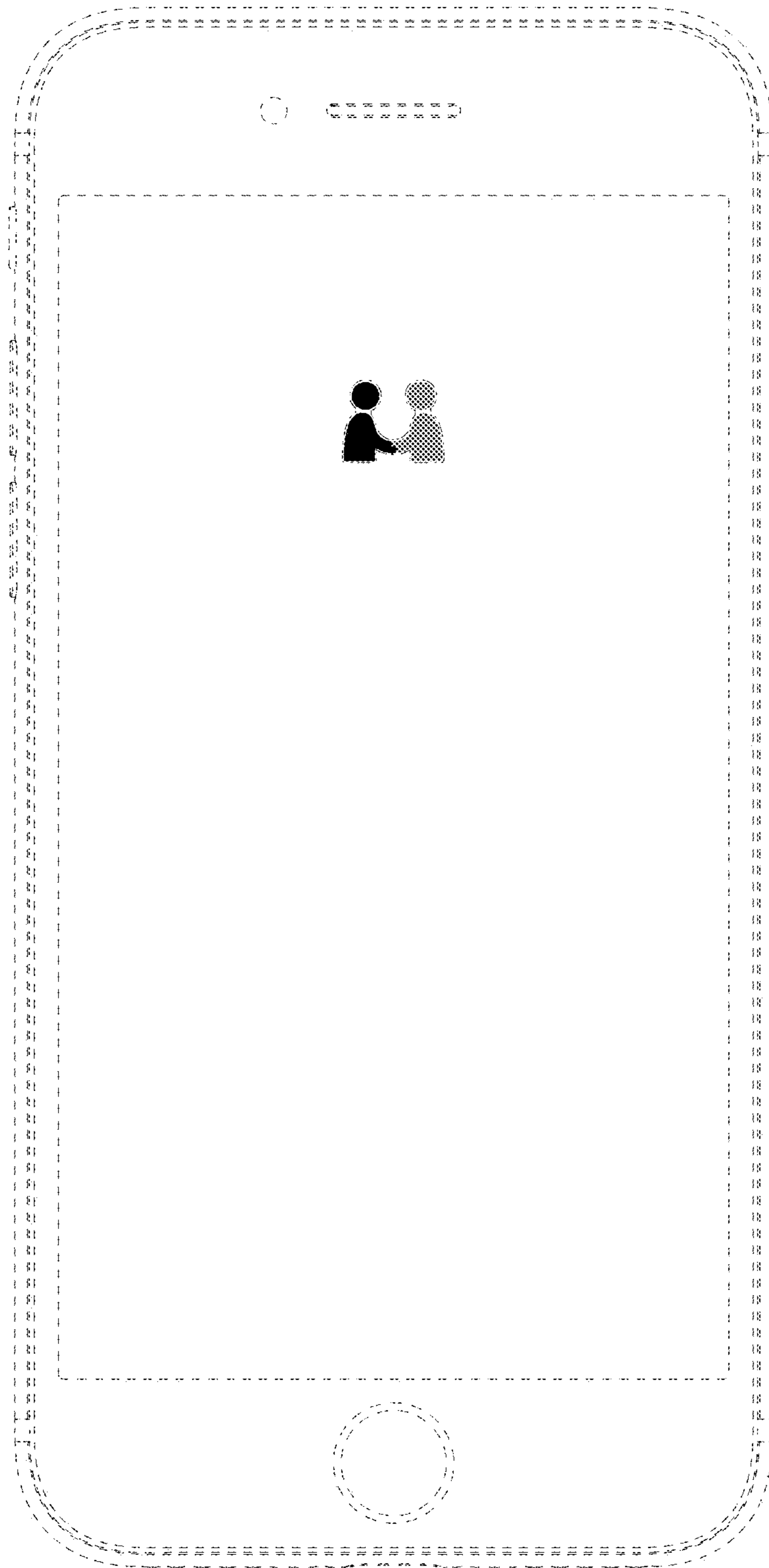
