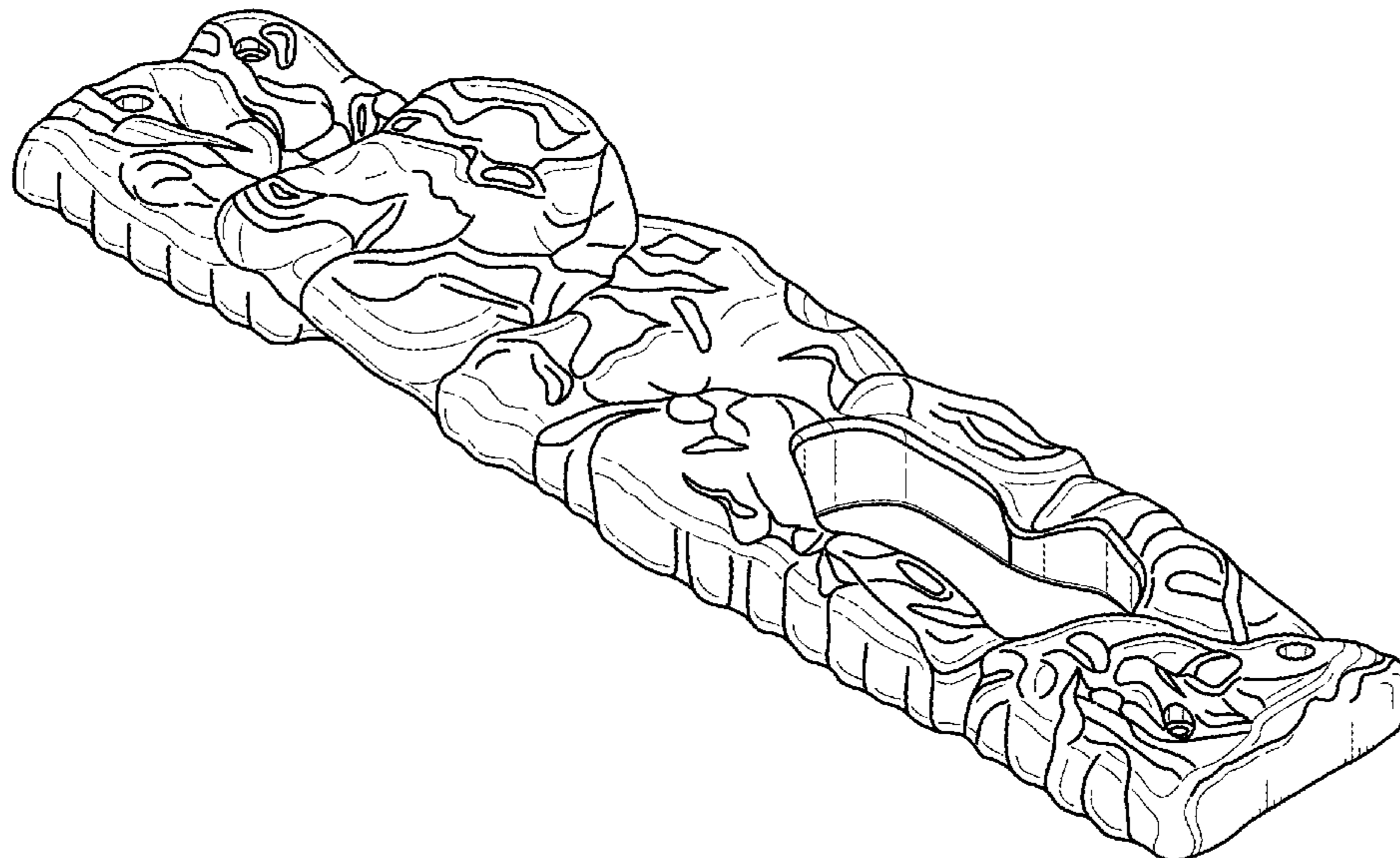
(57) **CLAIM**

The ornamental design for a rockwall slat and rock combo, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a rockwall slat and rock combo in accordance with the new design;
 FIG. 2 is a rear perspective view of the rockwall slat and rock combo in accordance with the new design;
 FIG. 3 is a front elevation view of the rockwall slat and rock combo in accordance with the new design;
 FIG. 4 is a rear elevation view of the rockwall slat and rock combo in accordance with the new design;
 FIG. 5 is a top plan view of the rockwall slat and rock combo in accordance with the new design;
 FIG. 6 is a bottom plan view of the rockwall slat and rock combo in accordance with the new design;
 FIG. 7 is a right side elevation view of the rockwall slat and rock combo in accordance with the new design;

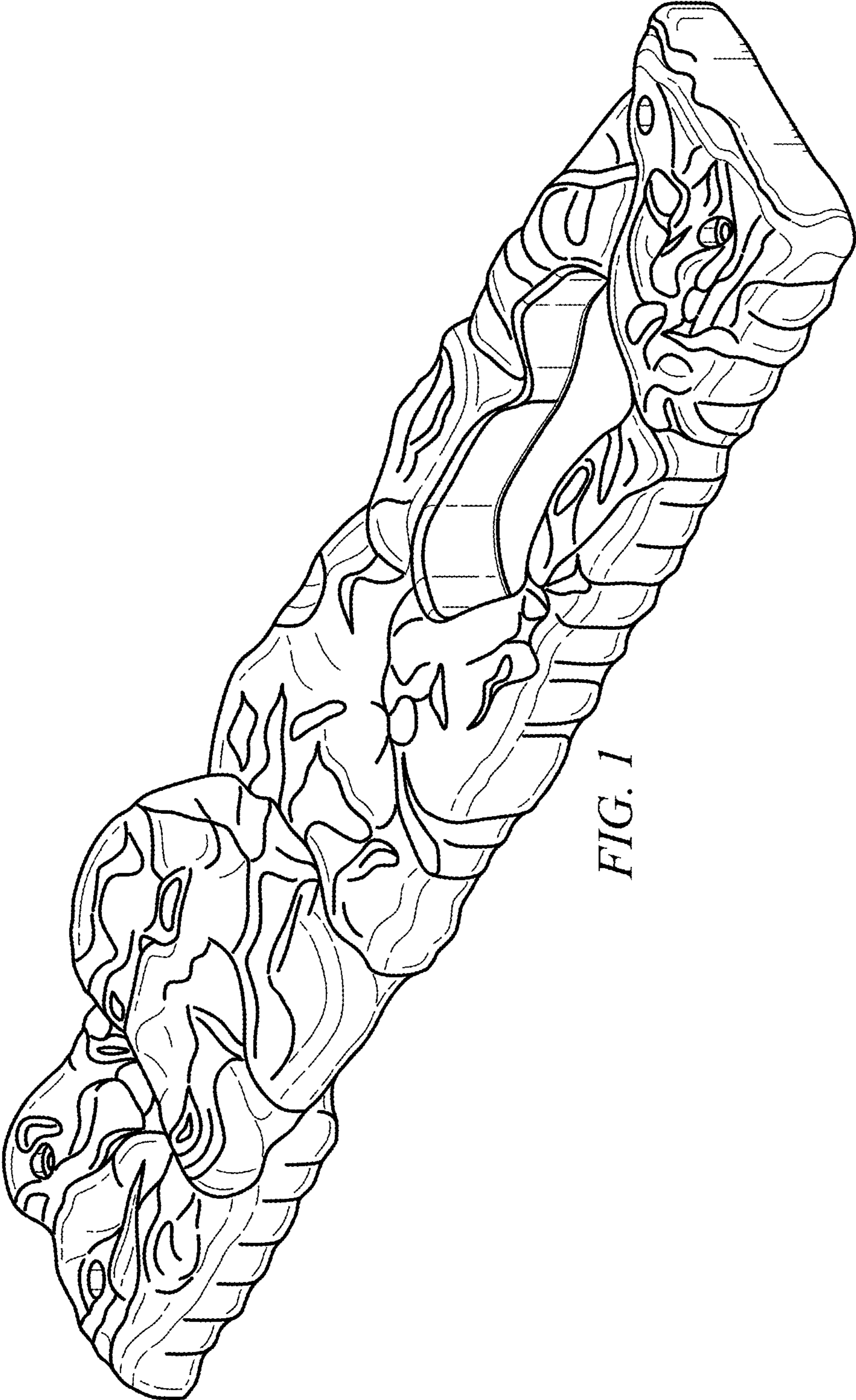

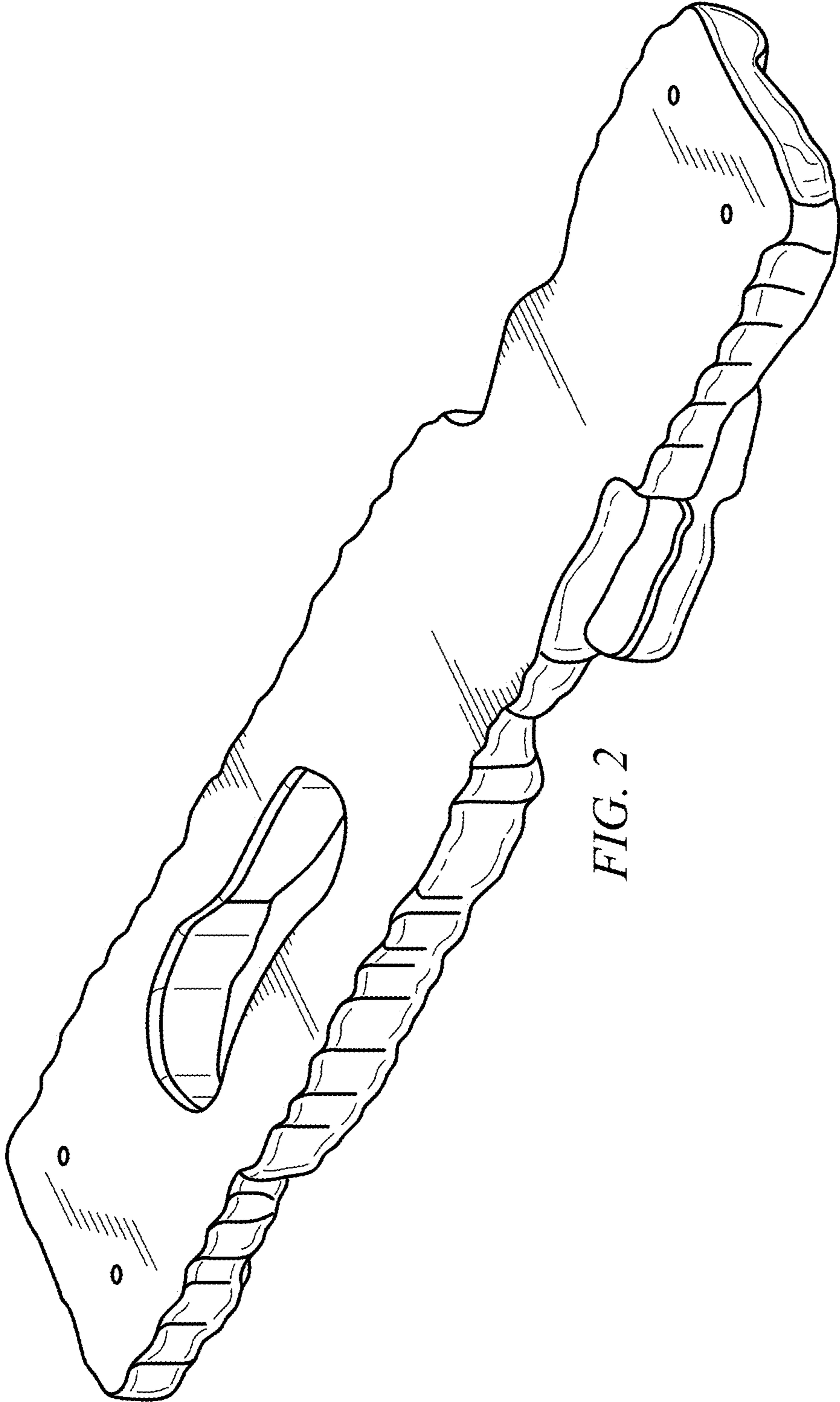

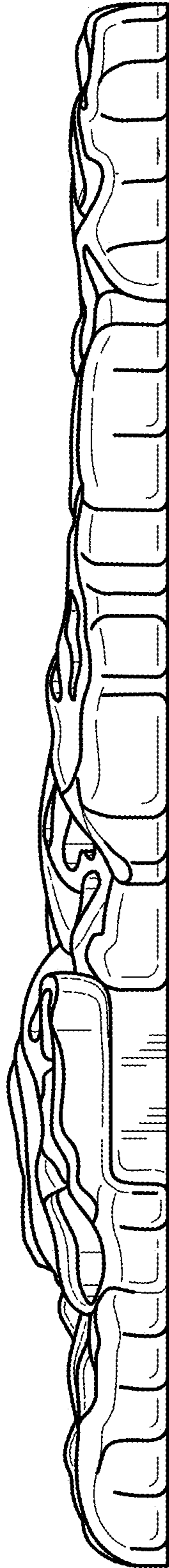

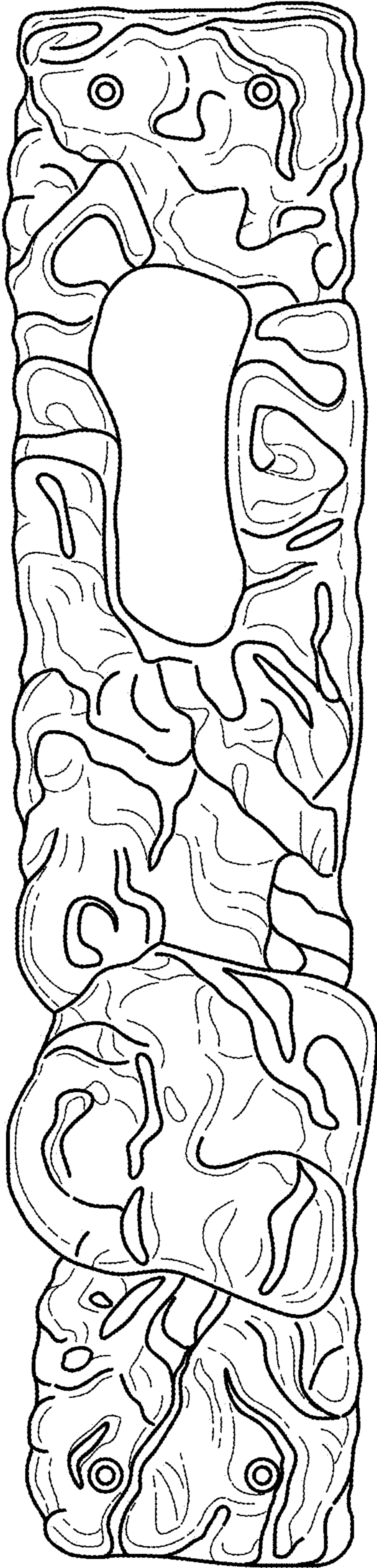

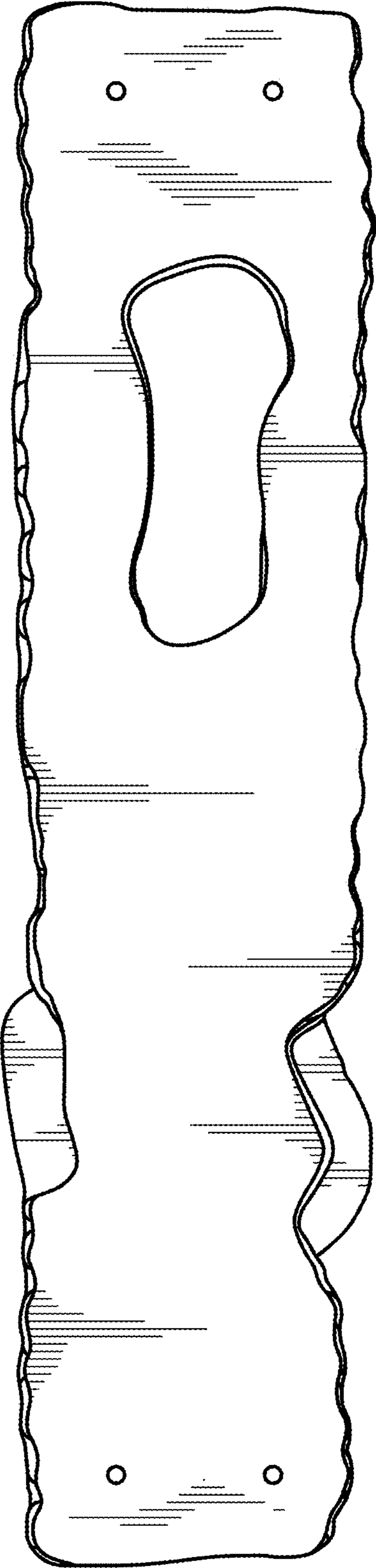

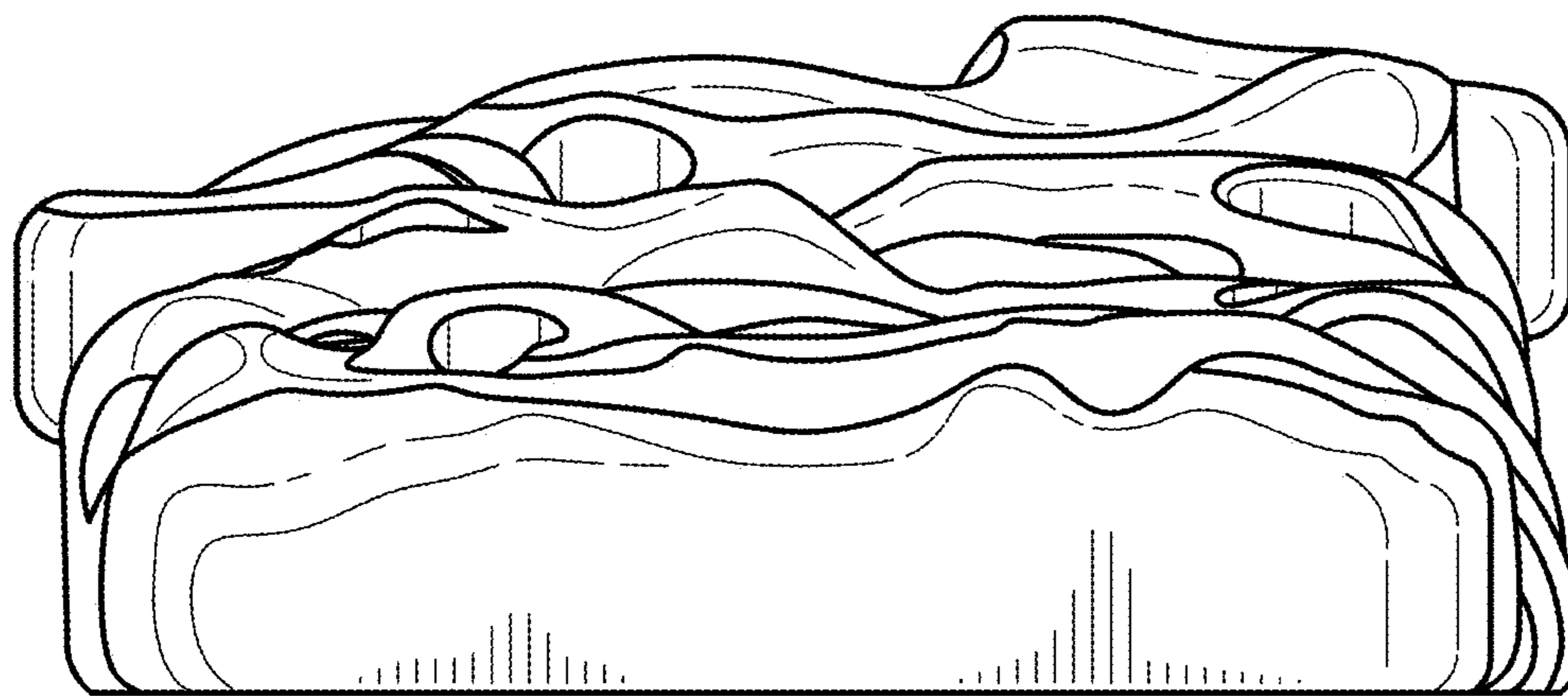

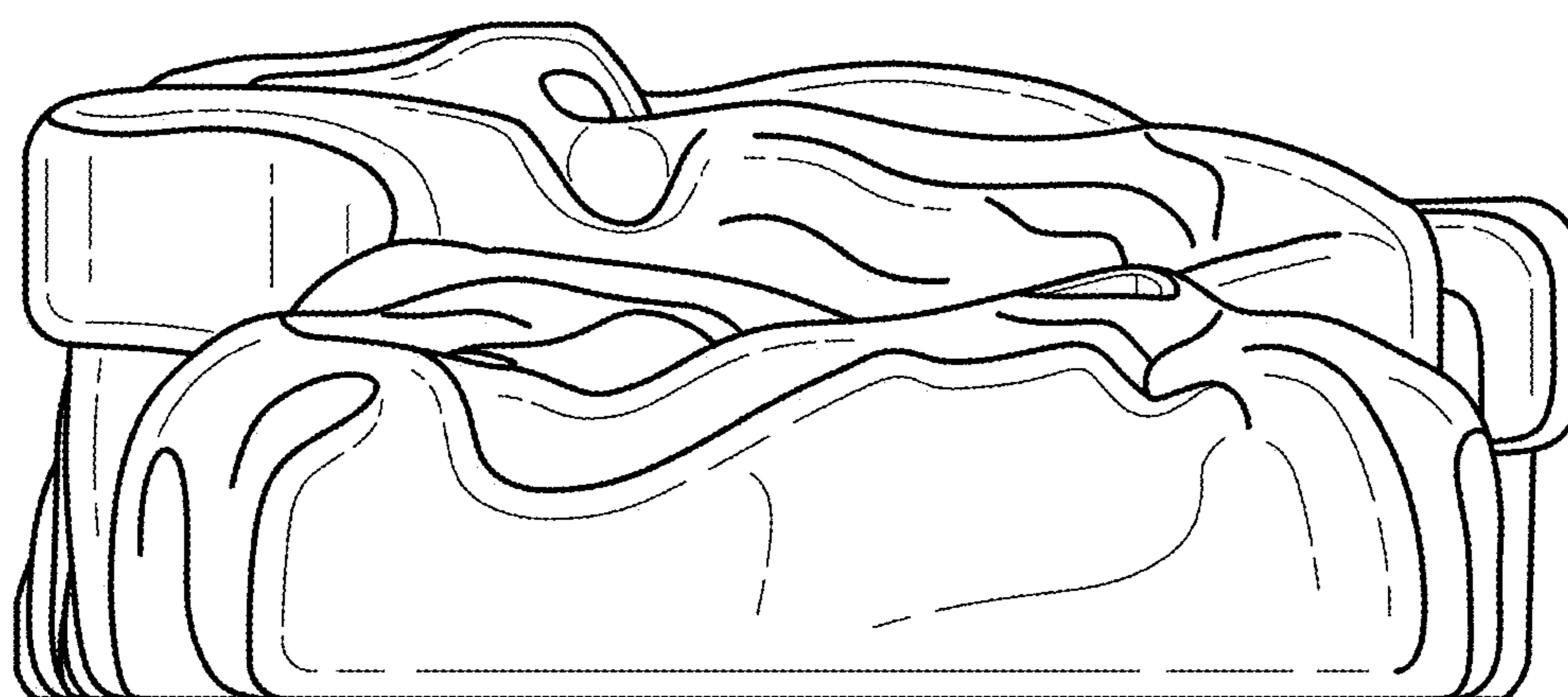

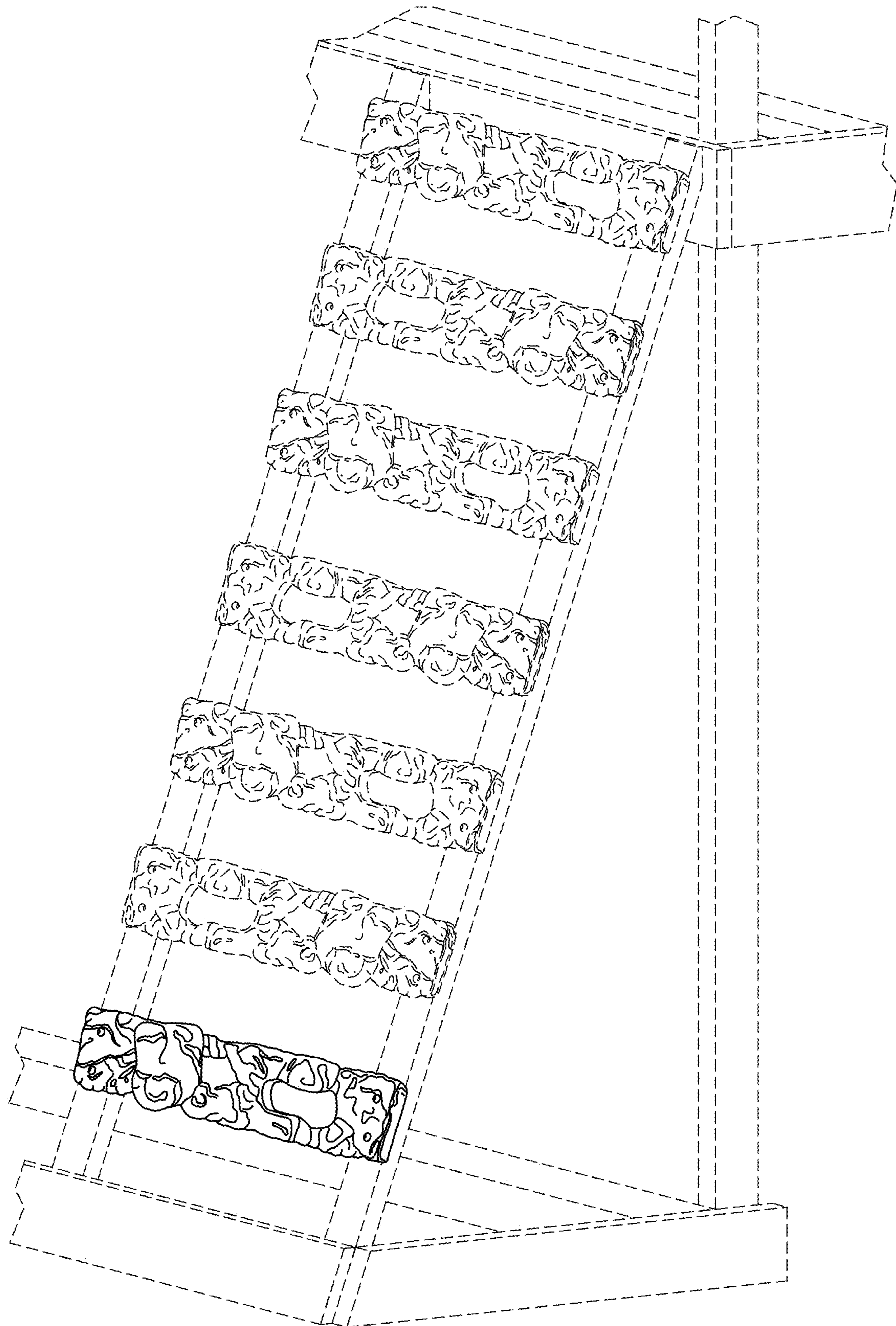
