FIG. 12 is a rear elevation view of another embodiment of a design for a washbasin.

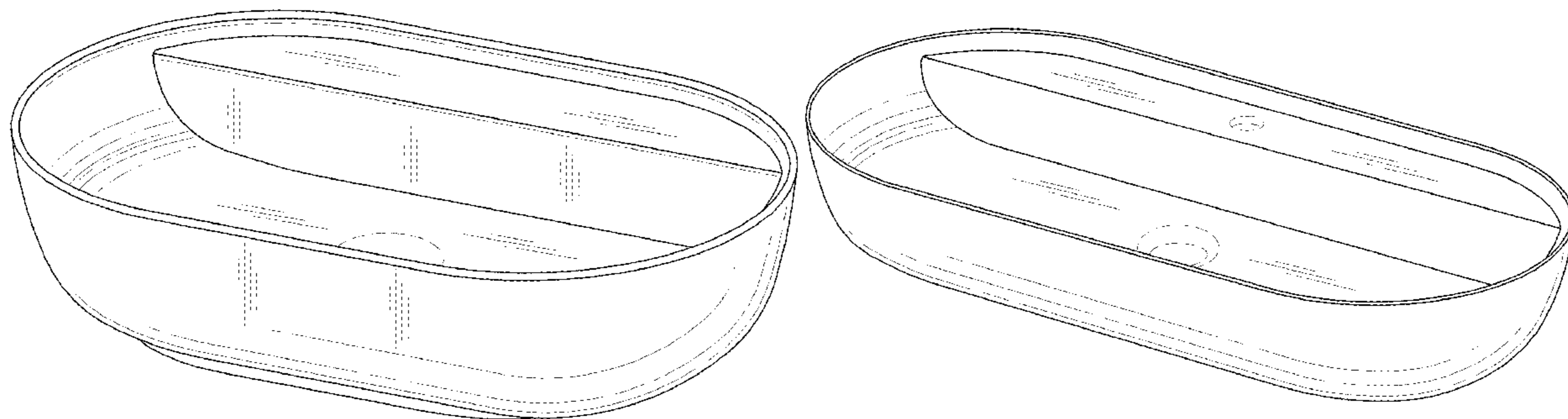
FIG. 13 is a right side elevation view of another embodiment of a design for a washbasin; and,

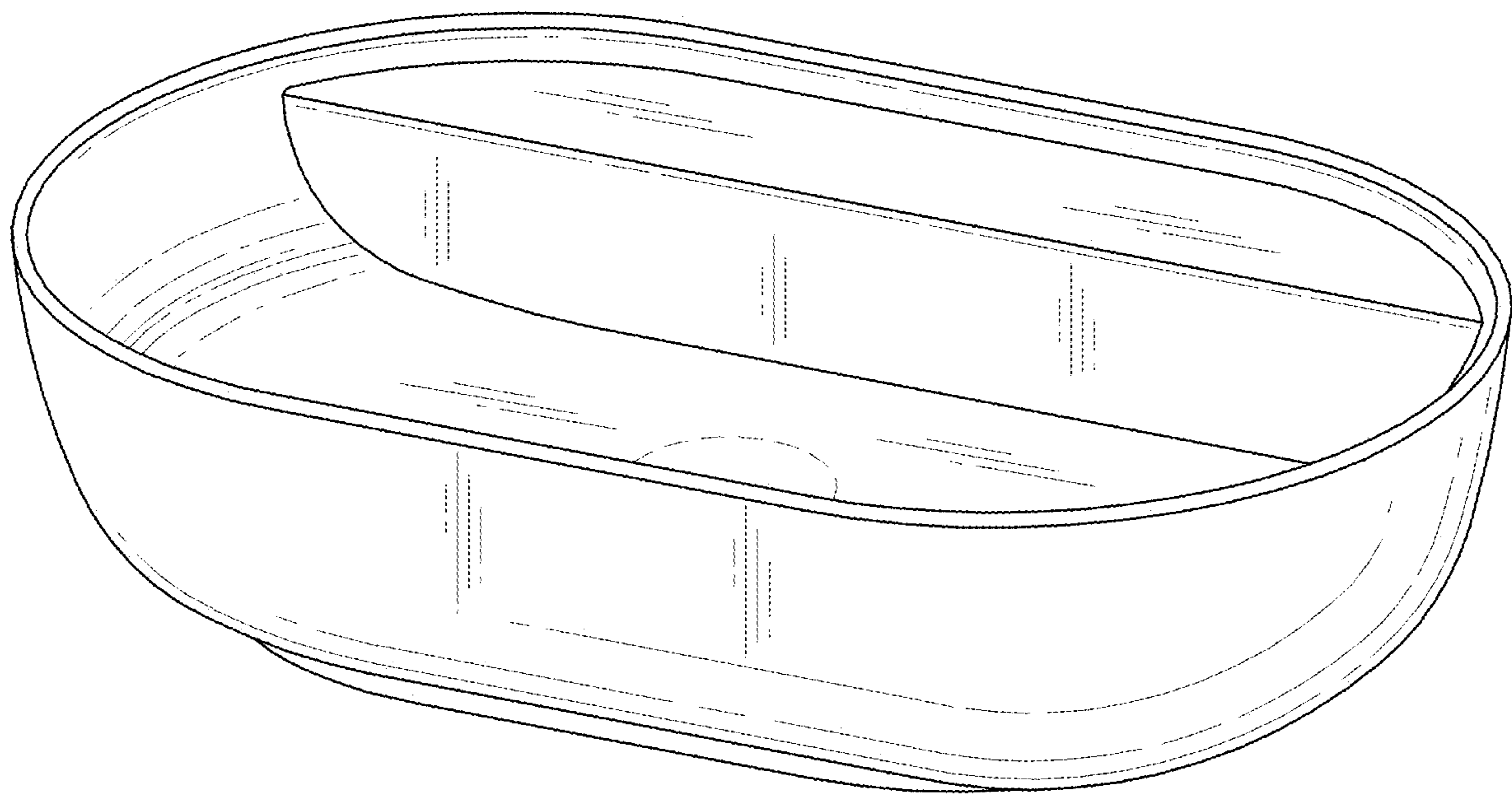

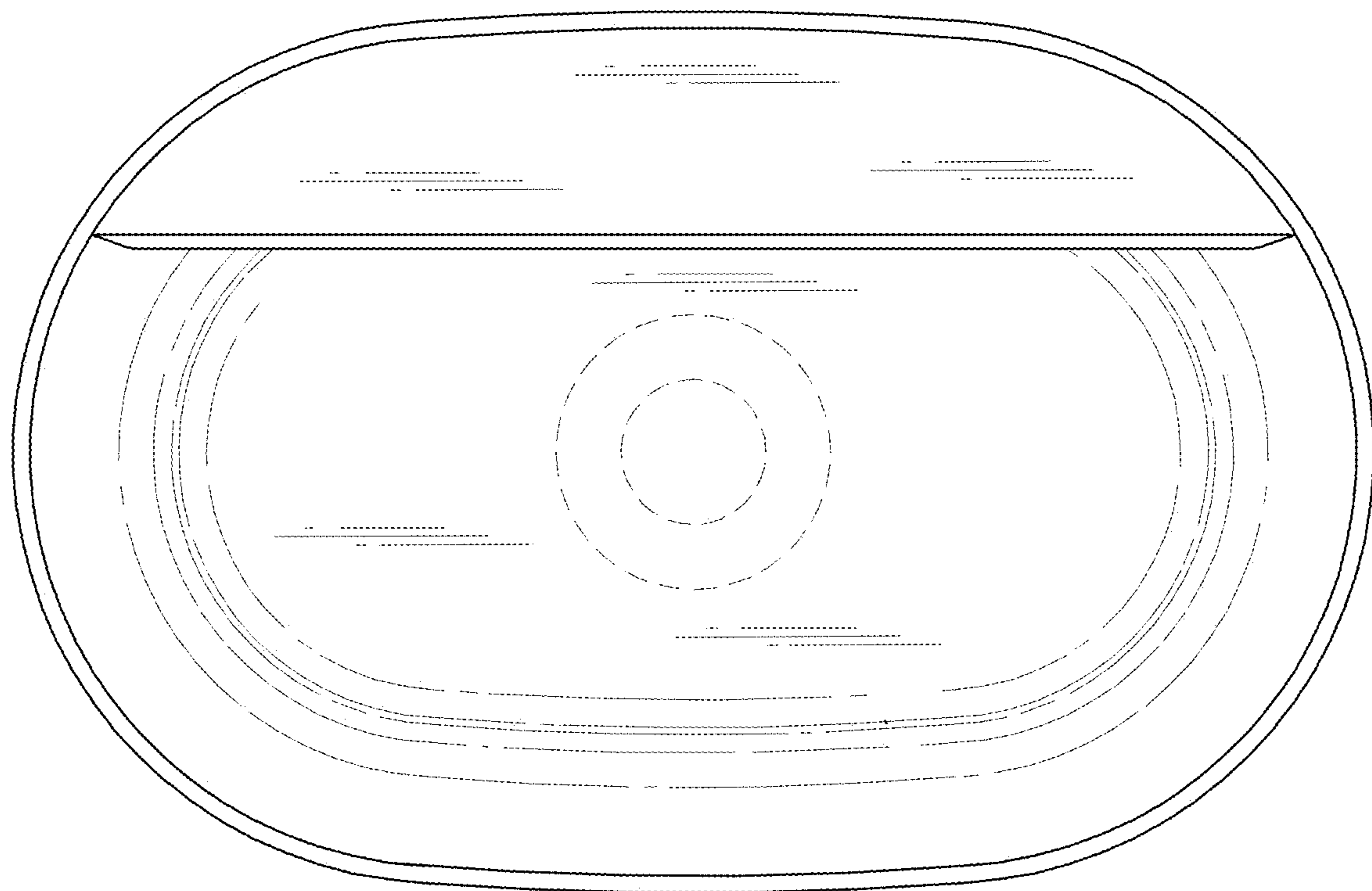

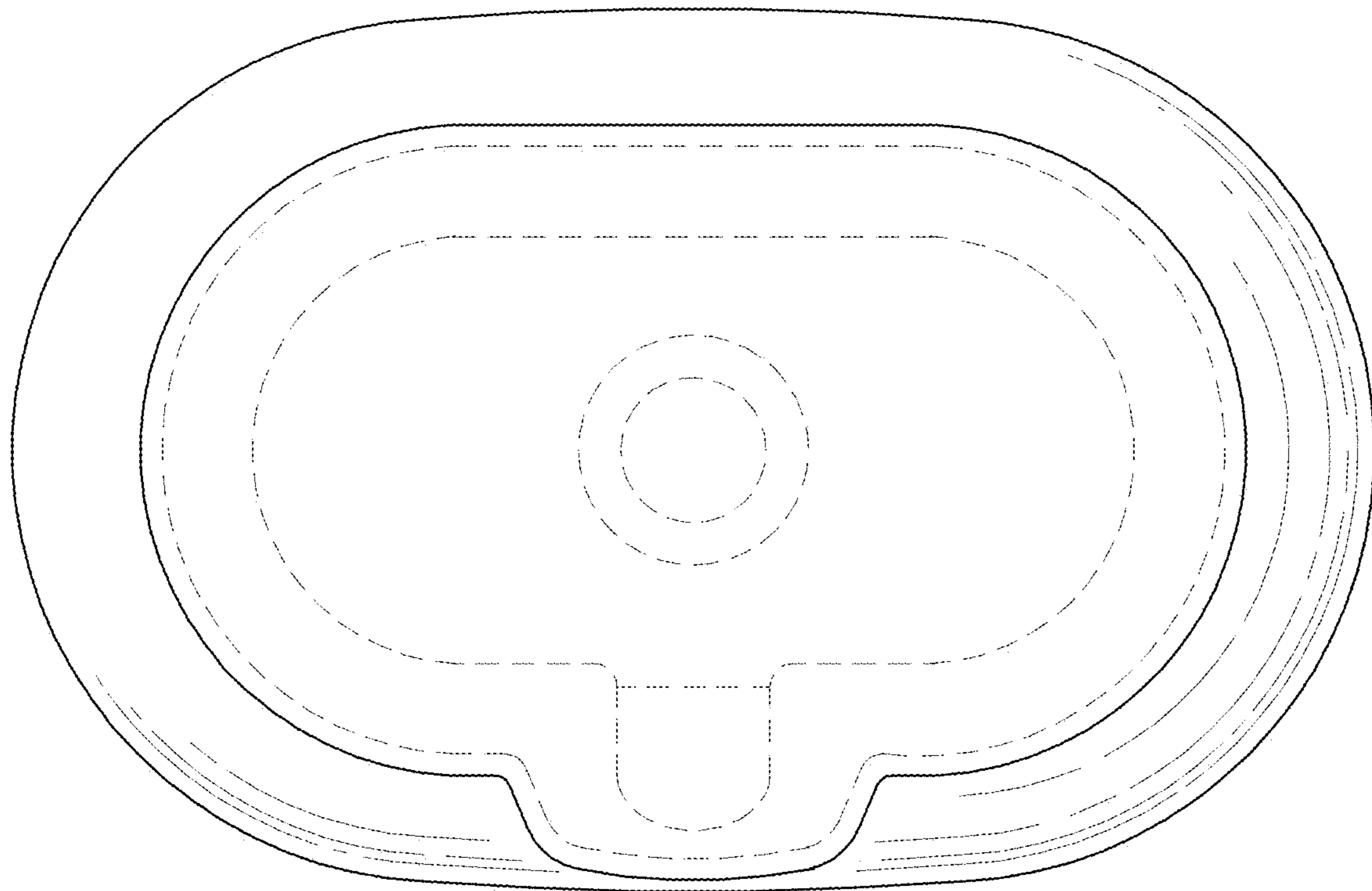

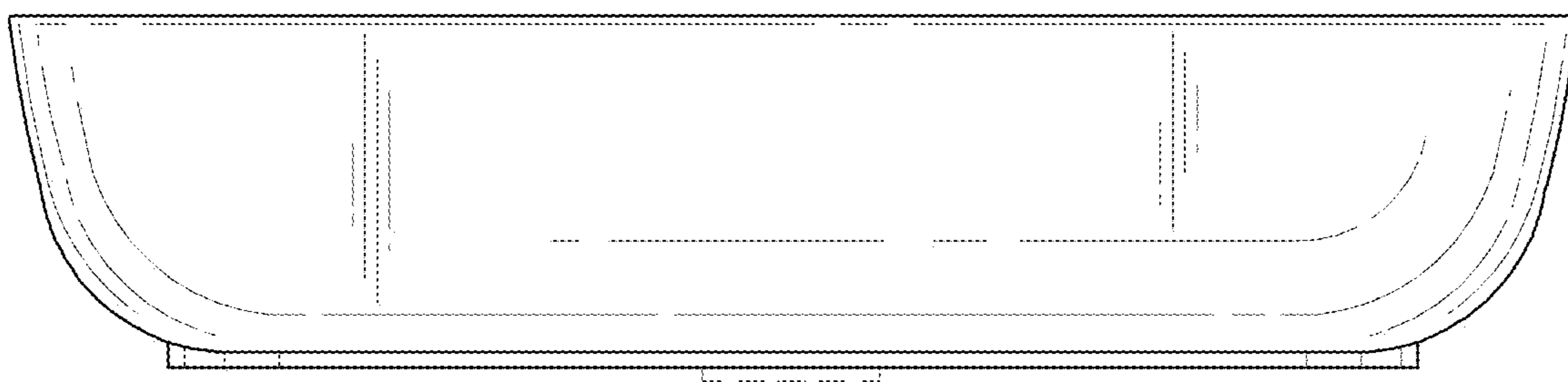

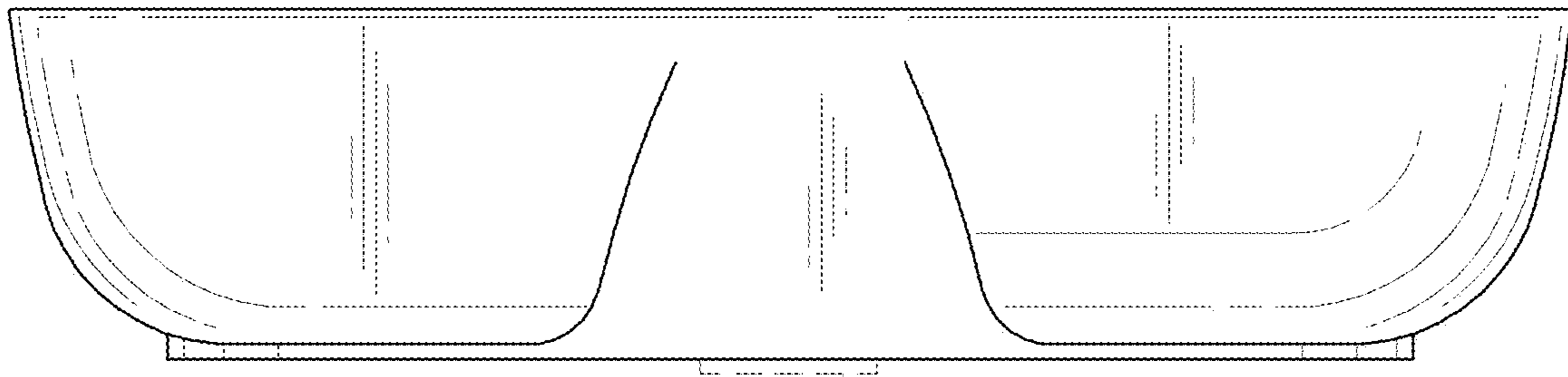

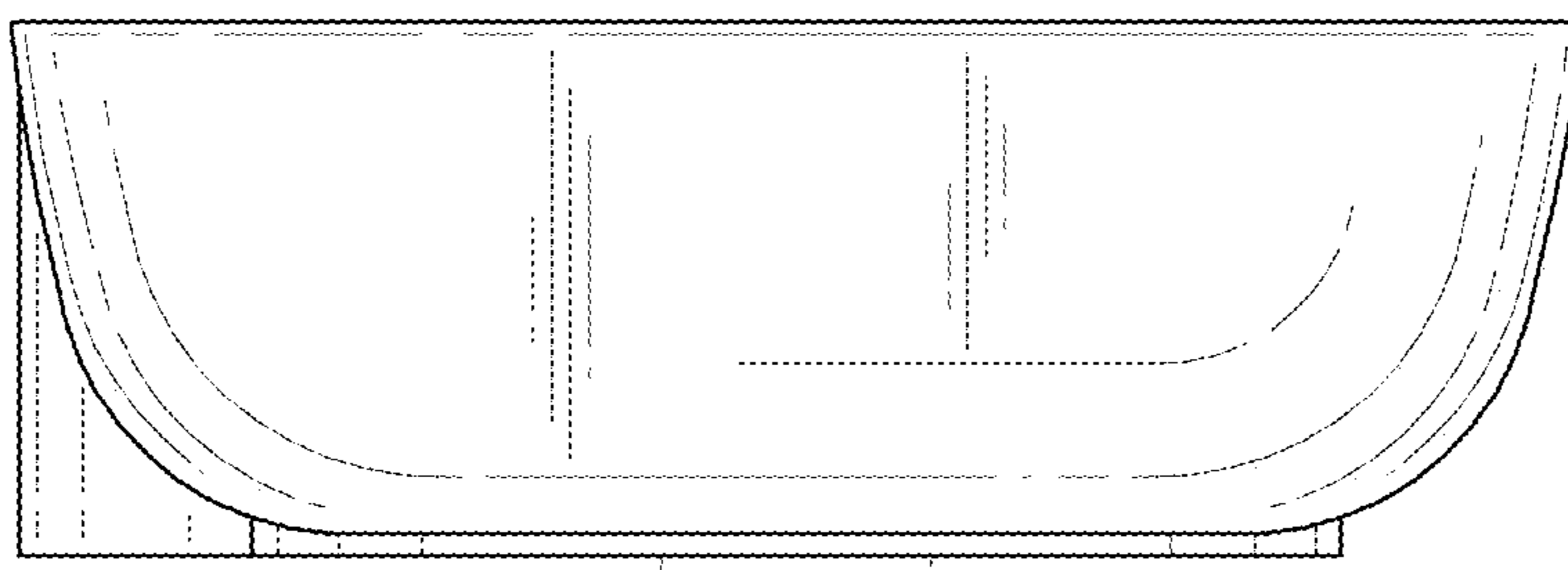

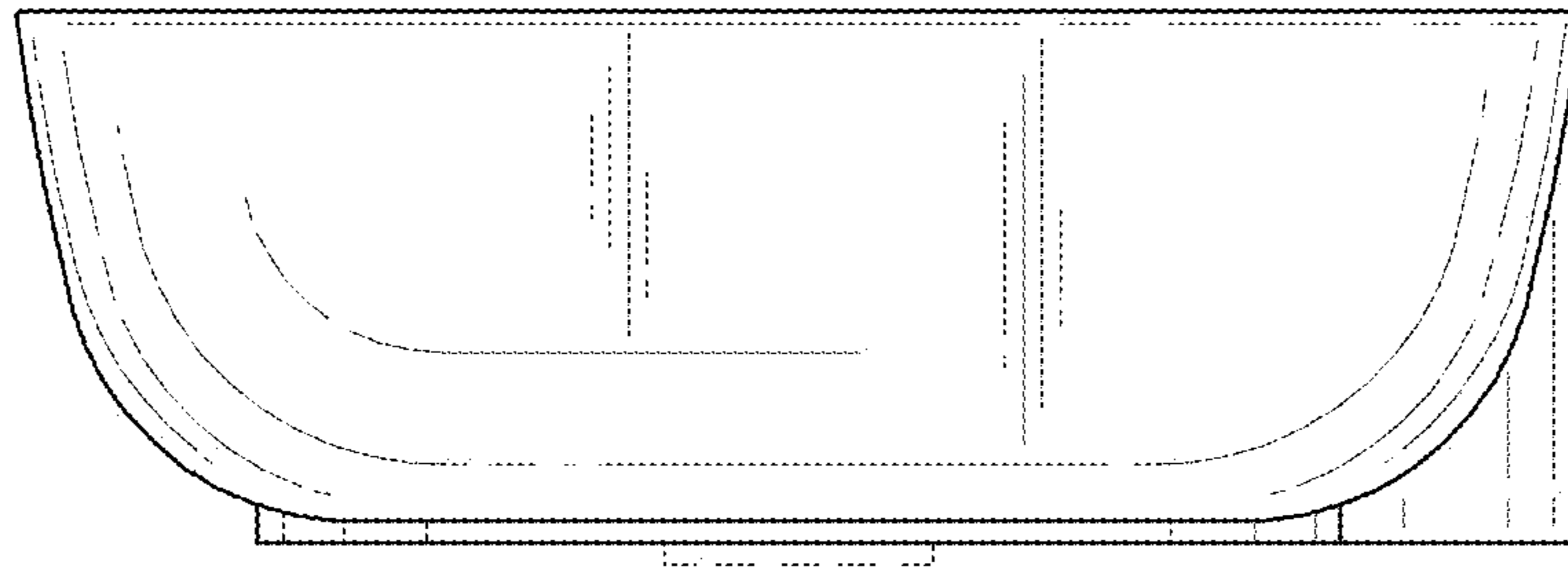

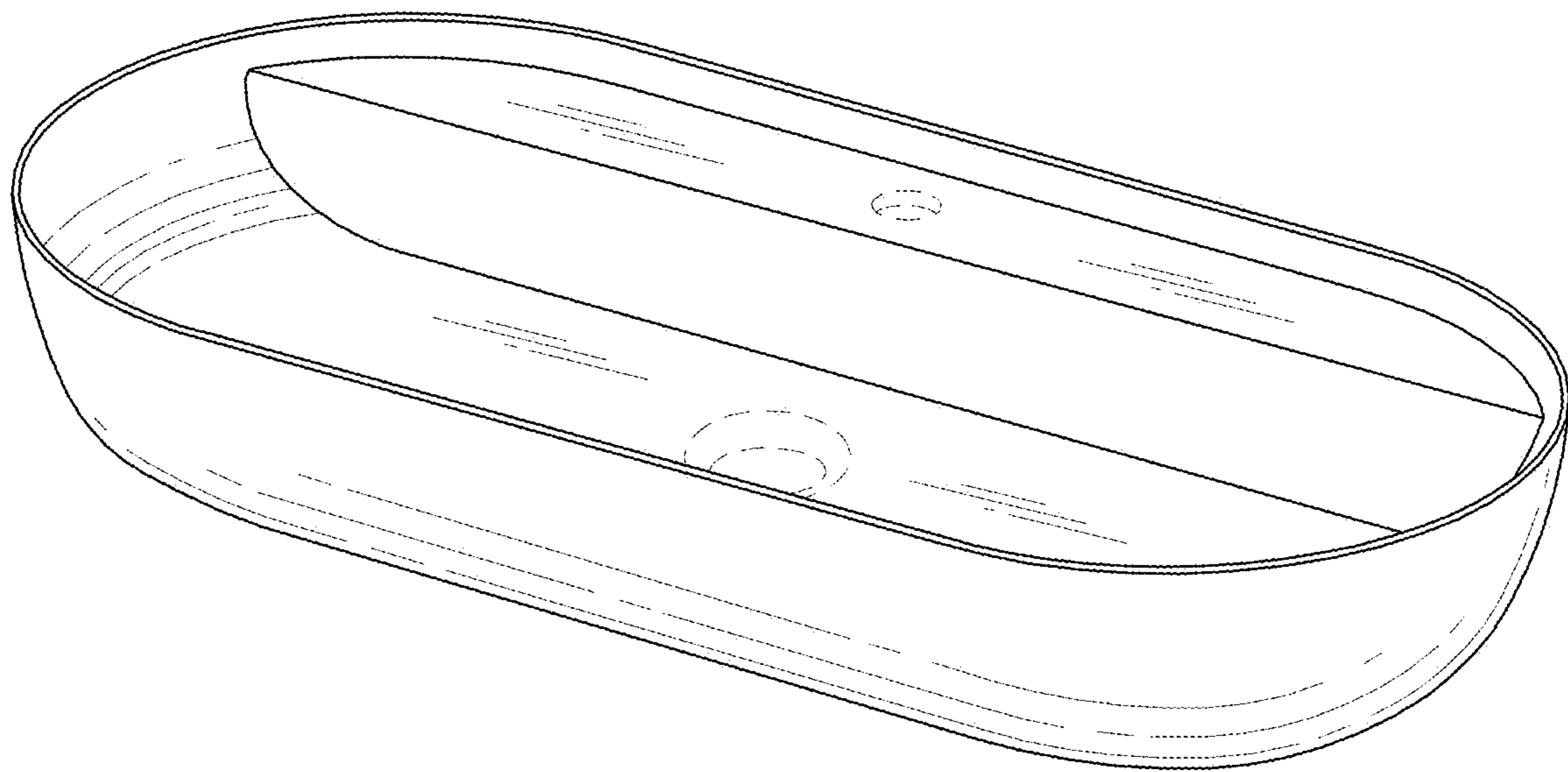

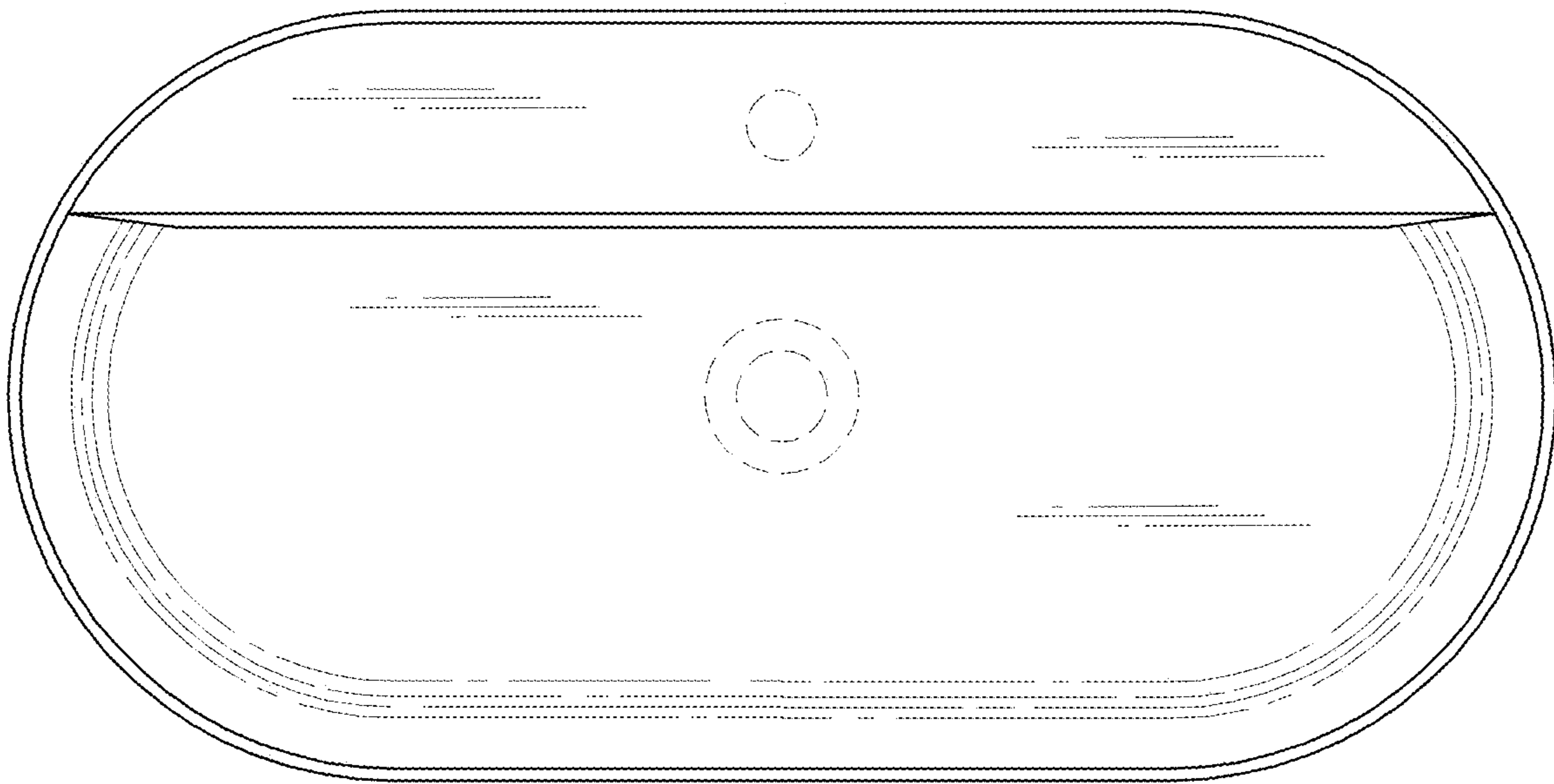

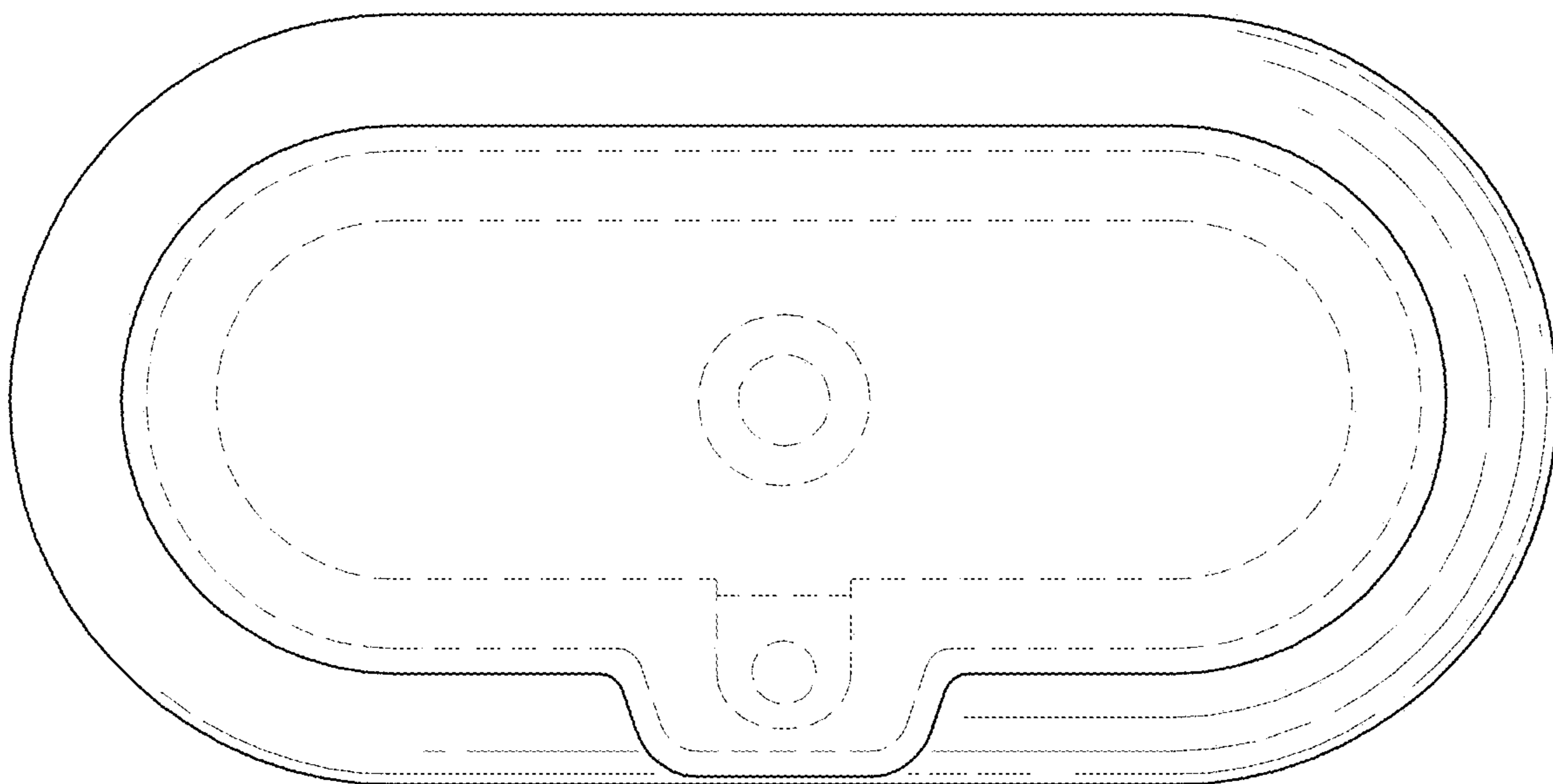
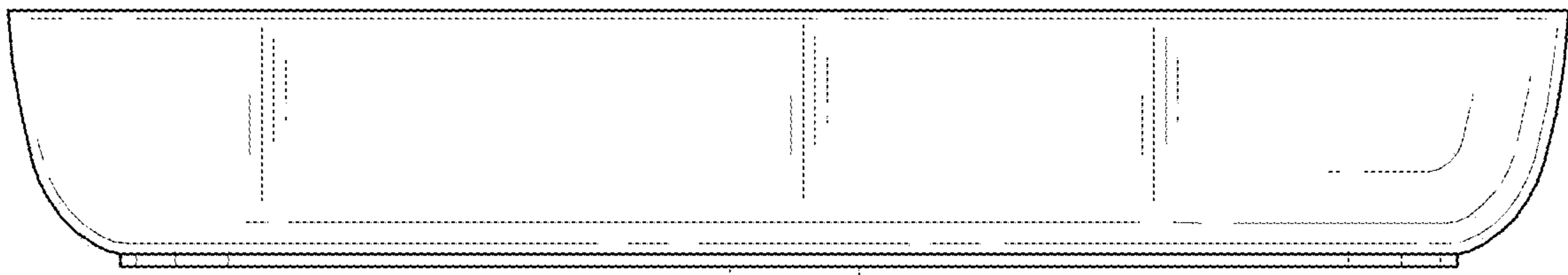
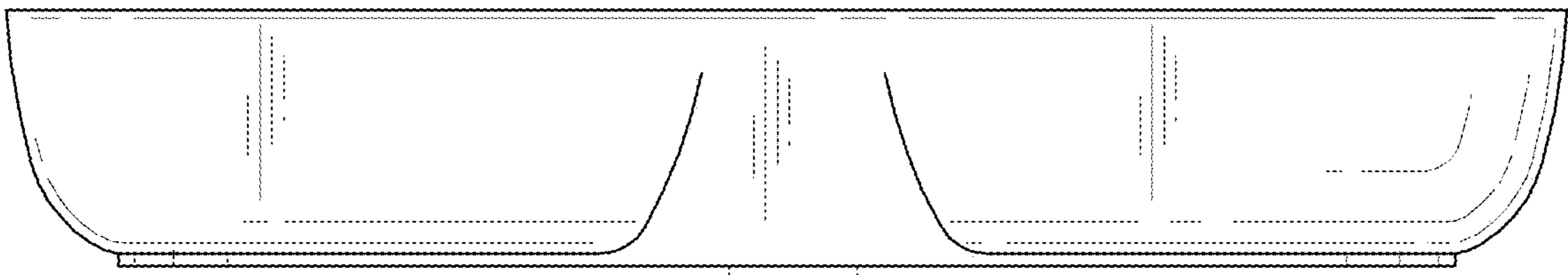

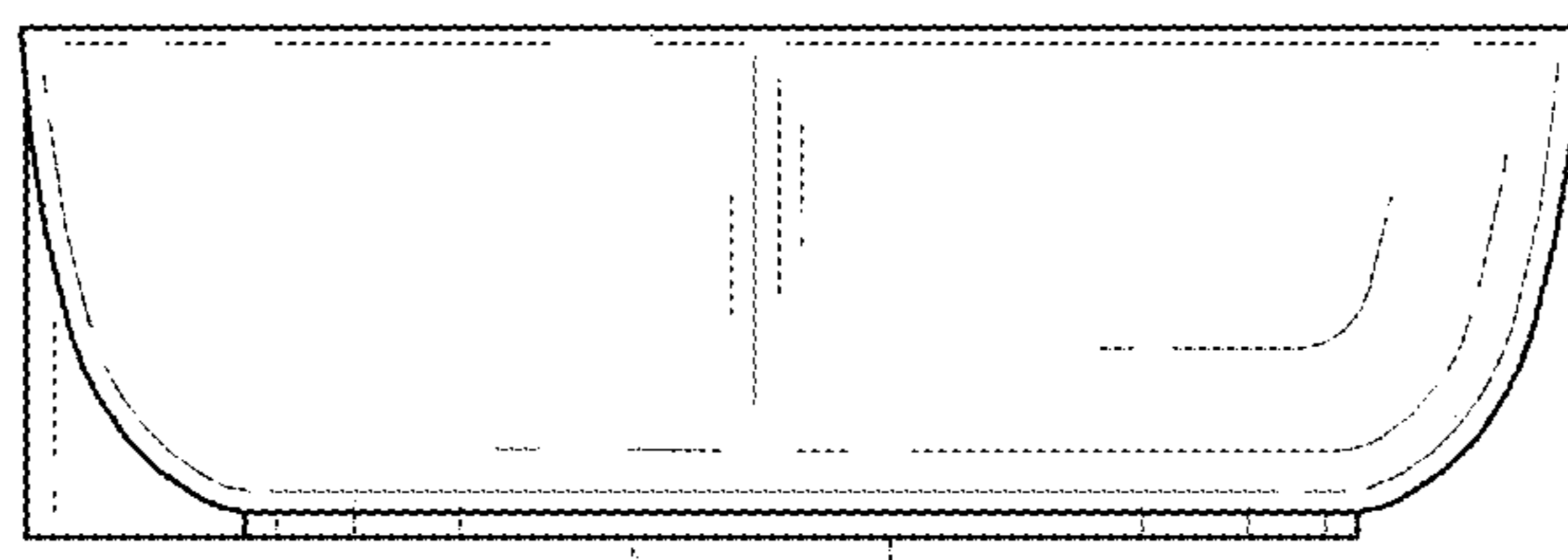

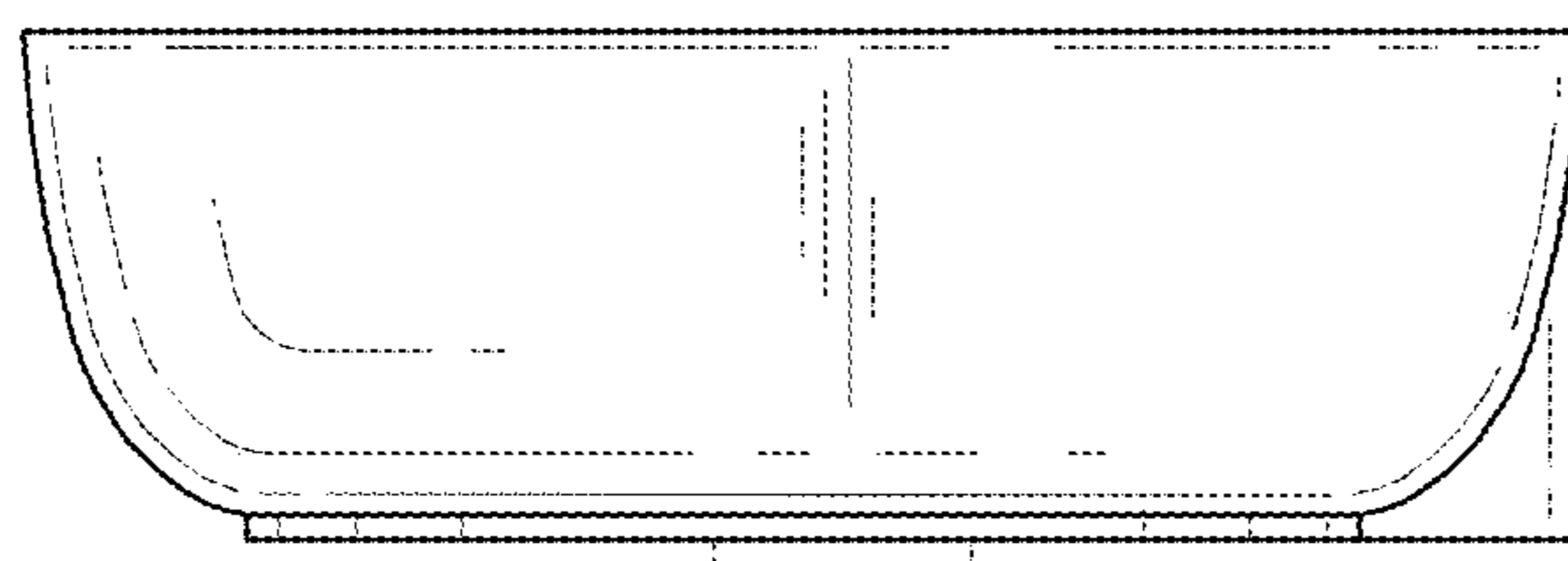
