FIG. 4 is a left side view illustration thereof.

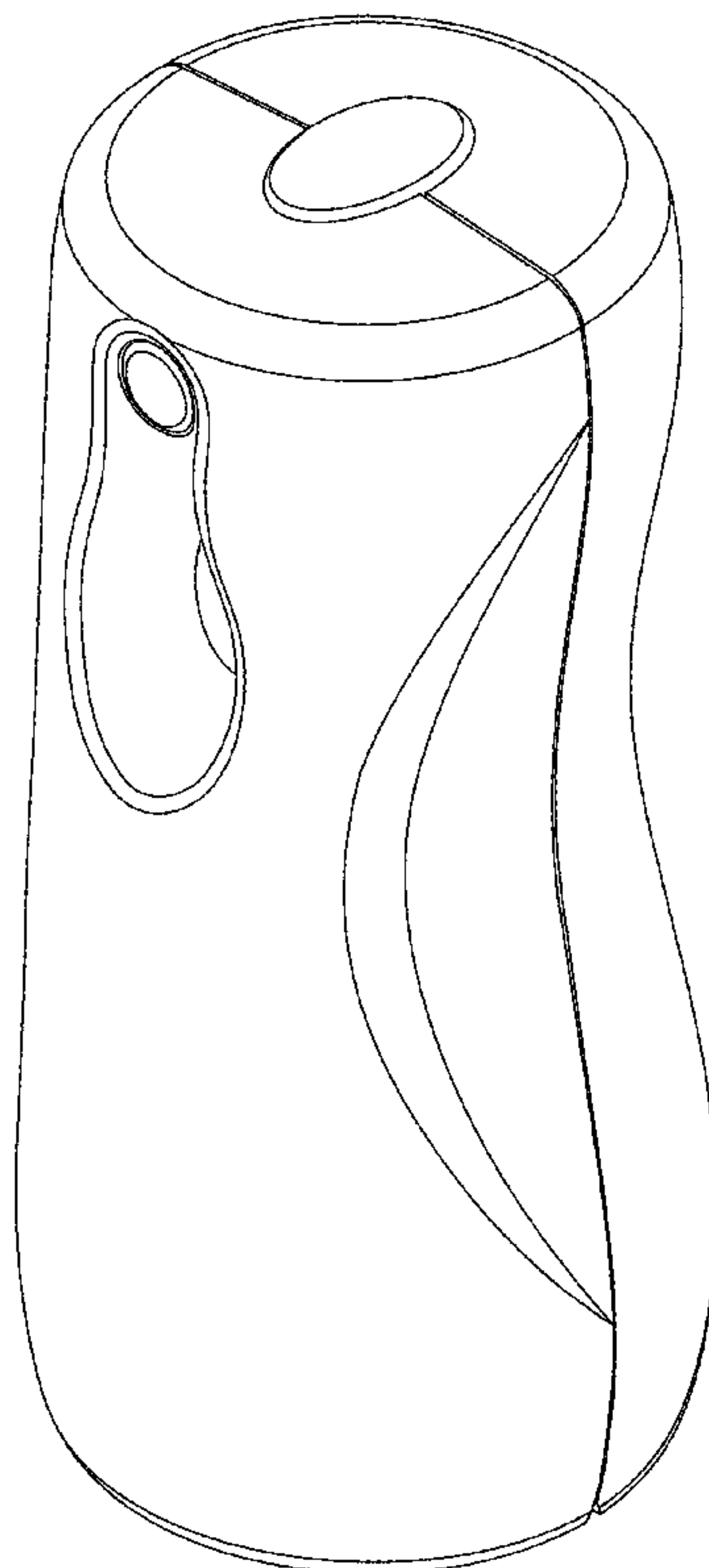
FIG. 5 is a rear view illustration thereof.

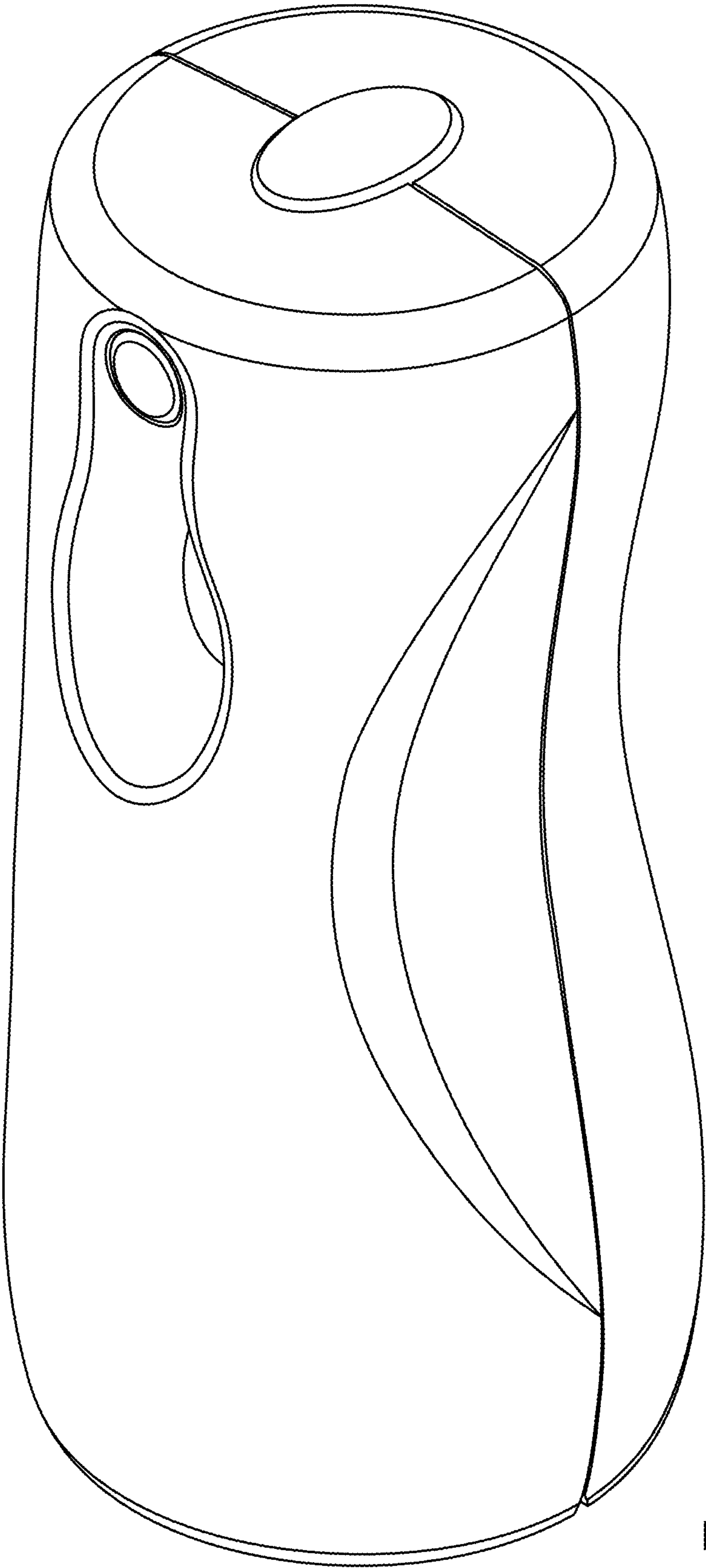

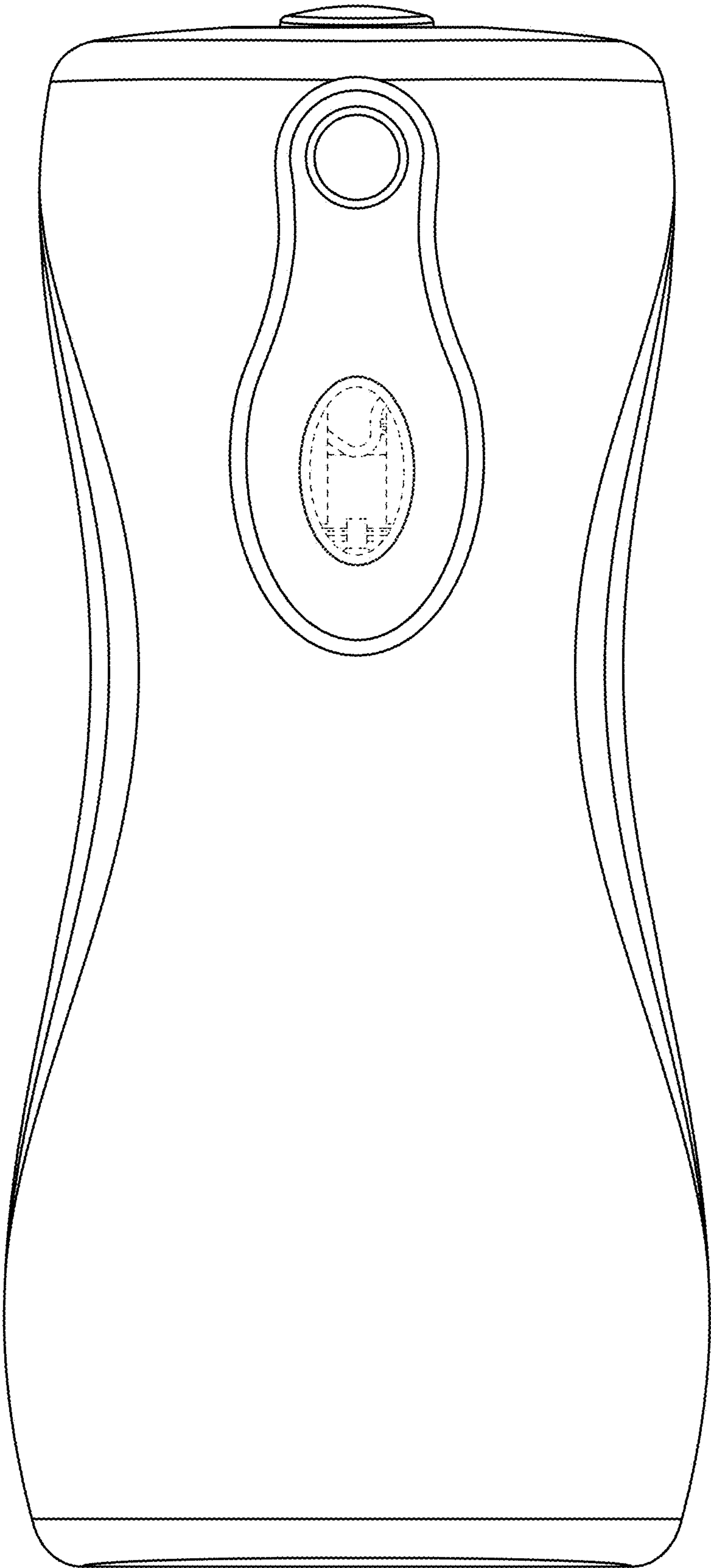

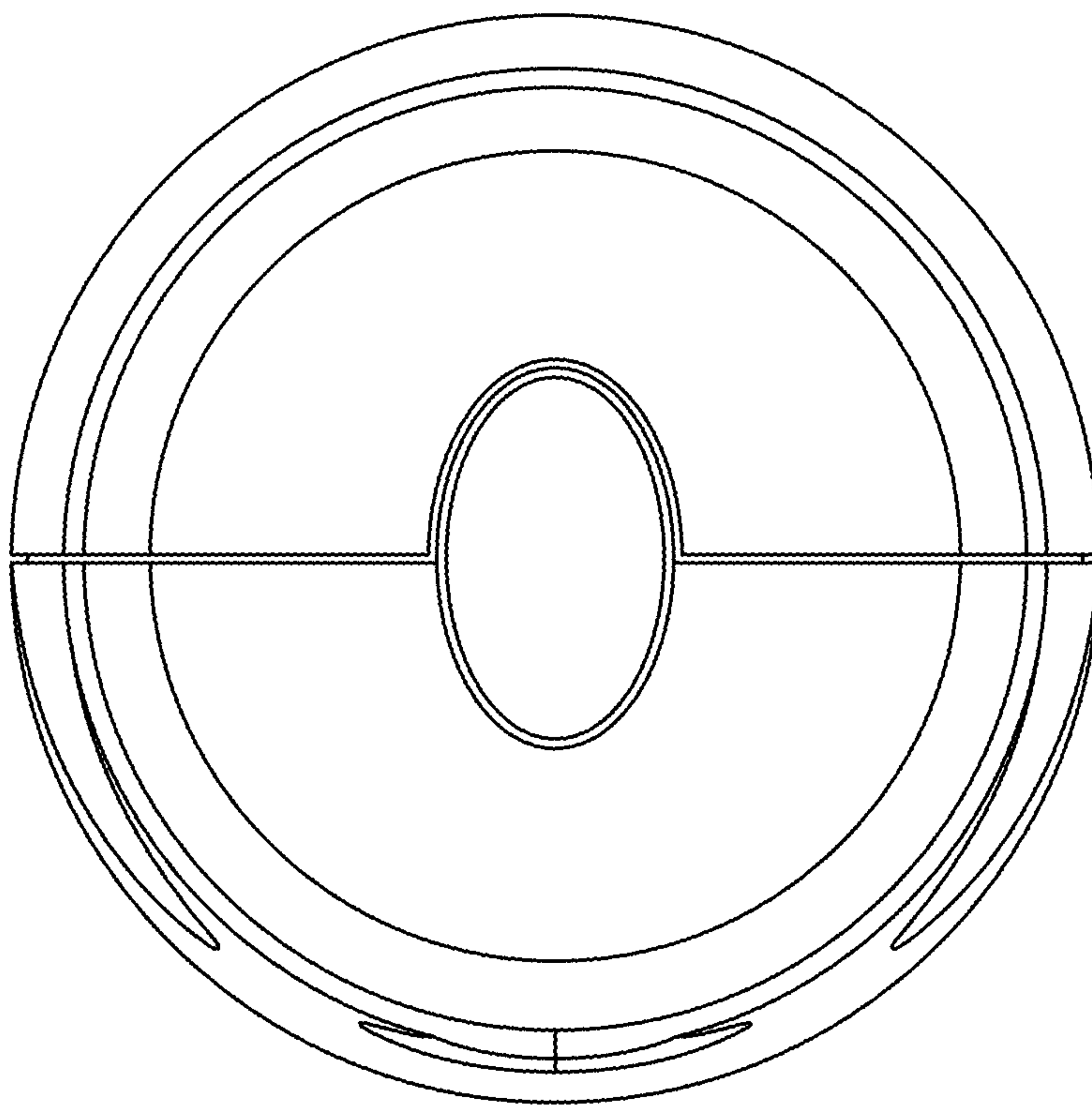

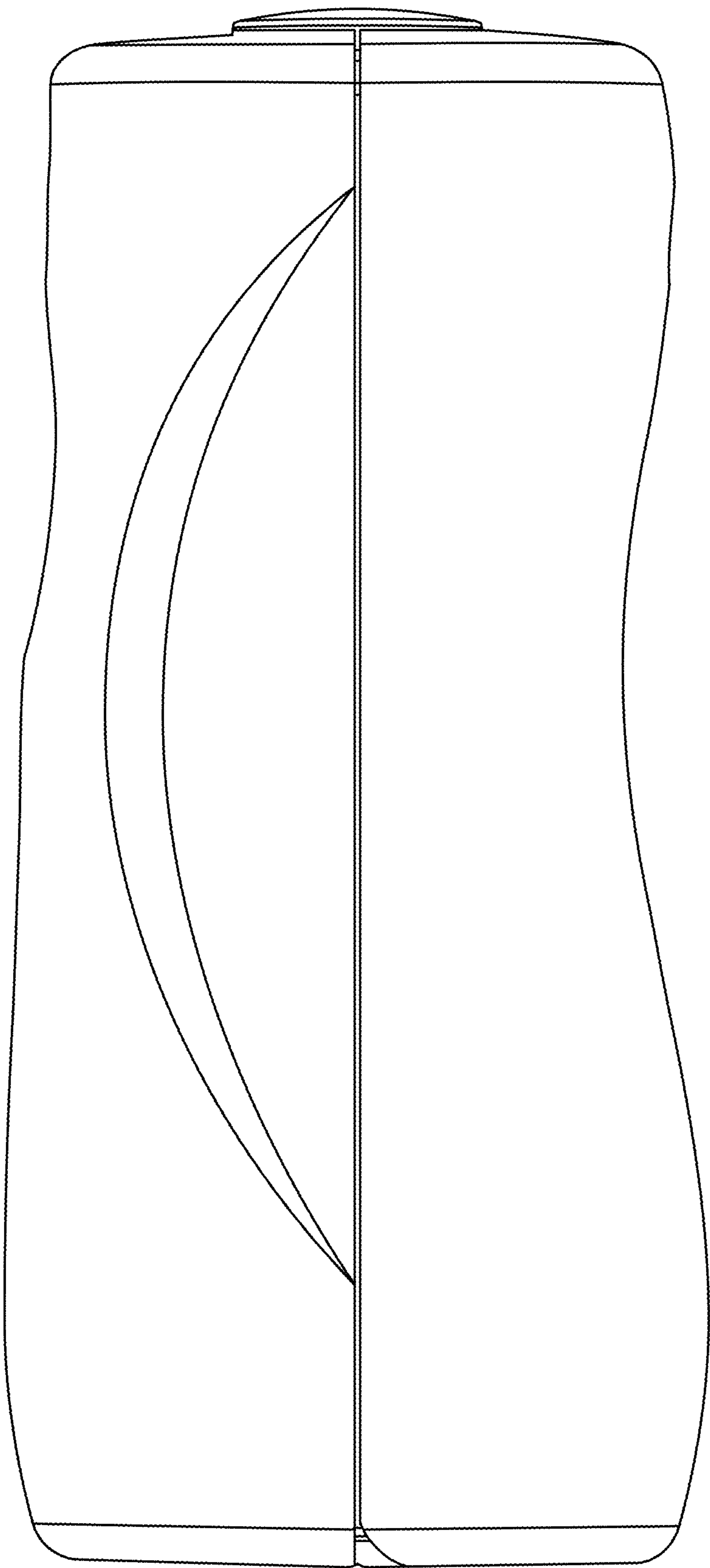

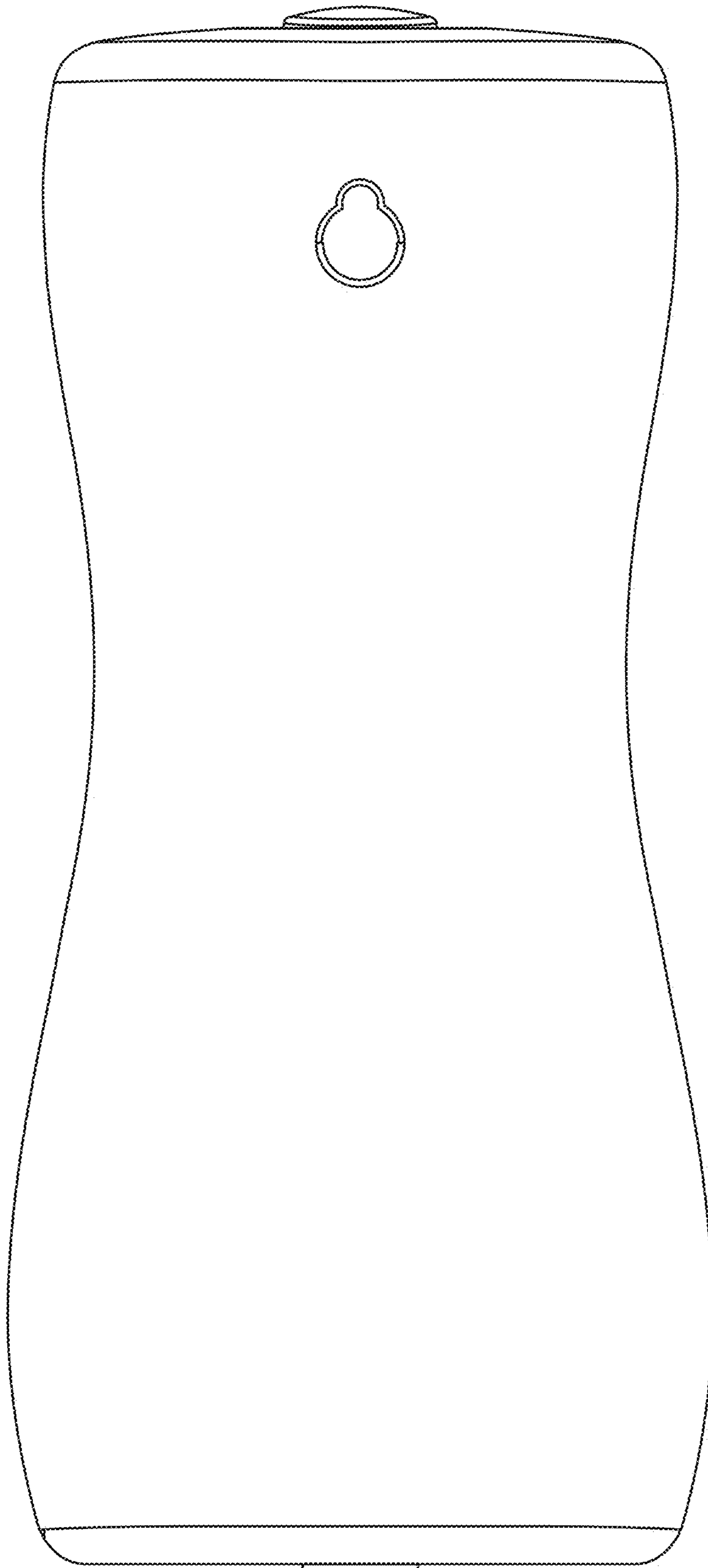

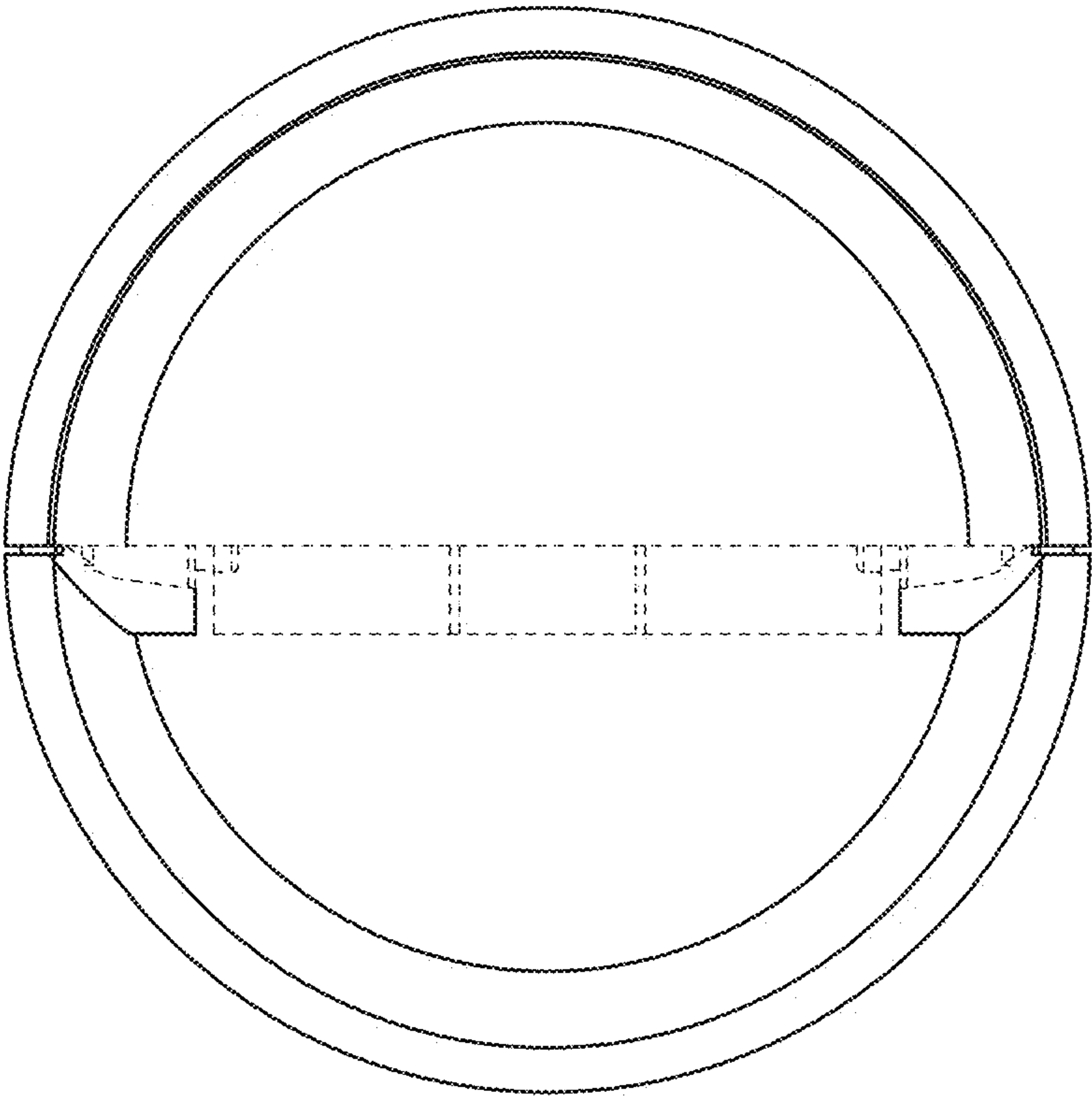

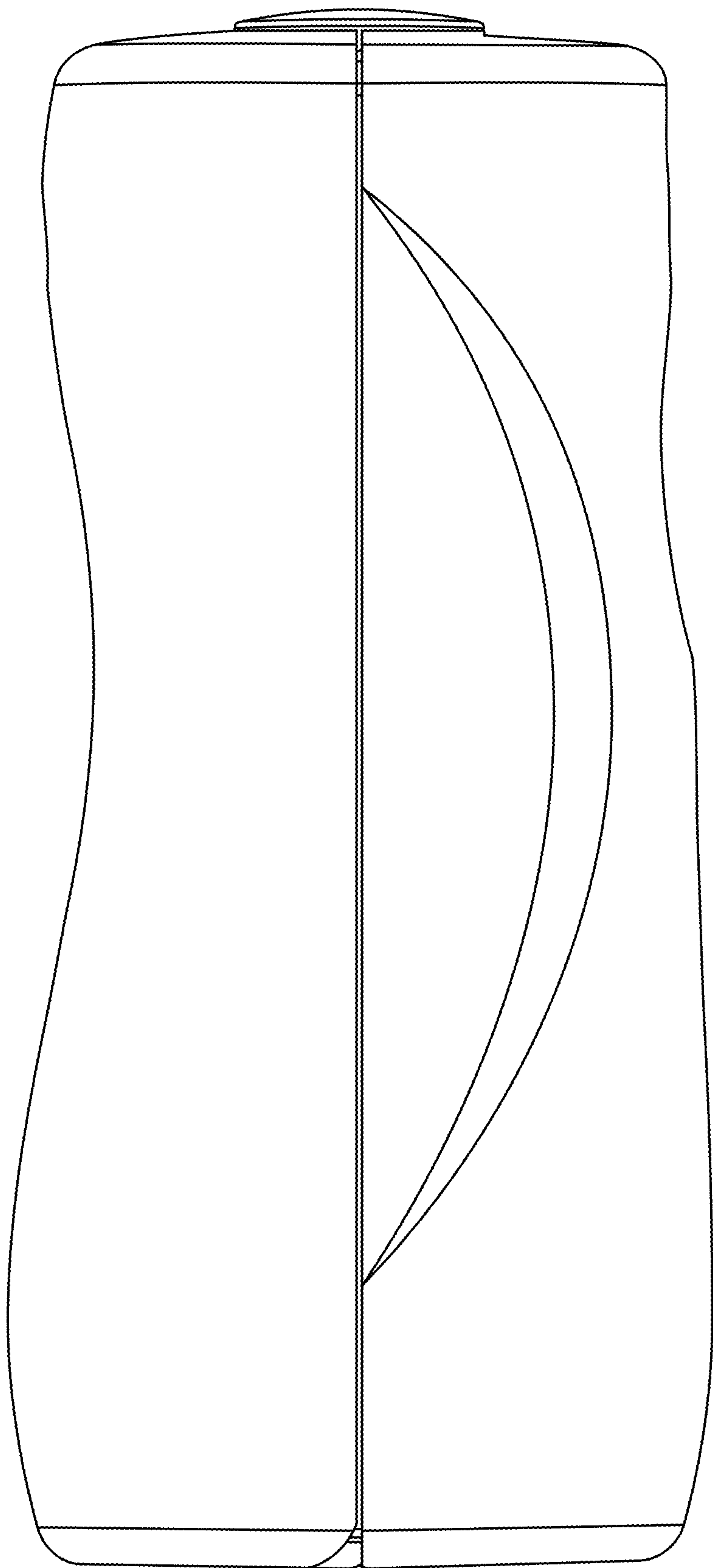
