(57) **CLAIM**

The ornamental design for a pendant luminaire with louvers, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pendant luminaire with louvers of the invention, with suspension supports and a billiard table being shown in broken lines that form no part of the claimed design.

FIG. 2 is a bottom perspective view of the pendant luminaire with louvers of FIG. 1.

FIG. 3 is a top view of the pendant luminaire with louvers of FIG. 1.

FIG. 4 is a bottom view of the pendant luminaire with louvers of FIG. 1.

FIG. 5 is a front or rear elevation view of the pendant luminaire with louvers of FIG. 1.

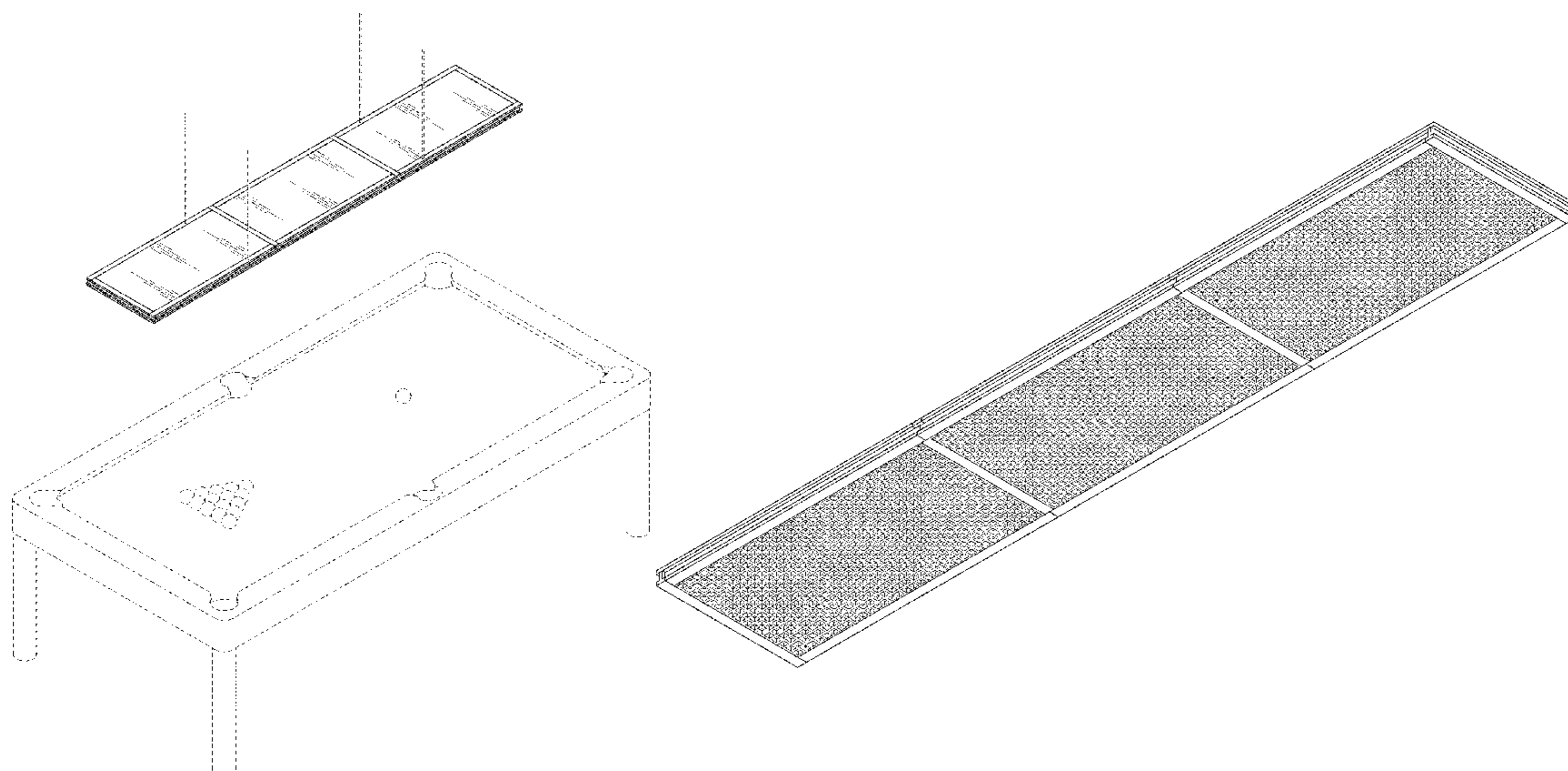
FIG. 7 is a bottom perspective view of an alternate embodiment pendant luminaire with louvers, to be hung as in FIG. 1, comparable to FIG. 2 but wherein two panels are present instead of three panels;

FIG. 6 is a right or left end view of the pendant luminaire with louvers of FIG. 1 or of the alternate embodiment of FIG. 7.

FIG. 8 is a front or rear elevation view of the pendant luminaire with louvers of FIG. 7.

FIG. 9 is a top view of the pendant luminaire with louvers of FIG. 7; and,

FIG. 10 is a bottom view of the pendant luminaire with louvers of FIG. 7.

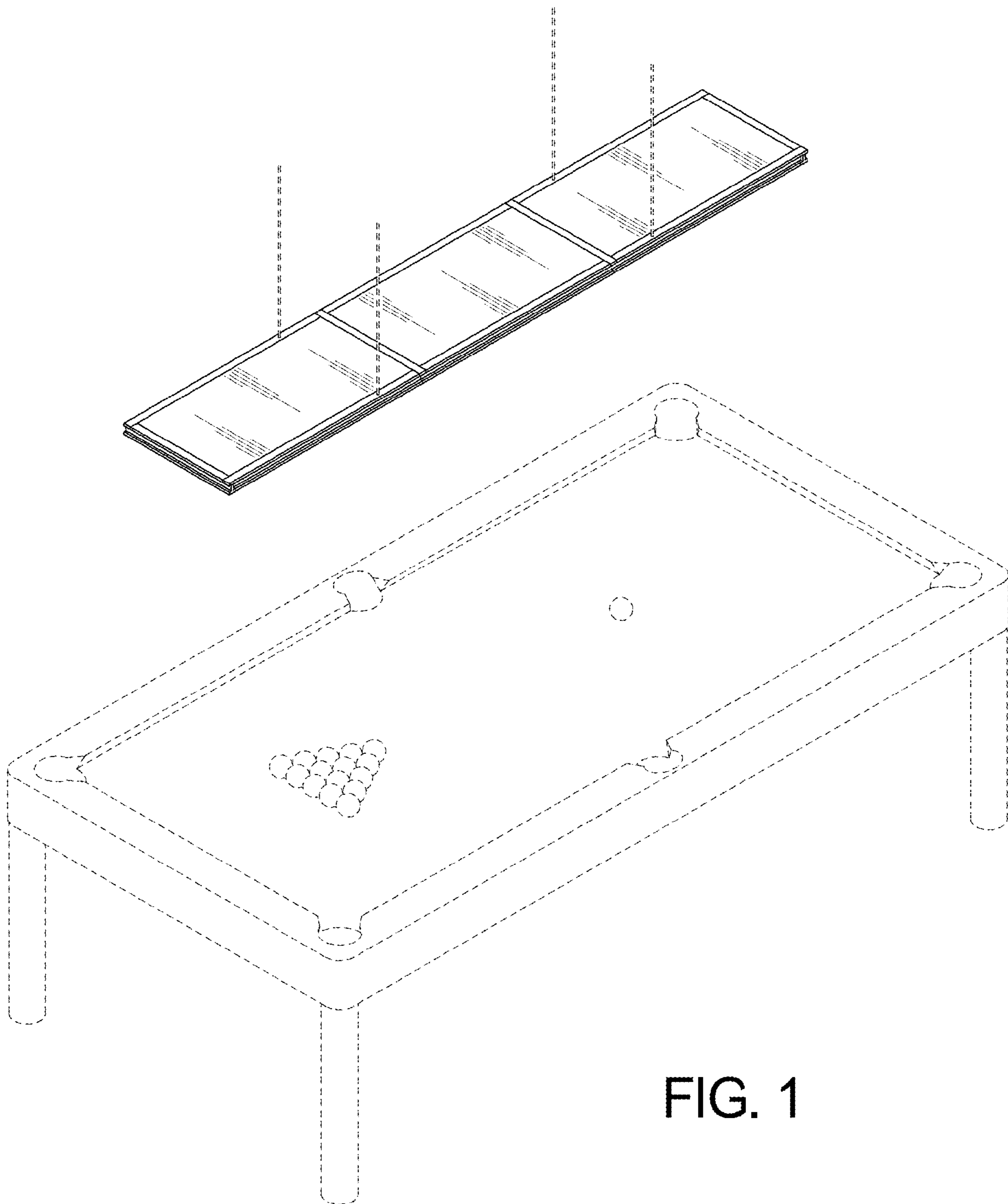

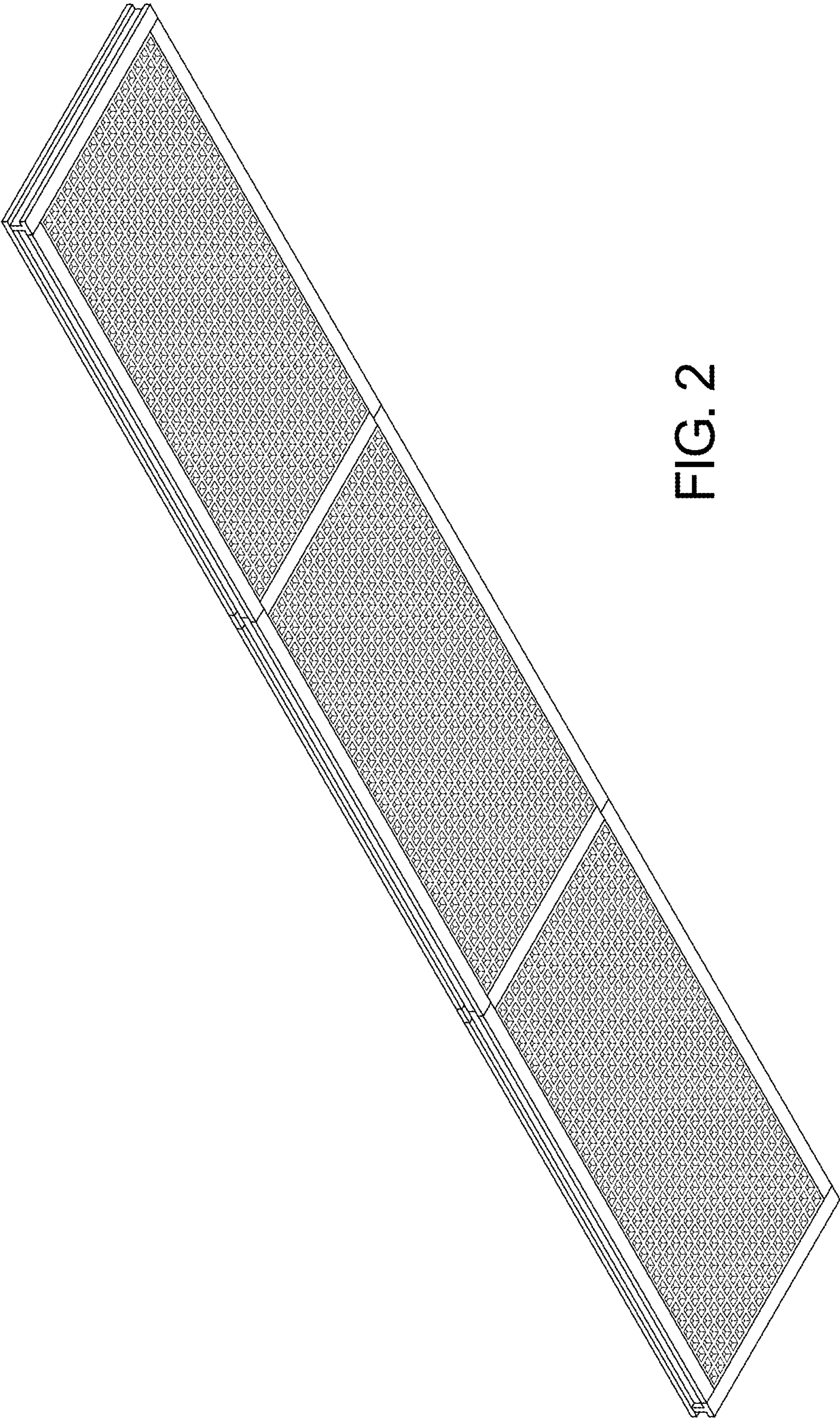

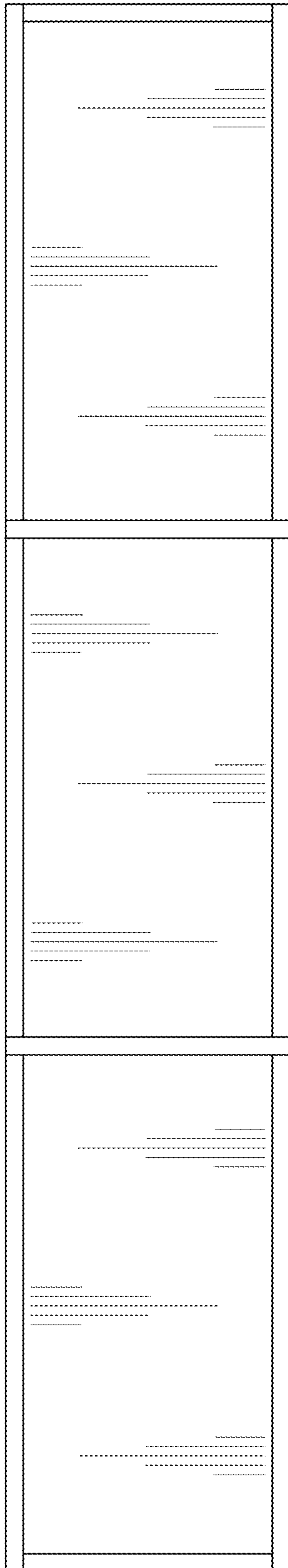

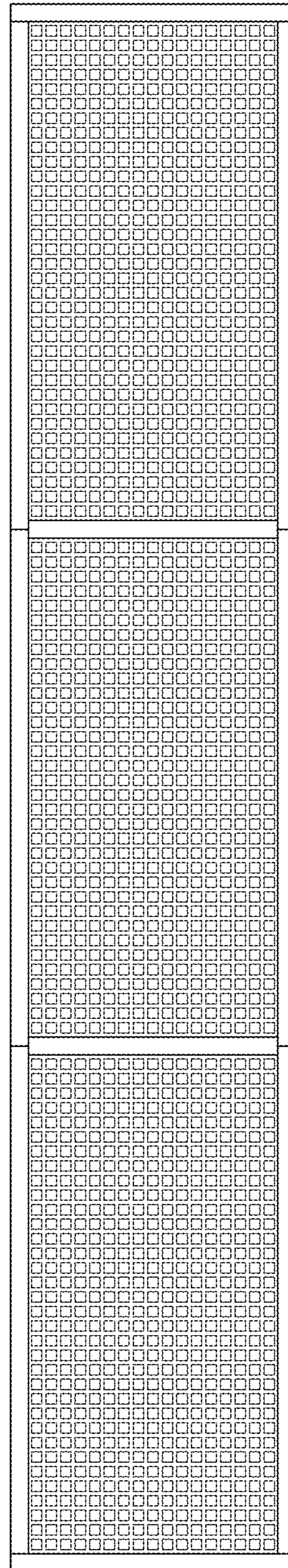

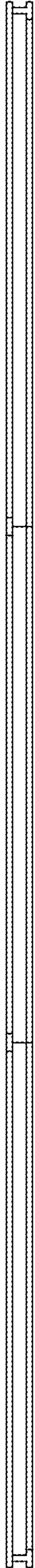

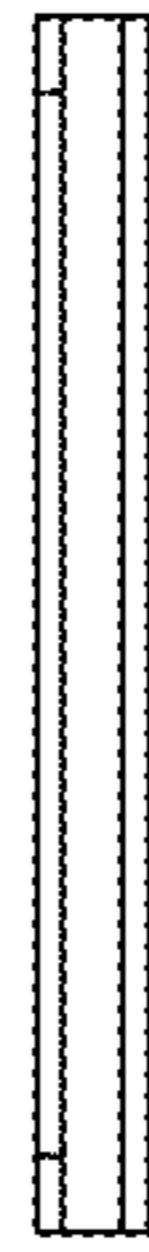

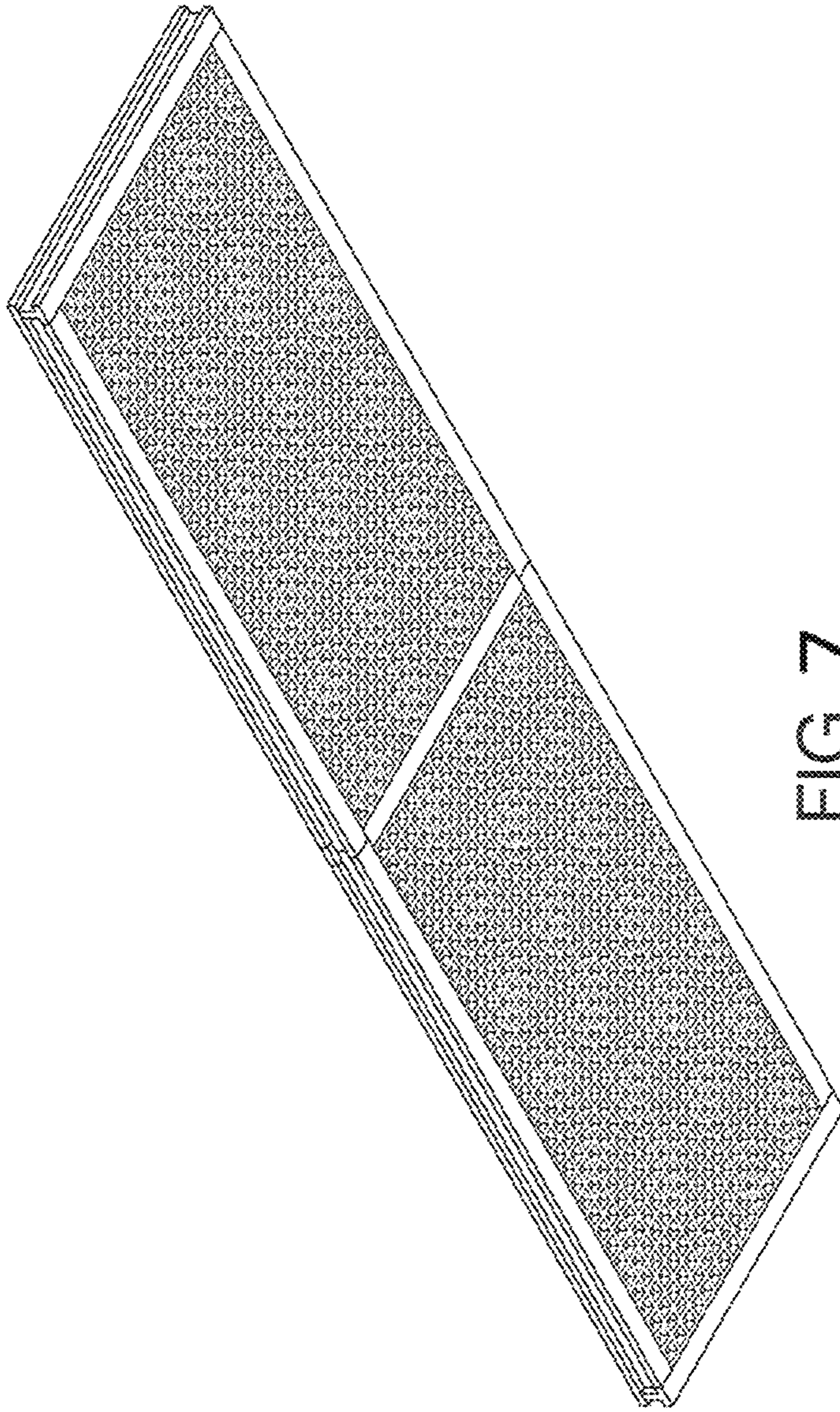

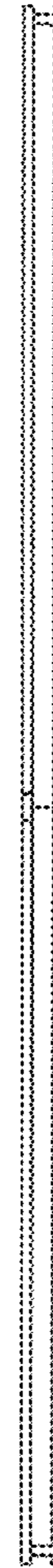

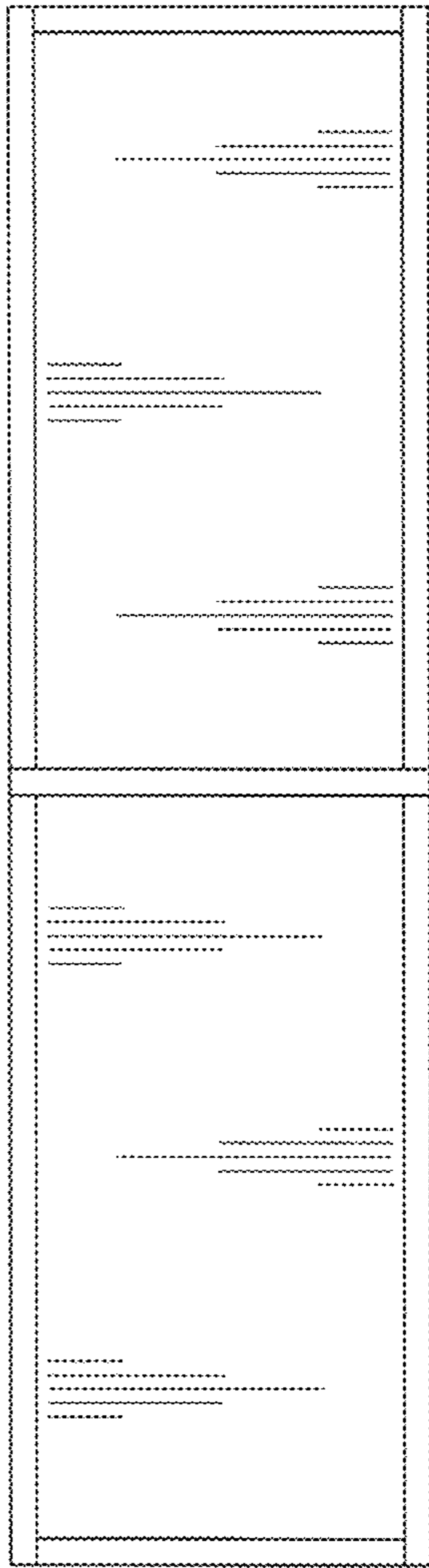

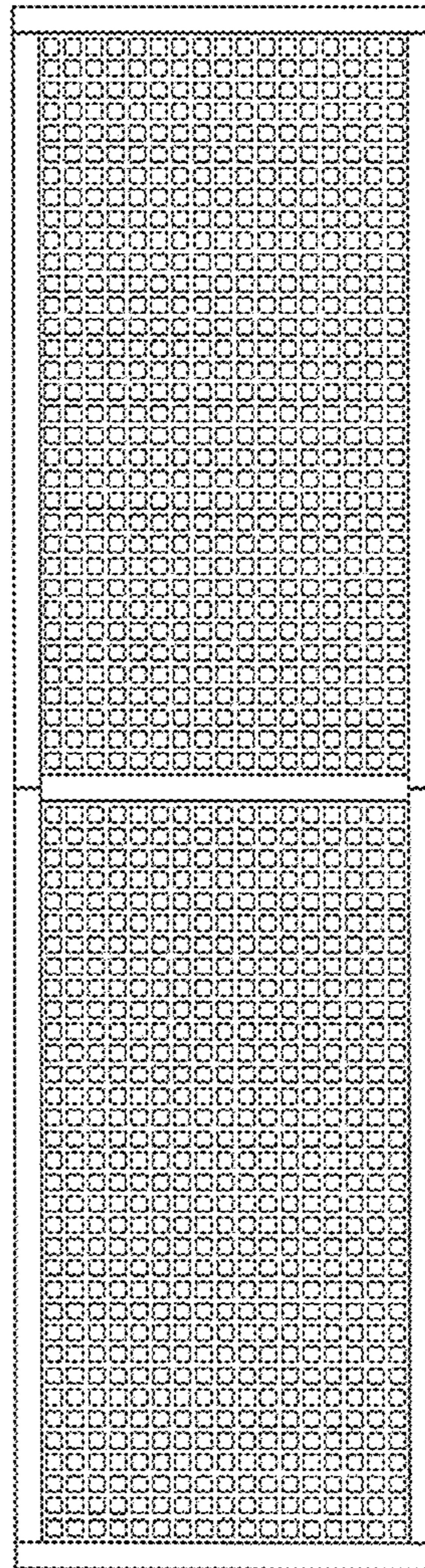
