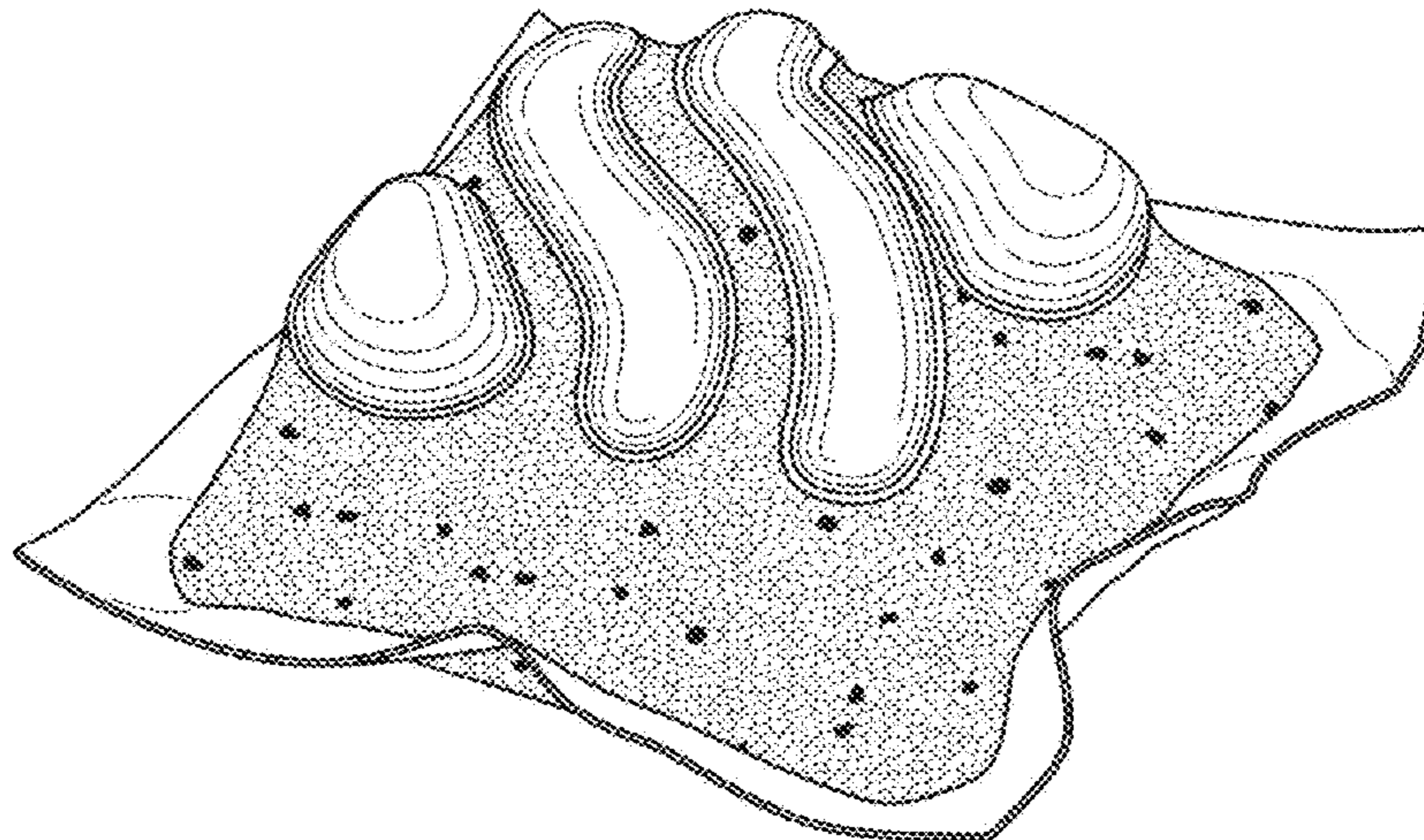


FIG. 20 is a top plan view of the third detergent capsule; and,

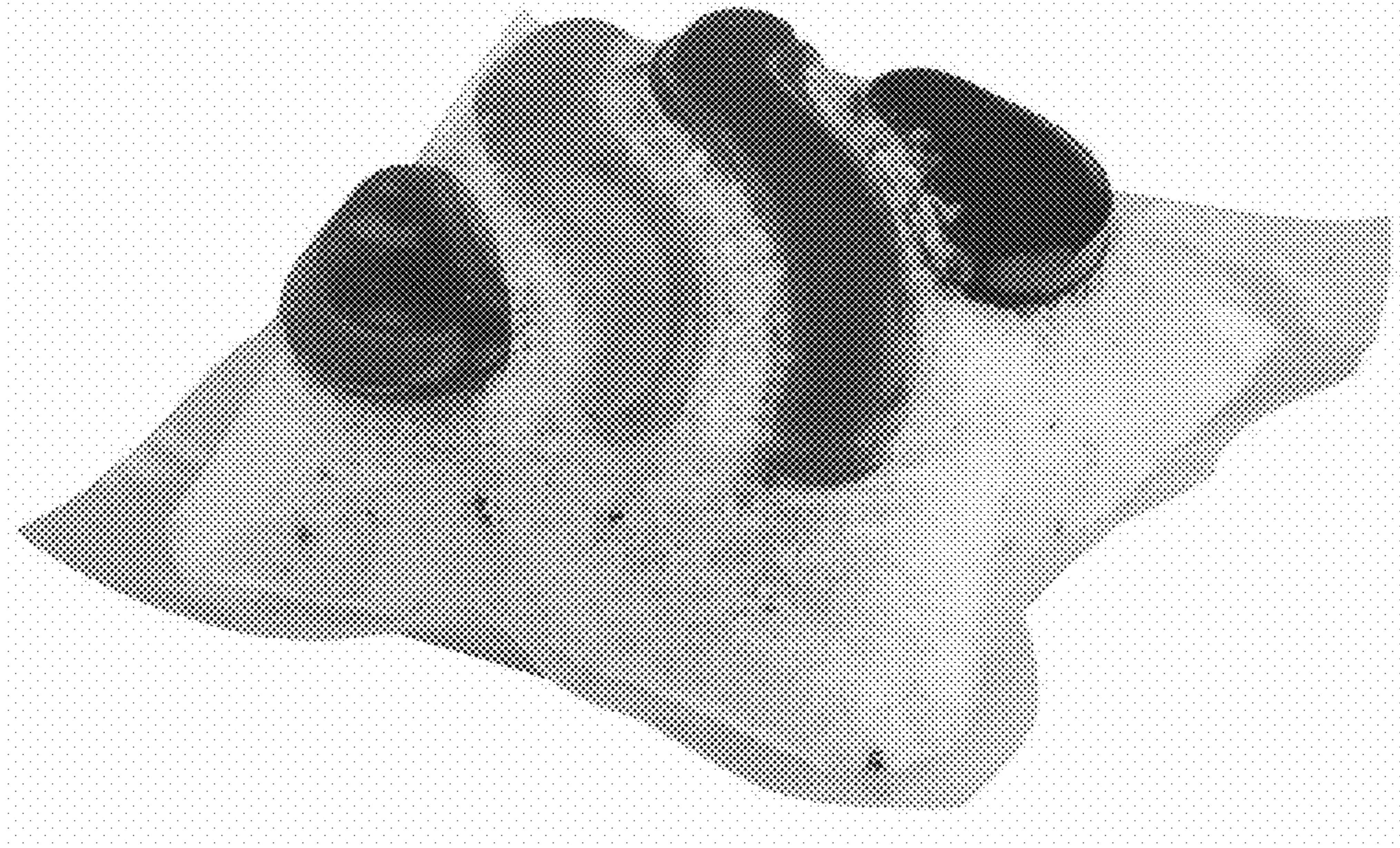

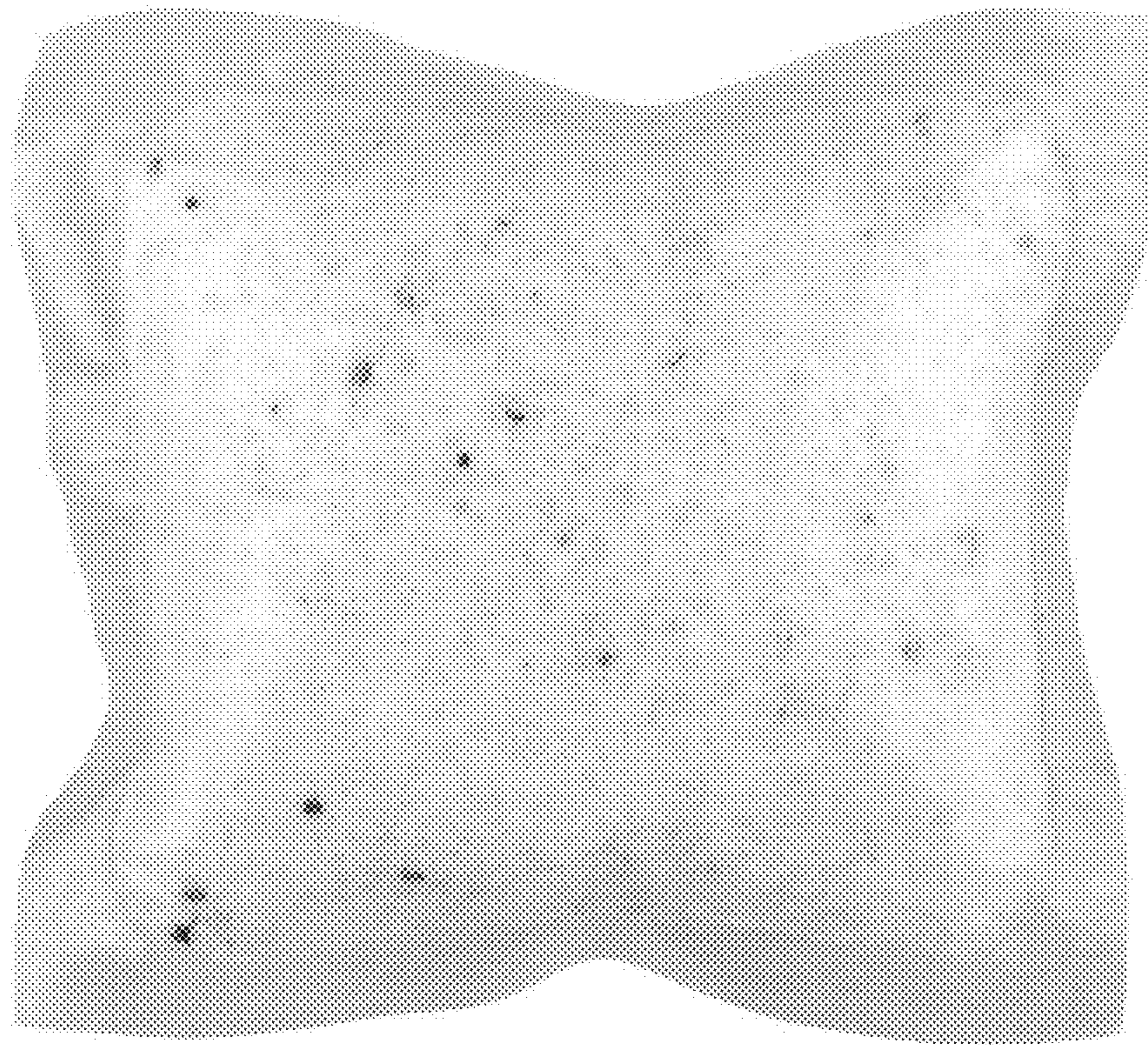

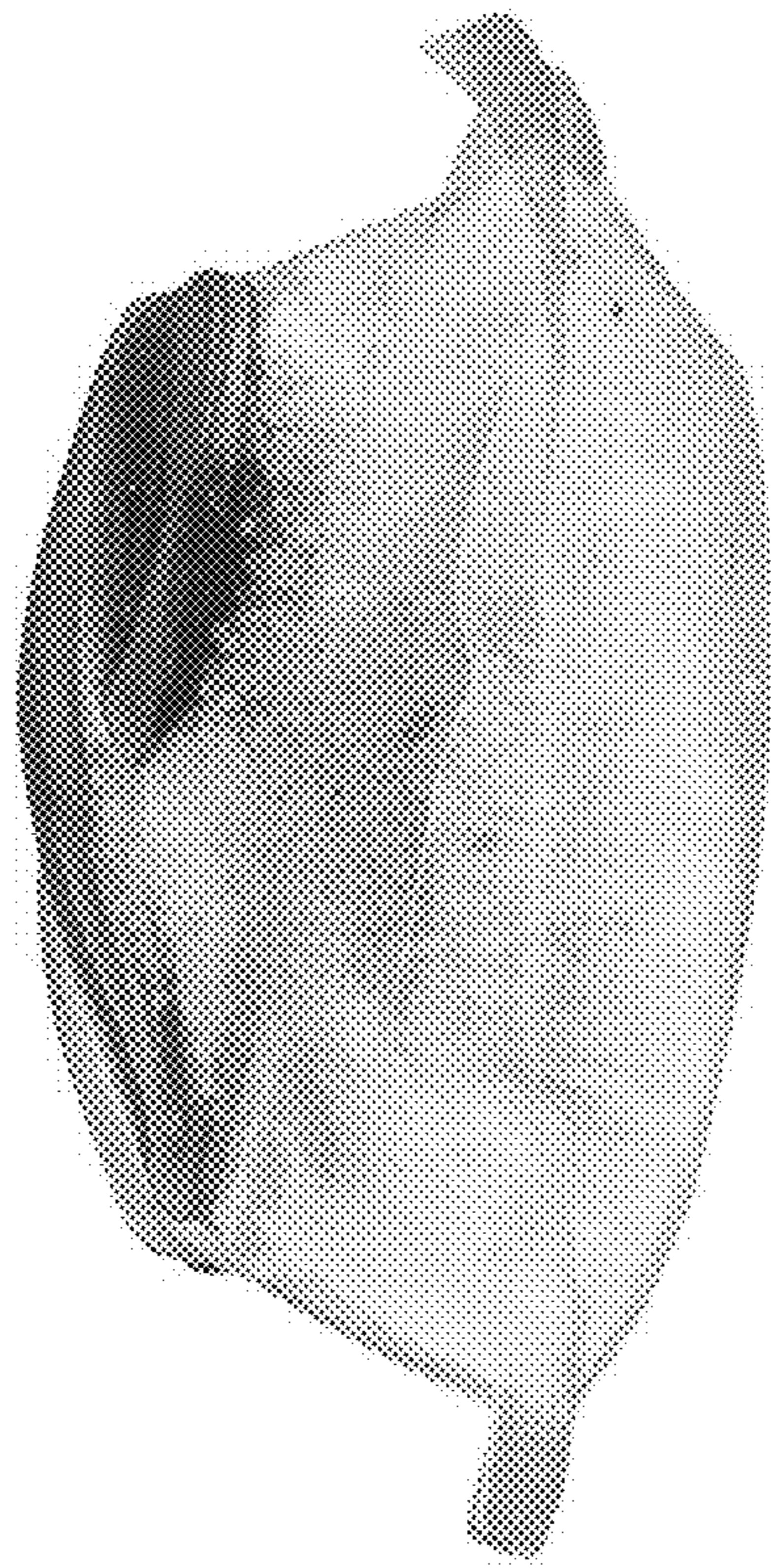

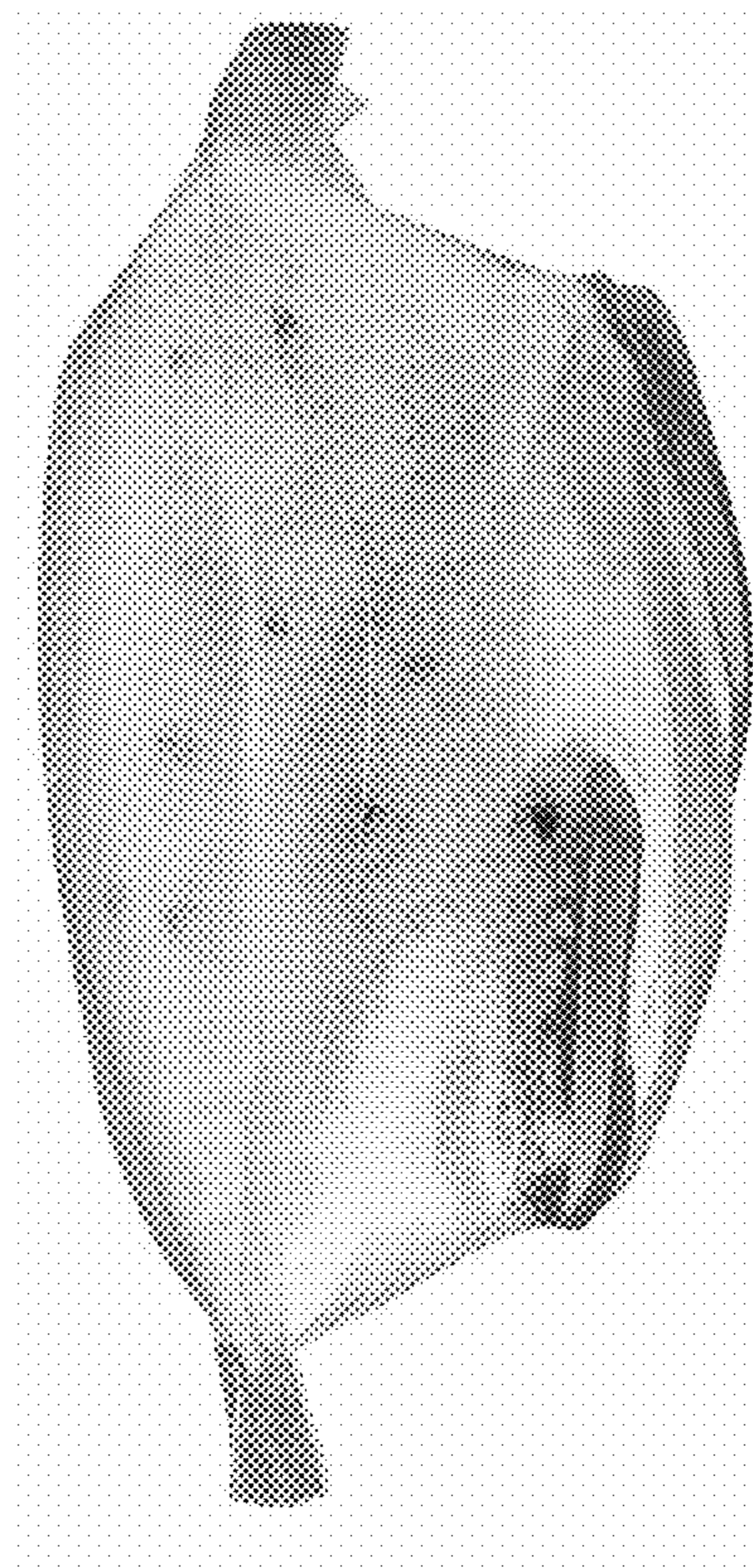

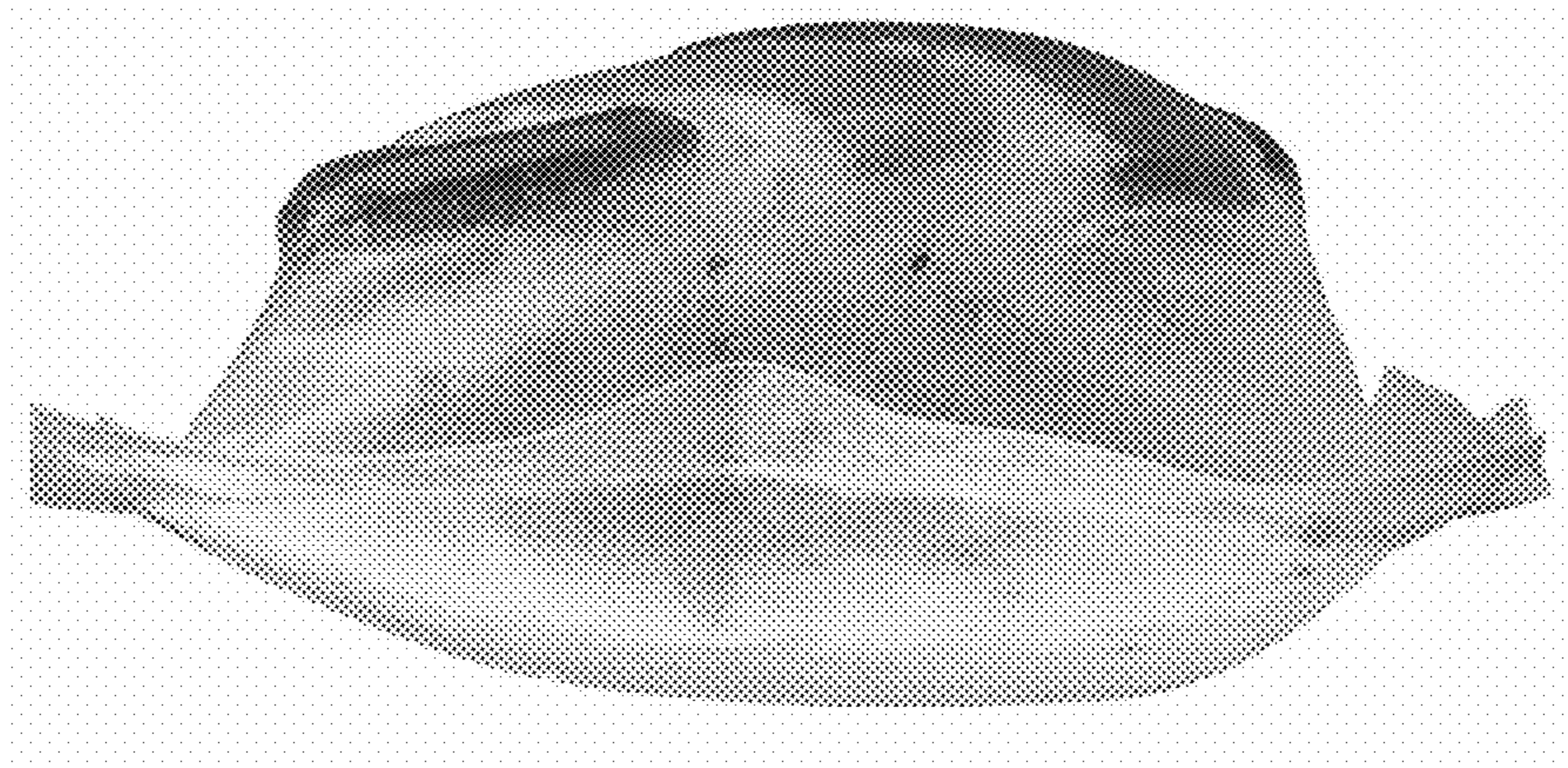

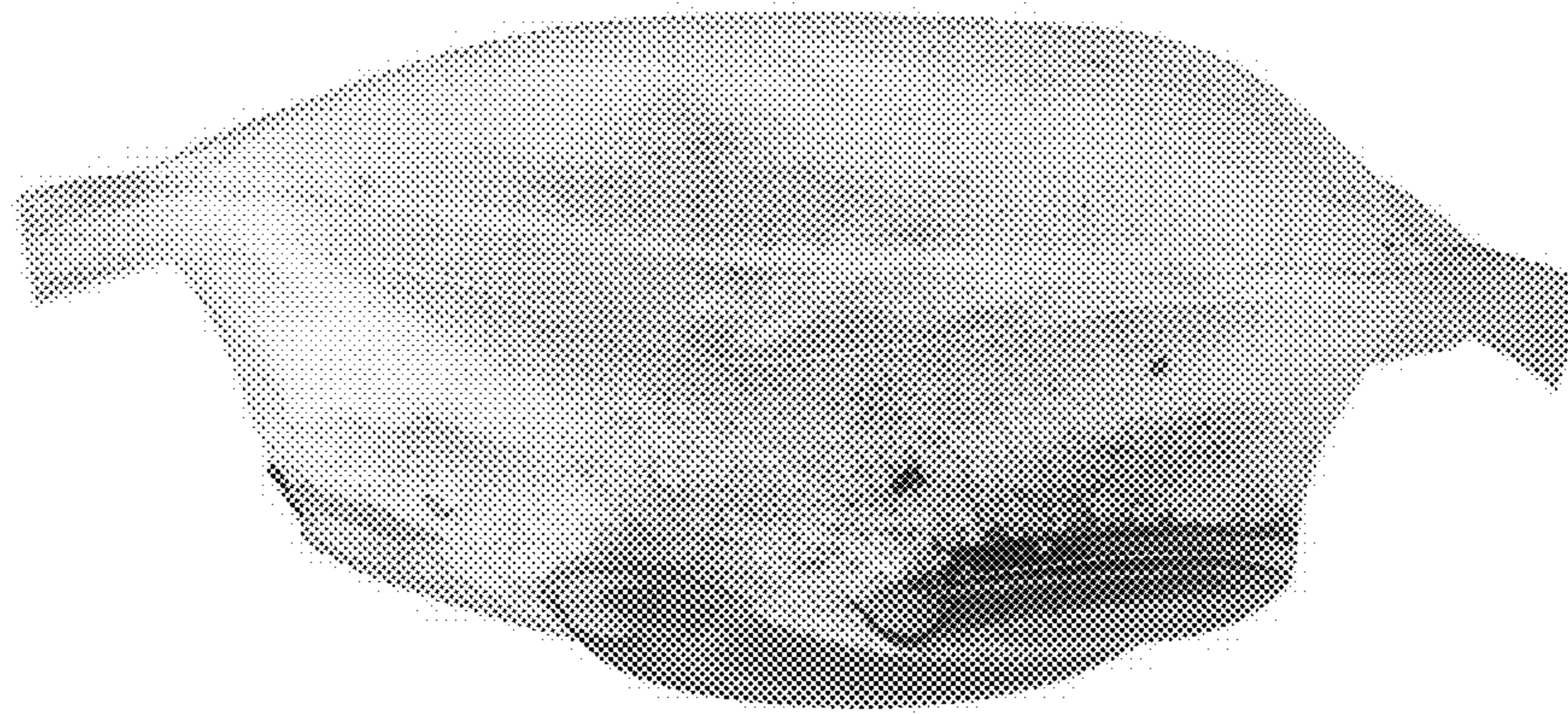

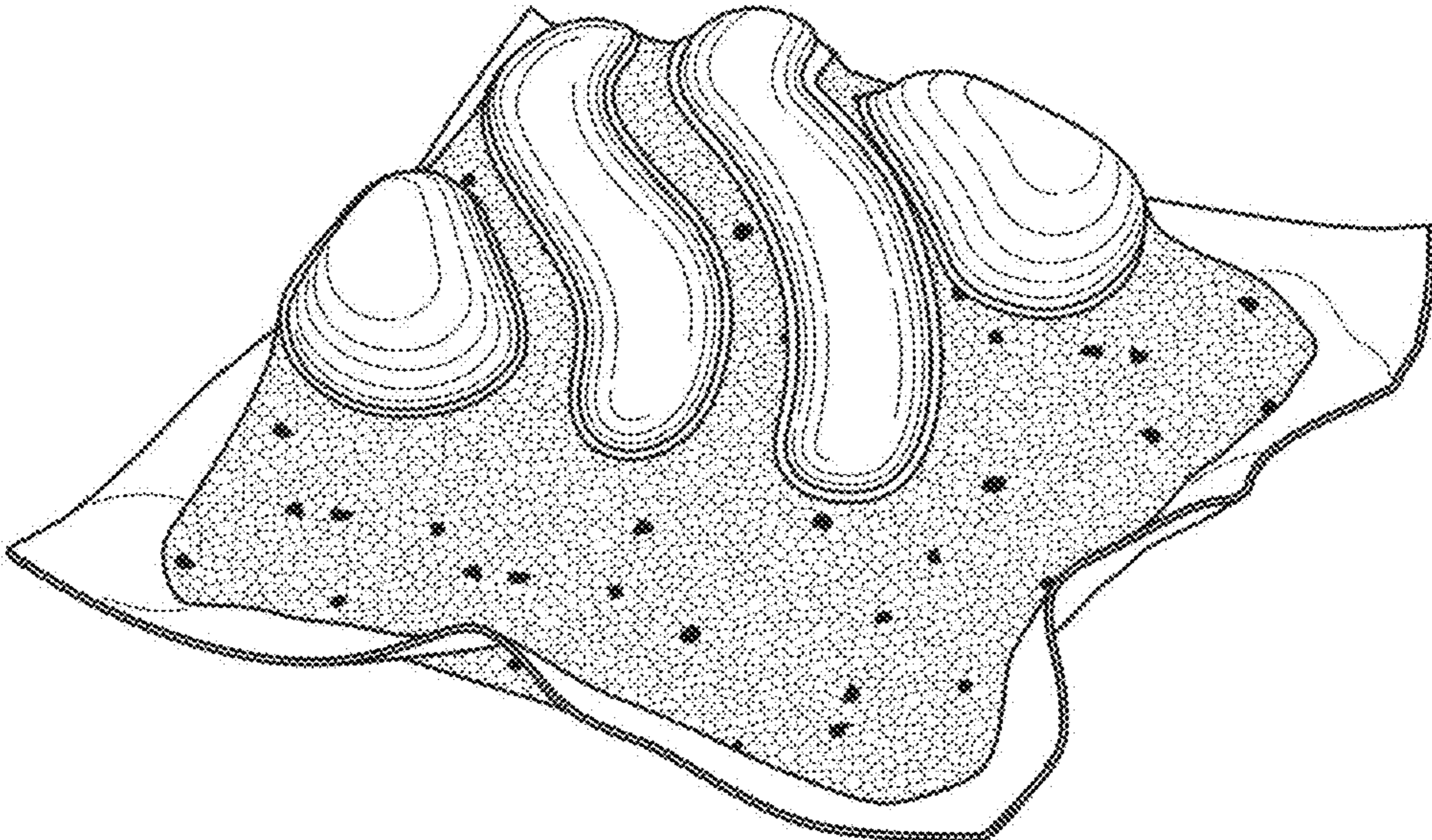

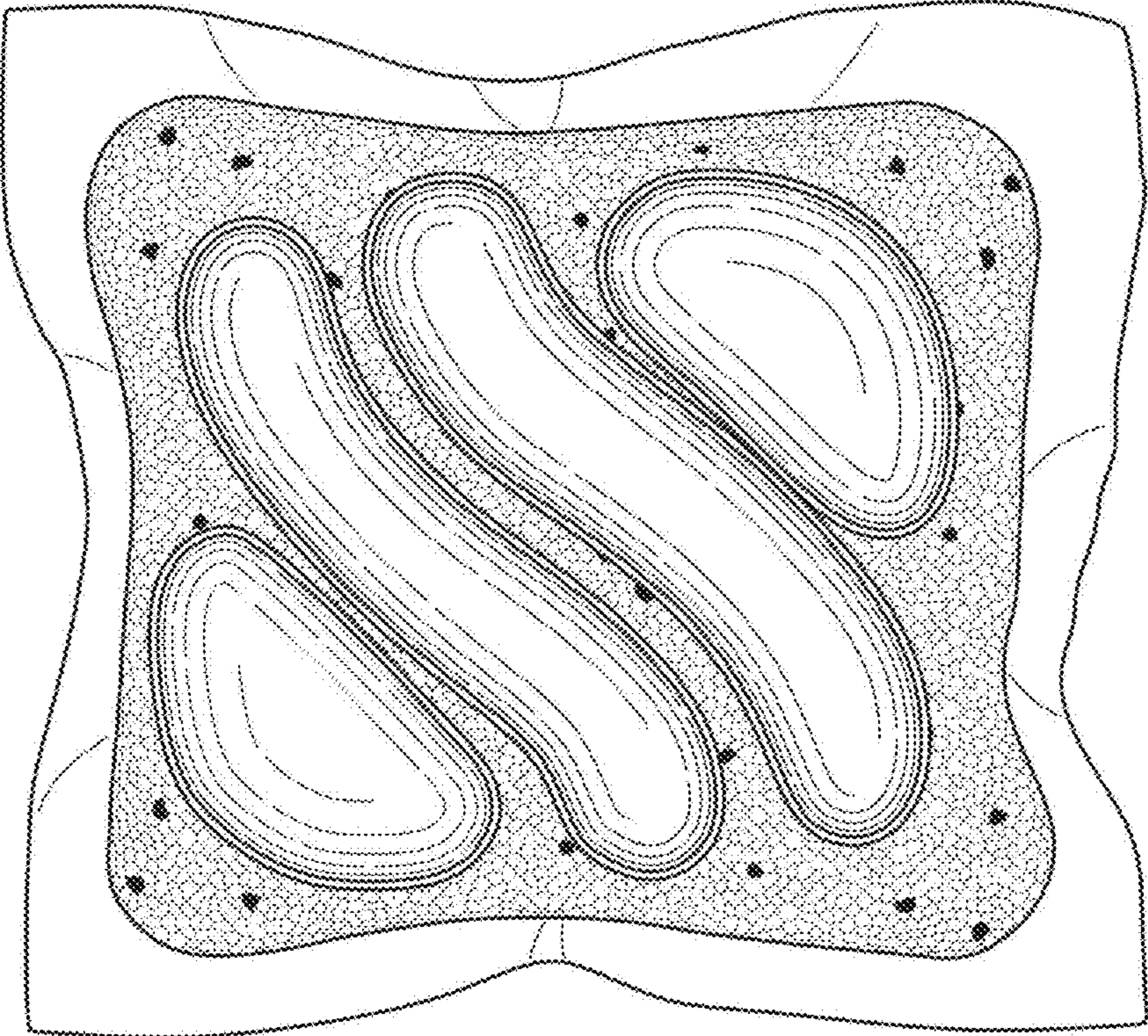

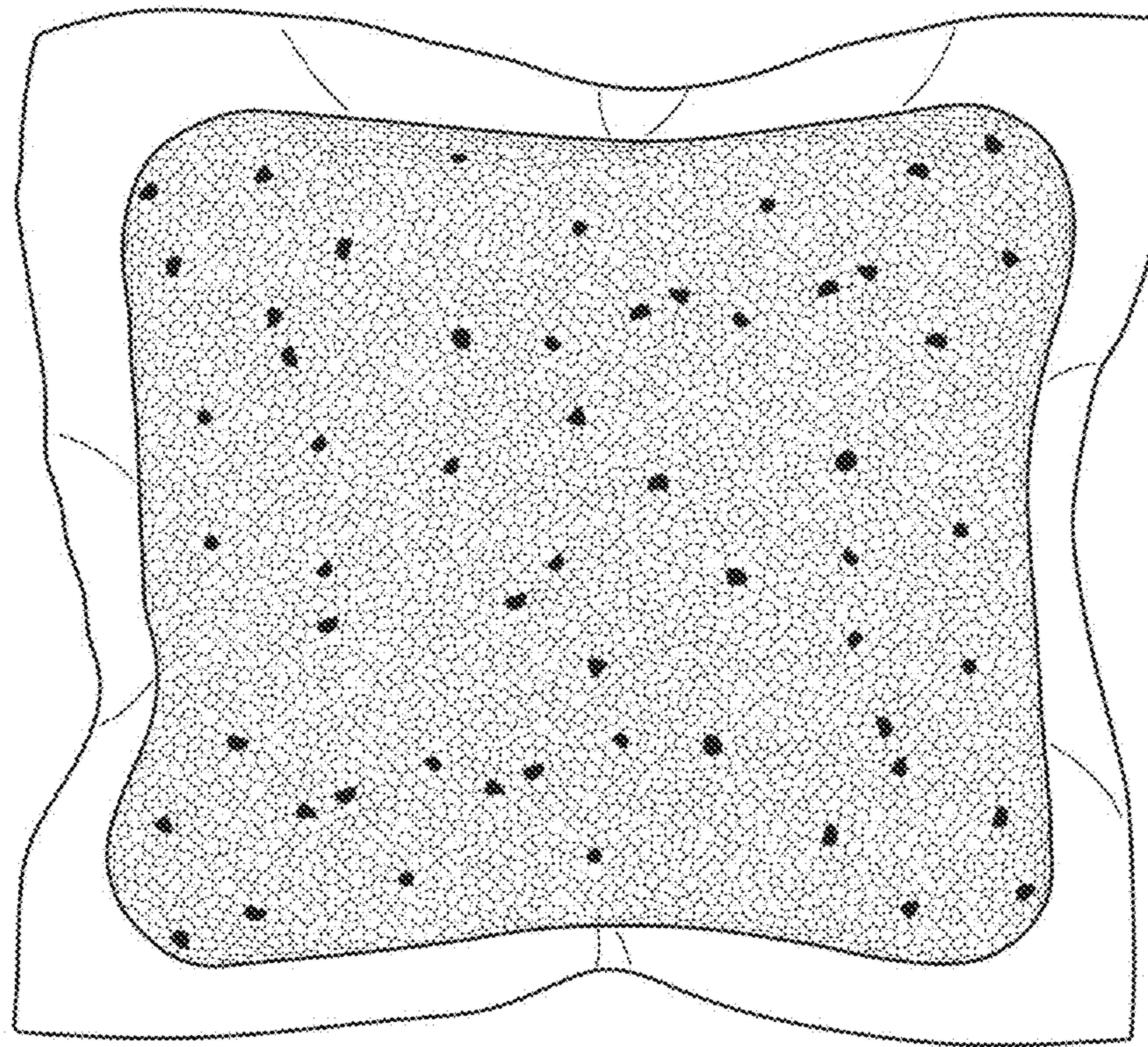

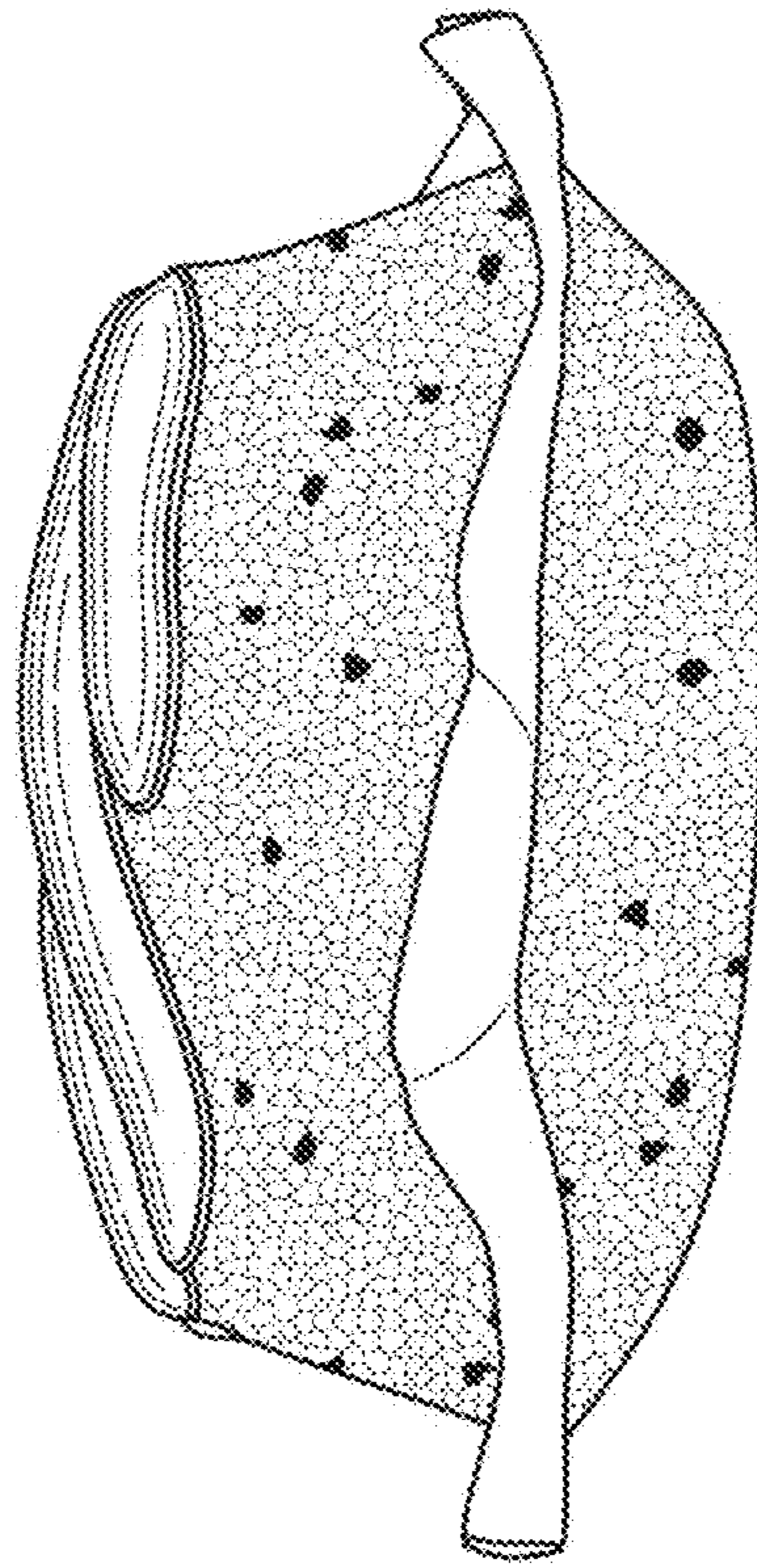

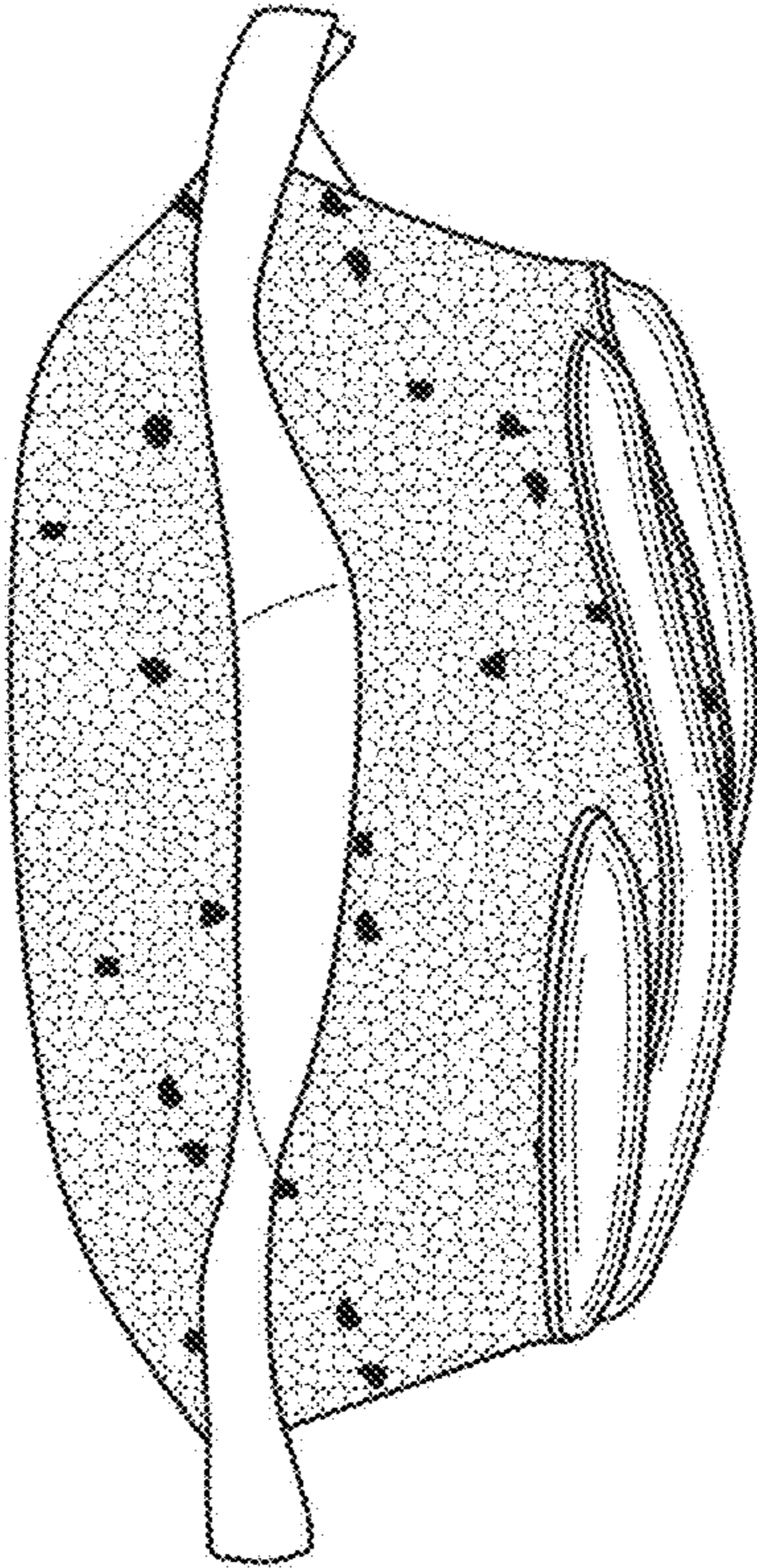

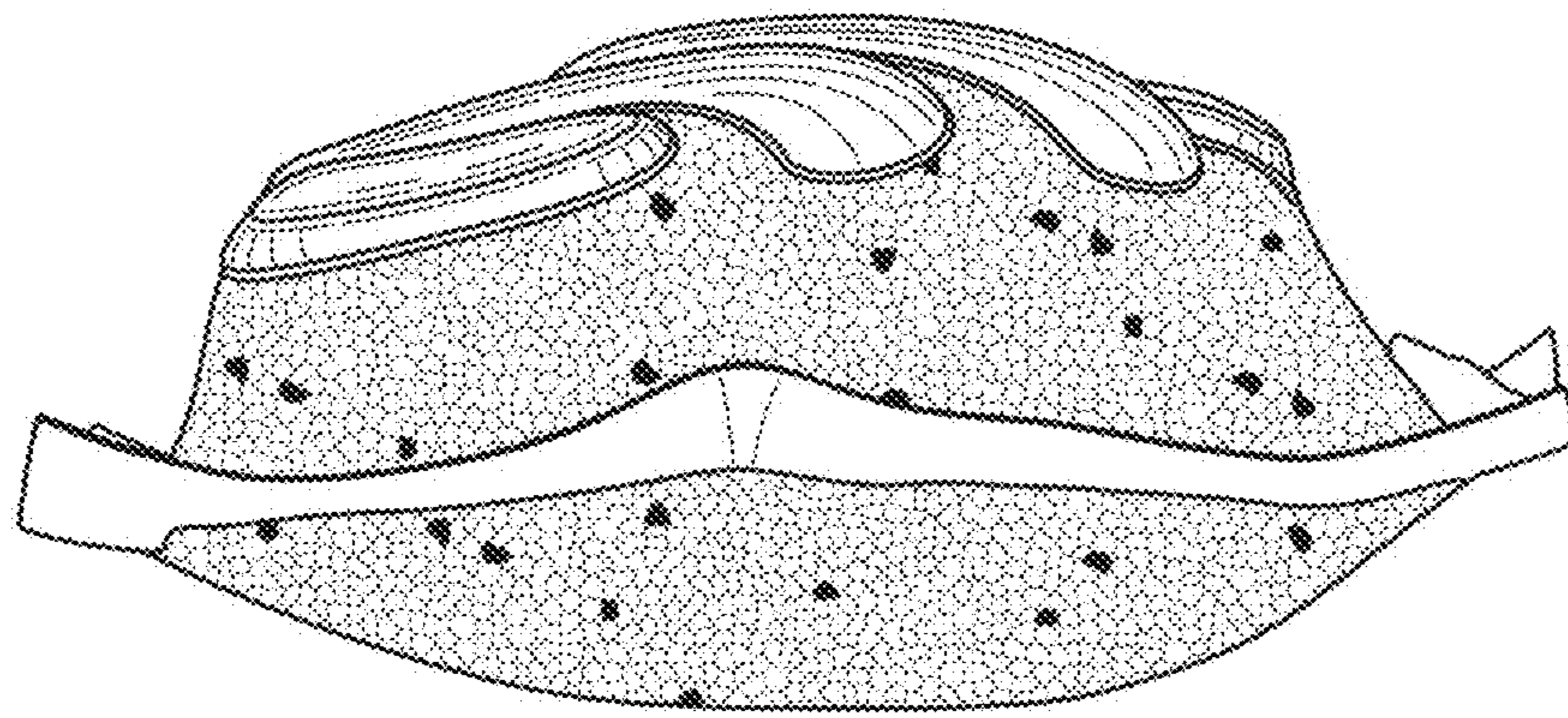

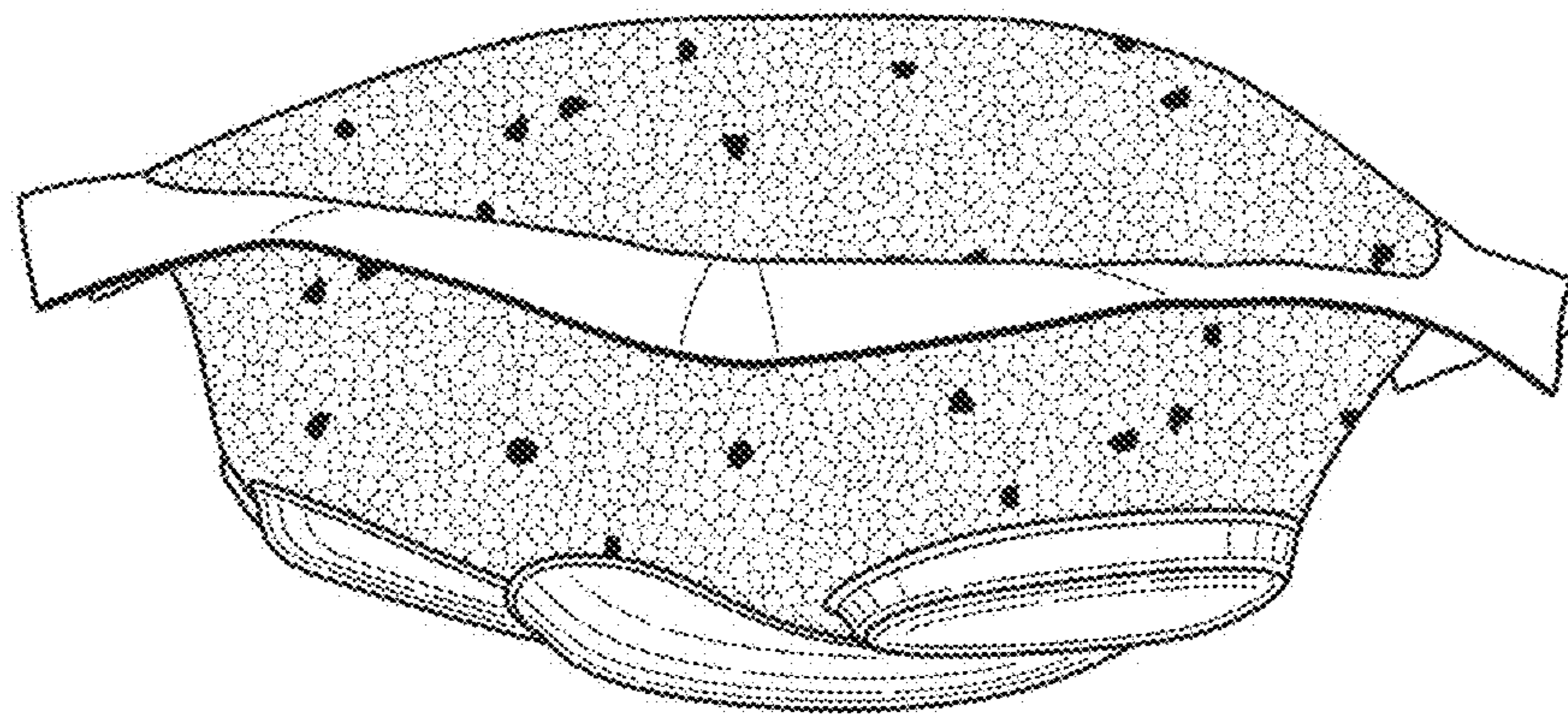

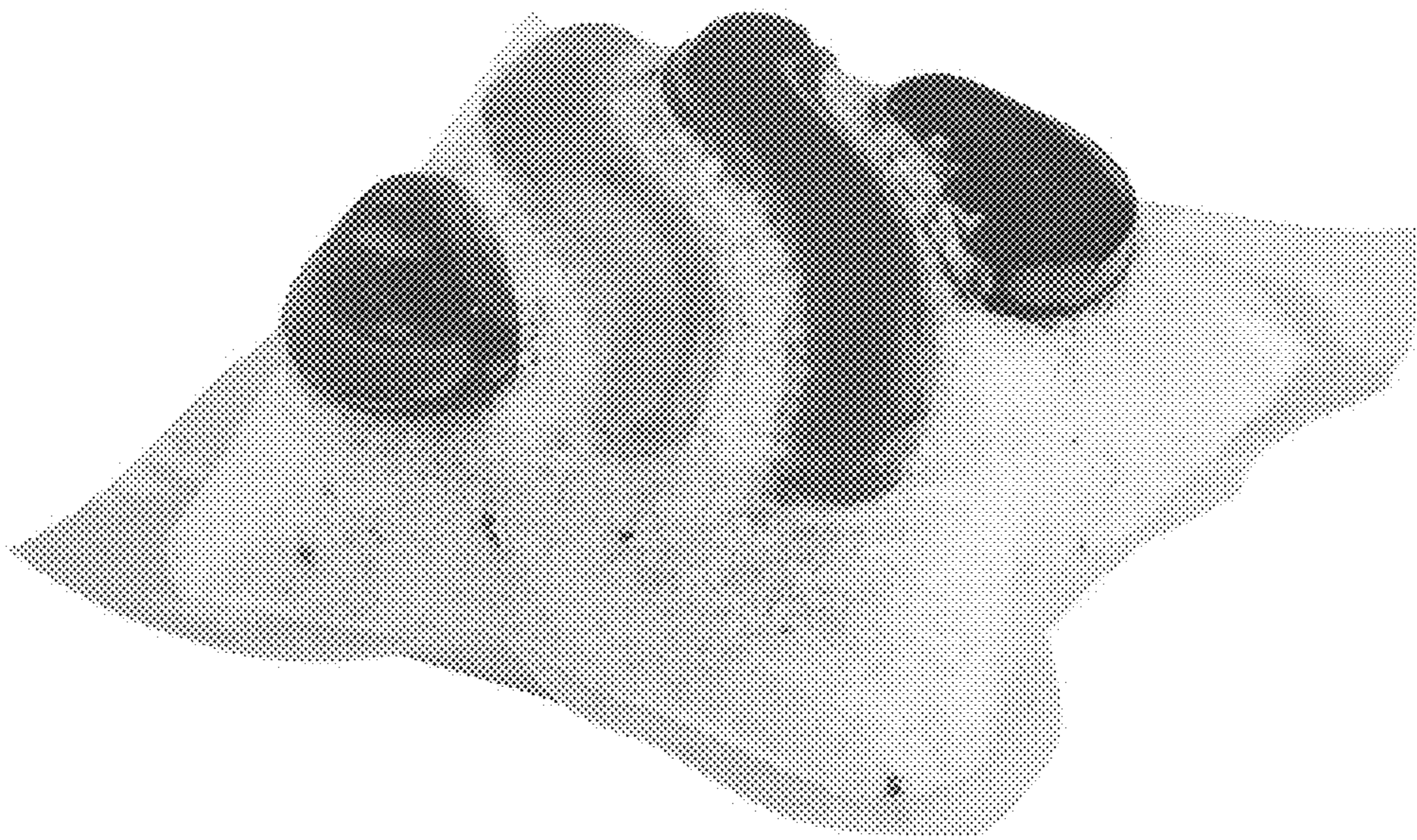

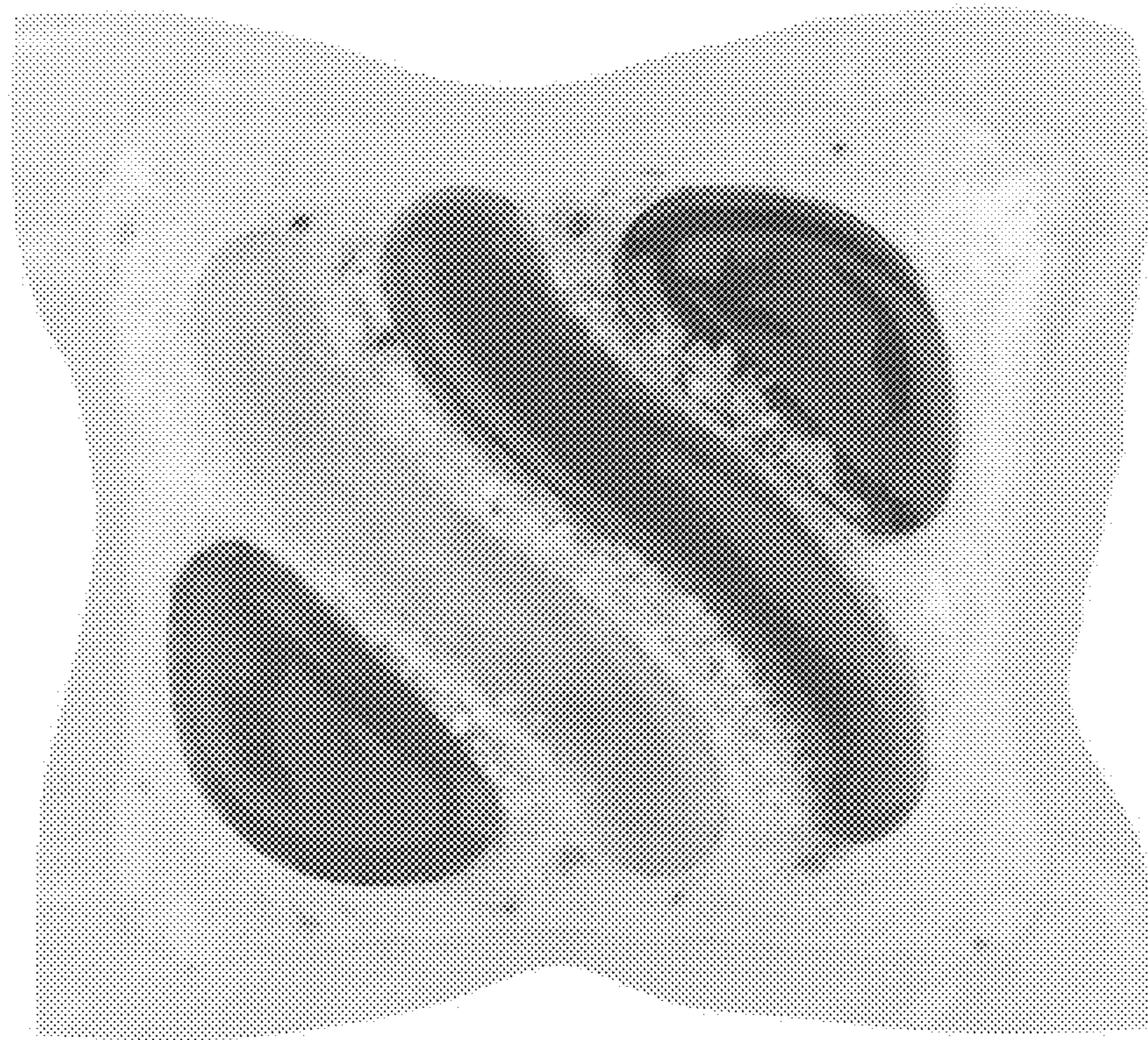

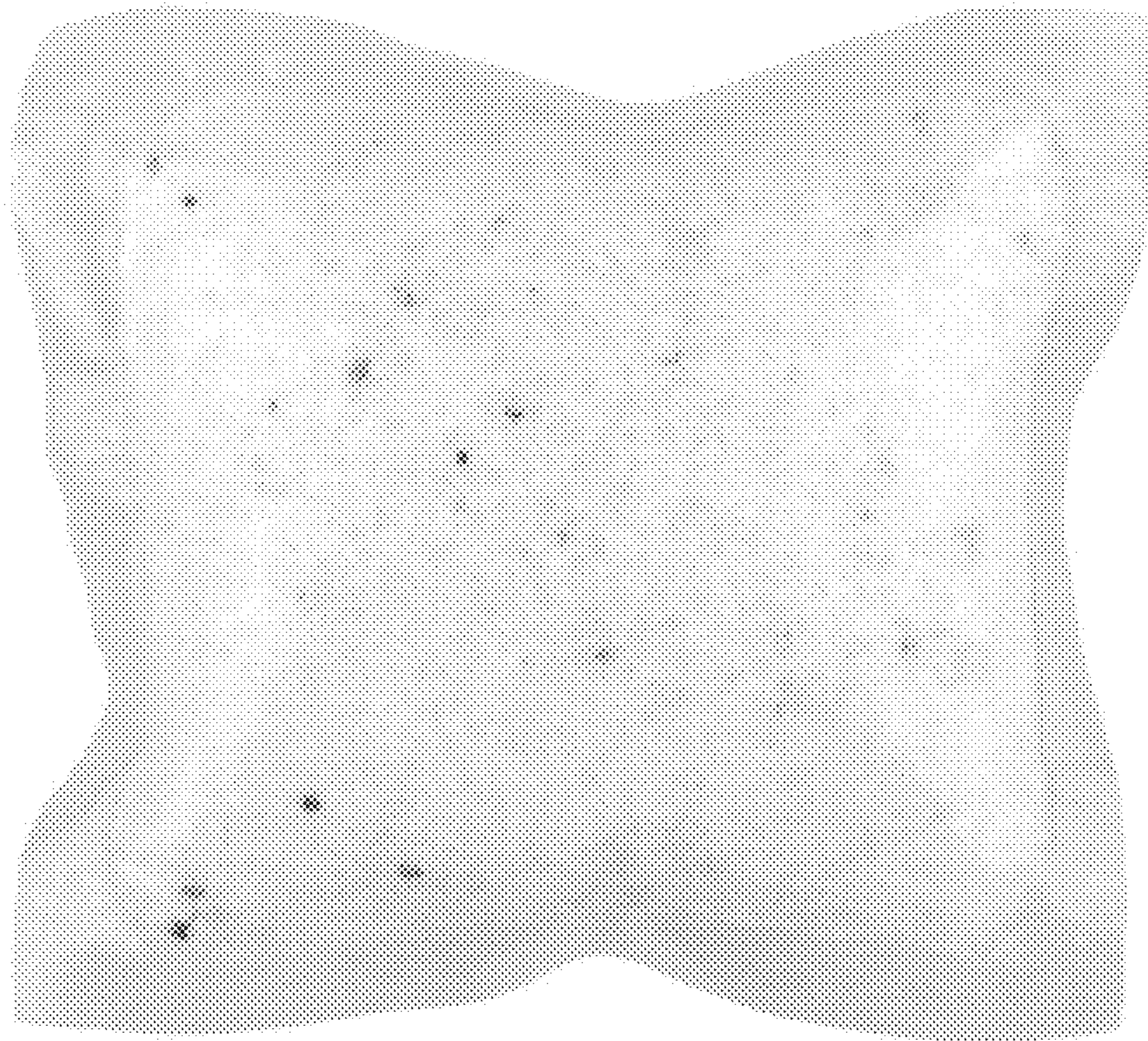

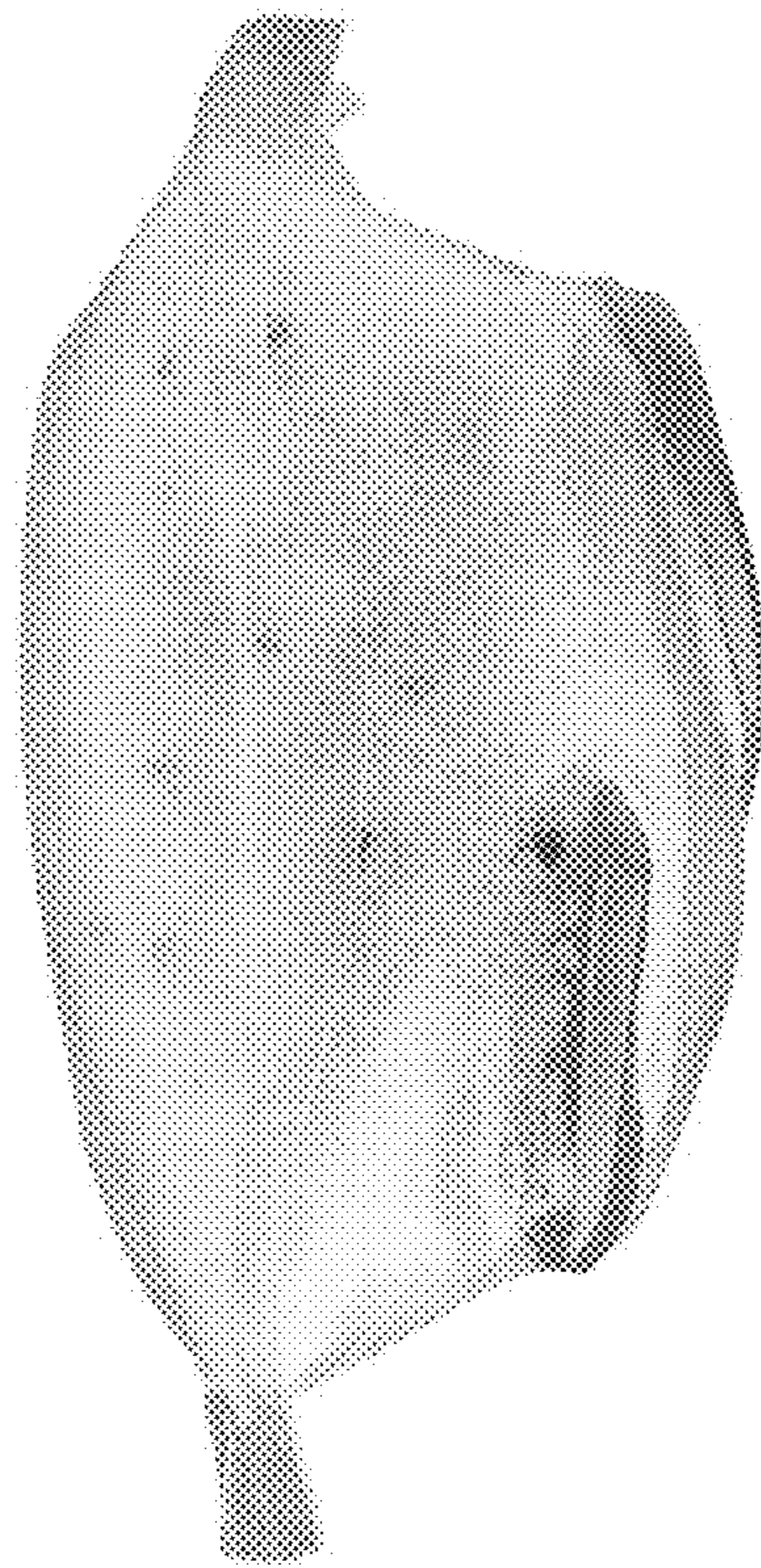

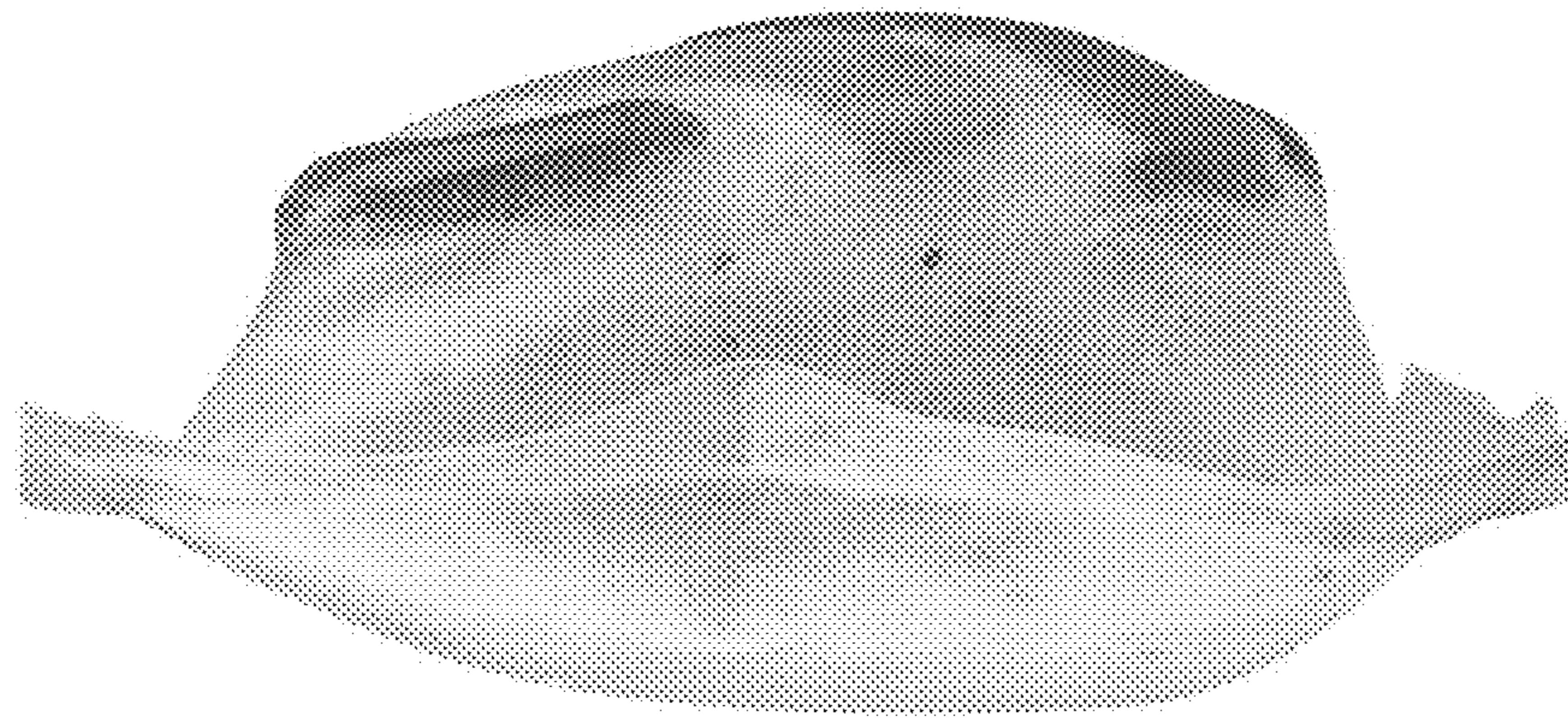

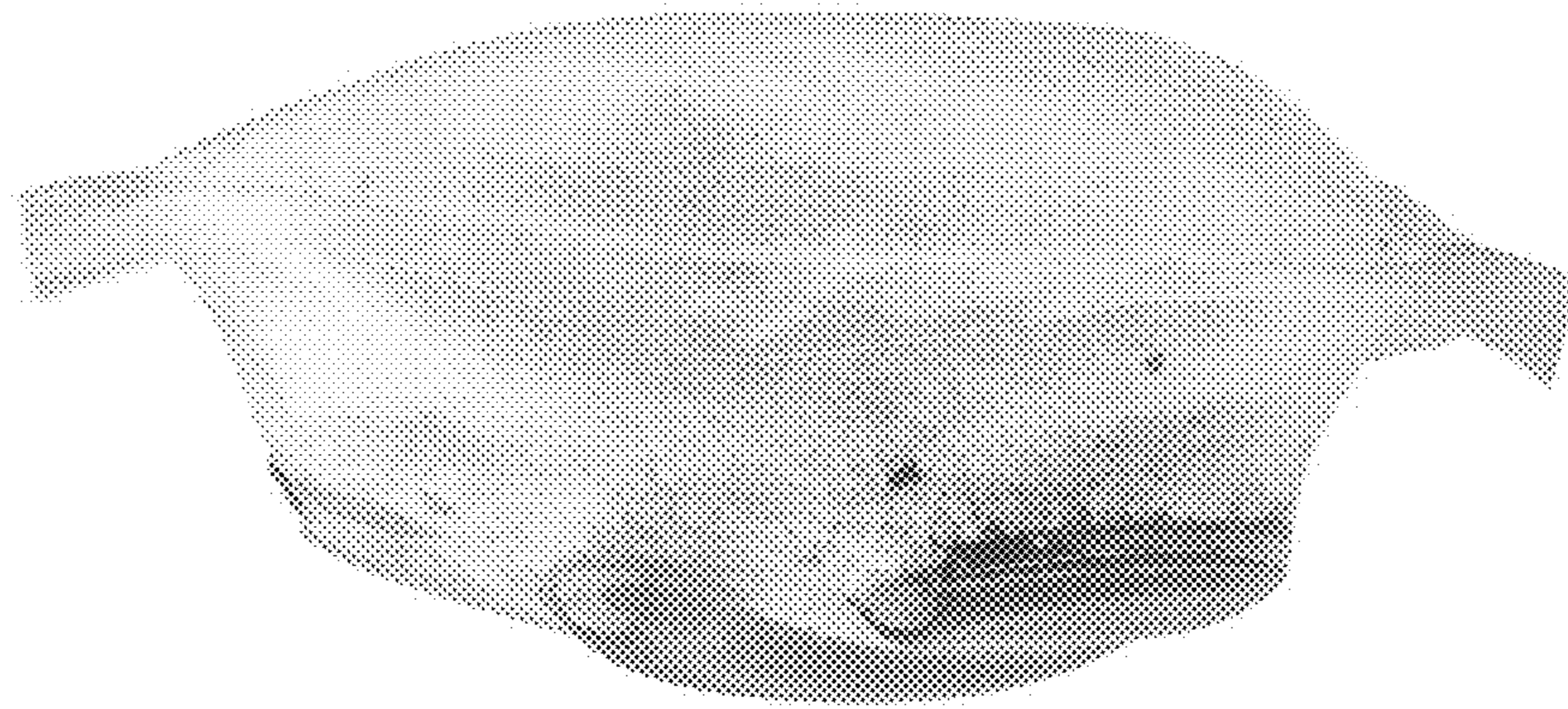
