(57) **CLAIM**

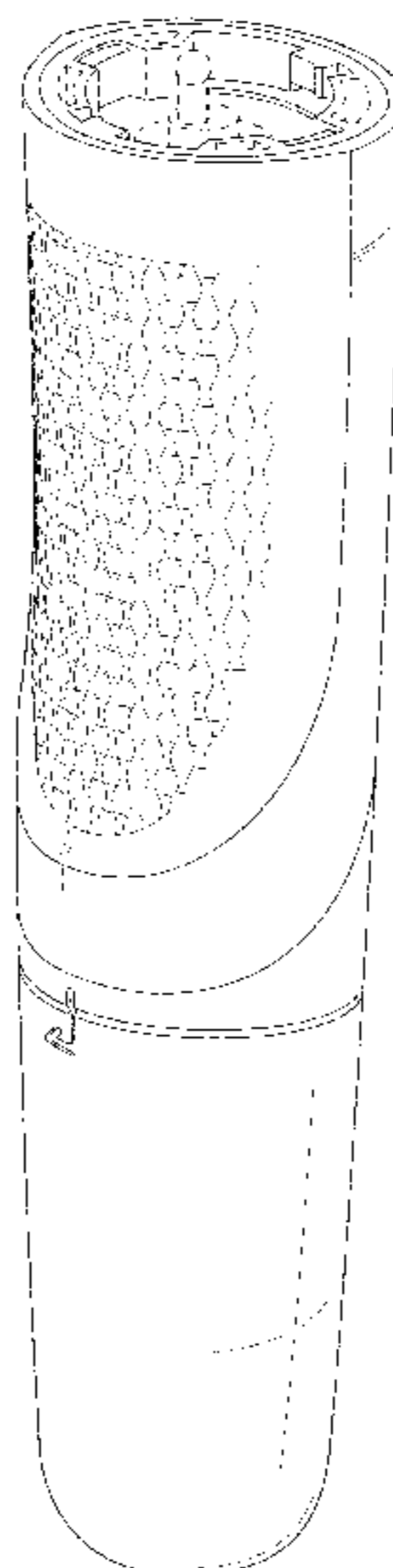
The ornamental design for a hair trimmer device body, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hair trimmer device body showing our new design;
FIG. 2 is a front elevation view of the hair trimmer device body of FIG. 1;
FIG. 3 is a side elevation view of the hair trimmer device body of FIG. 1;
FIG. 4 is a back elevation view of the hair trimmer device body of FIG. 1;
FIG. 5 is a side elevation view of the hair trimmer device body of FIG. 1, opposite the side shown in FIG. 3;
FIG. 6 is a top plan view of the hair trimmer device body of FIG. 1; and,
FIG. 7 is a bottom plan view of the hair trimmer device body of FIG. 1.

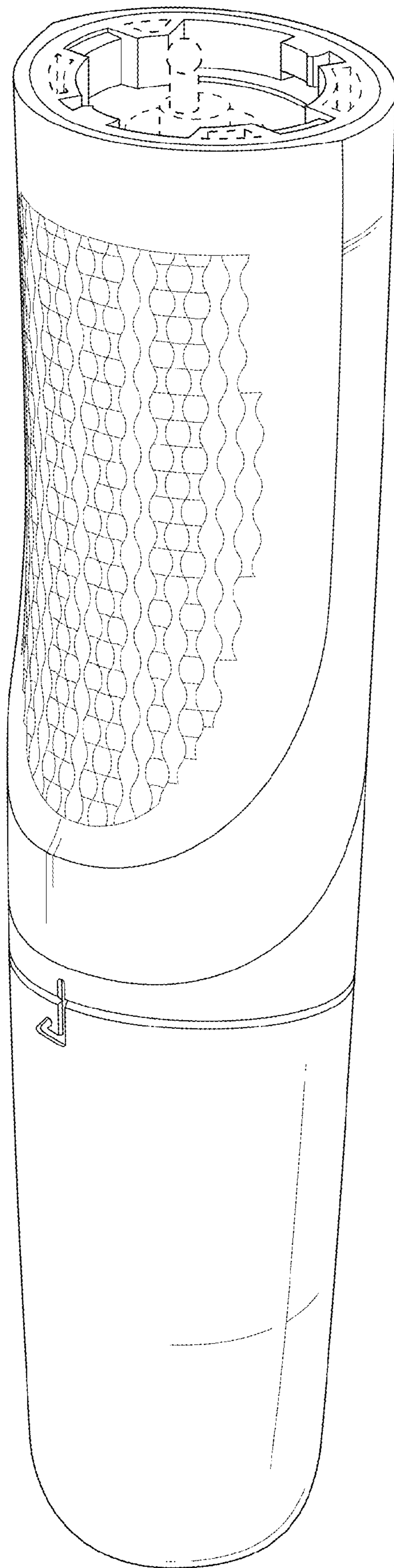

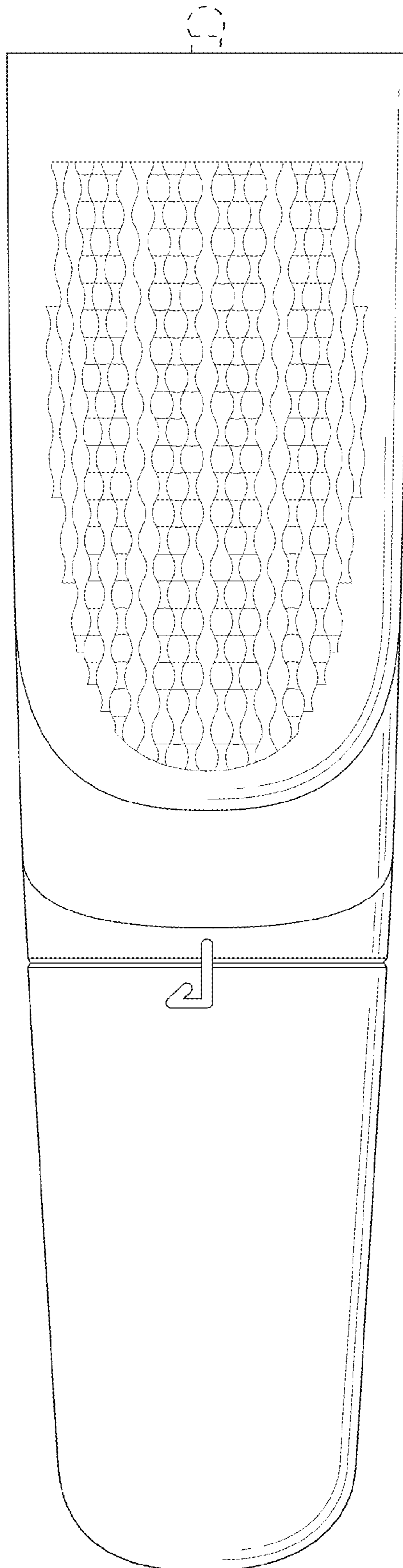

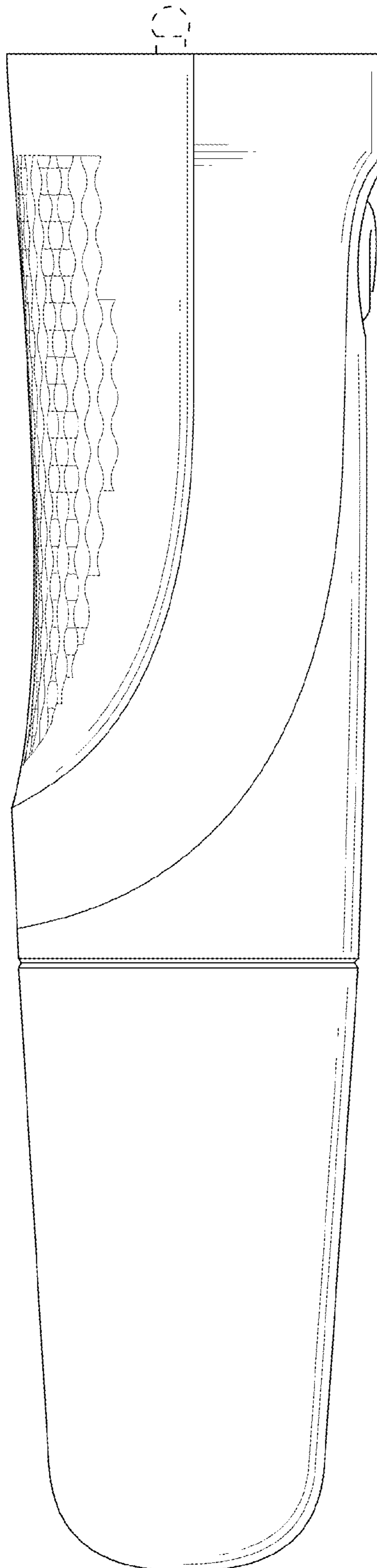

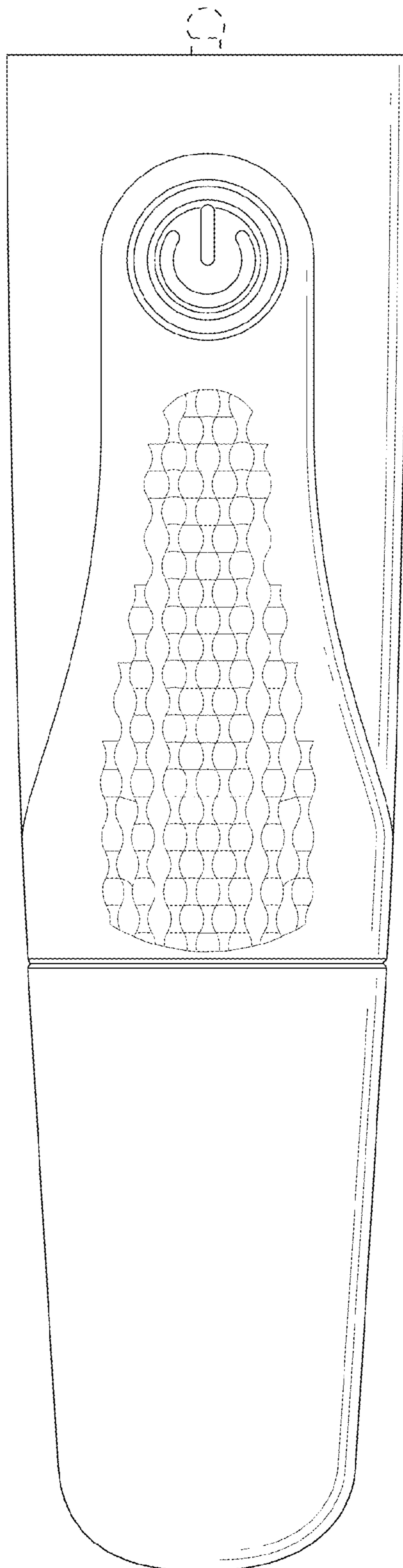

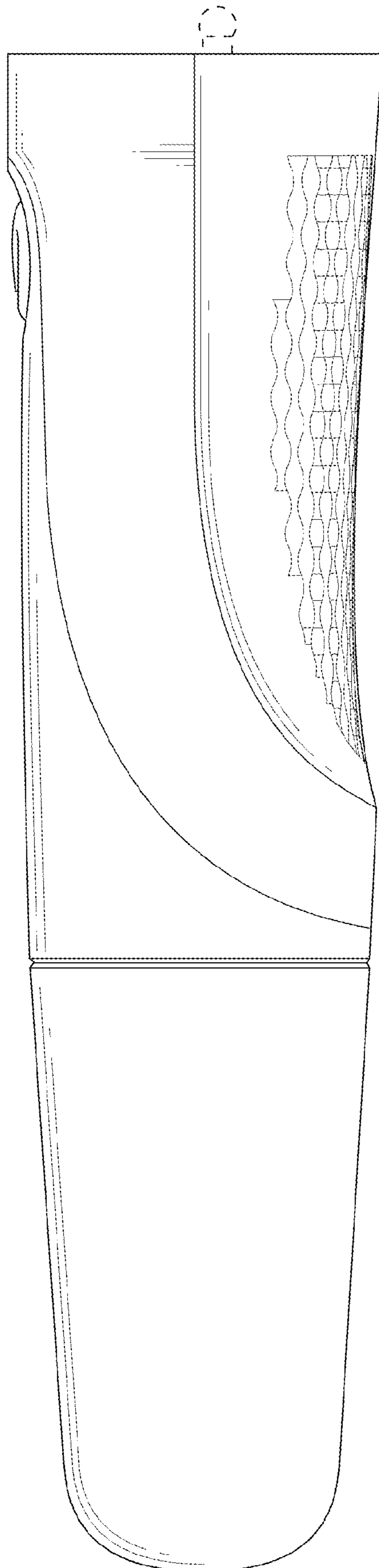

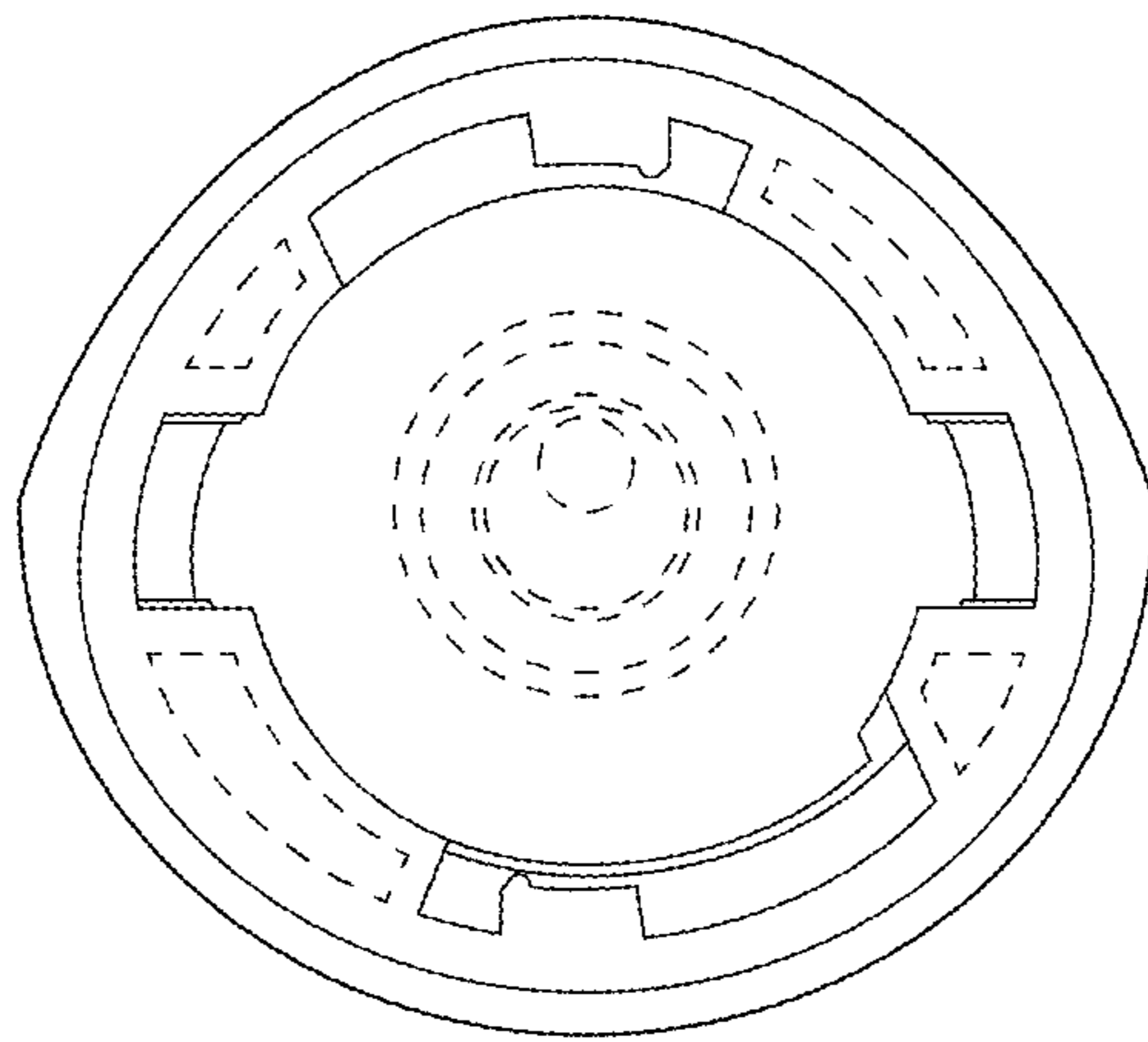

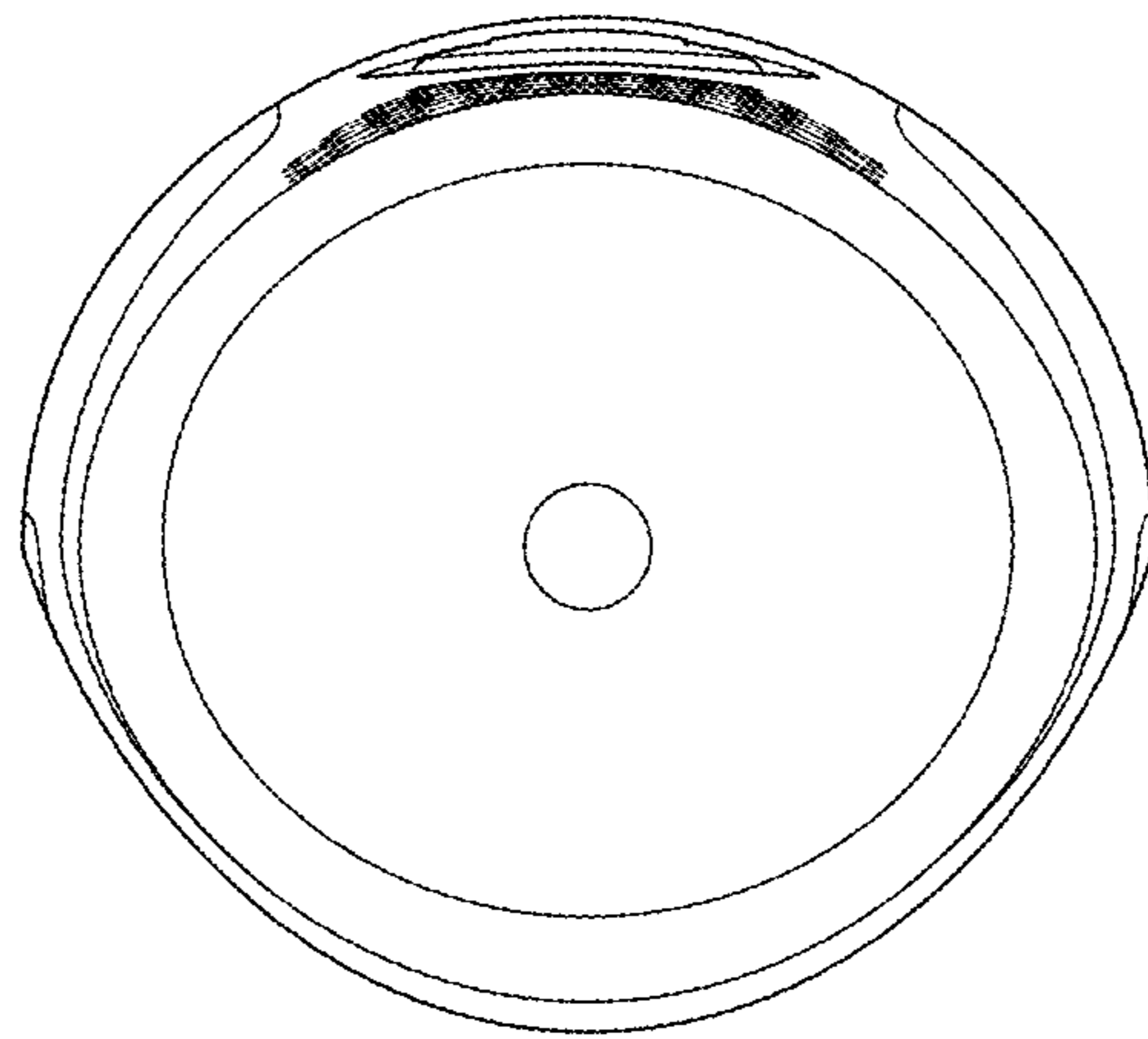
