(57) **CLAIM**

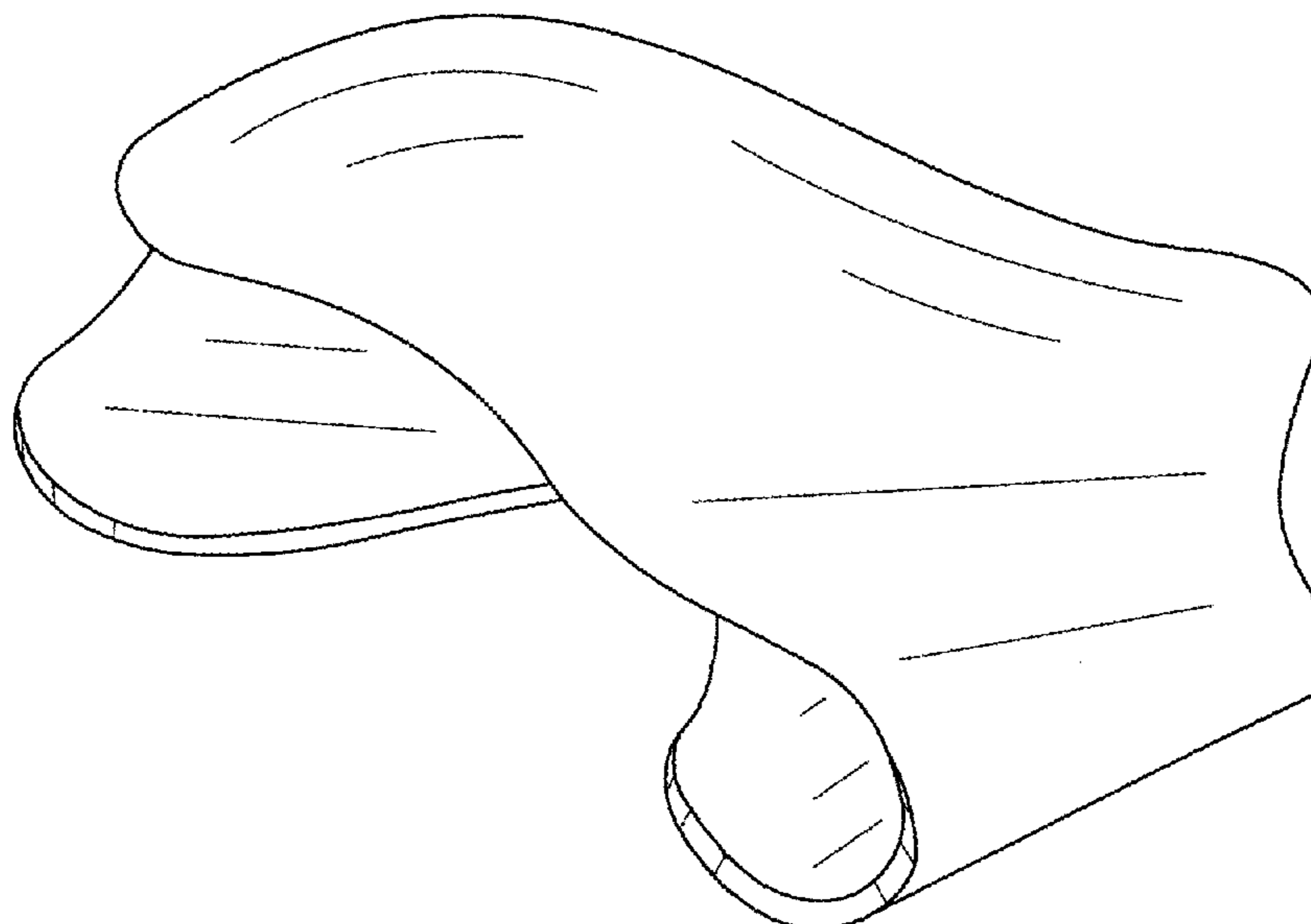
The ornamental design for a protective overlapping scale for an article of clothing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a protective overlapping scale for an article of clothing, showing my new design; FIG. 2 is a perspective rear view of the protective overlapping scale for an article of clothing of FIG. 1; FIG. 3 is a perspective side view of the protective overlapping scale for an article of clothing of FIG. 1 and in an arrangement for use and slightly smaller in dimension than that of FIG. 1; FIG. 4 is a perspective view of the protective overlapping scale for an article of clothing of FIG. 1 in use attached to a sleeve of a jacket and smaller in dimension than that of FIG. 1; FIG. 5 is a perspective view of the protective overlapping scale for an article of clothing of FIG. 1 in use attached to a glove and smaller in dimension than that of FIG. 1; FIG. 6 is a right side elevational side view of the protective overlapping scale for an article of clothing of FIG. 1; FIG. 7 is a left side elevational view thereof; FIG. 8 is a front elevational view thereof; FIG. 9 is a rear elevational view thereof; FIG. 10 is a top plan view thereof; and, FIG. 11 is a bottom plan view thereof.

The broken line showing of a jacket in FIG. 4 and of a glove in FIG. 5 is for illustrative purposes only and forms no part of the claimed design. The broken line showing of more than one protective overlapping scale for an article of clothing in FIGS. 3, 4, and 5 is for illustrative purposes.

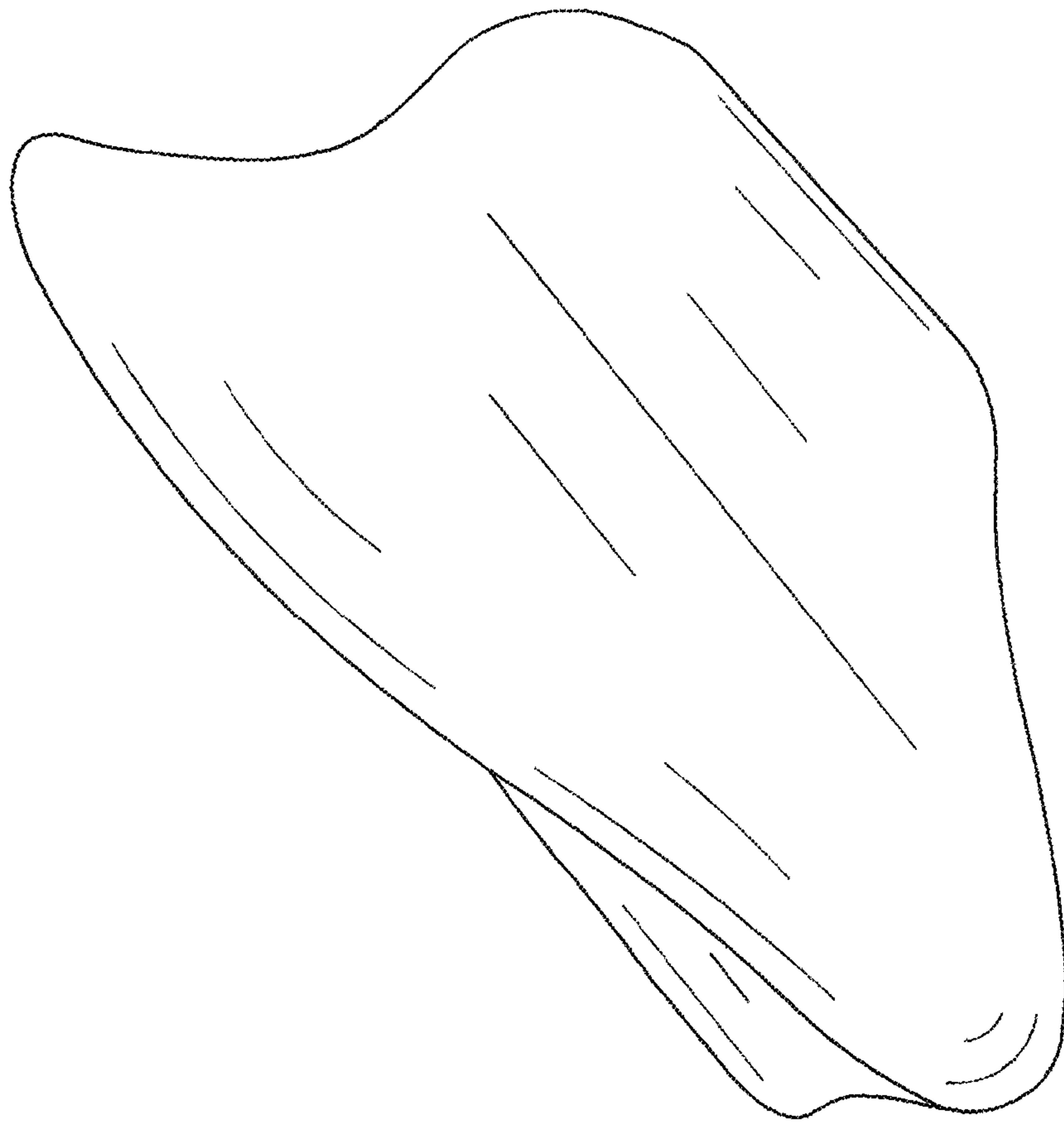

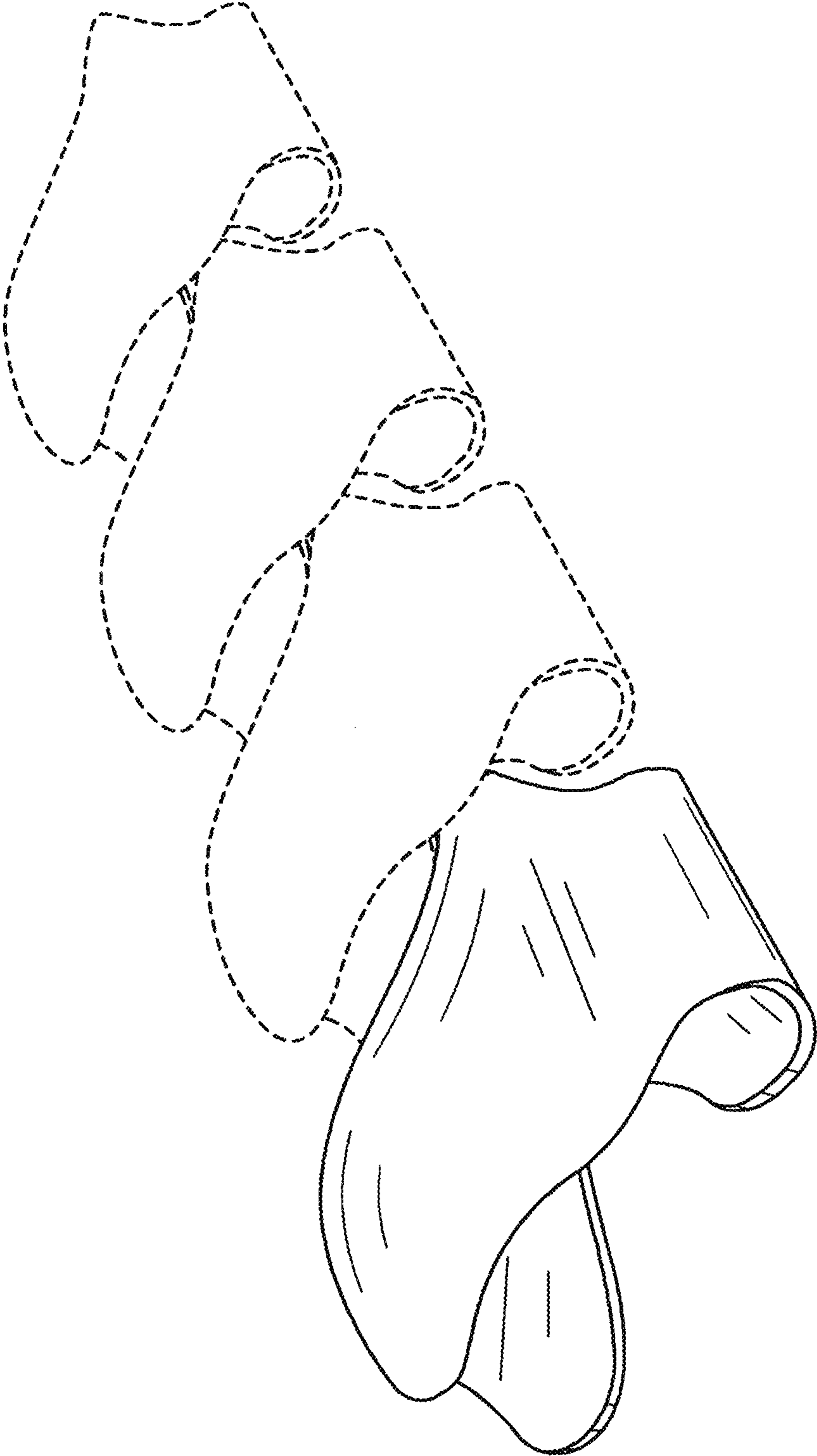

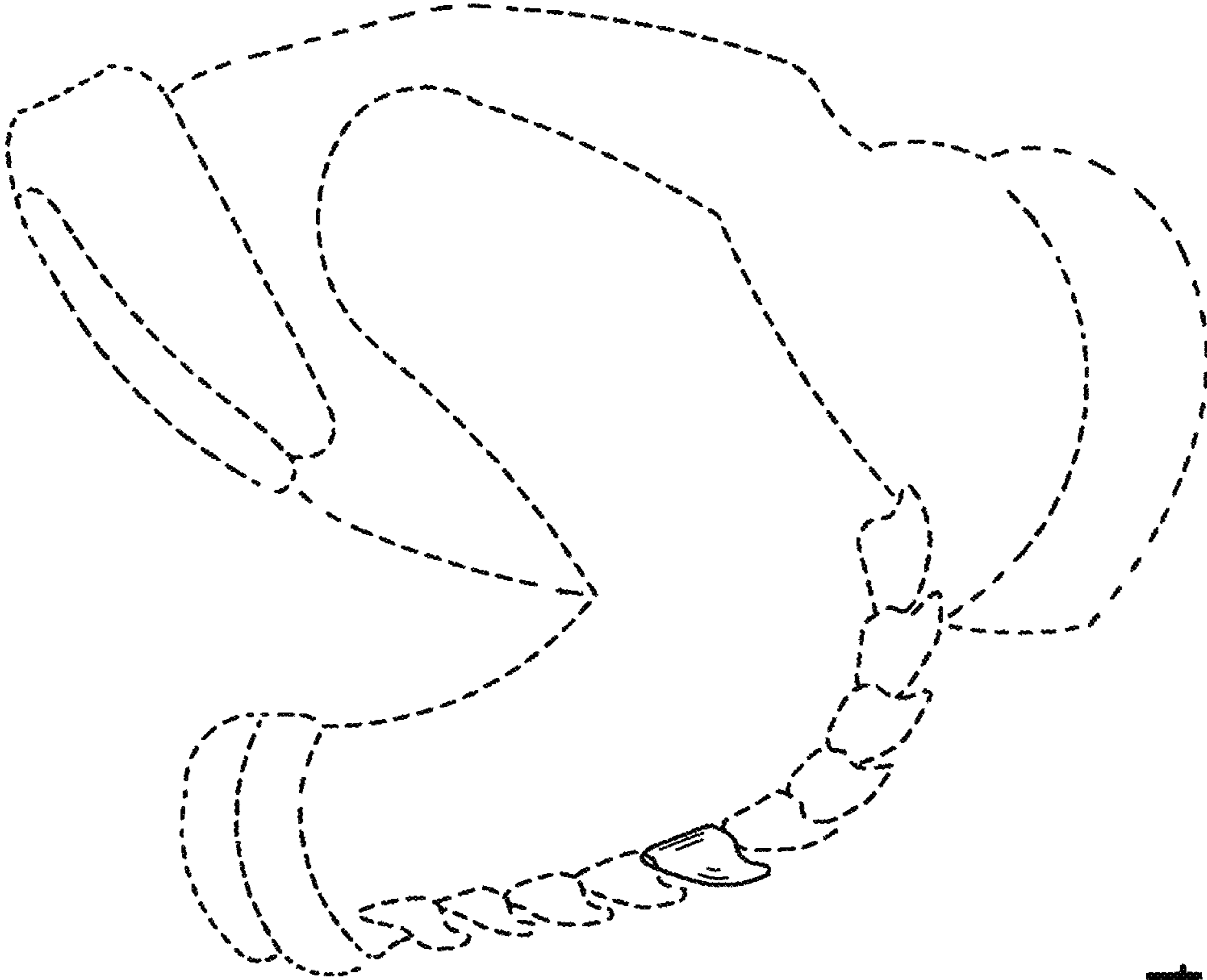

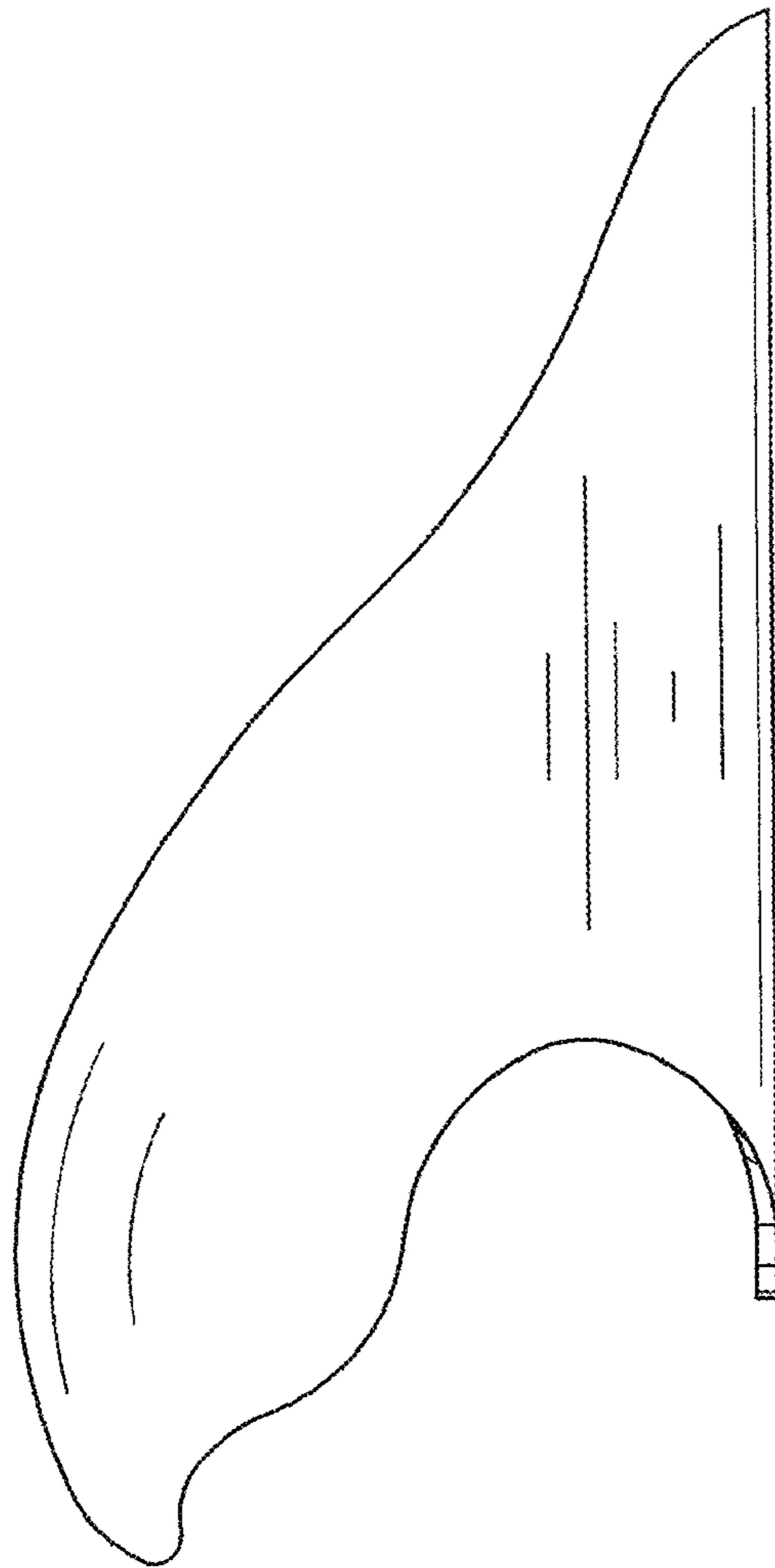

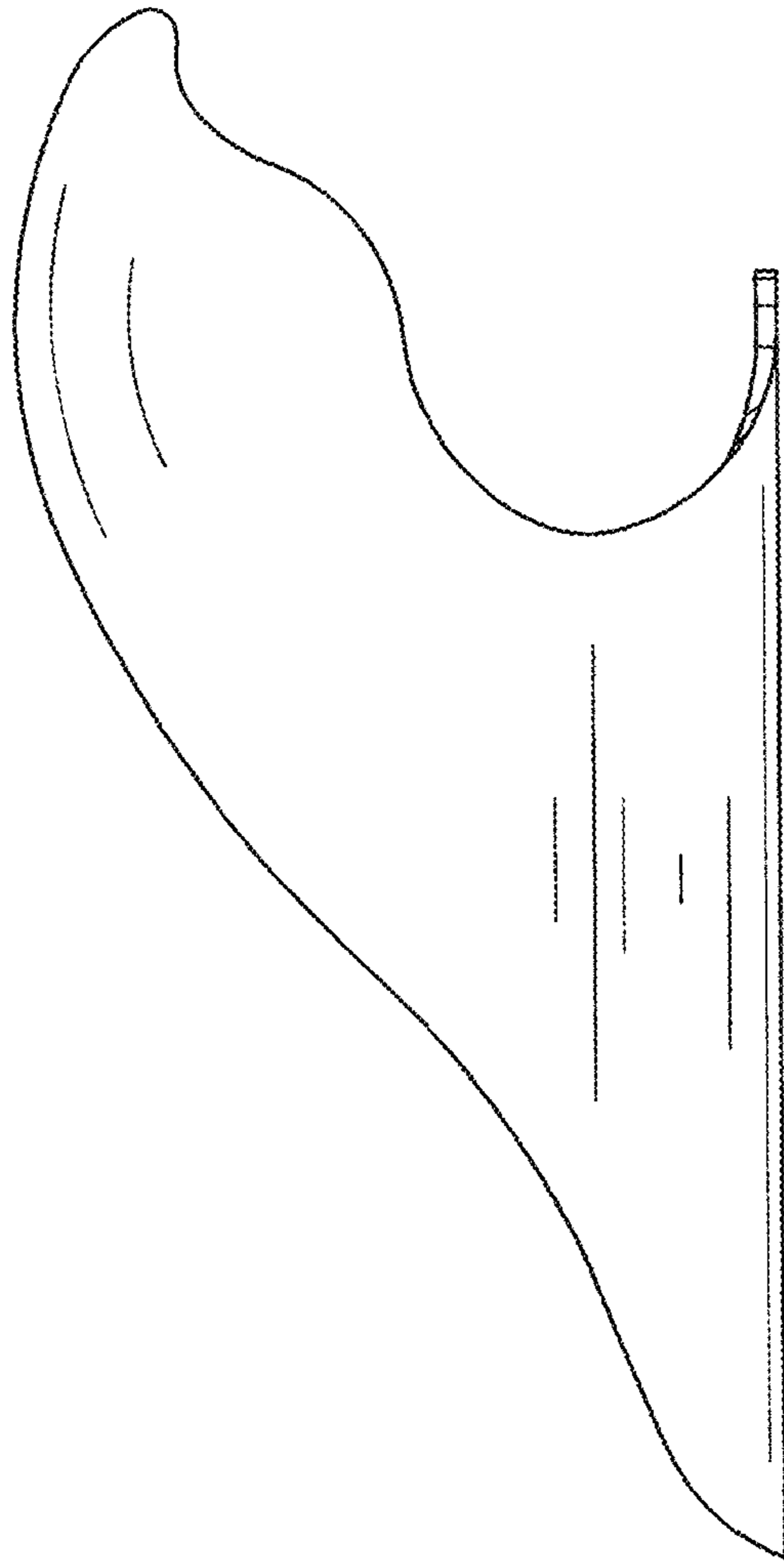

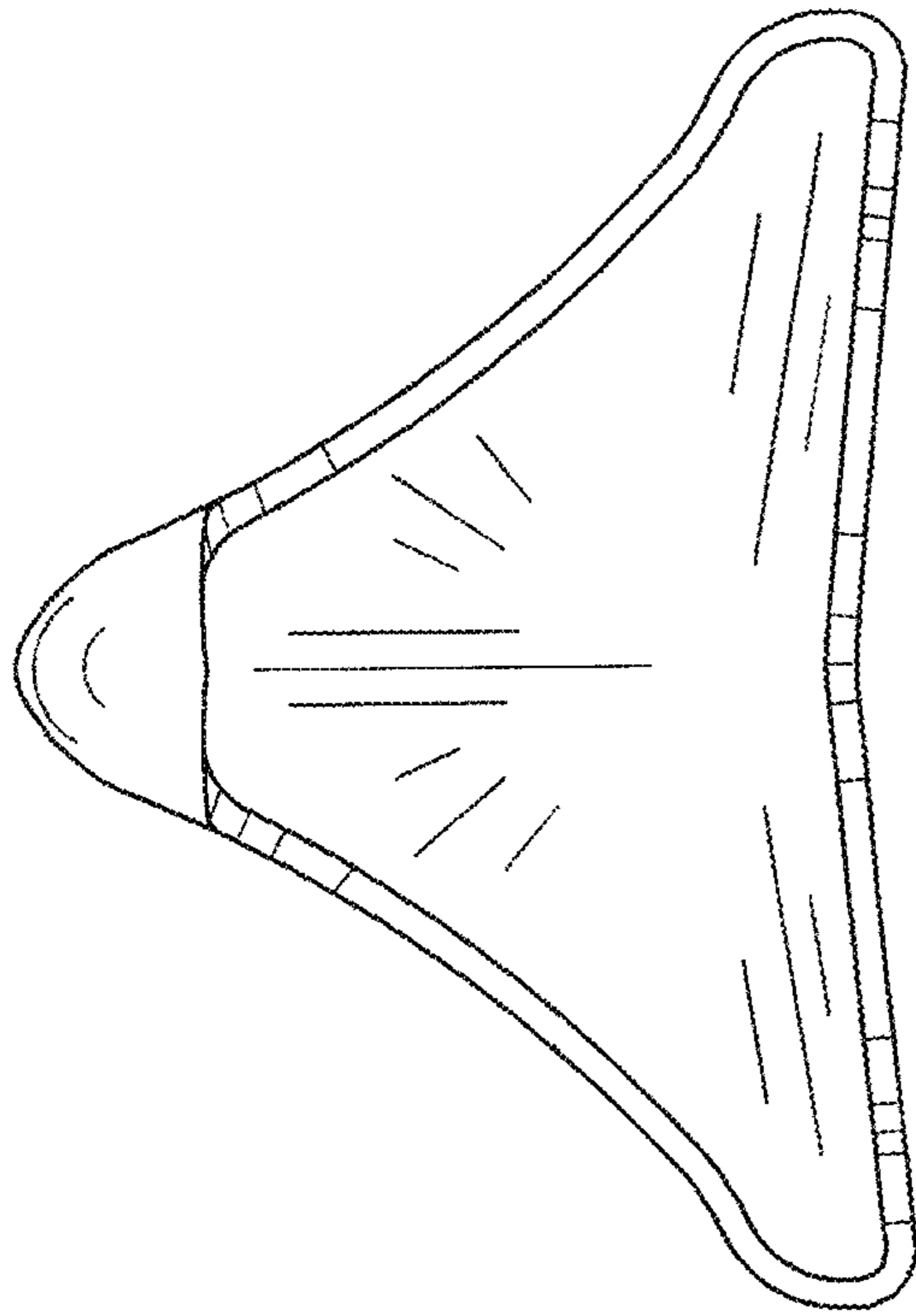

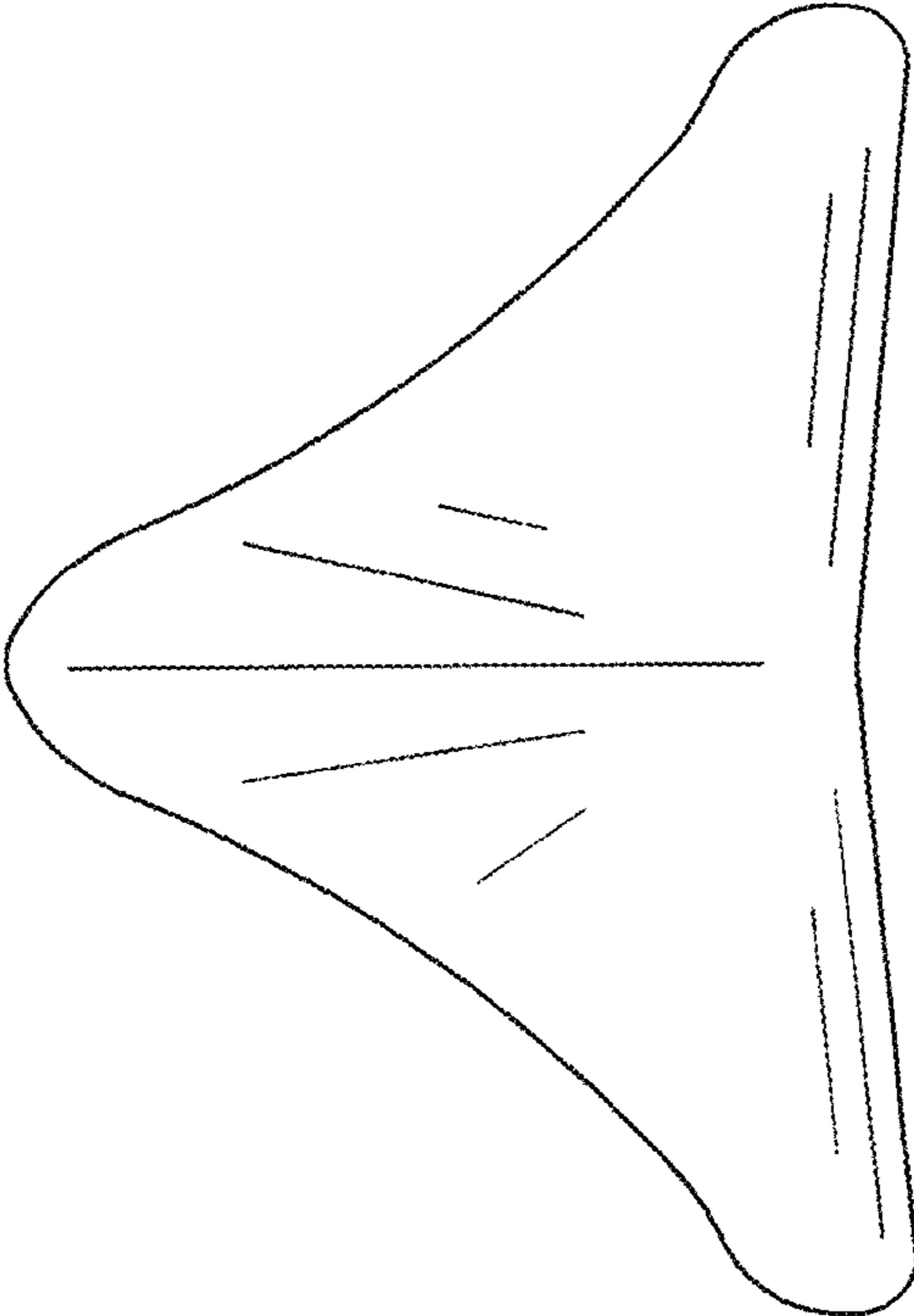

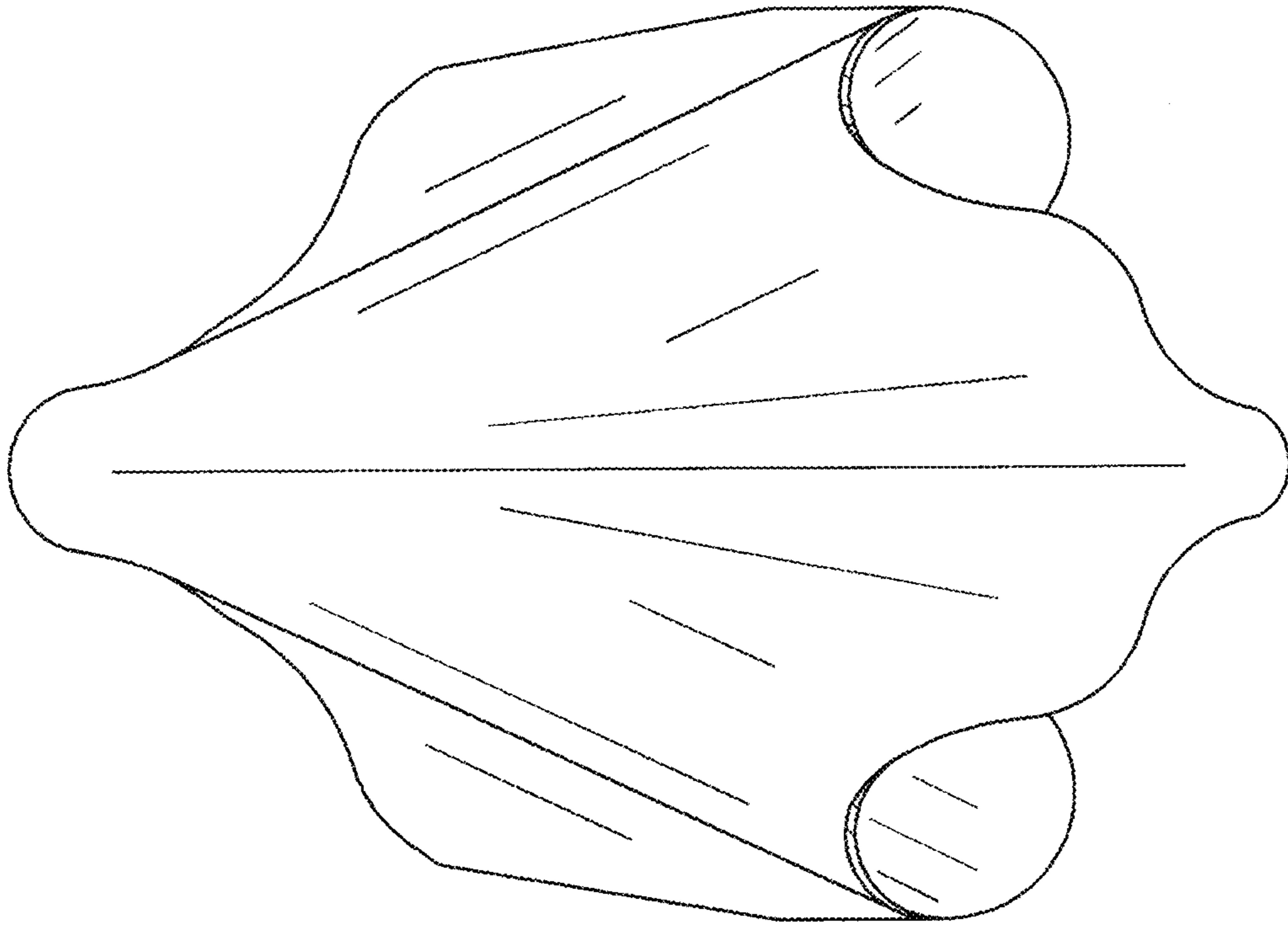

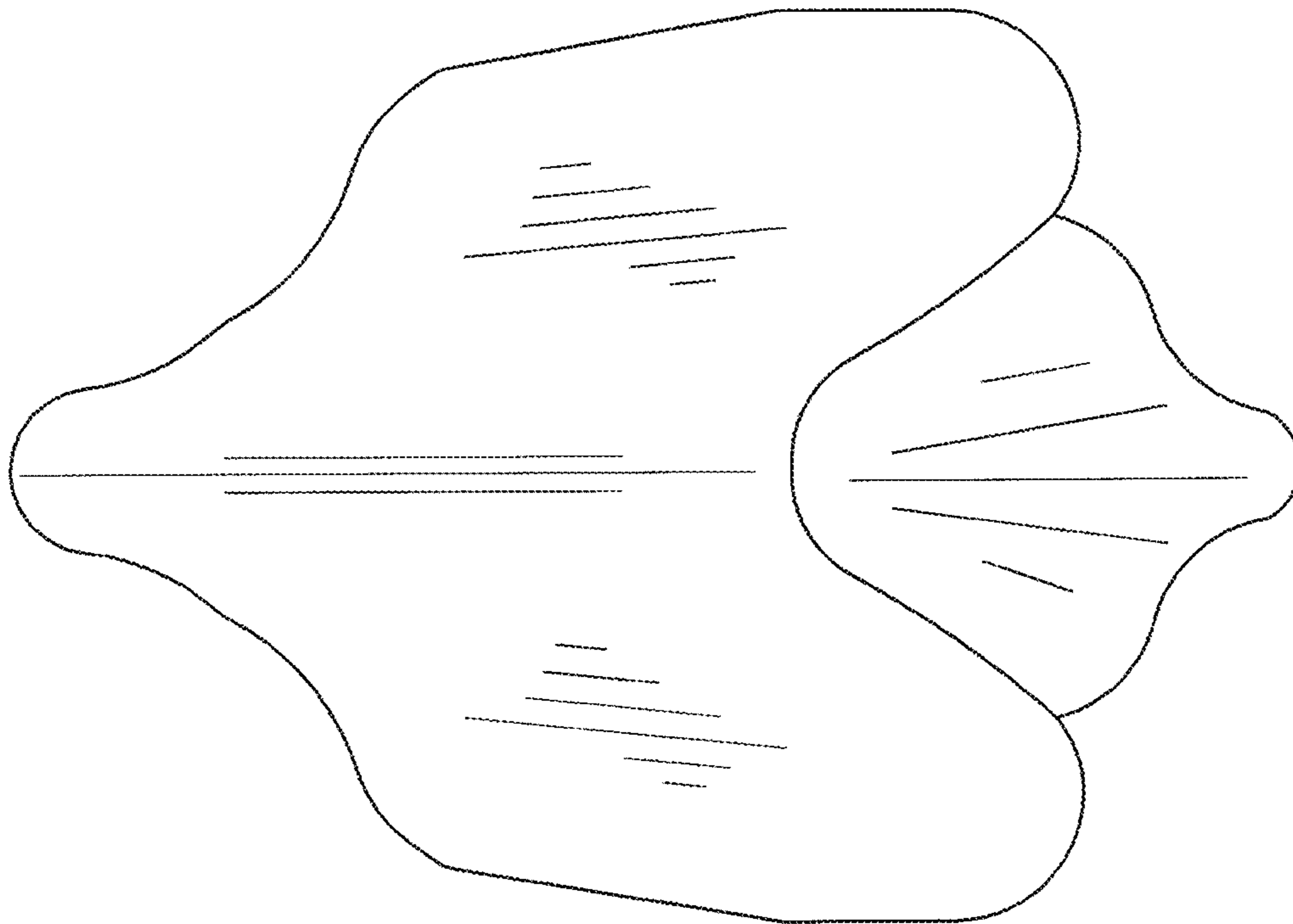
