(57) **CLAIM**

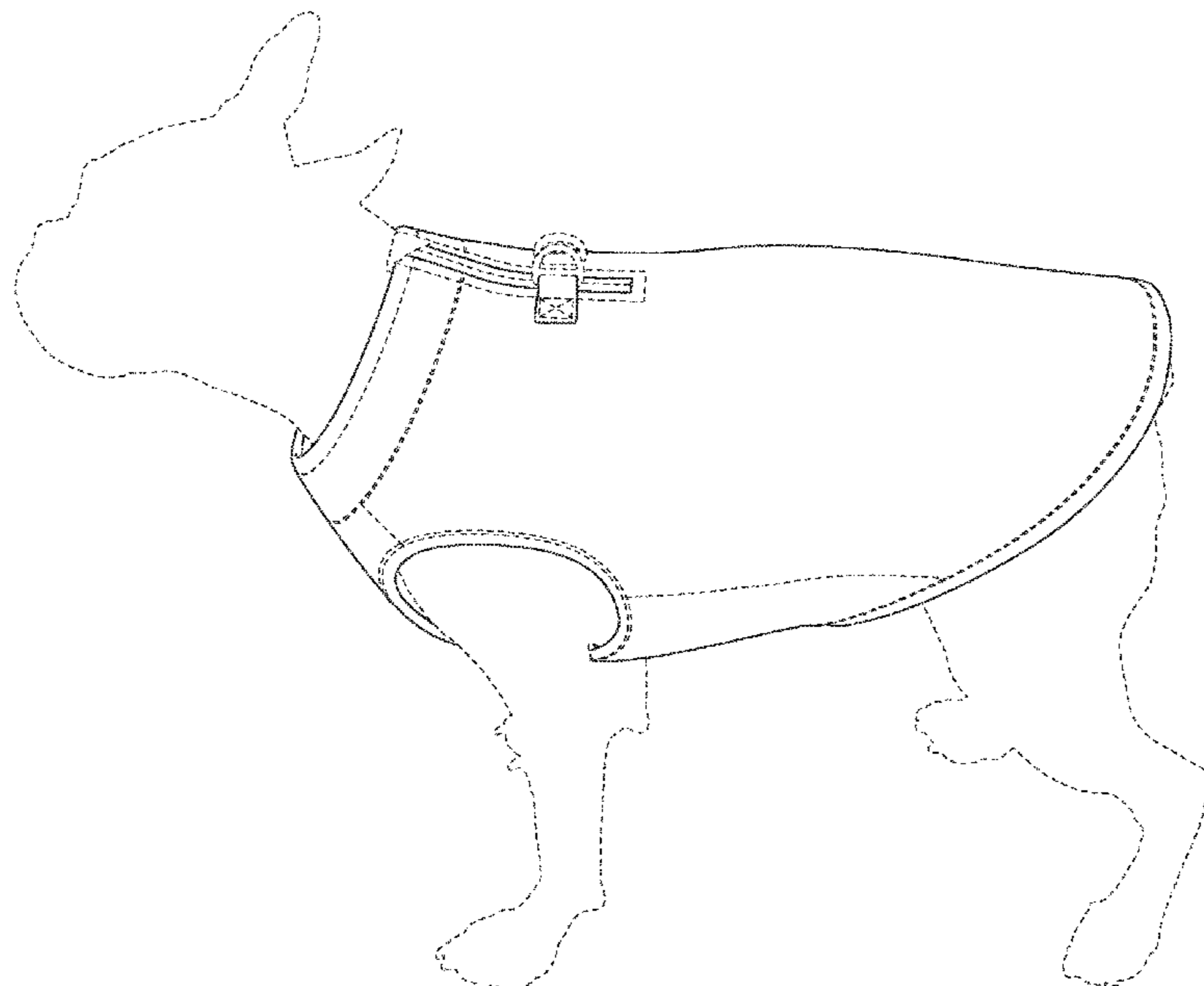
The ornamental design for a dog garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a dog garment, showing my new design in condition of use;  
FIG. 2 is a top, front, left perspective view of the dog garment of FIG. 1, shown enlarged for clarity of disclosure;  
FIG. 3 is a top, rear, left perspective view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a front elevational view of the dog garment of FIG. 2, shown more enlarged for clarity of disclosure;

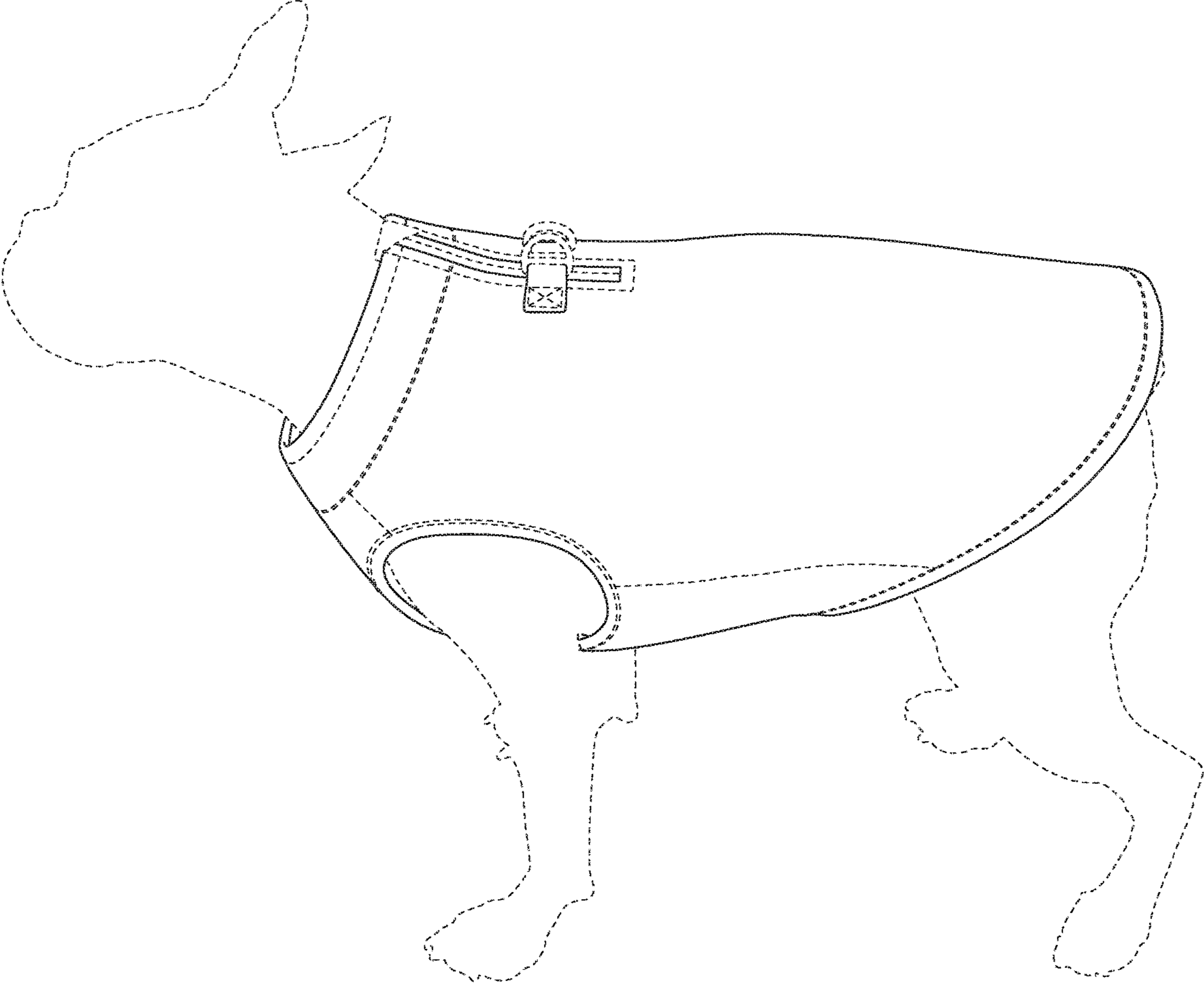

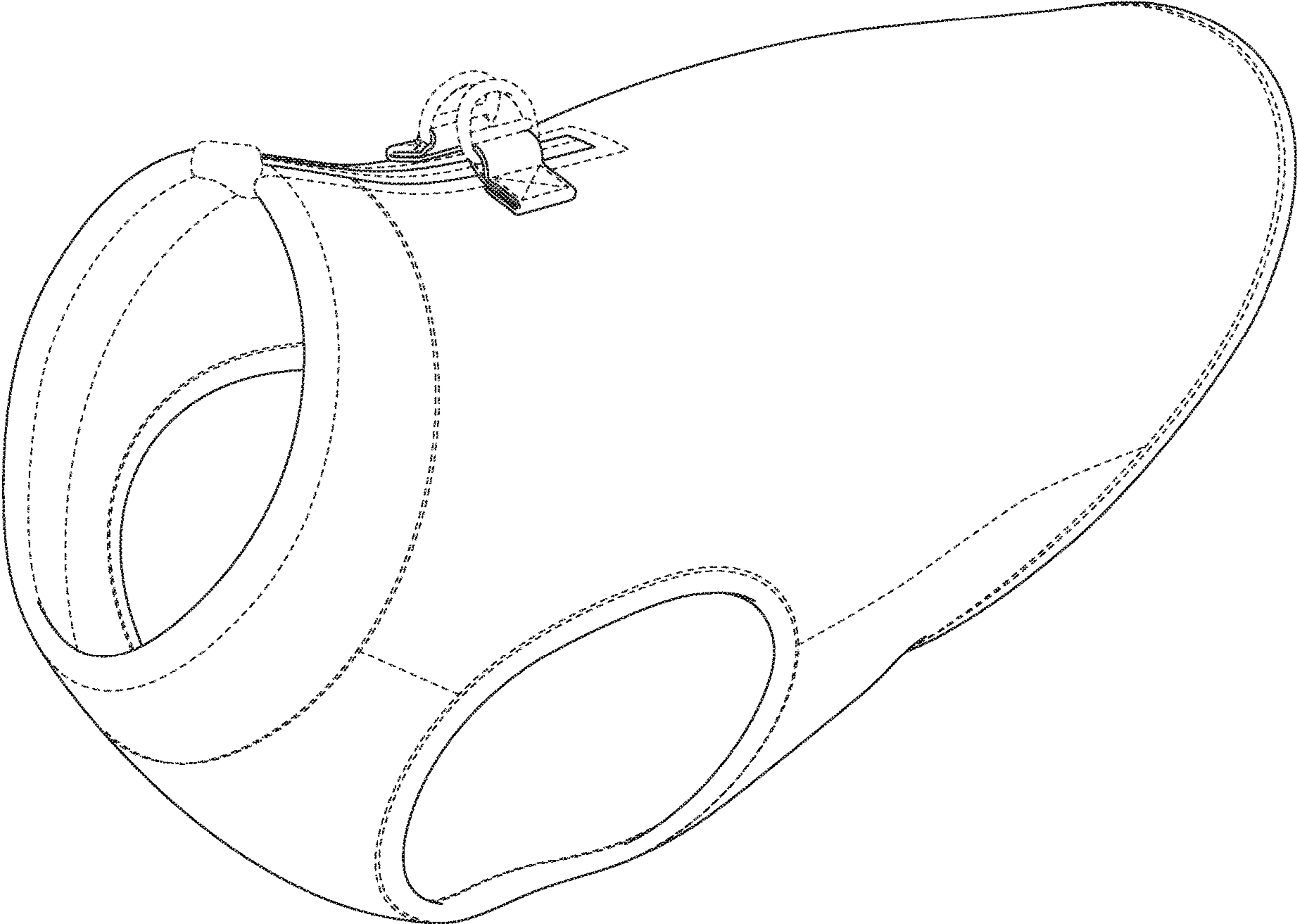

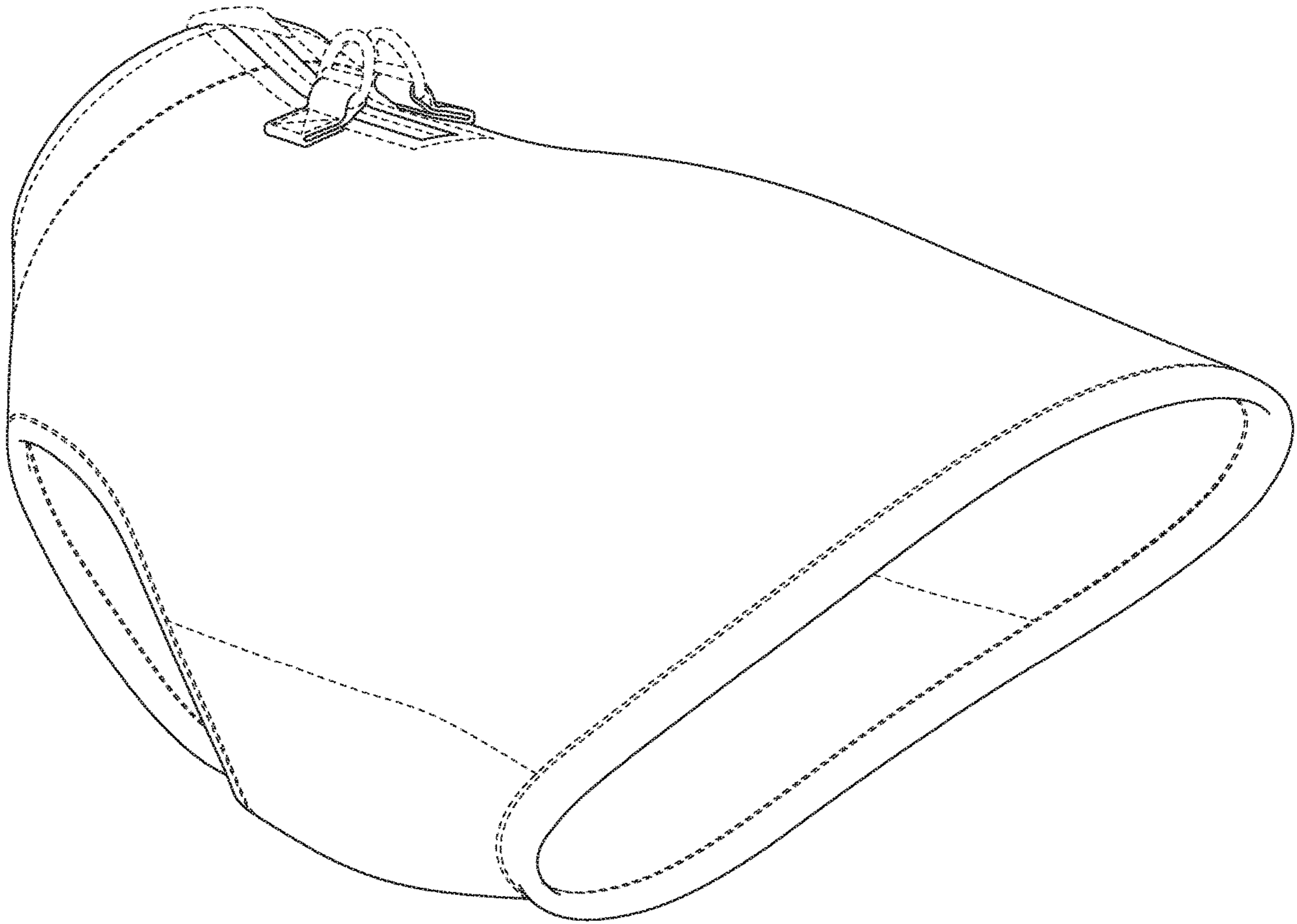

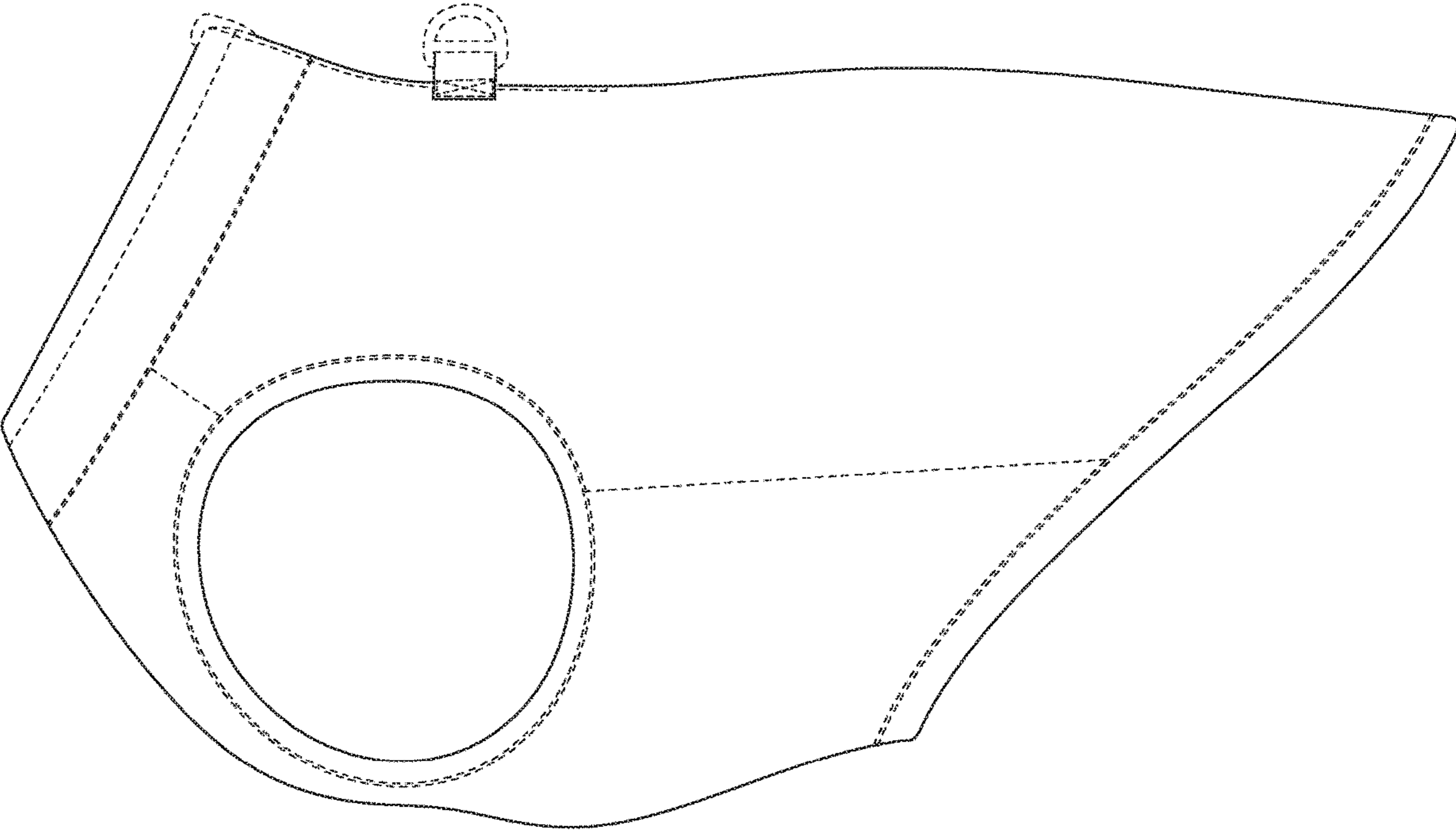

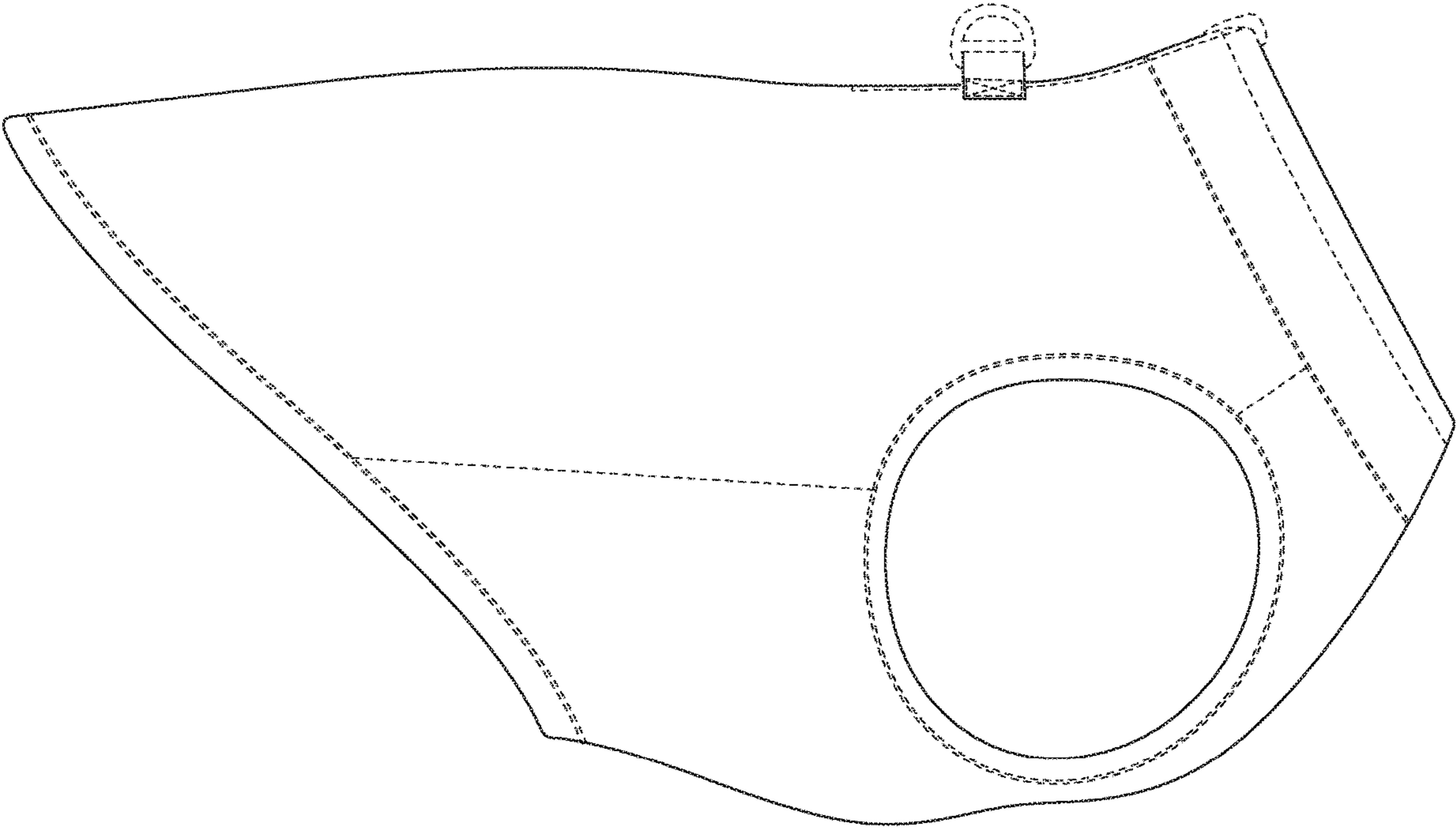

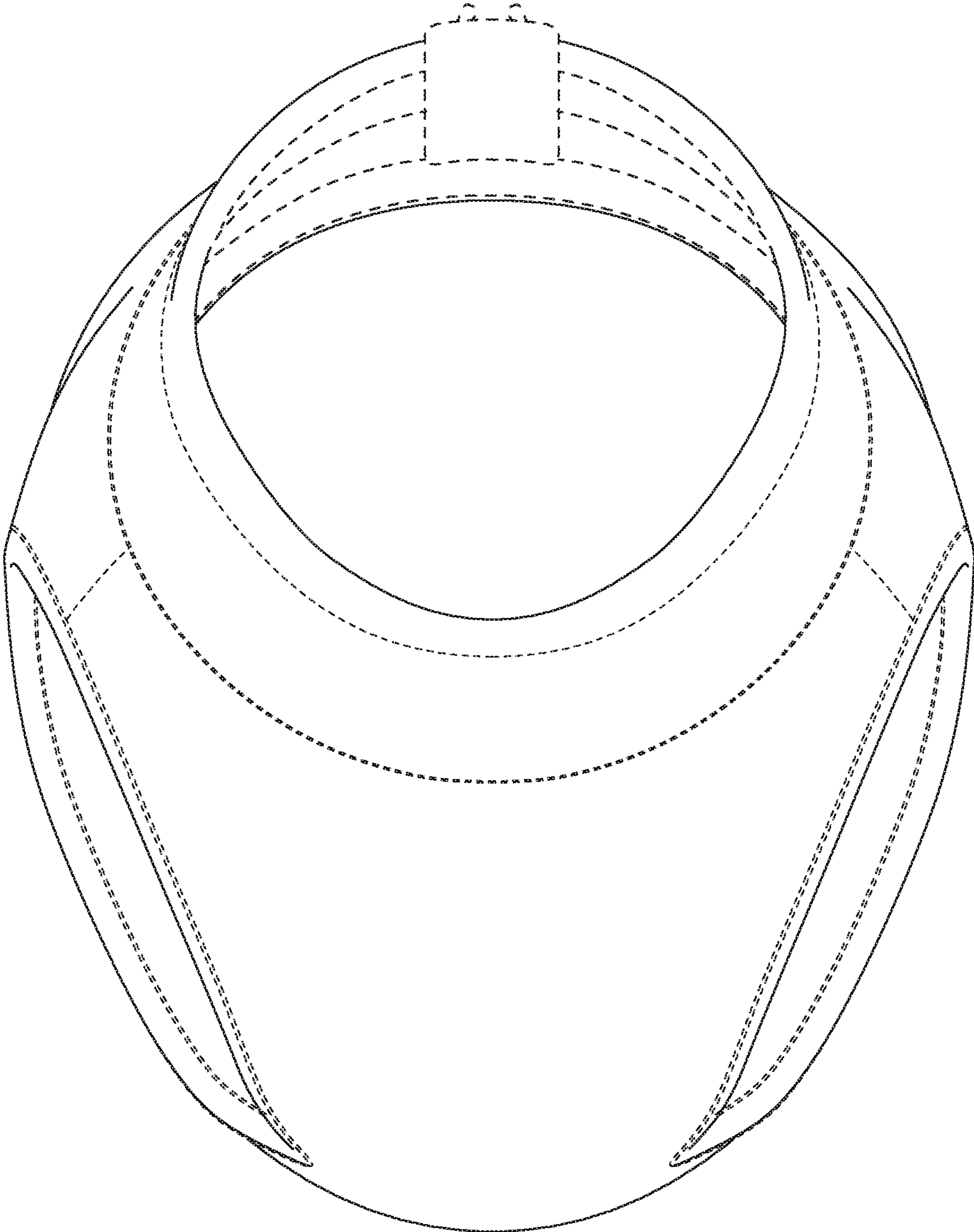

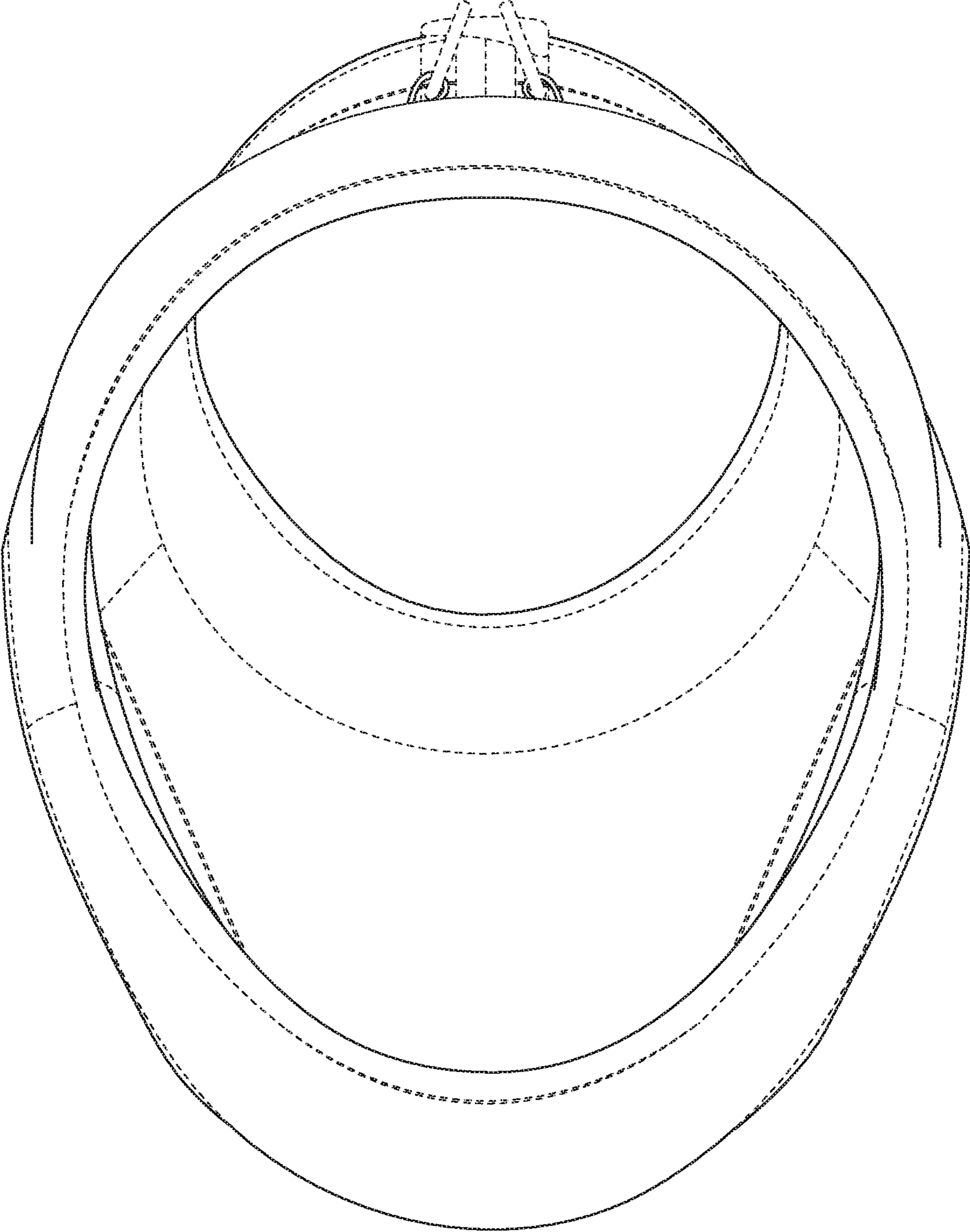

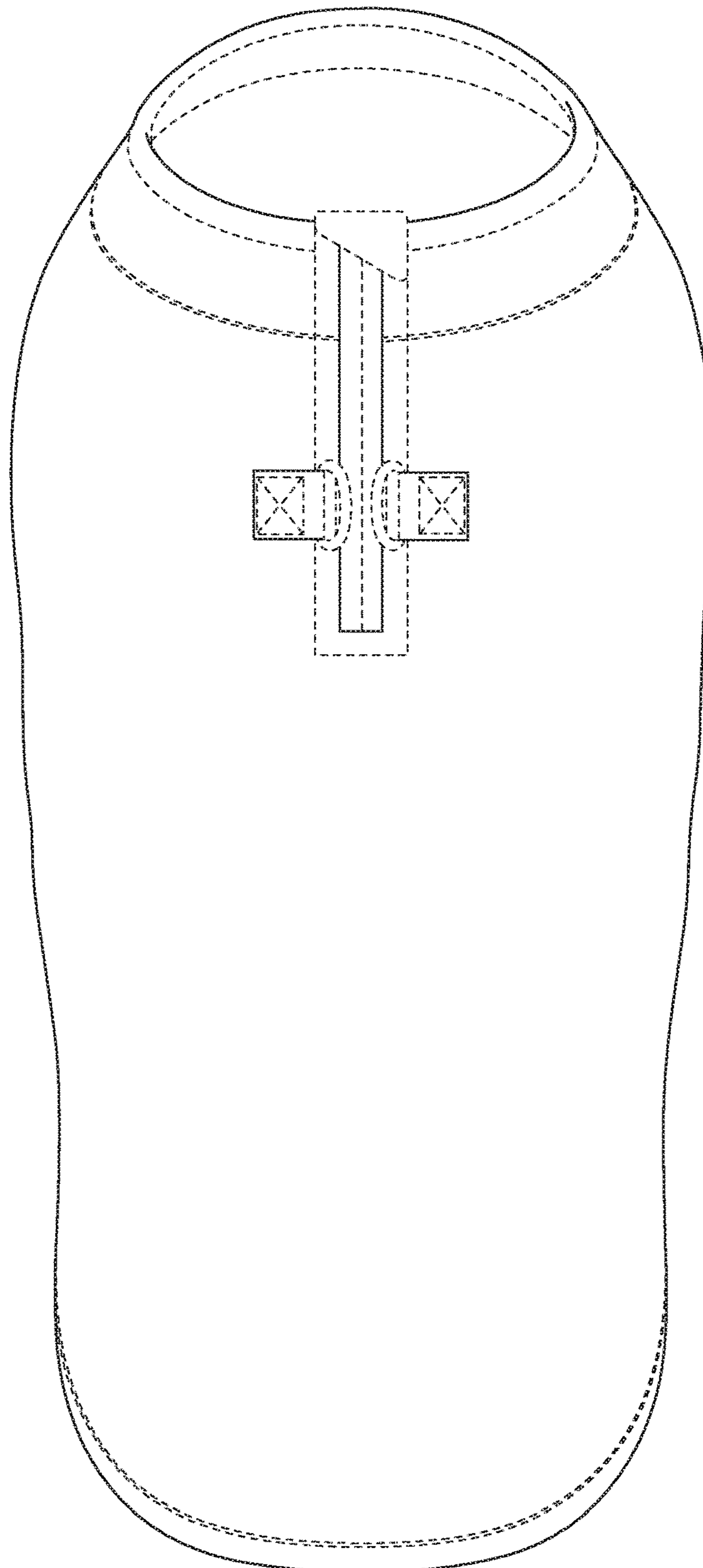
