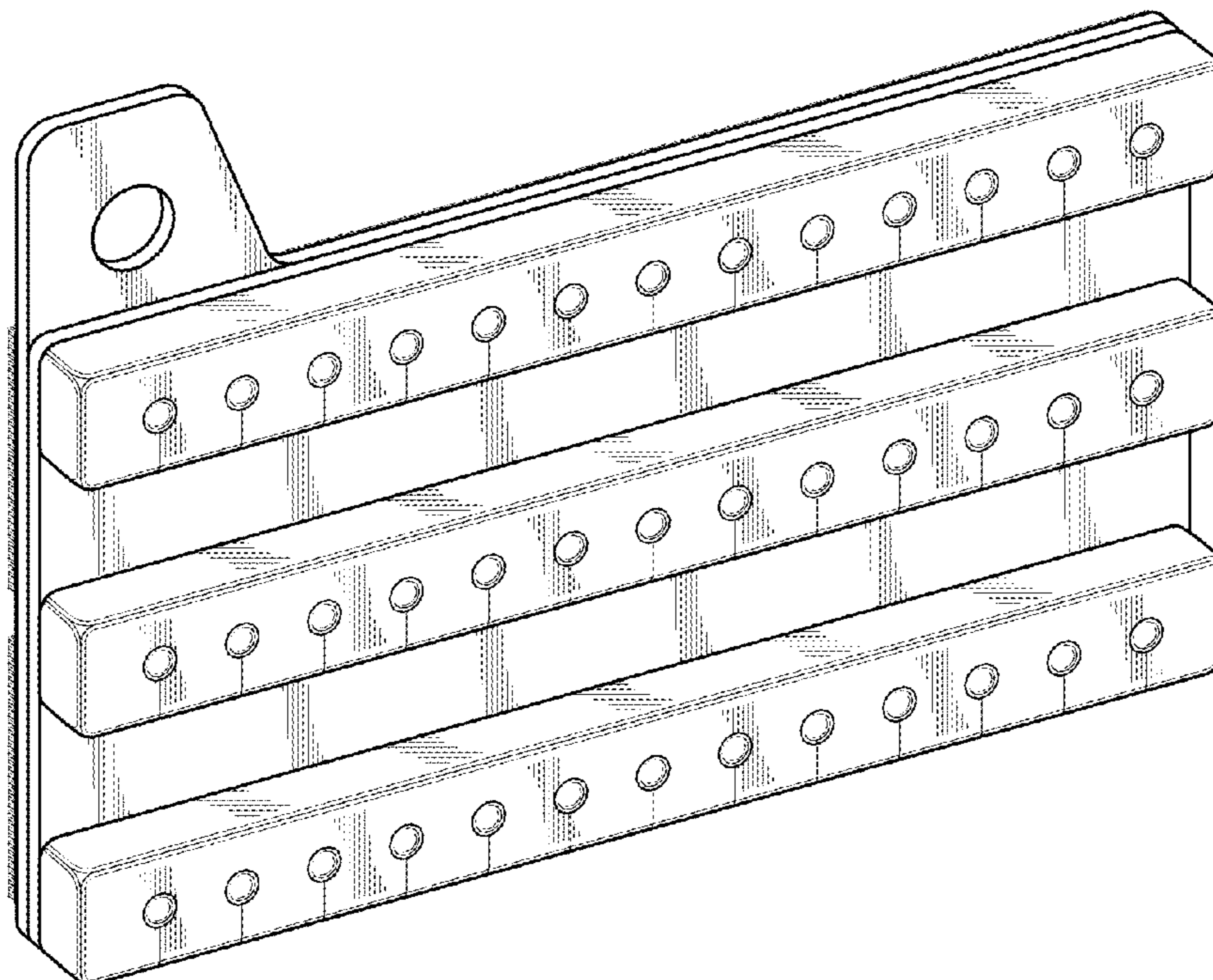
The design for a vest patch, as shown and described.

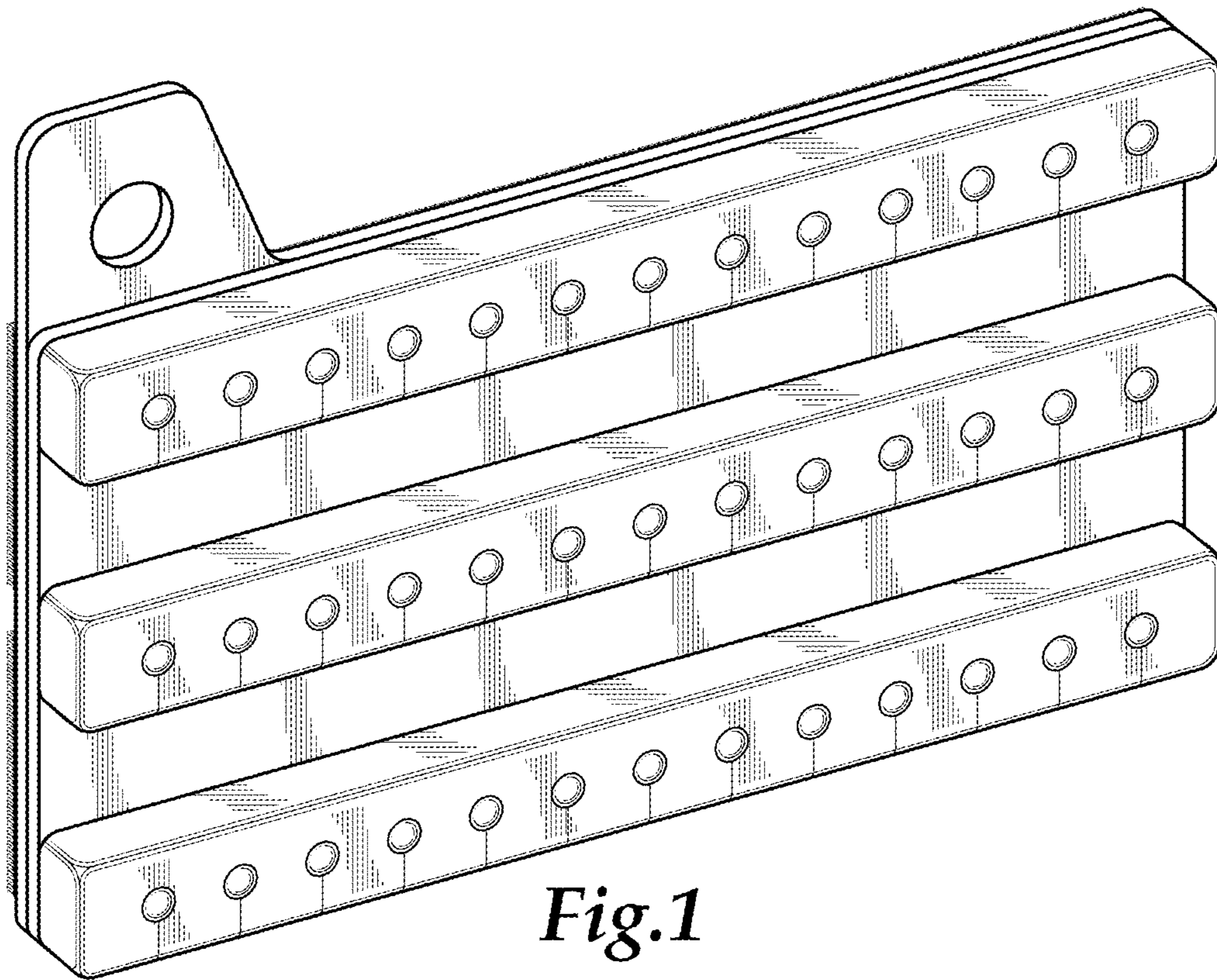

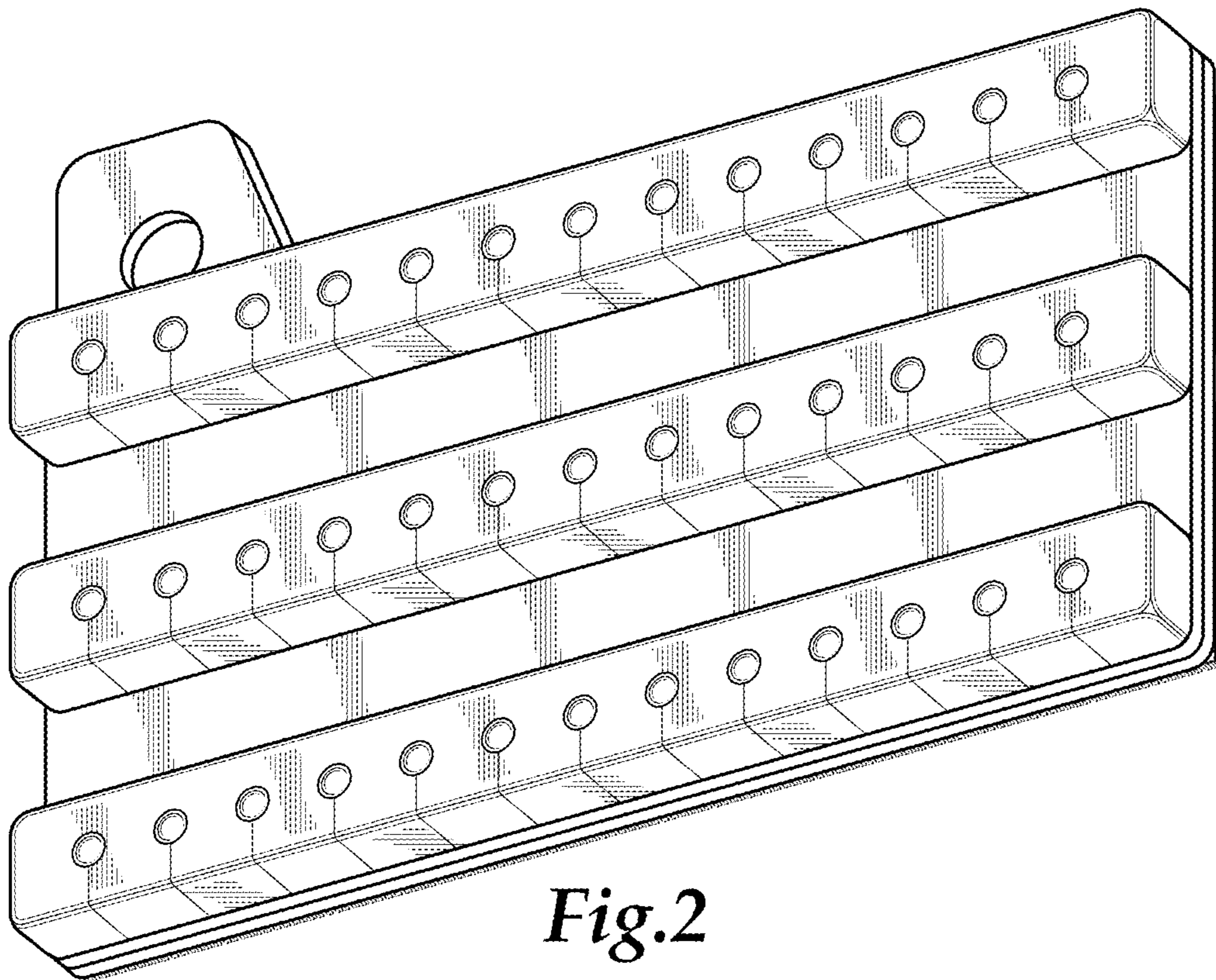

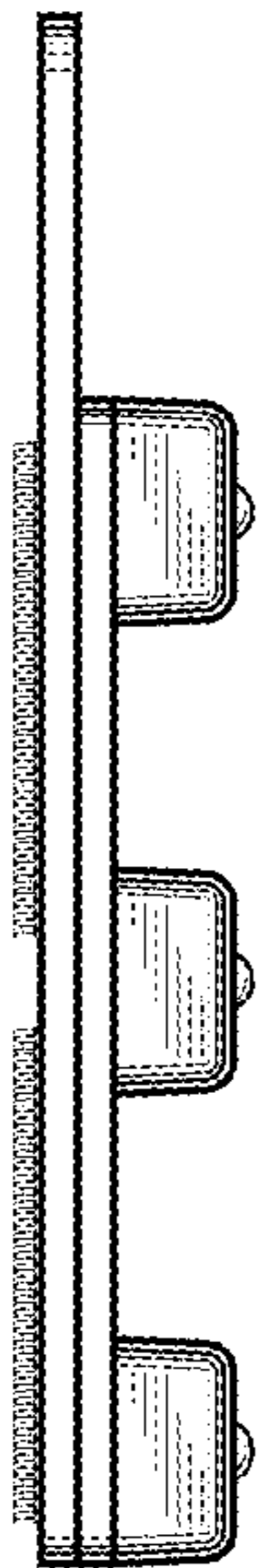

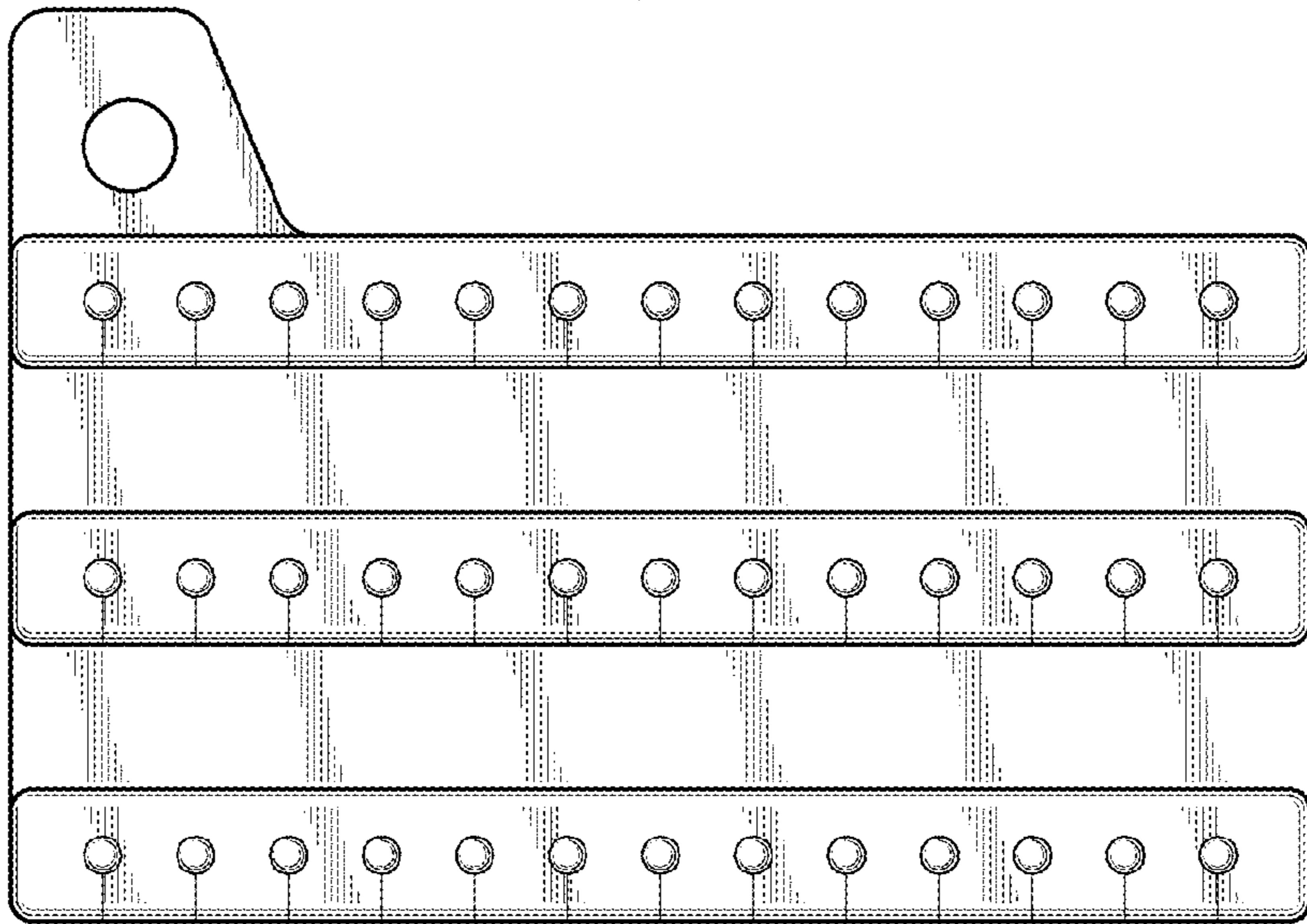

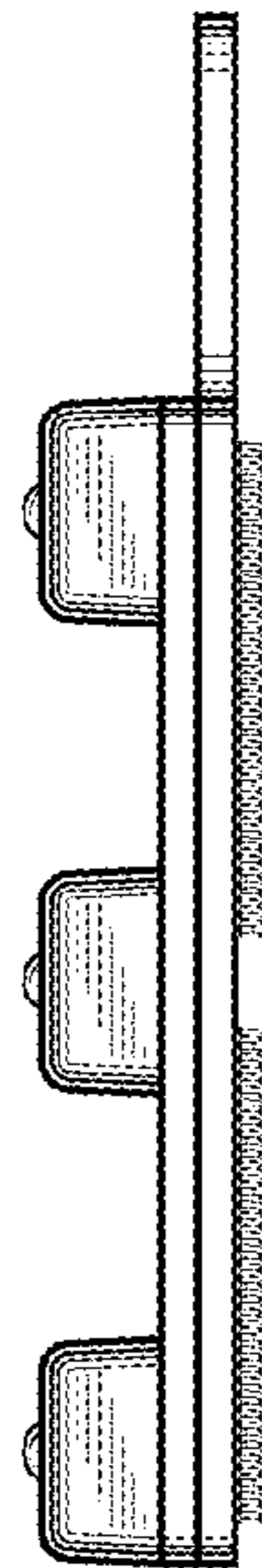

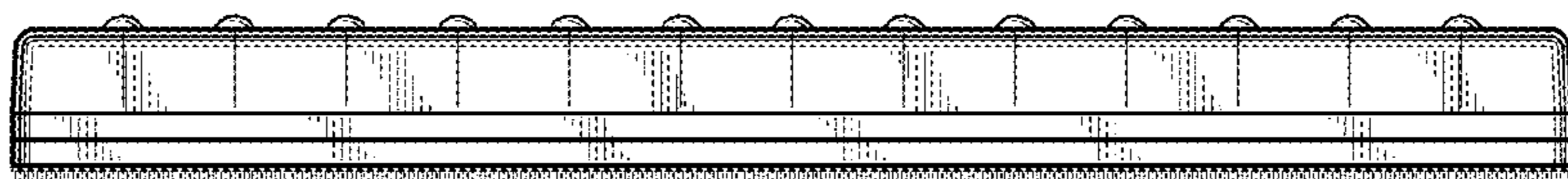
