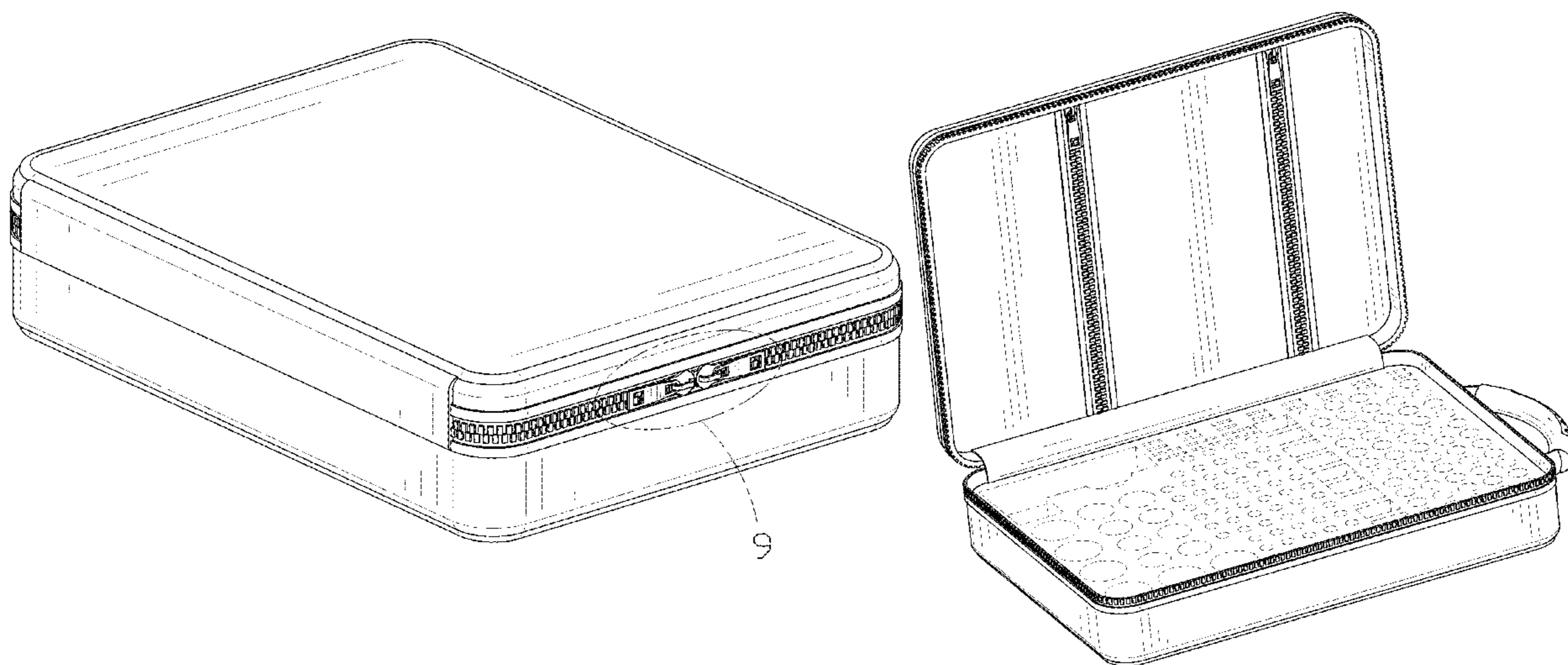
(57) **CLAIM**

The ornamental design for a fireproof battery organizer storage box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fireproof battery organizer storage box showing my new design;

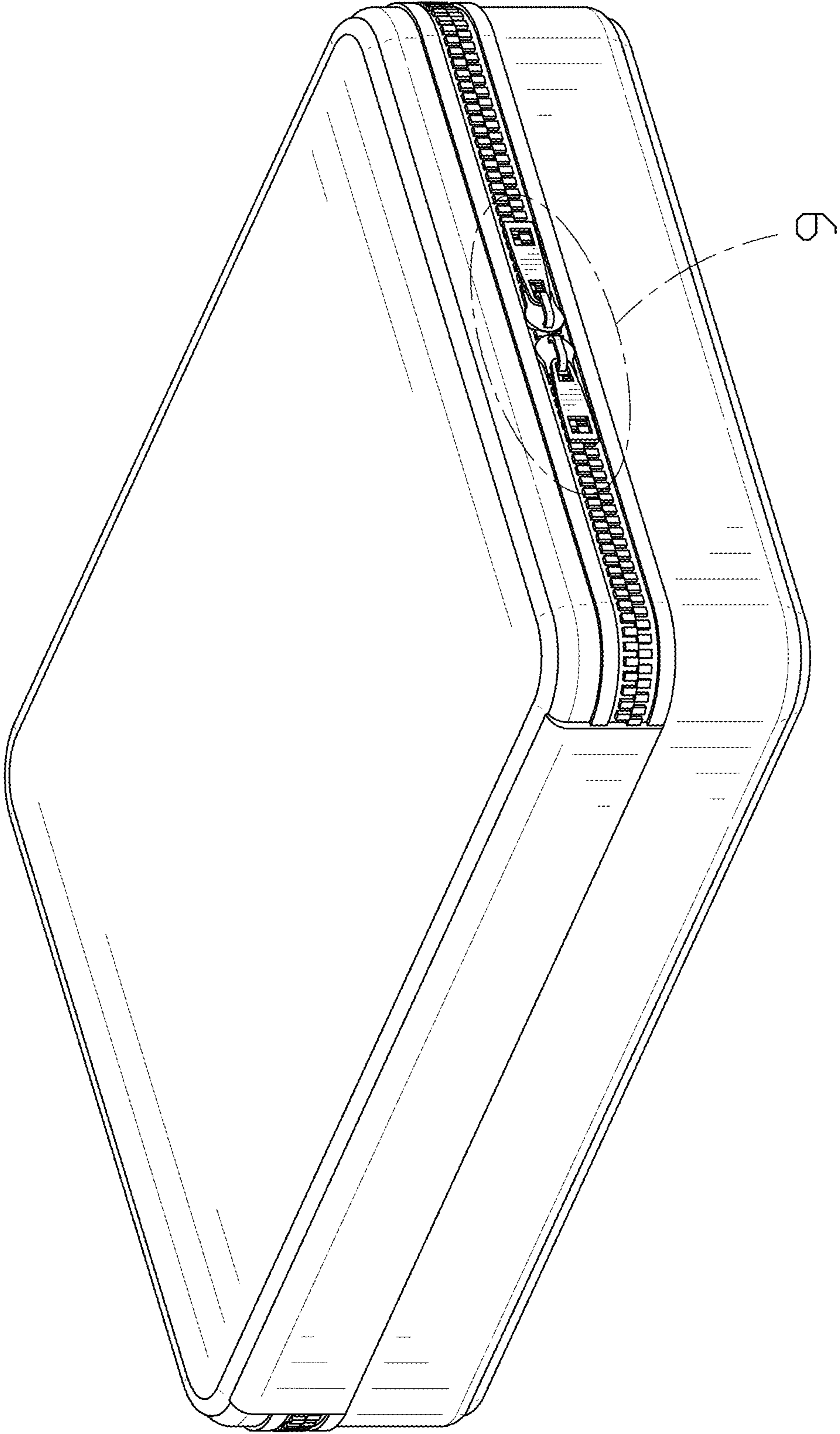

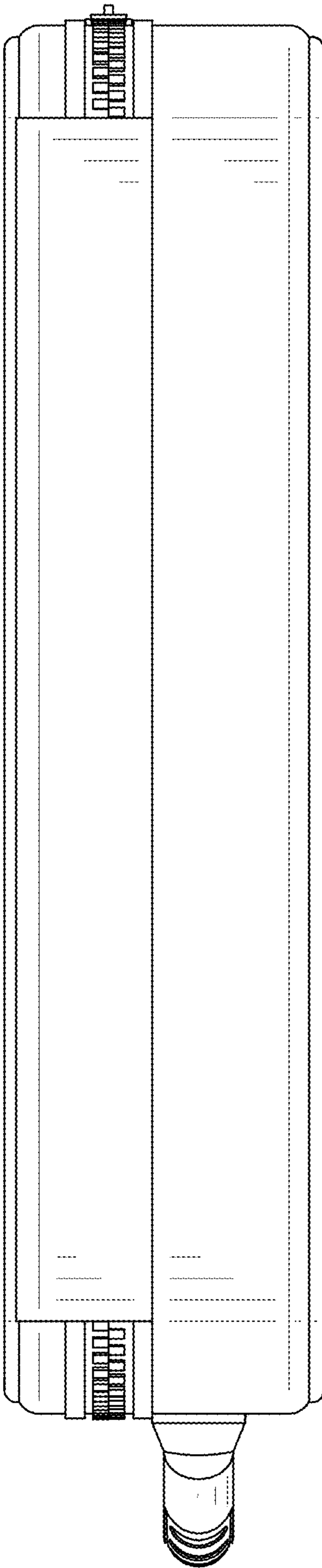

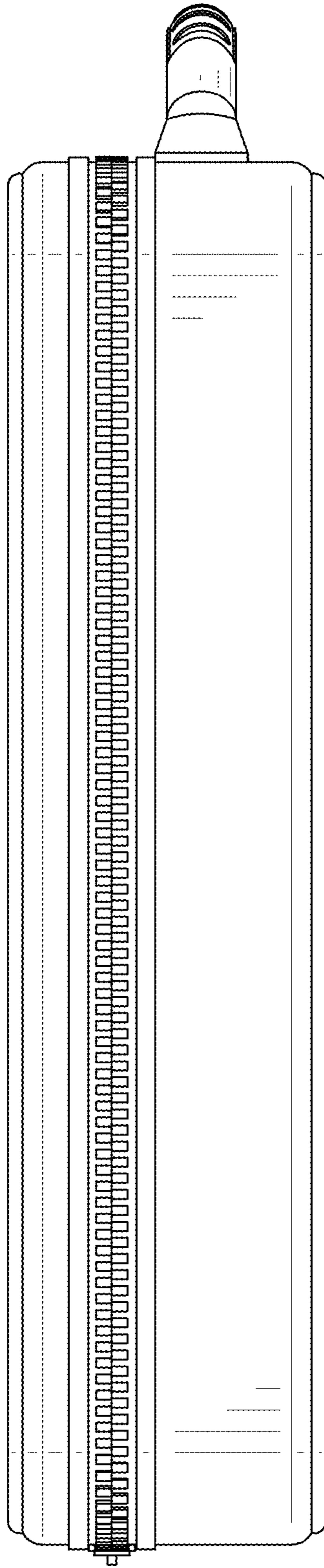

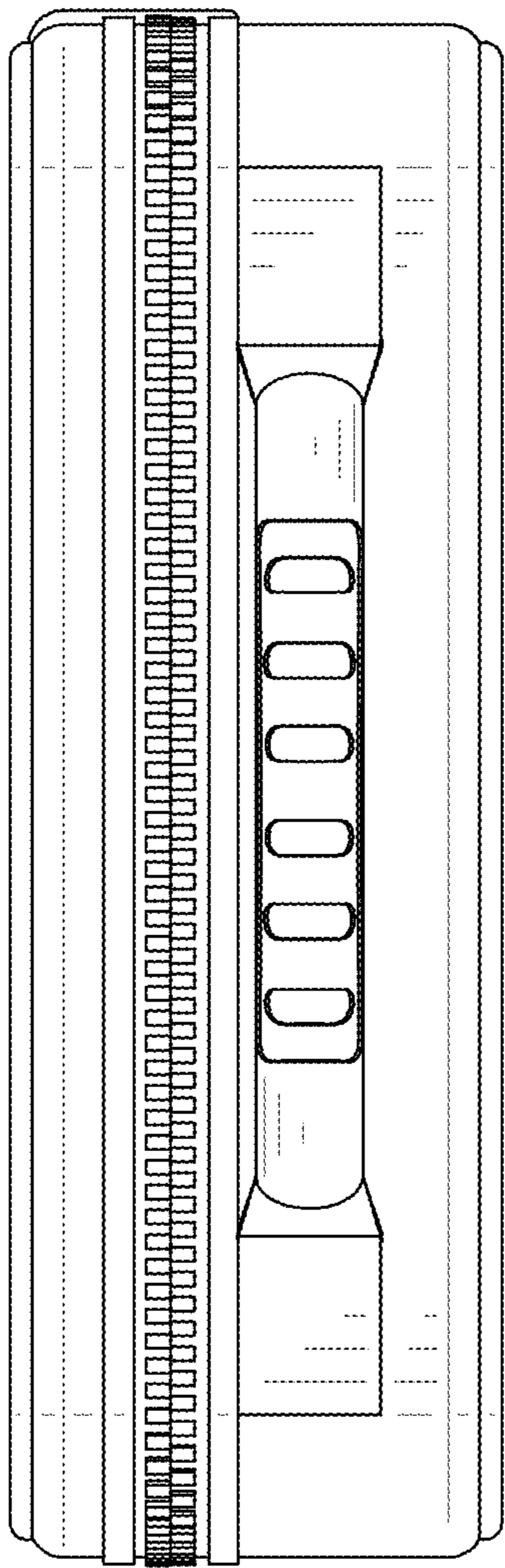

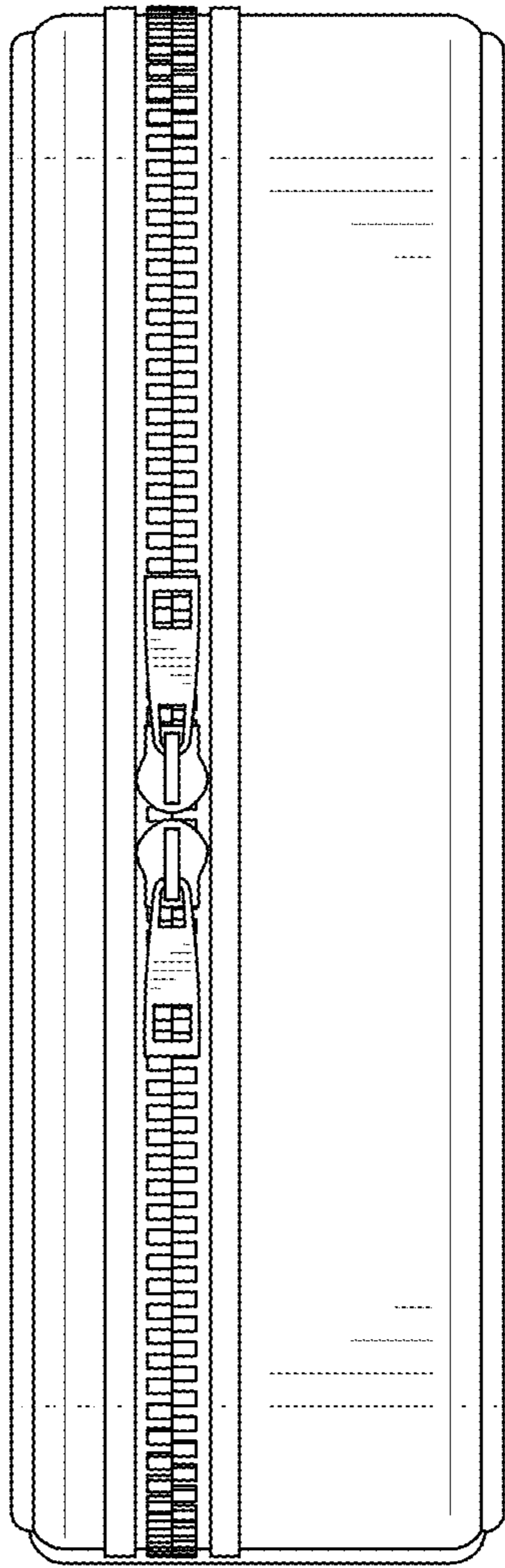

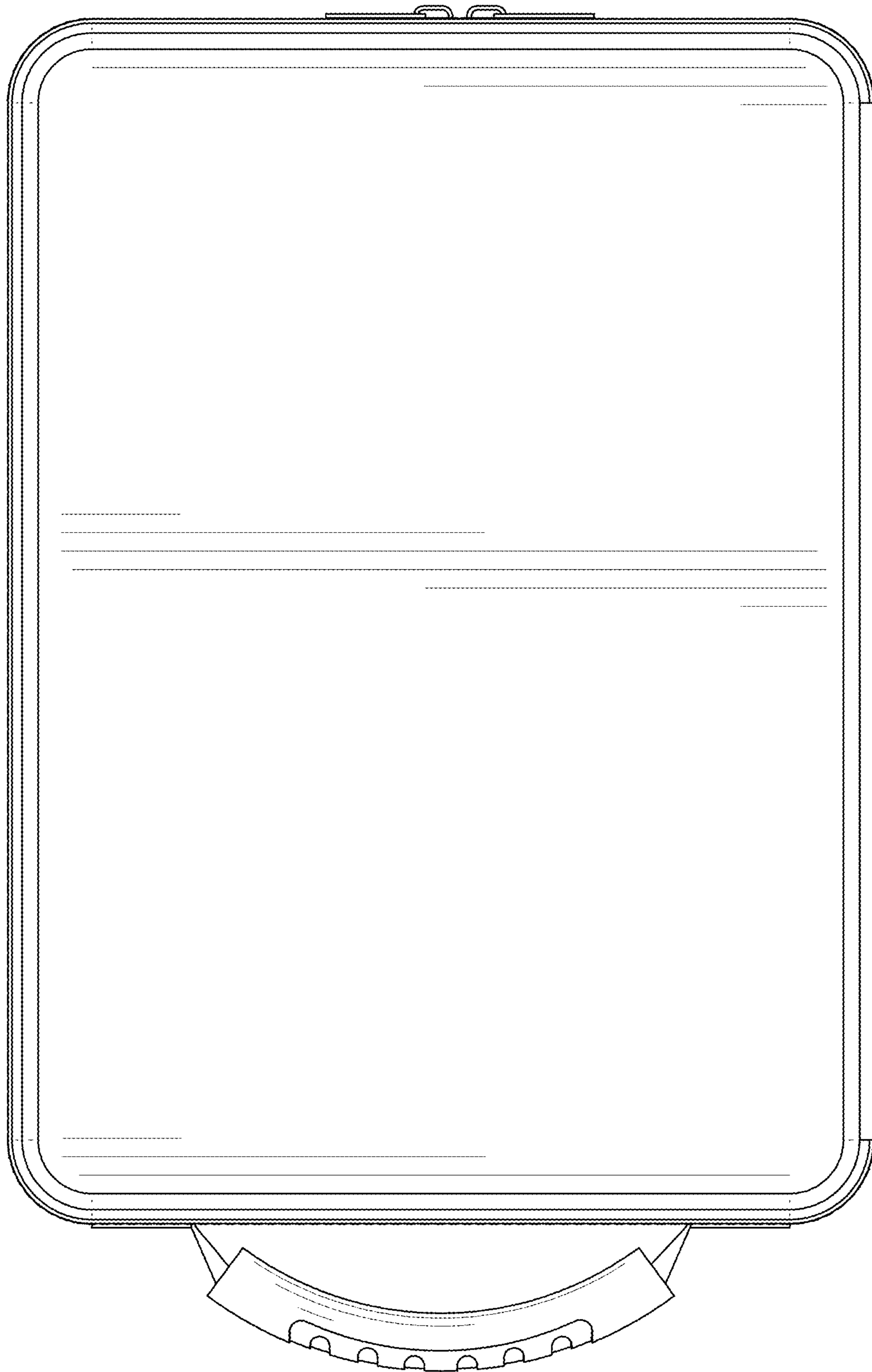

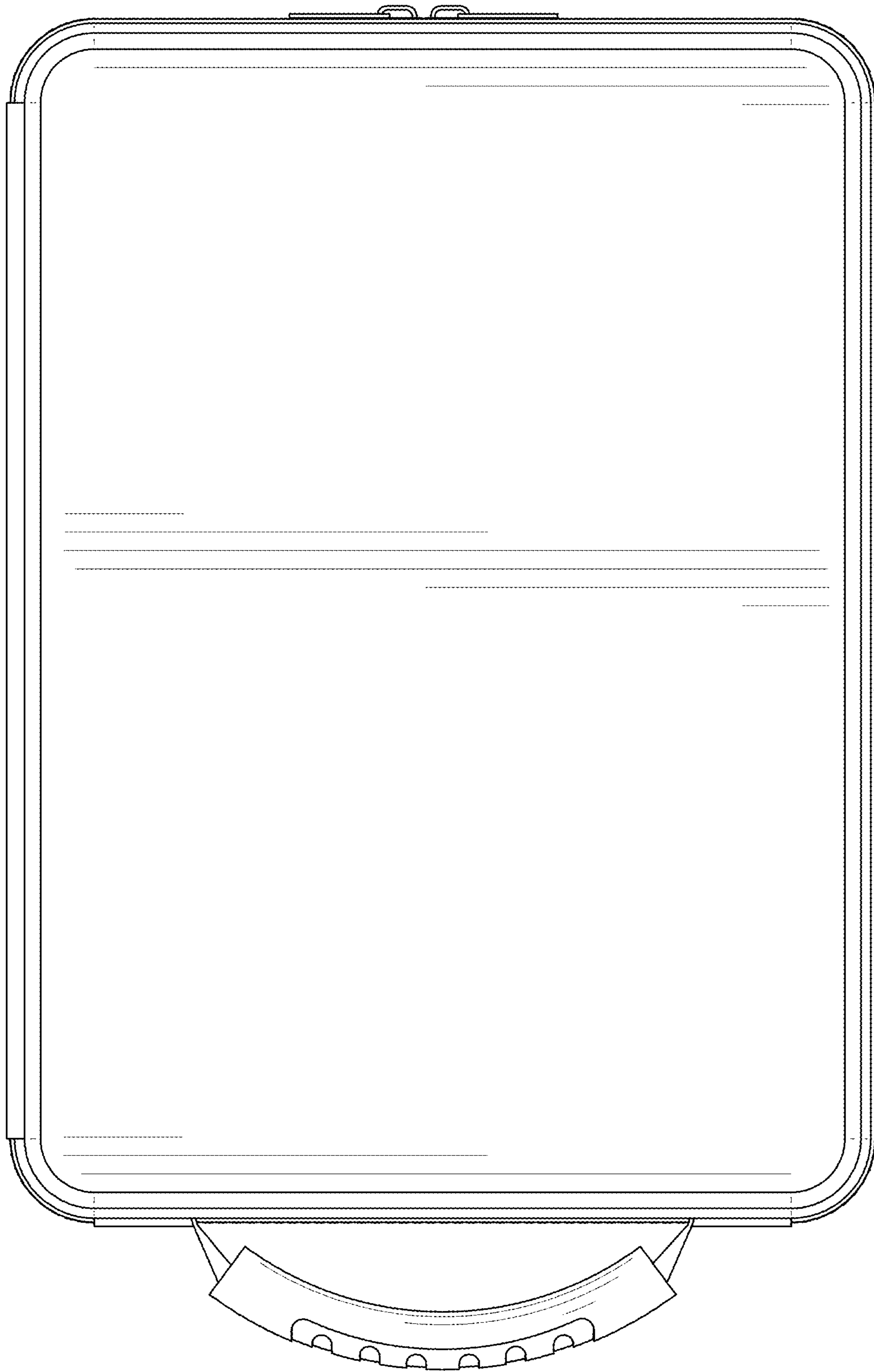

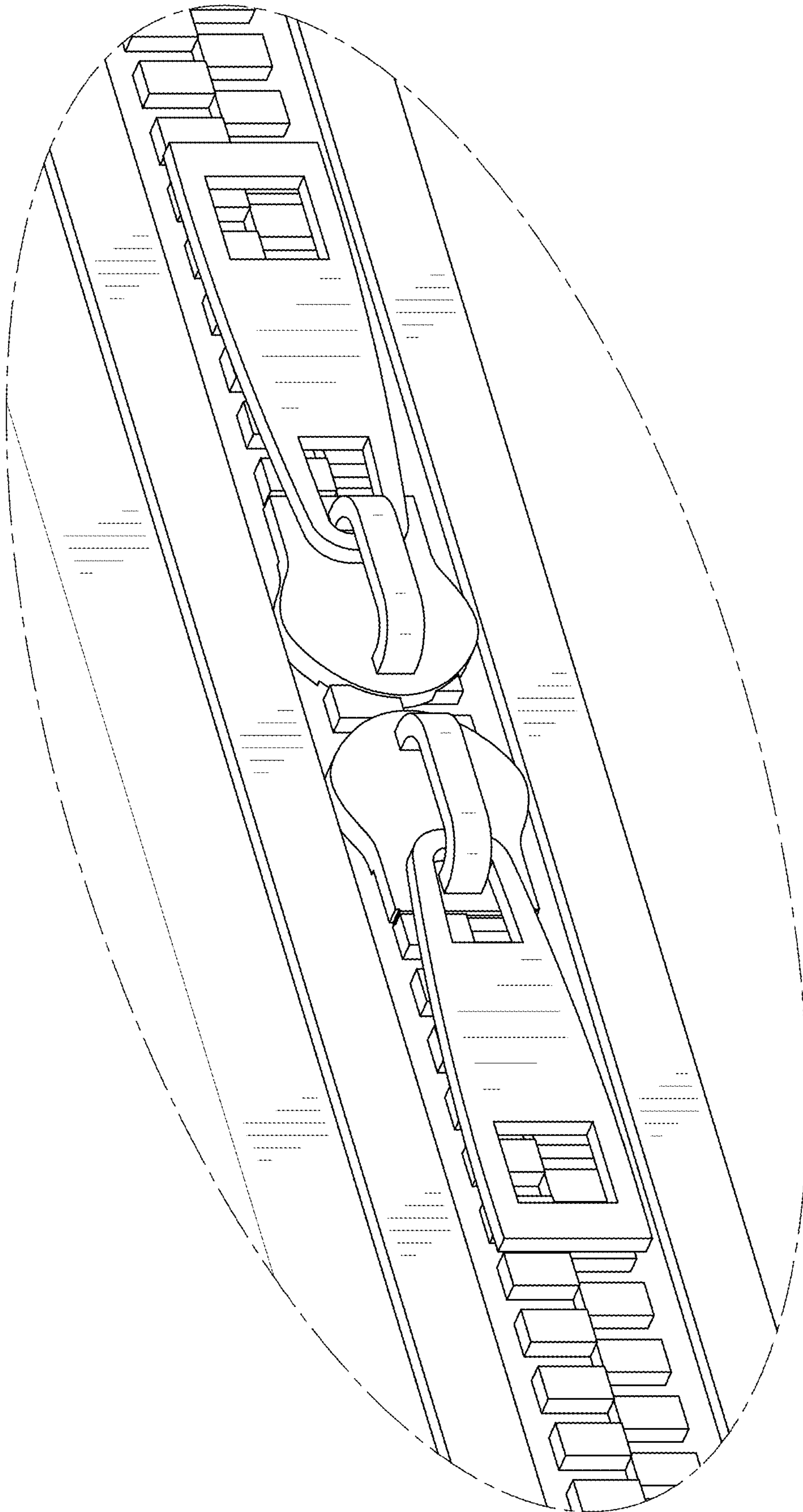
