The ornamental design for a woven fabric, as shown and described.

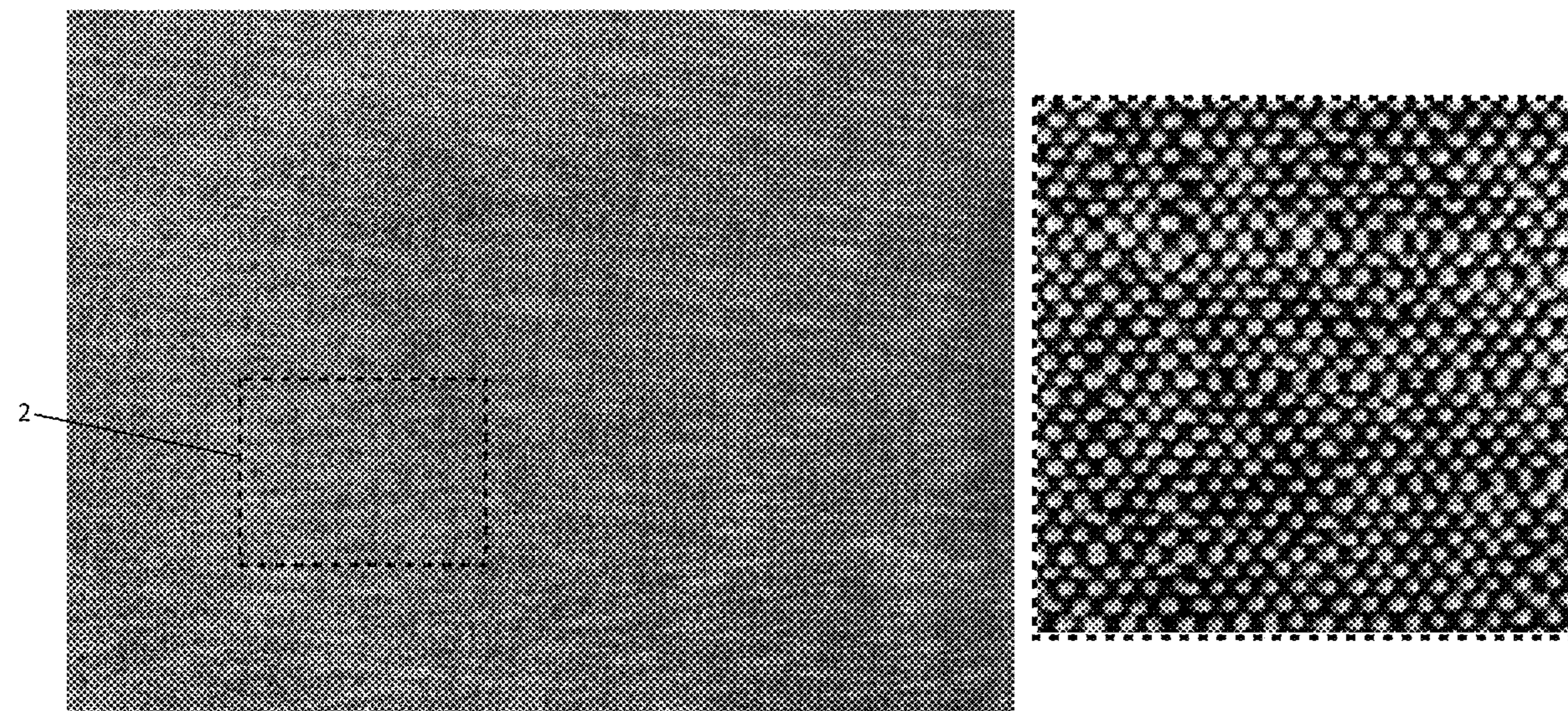
DESCRIPTION

FIG. 1 is a top view of a woven fabric;

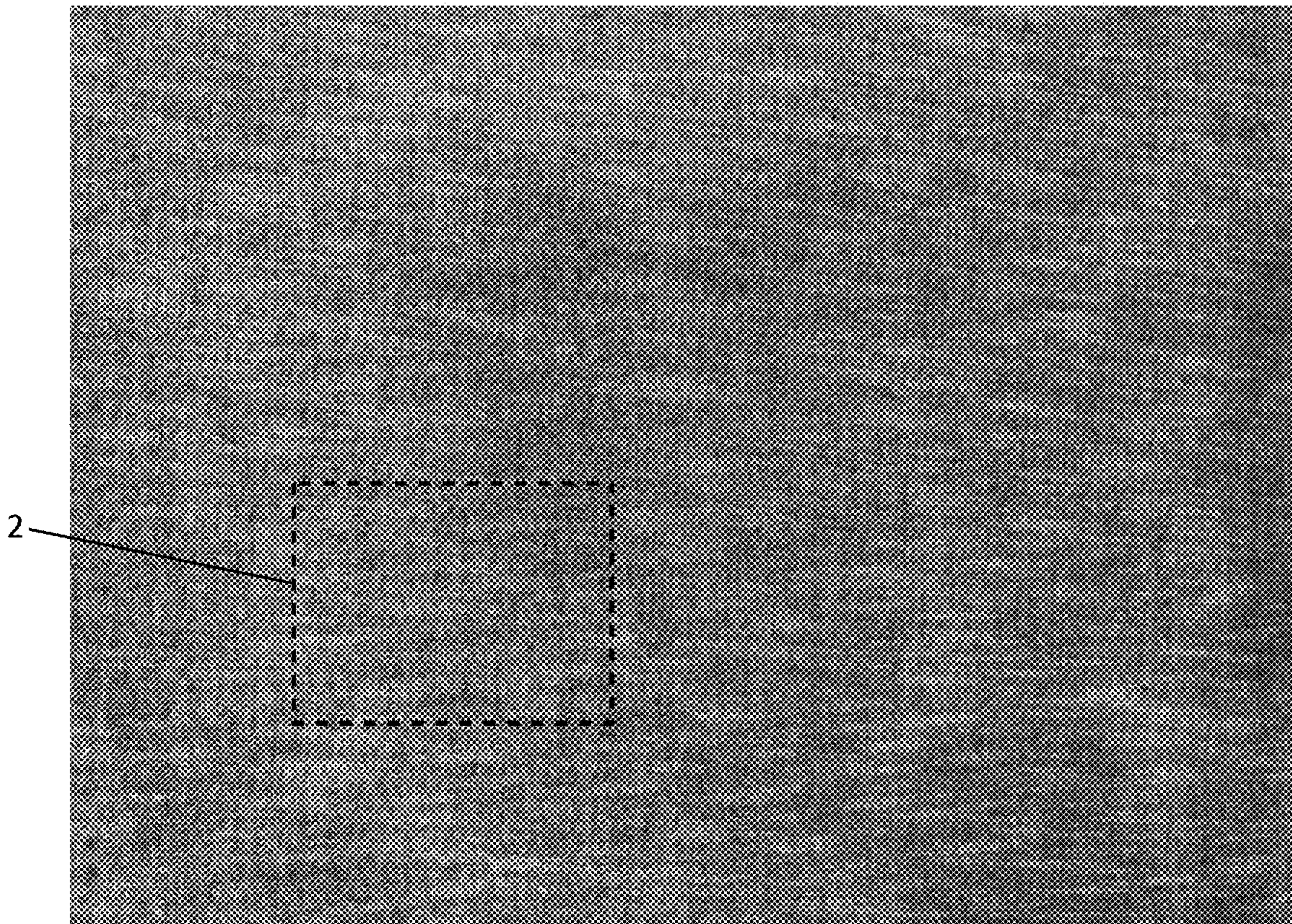

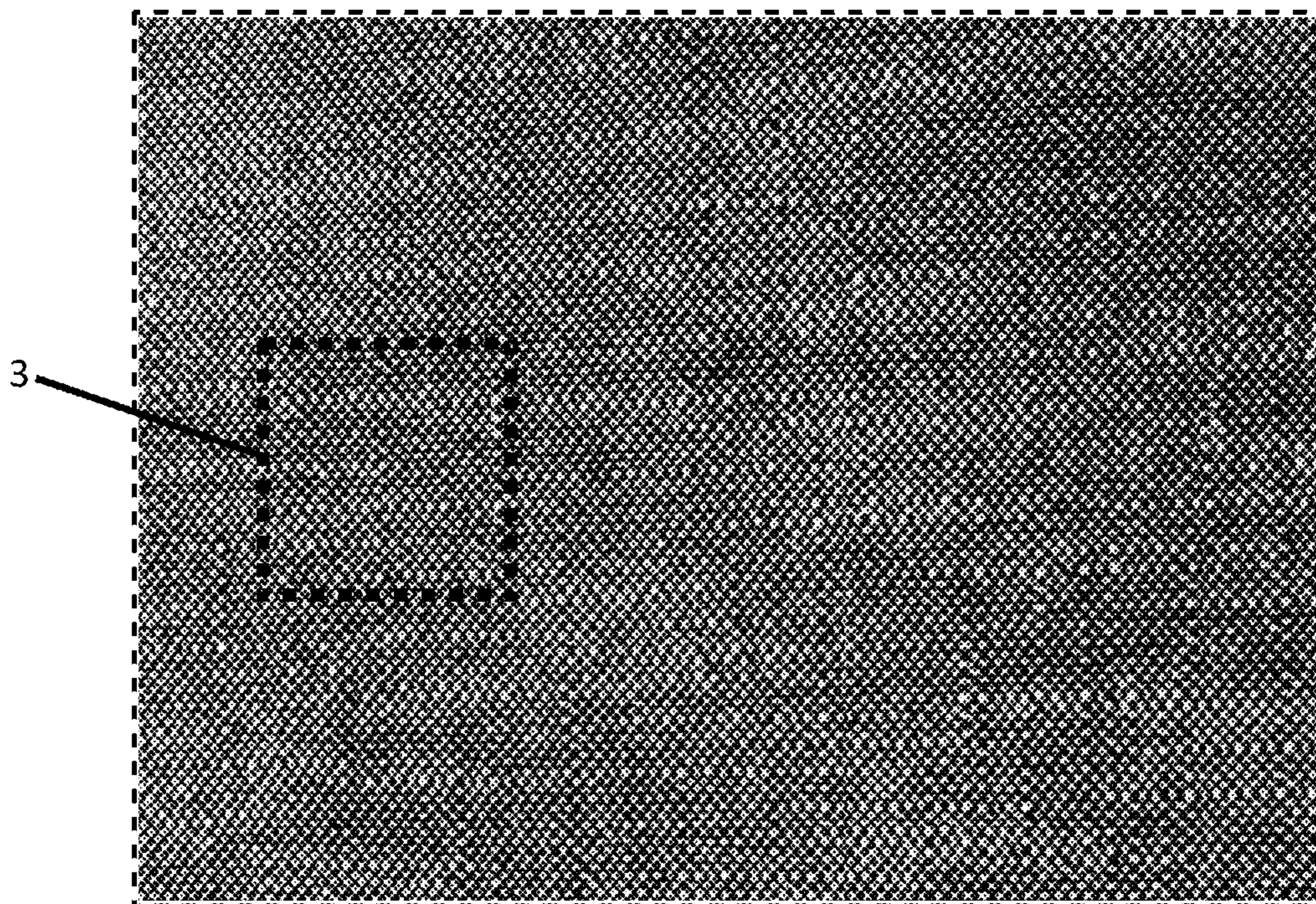

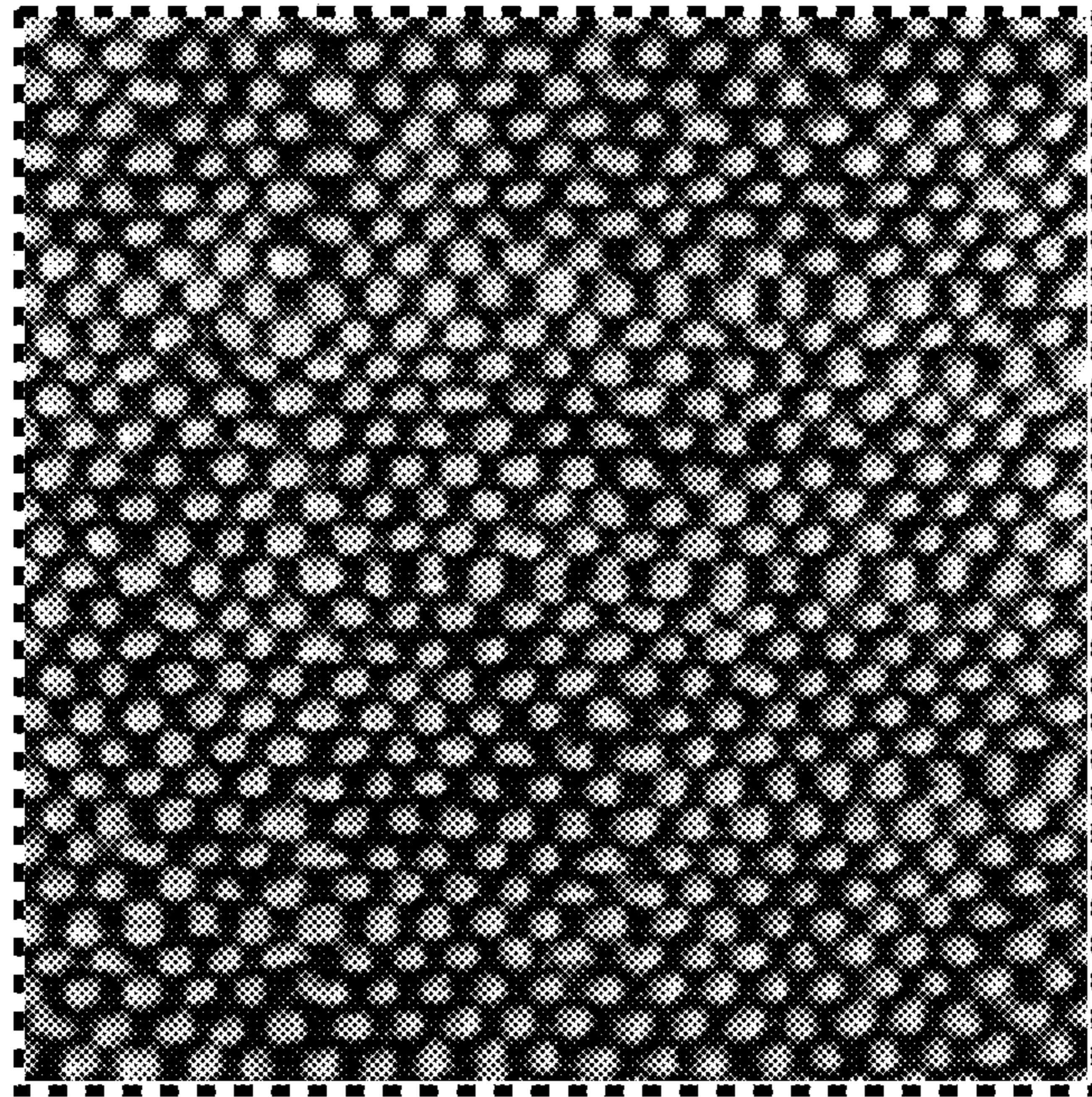
