(57) **CLAIM**

The ornamental design for a chaise, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of an exemplary chaise showing my new design in a first (elevated back) configuration;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a right side elevation view thereof, the left side being a mirror image;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a front and right side perspective view of the exemplary chaise showing my new design in a second (lowered back) configuration; and,
FIG. 7 is a close-up view of a weave pattern on the chaise, as viewed from a right side elevation view thereof.
The broken lines show environmental subject matter and form no part of the claimed design.

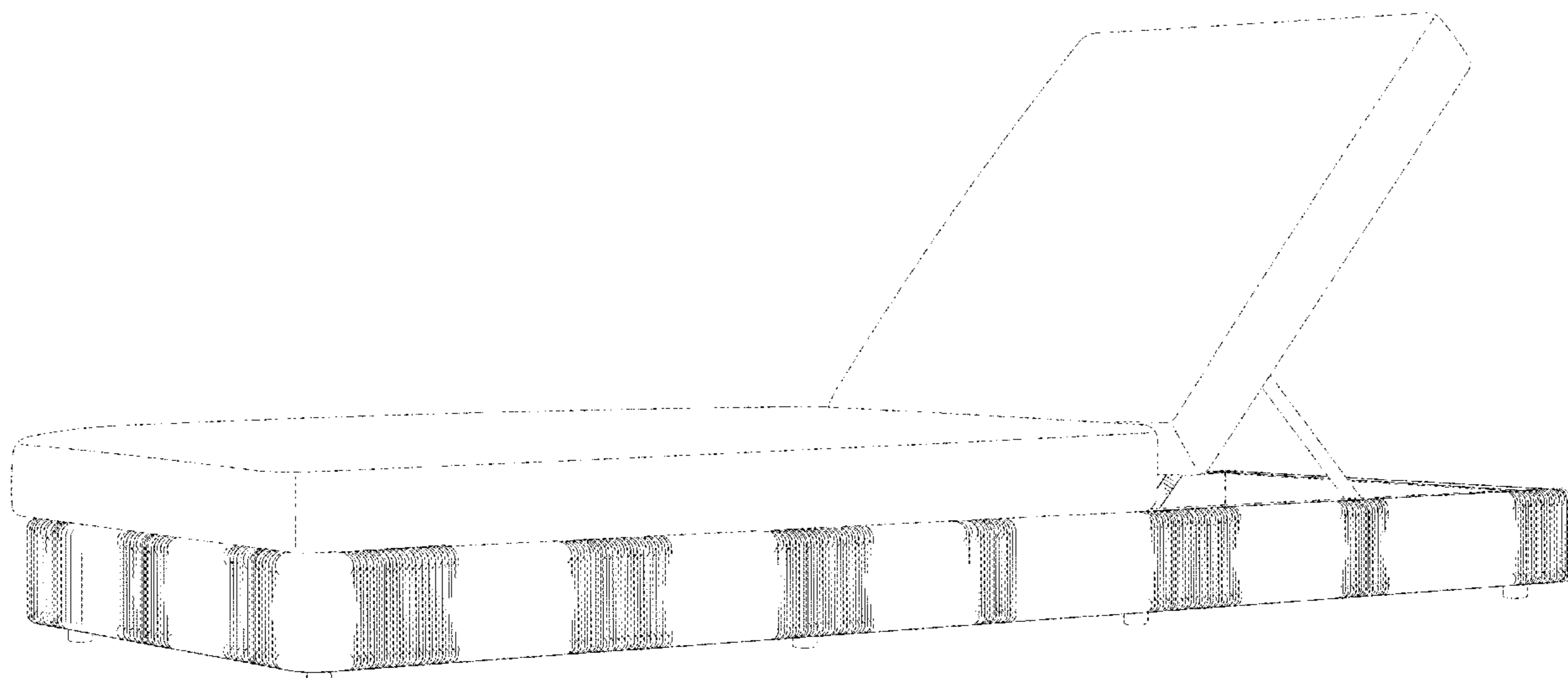

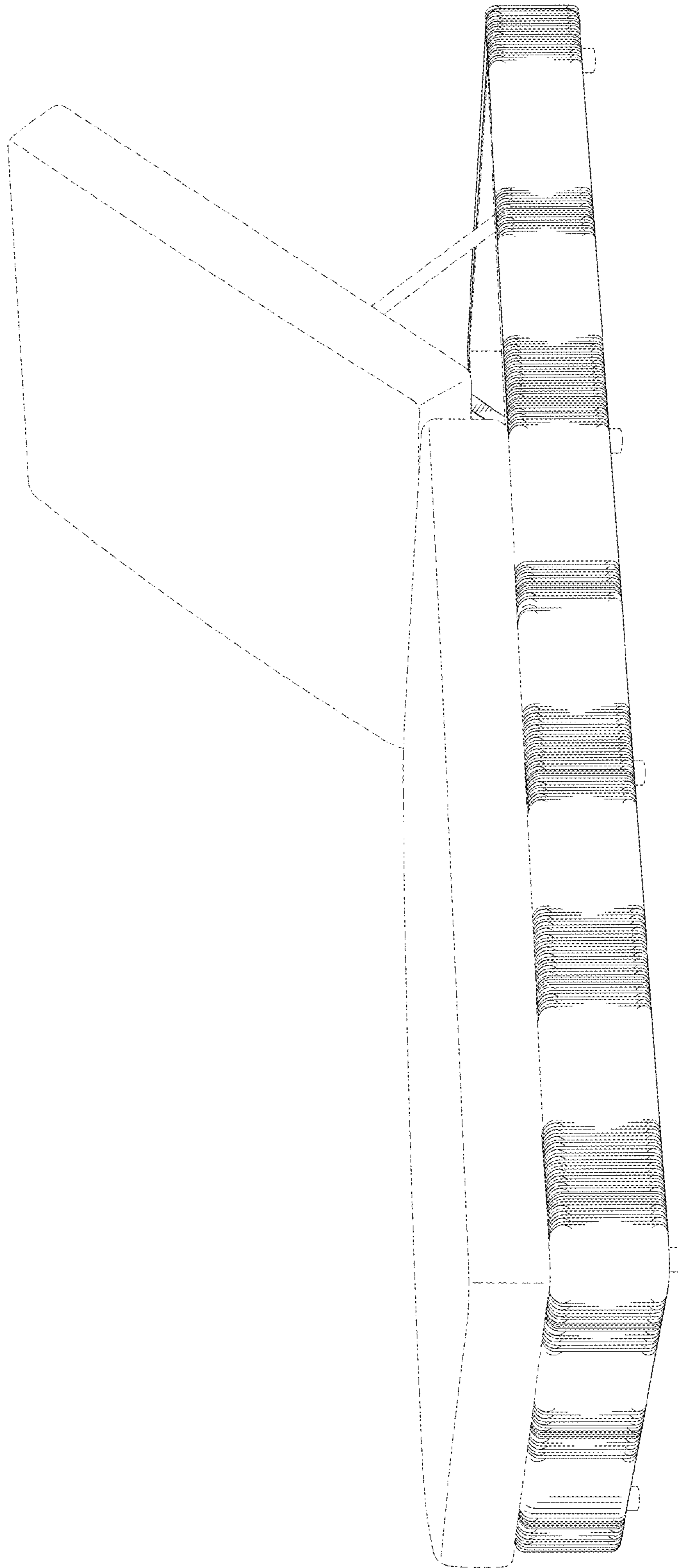

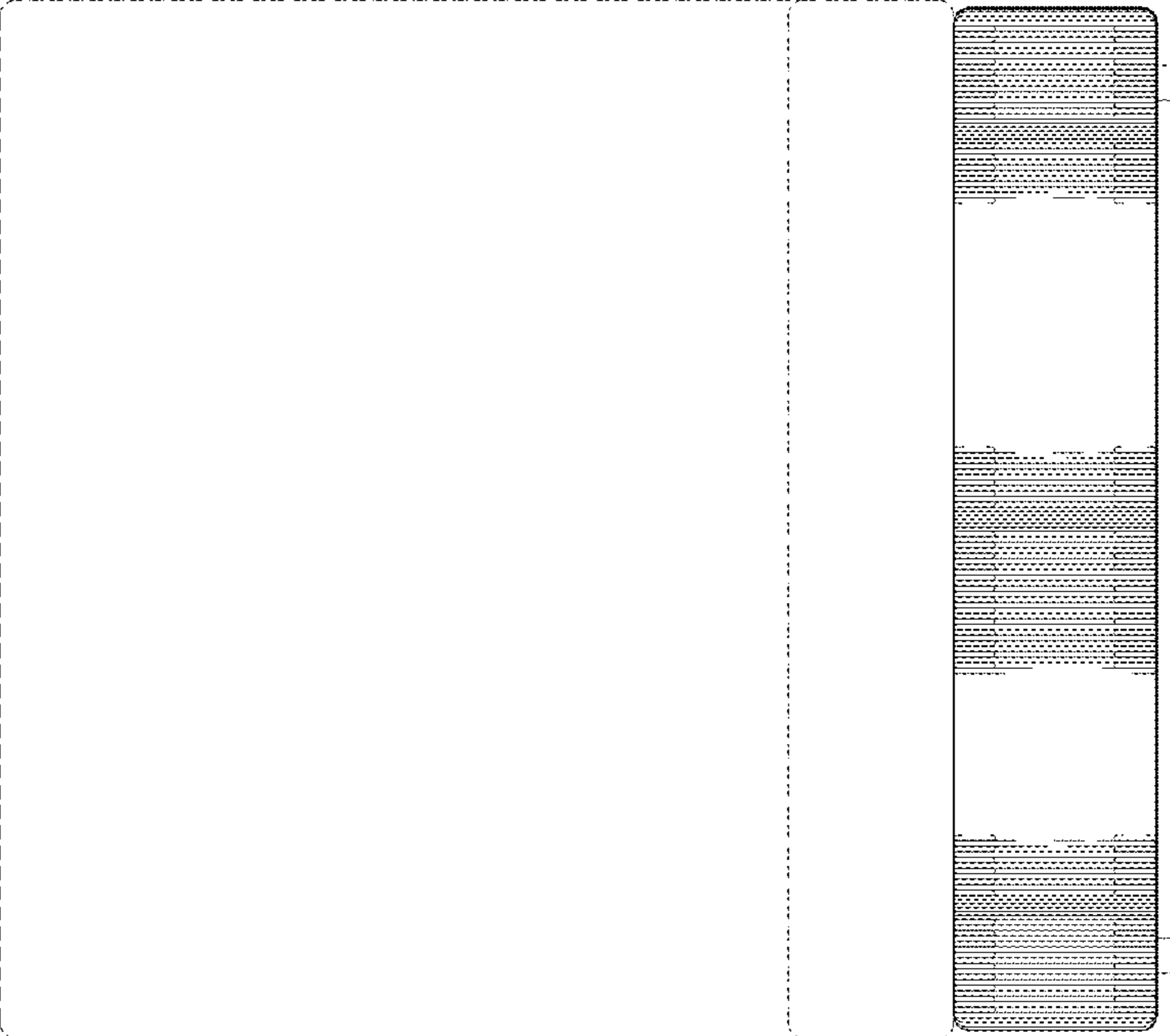

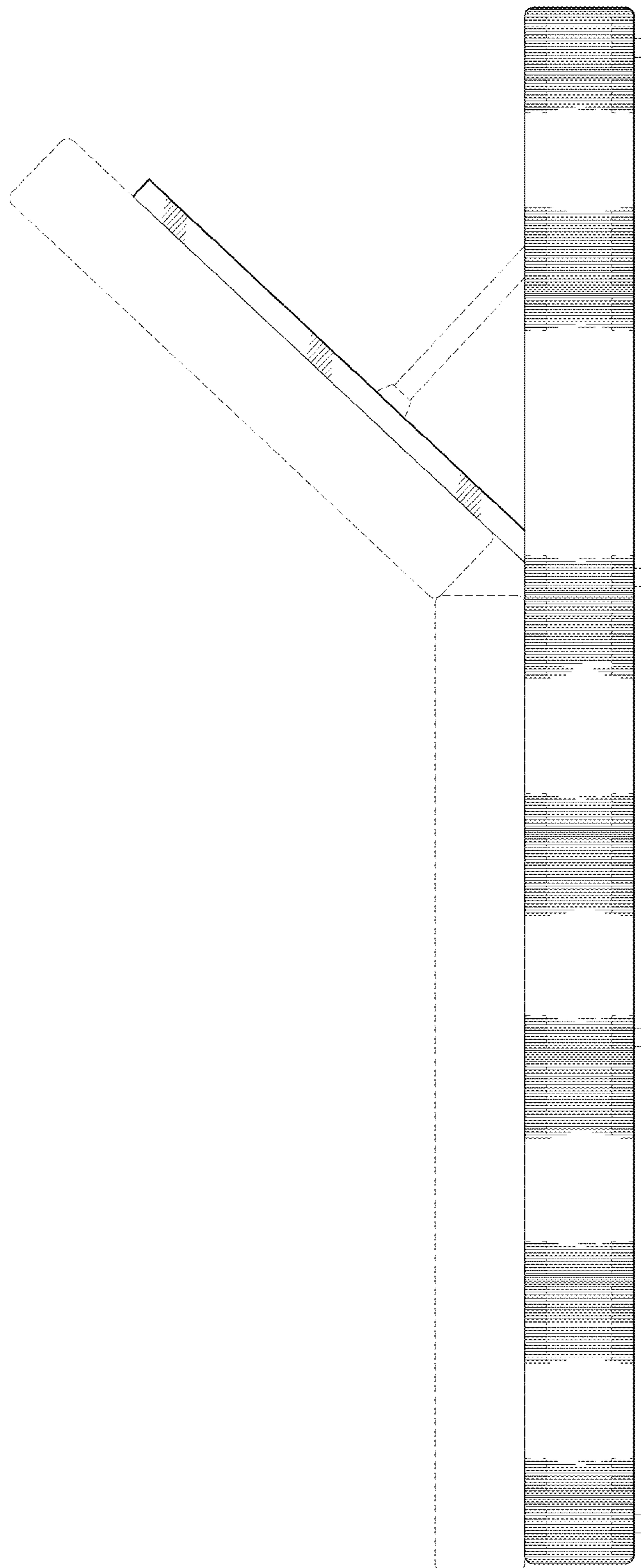

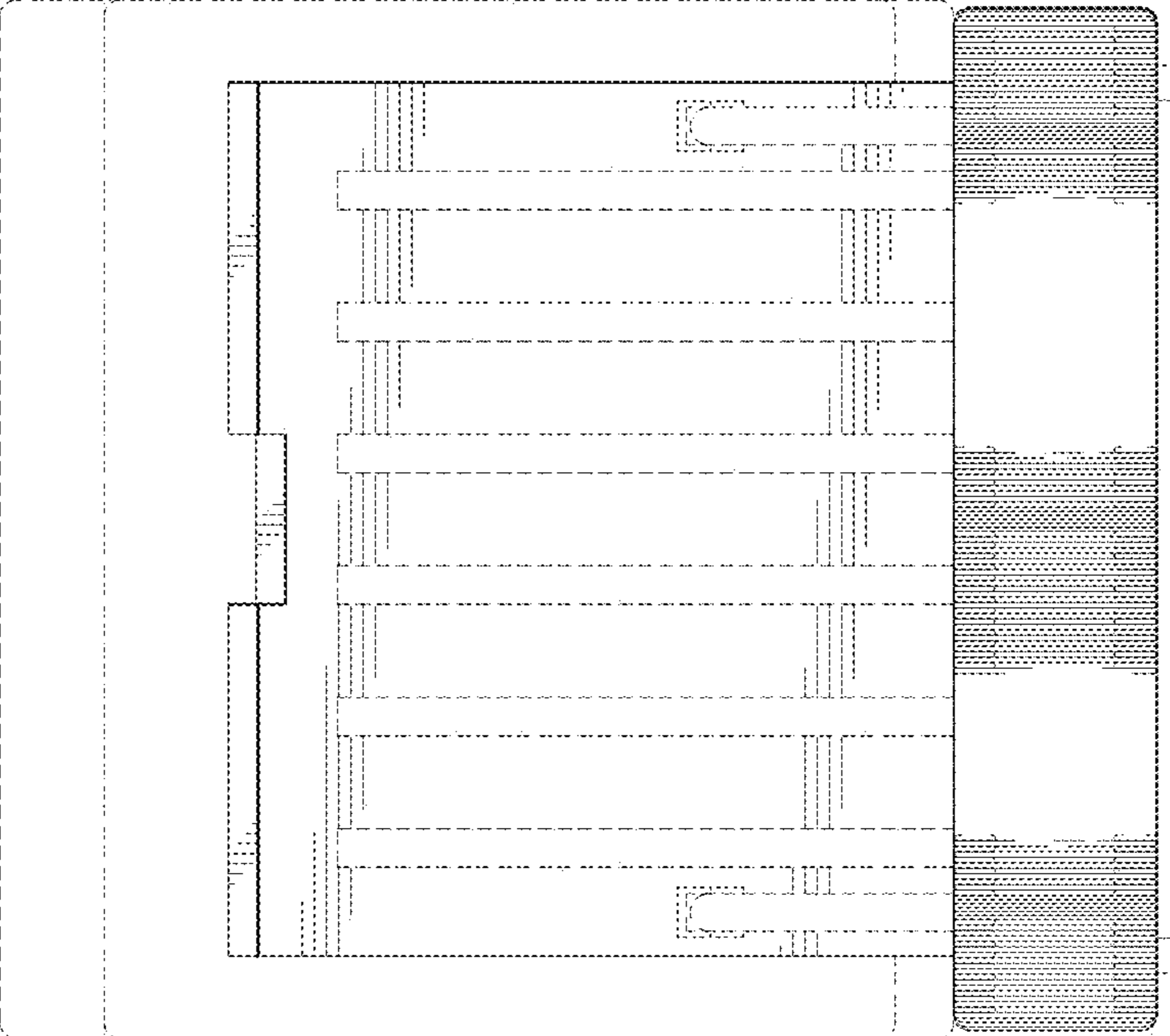

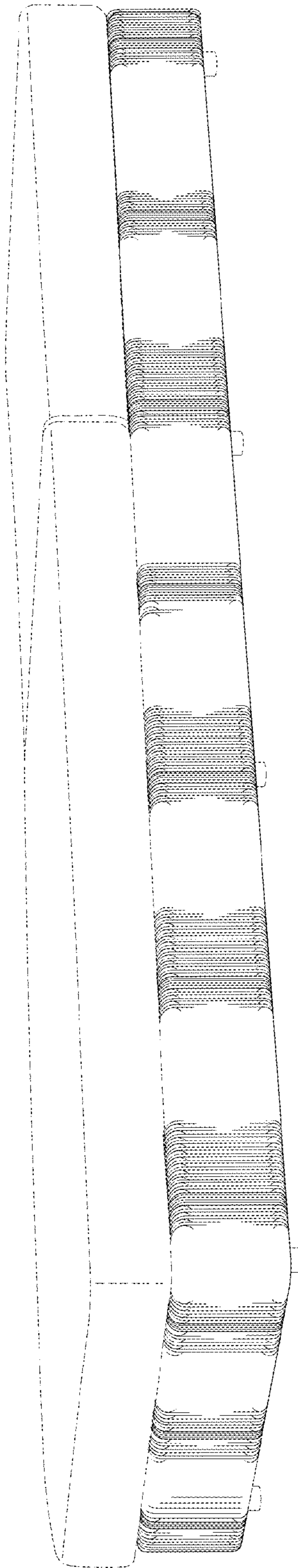
