(57) **CLAIM**

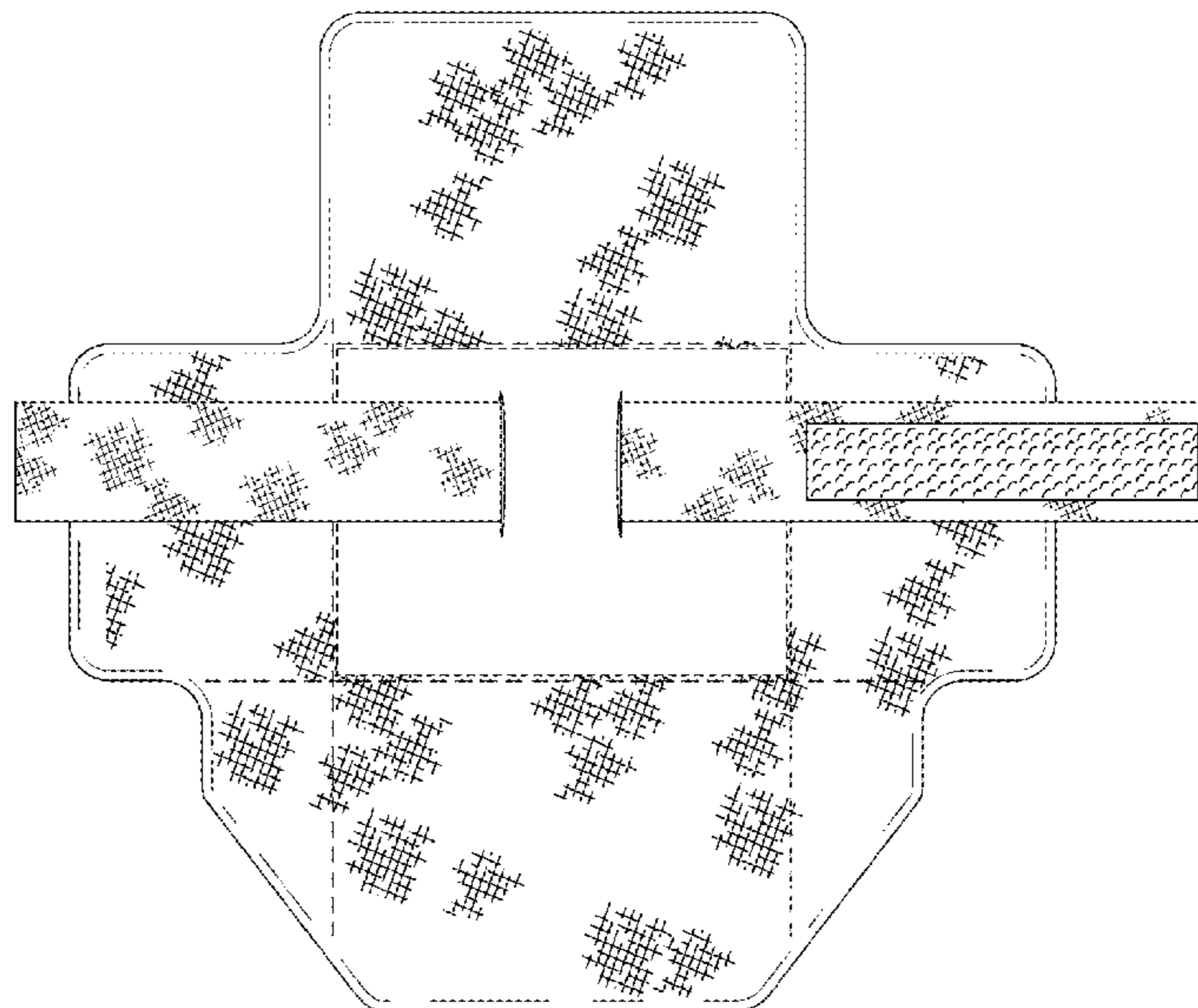
The ornamental design for a baby changing mat, as shown

**DESCRIPTION**

FIG. 1 is a front elevational view of a baby changing mat,  
showing my new design;  
FIG. 2 is a front elevational view thereof illustrating the  
baby changing mat in a partially folded configuration;  
FIG. 3 is a front elevational view thereof illustrating the  
baby changing mat in a fully folded configuration;  
FIG. 4 is a rear elevational view thereof;

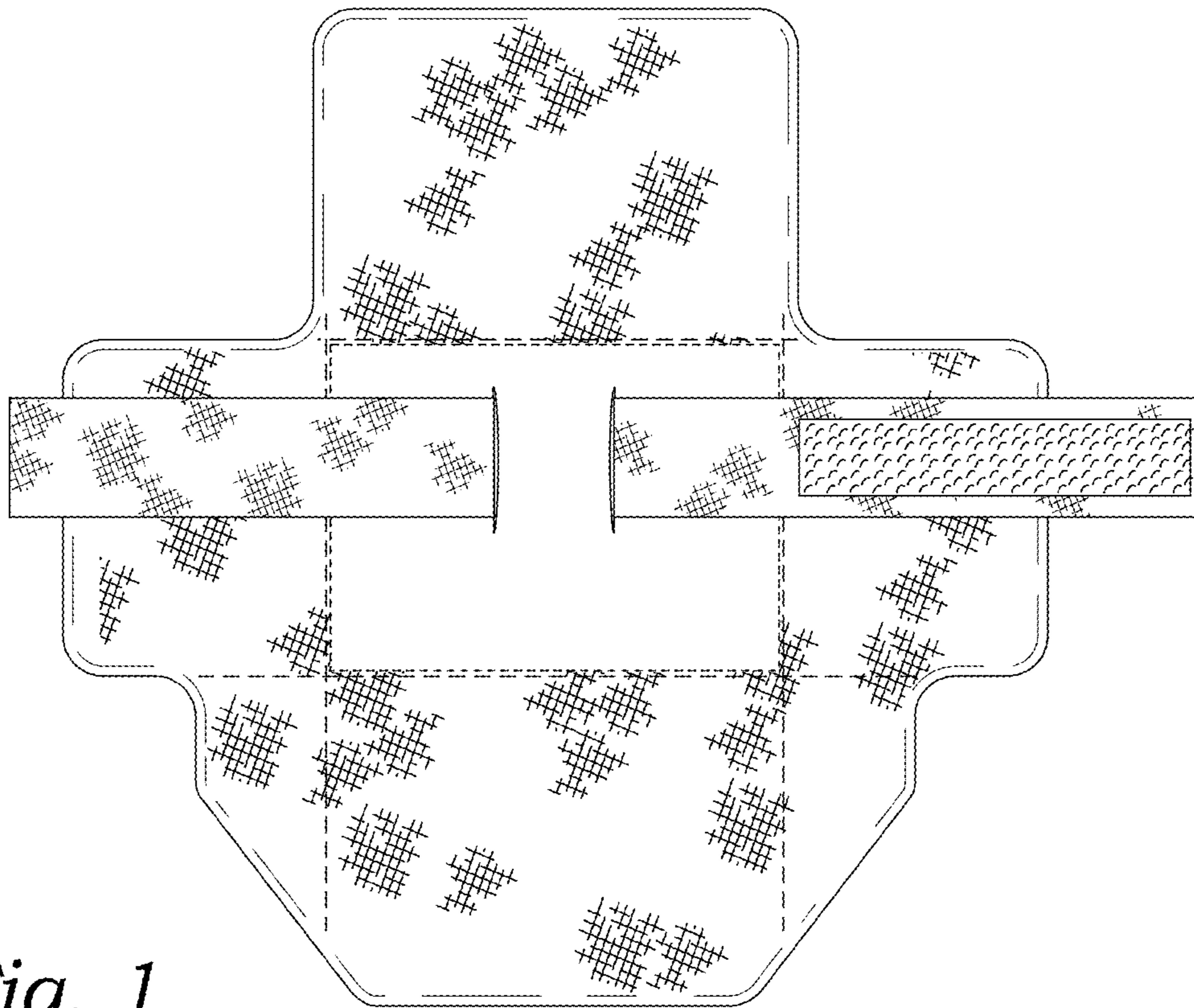

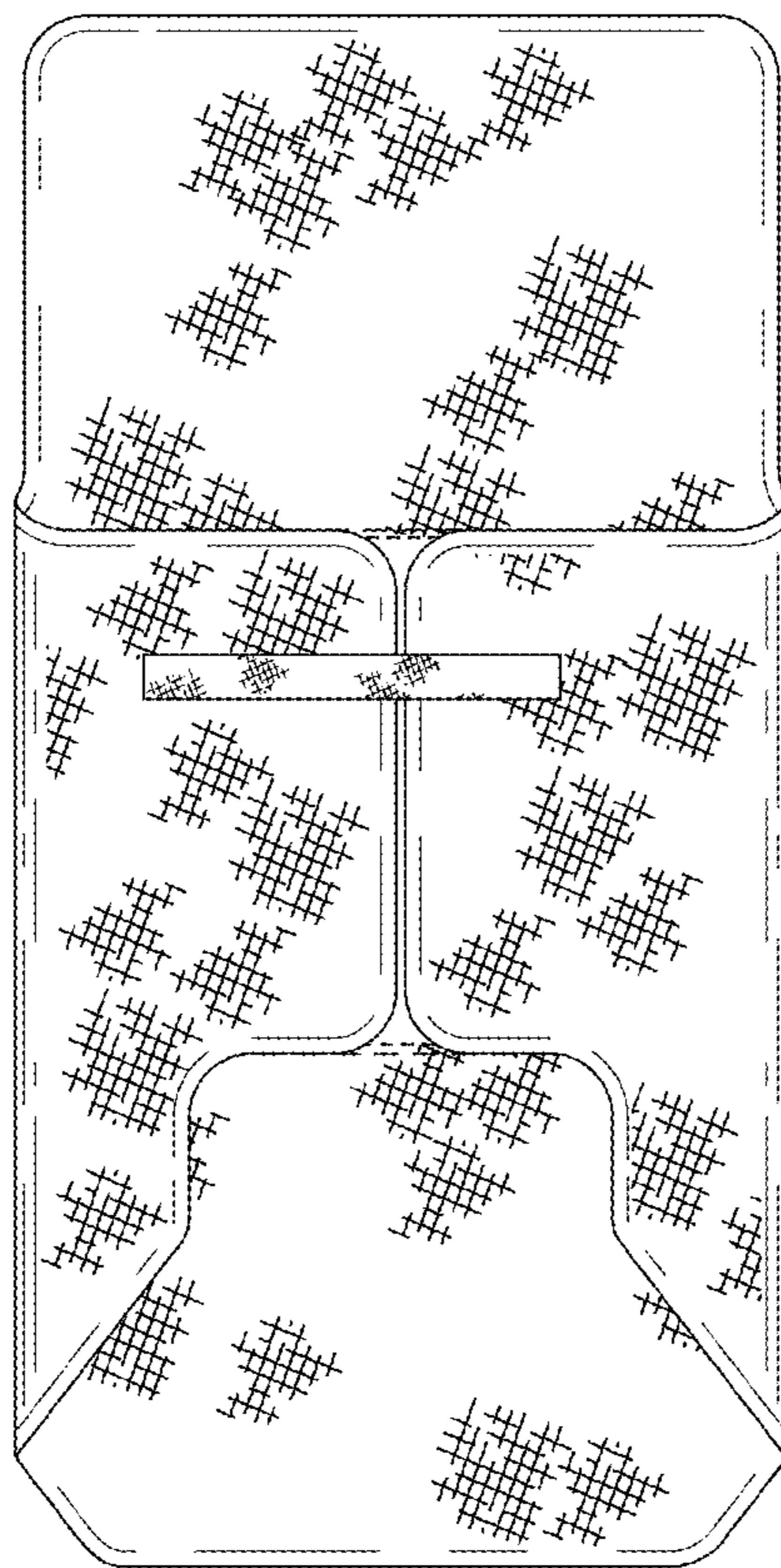

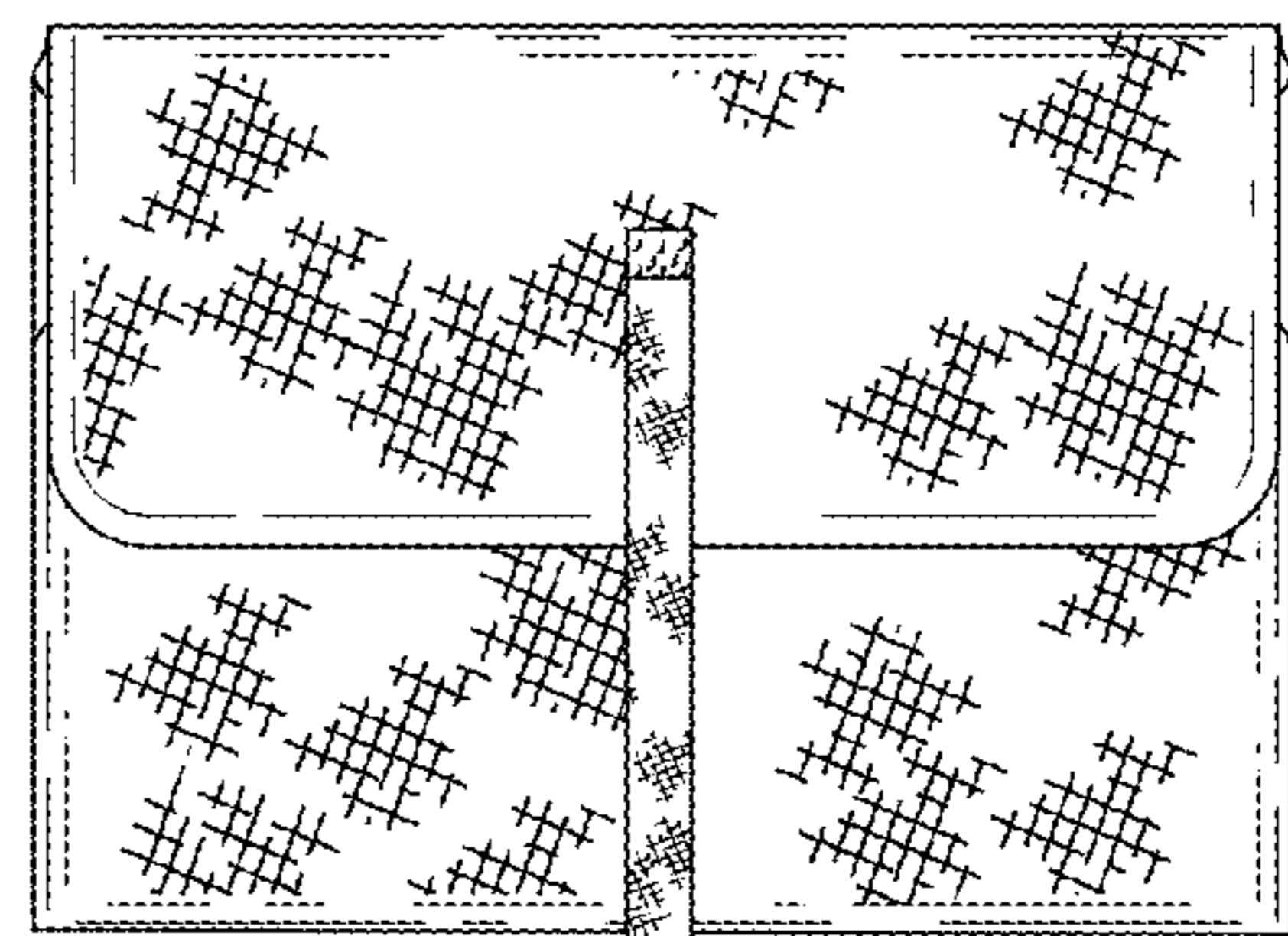

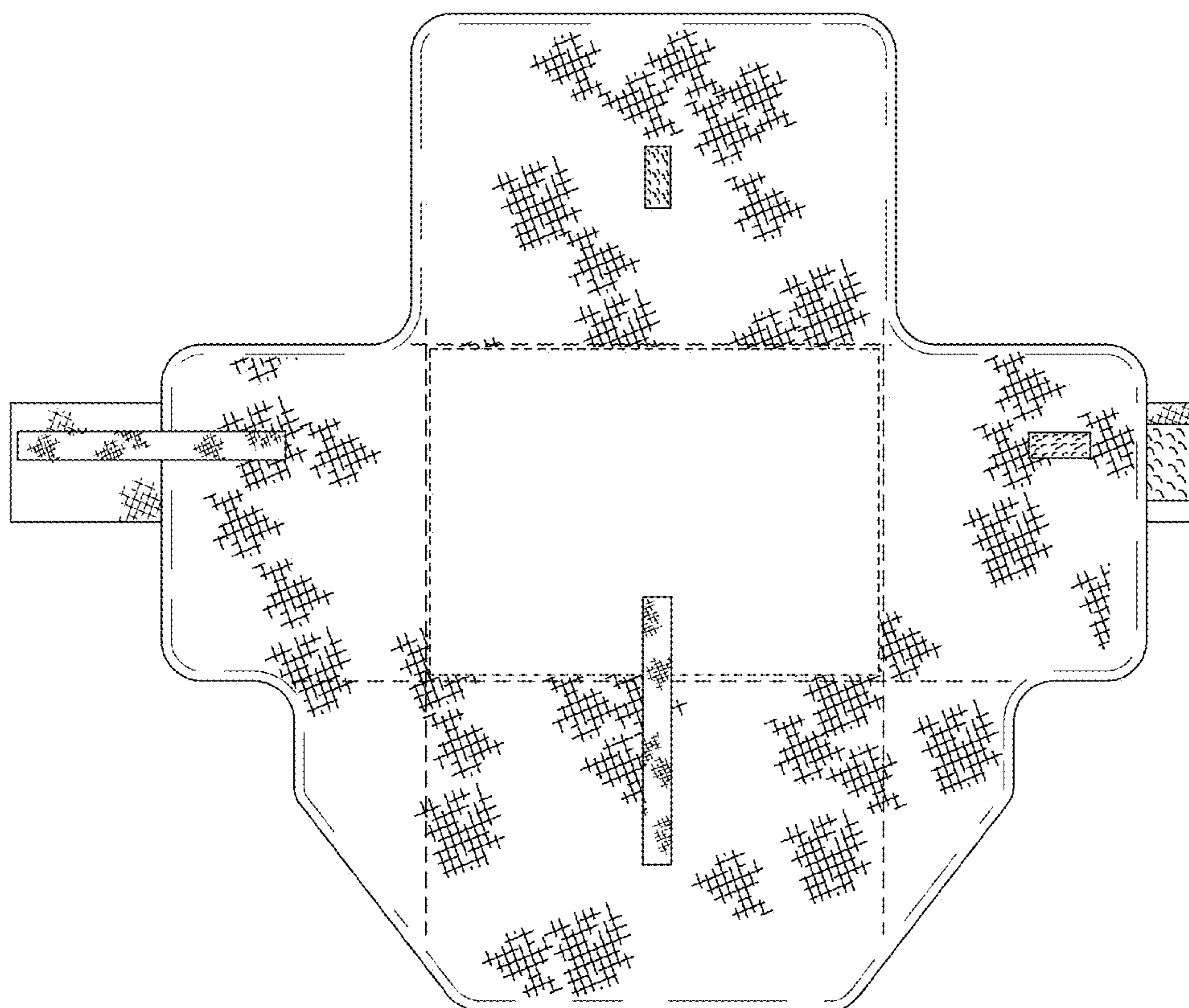

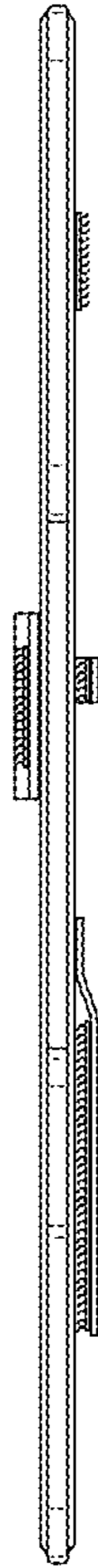

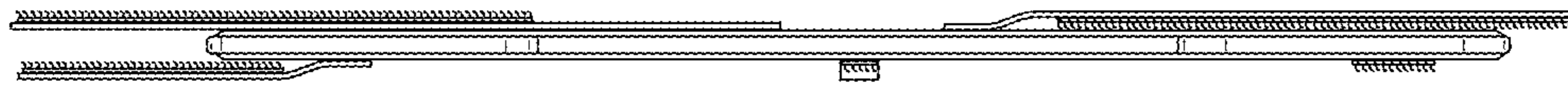

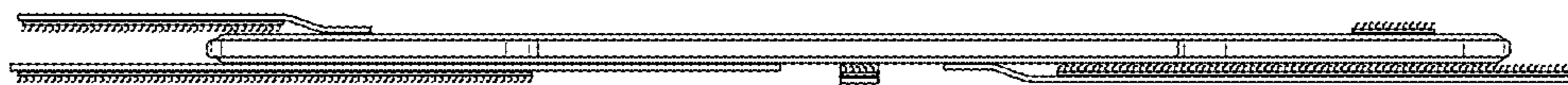
