(57) **CLAIM**

The ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a table showing my new design;

FIG. 2 is a front view thereof, a rear view thereof being identical;

FIG. 3 is a right side view thereof, a left view thereof being identical;

FIG. 4 is a bottom view thereof;

FIG. 5 is an enlarged cross-sectional view taken along the line 5-5 in FIG. 4 in which the internal structure is omitted thereof; and,

FIG. 6 is a perspective view thereof showing an alternative position.

The broken lines shown in the drawings illustrate portions of the table that form no part of the claimed design. The top view is excluded as it depicts only environmental subject matter.

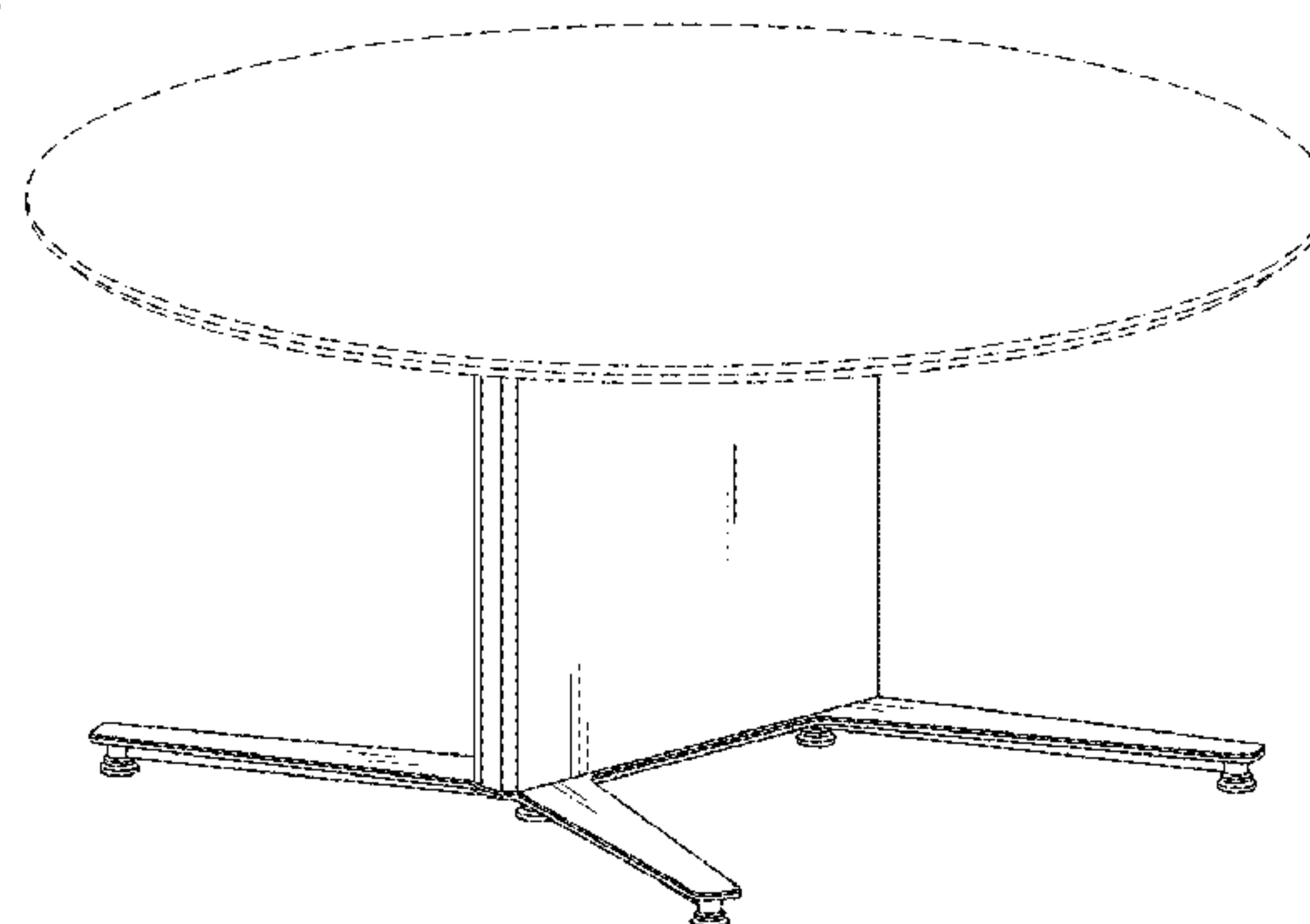
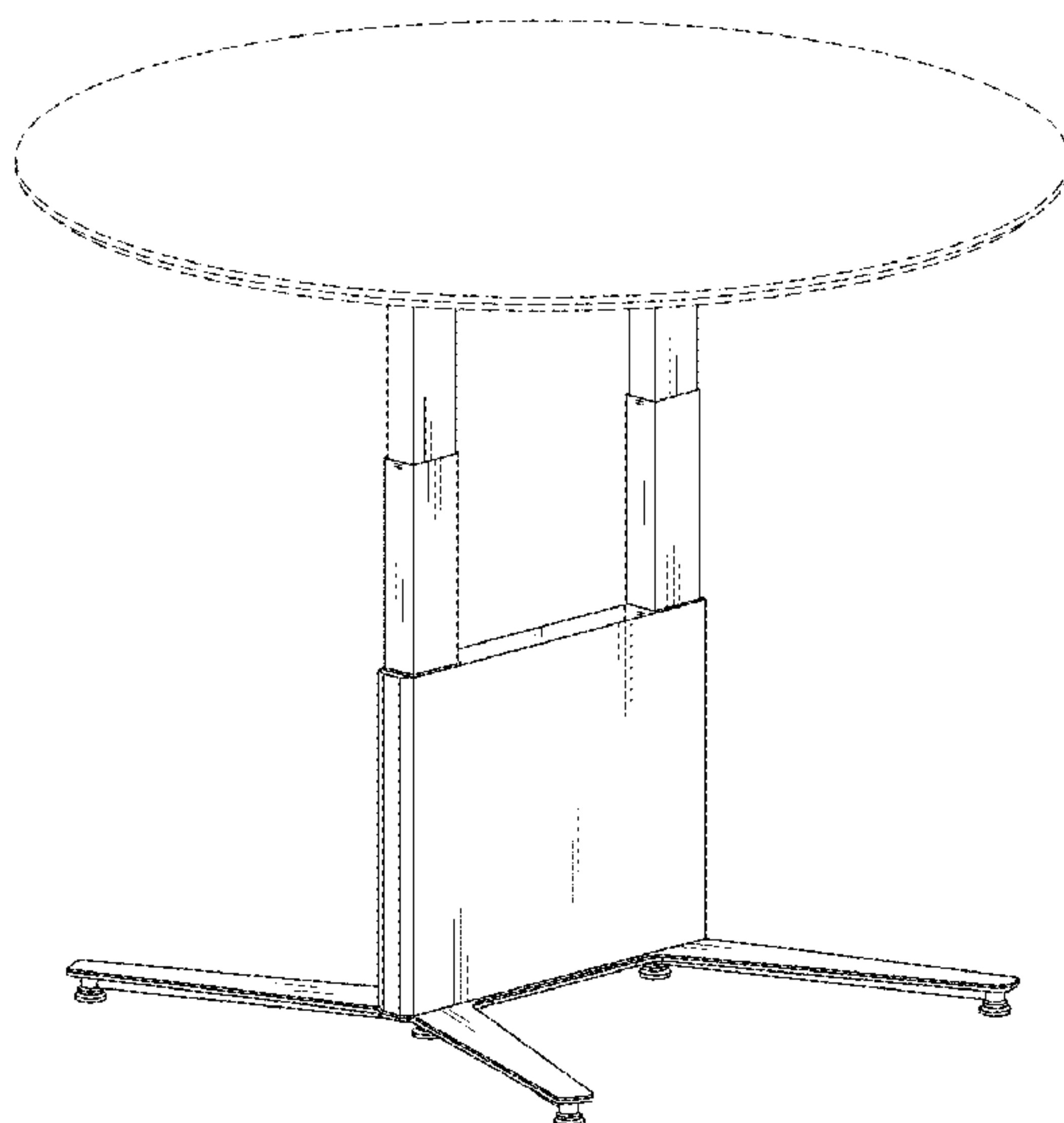

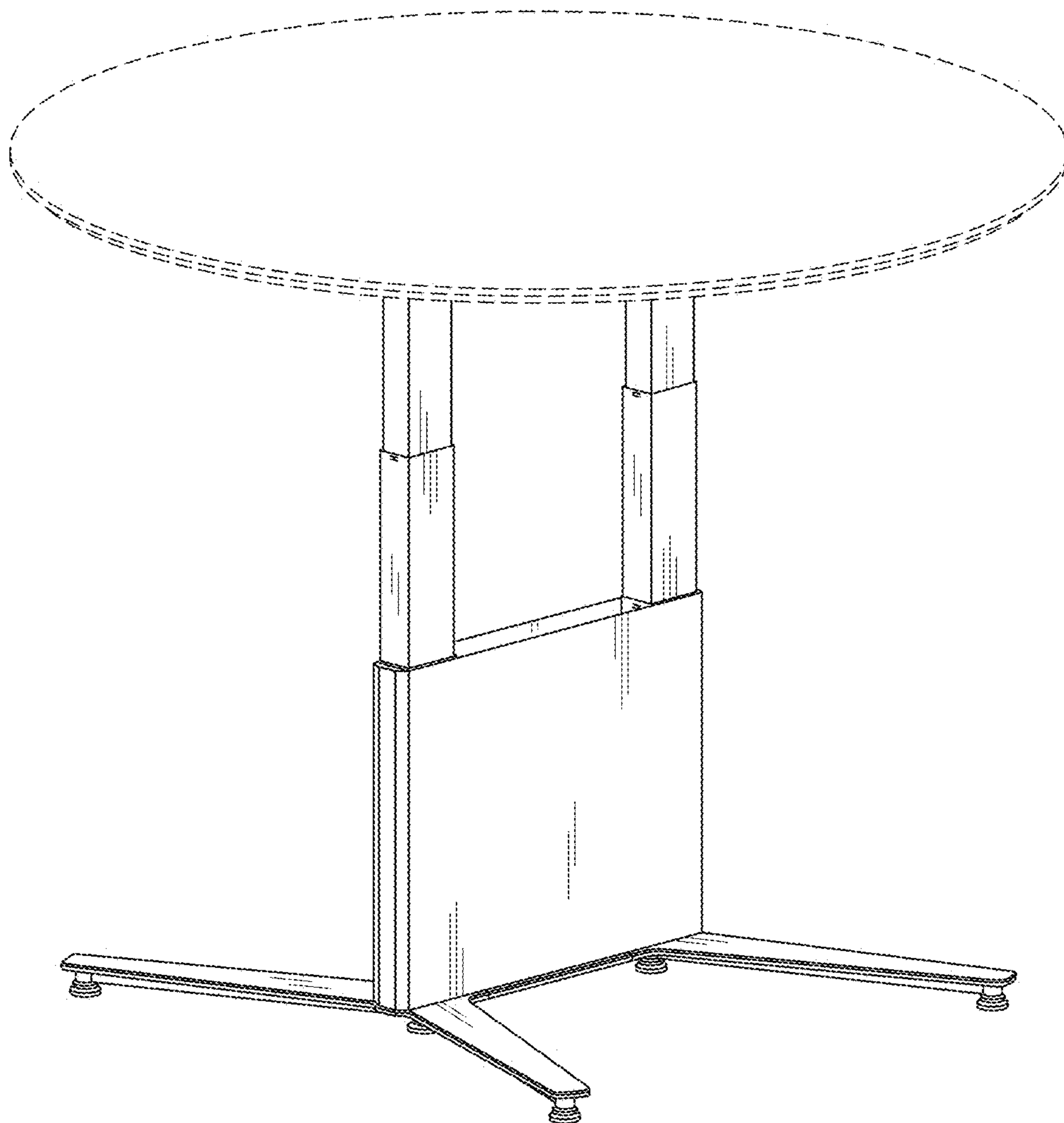

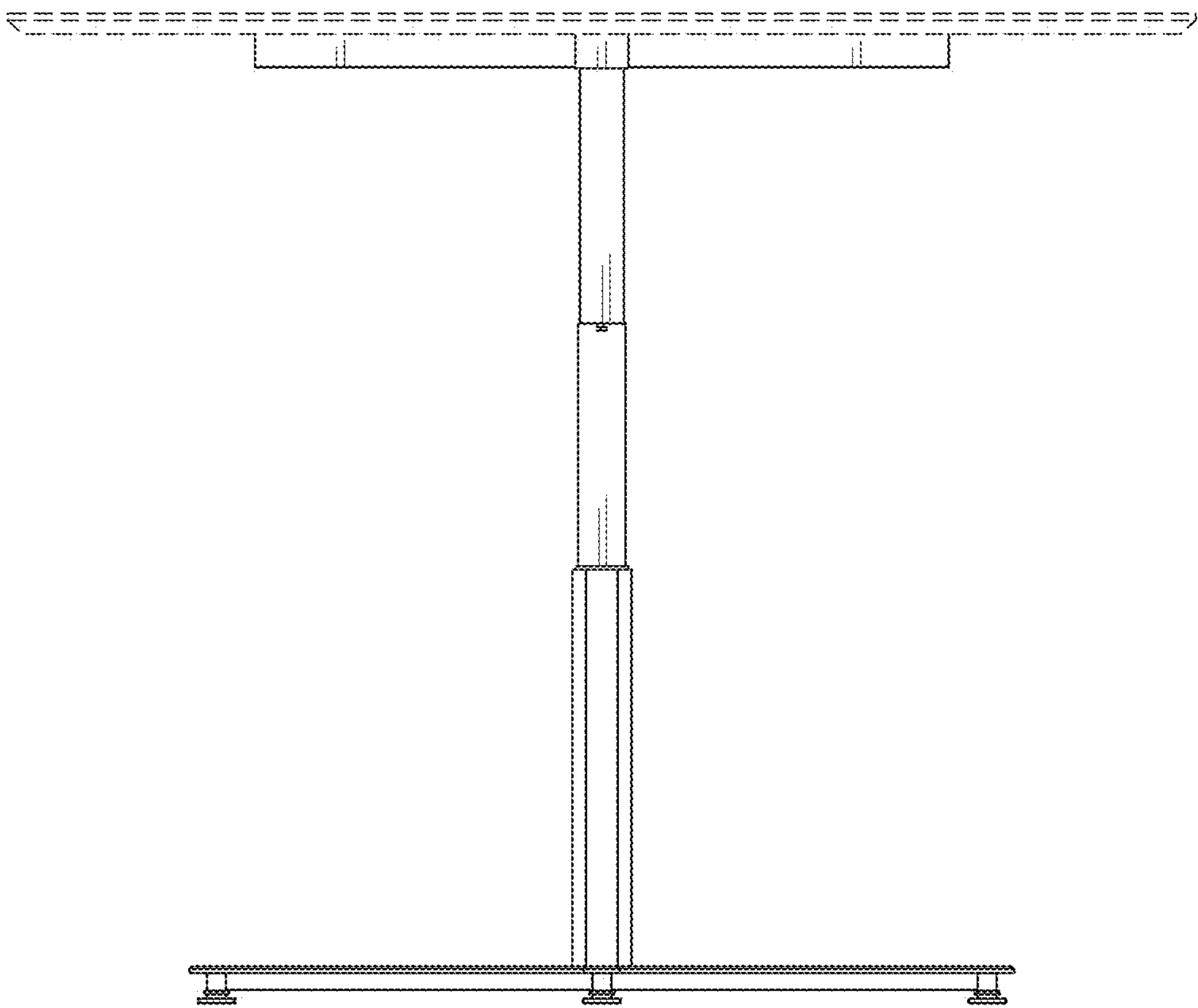

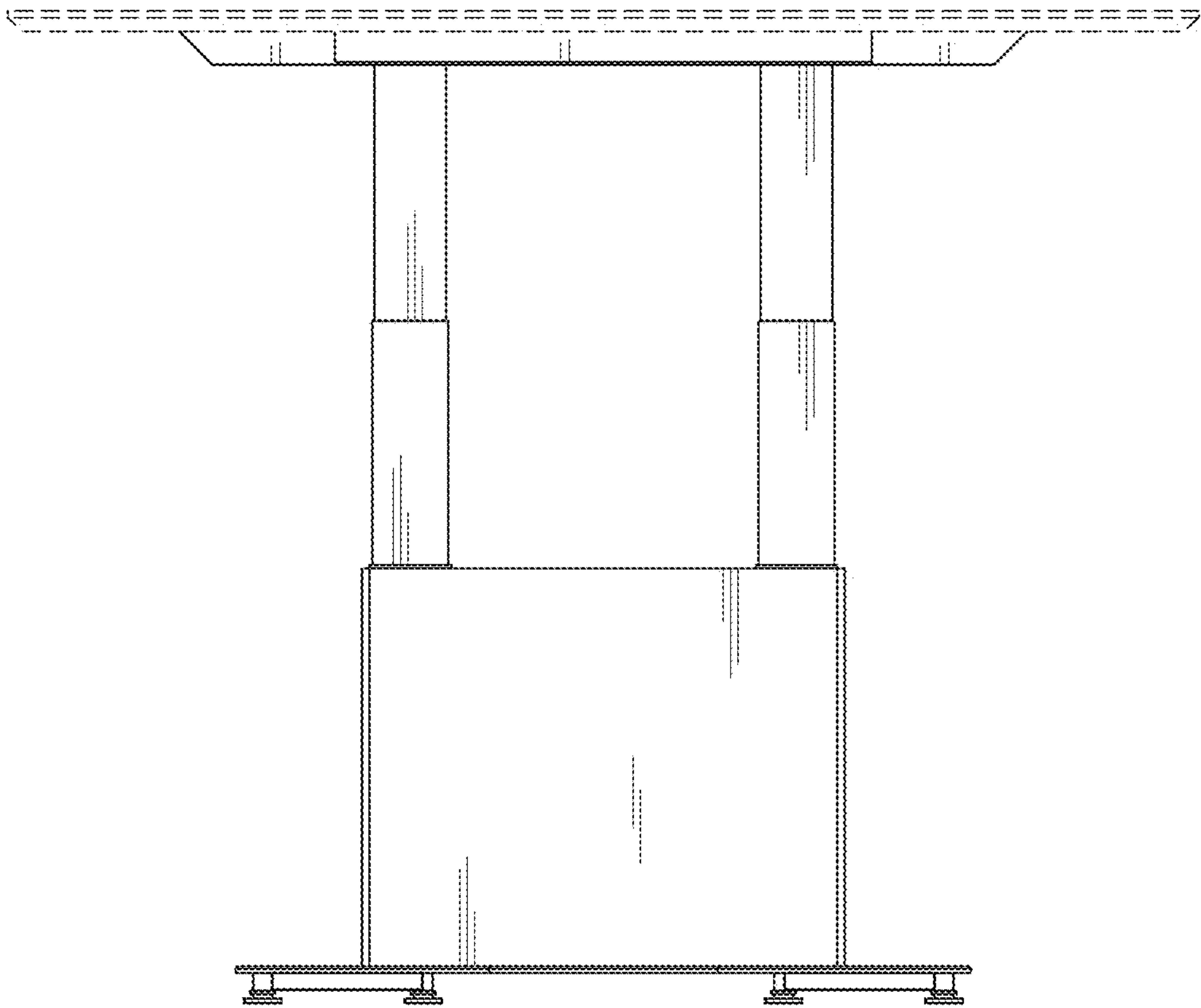

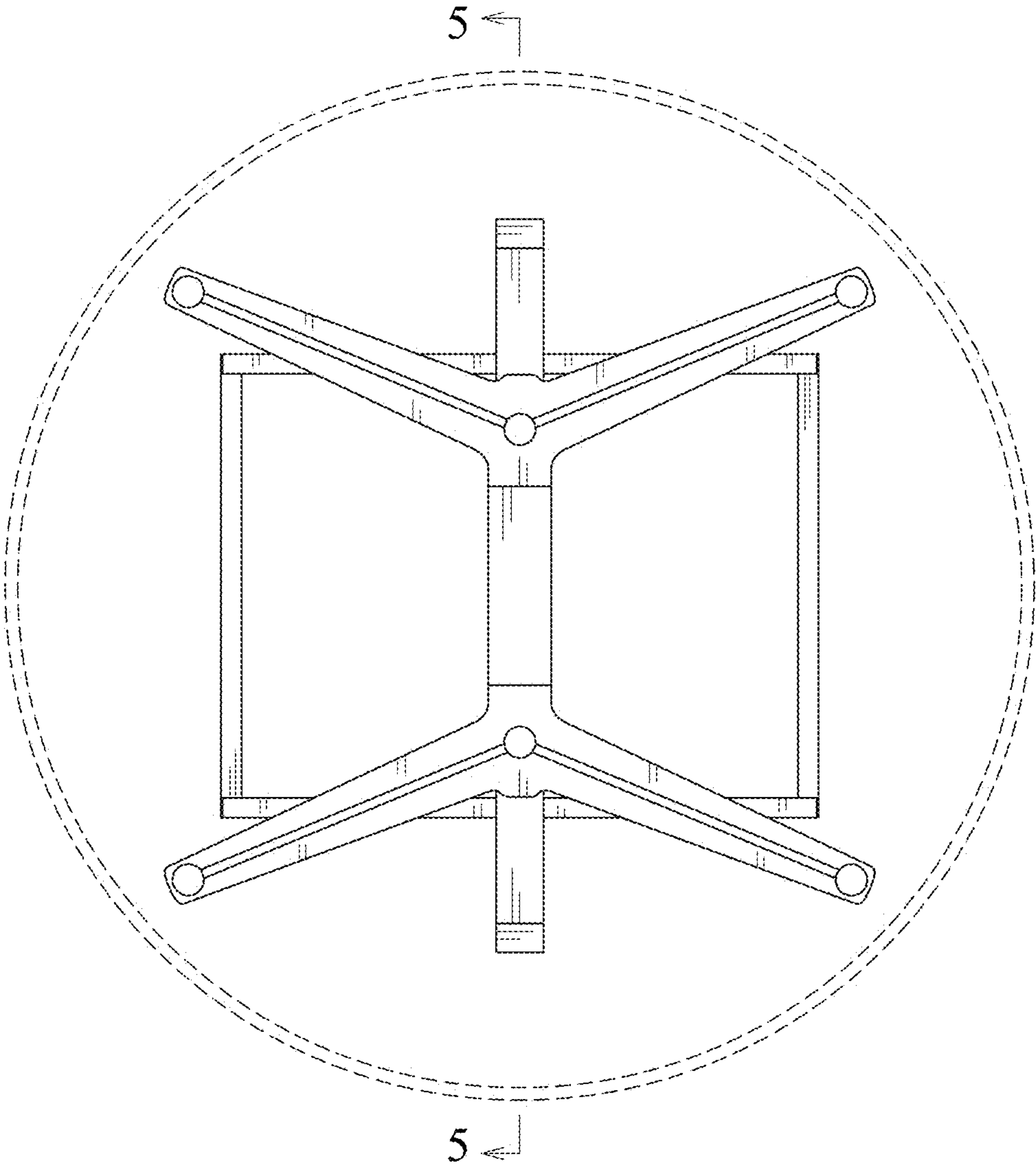

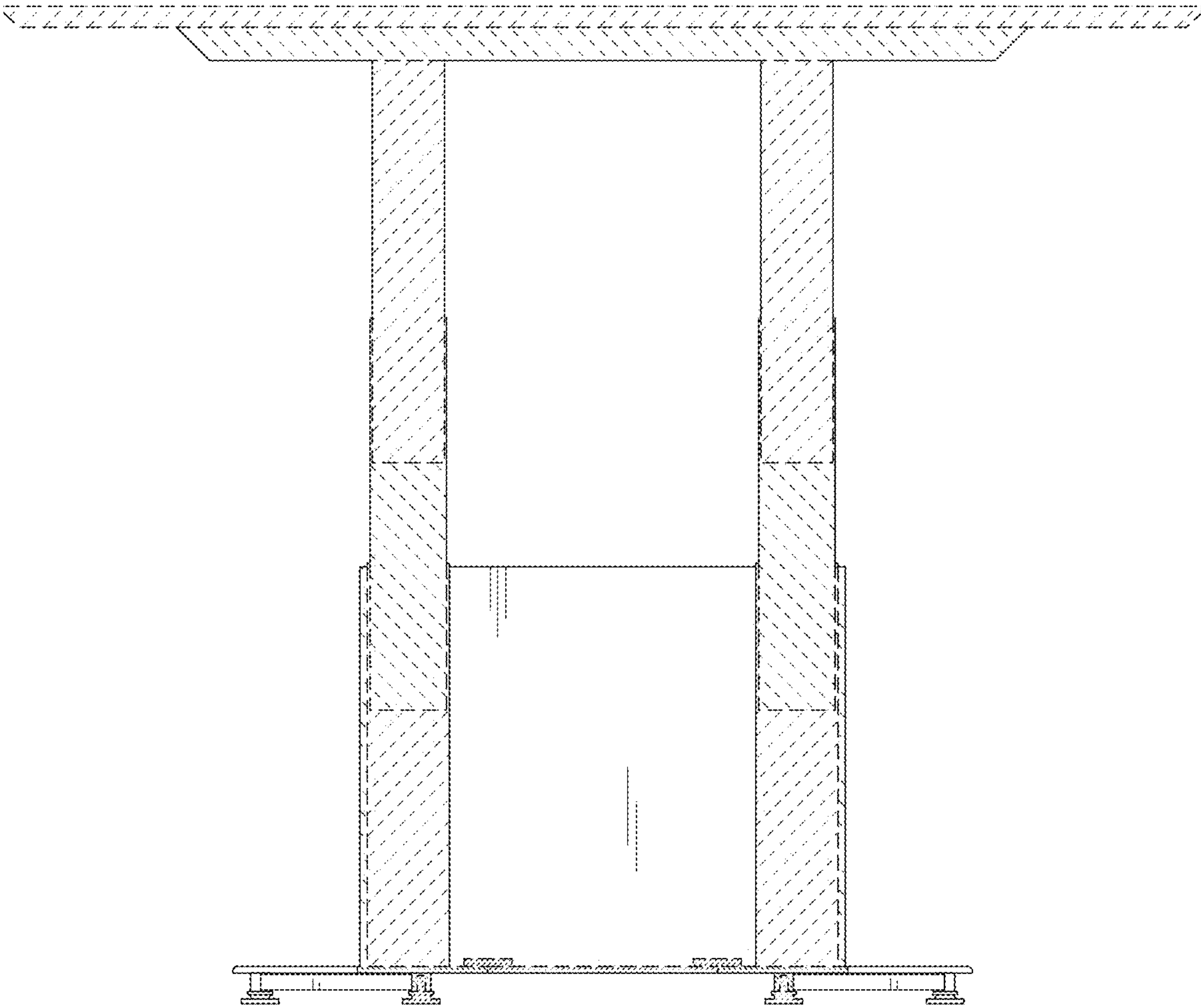
