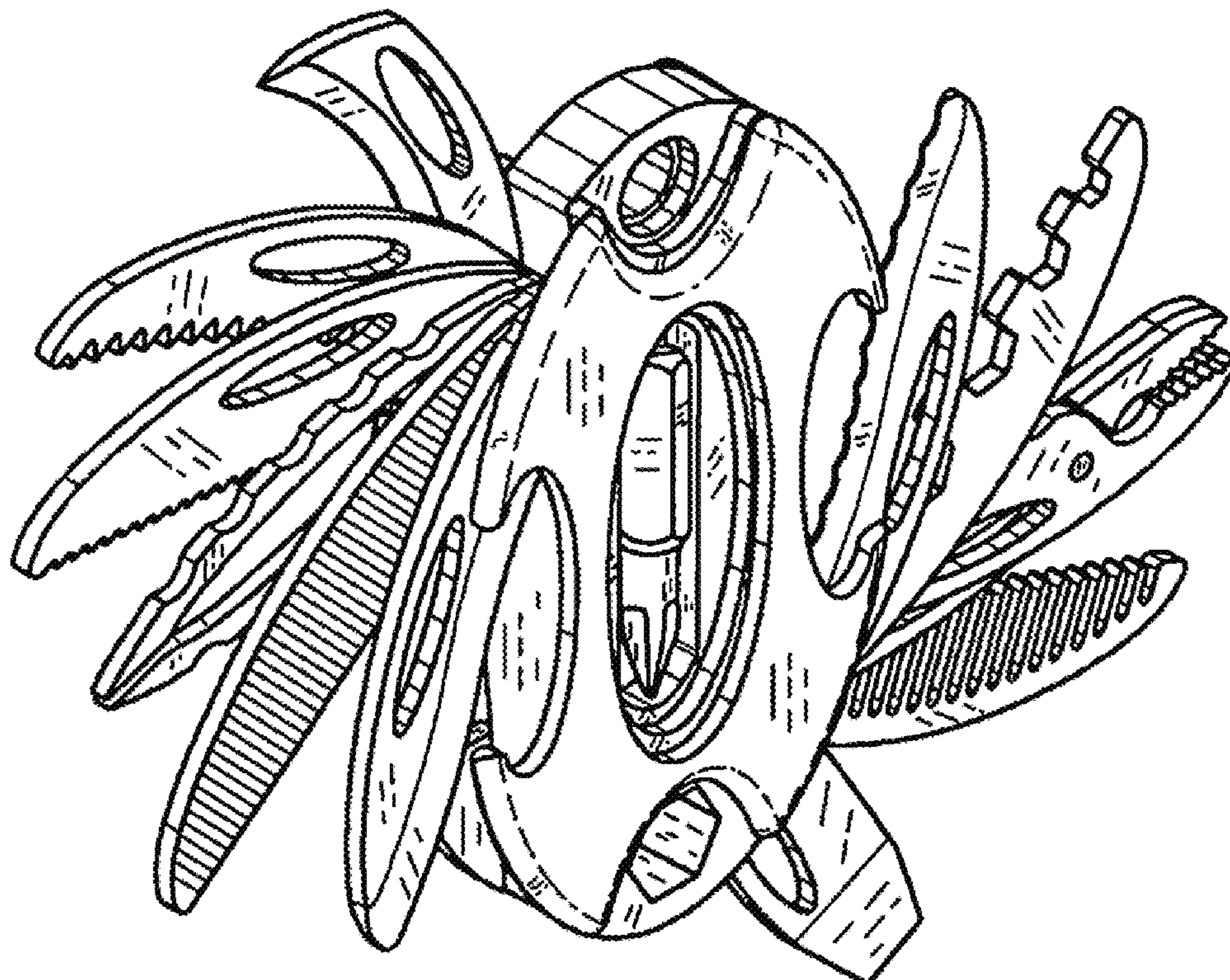
The ornamental design for a multi function hand tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi function hand tool embodying my new design, wherein the tools are deployed; FIG. 2 is a perspective view thereof, wherein the tools are stowed; FIG. 3 is a front elevation view thereof, wherein the tools are stowed; FIG. 4 is a front elevation view thereof, wherein the tools are deployed; FIG. 5 is a rear elevation view thereof, wherein the tools are stowed; and, FIG. 6 is a left side elevation view thereof, wherein the tools are stowed, the right side view being a mirror image.

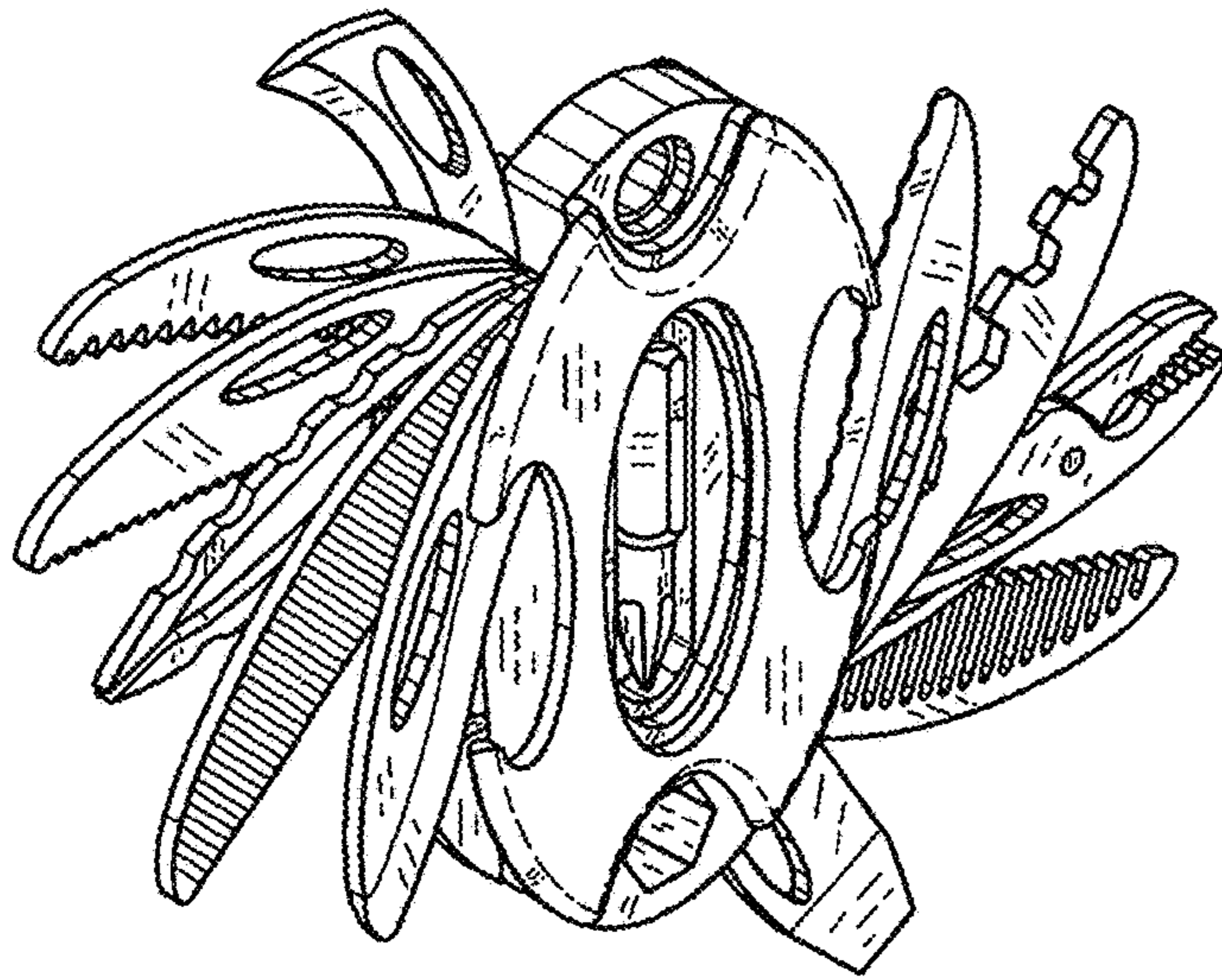

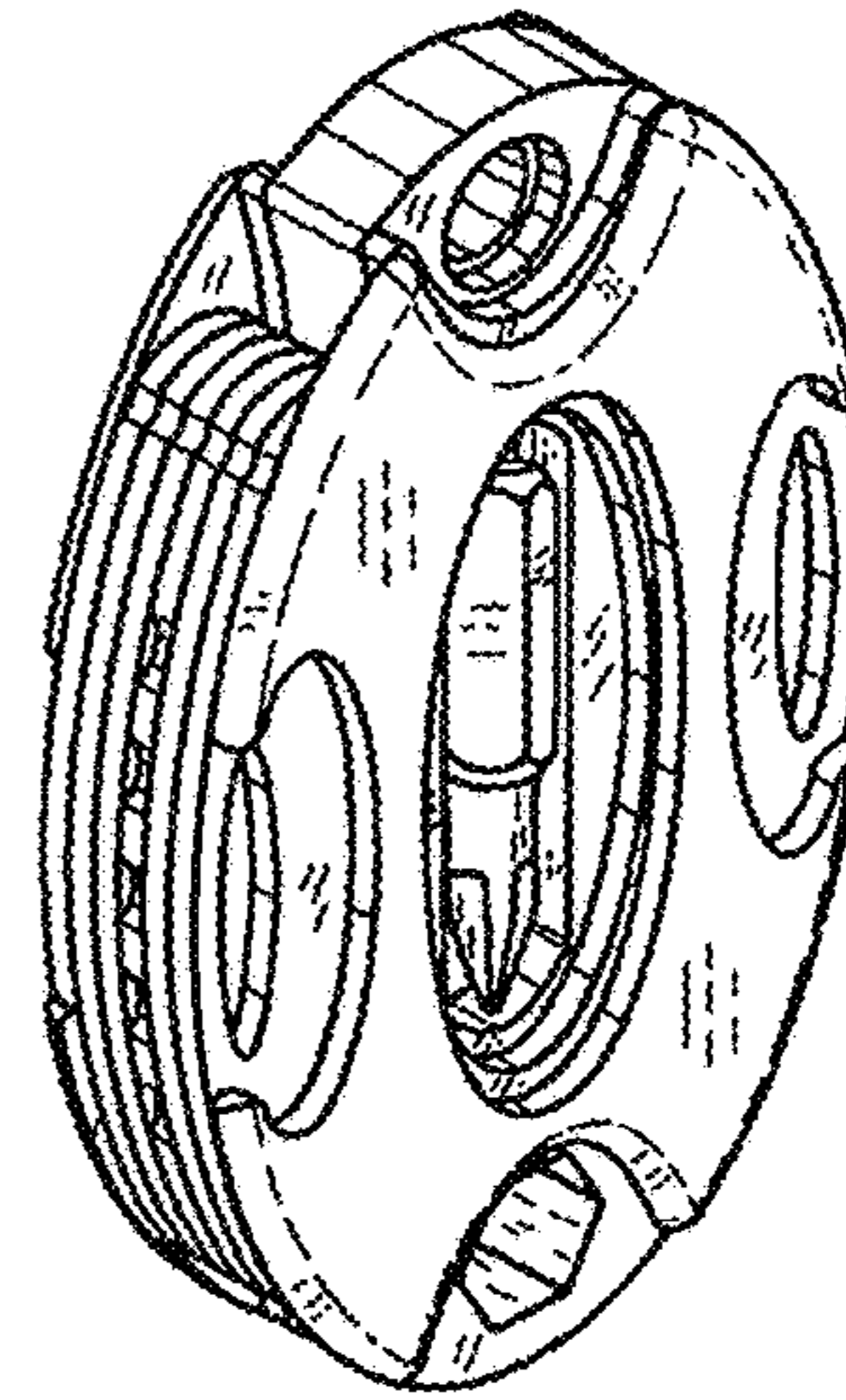

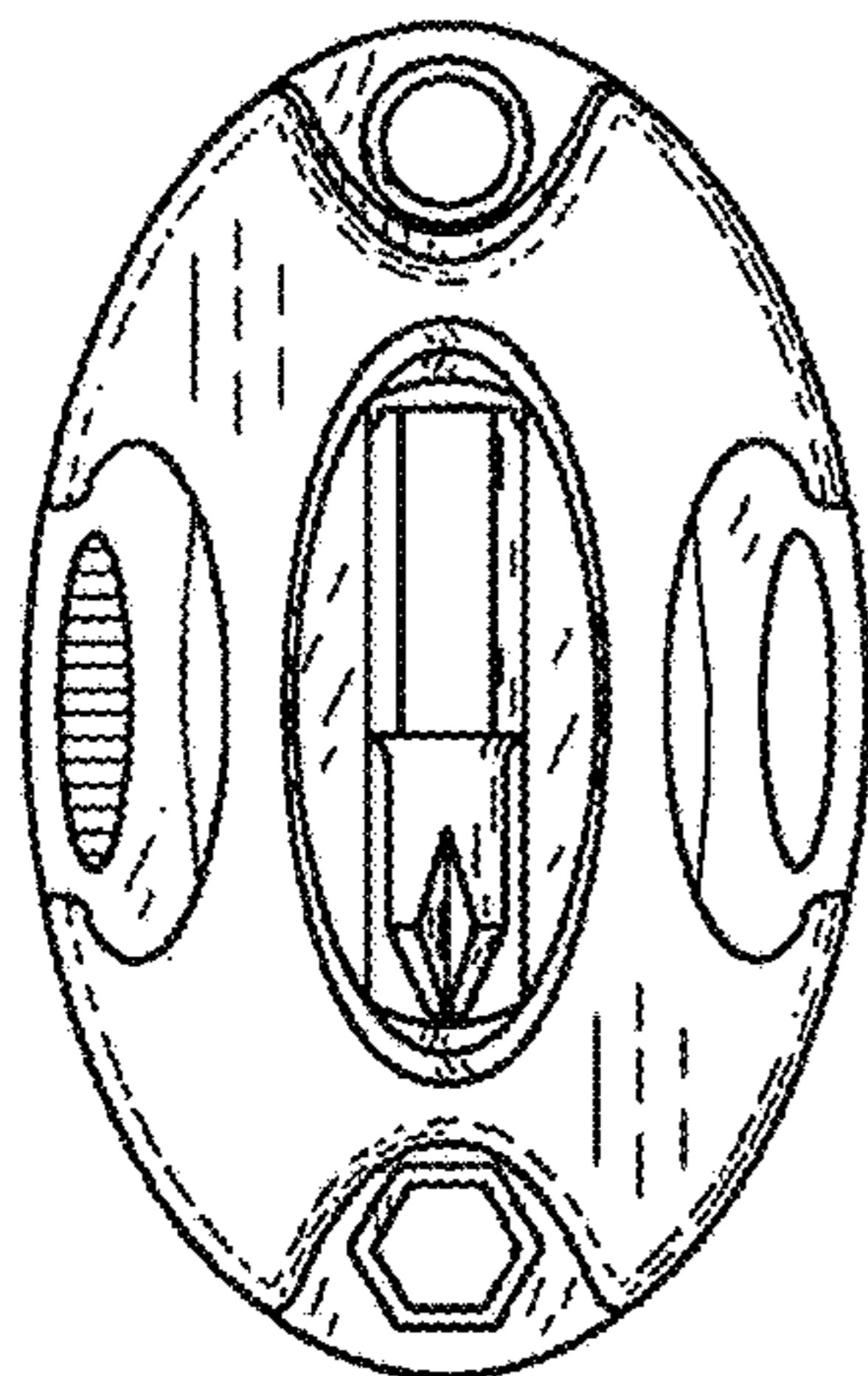

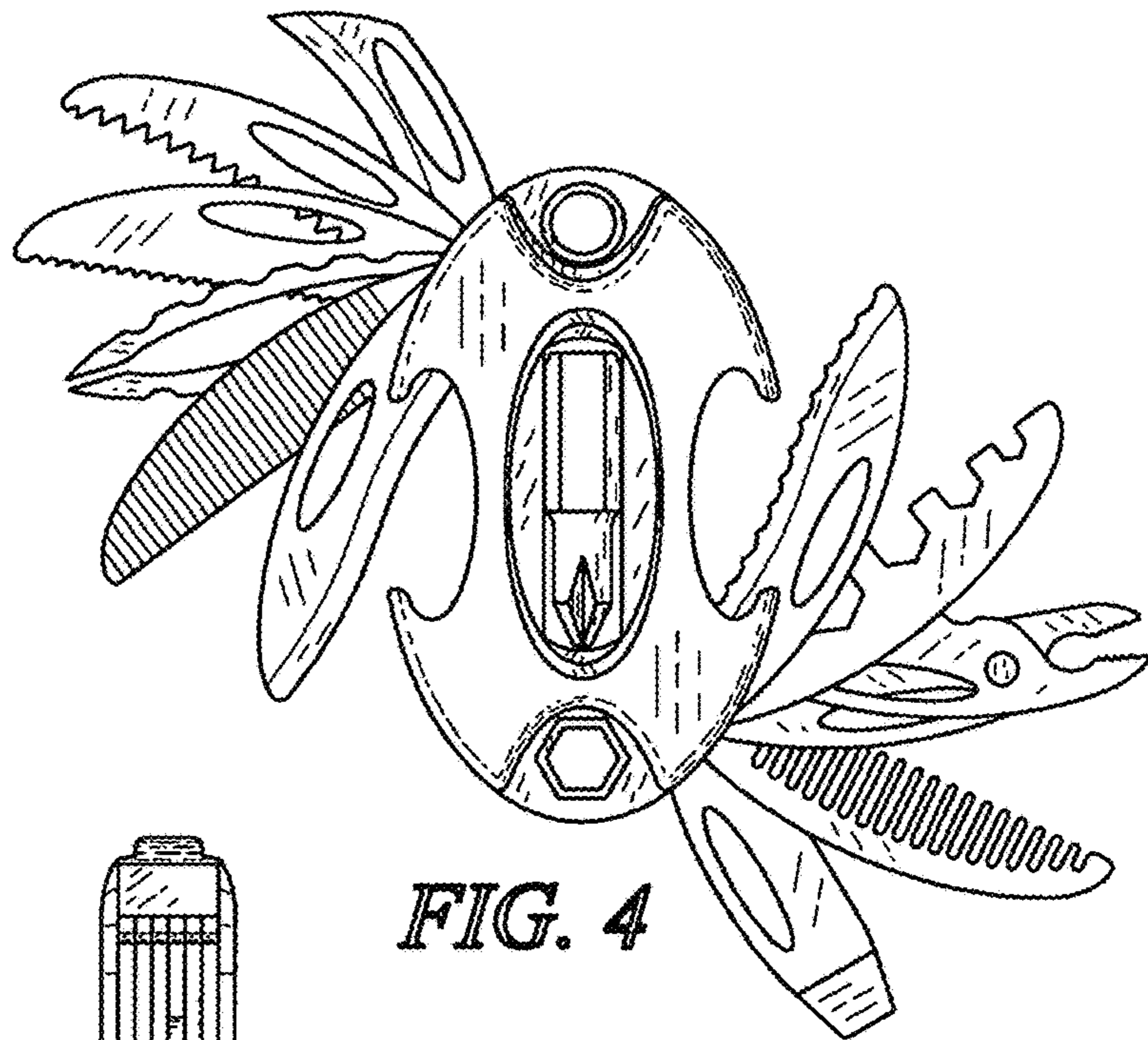

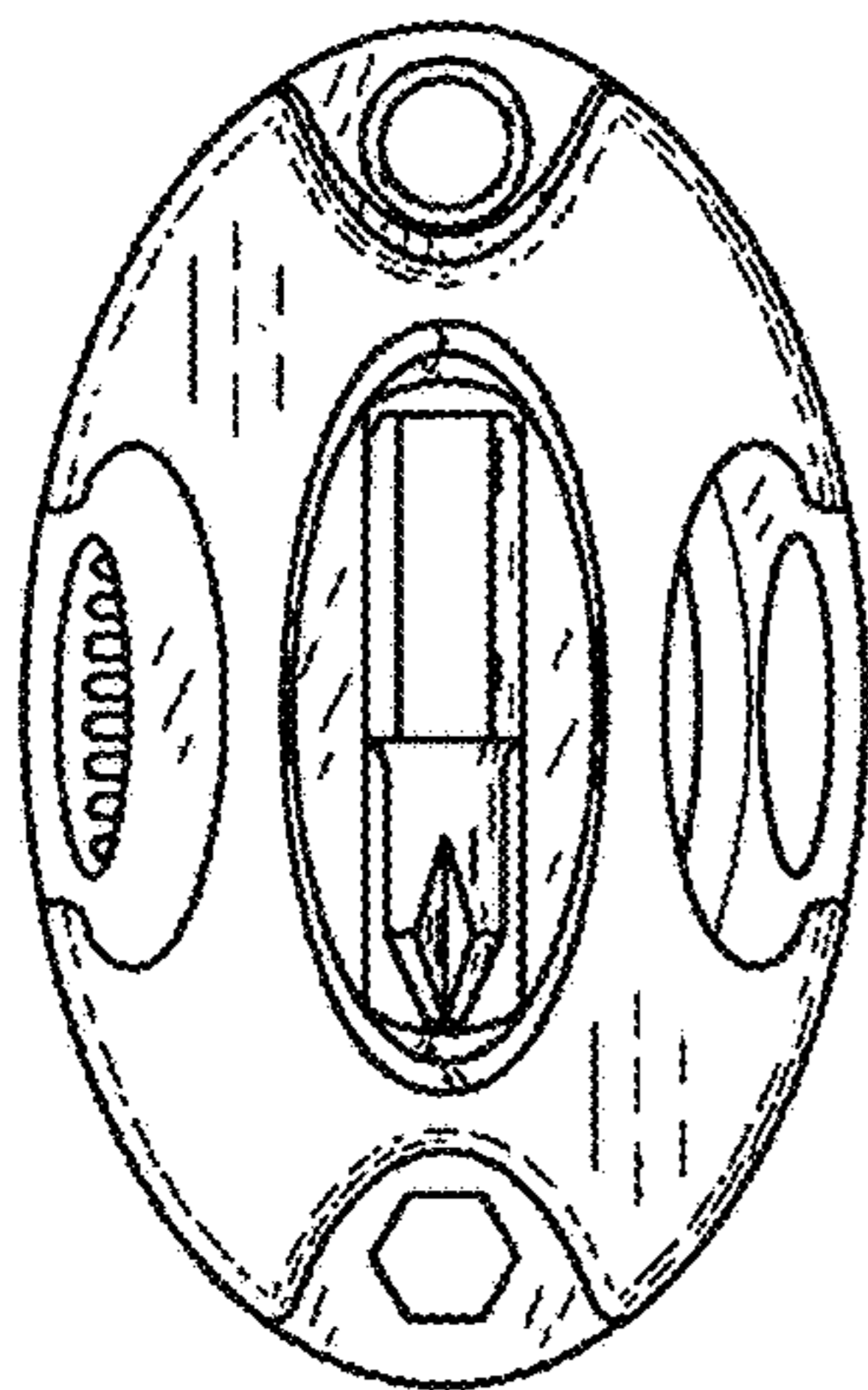

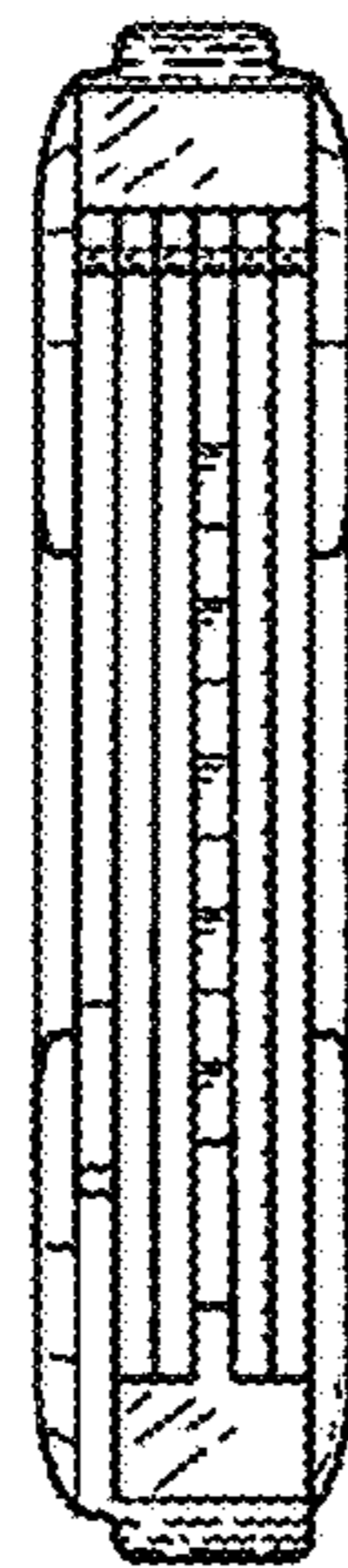
