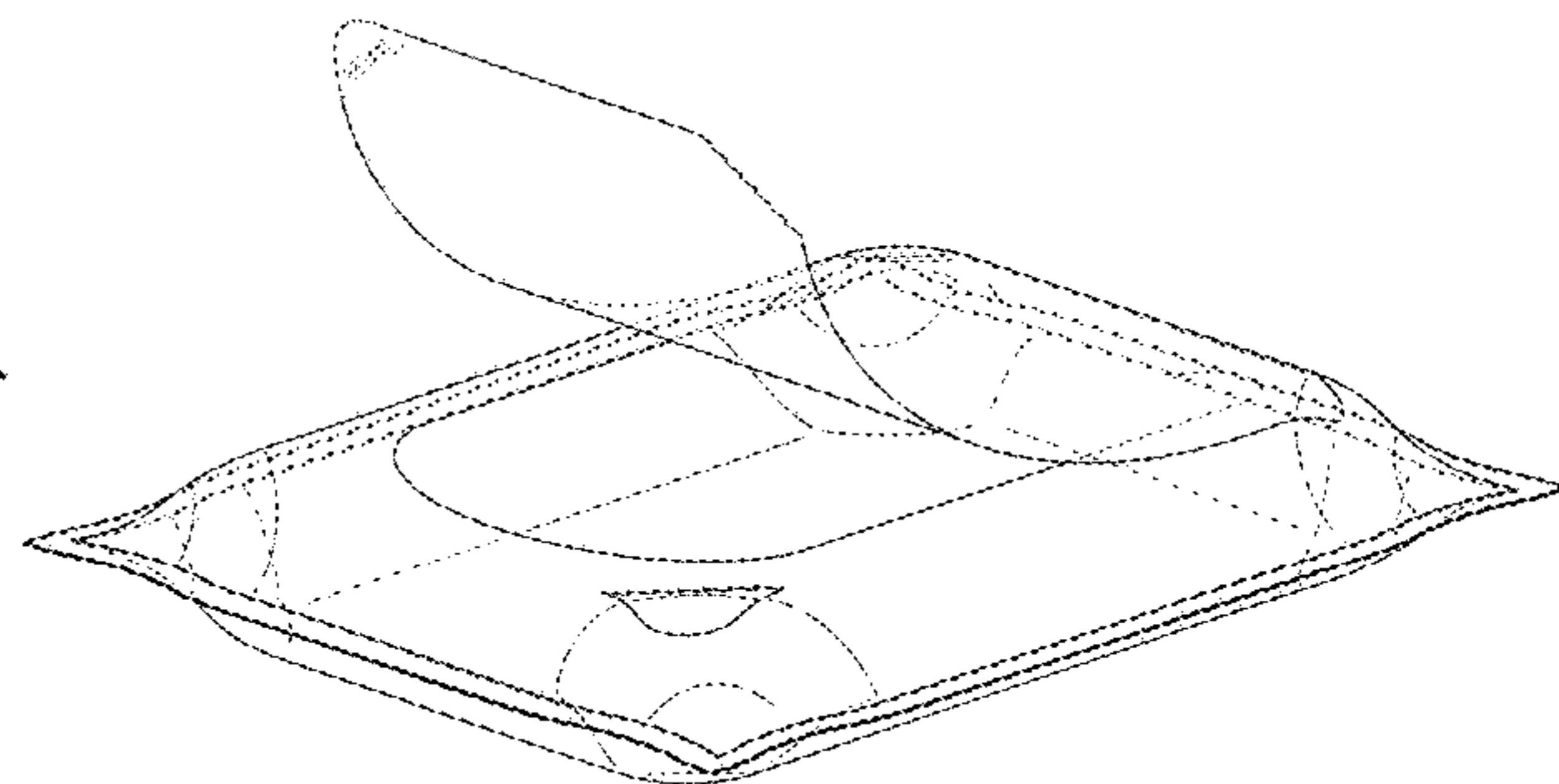
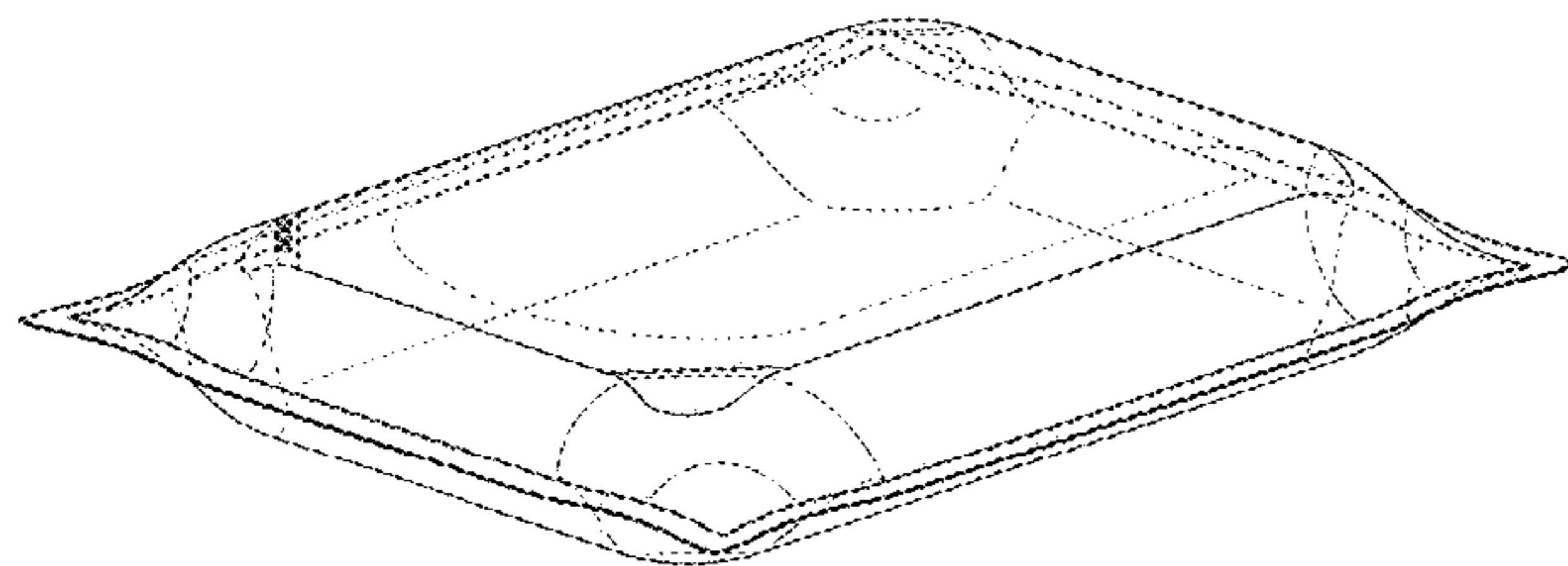
(57) **CLAIM**

The ornamental design for the resealable steam bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a resealable steam bag in a closed state; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a first side view thereof; FIG. 5 is a second side view thereof; FIG. 6 is a third side view thereof; FIG. 7 is a fourth side view thereof; FIG. 8 is a perspective view of the resealable steam bag in an open state; FIG. 9 is a top view thereof; FIG. 10 is a bottom view thereof; FIG. 11 is a first side view thereof; FIG. 12 is a second side view thereof; FIG. 13 is a third side view thereof; and, FIG. 14 is a fourth side view thereof. 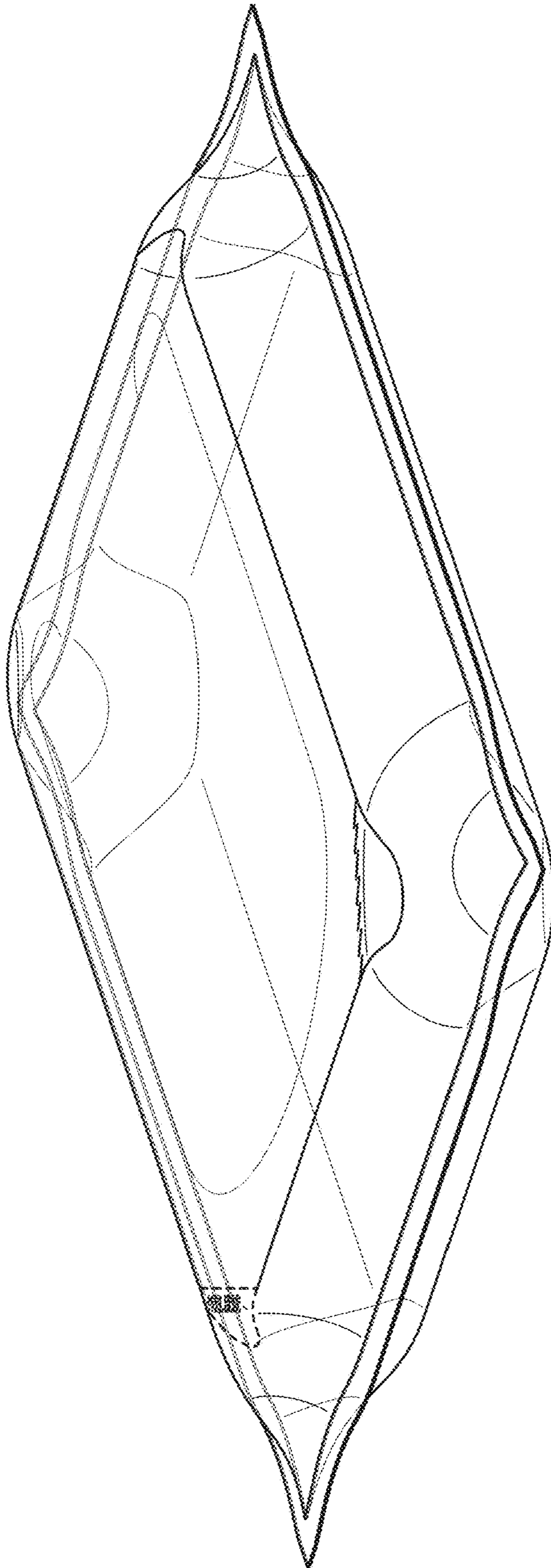

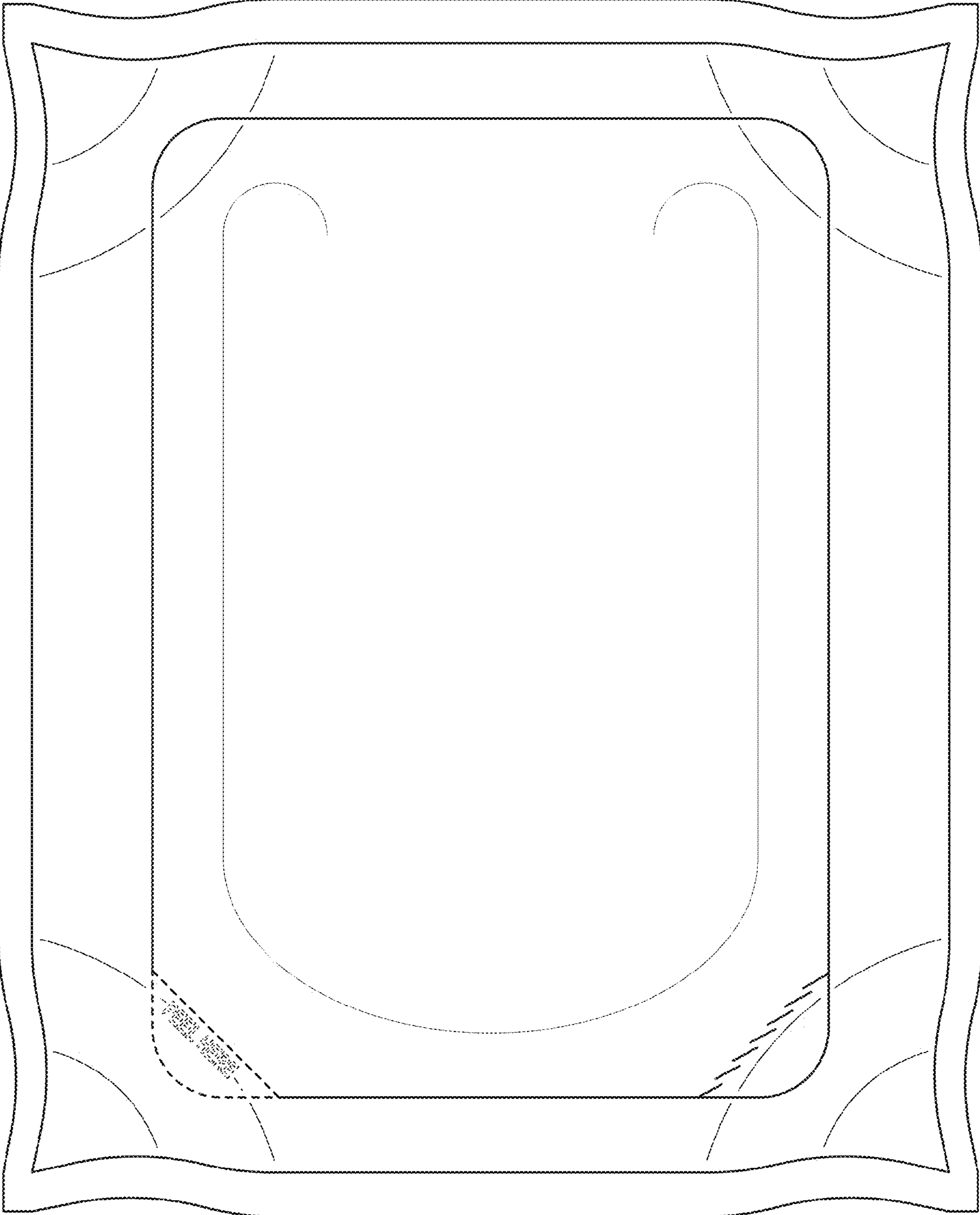

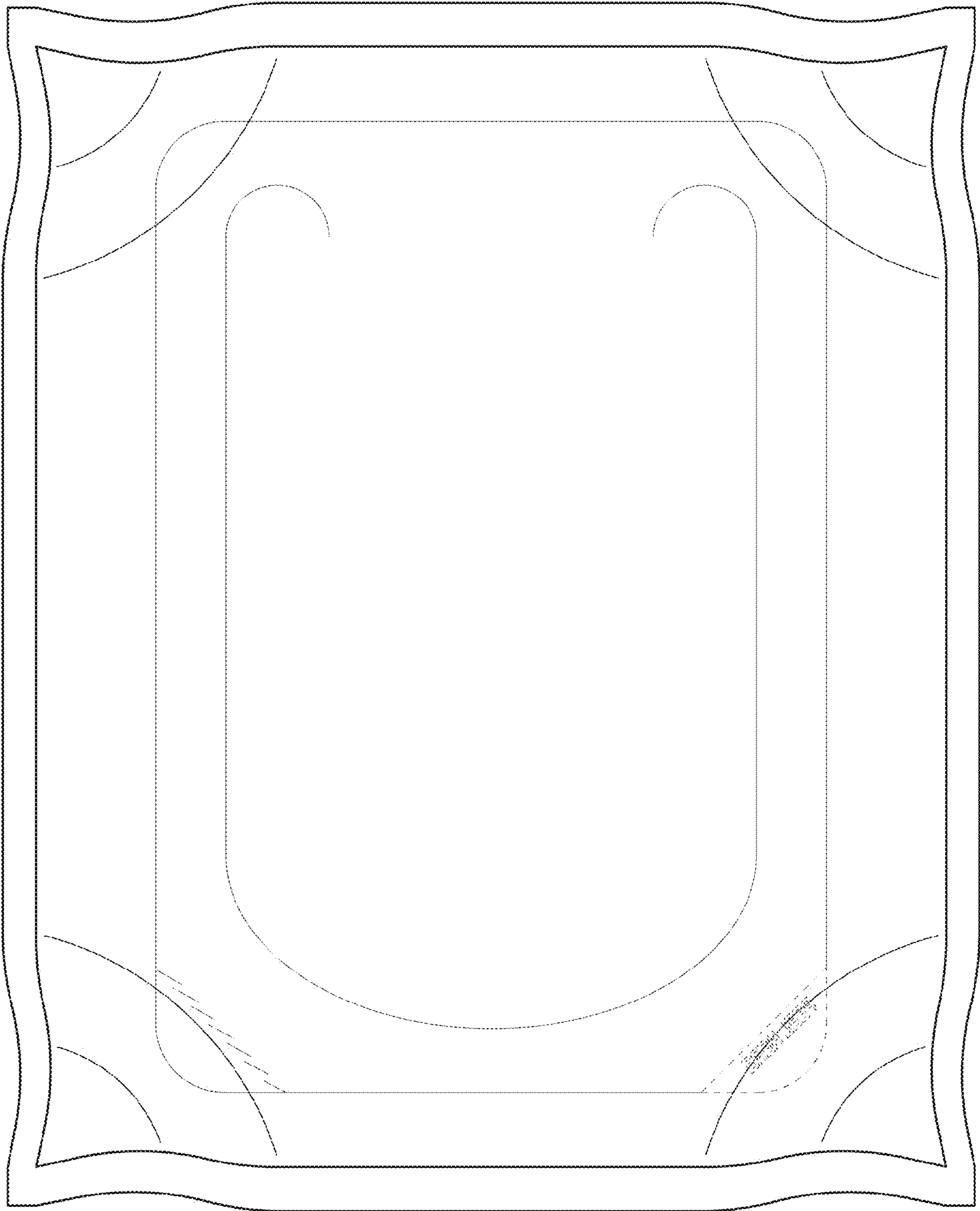

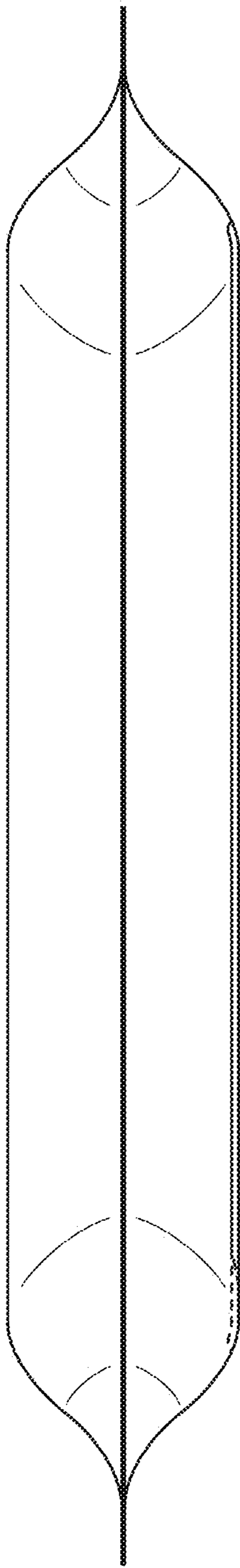

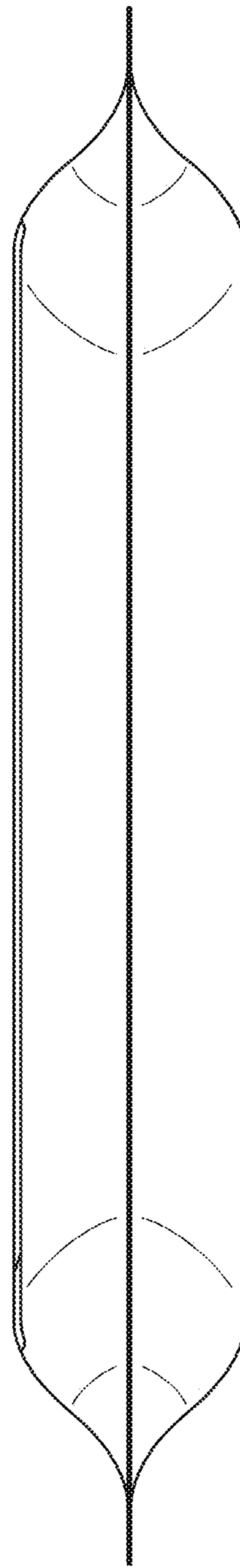

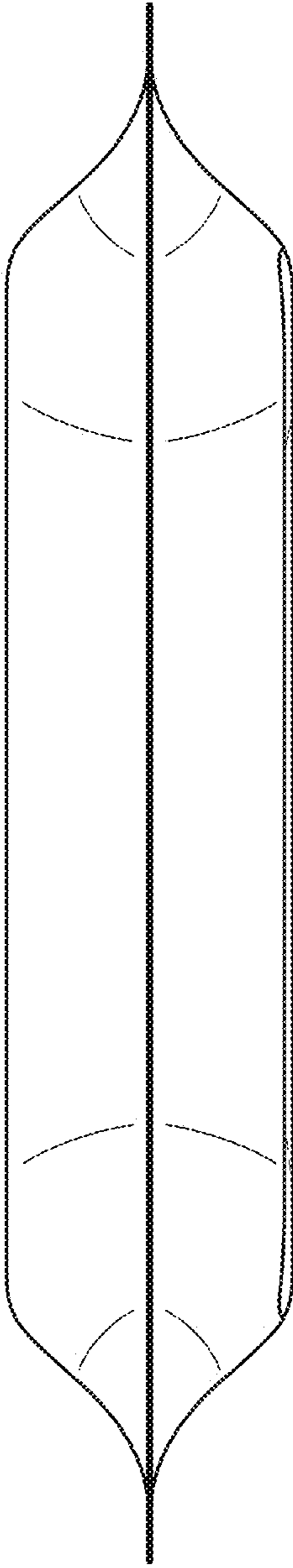

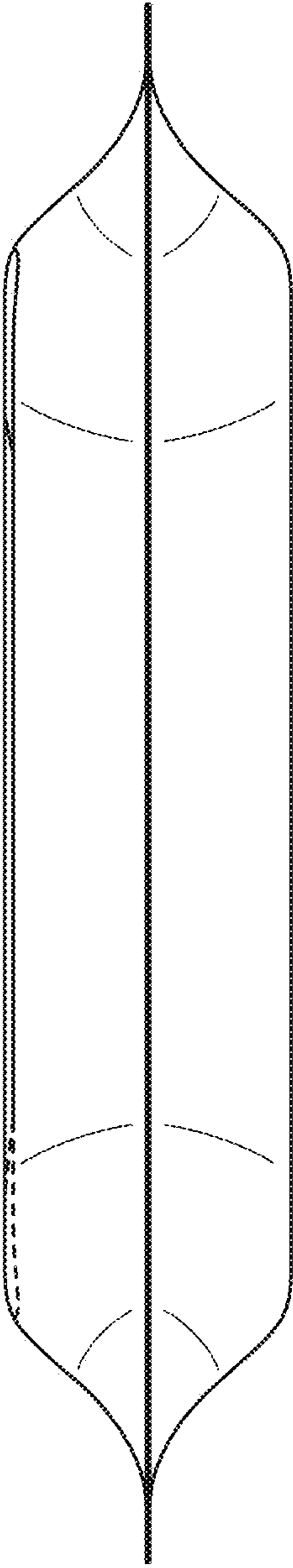

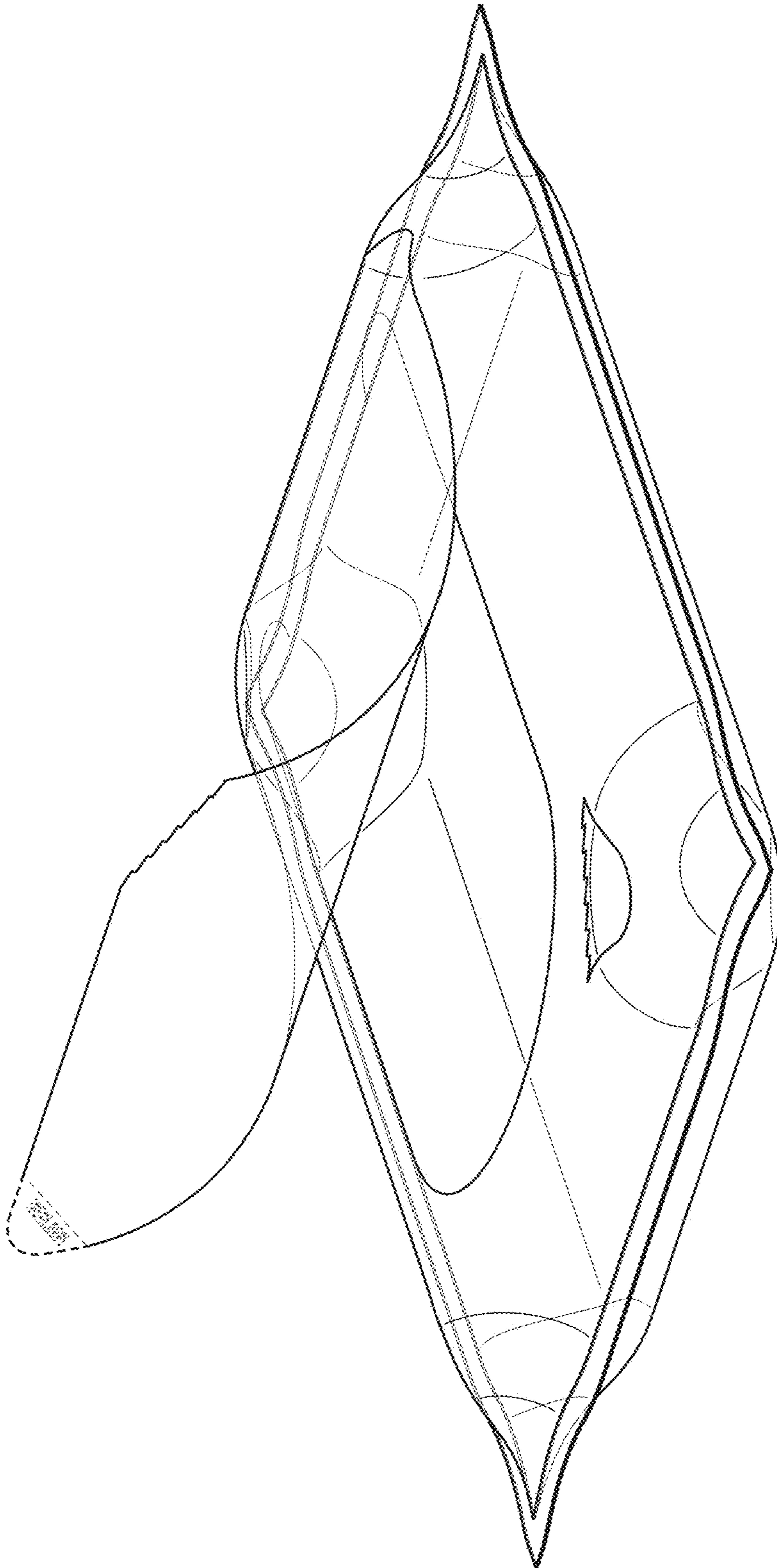

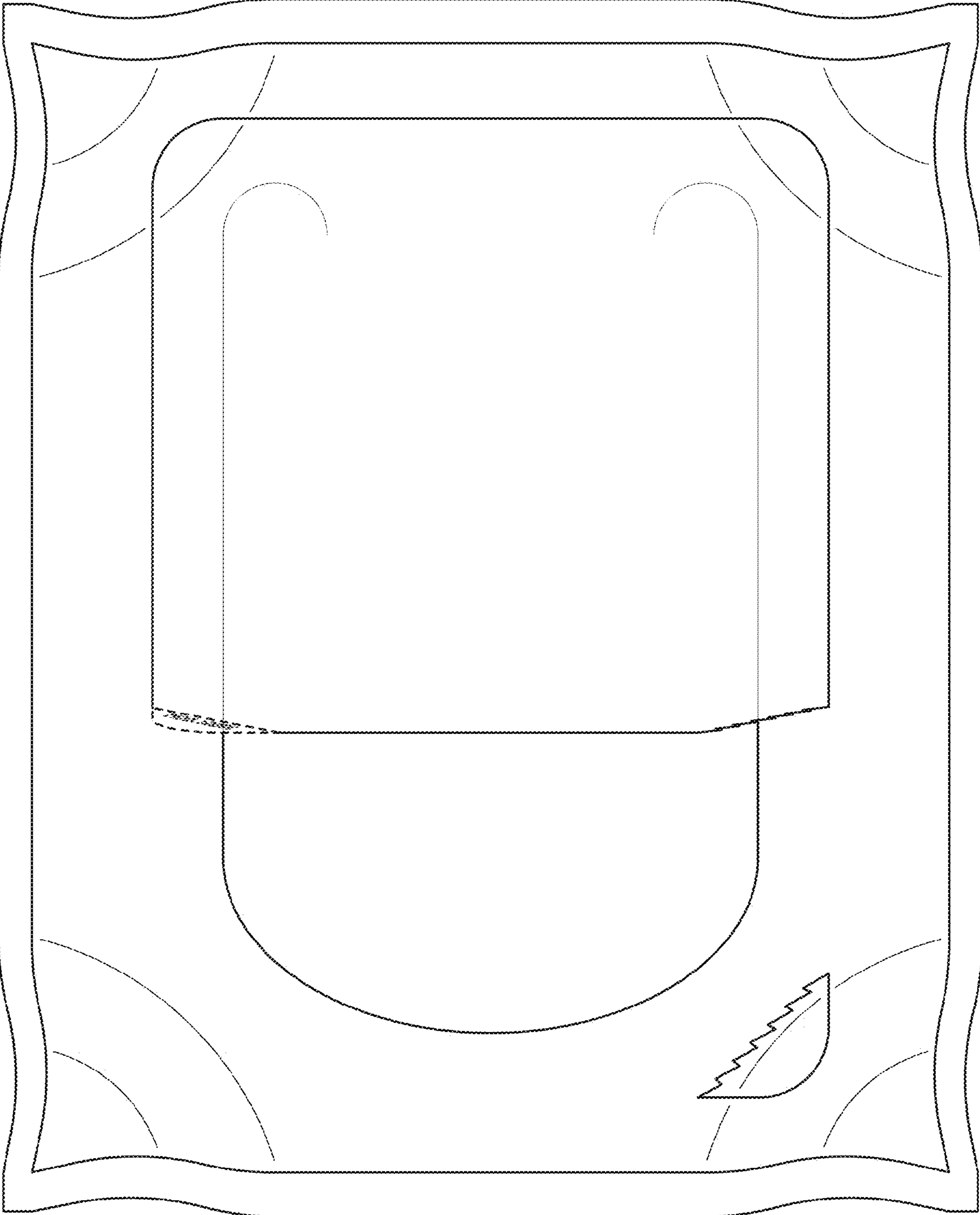

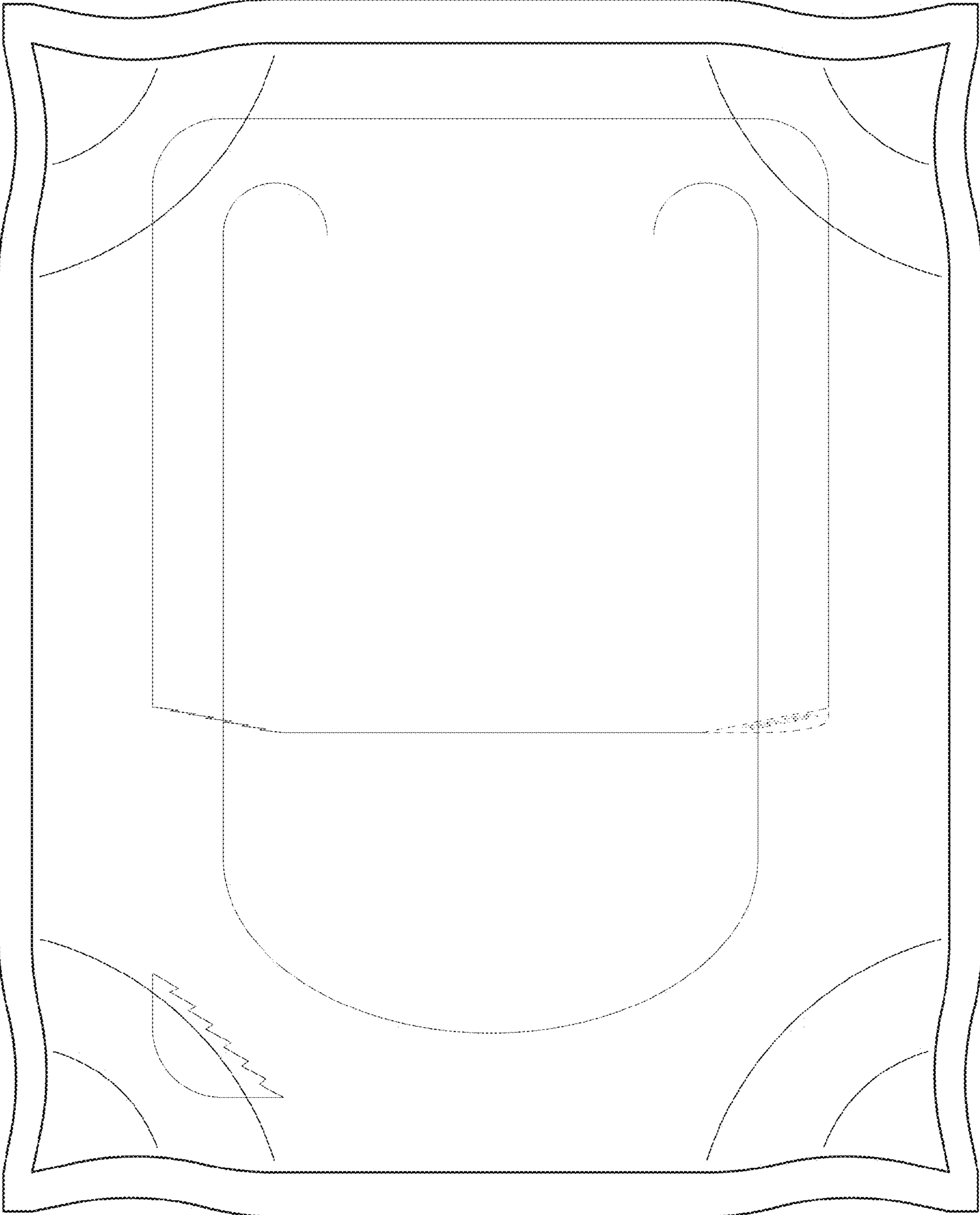

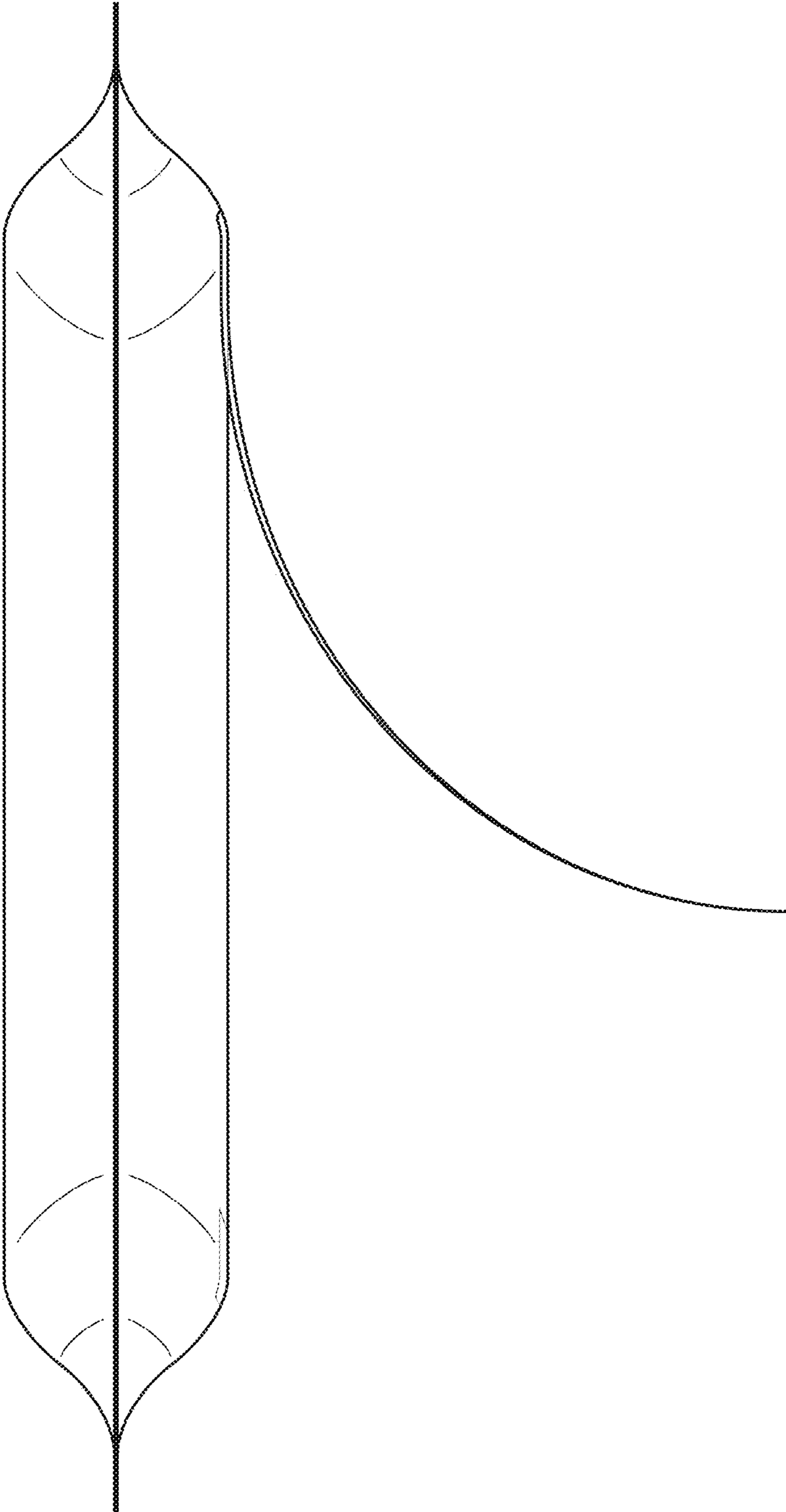

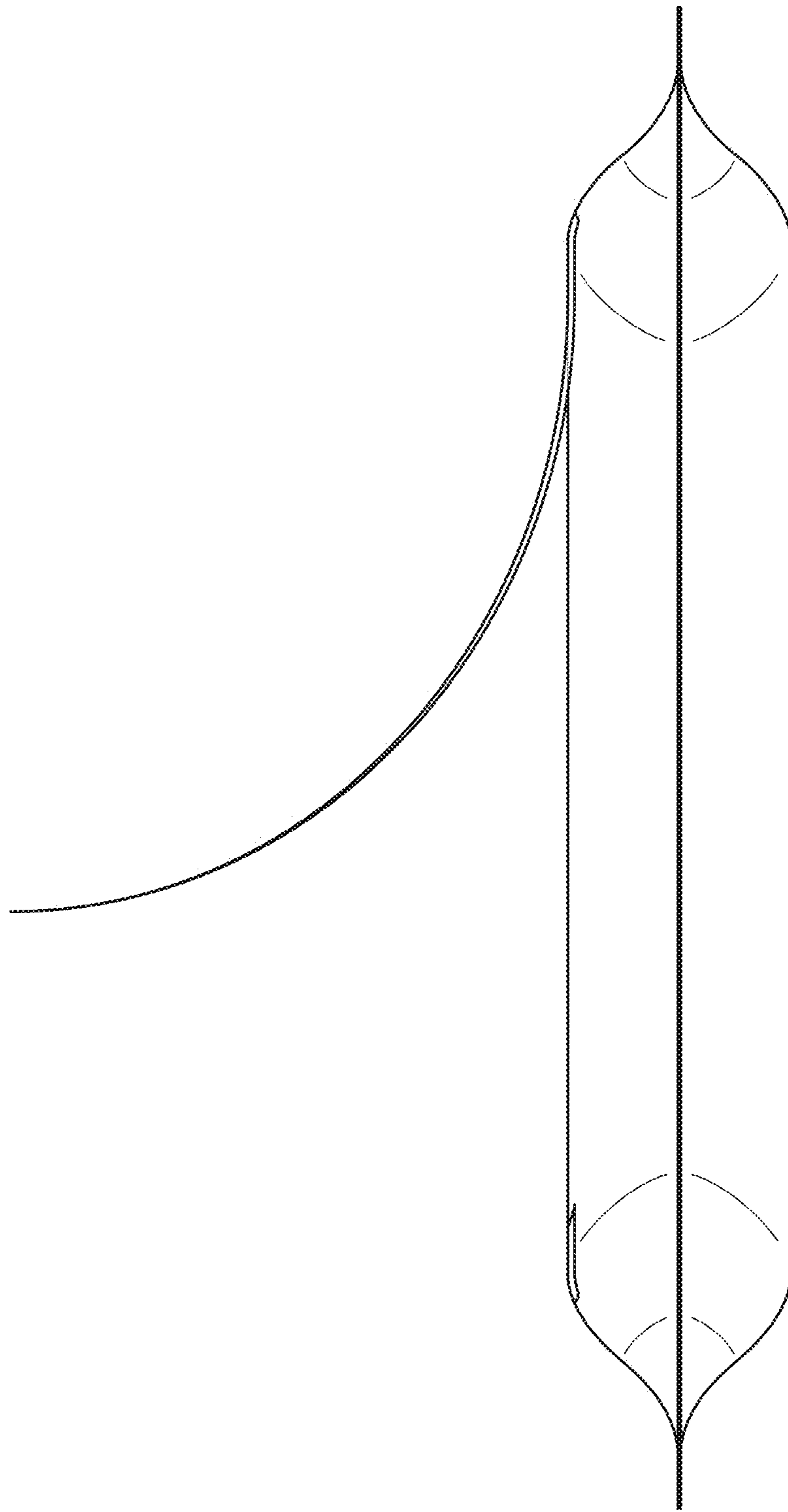

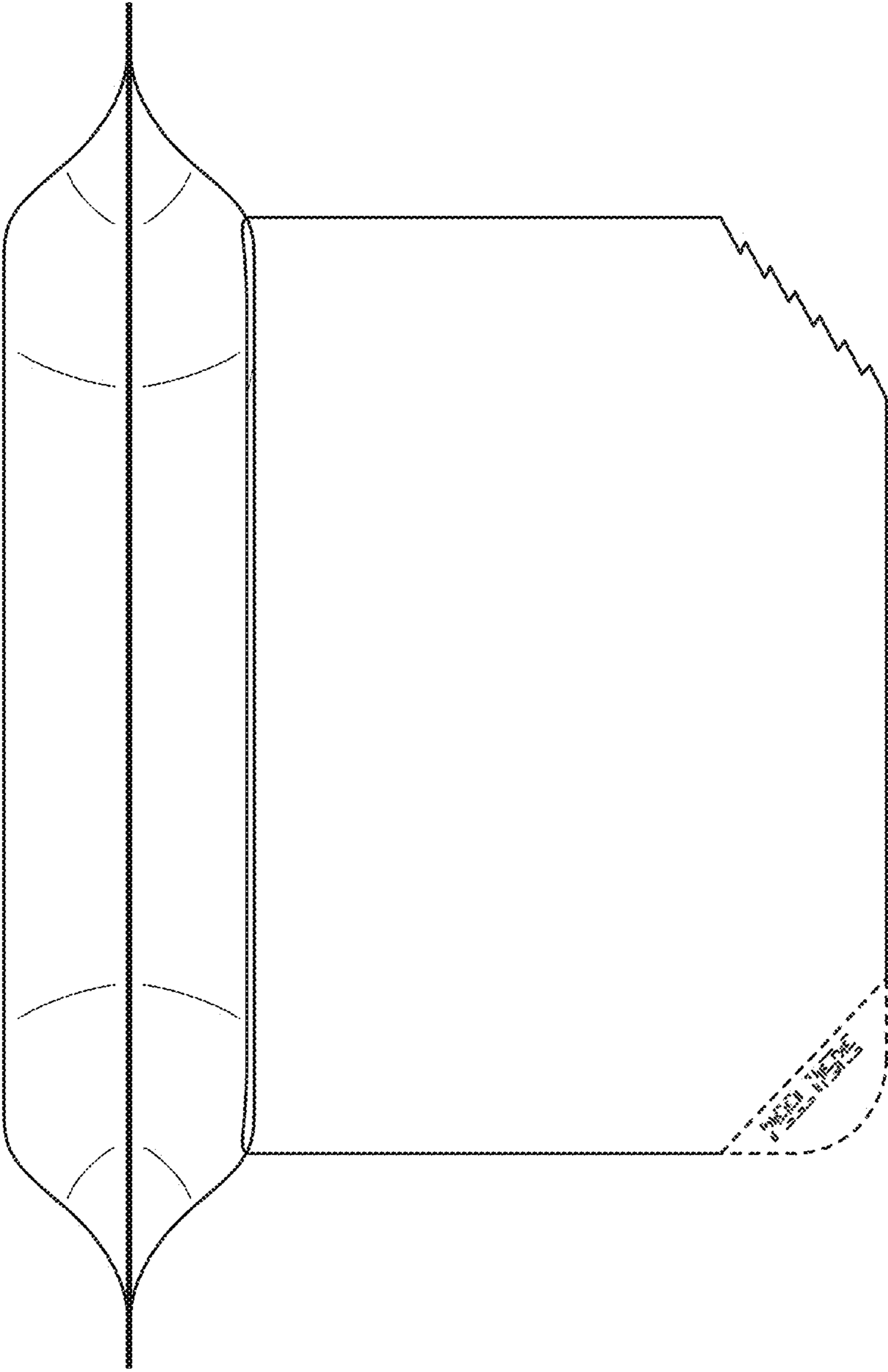

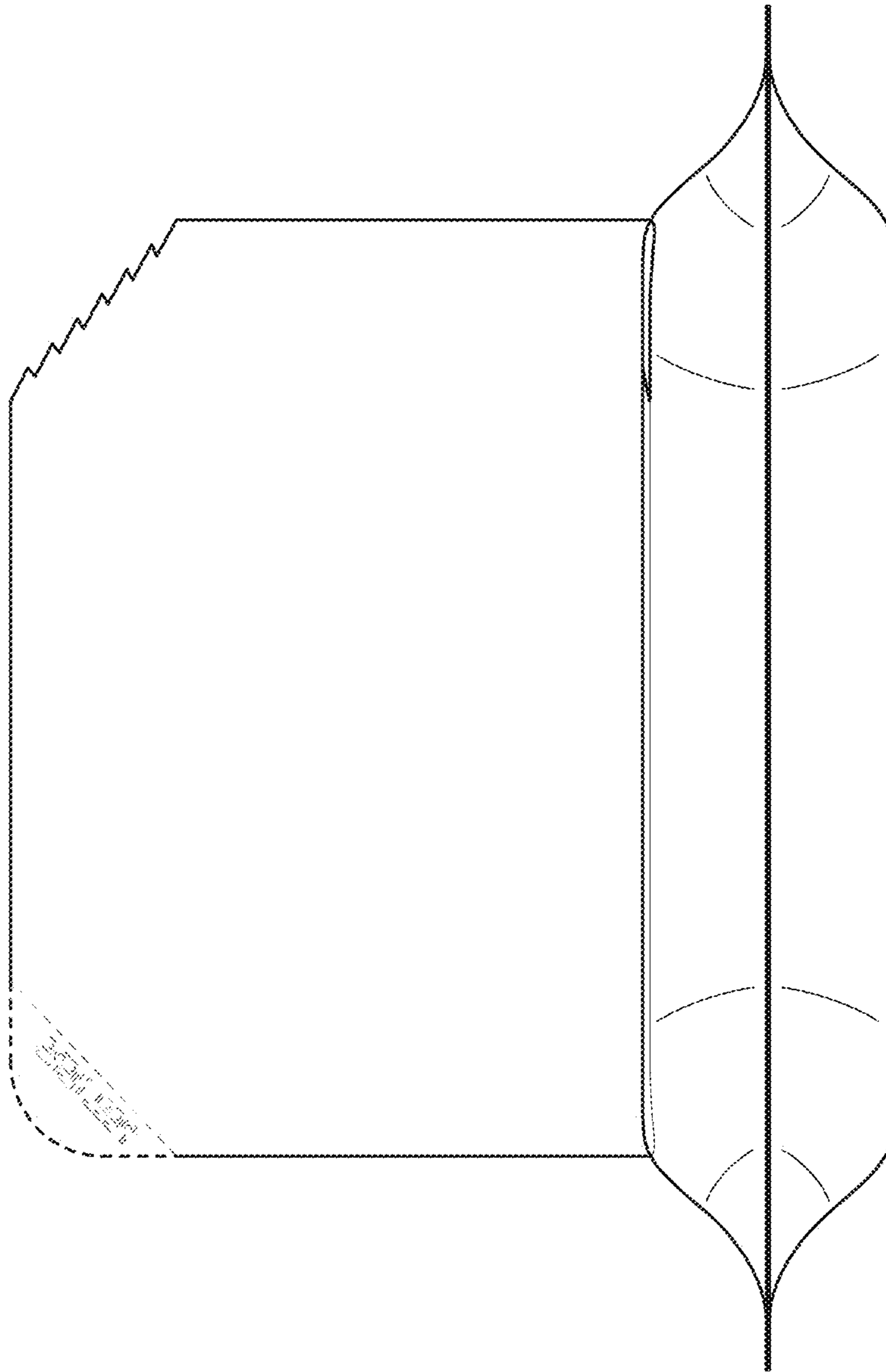
