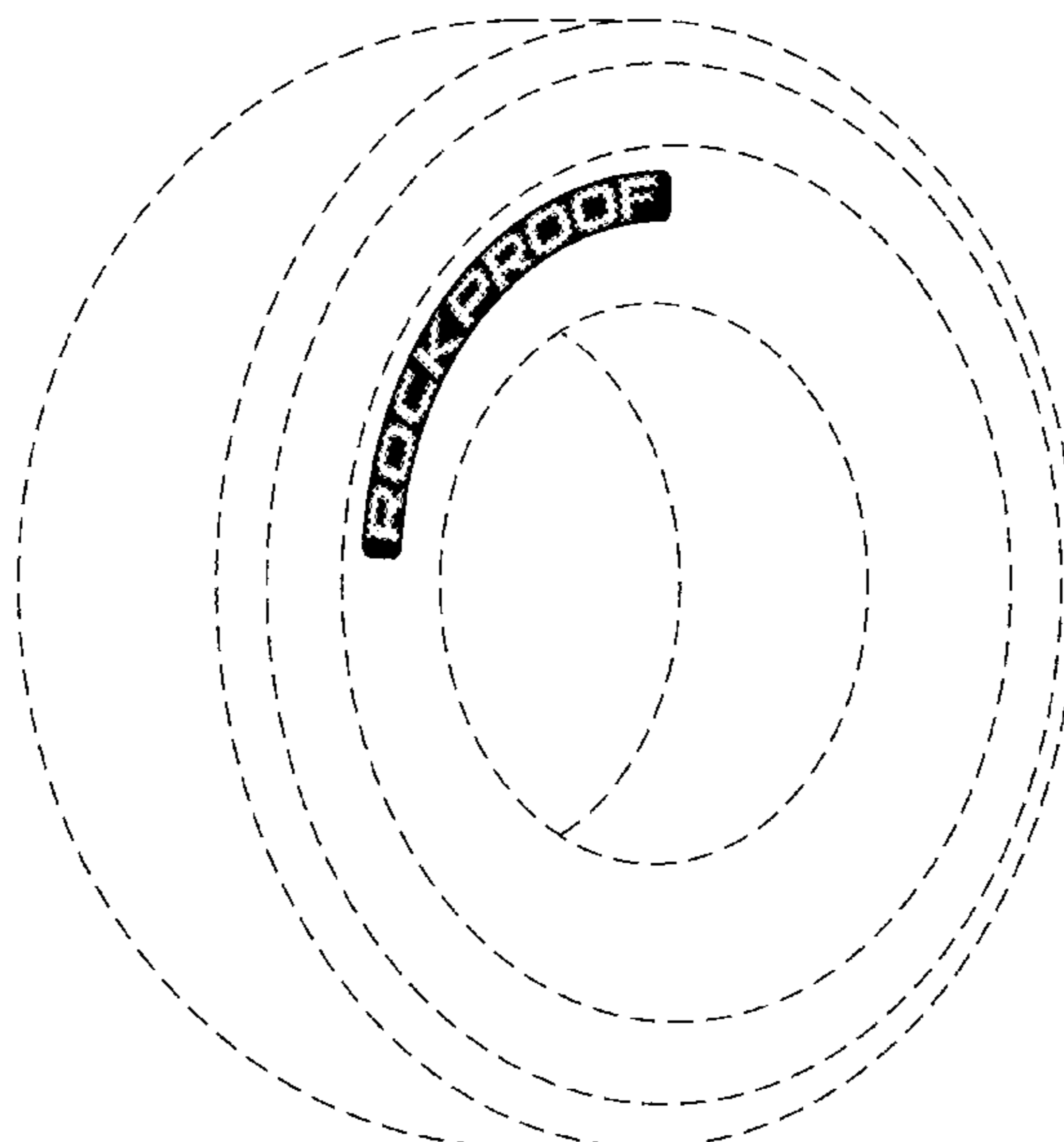
(57) **CLAIM**

The ornamental design for a tyre, as shown and described.

**DESCRIPTION**

FIG. 1 is front right side perspective view of a tyre, showing our new design;  
FIG. 2 is a right side view of the tyre in FIG. 1, a left side view being the mirror image thereof; and,  
FIG. 3 is a partial front right perspective view of the tyre in FIG. 1, showing our new design.  
The broken lines in the drawings illustrate portions of the tyre that form no part of the claimed design.

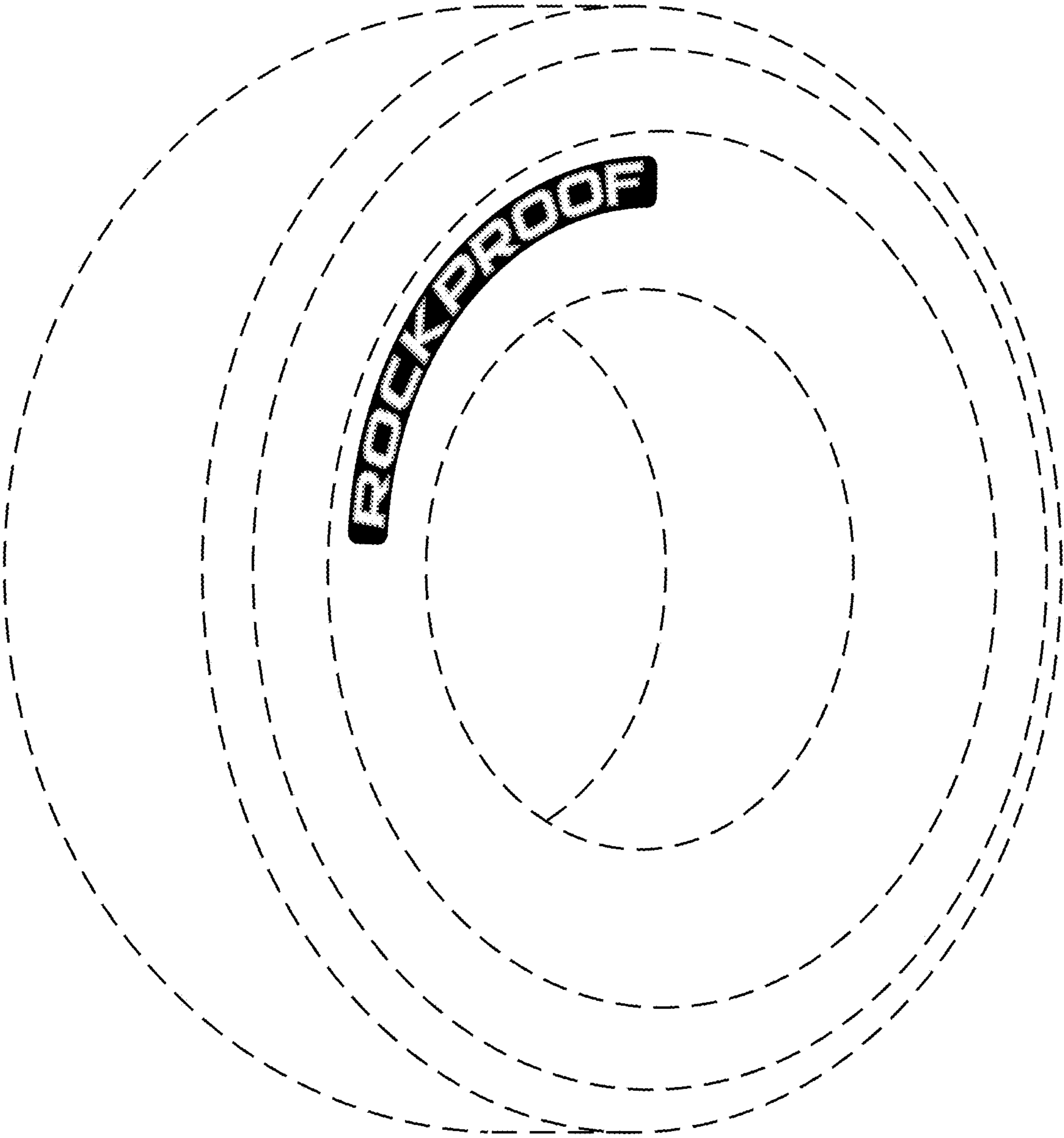

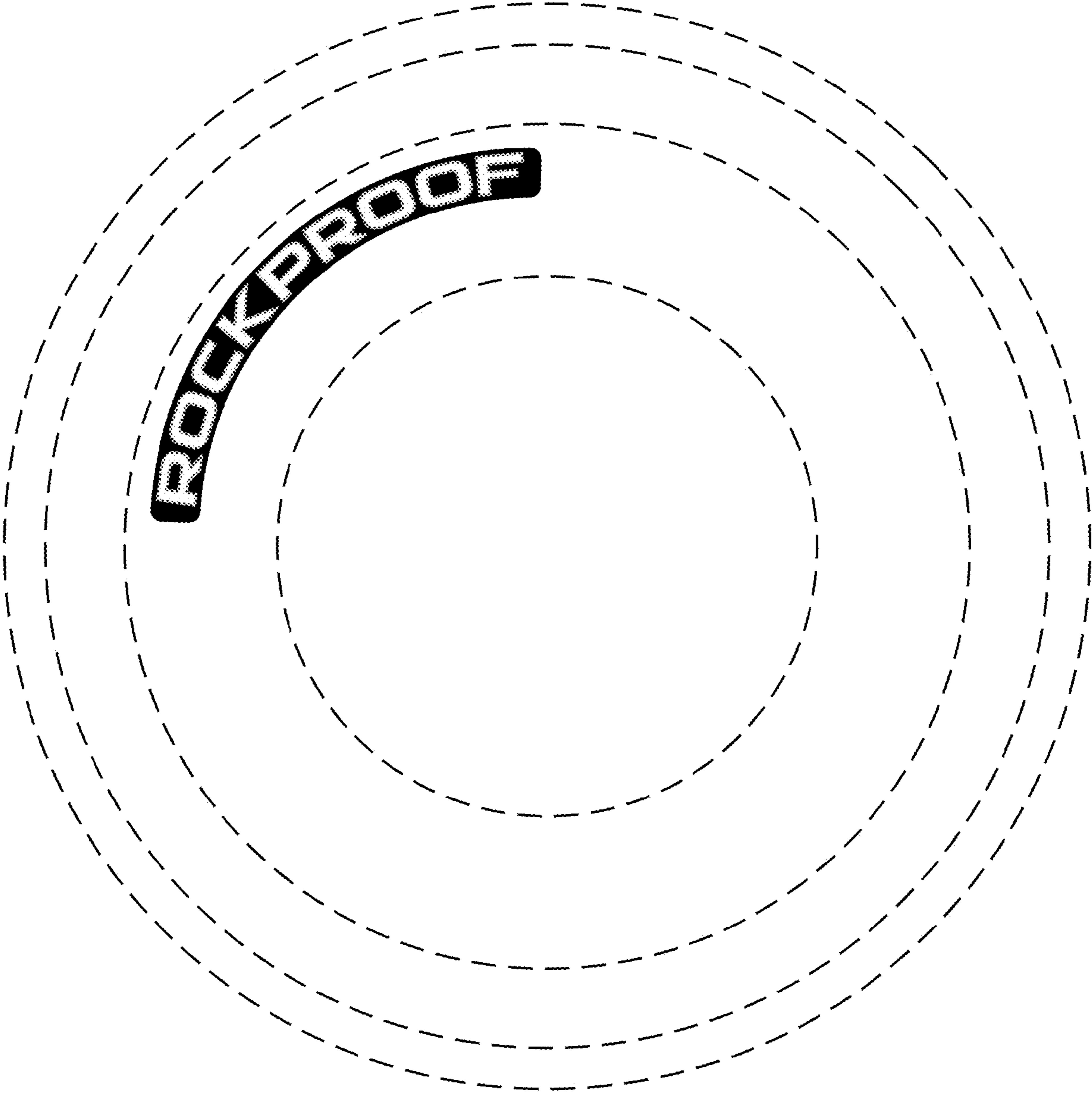

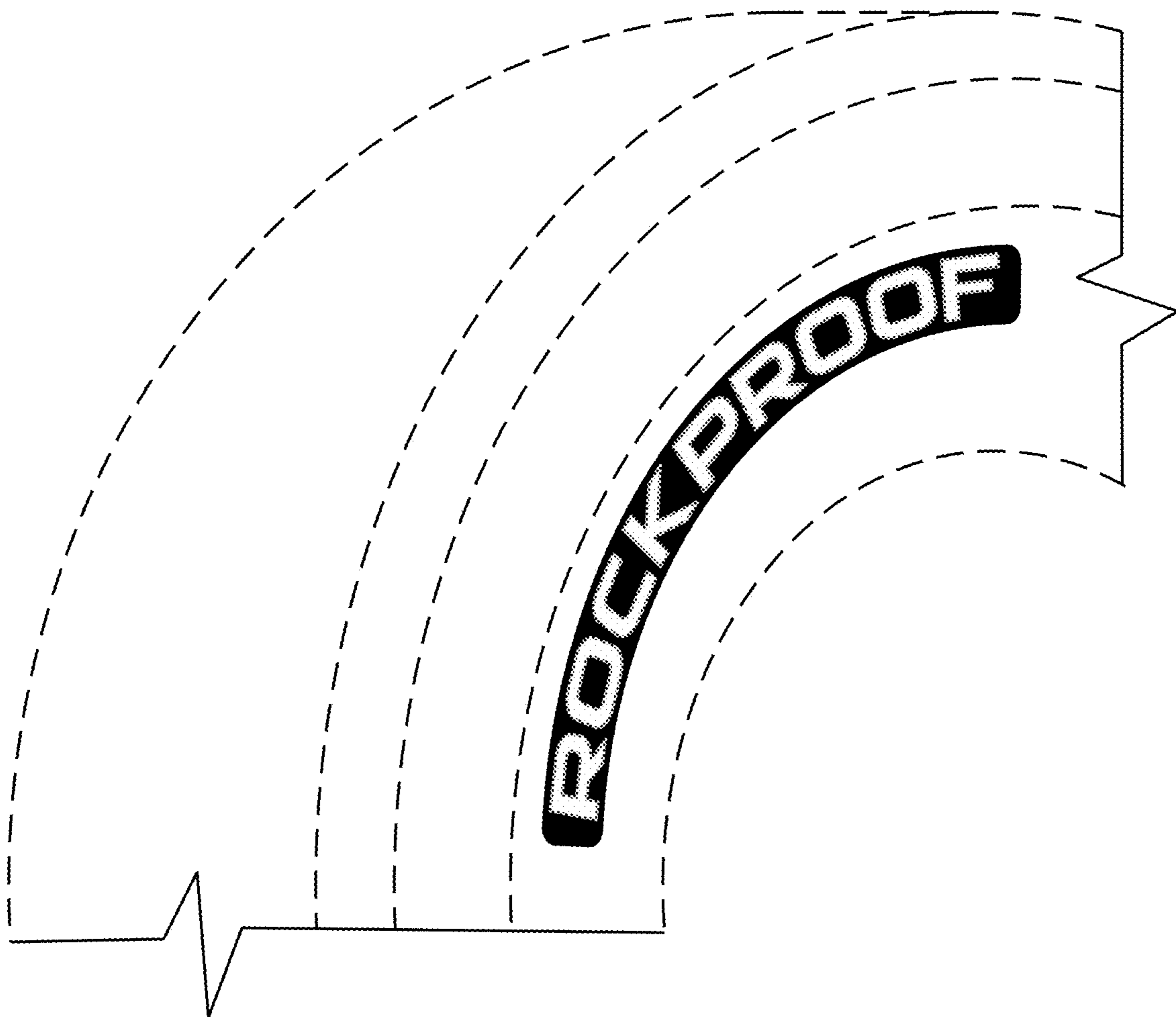
