(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 shows a first image of a display screen or portion thereof with animated graphical user interface showing our new design; and,

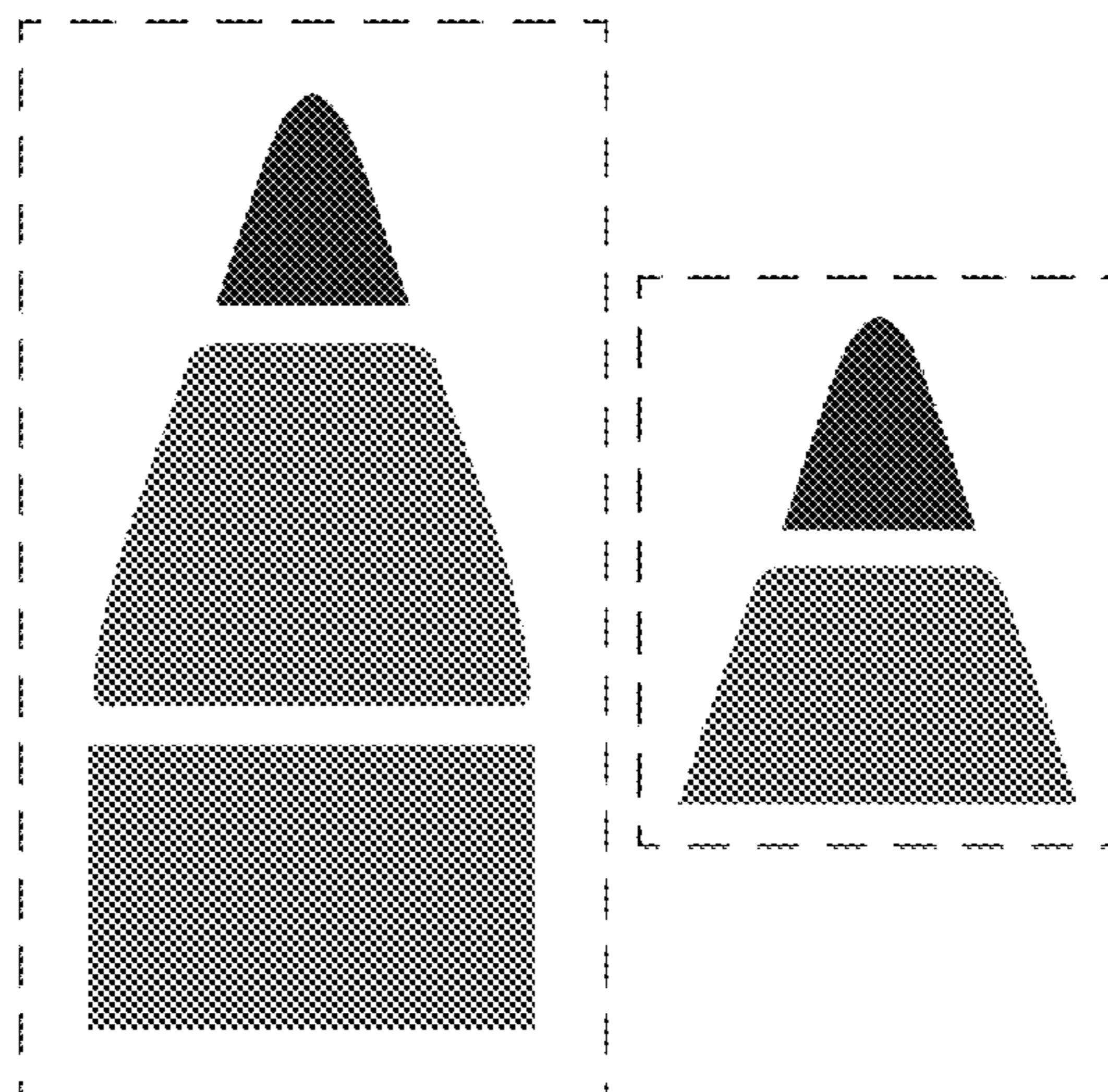
FIG. 2 shows a second image thereof.

The peripheral dashed broken lines illustrate a display screen or portion thereof and form no part of the claimed design.

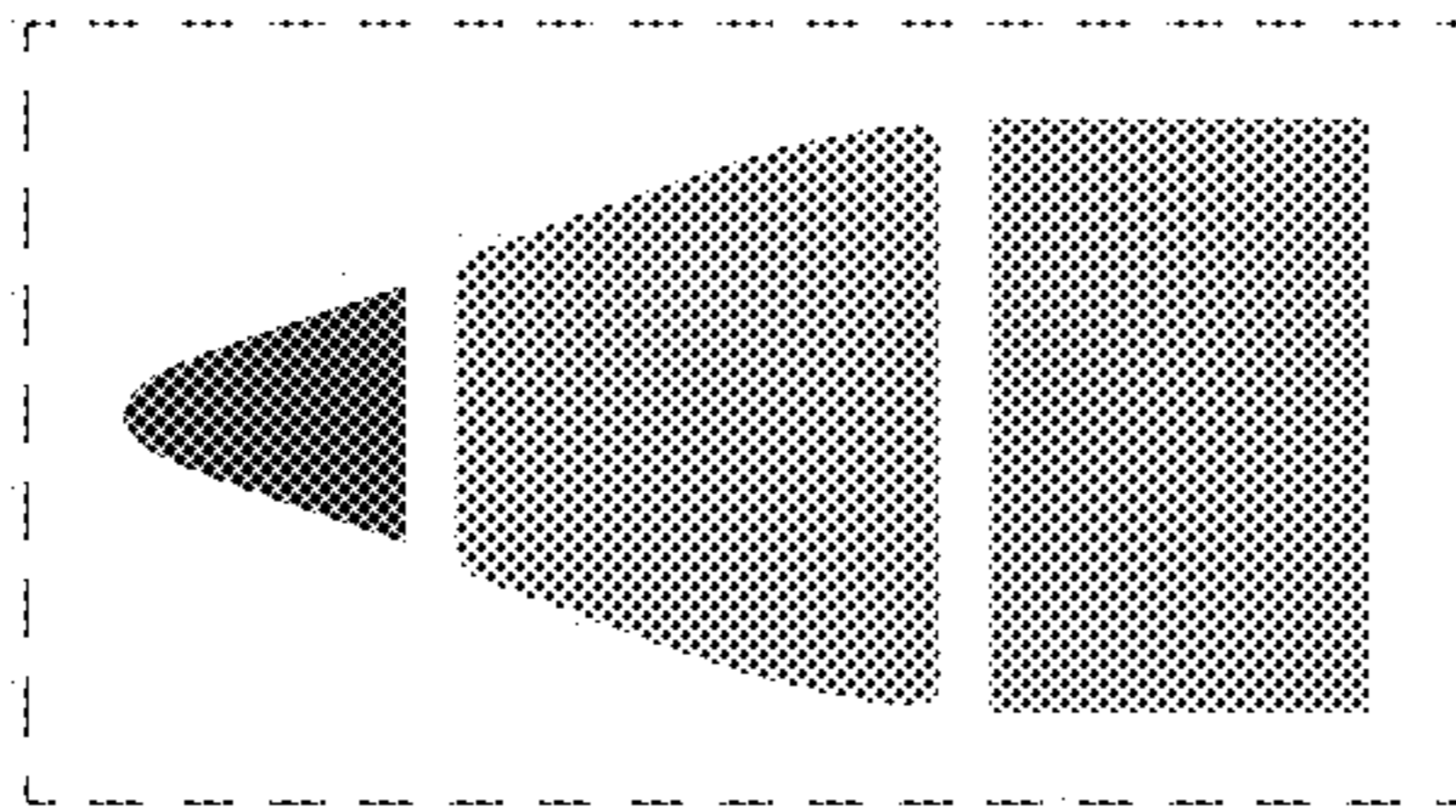

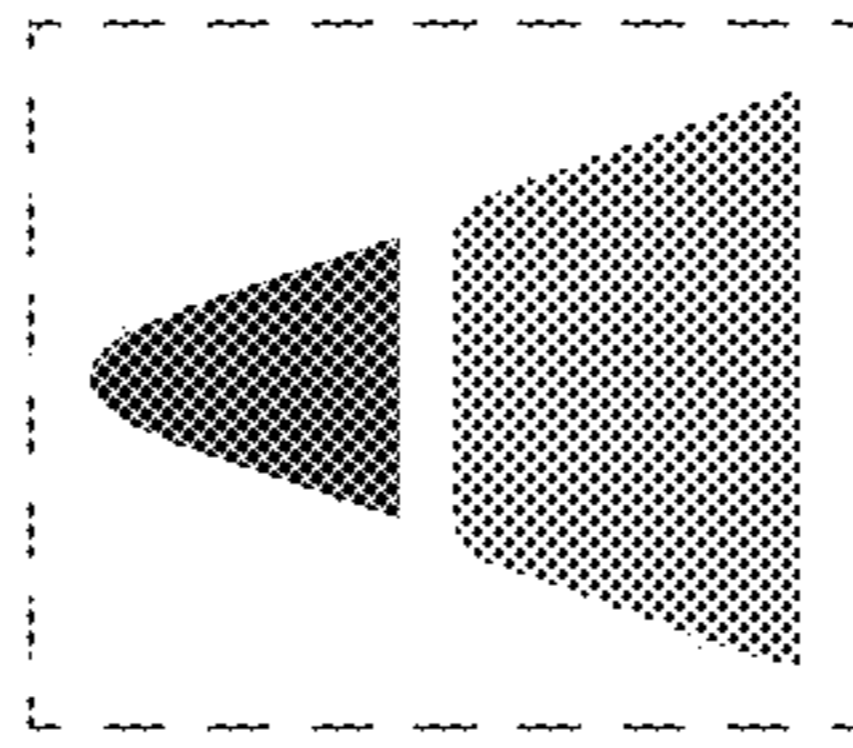
