(57) **CLAIM**

The ornamental design for a gift card, as shown and described.

DESCRIPTION

FIG. 1 is a front view of gift card. The top view, bottom view, left-side view, and right-side view are omitted since no claim is made to a thickness of the gift card;

FIG. 2 is a back view thereof;

FIG. 3 is an alternative back view showing a removable portion on the back of the gift card; and,

FIG. 4 is an enlarged view of the area marked "FIG. 4" in FIG. 1.

The dashed broken lines depict portions of the gift card which form no part of the claimed design. The dot-dashed broken lines represent boundaries of the claimed gift card and form no part of the claimed design.

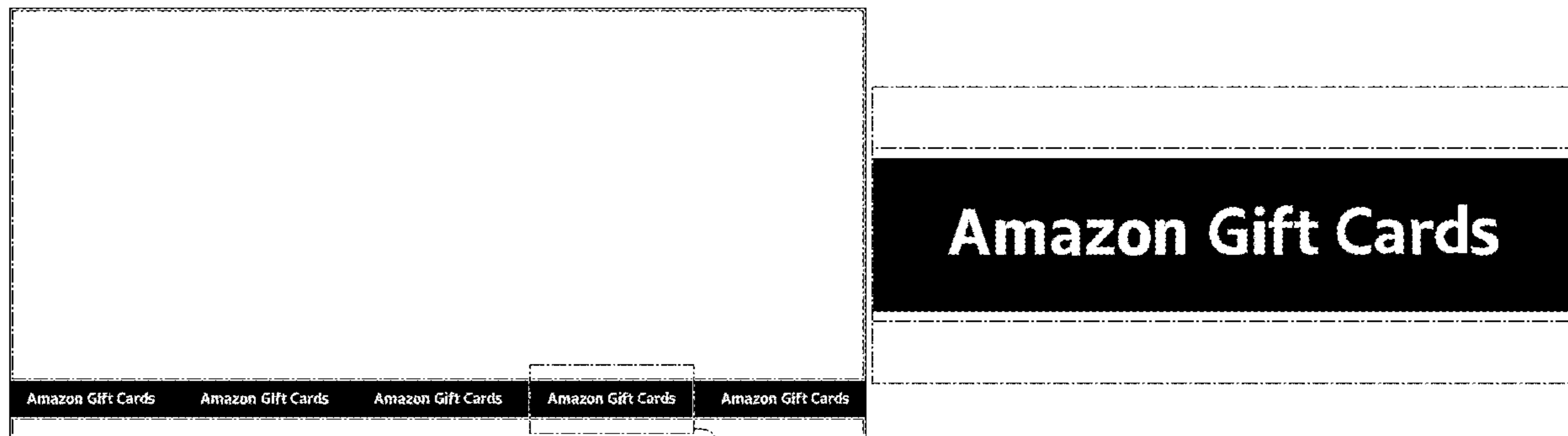

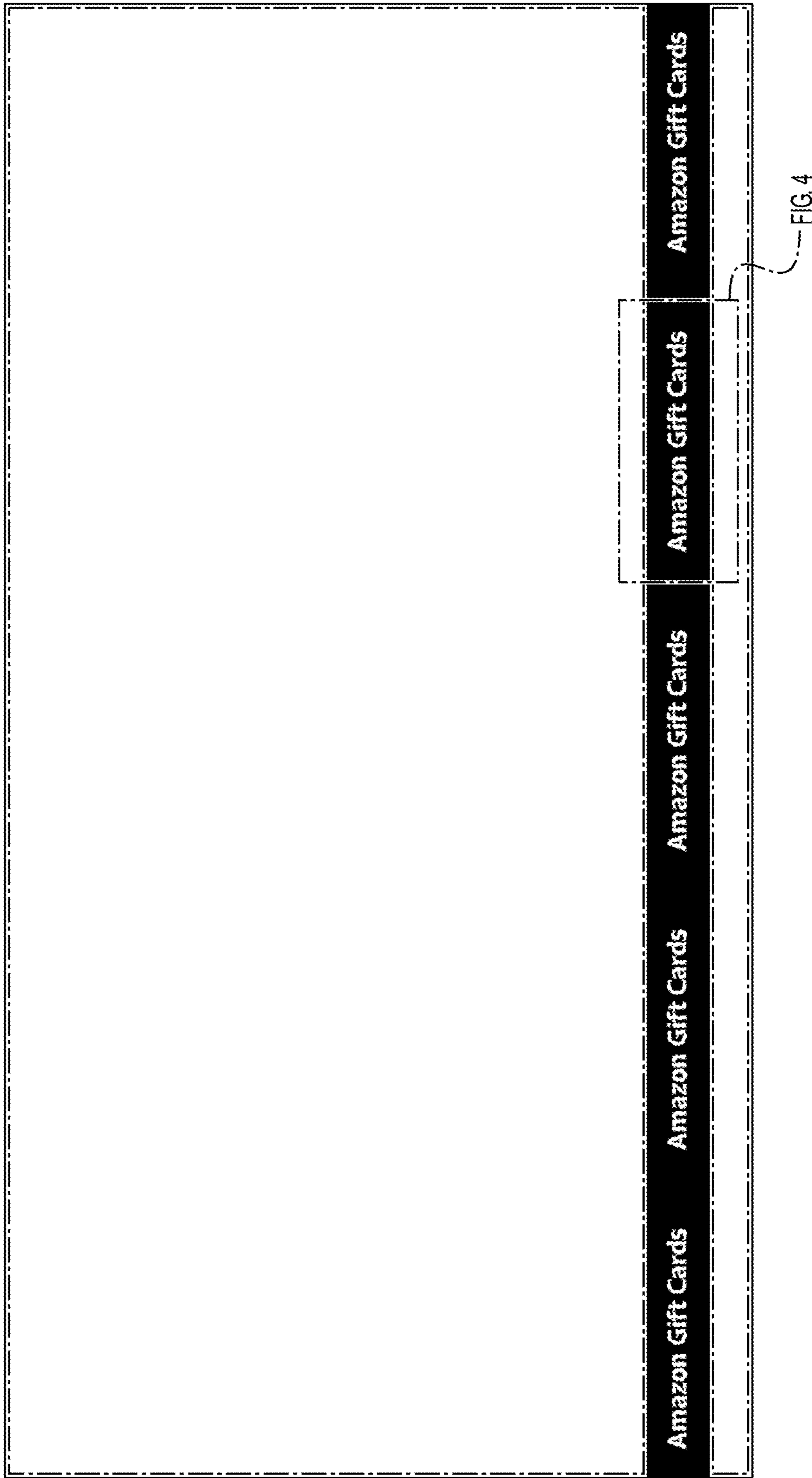

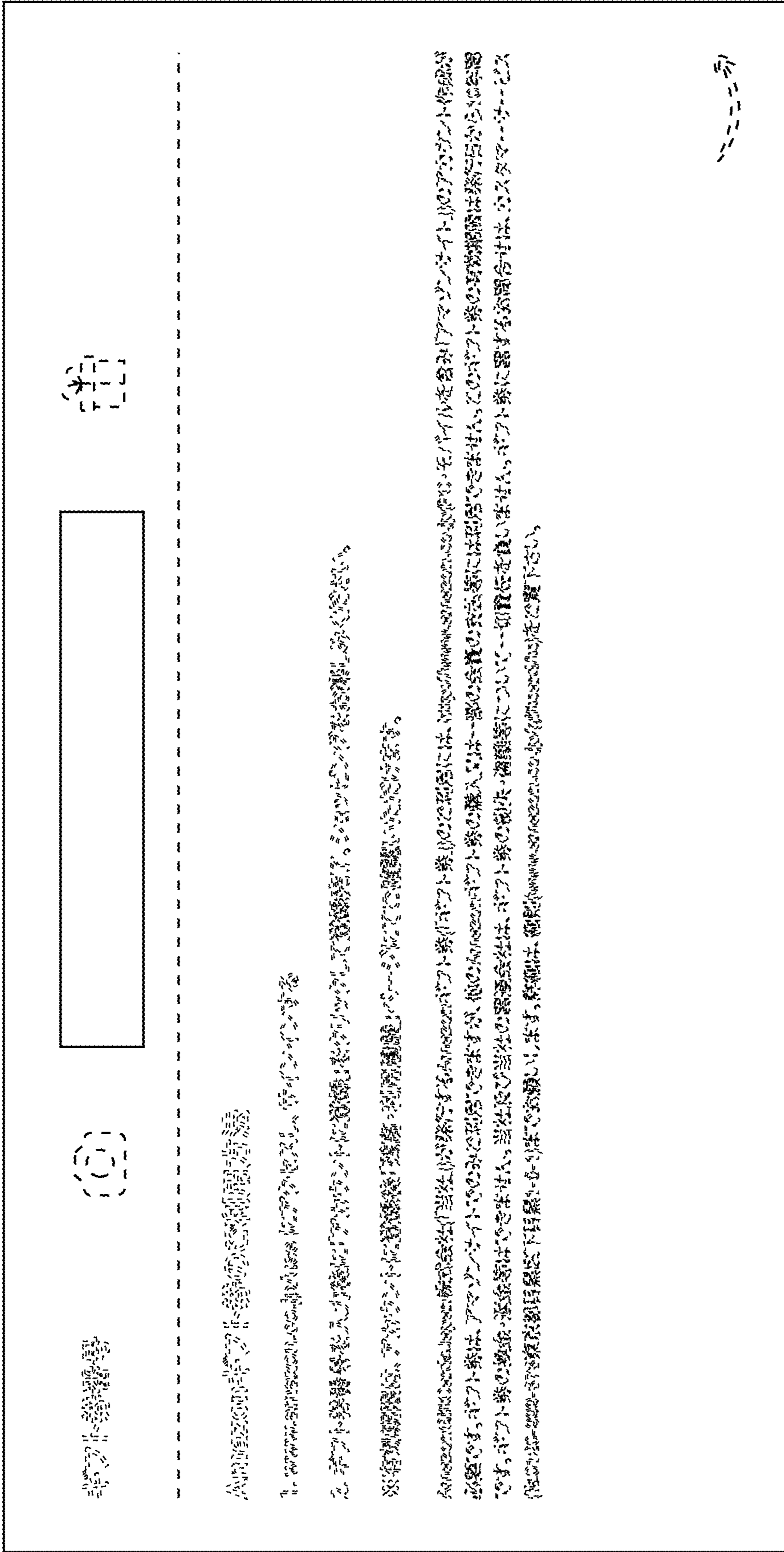

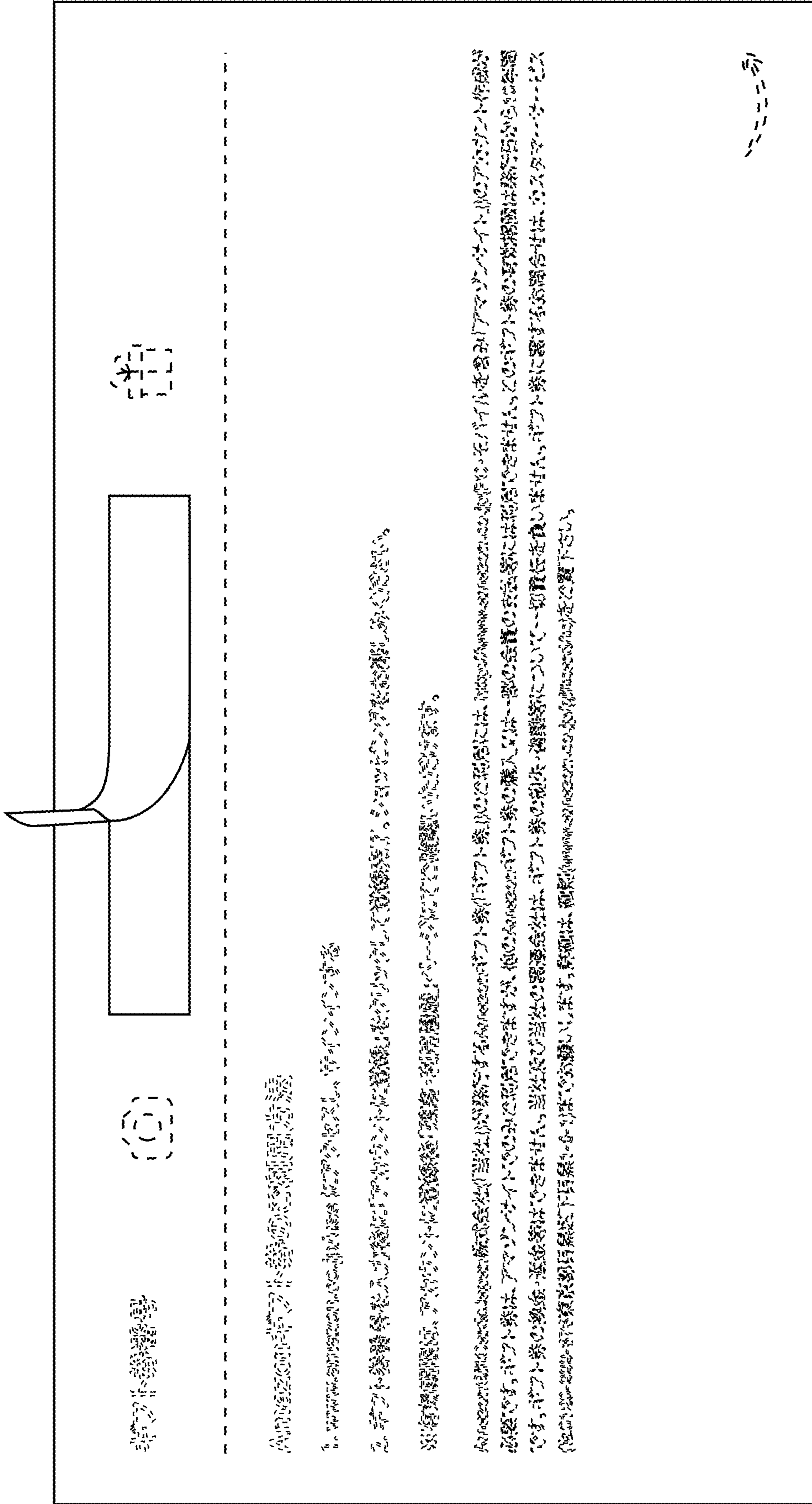

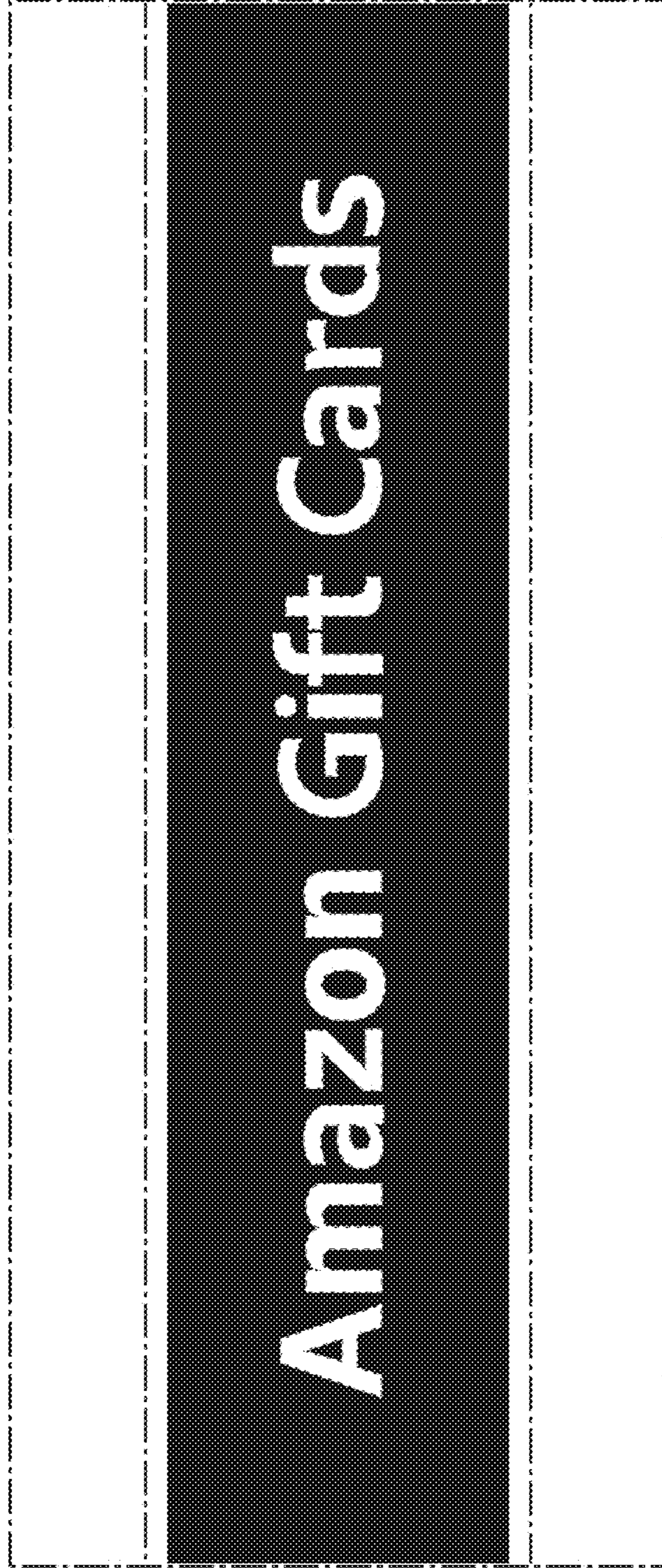
