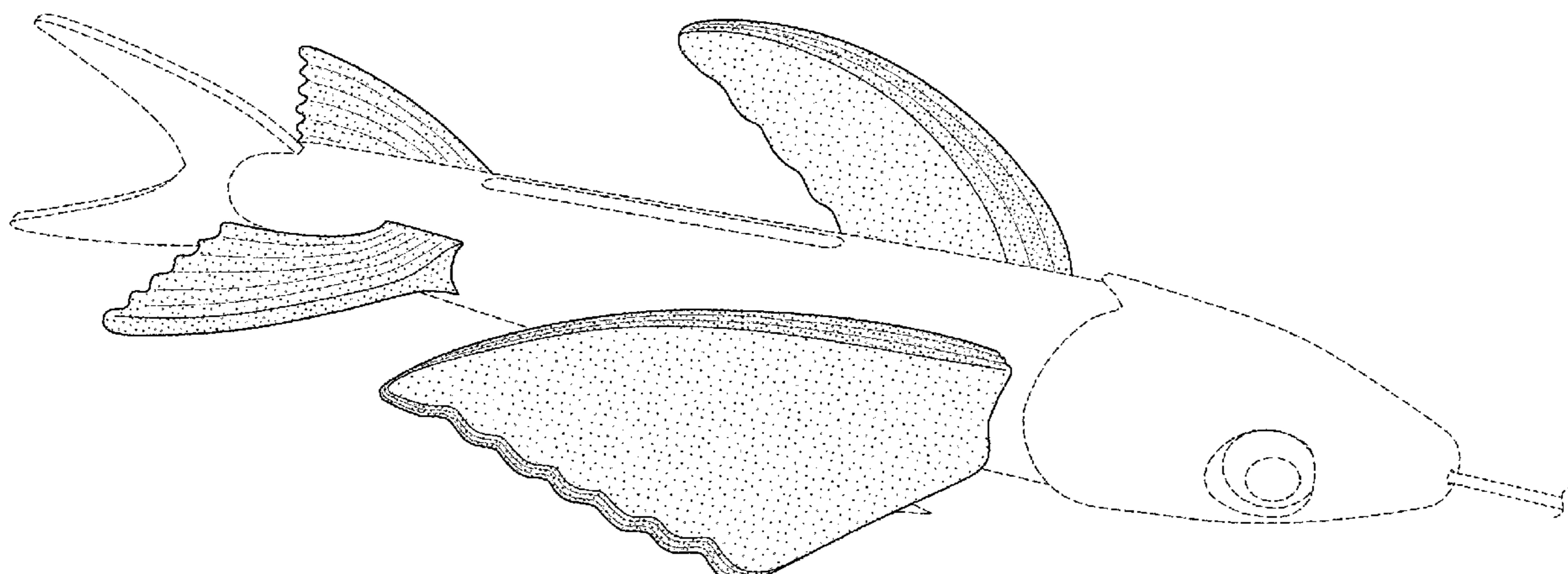


FIG. 19 is a left side view of the fish caricature lure/novelty of FIG. 15.

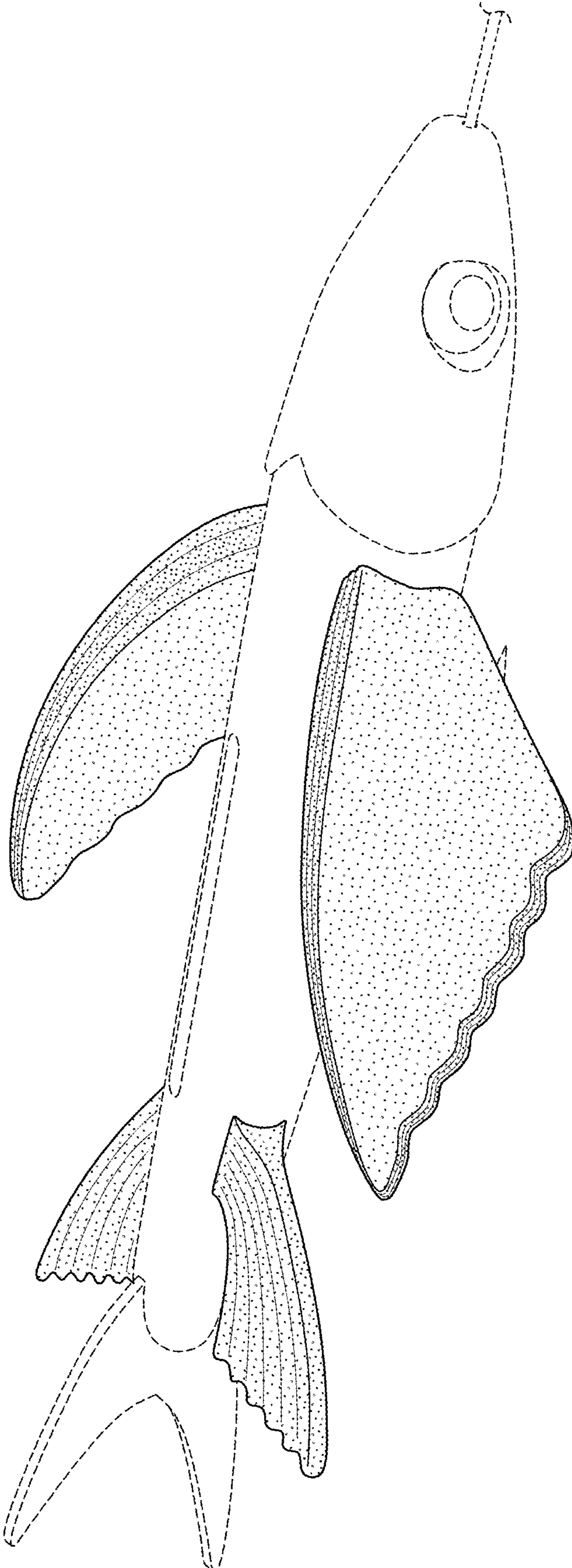

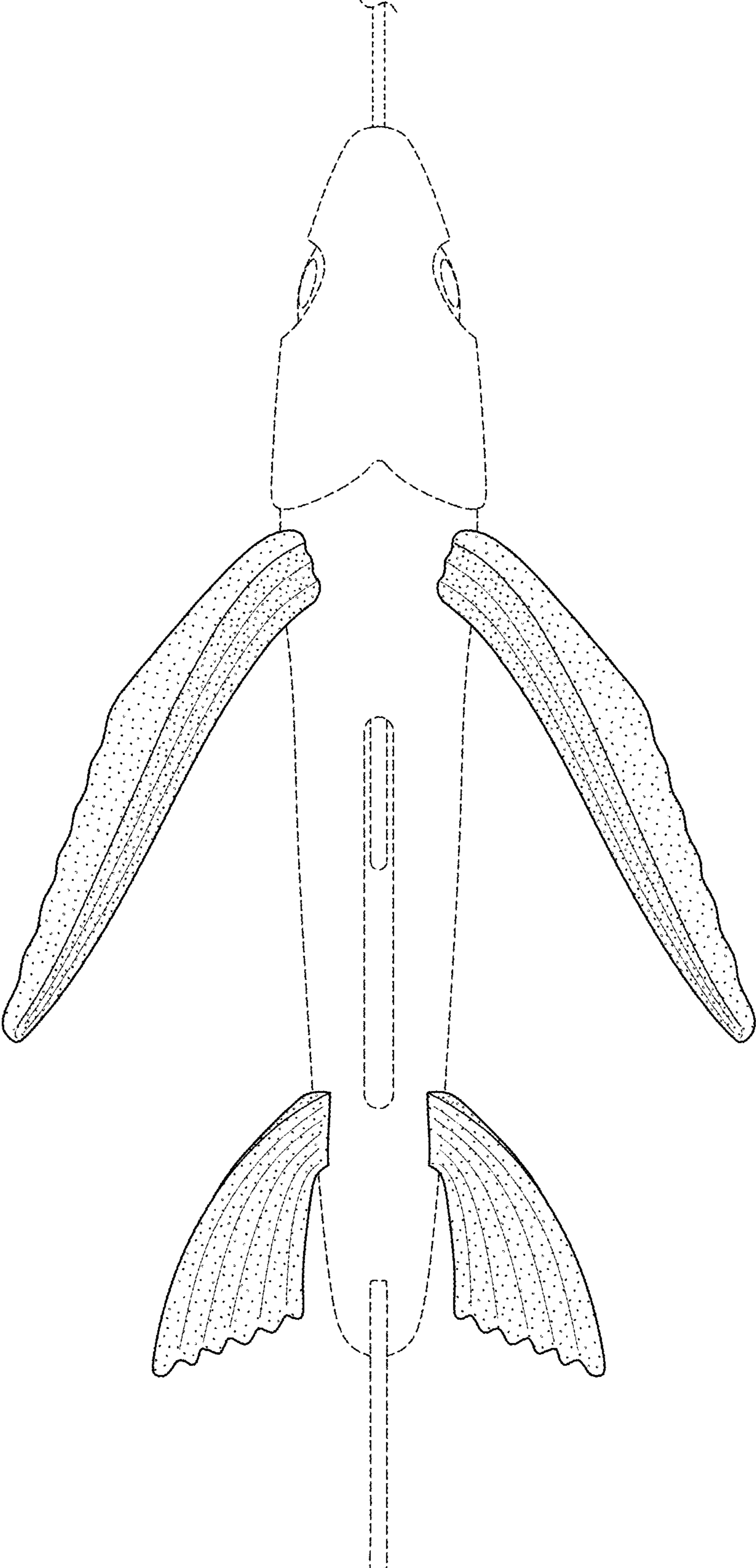

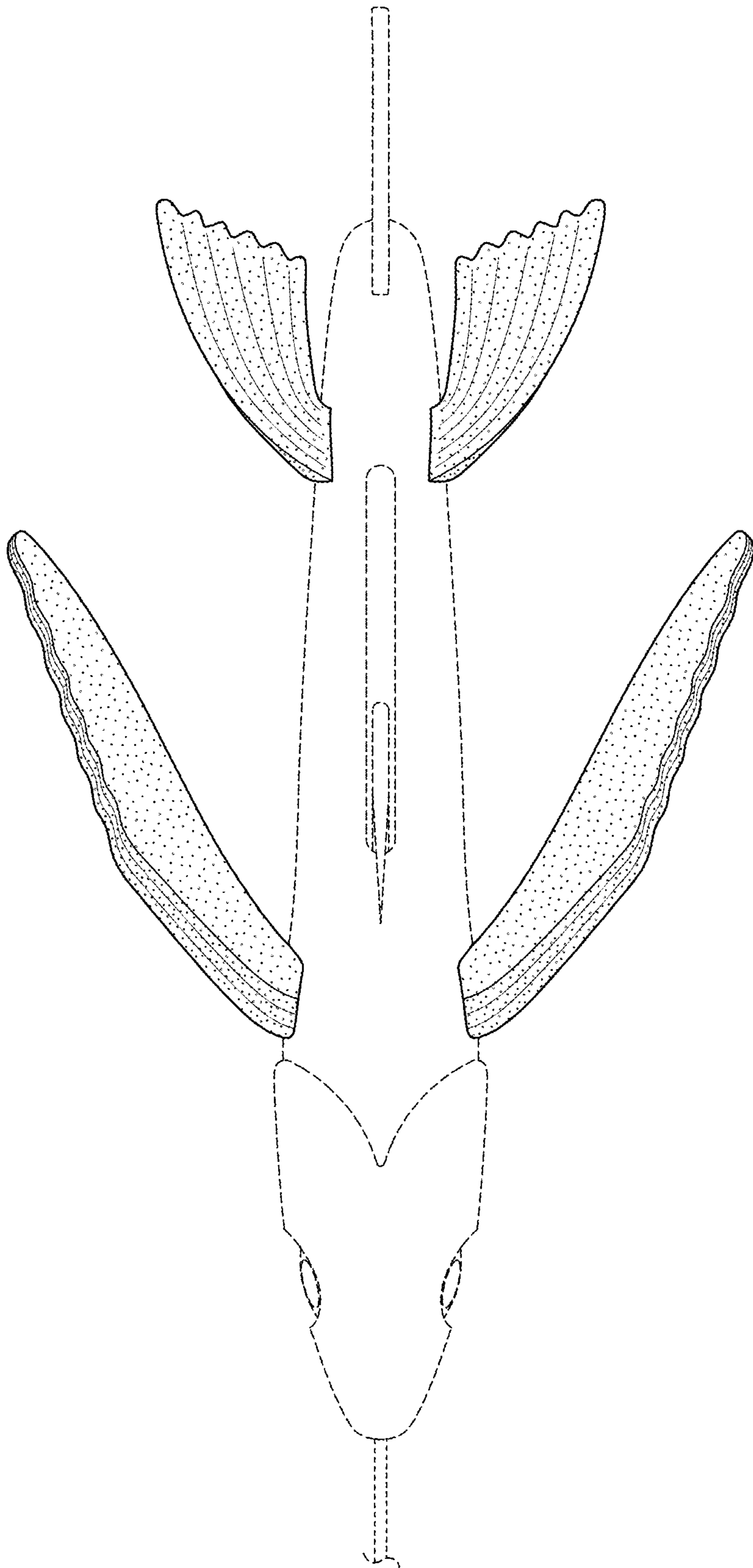

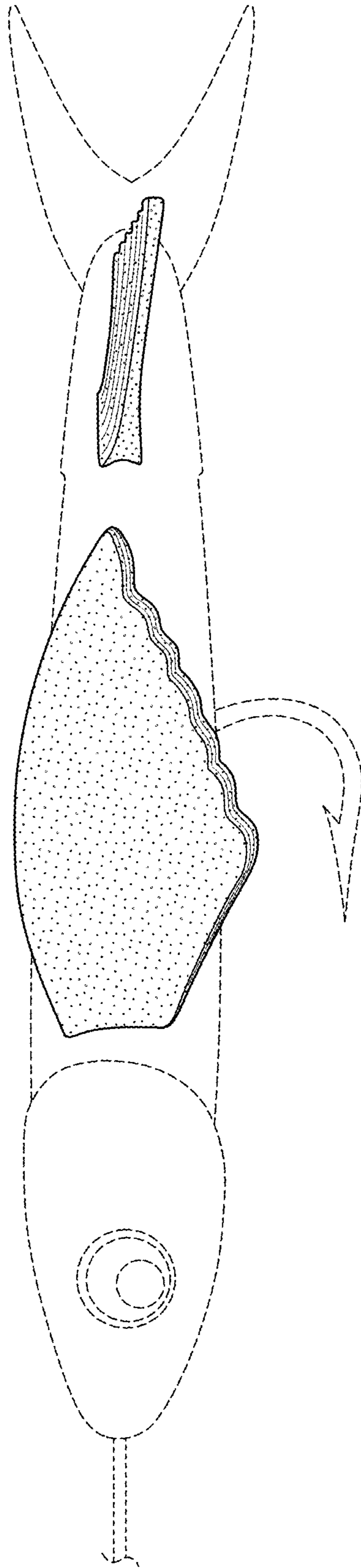

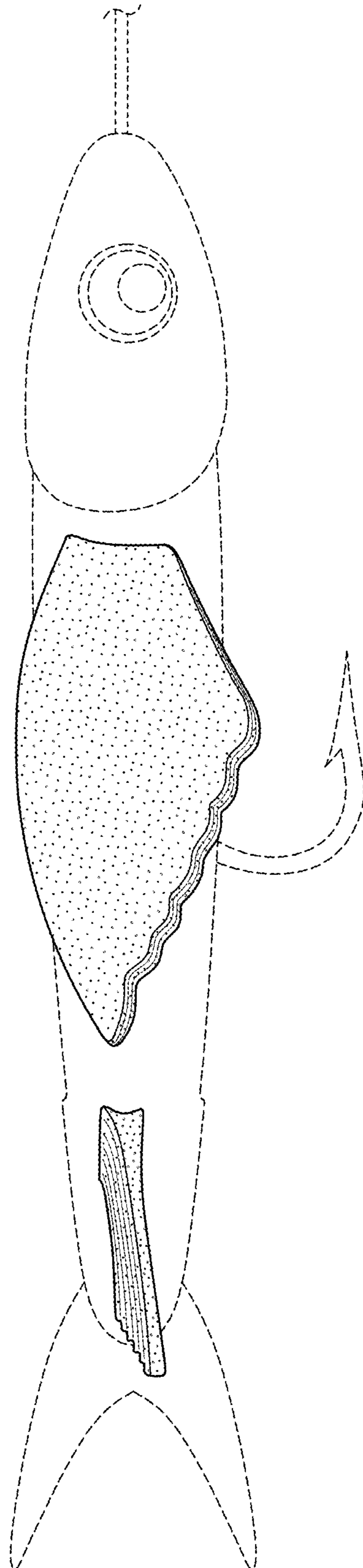

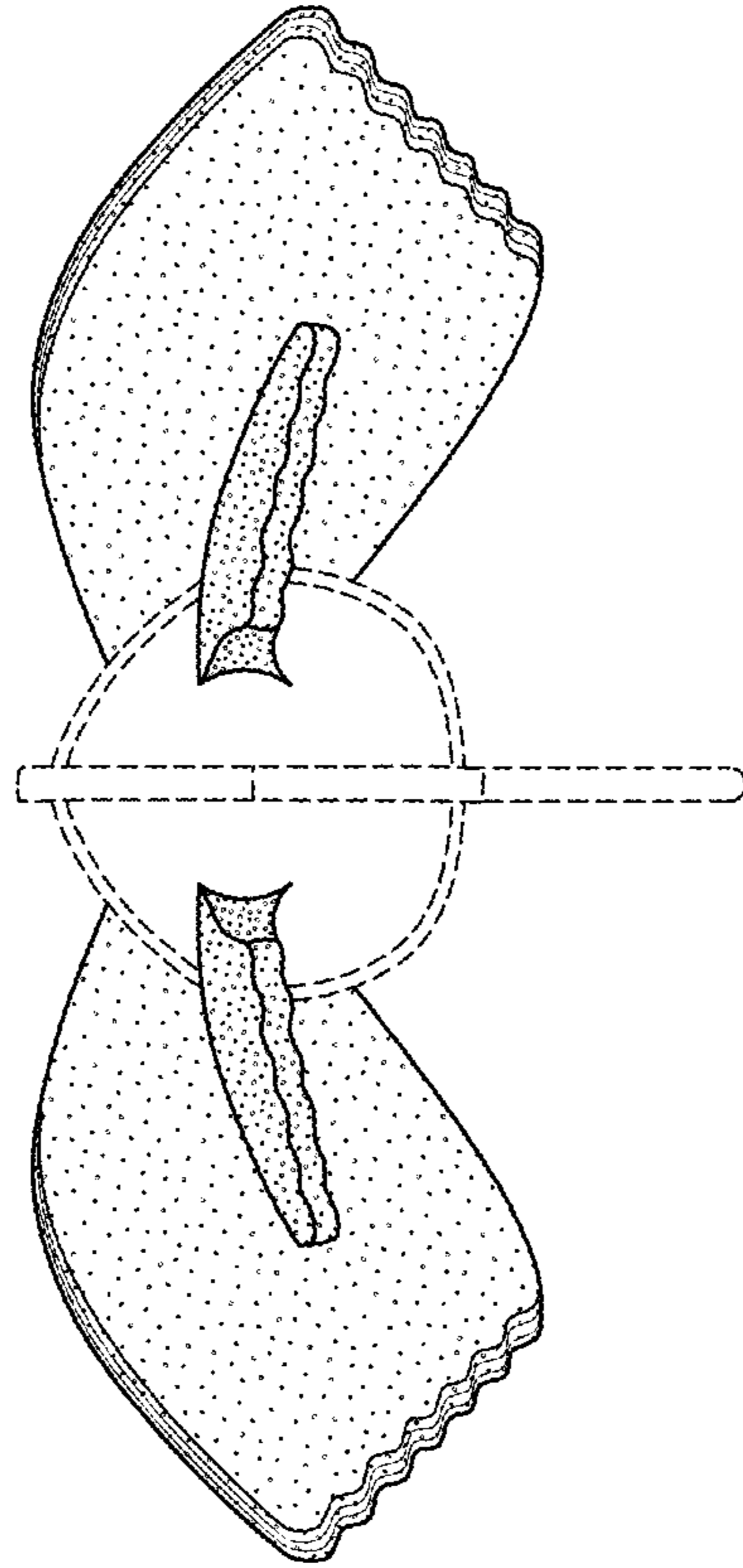

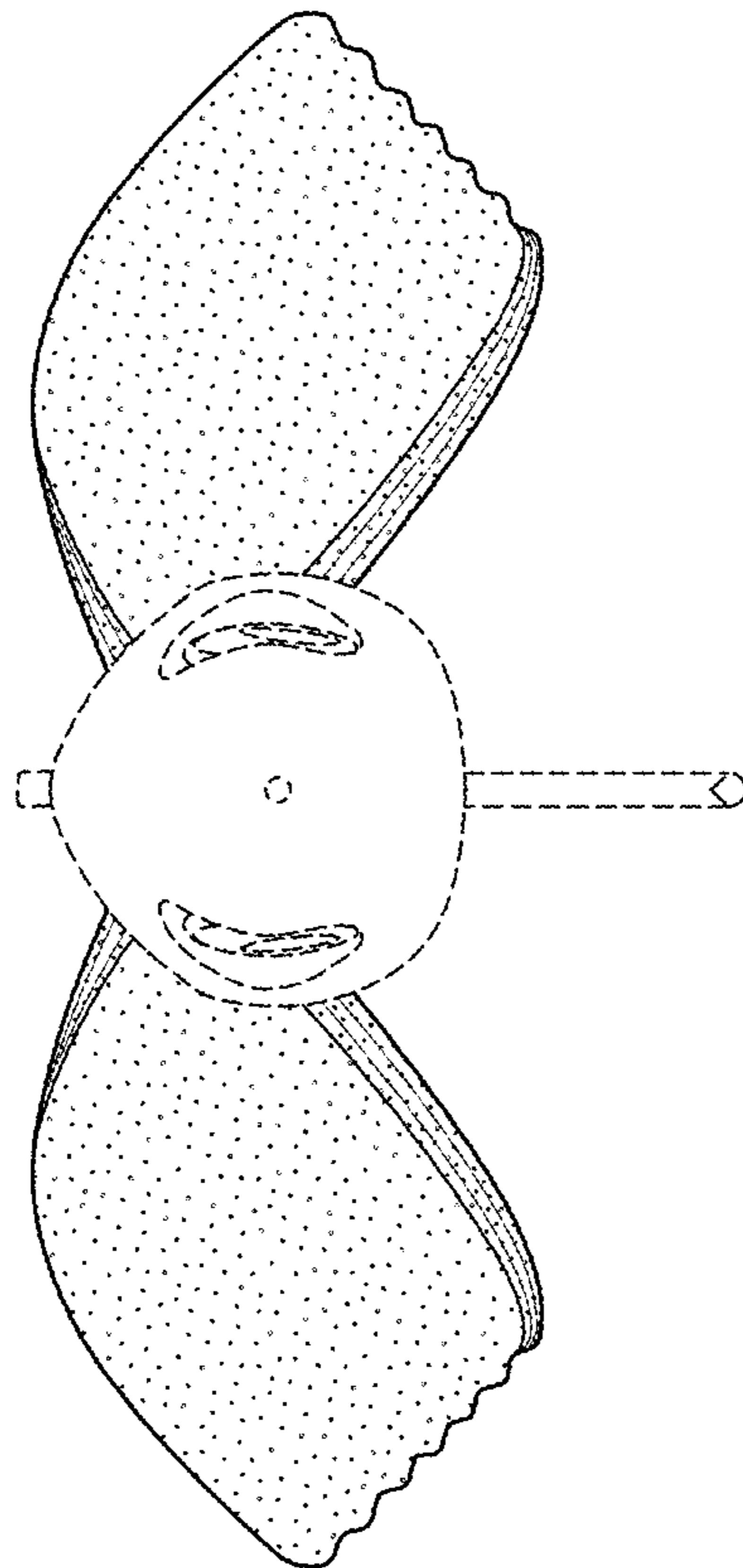

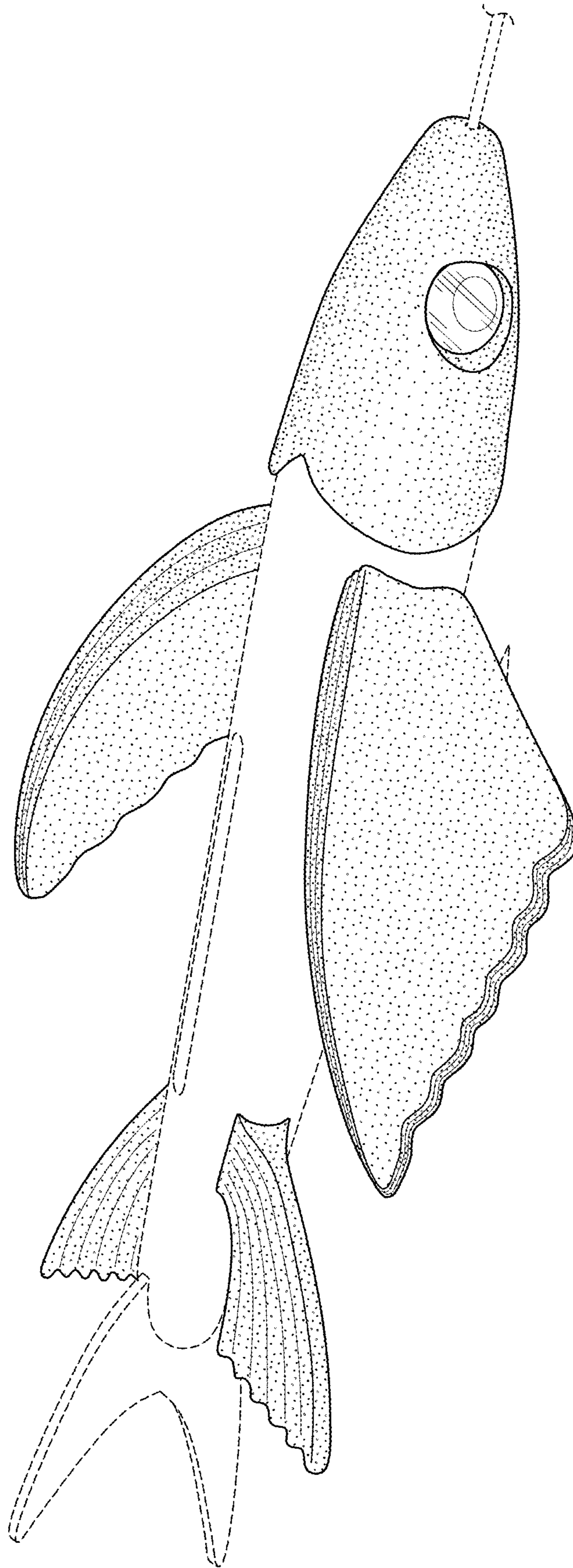

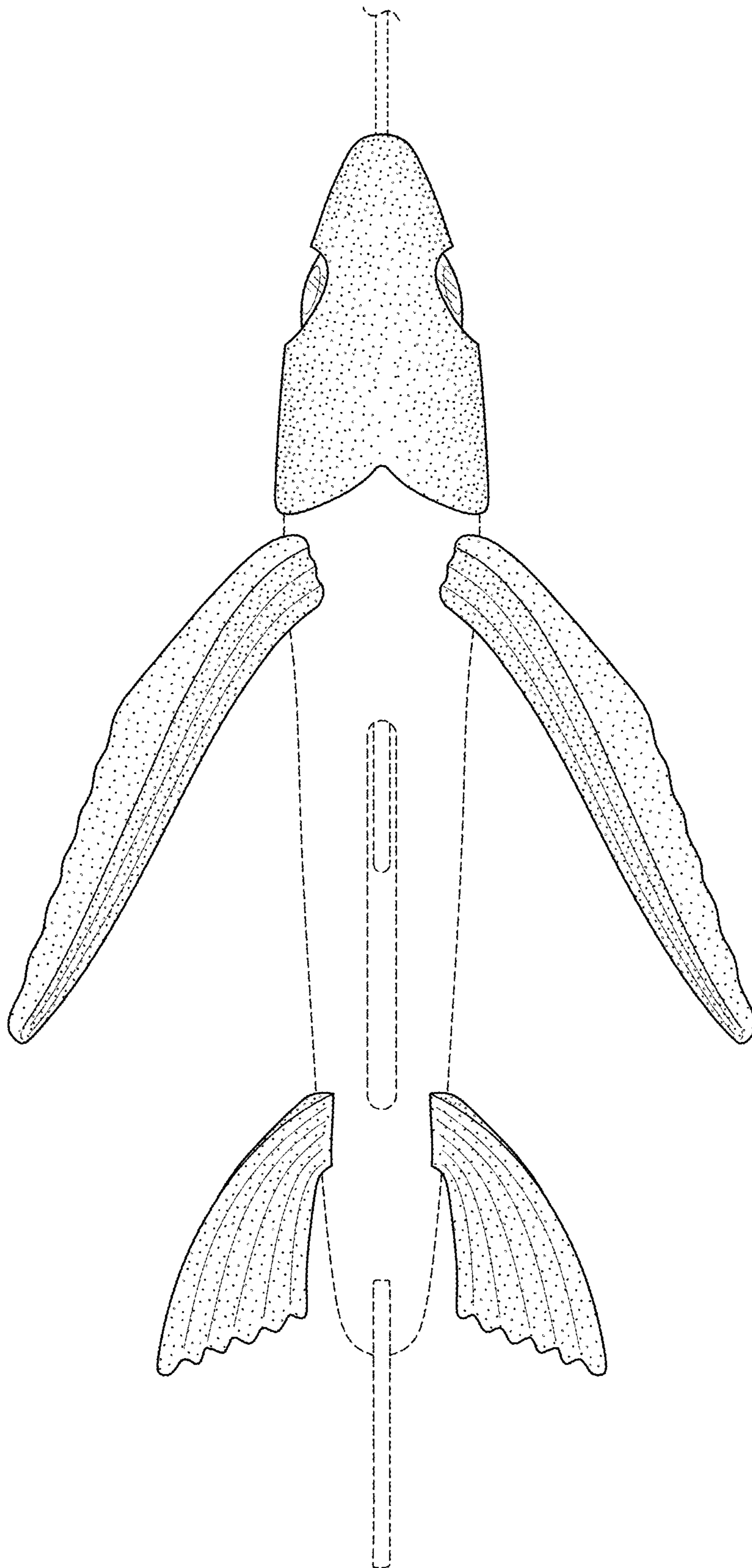

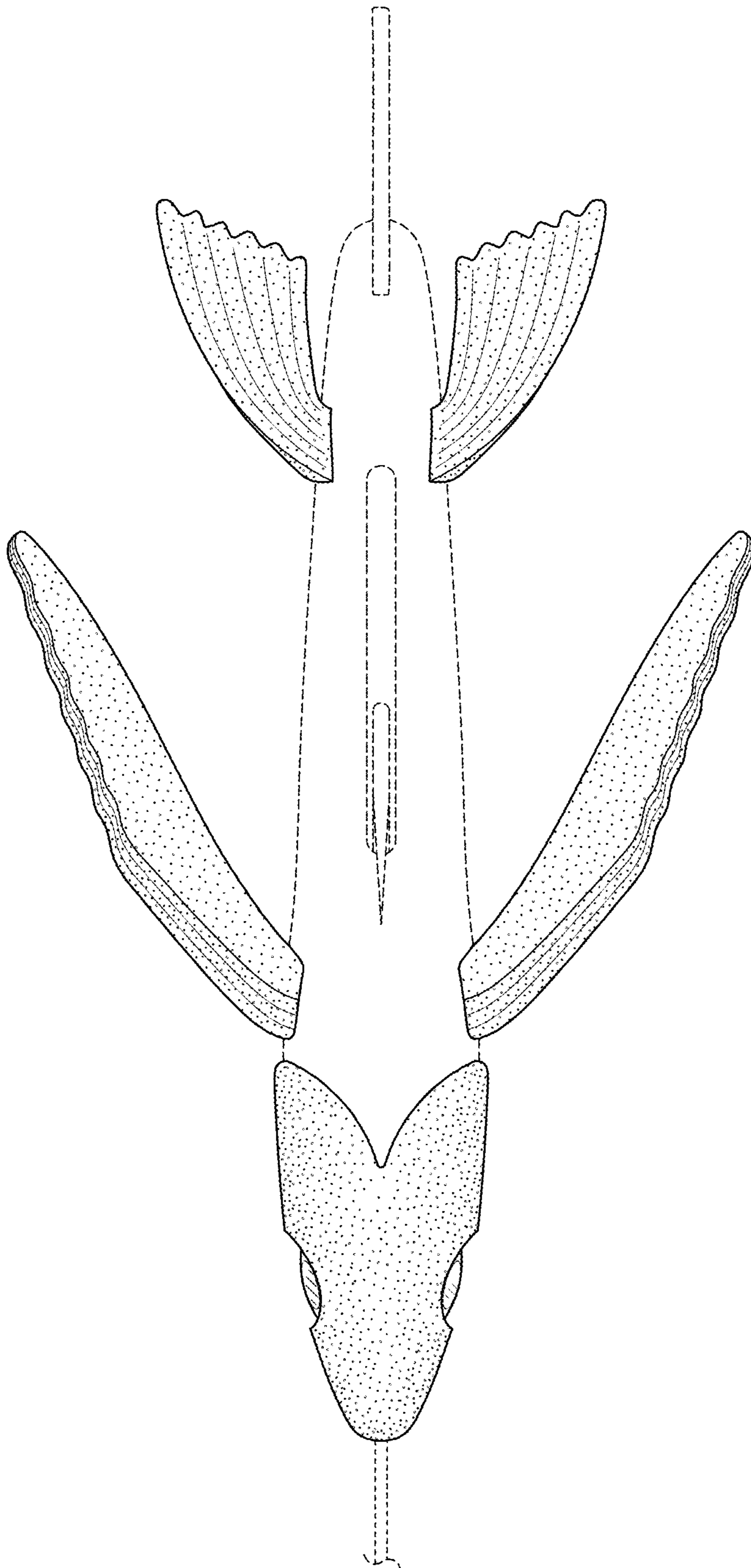

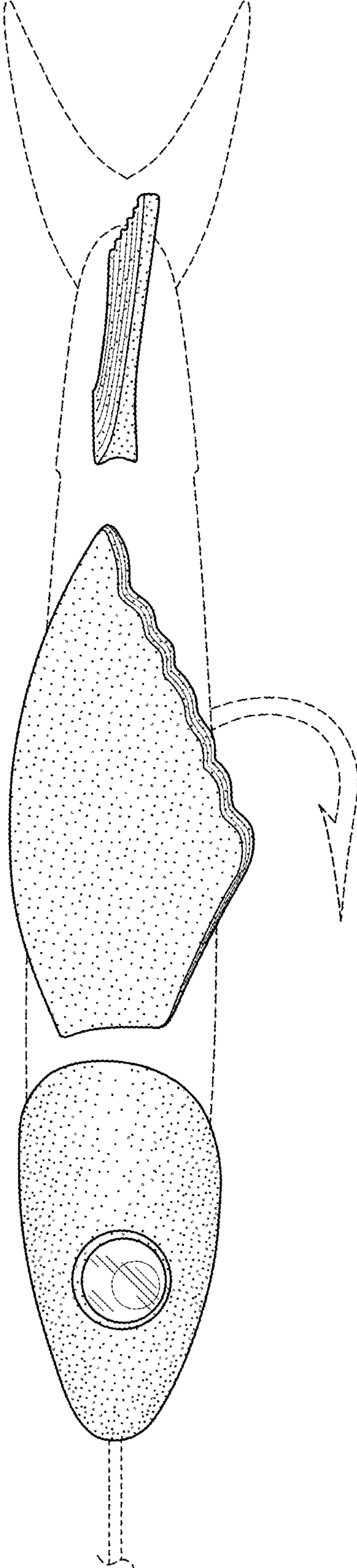

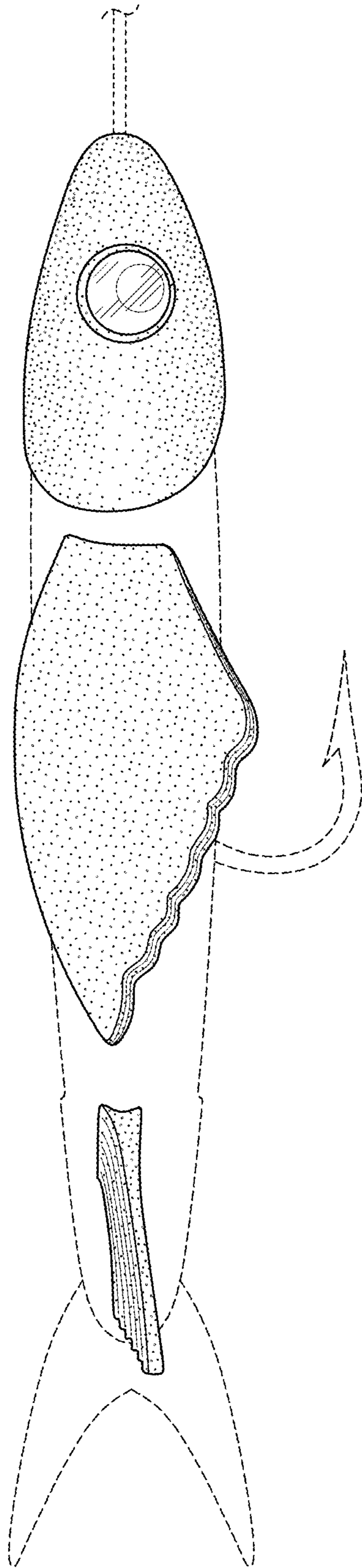

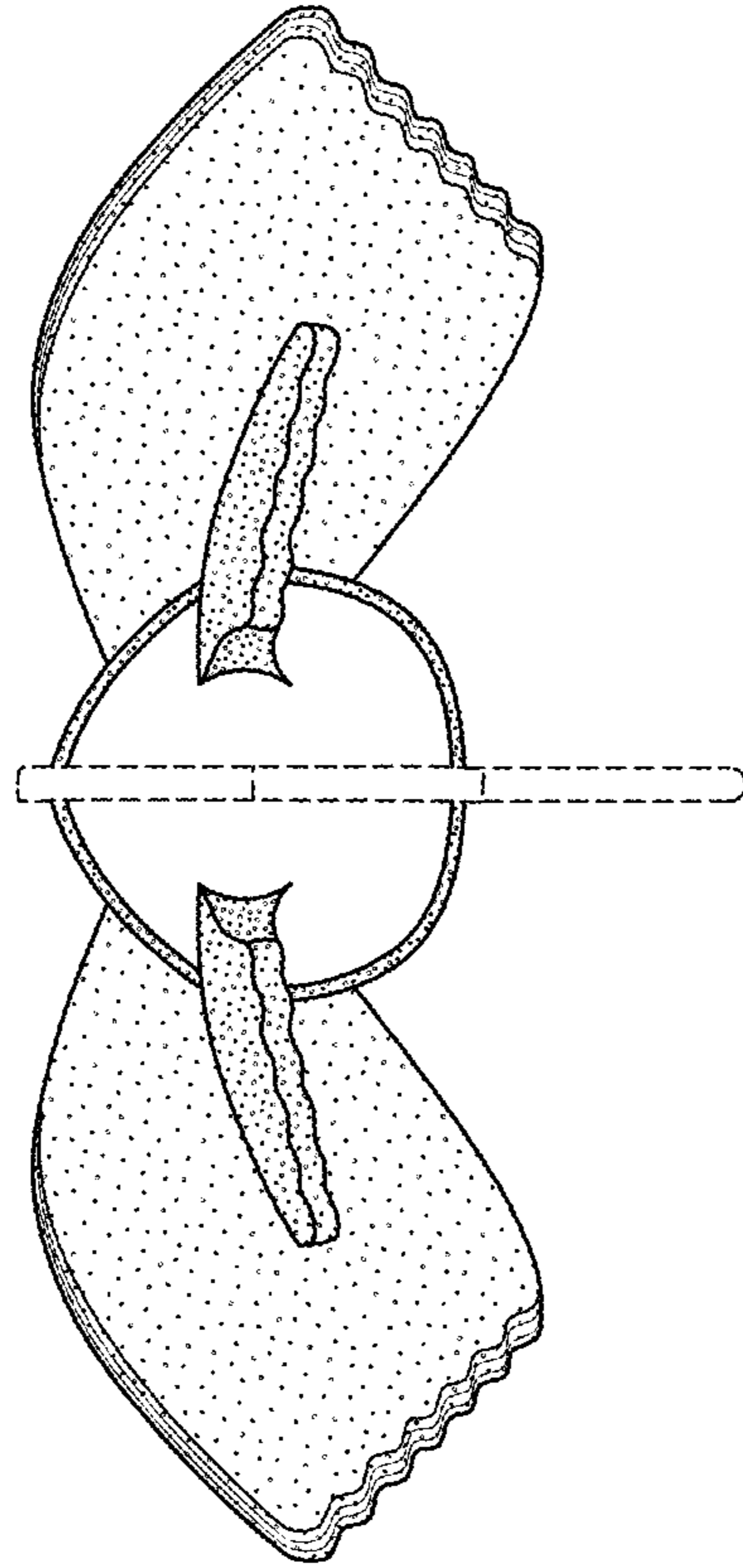

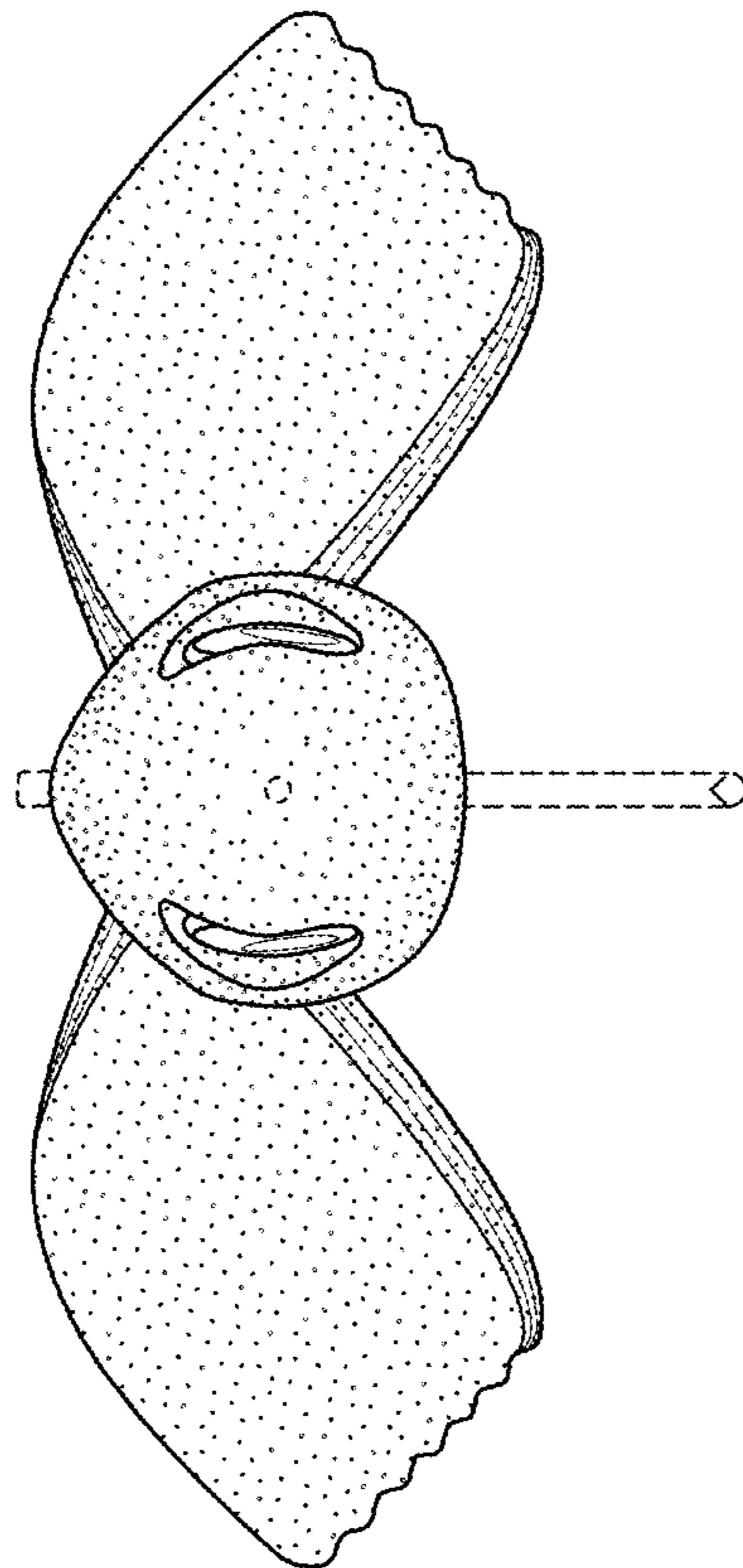

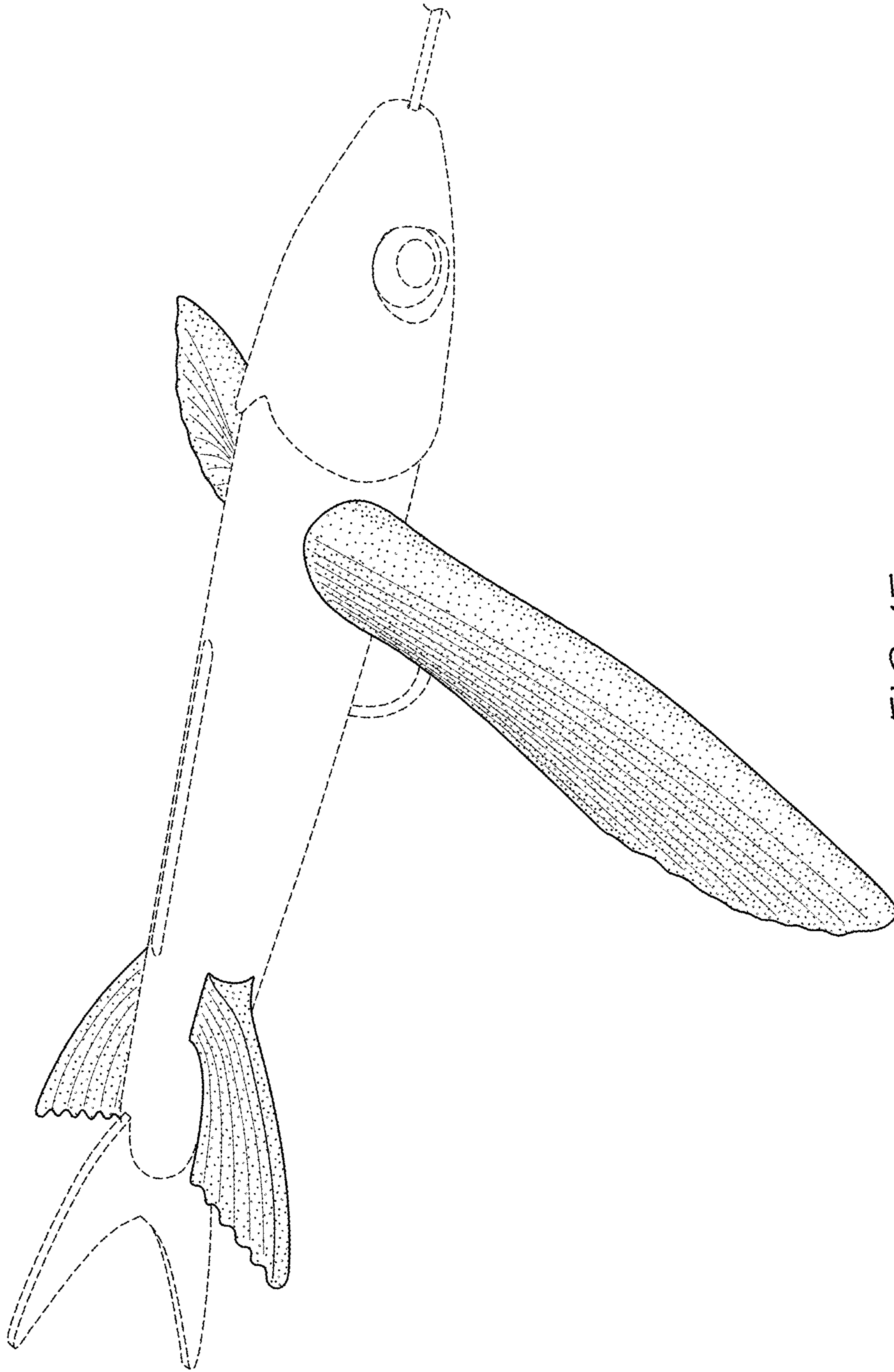

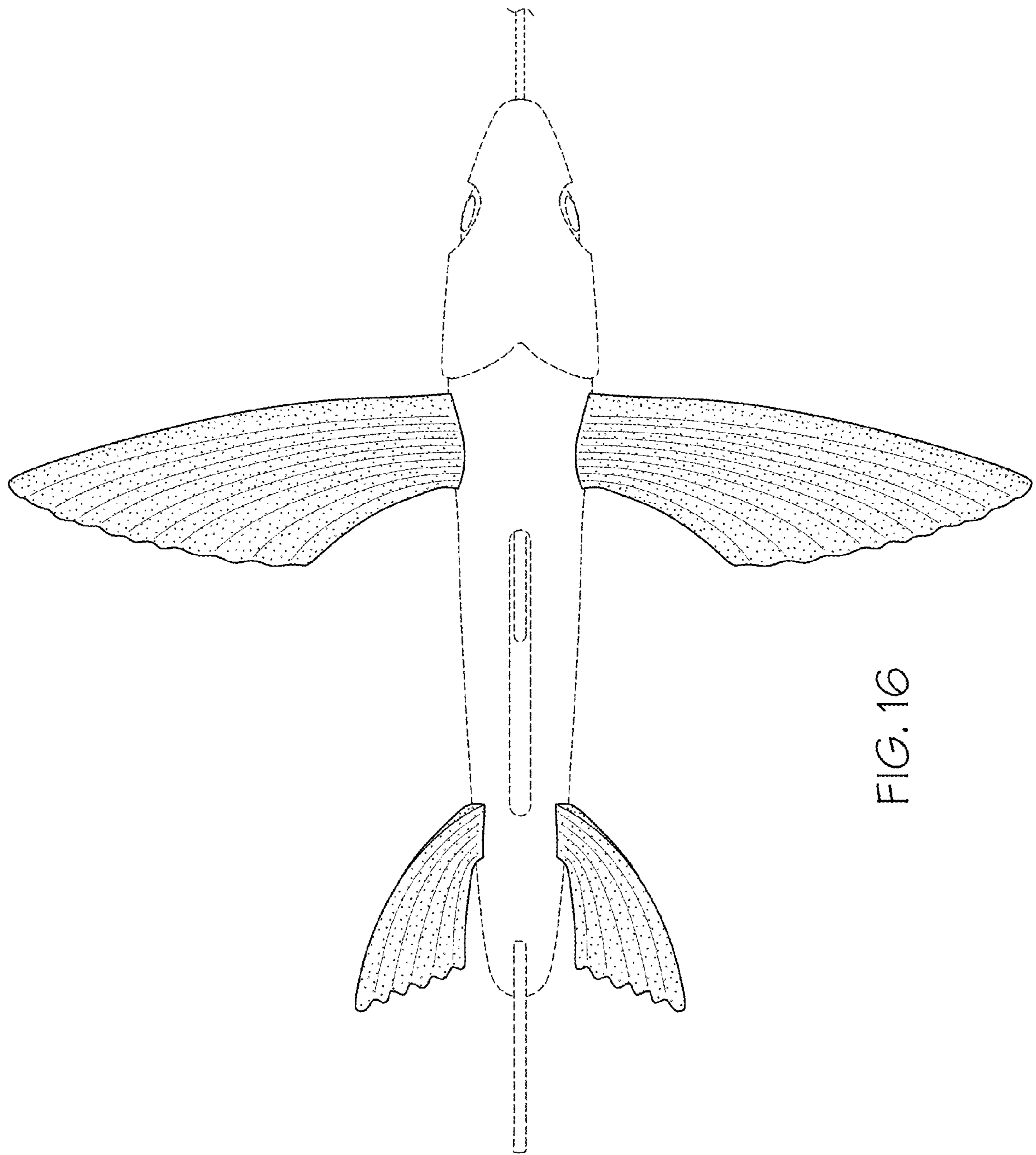

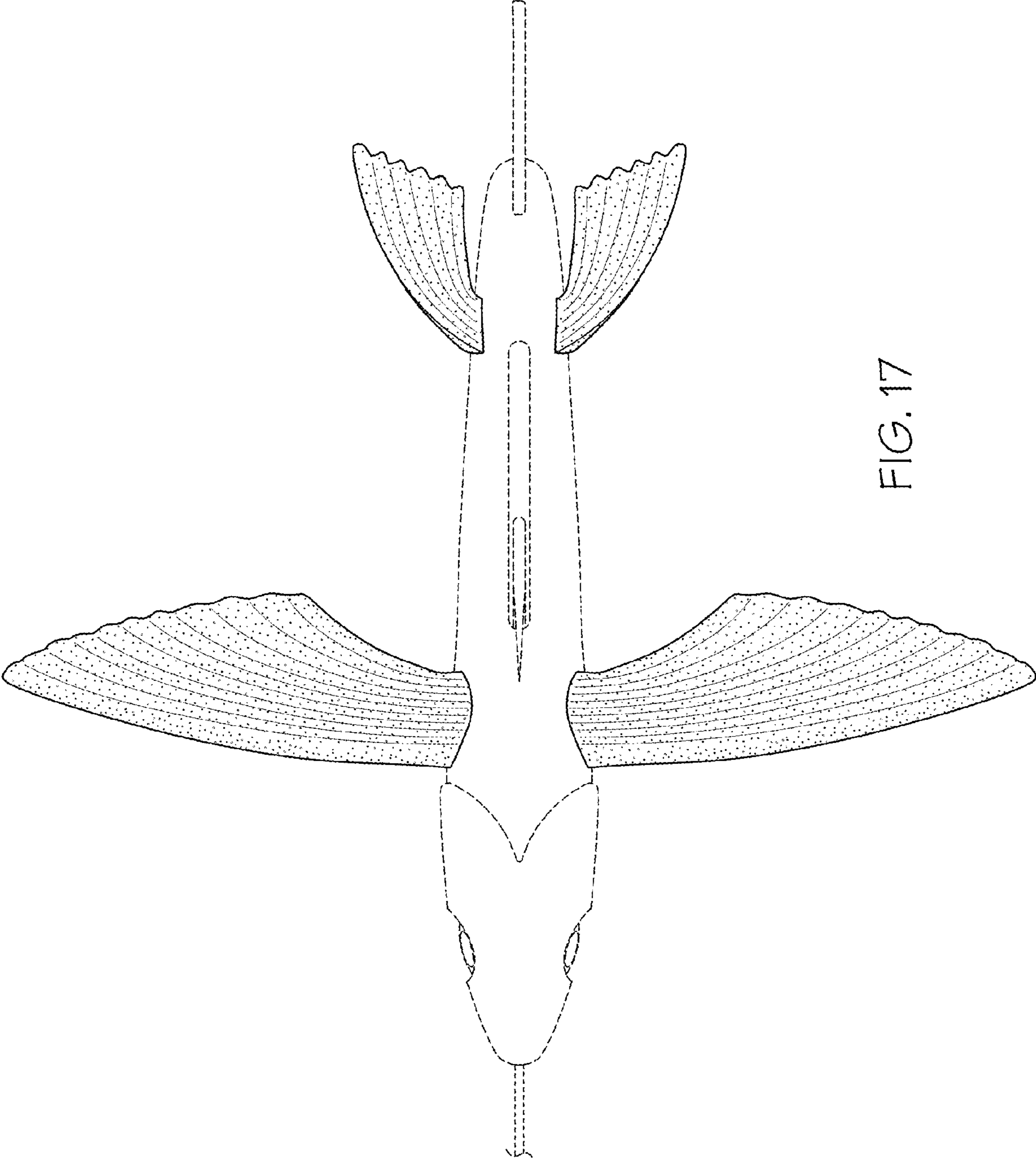

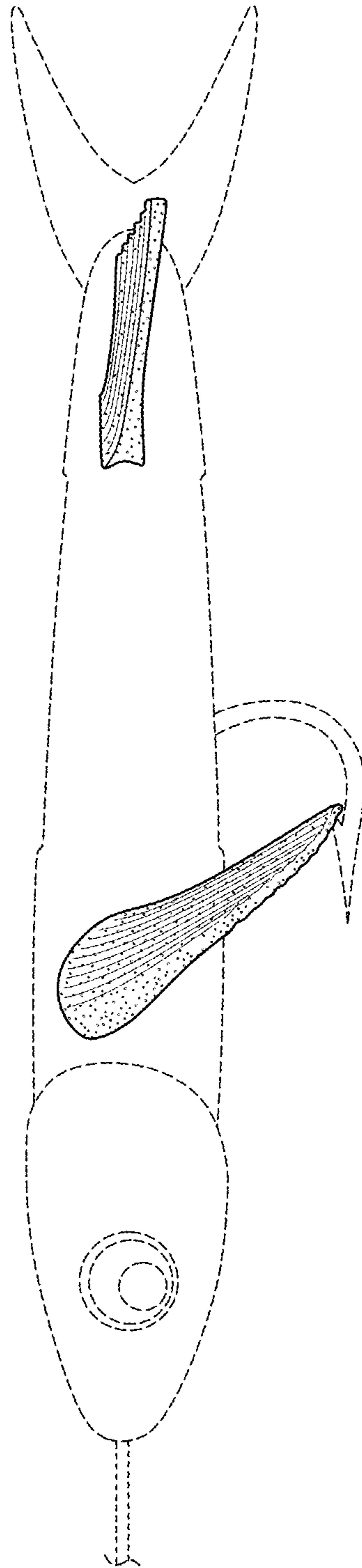

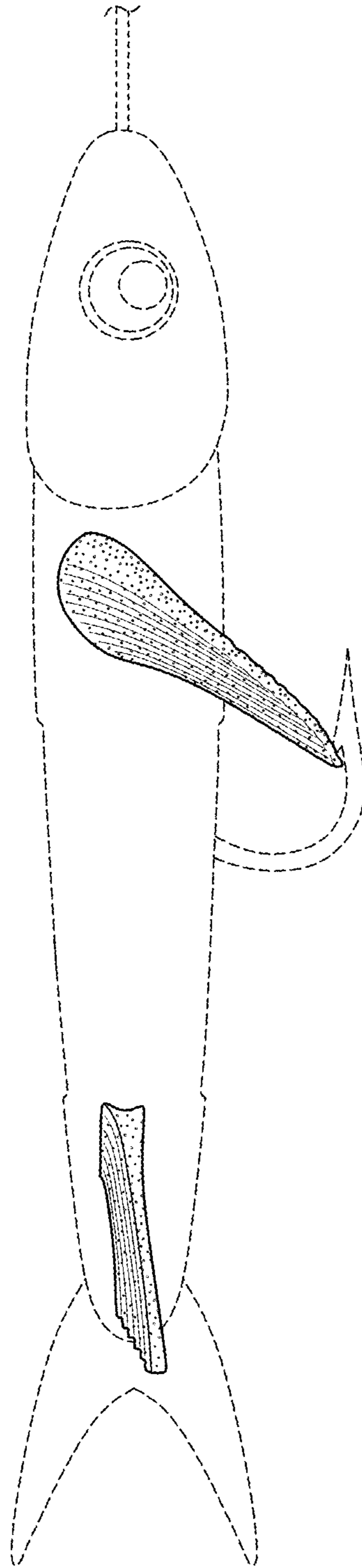

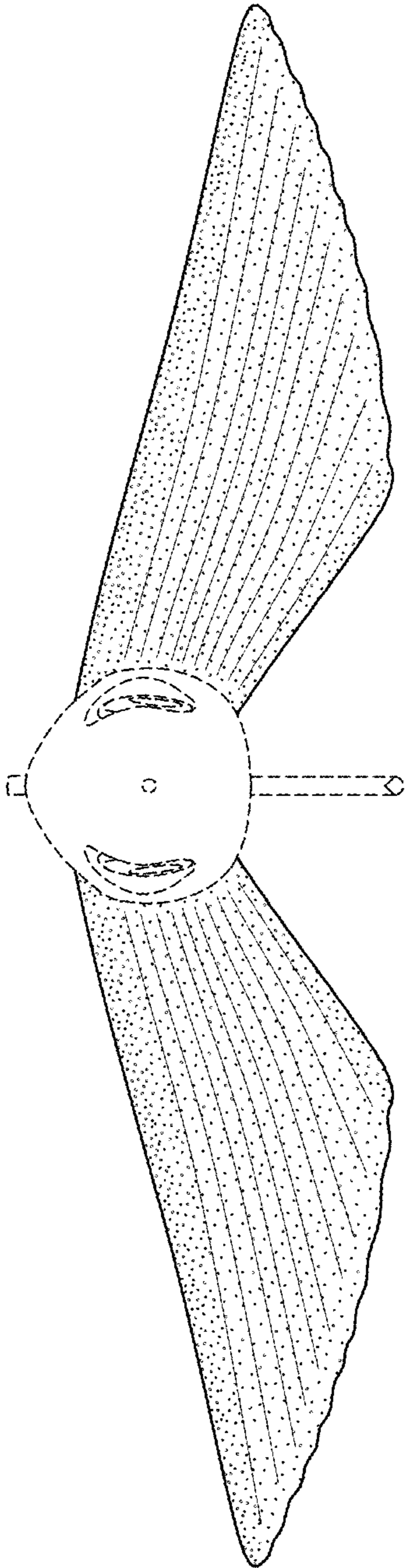

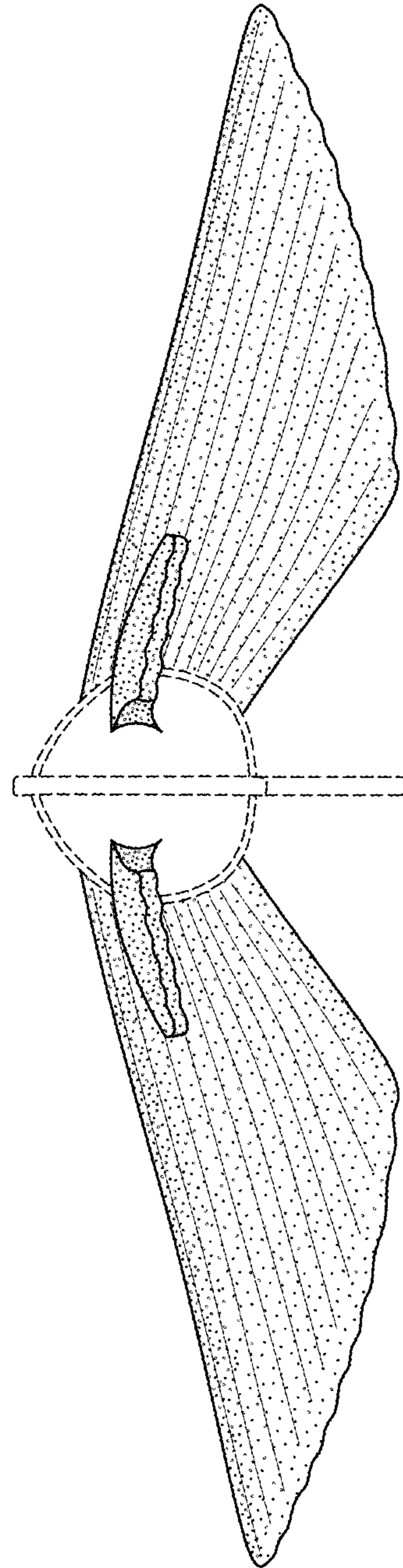

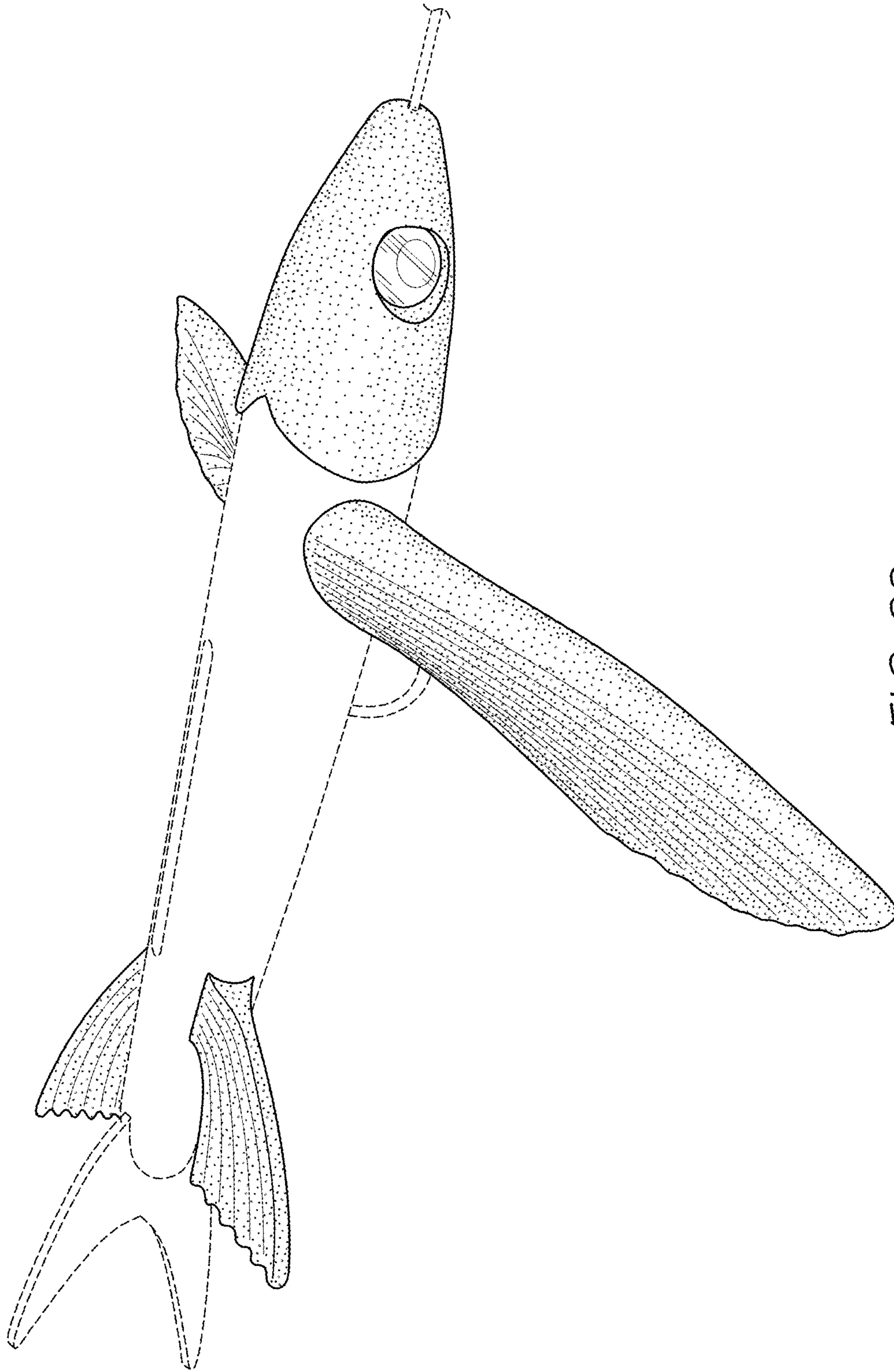

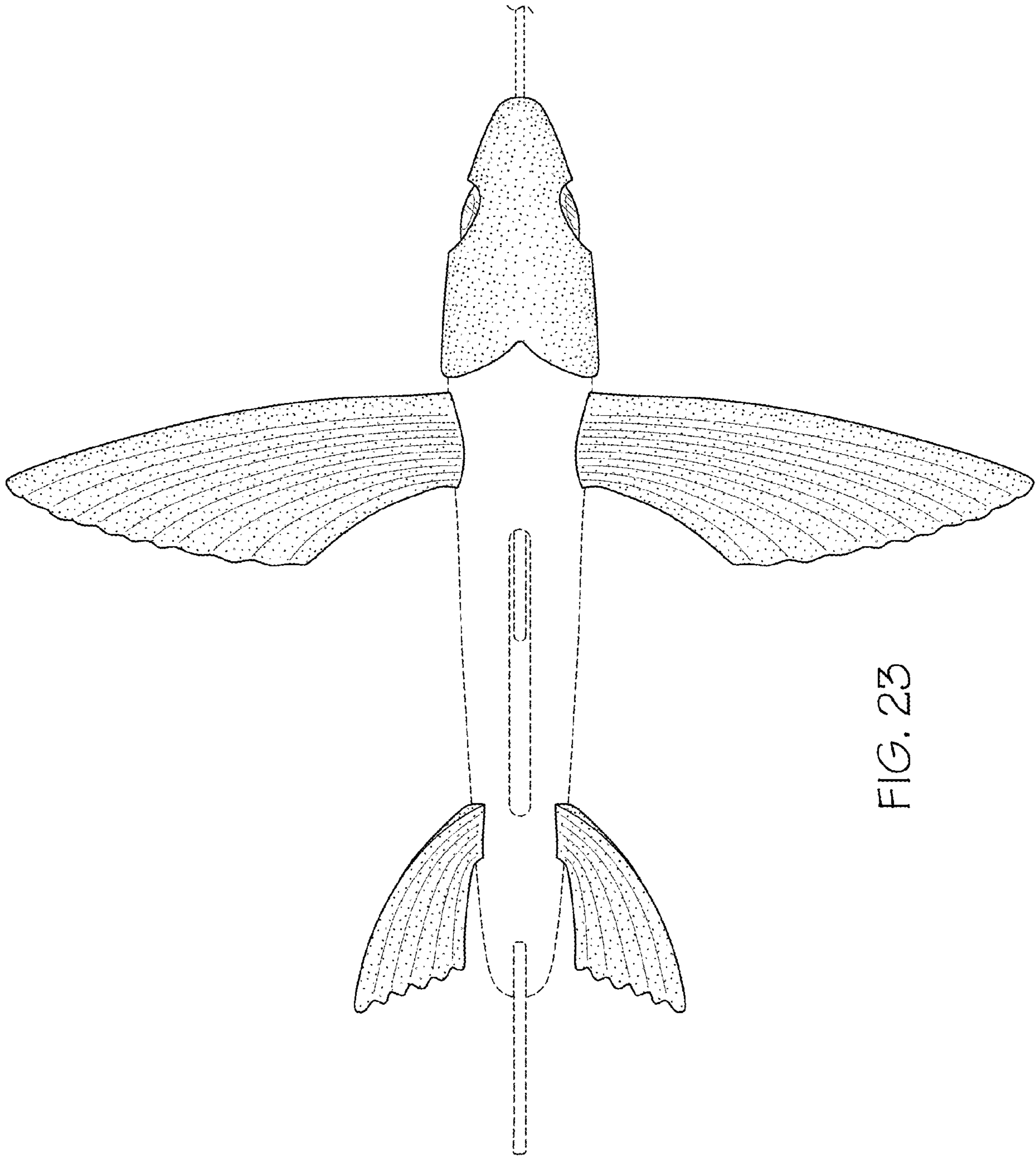

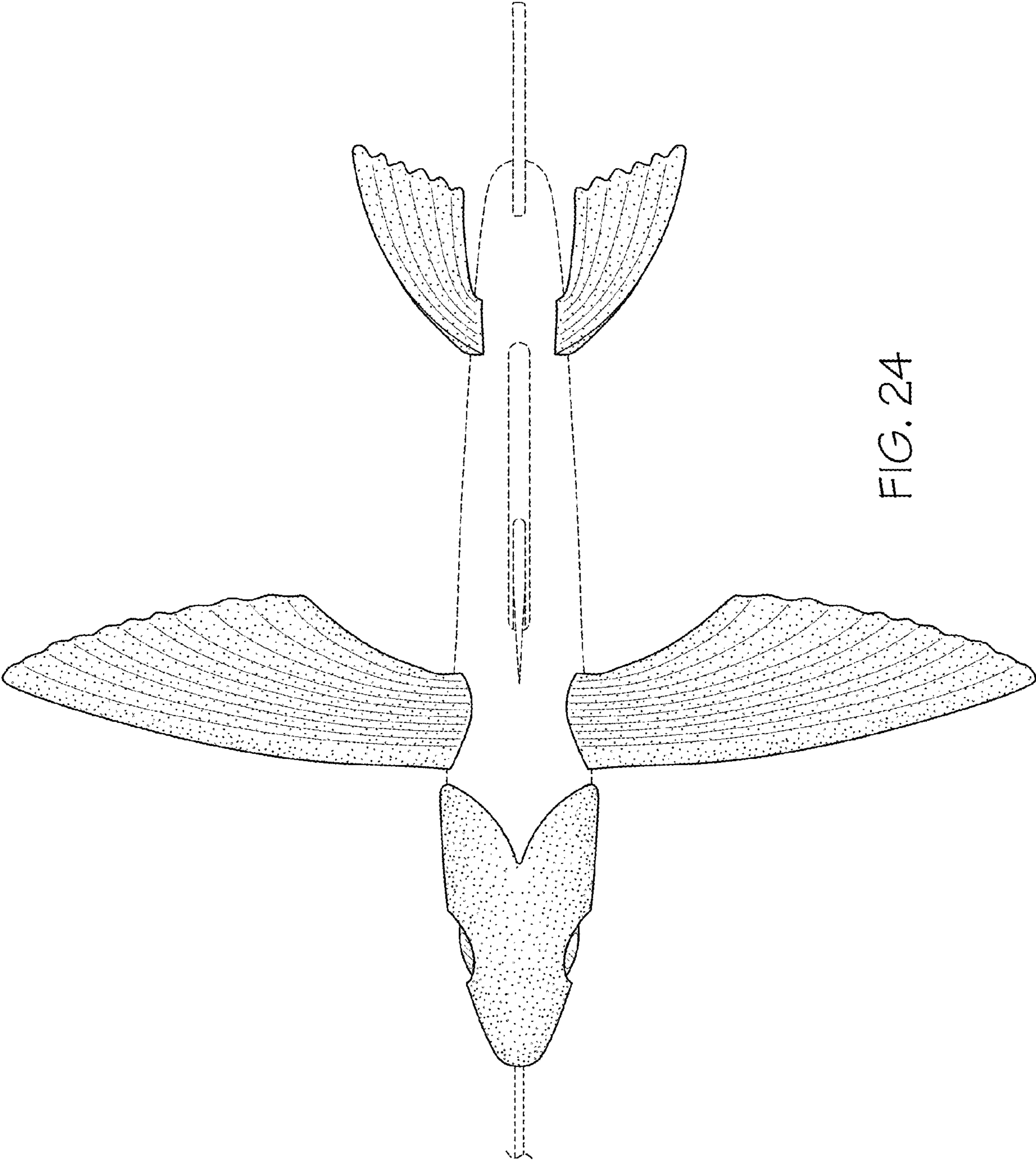

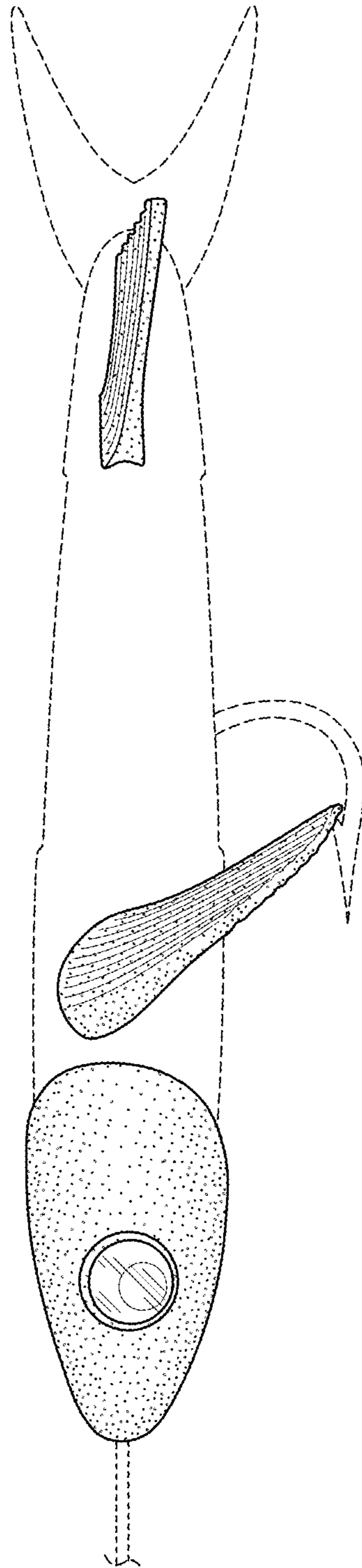

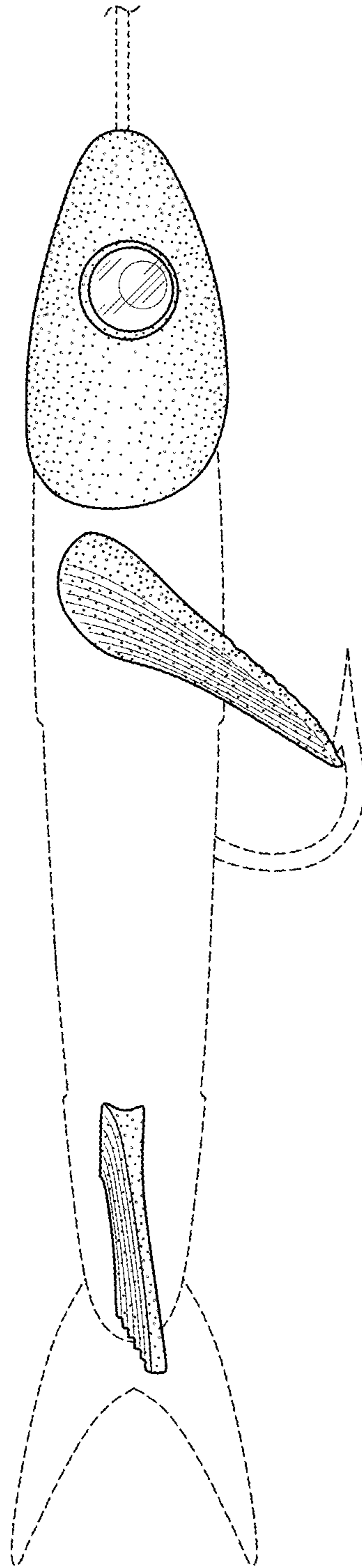

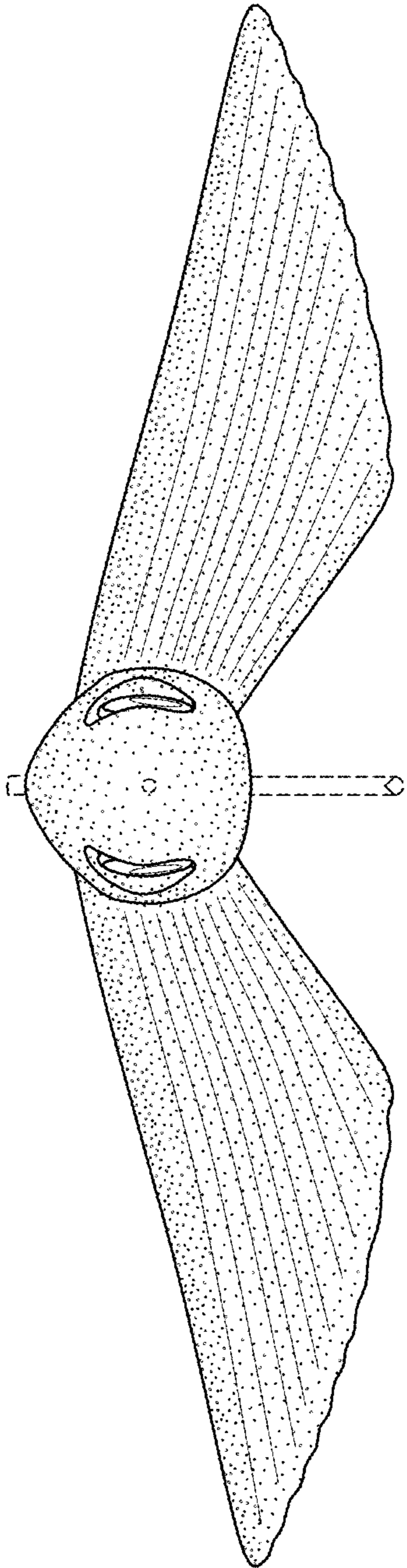

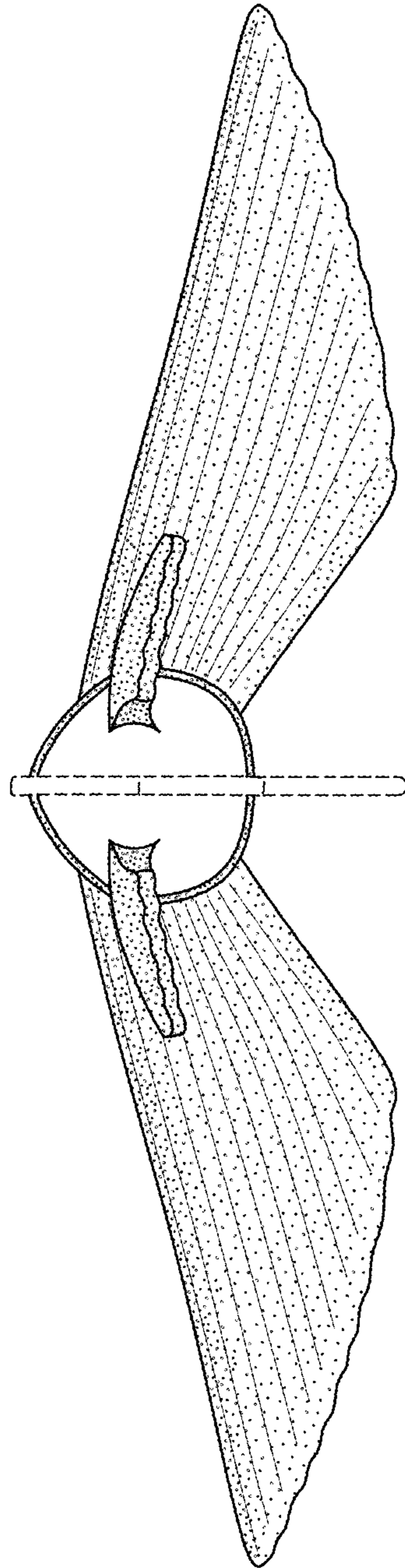
