DESCRIPTION

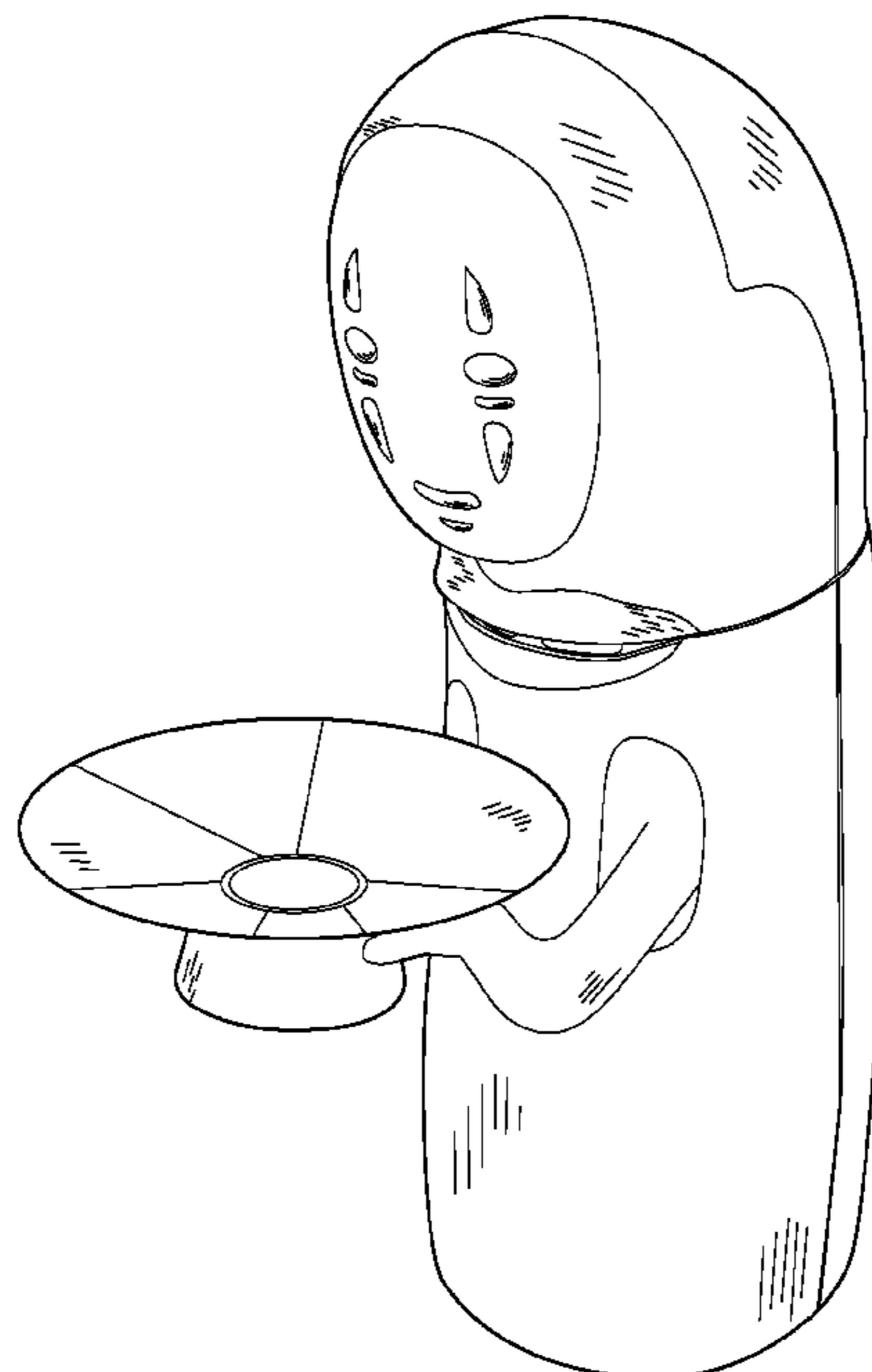
FIG. 1 is a Front elevational view of a money box showing my new design;

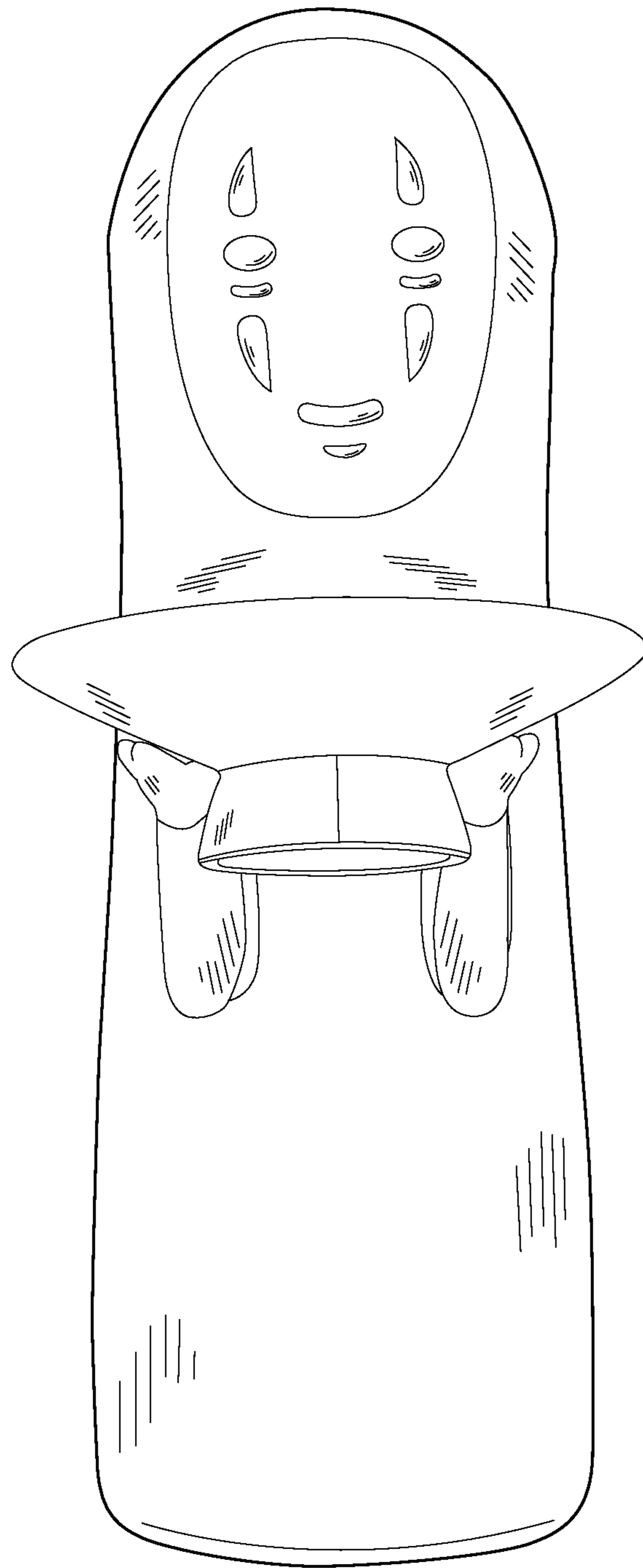

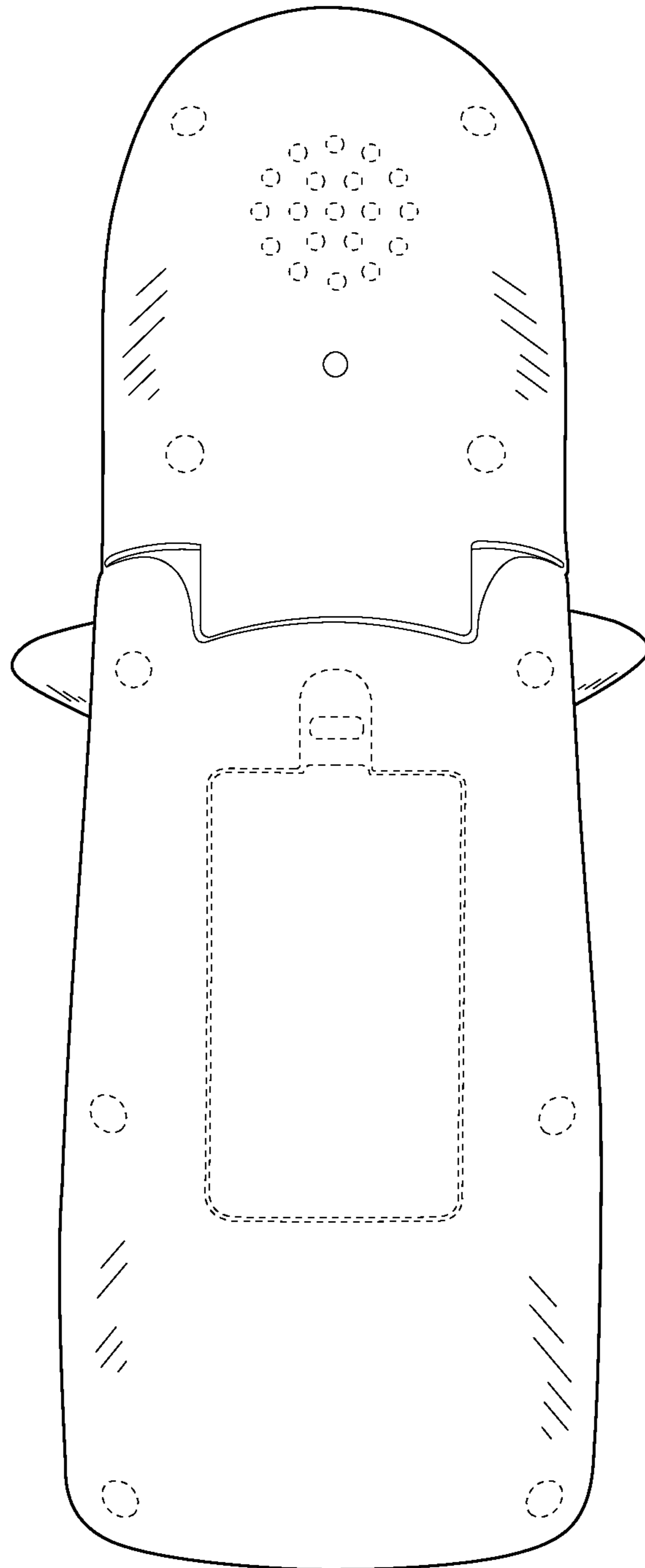

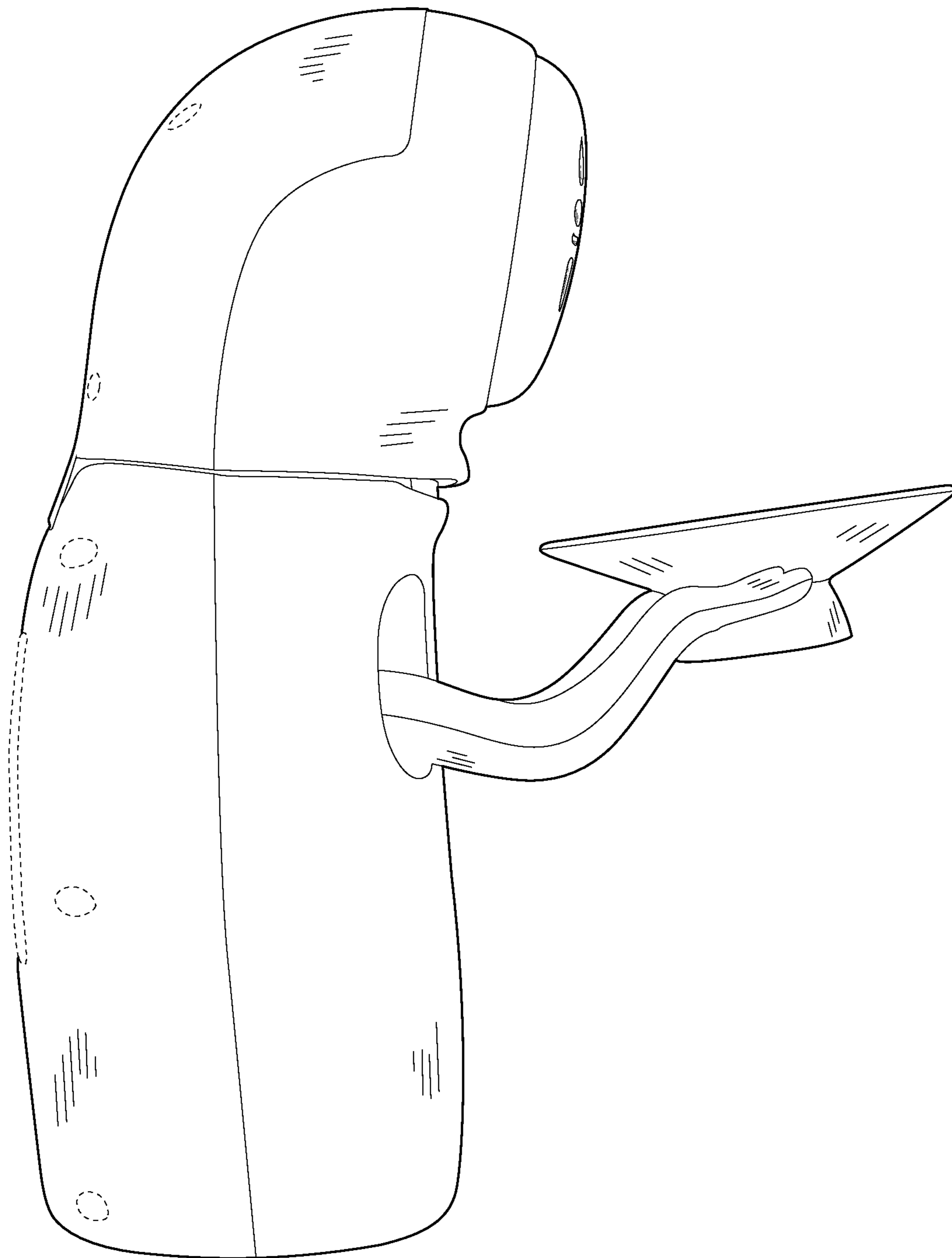

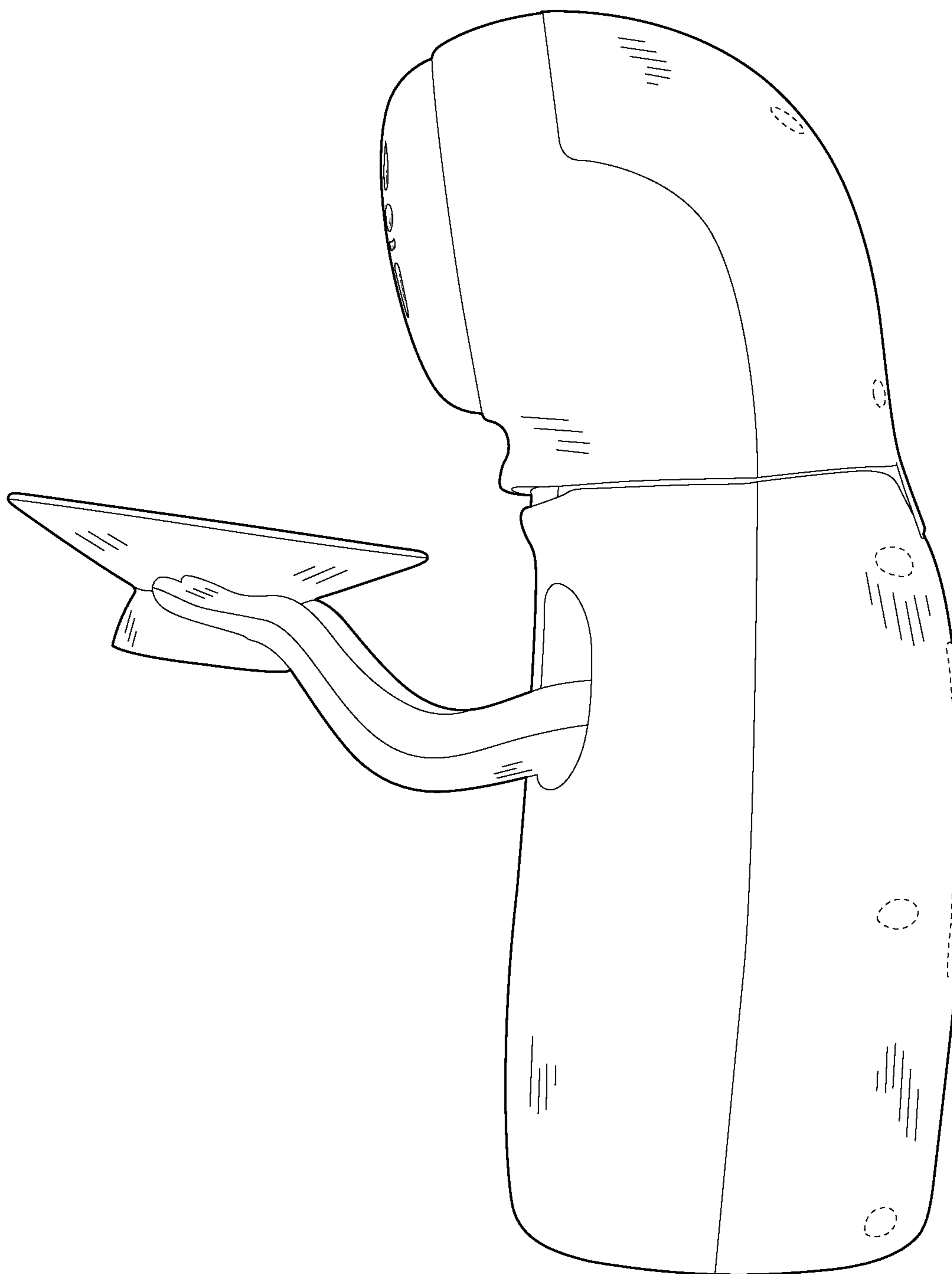

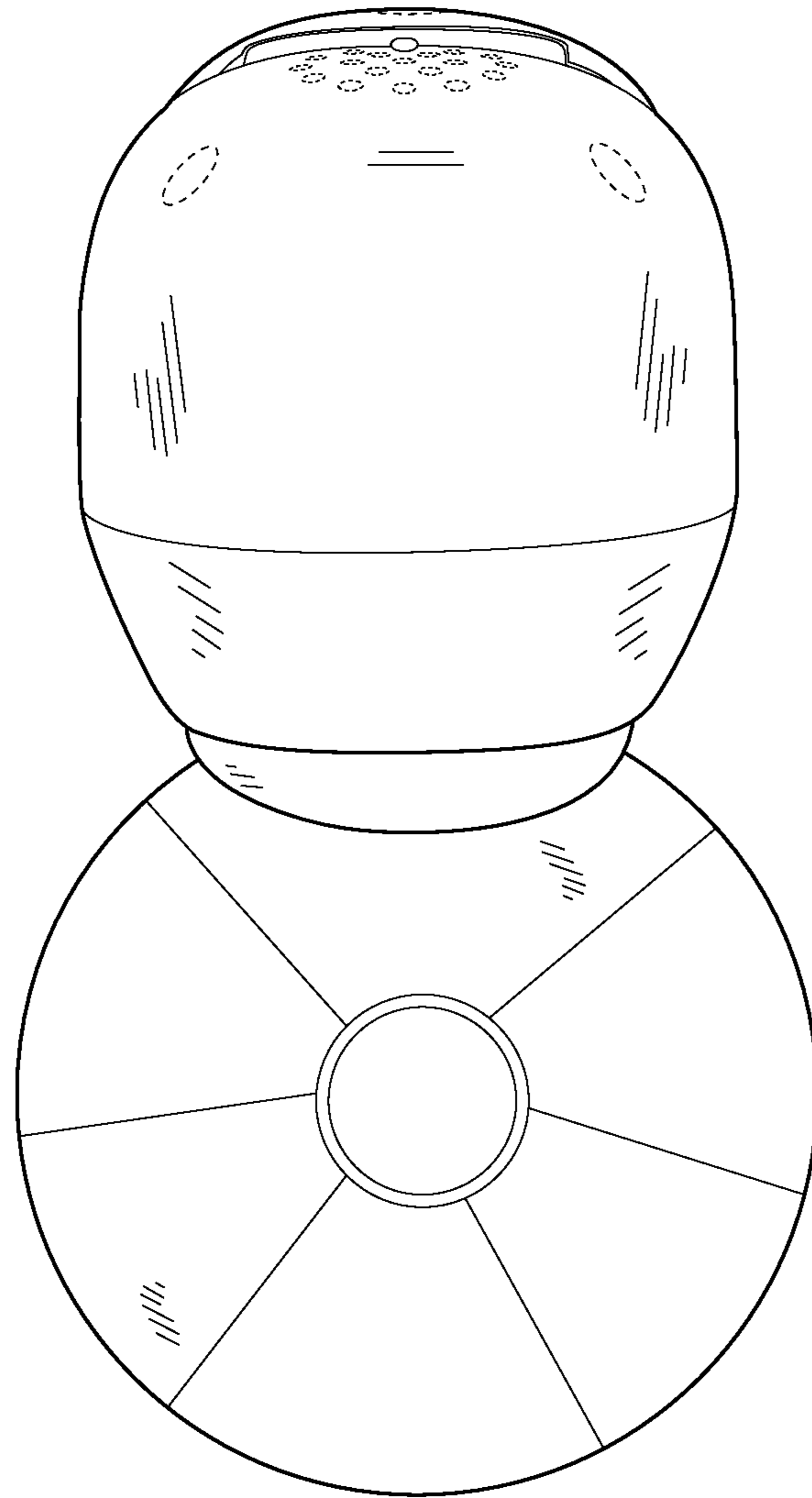

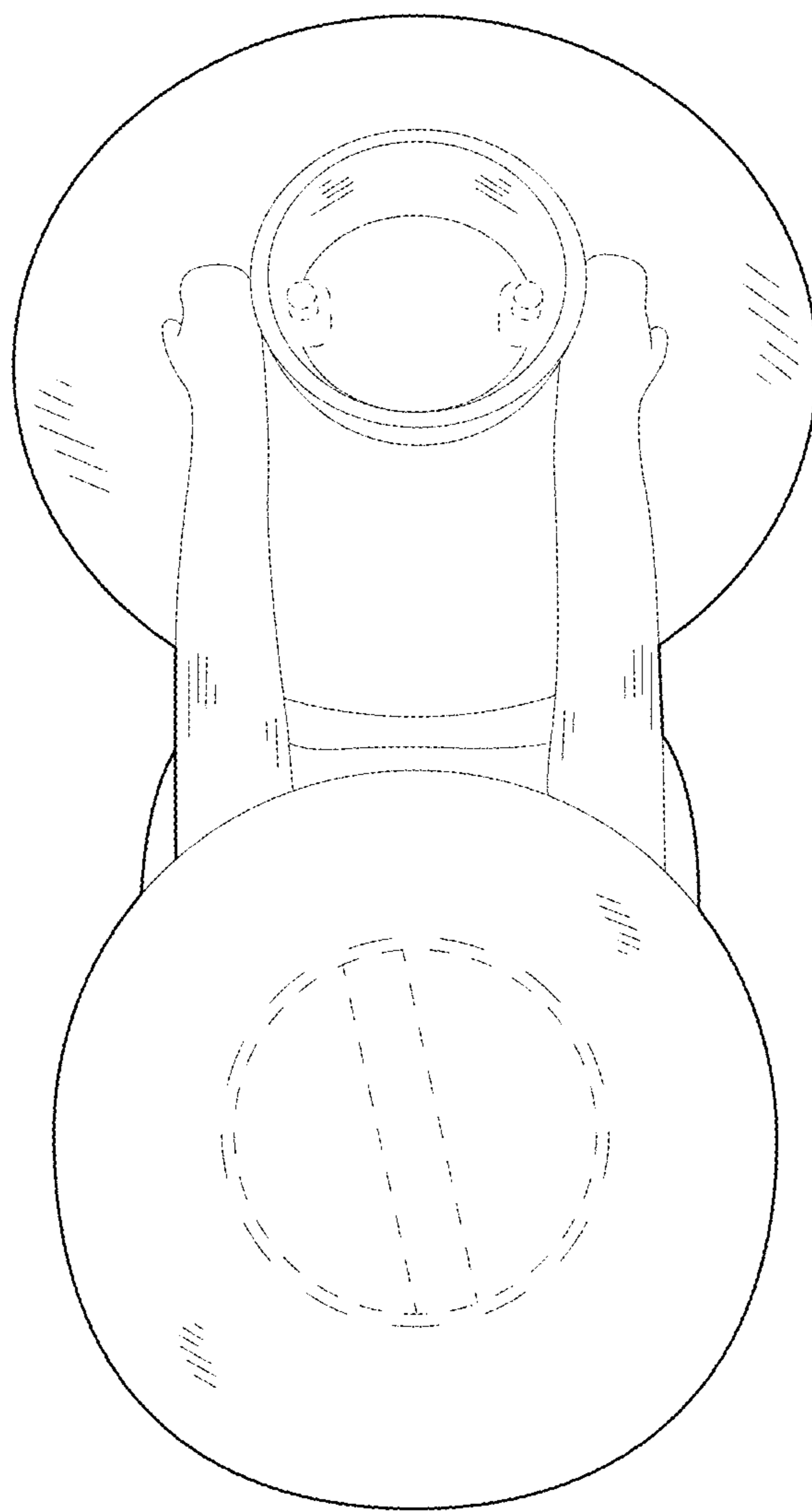

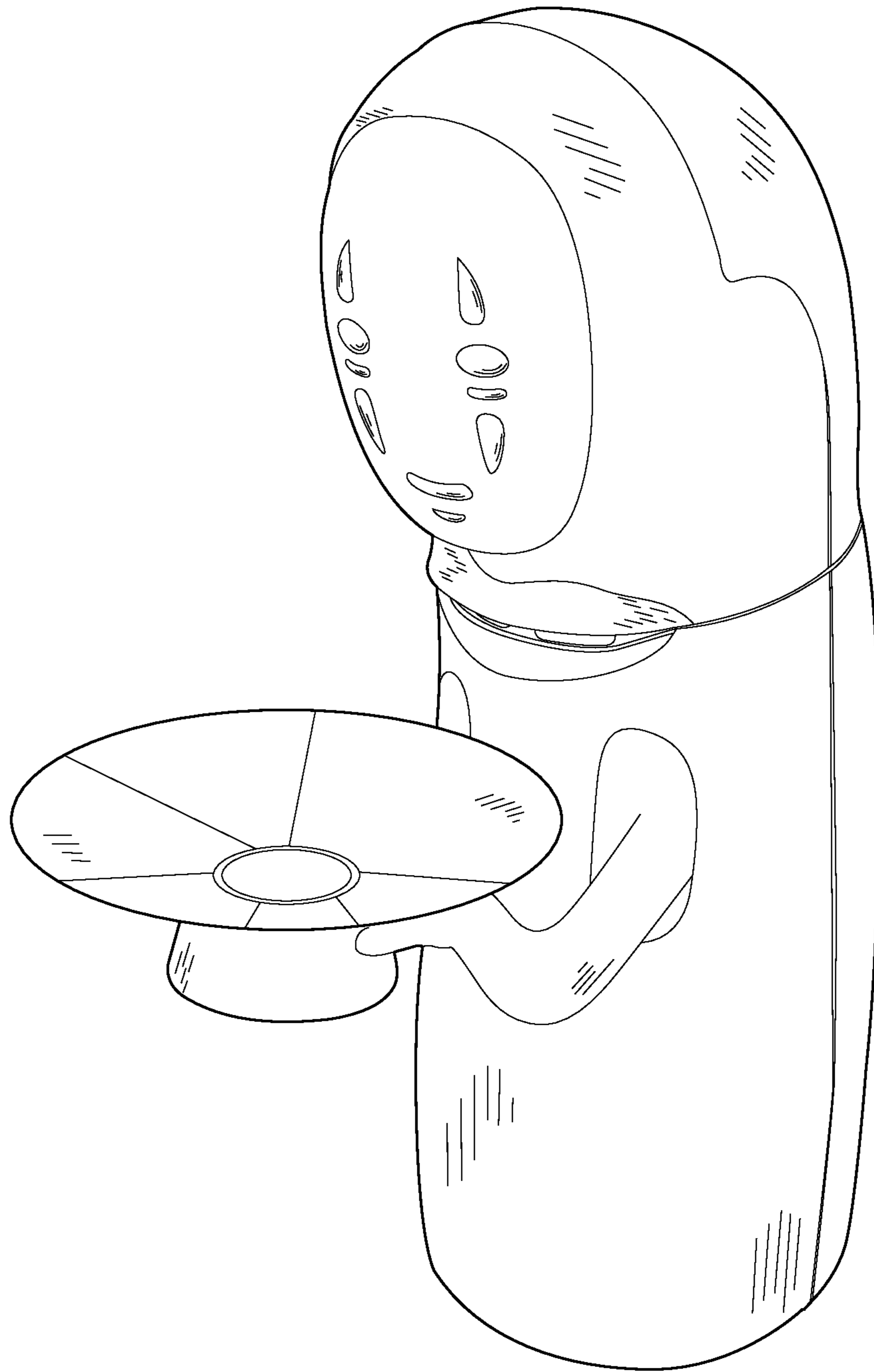
