(57) **CLAIM**

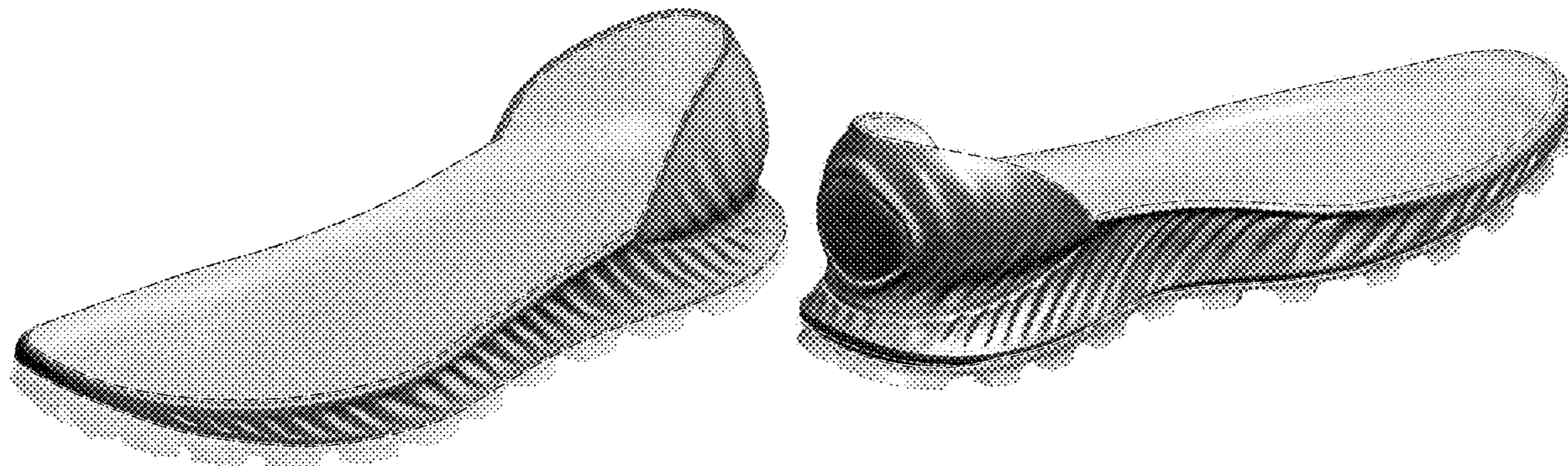
The ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a top front, right perspective view of a sole for footwear showing my new design;
FIG. 2 is a top rear, left perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof, shown in a lighter contrast indicating that the bottom in its entirety forms no part of the claimed design.

The broken lines of uneven length illustrate the boundary of the claimed design and form no part thereof. The portions of FIGS. 1 through 7, and FIG. 8 in its entirety, shown in lighter contrast form no part of the claimed design.

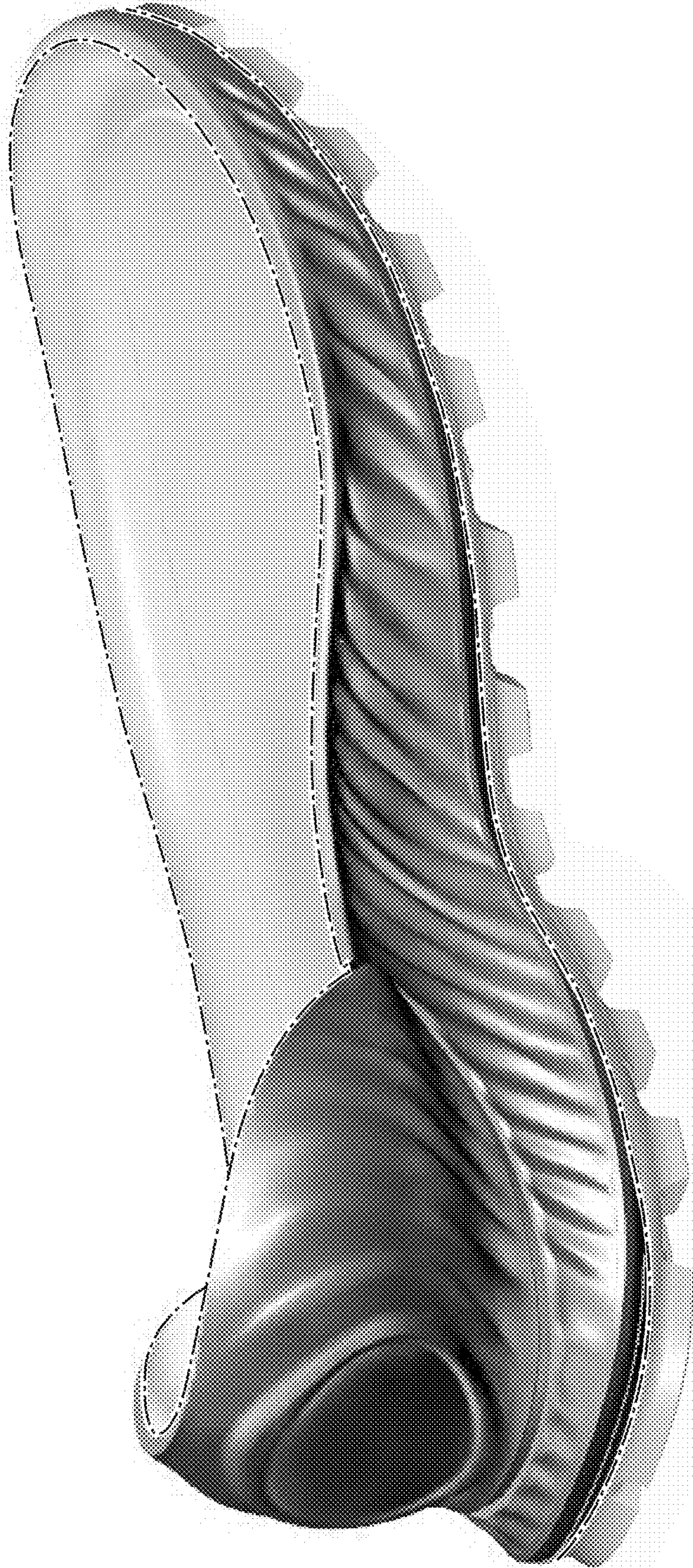

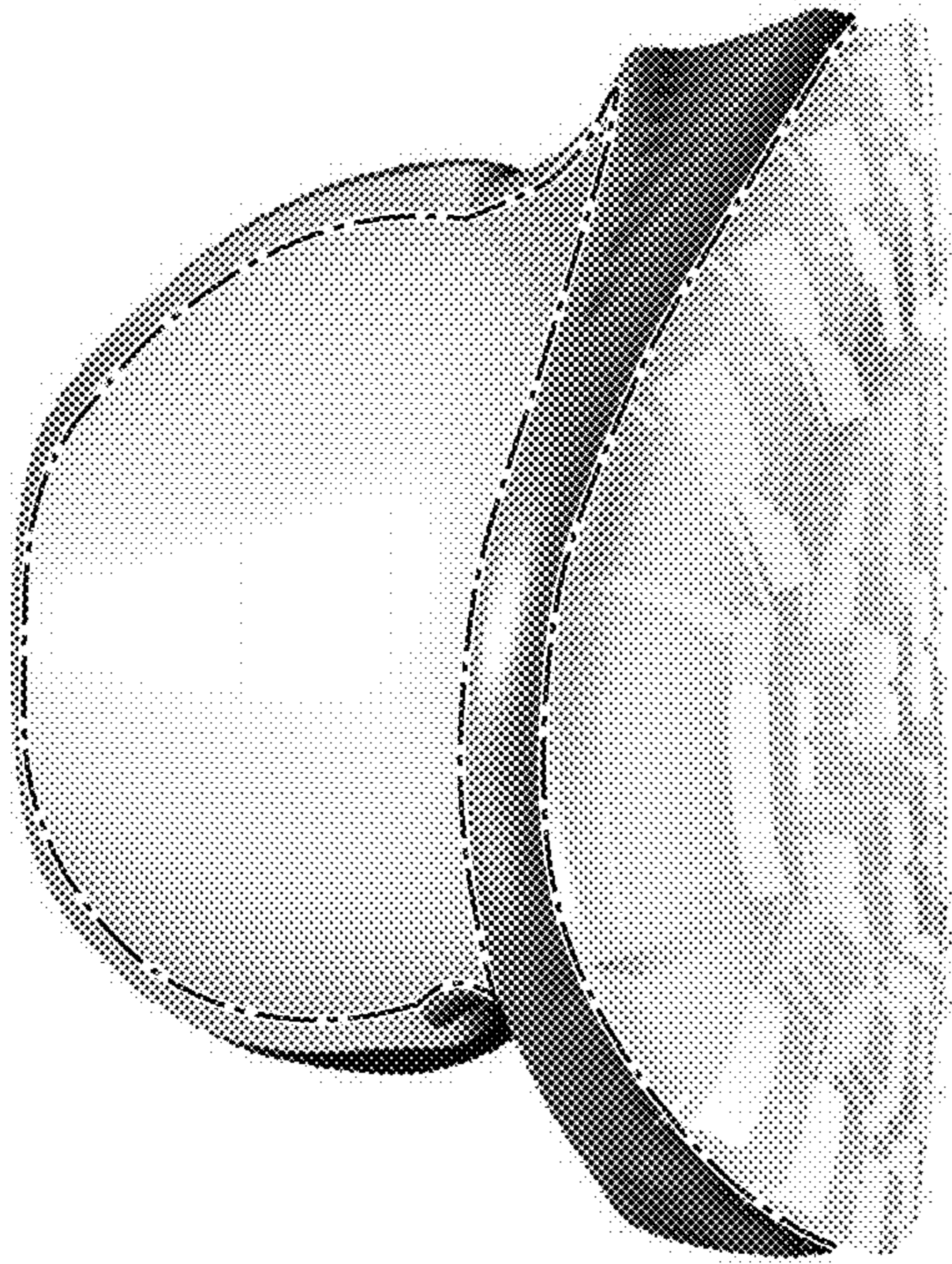

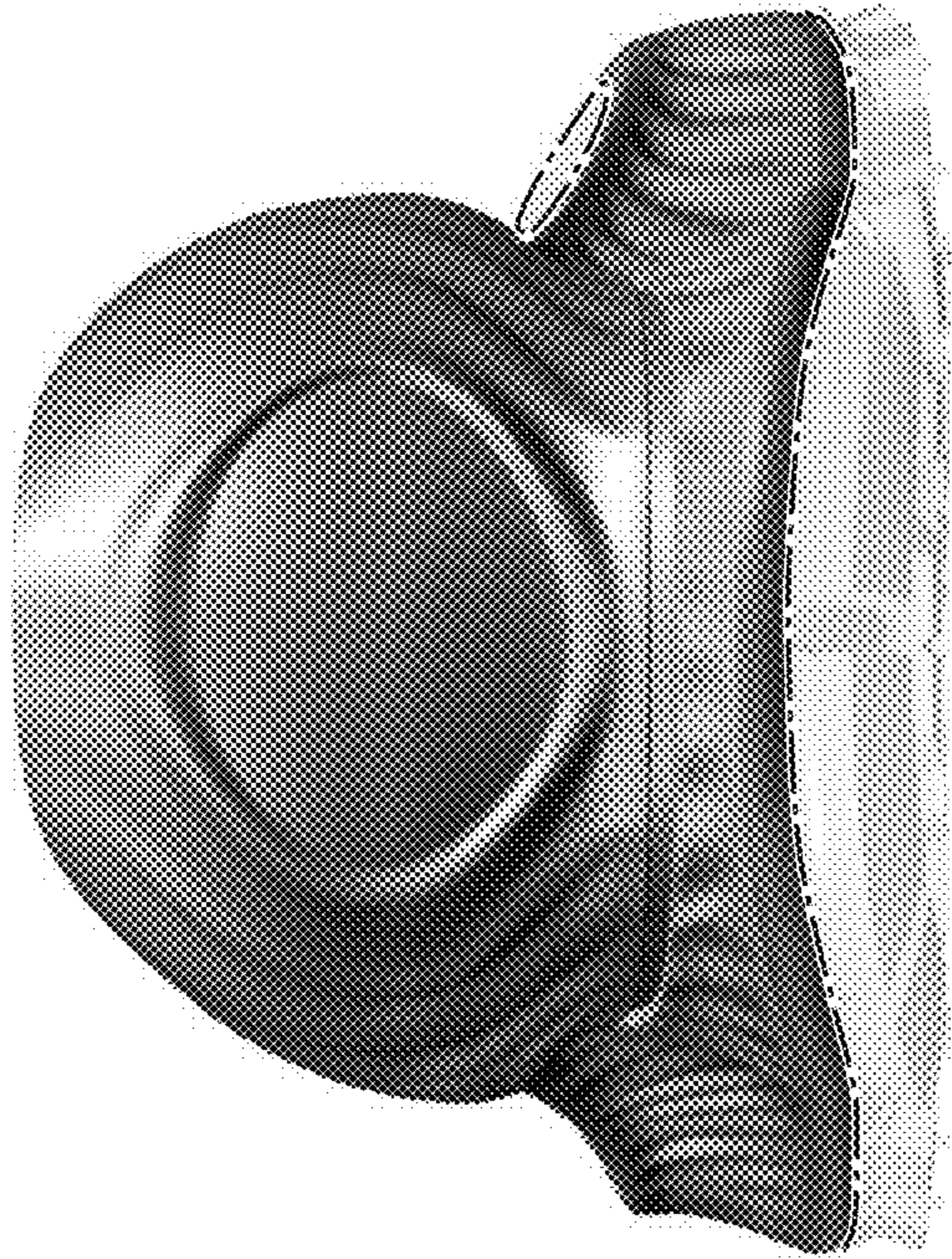

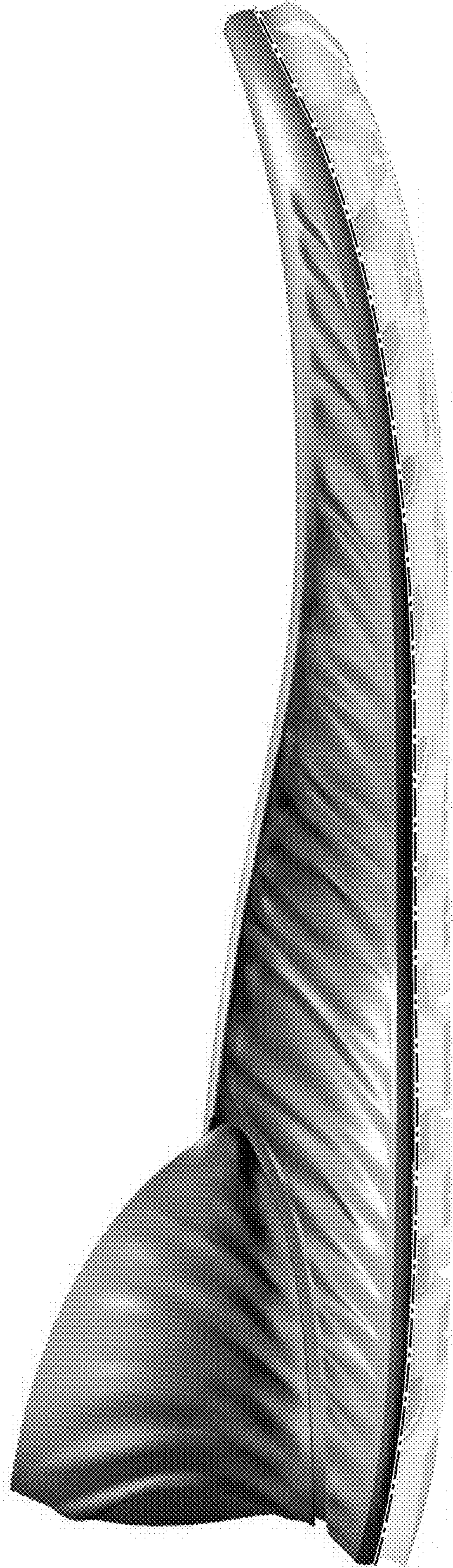

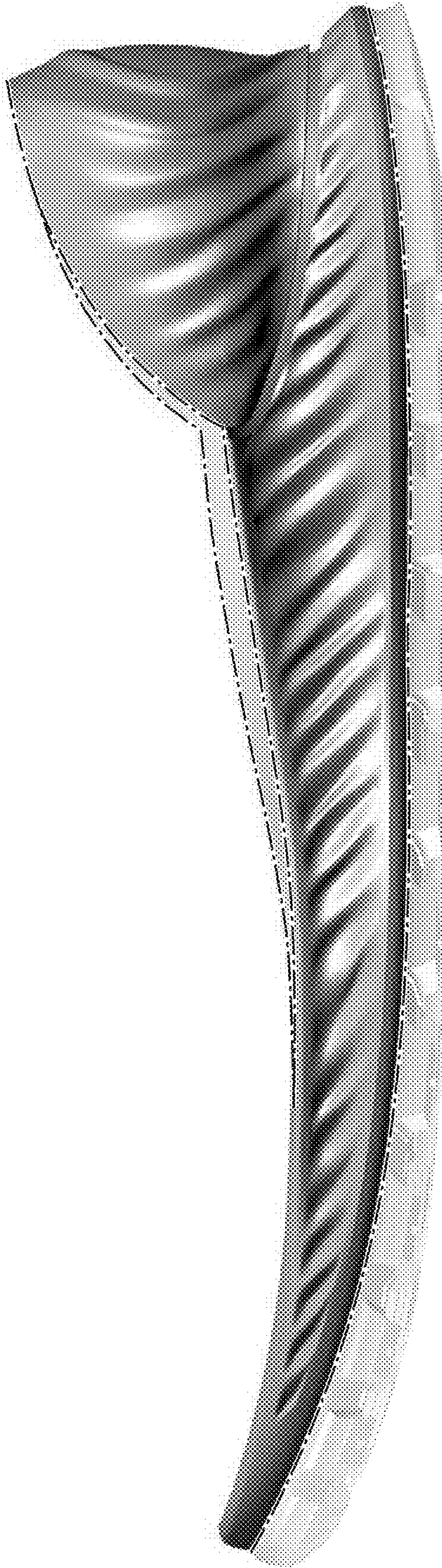

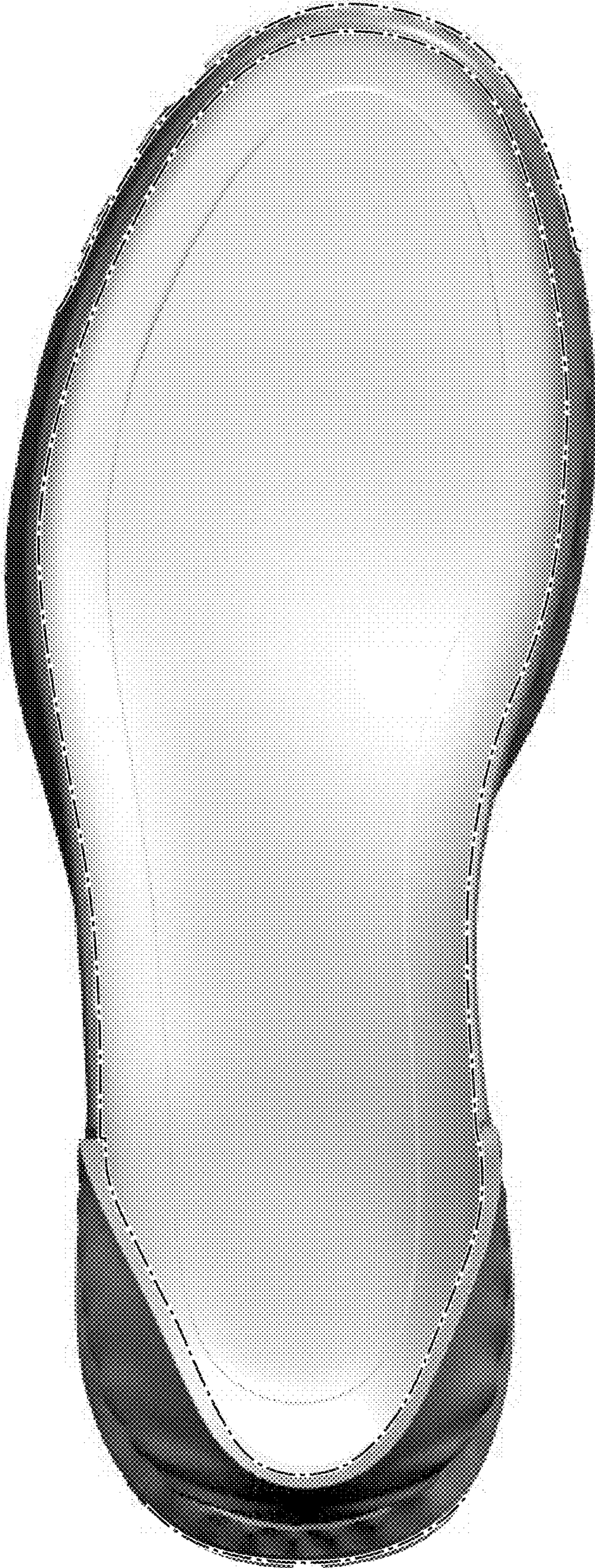
