(57) **CLAIM**

I claim the ornamental design for a fabric material having a pattern resembling mesh, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a fabric material having a pattern resembling mesh;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

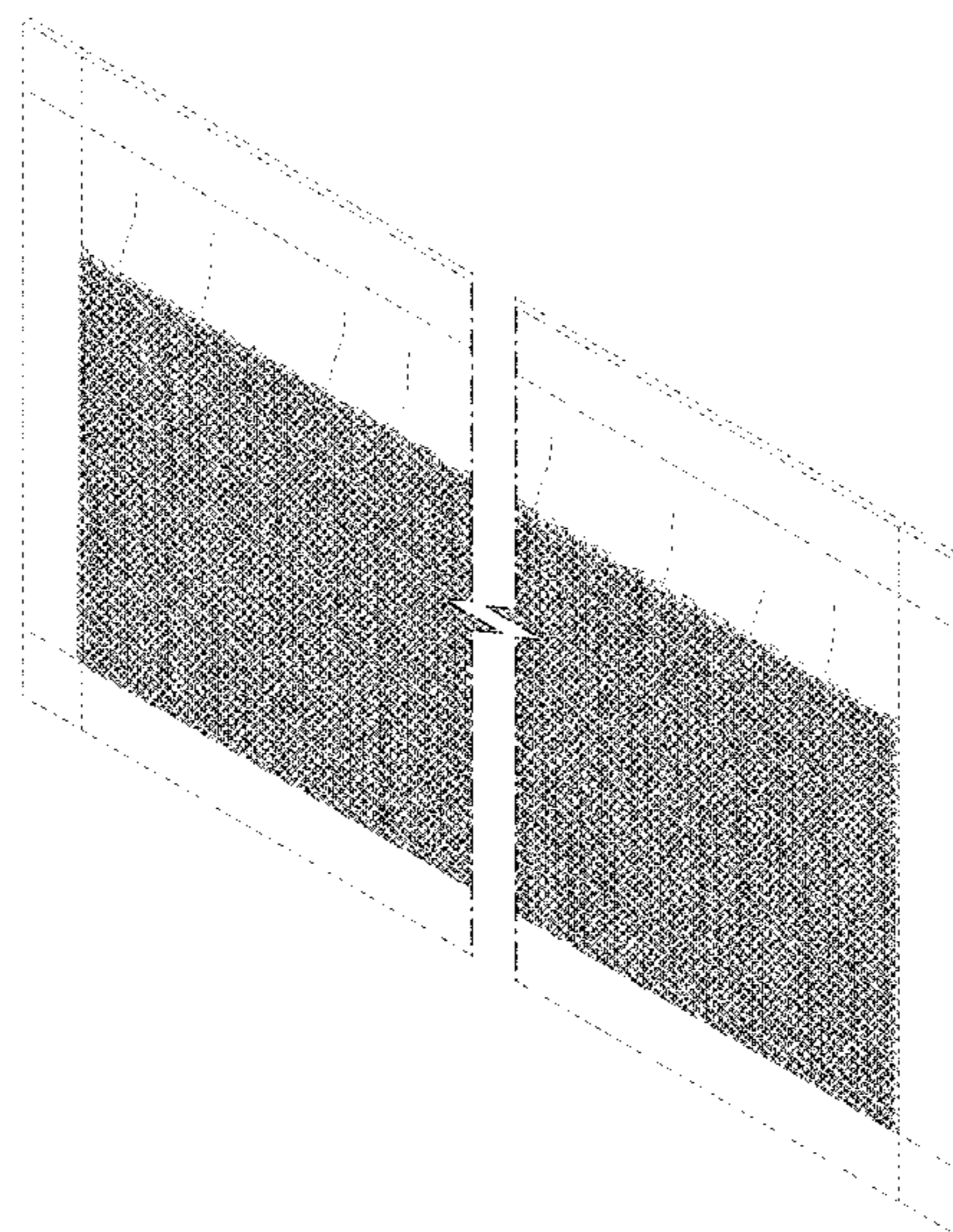
FIG. 7 is an enlarged detail view of area 7 circumscribed within FIG. 2.

The dash-dash broken lines of FIGS. 1-7 depict portions of the fabric material having a pattern resembling mesh that form no part of the claimed design.

The dot-dash-dot broken line encircling the area of the detail in FIG. 2 and surrounding FIG. 7 denotes the boundary of the enlarged detail and forms no part of the claimed design.

The fabric material having a pattern resembling mesh is shown with a symbolic break drawn in dot-dash-dot broken lines in its width. The symbolic break lines and the appearance of any portion of the article between the symbolic break lines form no part of the claimed design.

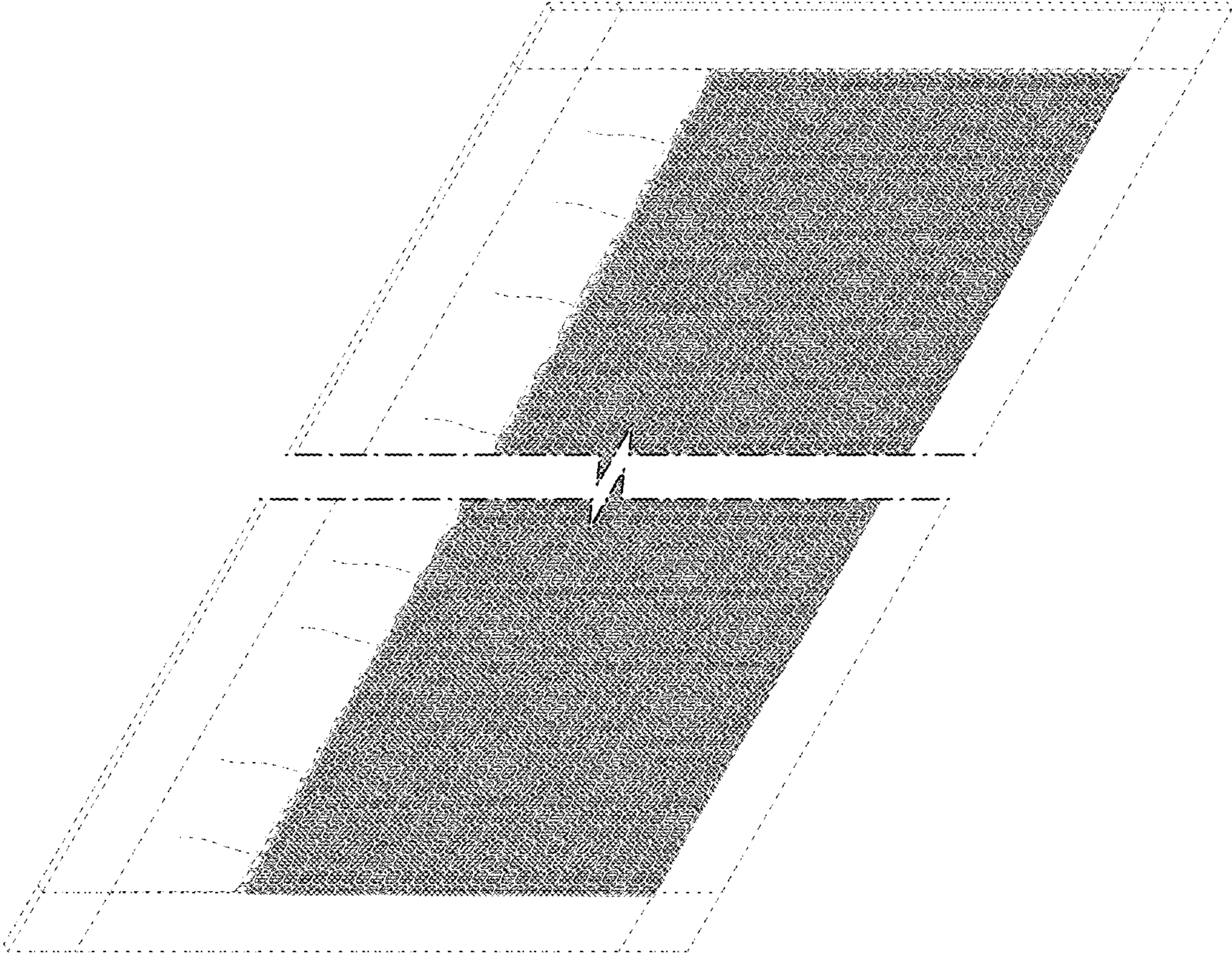

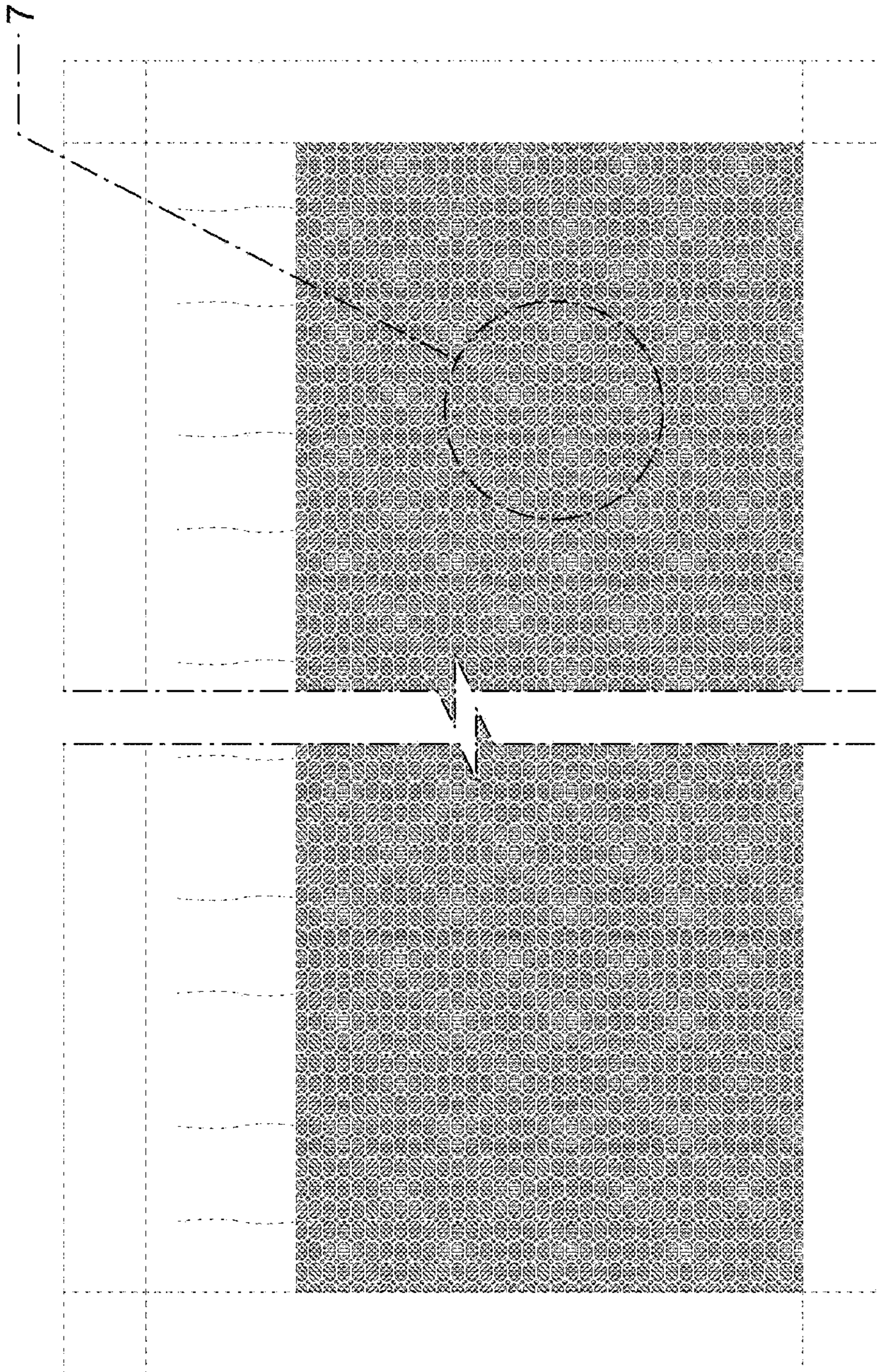

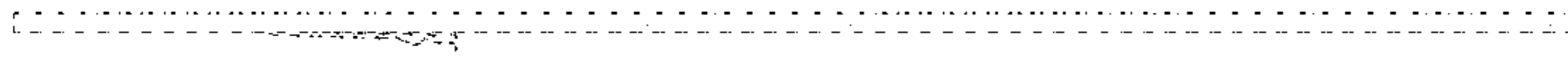

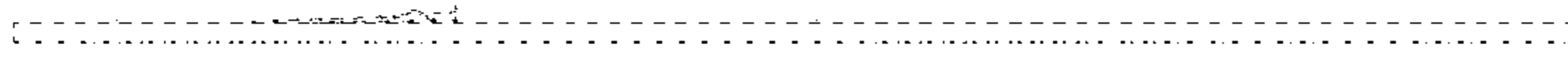

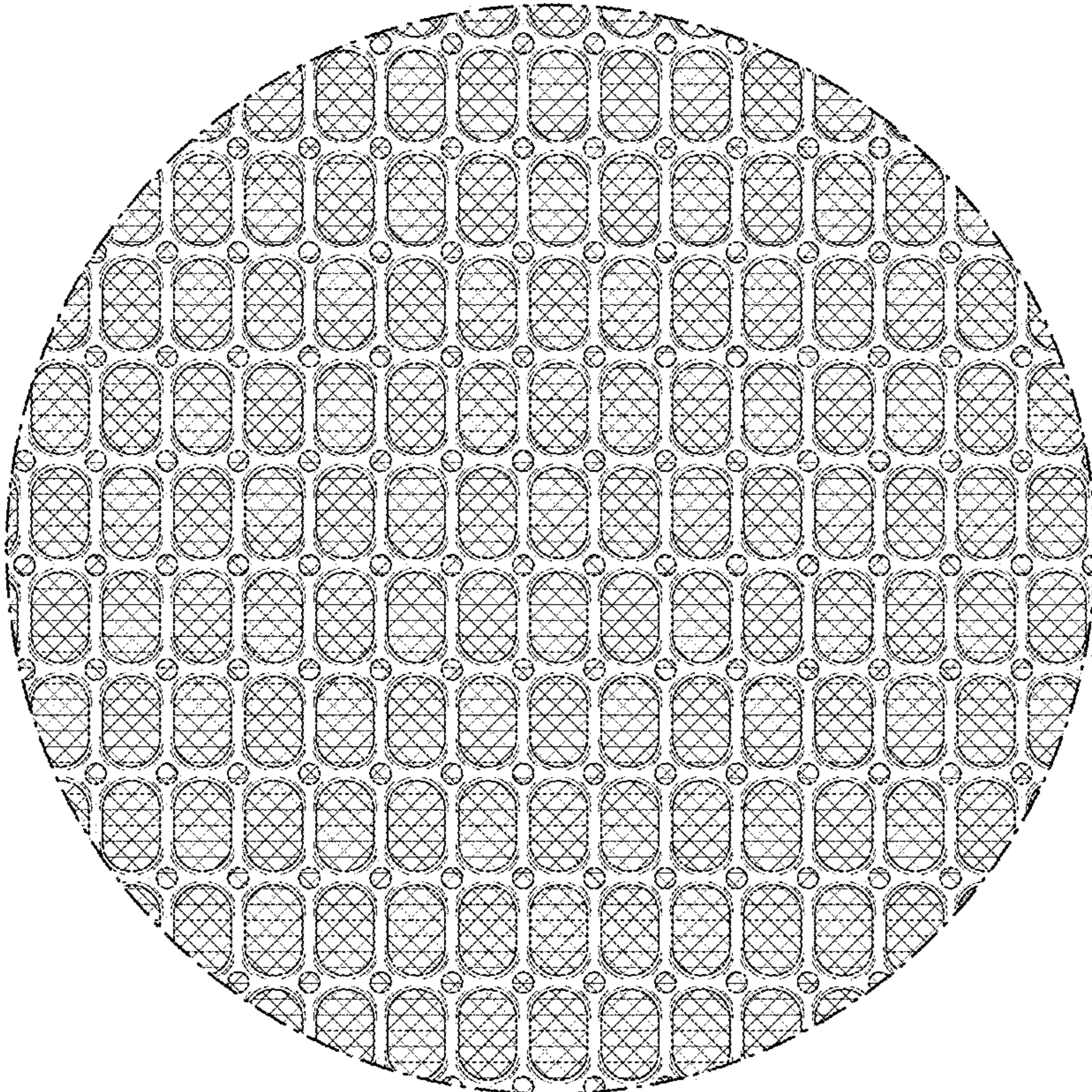
