FIG. 5 is a left view of FIG. 1;

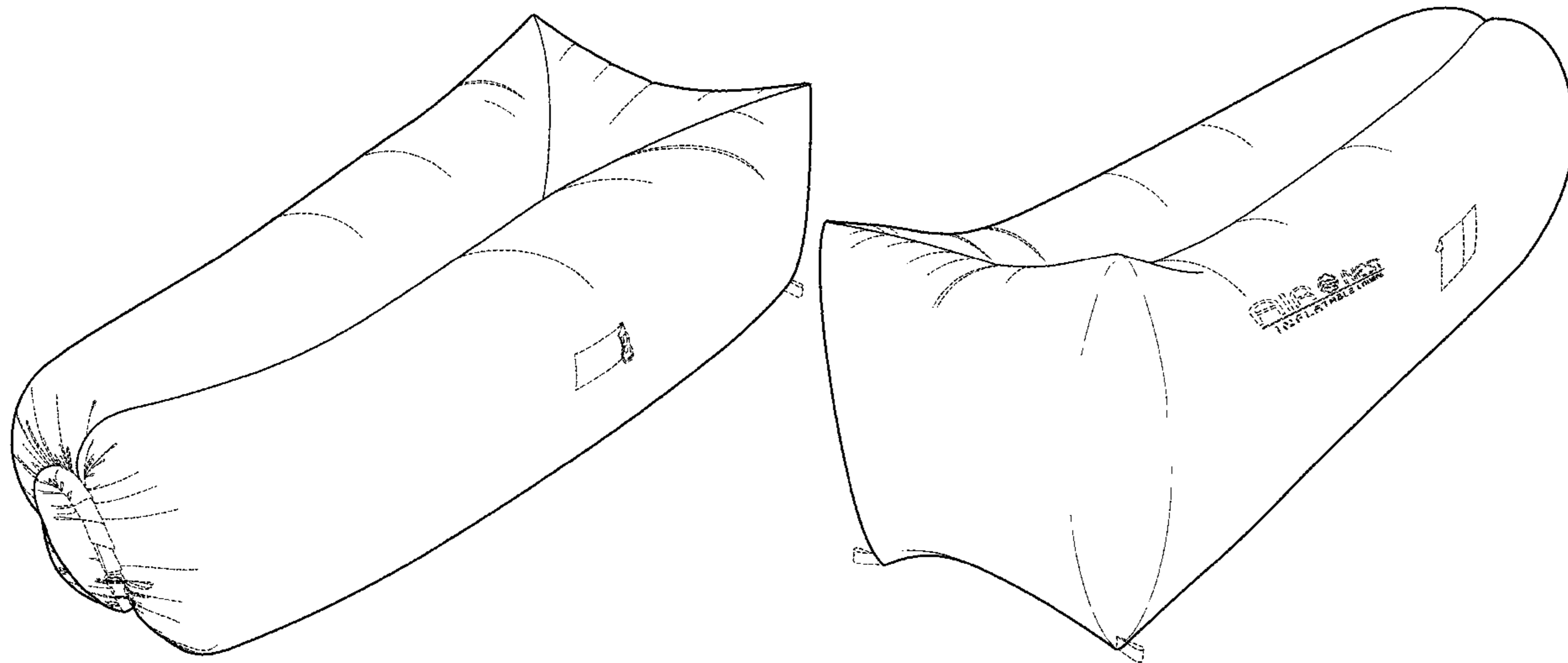
FIG. 6 is a right view of FIG. 1;

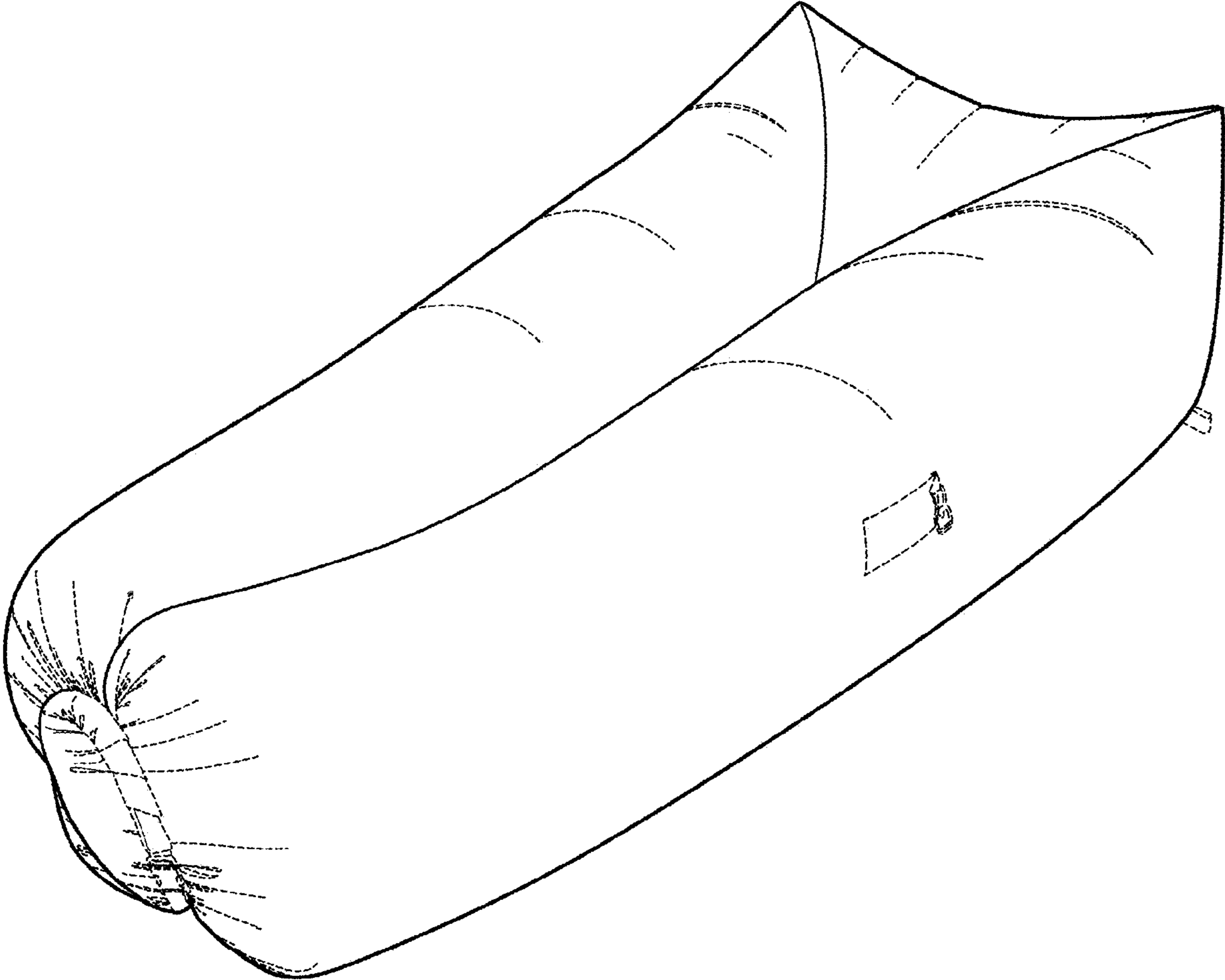

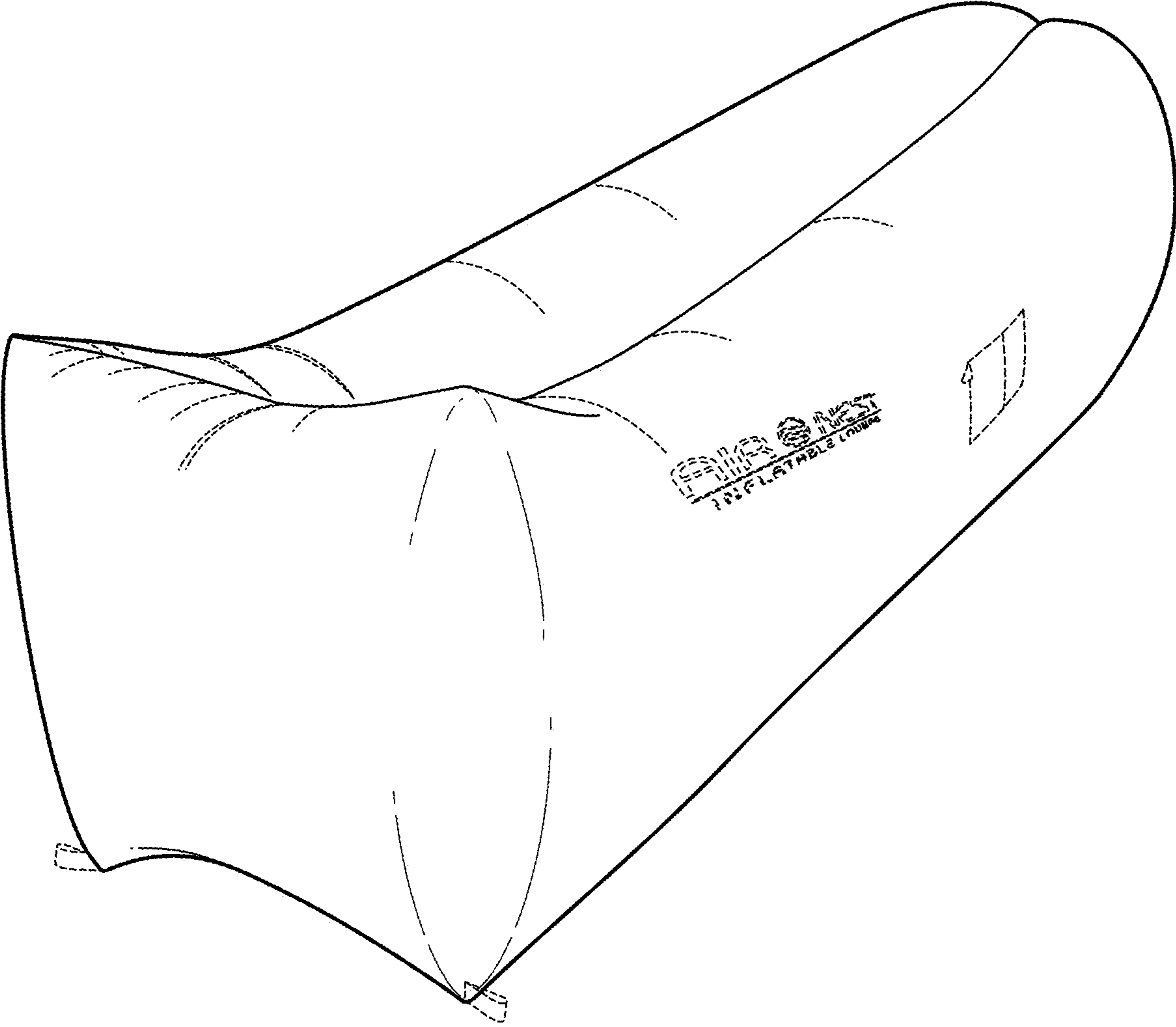

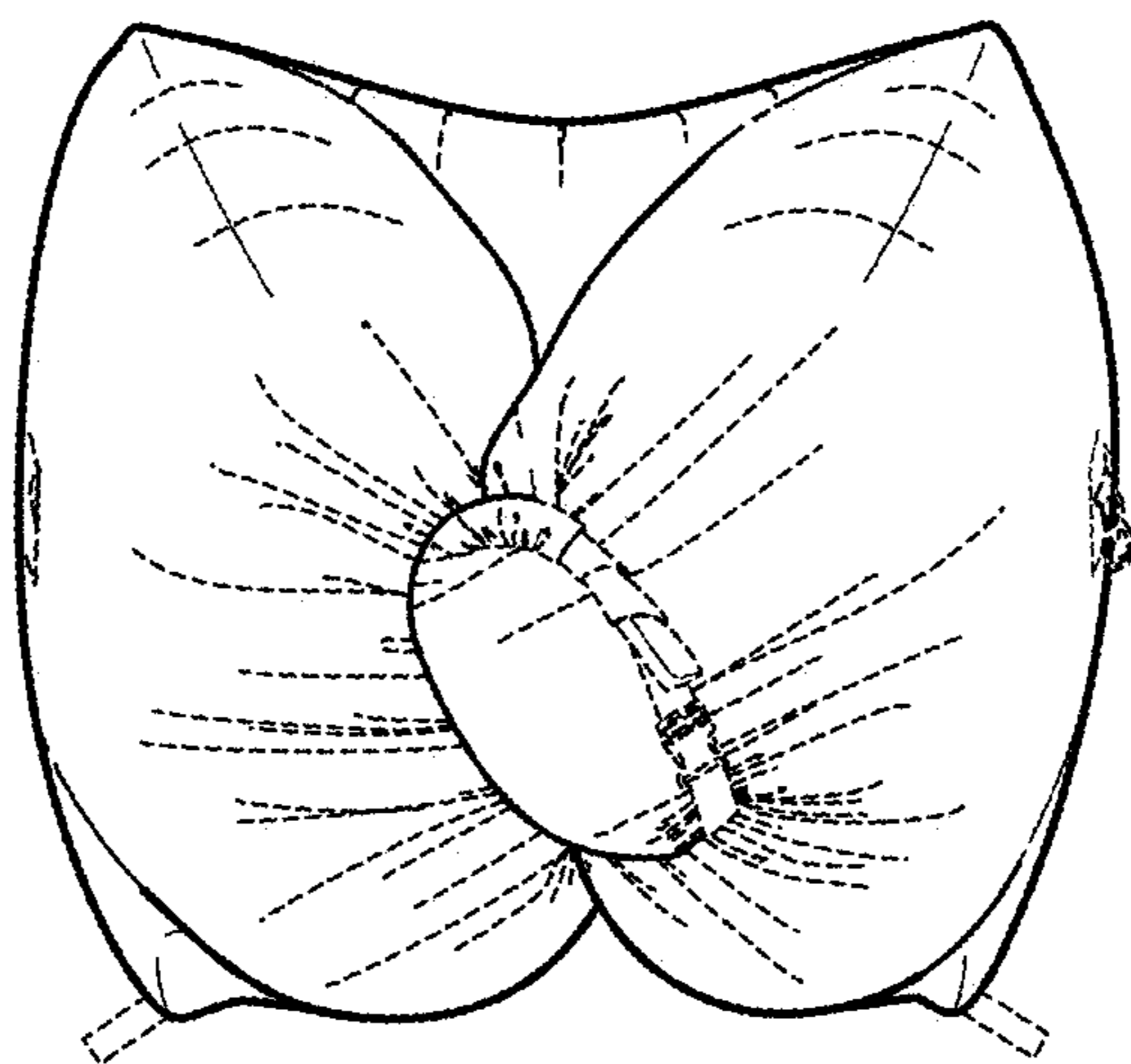

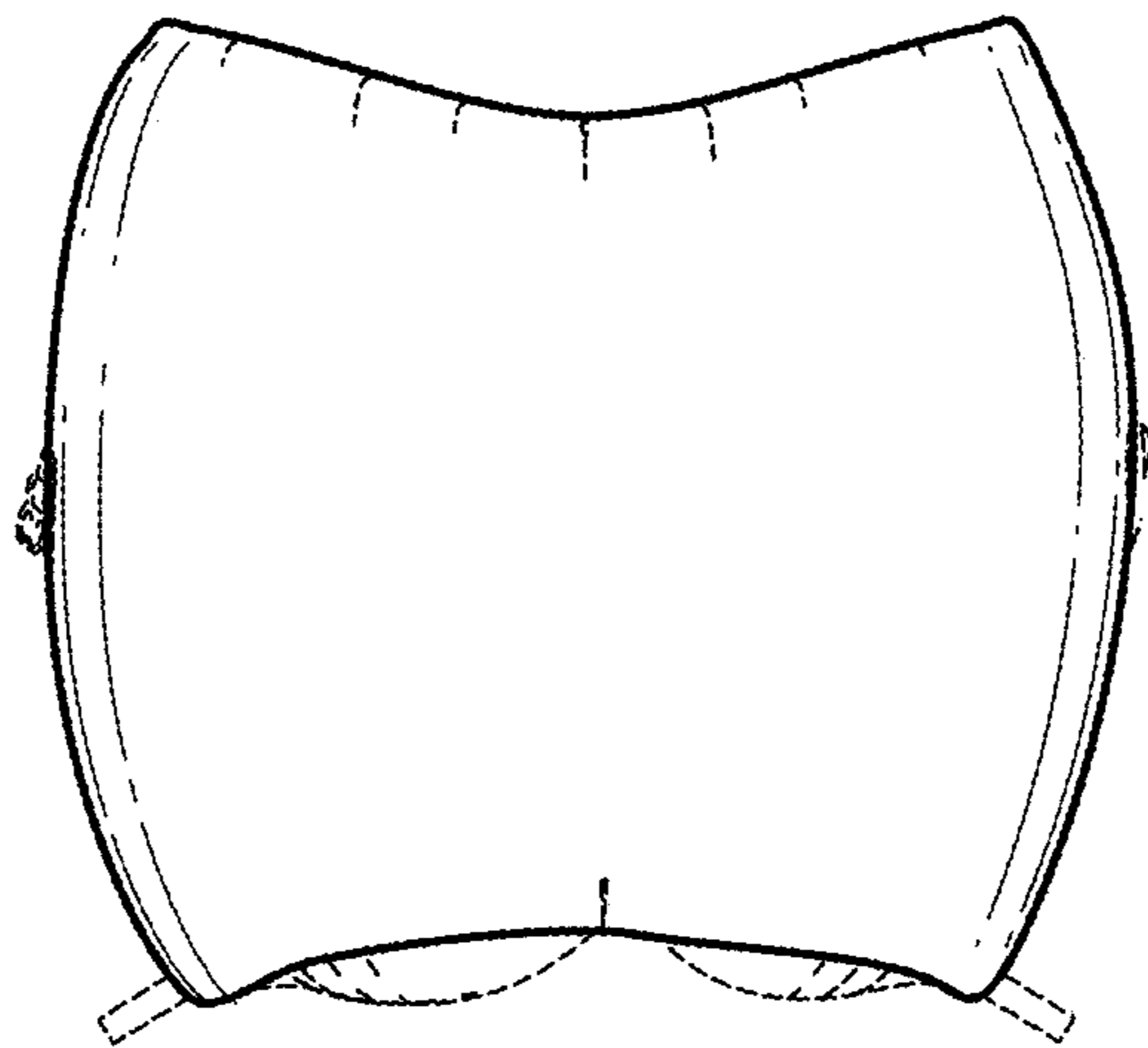

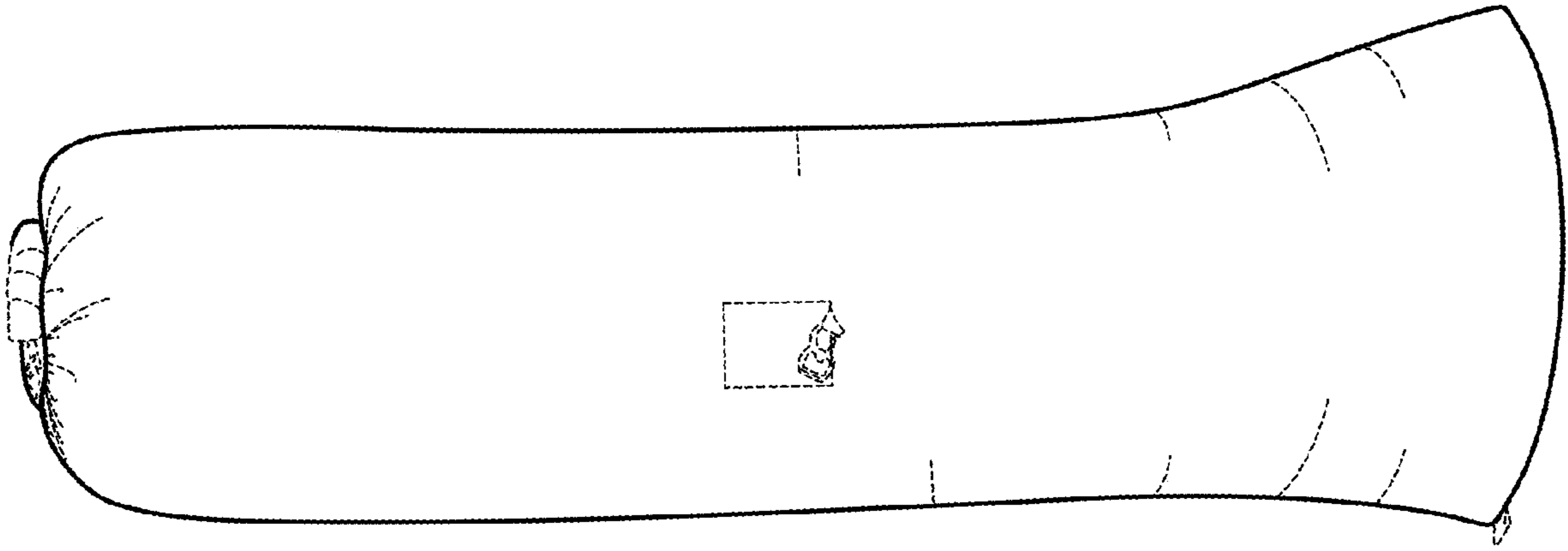

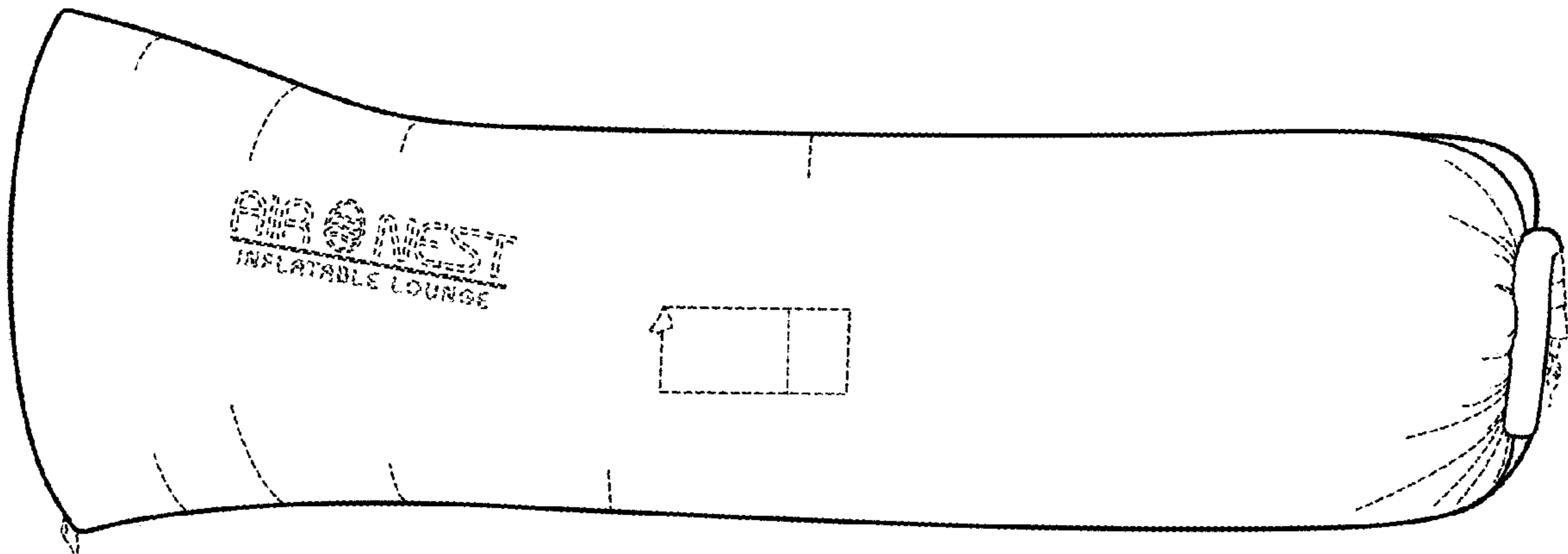

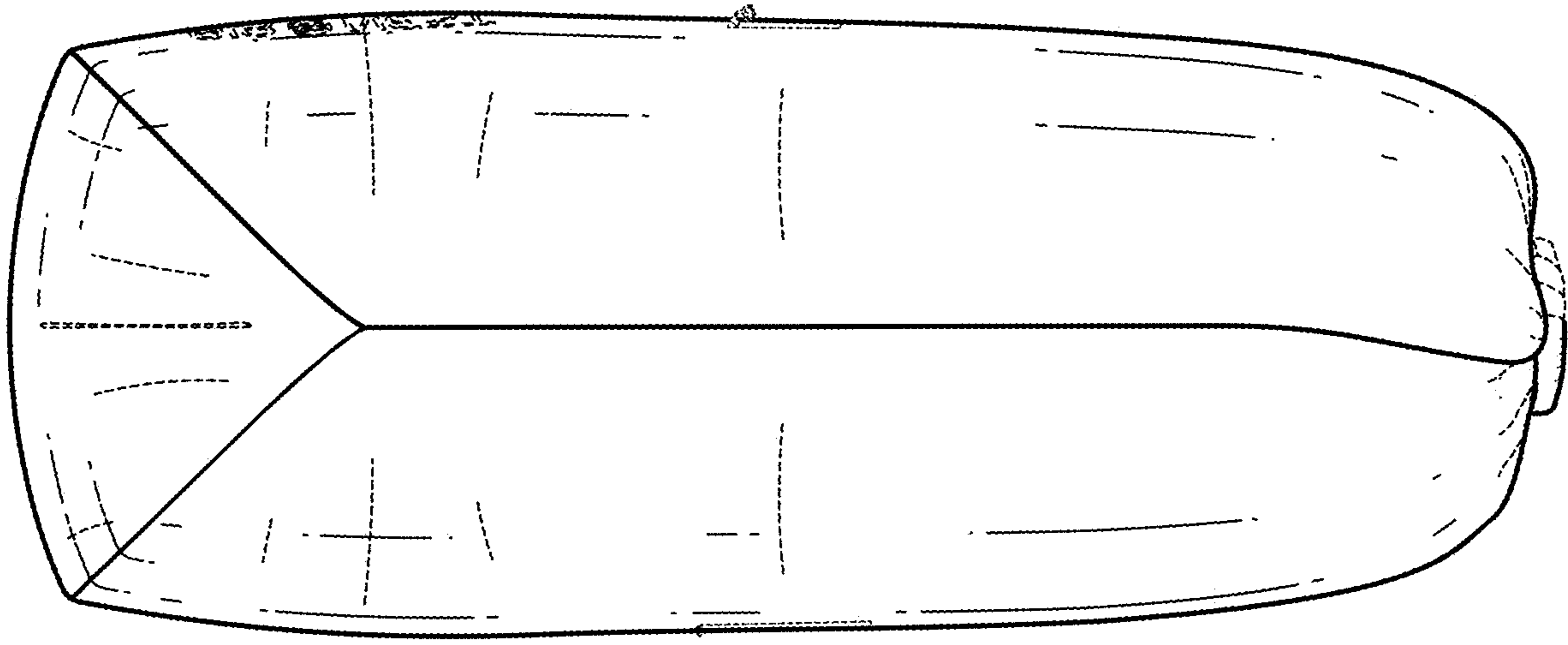

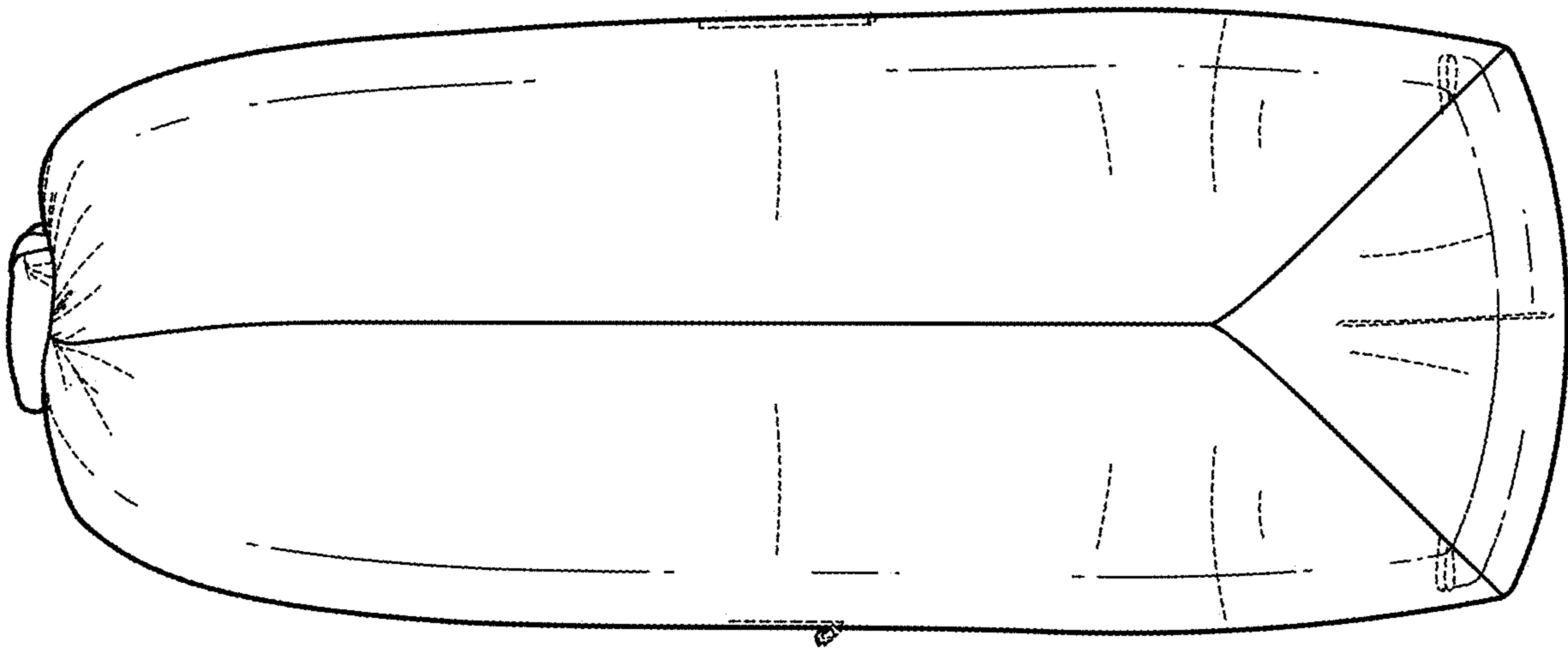
