(57) **CLAIM**

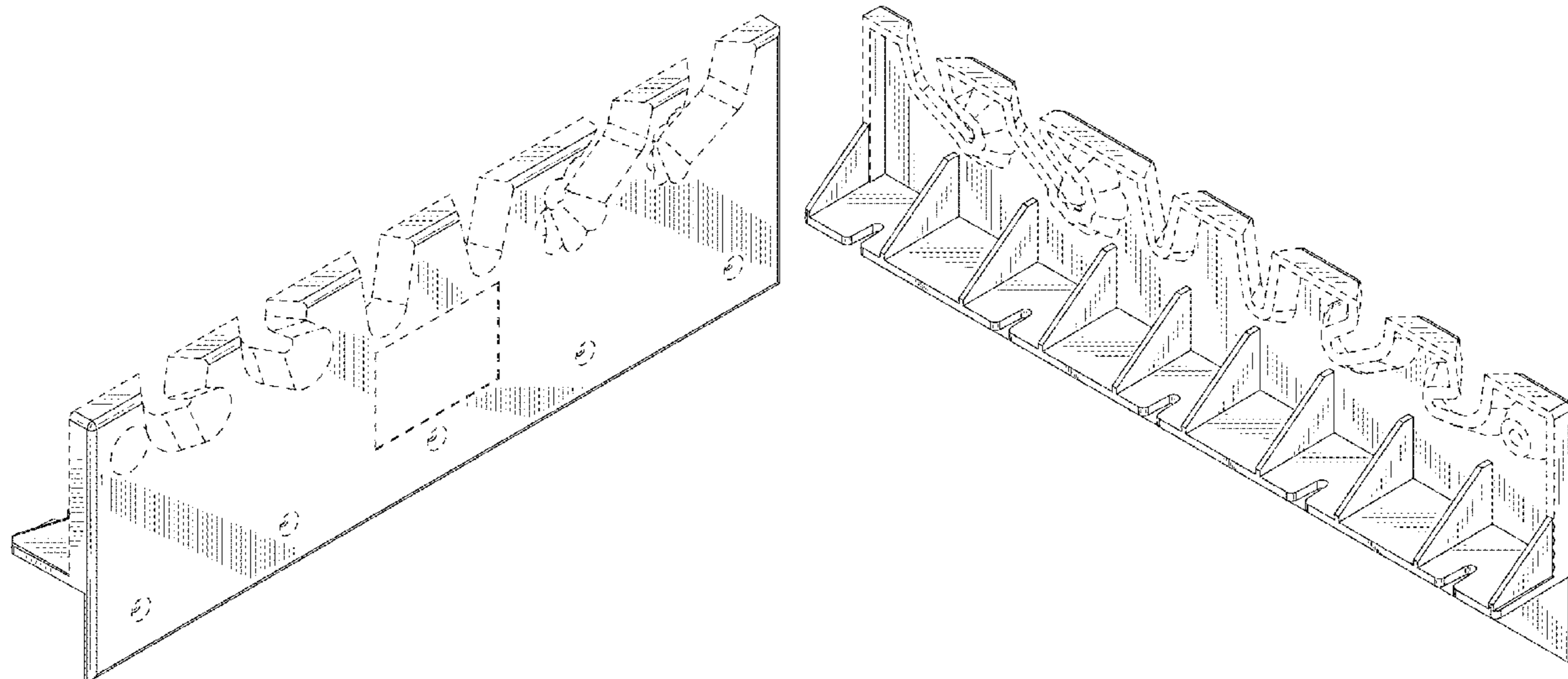
The ornamental design for a flower stripper, as shown and

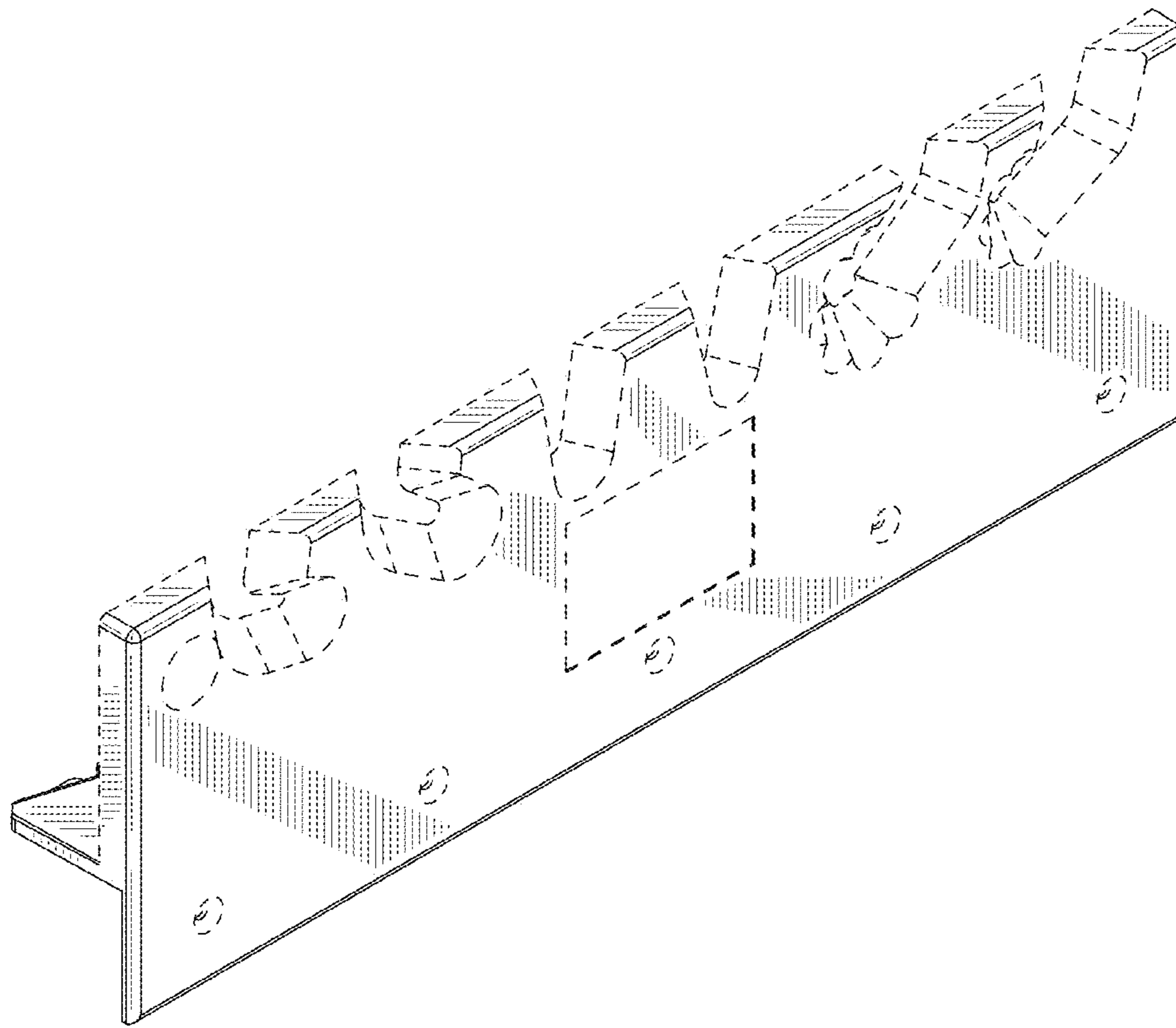

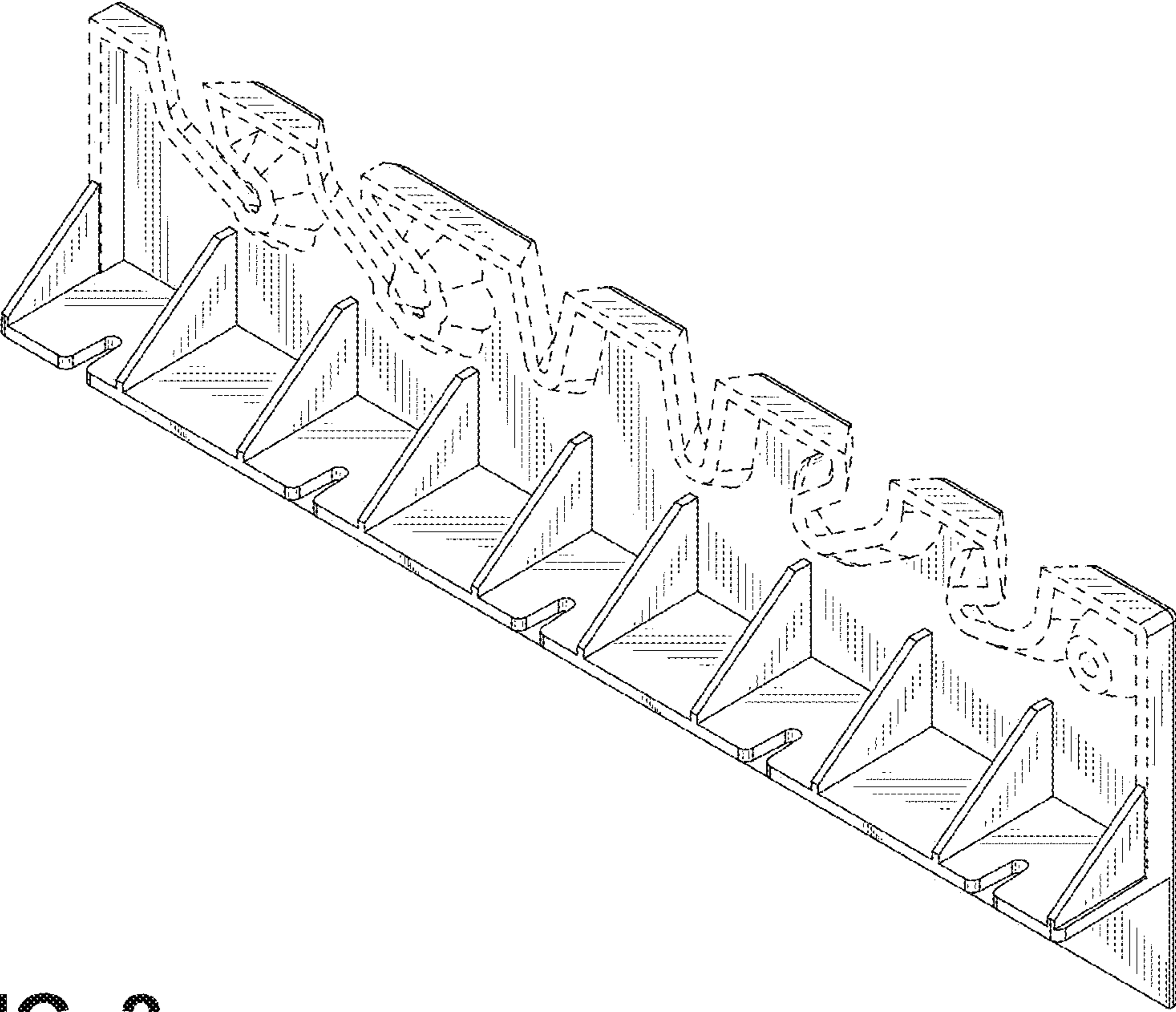

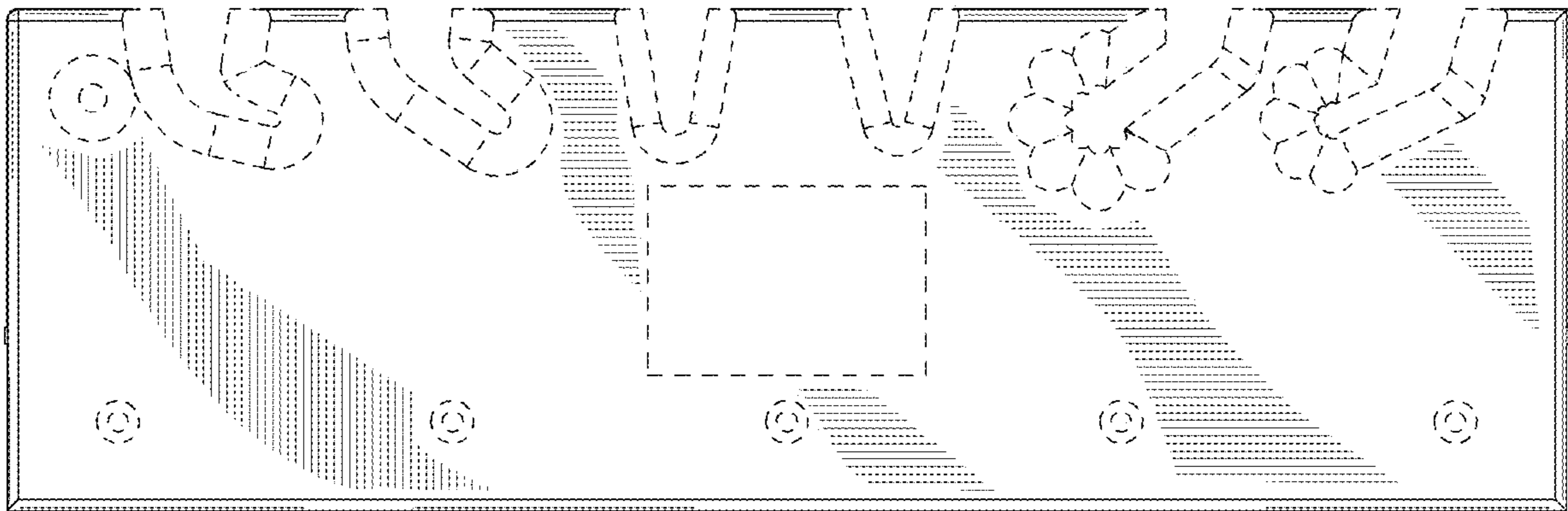

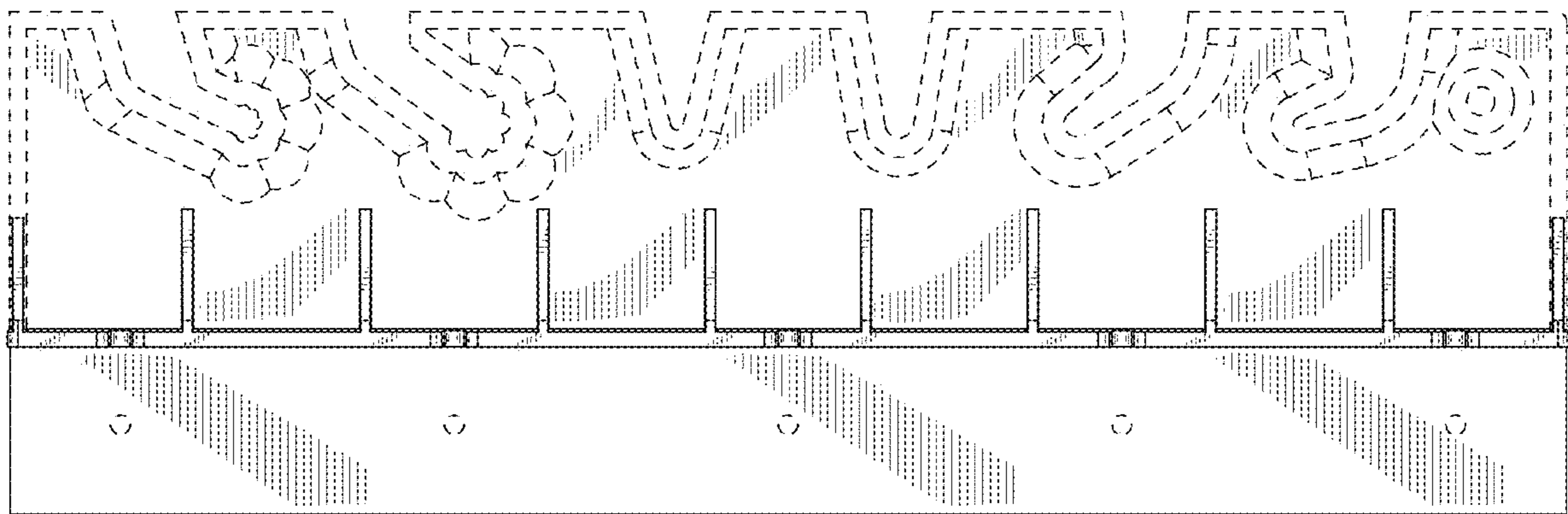

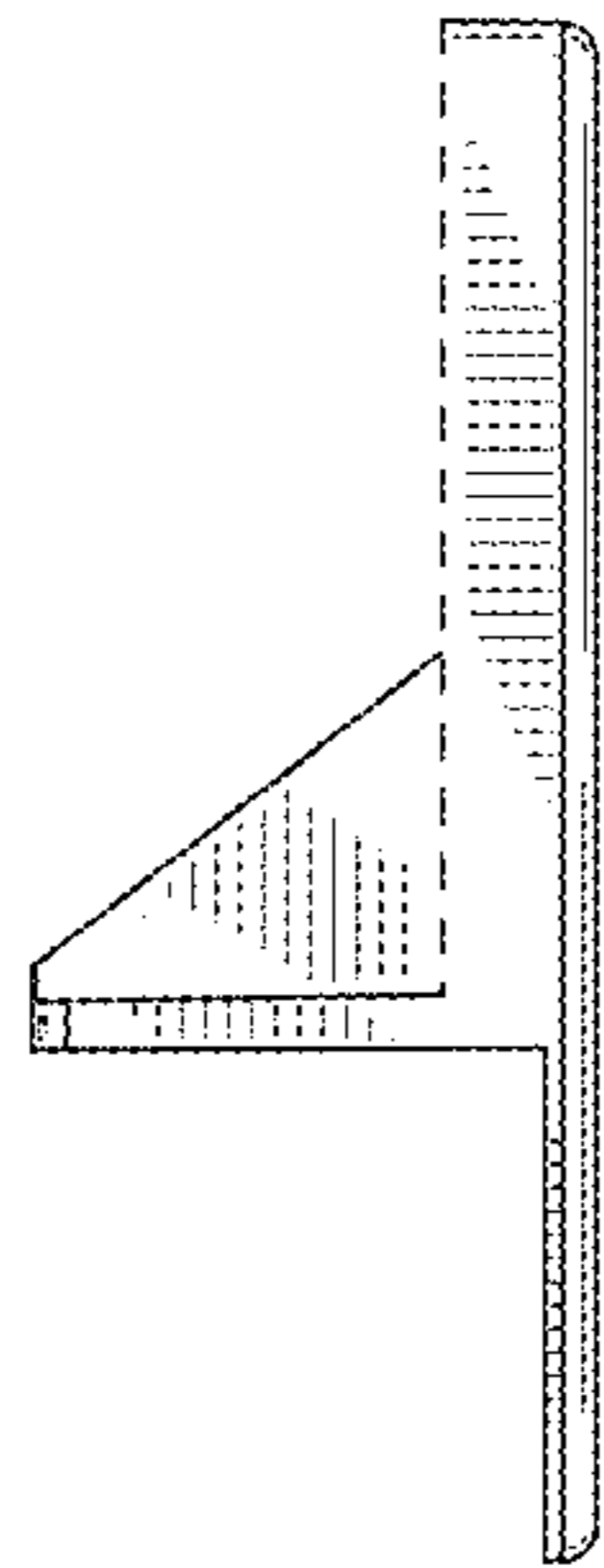

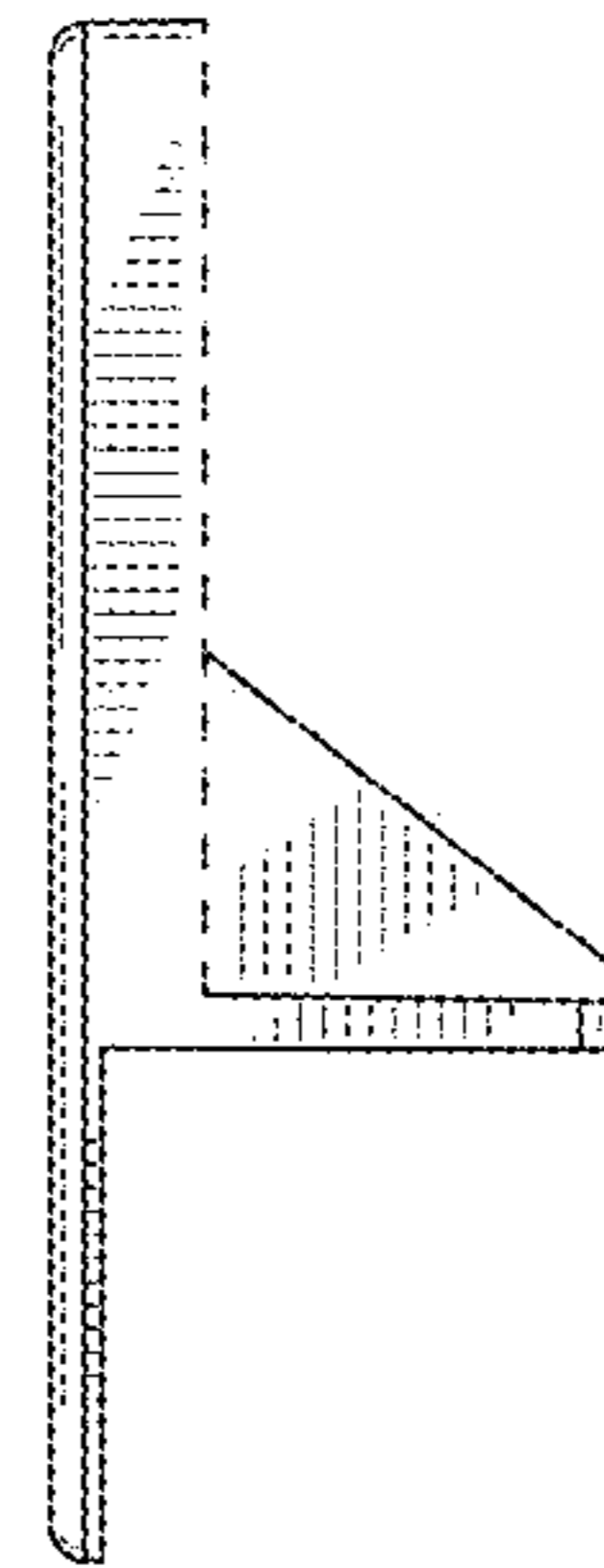

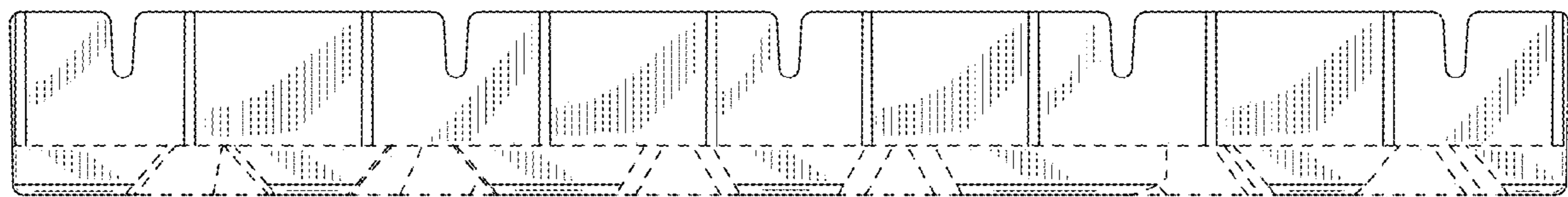

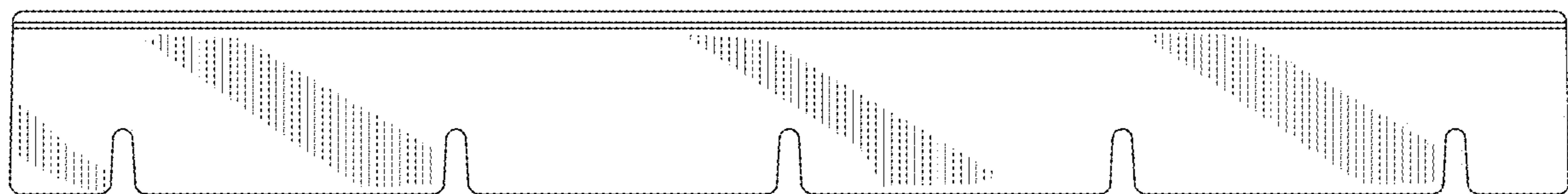
