FIG. 1 is a perspective view of a wristband according to the invention;

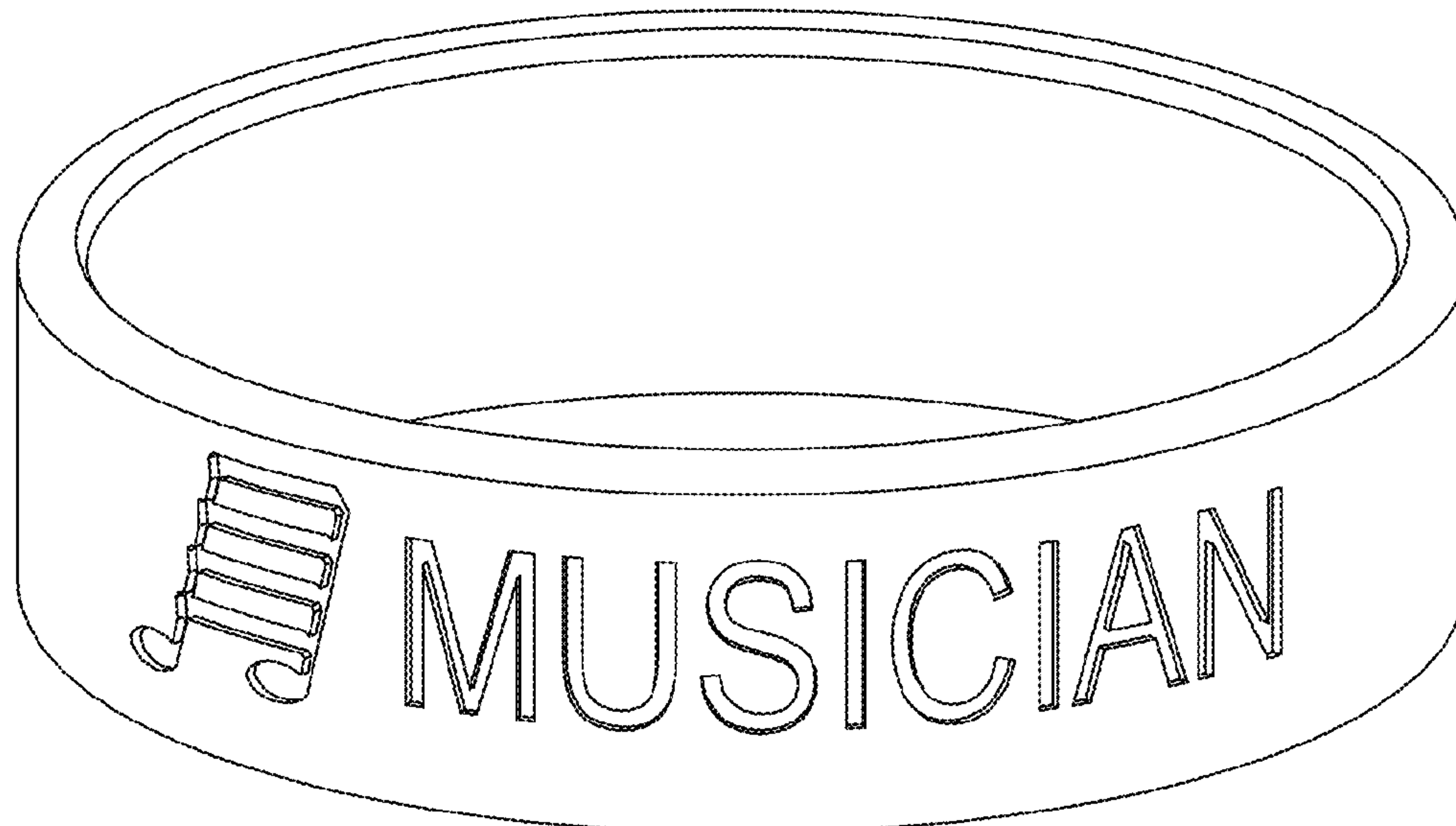
FIG. 2 is a front elevation thereof;

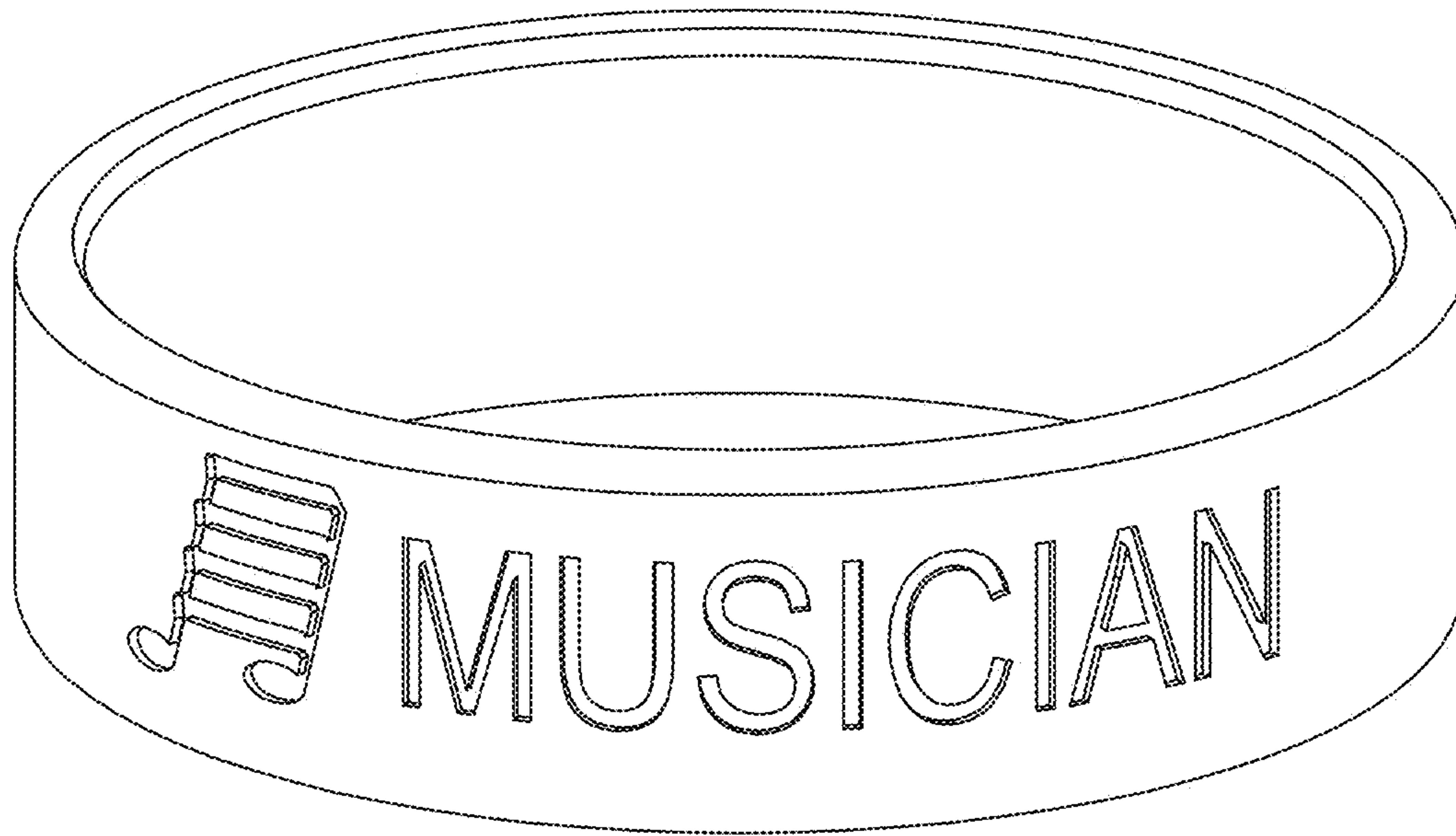

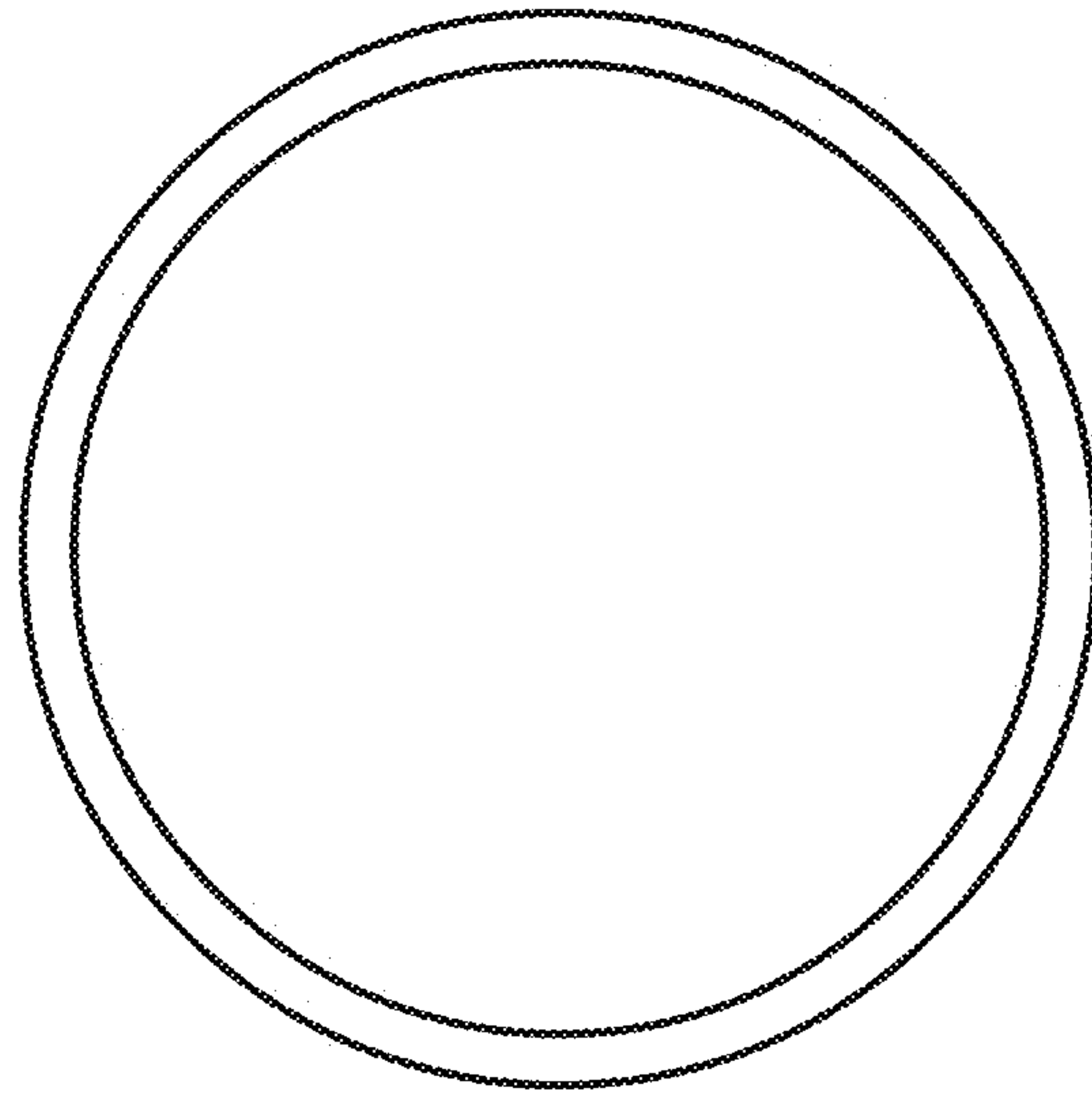

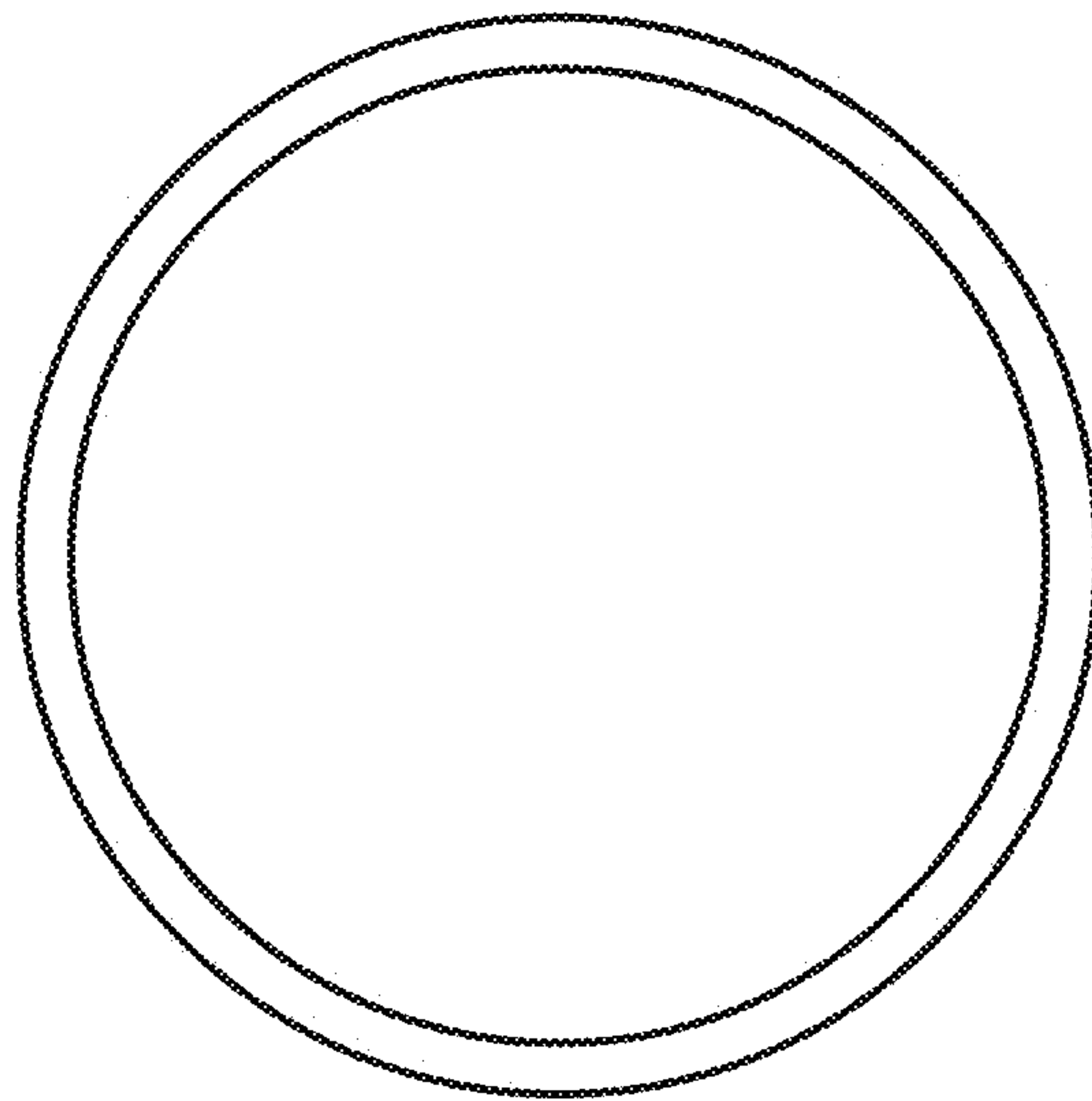
