DESCRIPTION

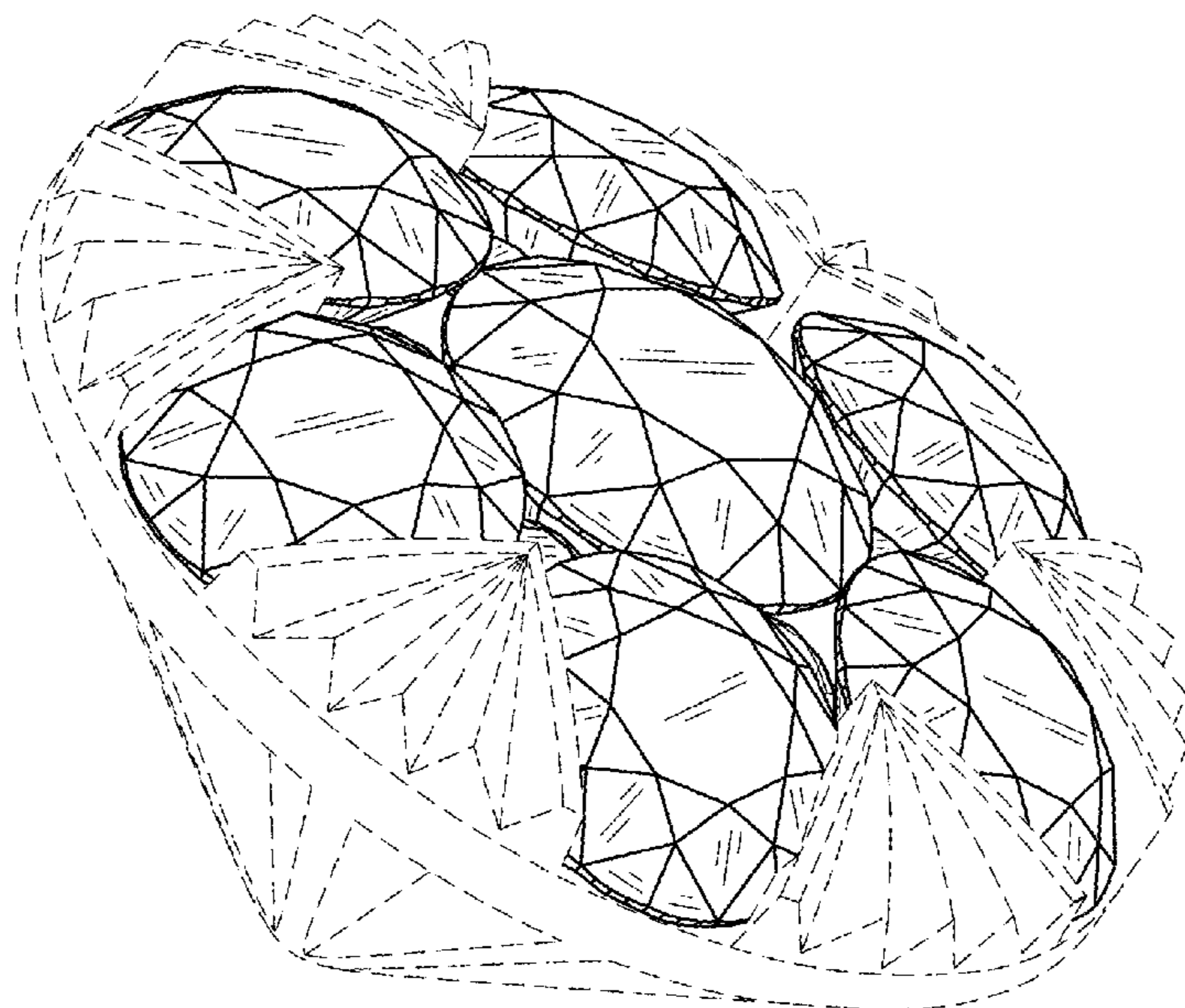
FIG. 1 is a perspective view of a jewelry set showing my new design;

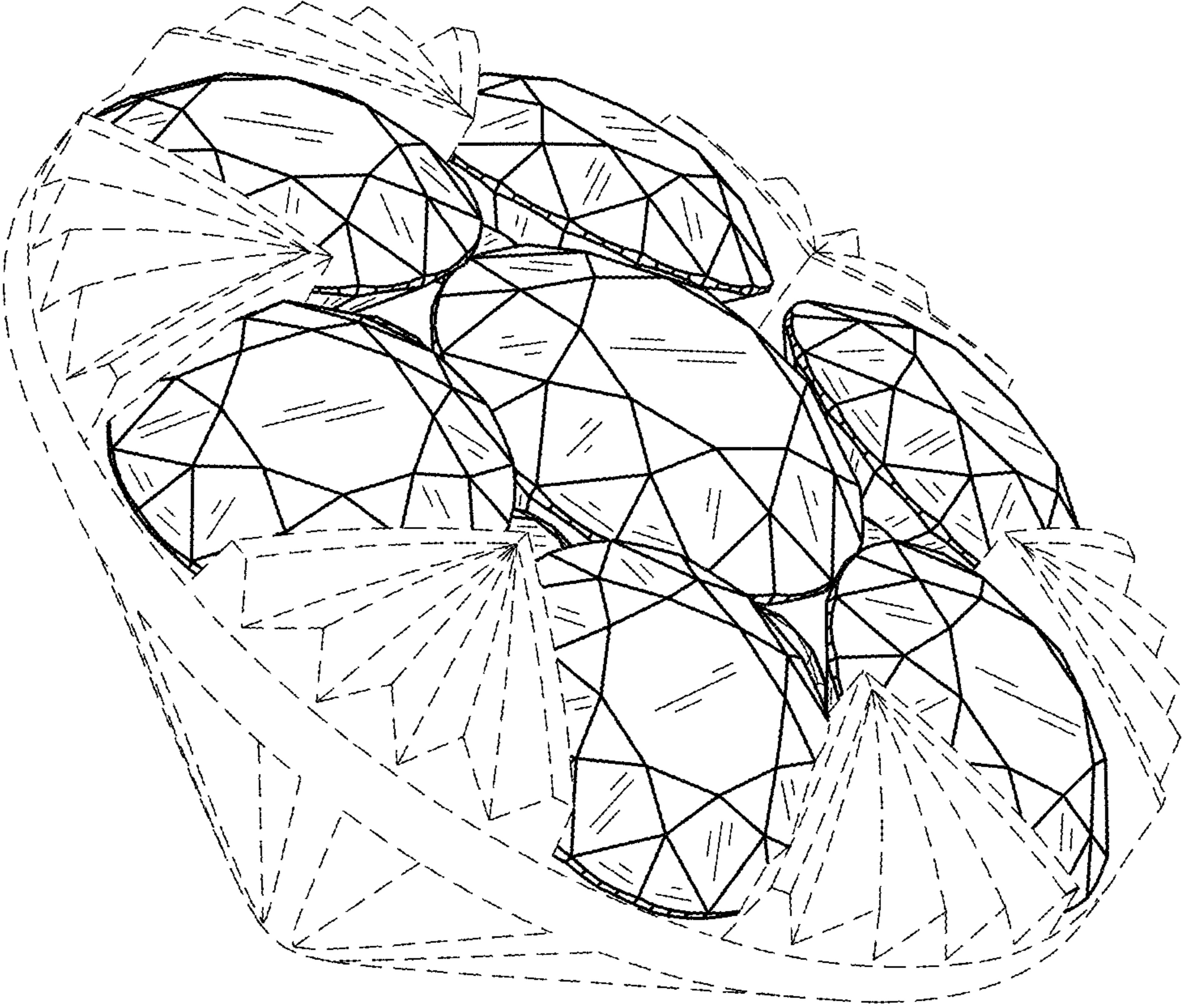

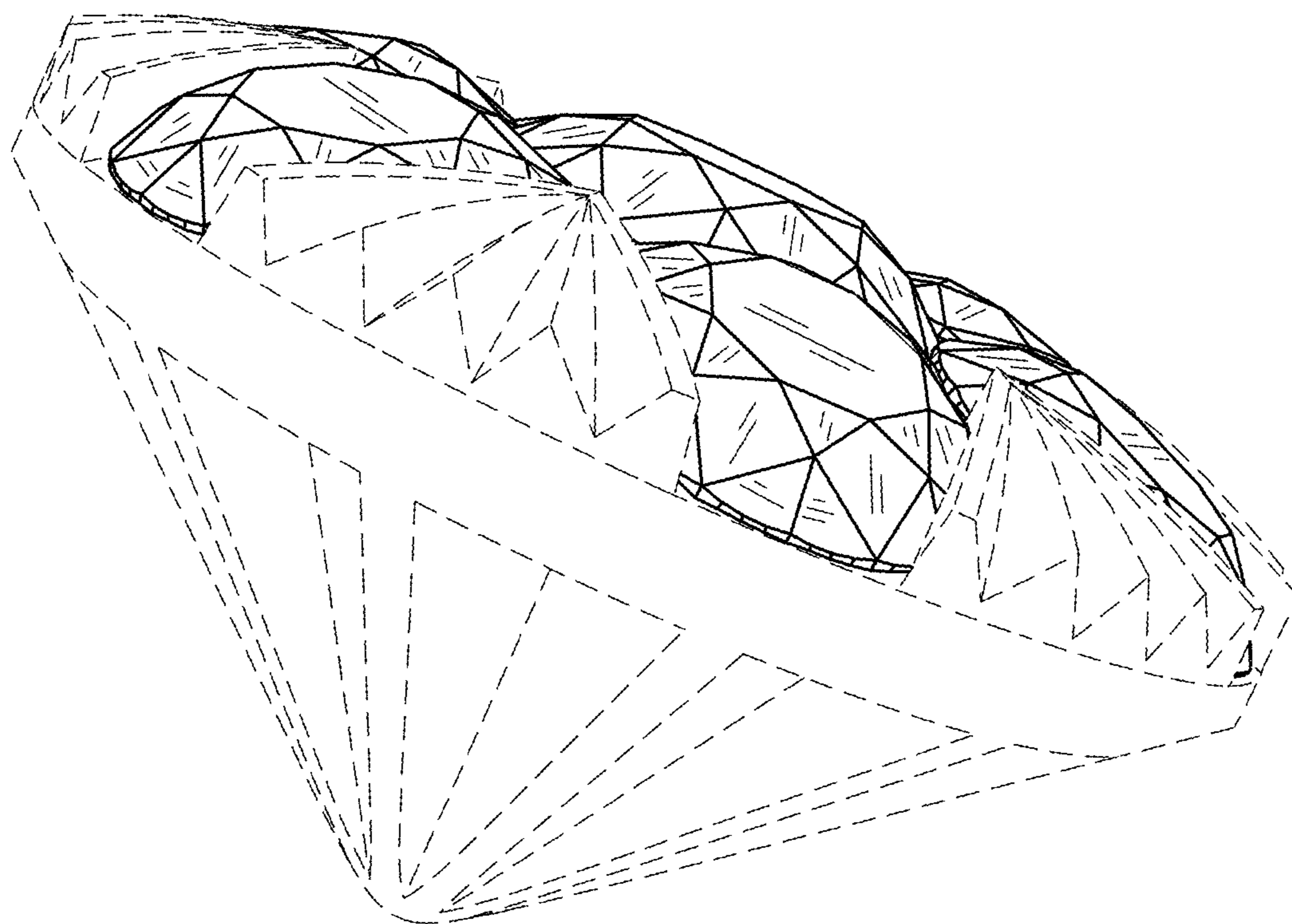

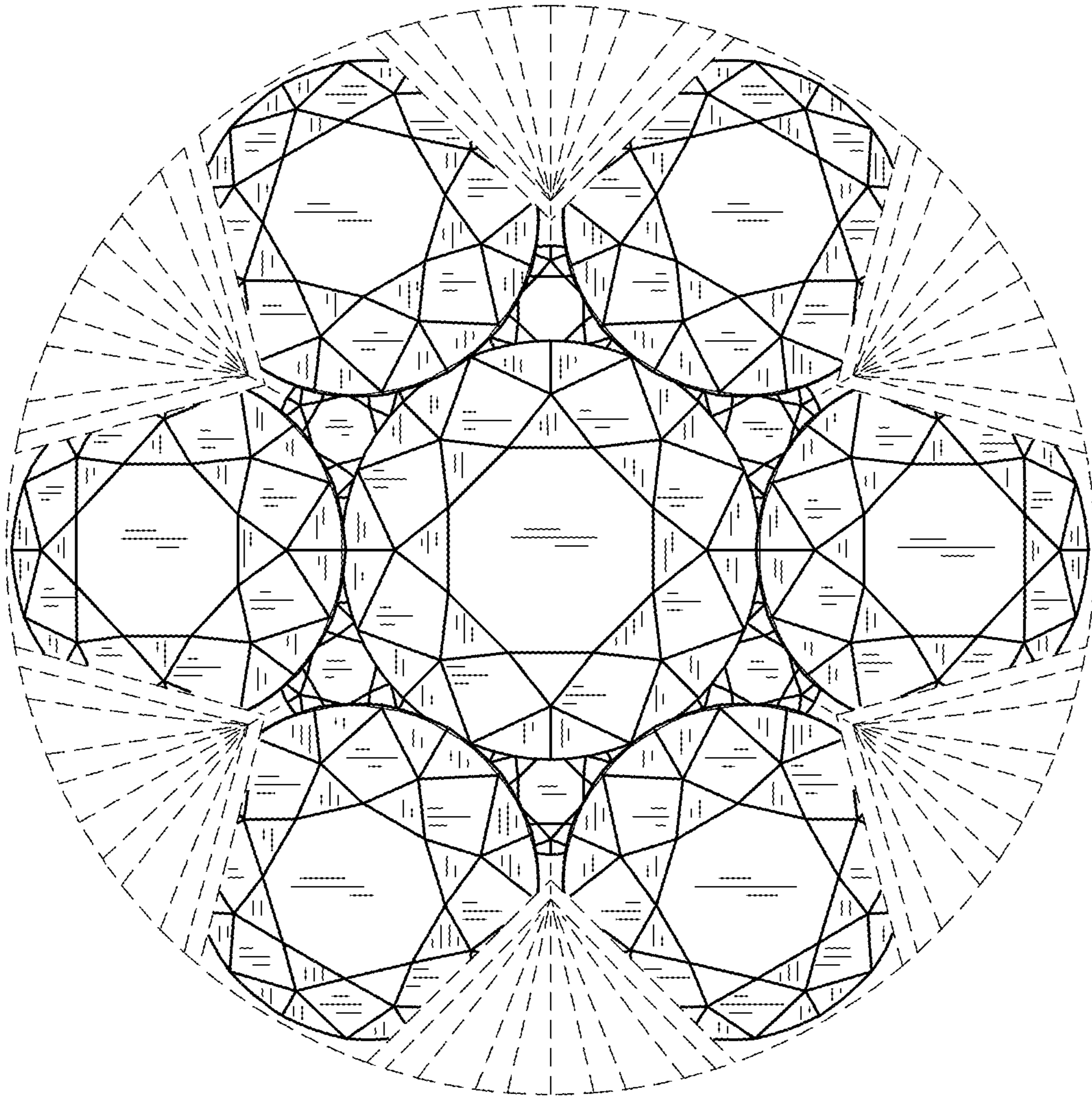

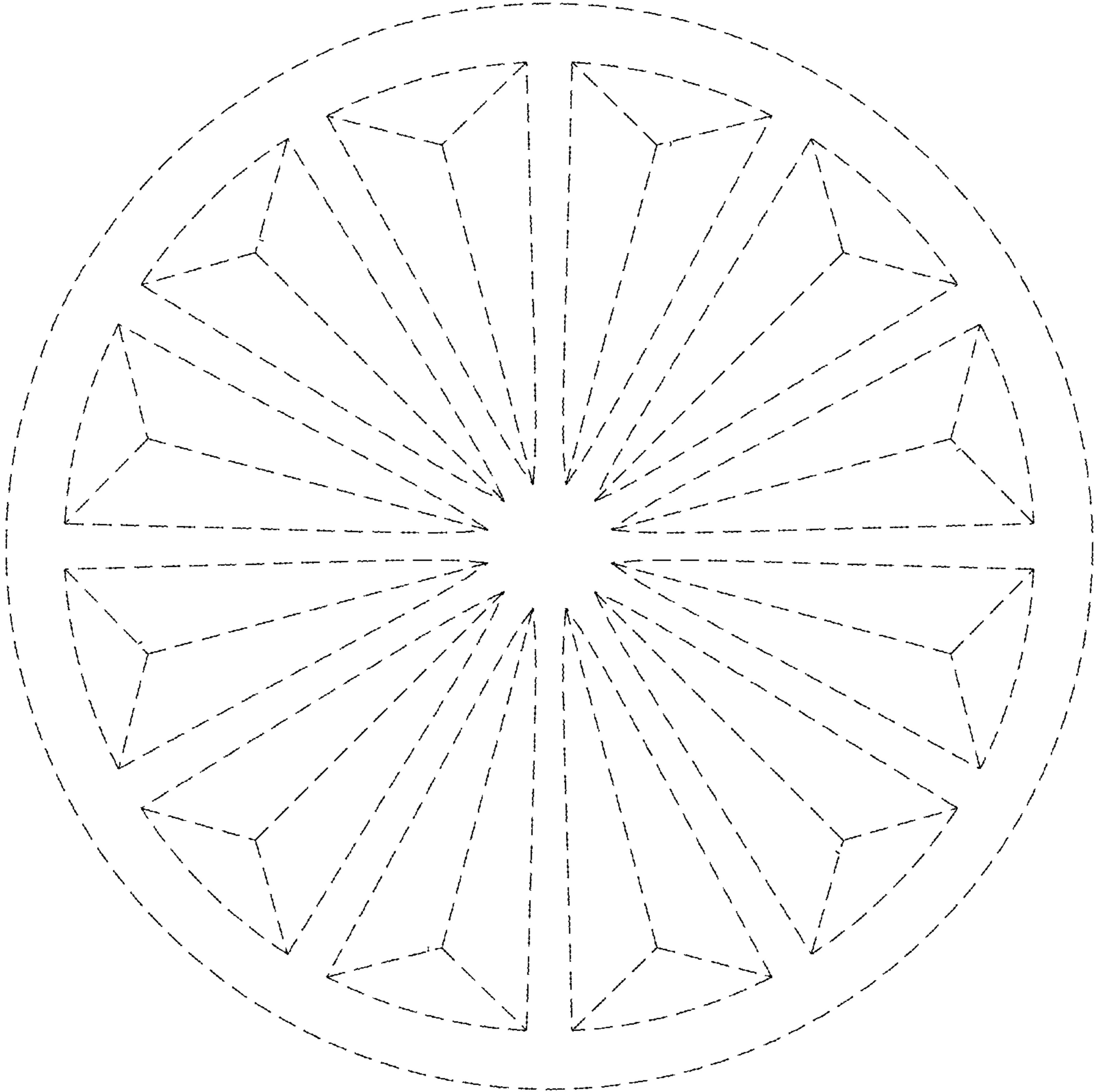

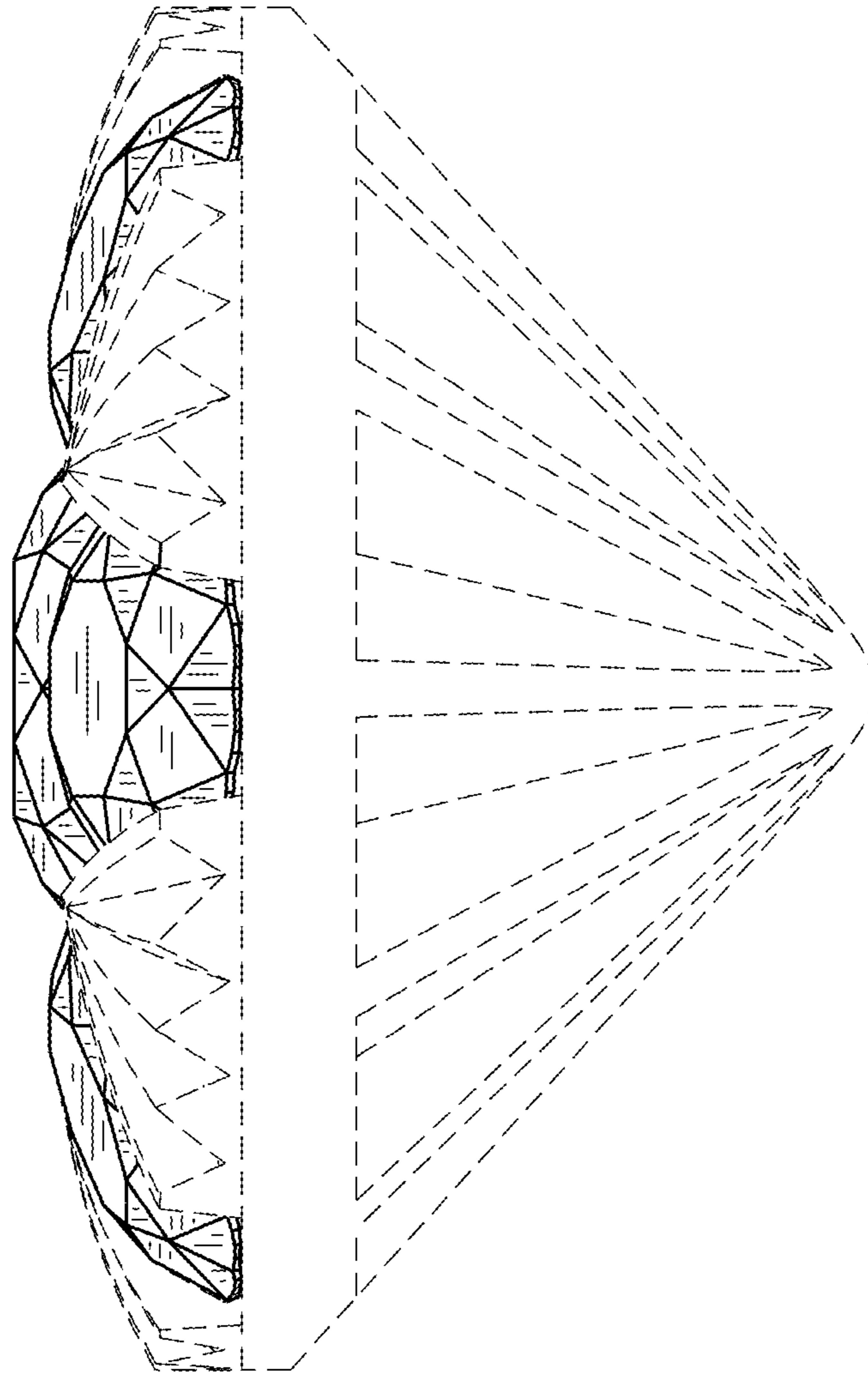

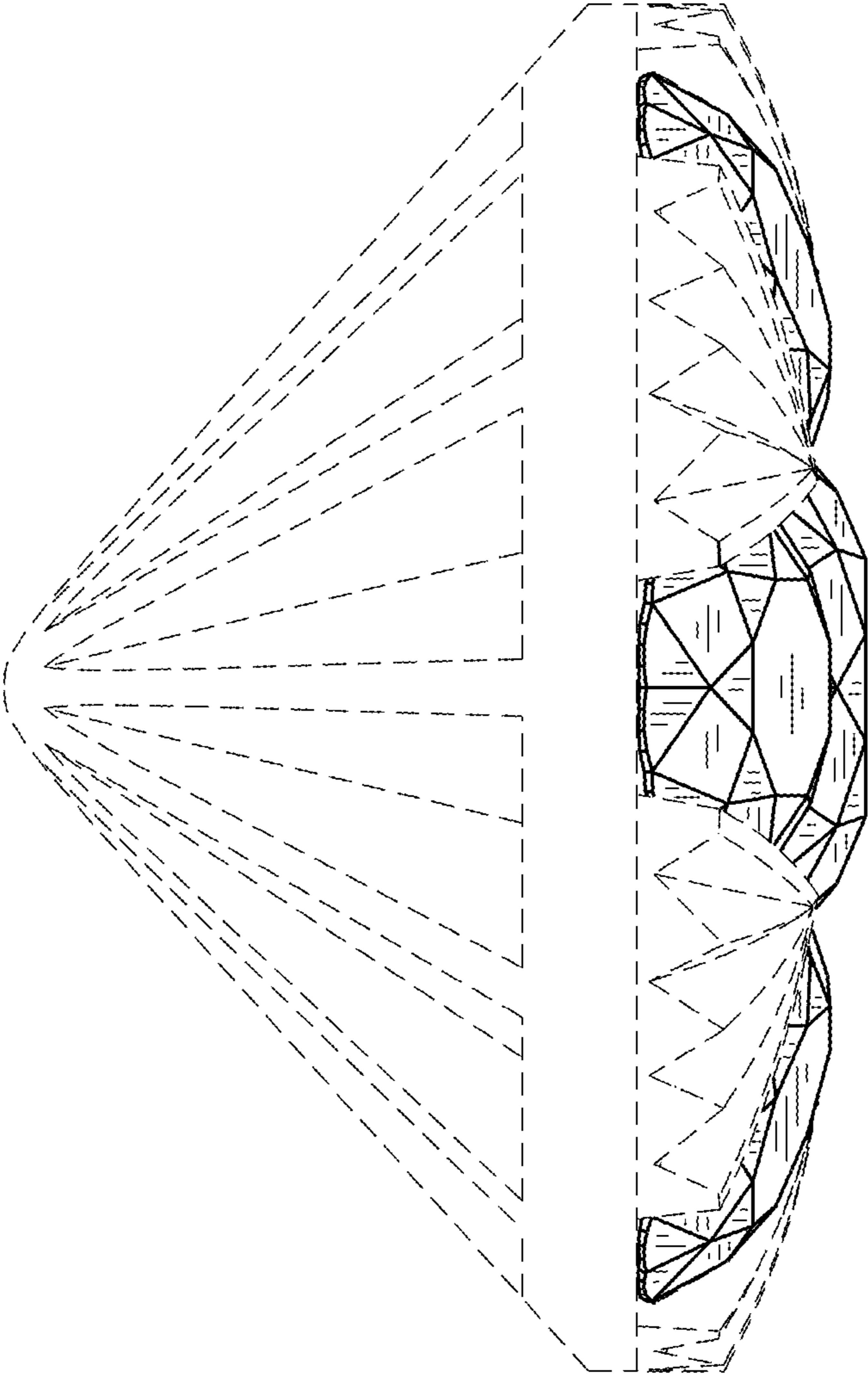

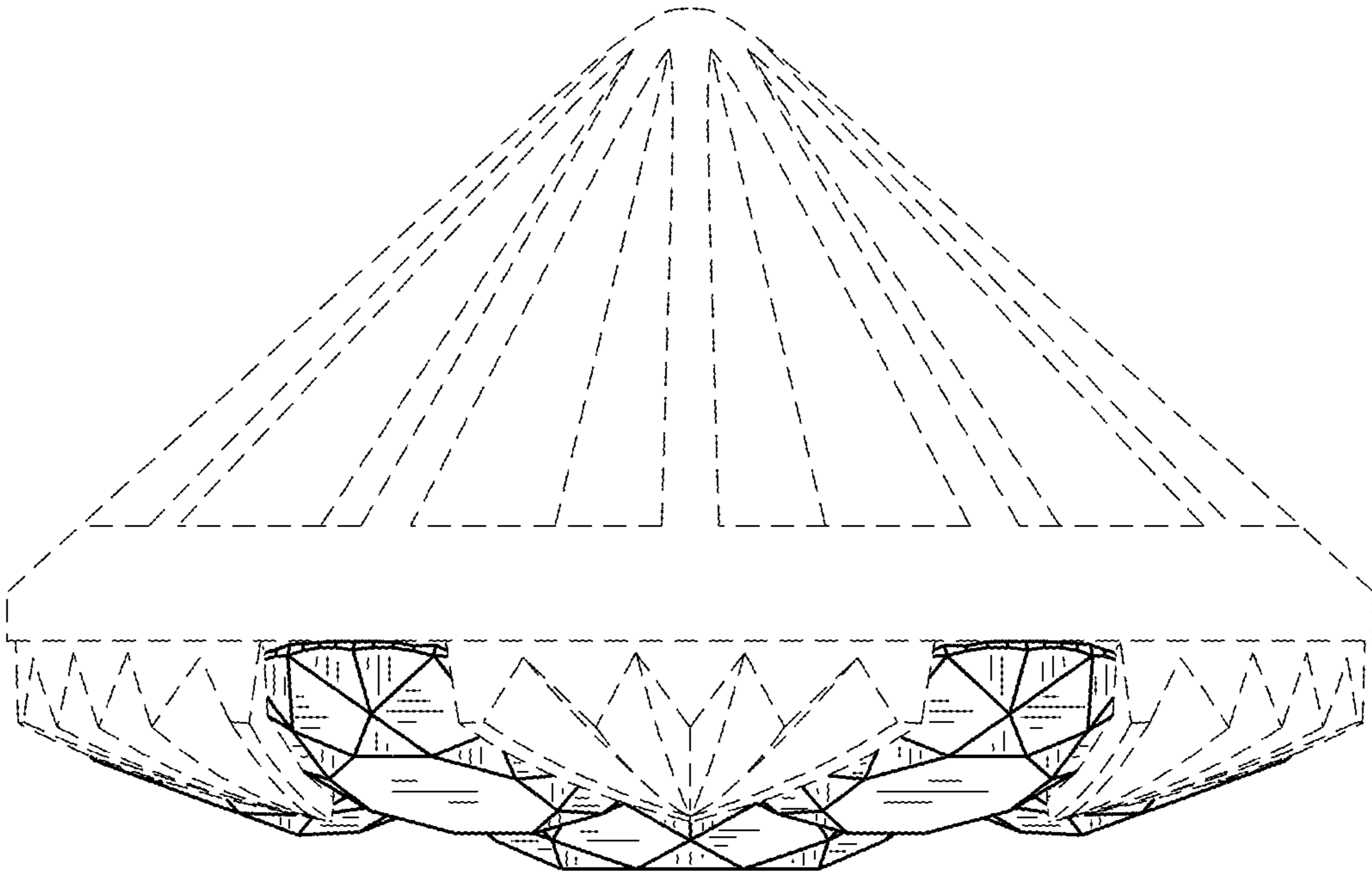

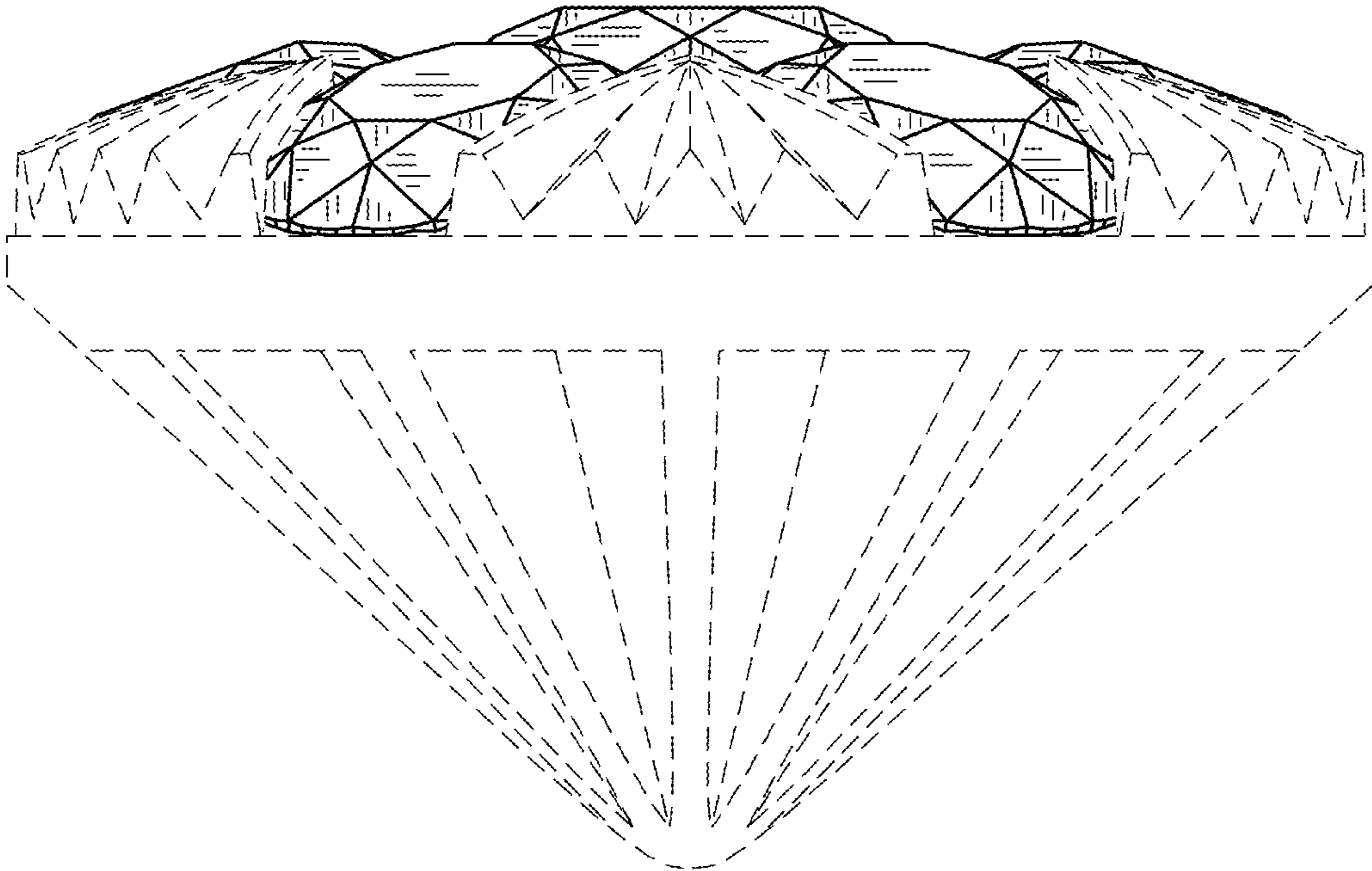
