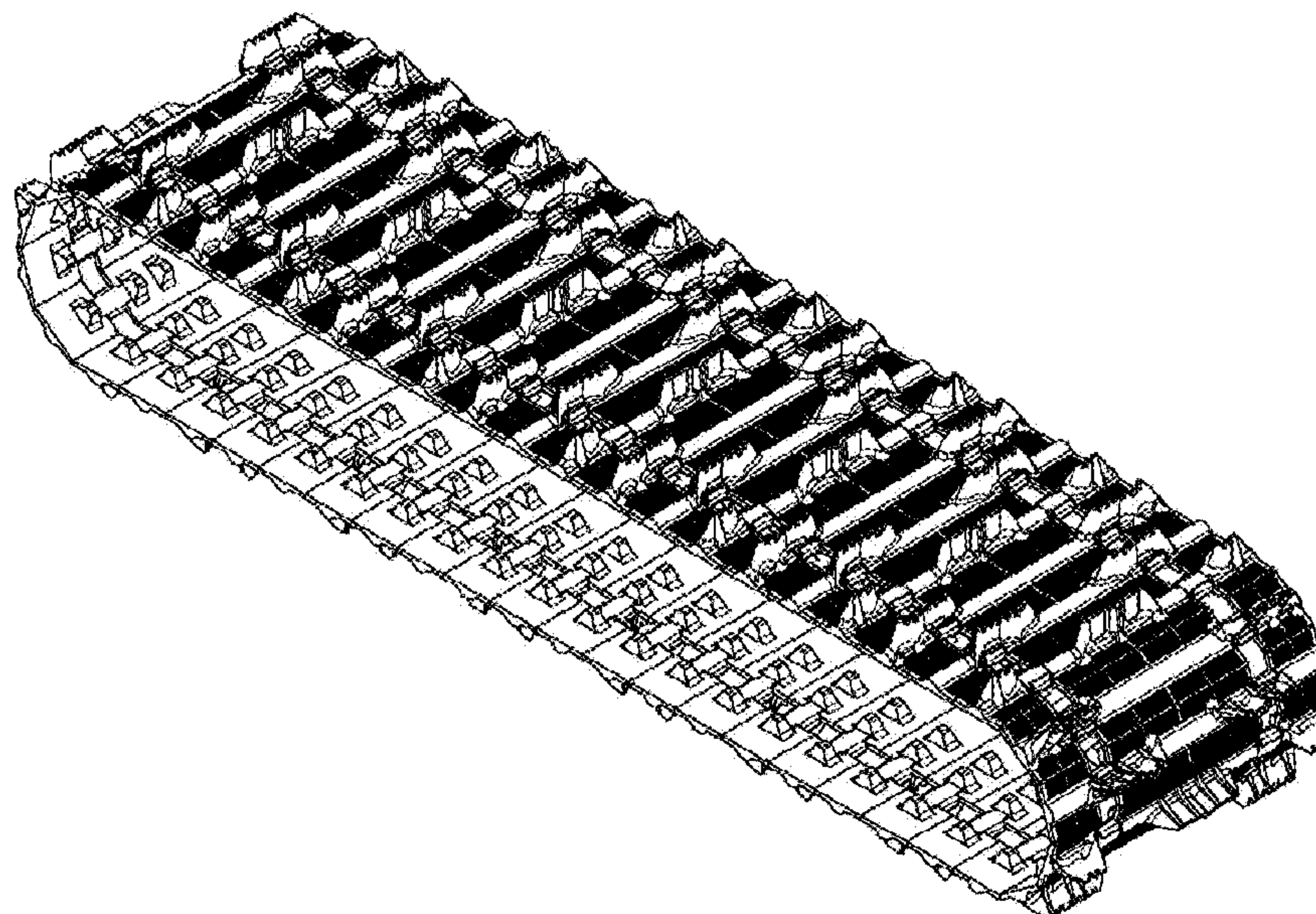
(57) **CLAIM**

The ornamental design for an endless track, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right, front perspective view of an endless track showing my new design therefor;  
FIG. 2 is an enlarged side elevational view of a section thereof;  
FIG. 3 is an enlarged top plan view of a section thereof; and,  
FIG. 4 is an enlarged top plan view of a section of the inside surface of the endless track thereof.

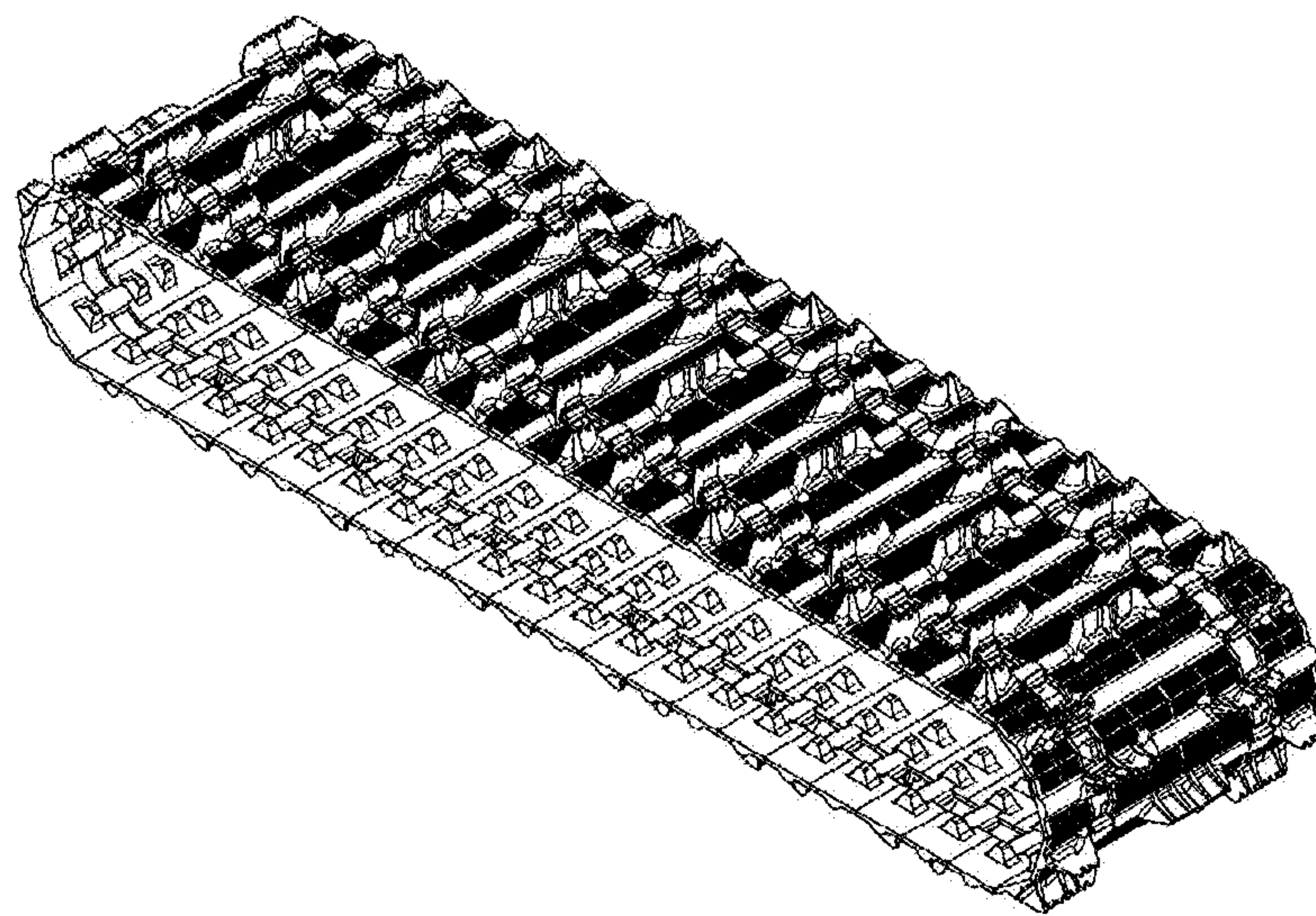

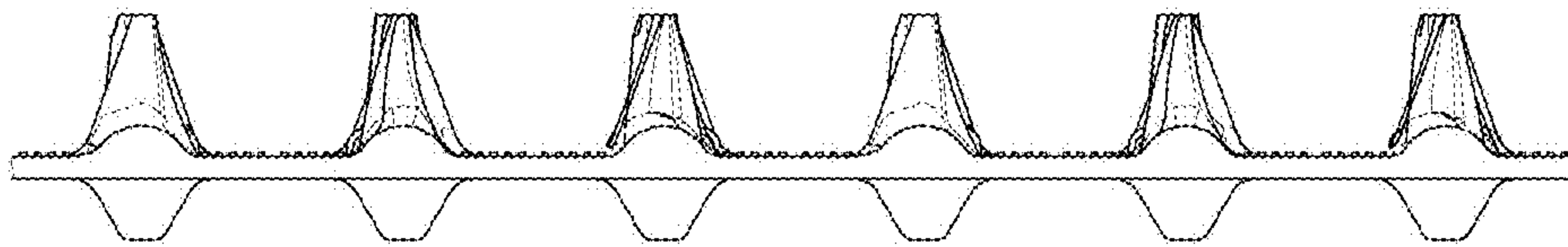

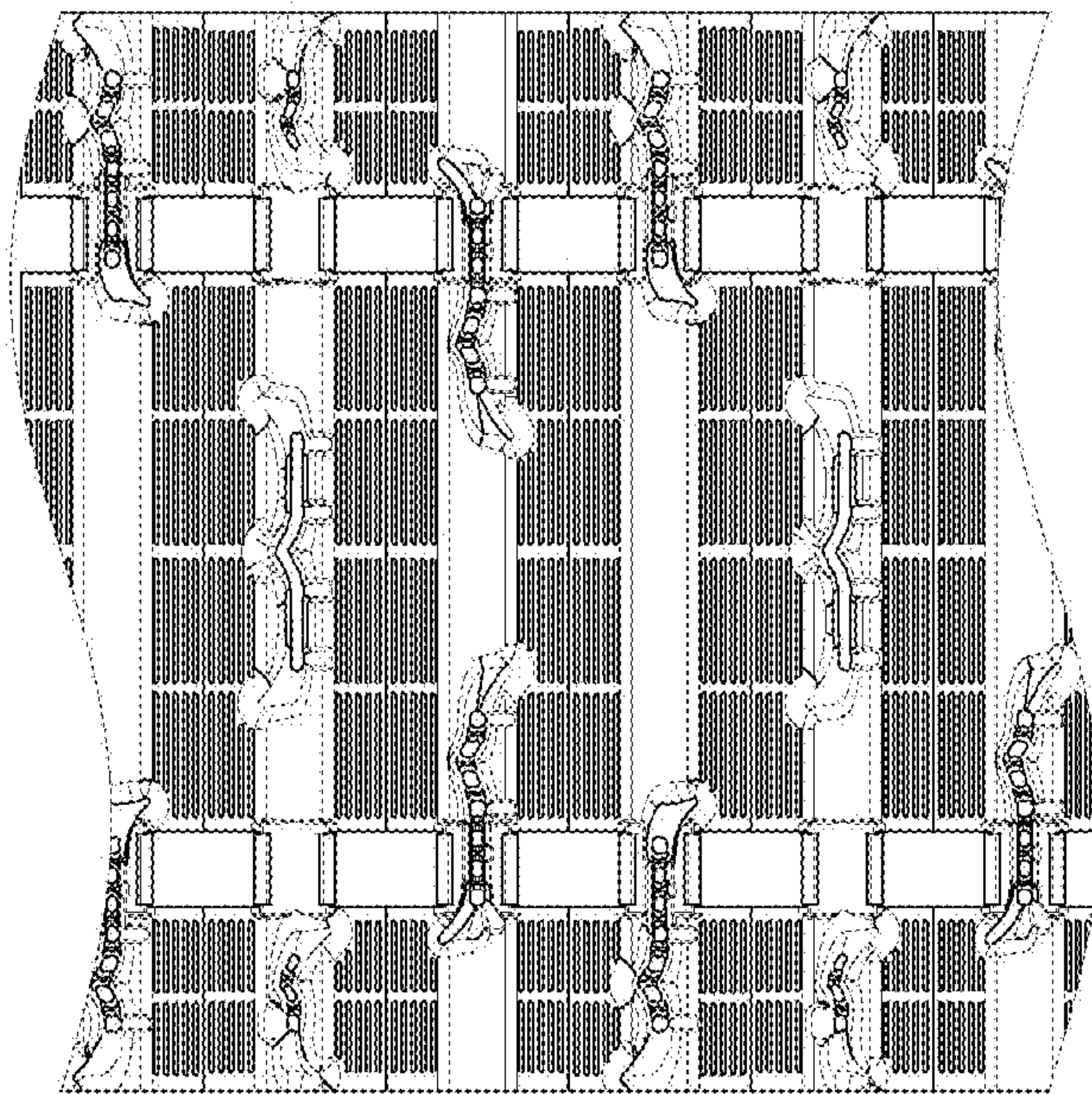

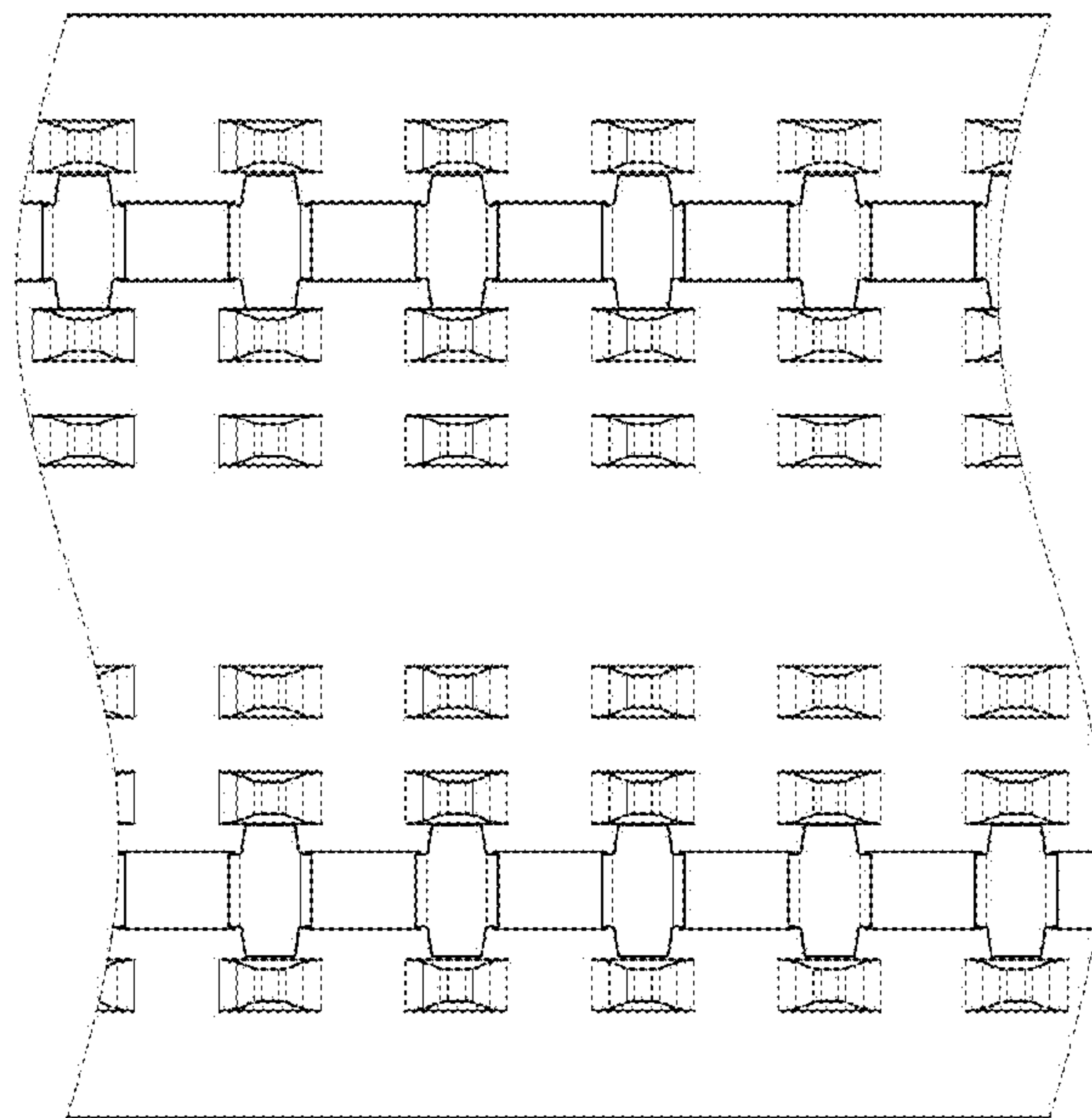
