(57) **CLAIM**

What is claimed is the ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

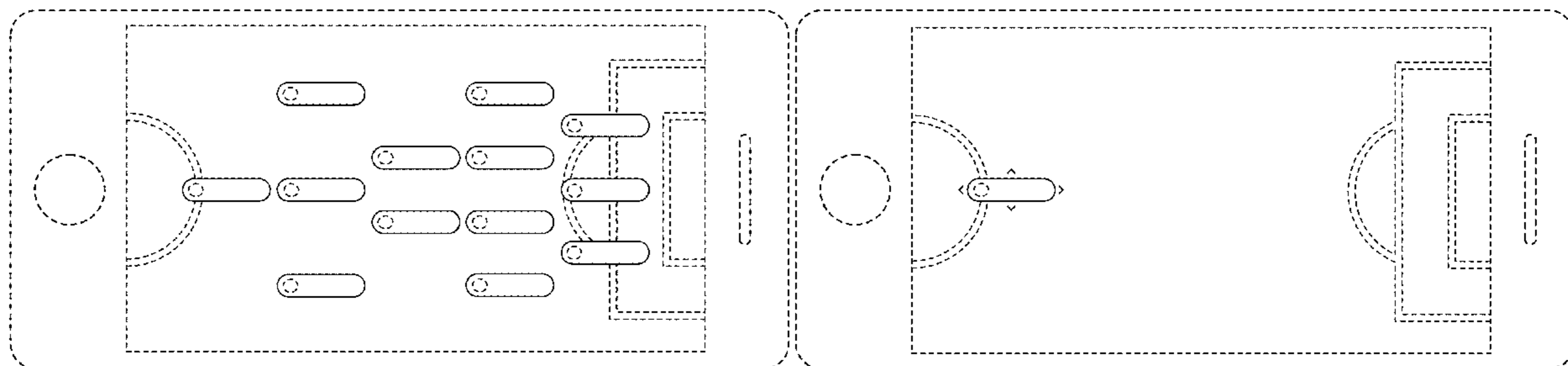
**DESCRIPTION**

FIG. 1 is a front view of a first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design; and, FIG. 2 is a front view of a second image thereof.

The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another forms no part of the claimed design.

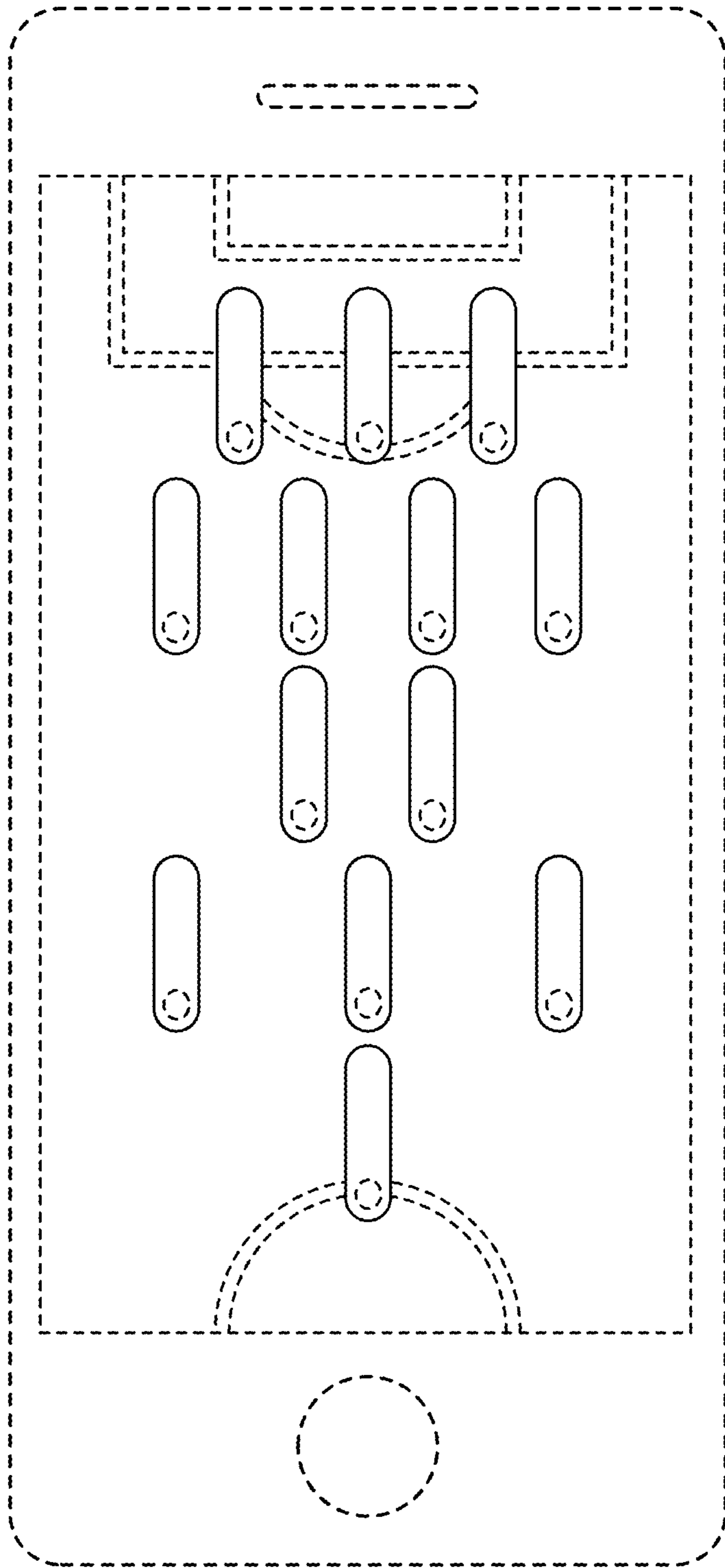

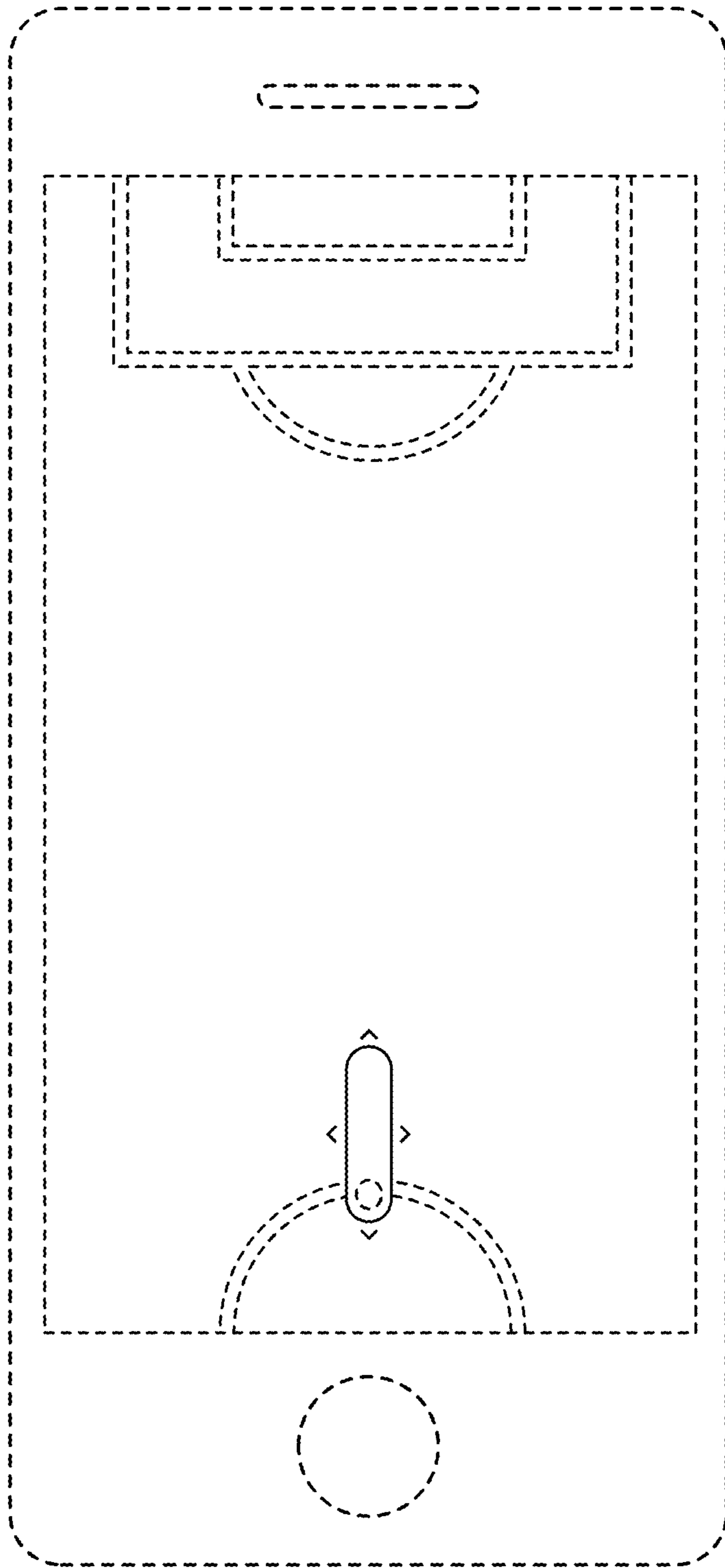
