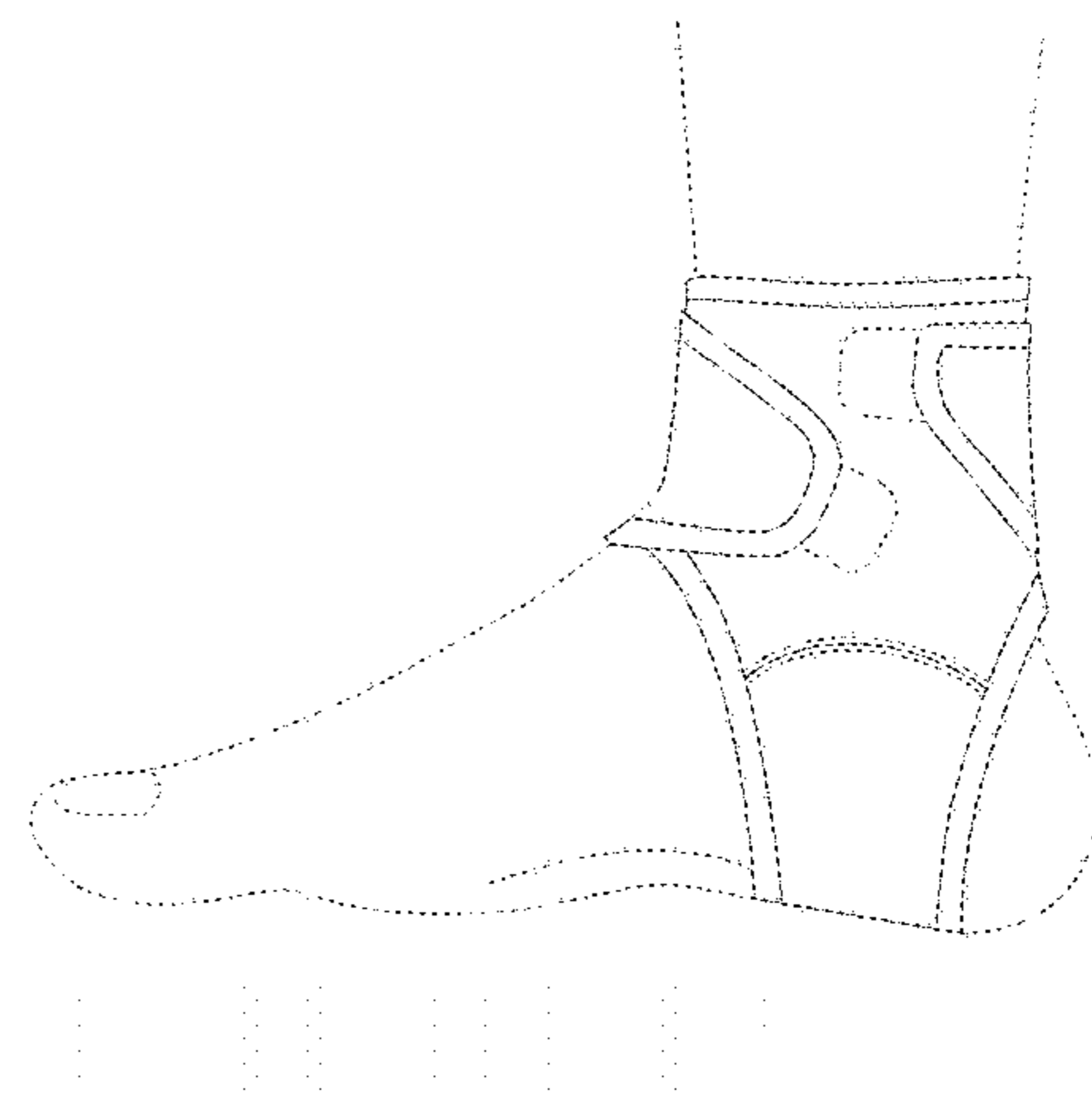
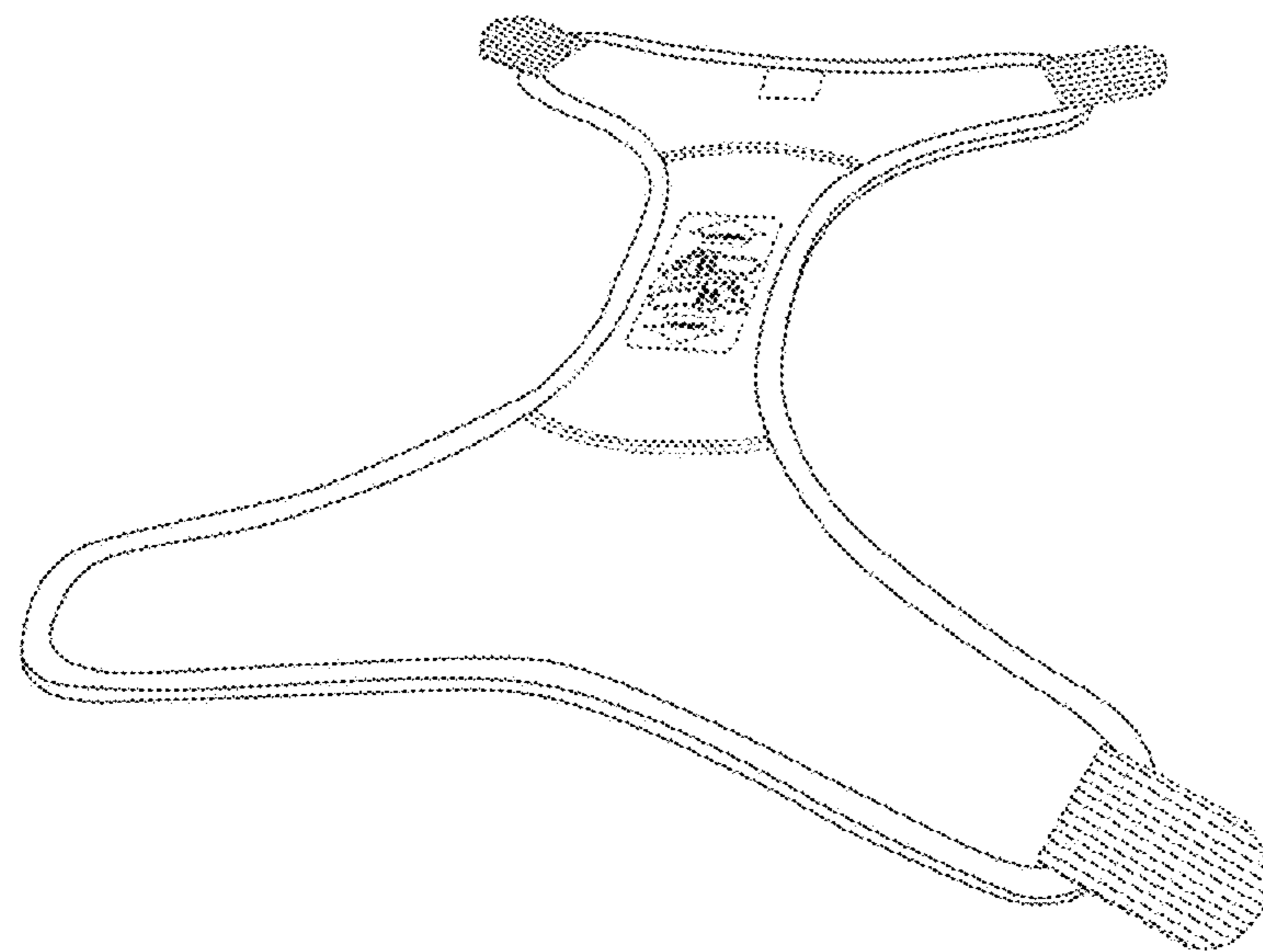
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the inner side of a reversible ankle support showing my new design;
 FIG. 2 is a perspective view of the outer side thereof;

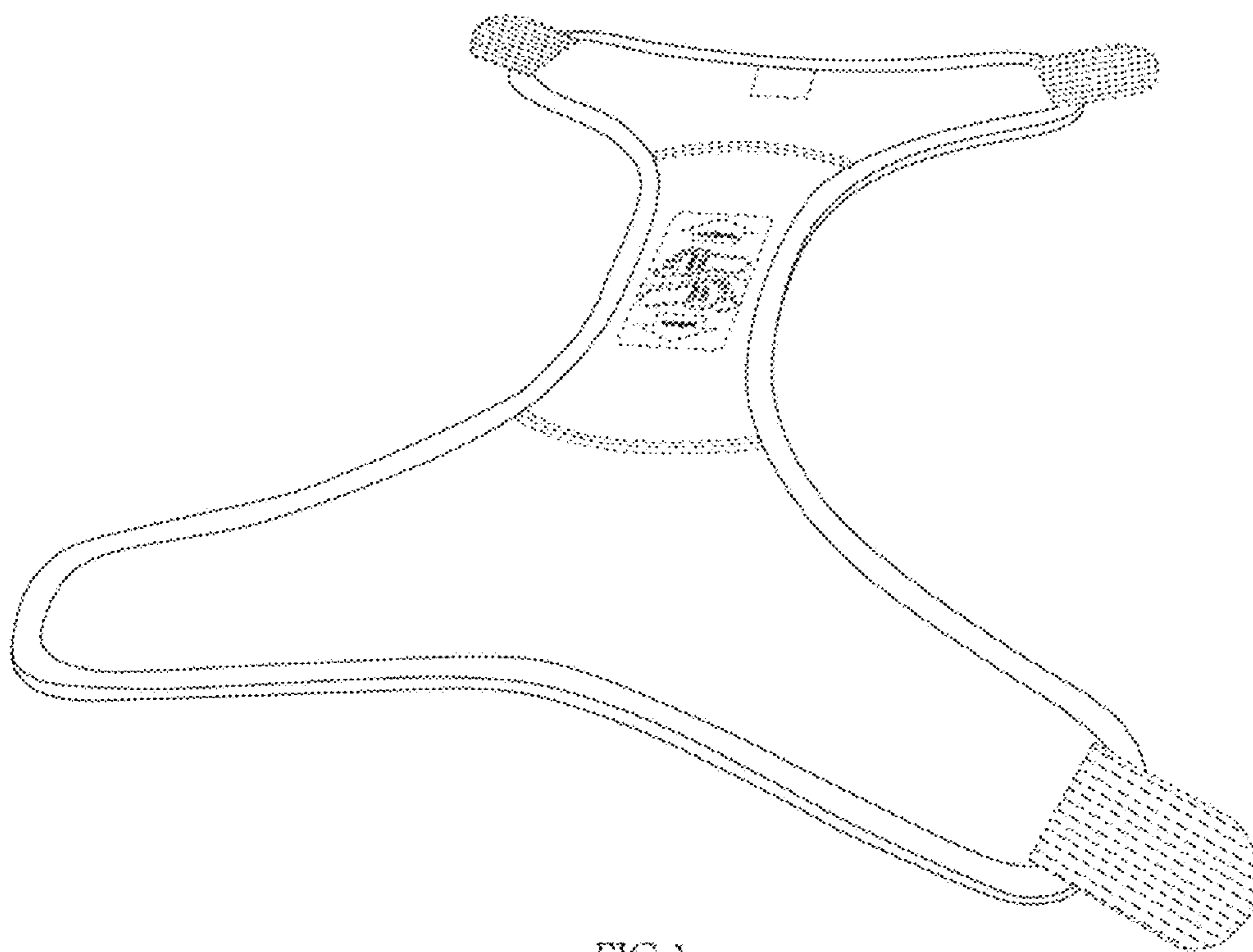

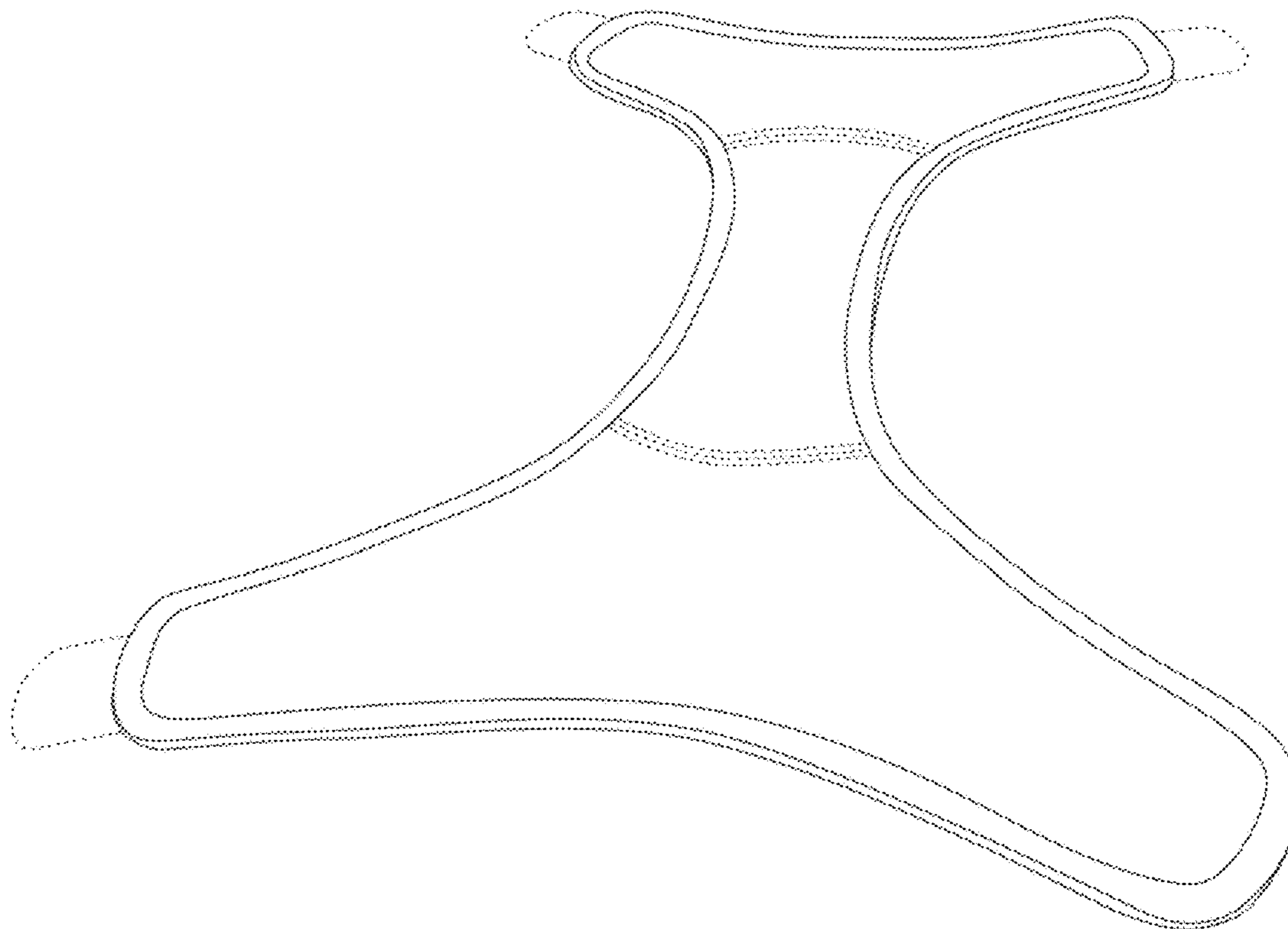

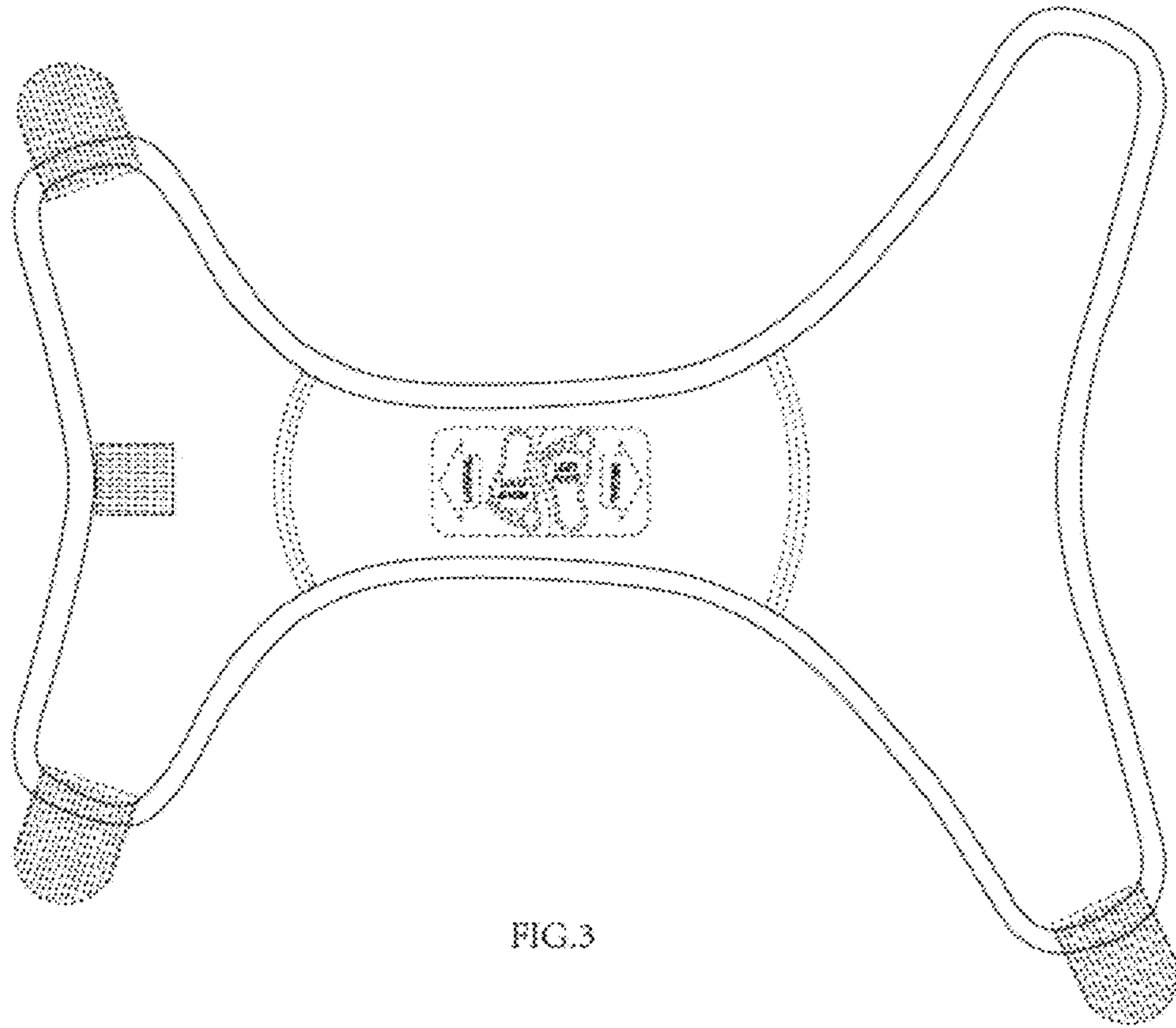

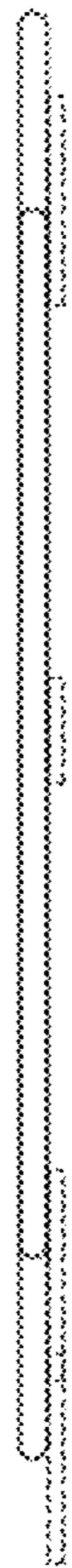

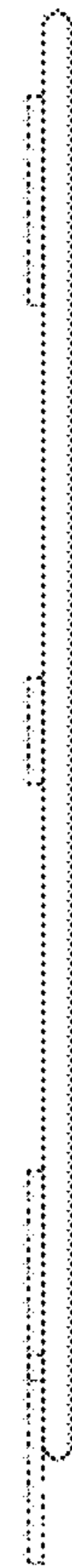

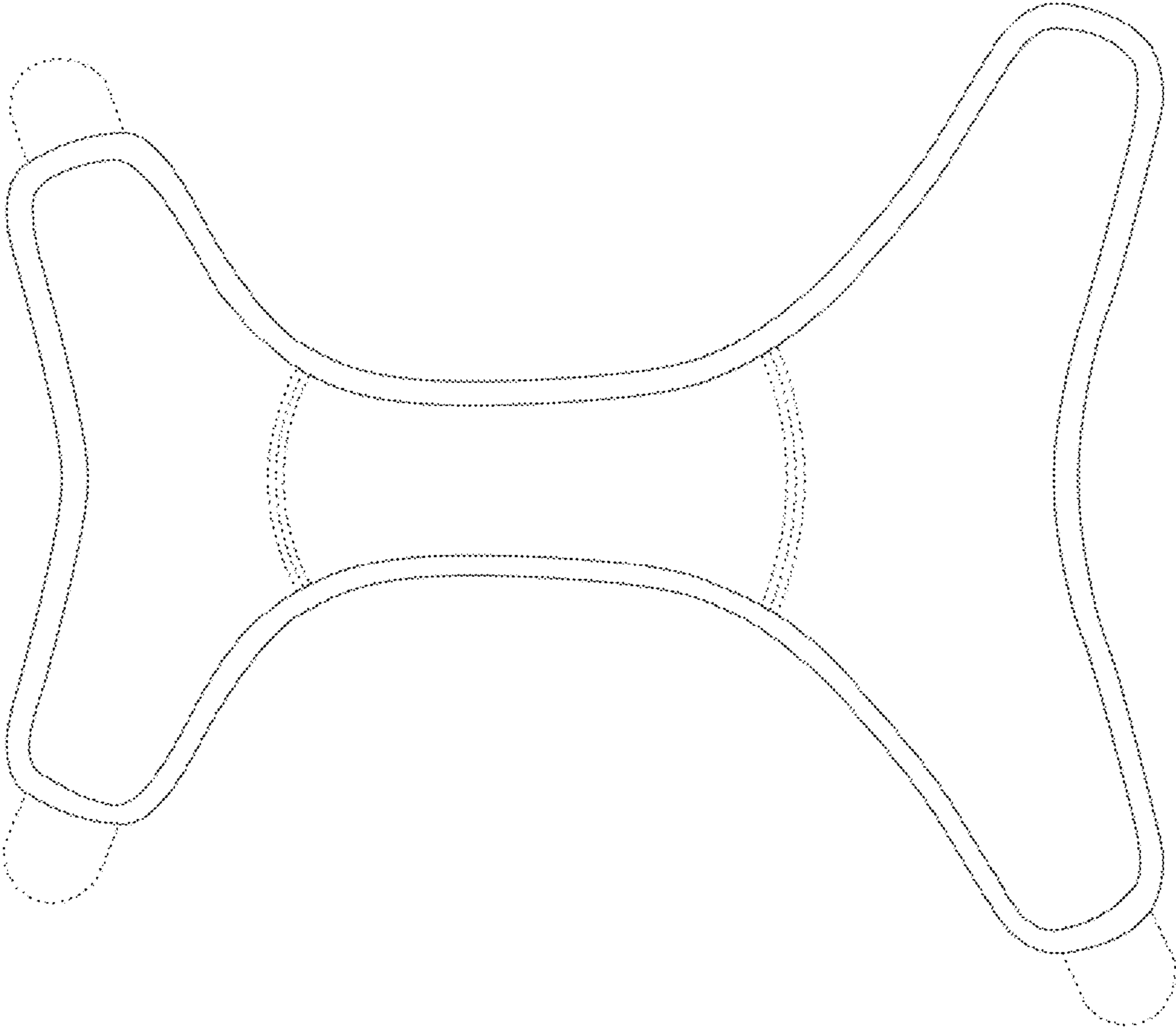

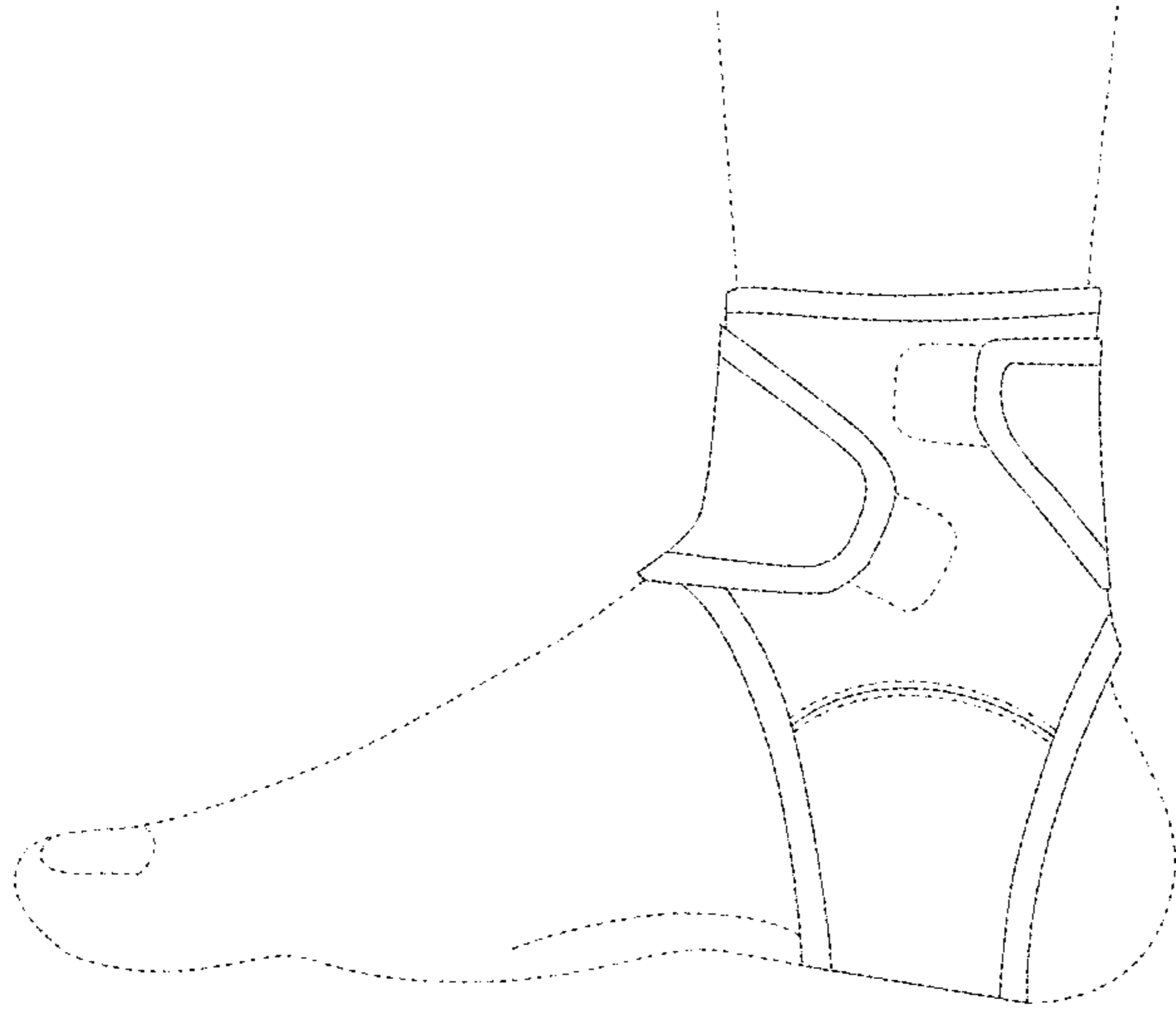

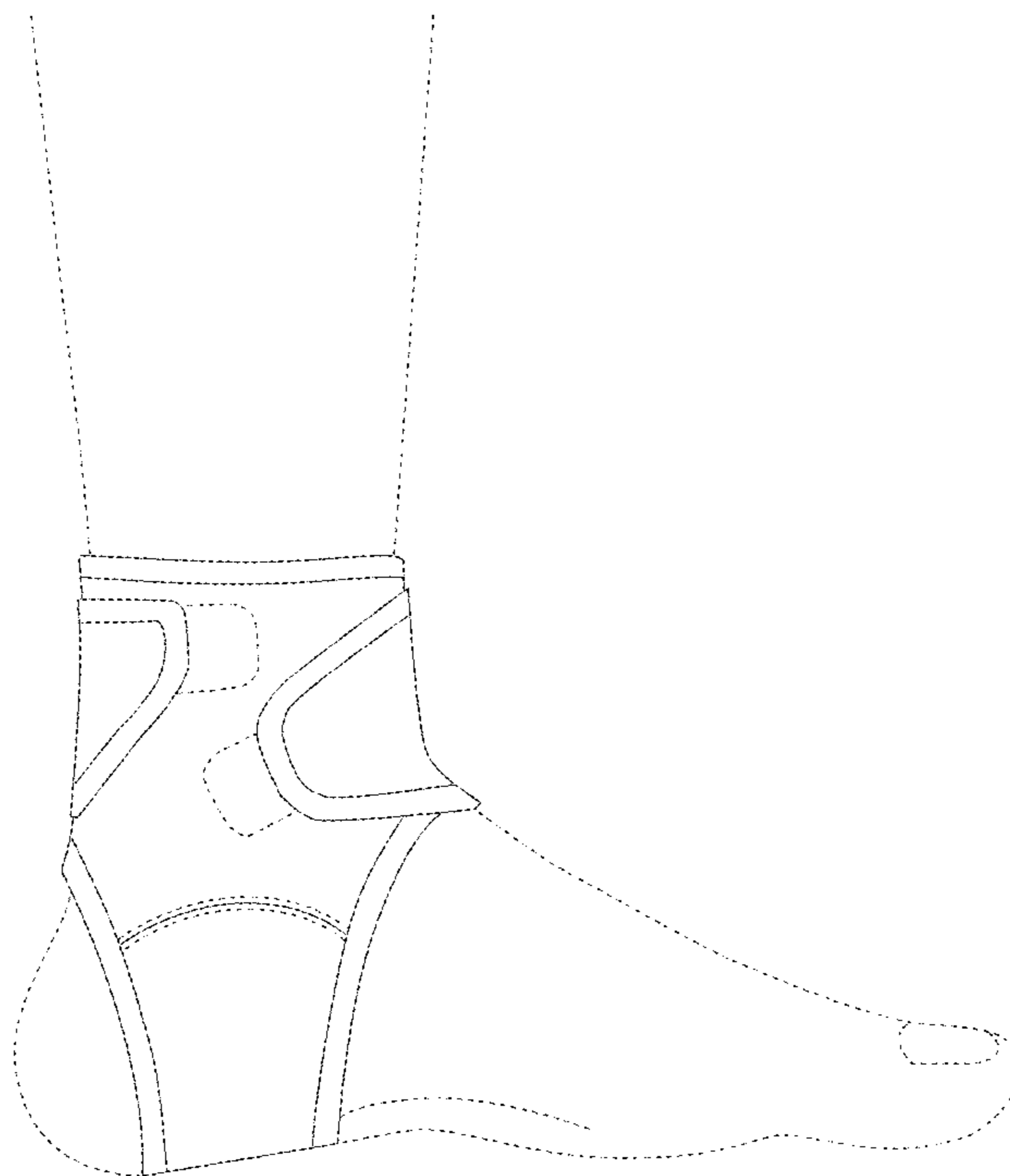
