The broken lines shown in FIGS. 1.3 and 1.4 illustrate portions of the transportable modular dwelling that form no part of the claimed design.

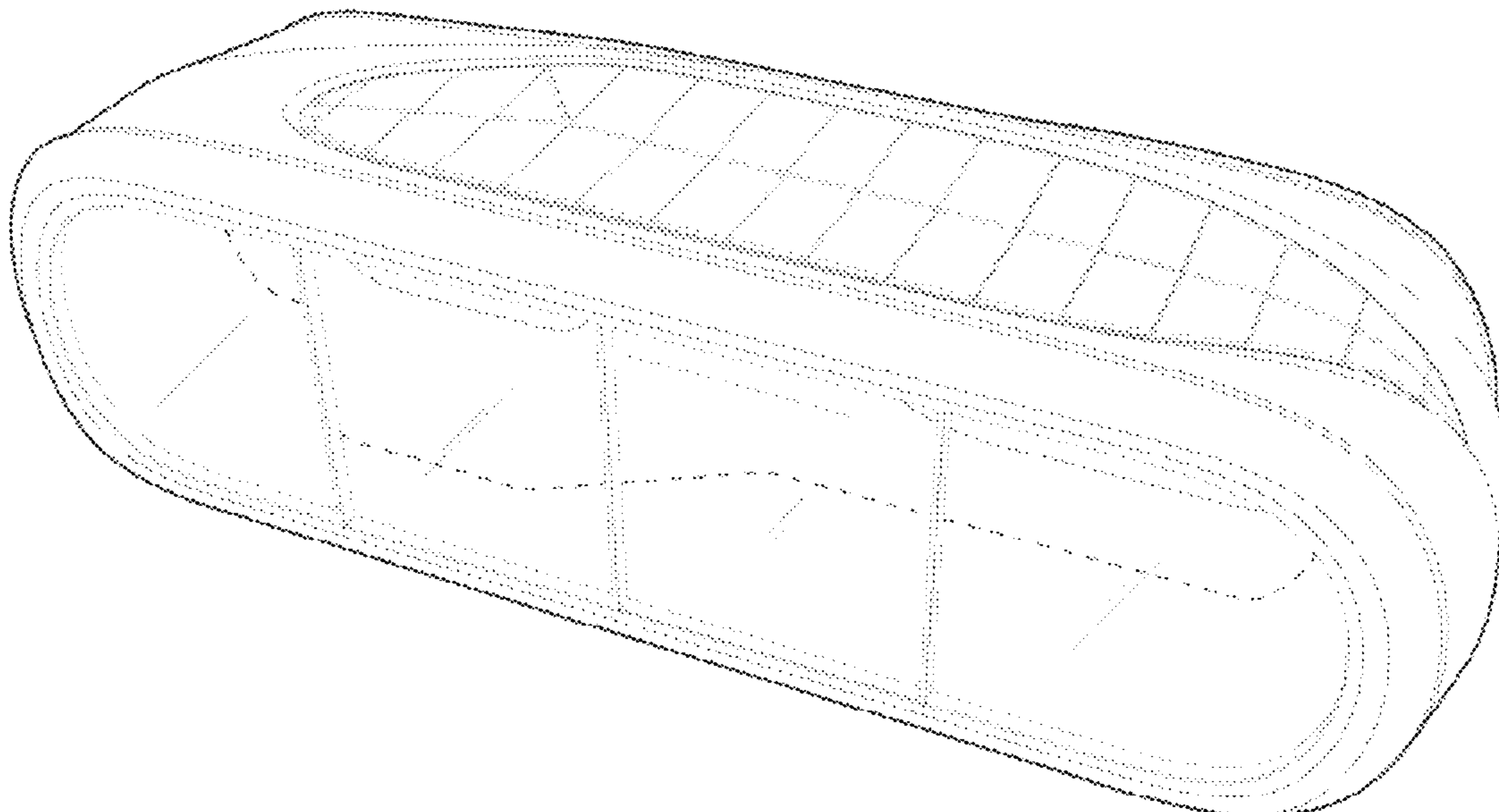

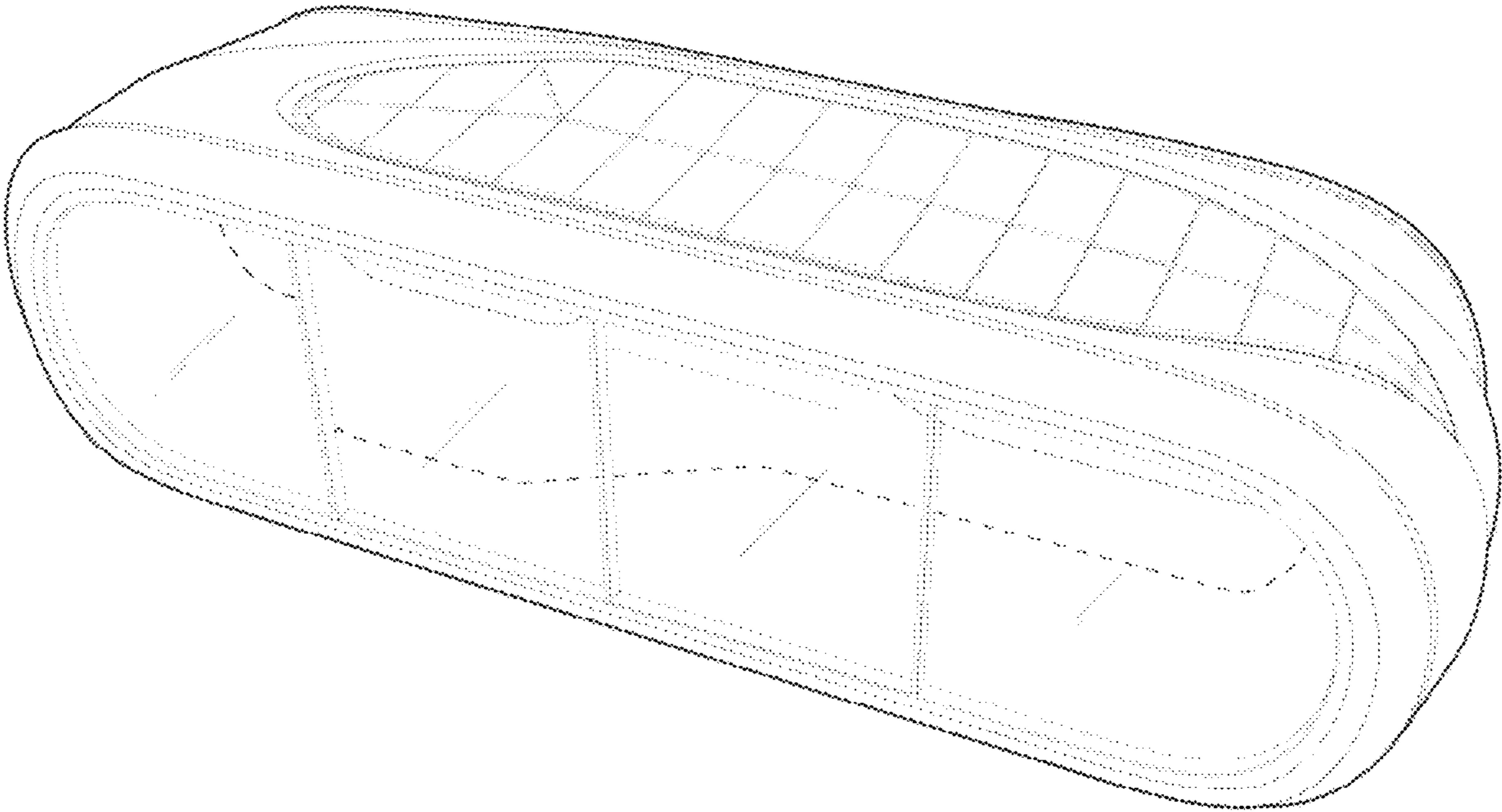

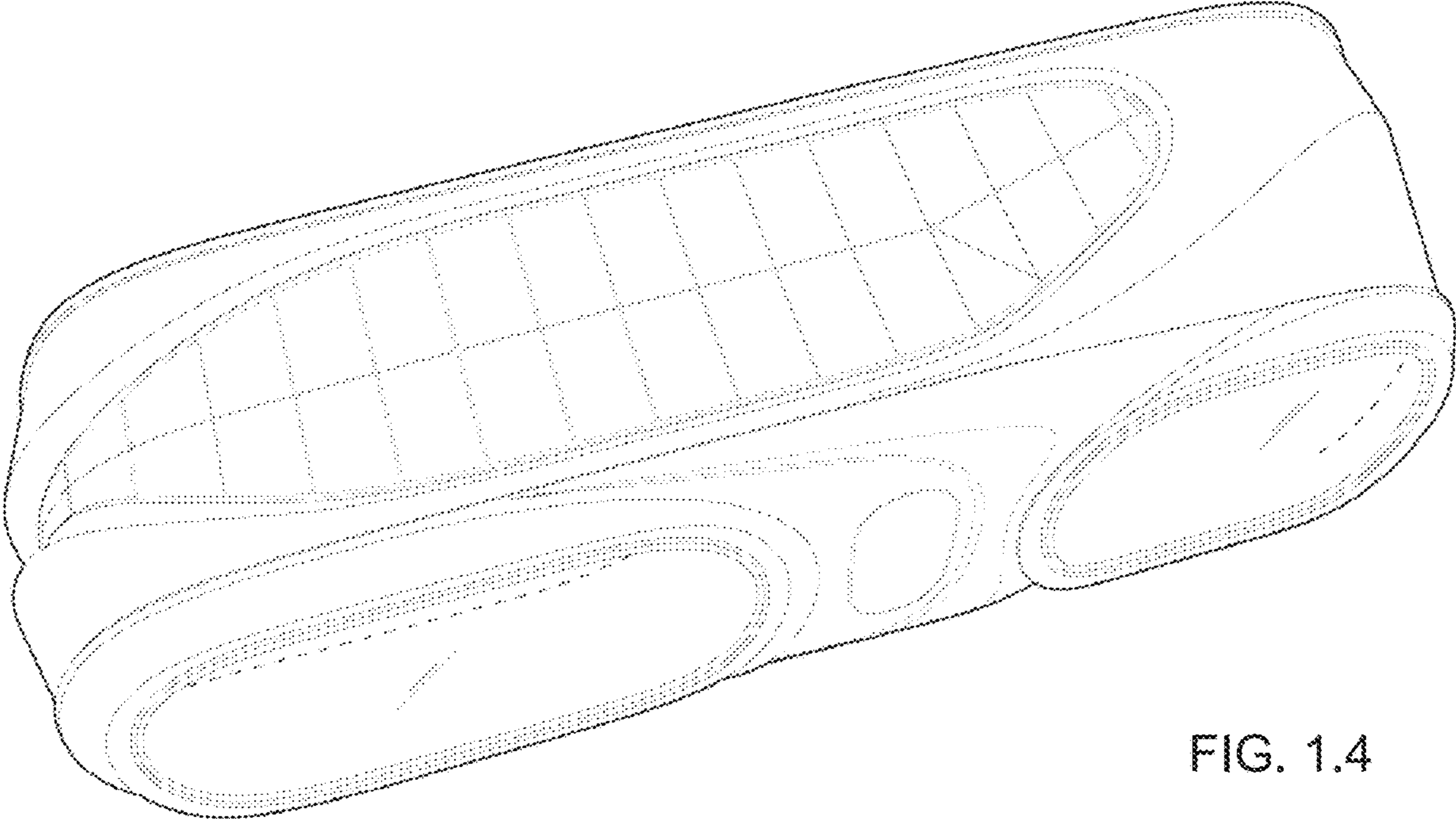

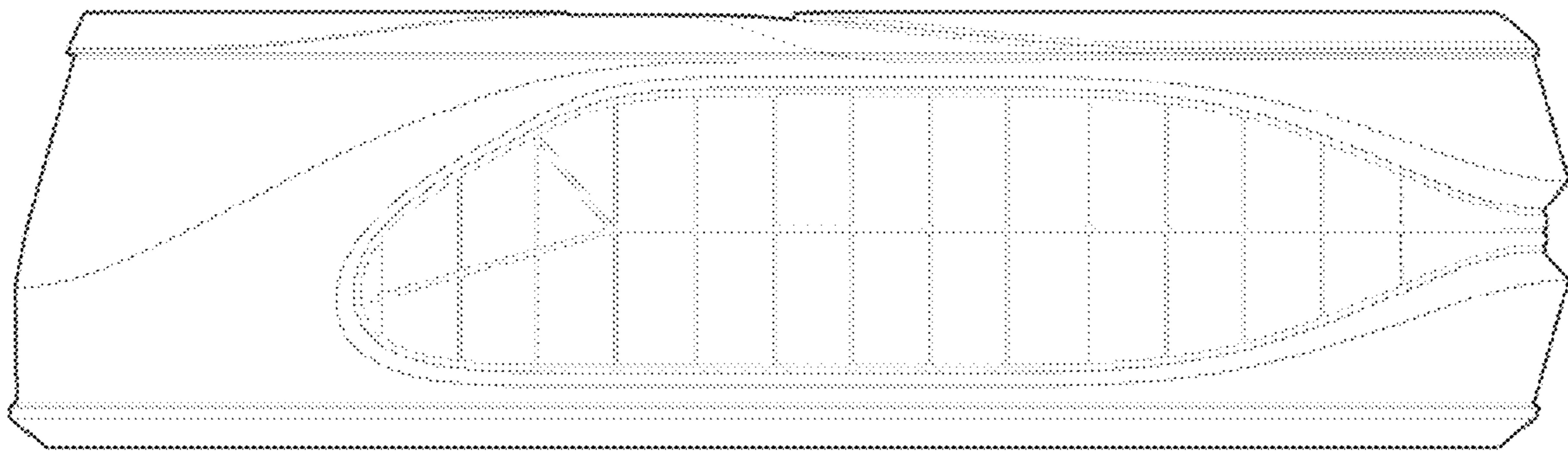

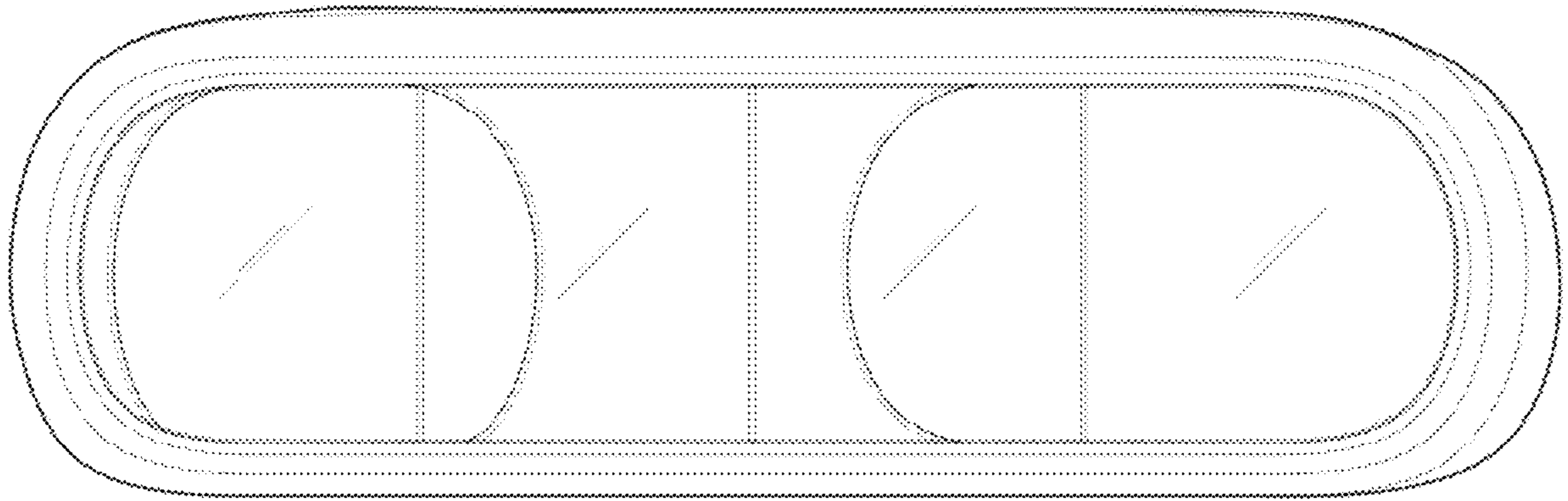

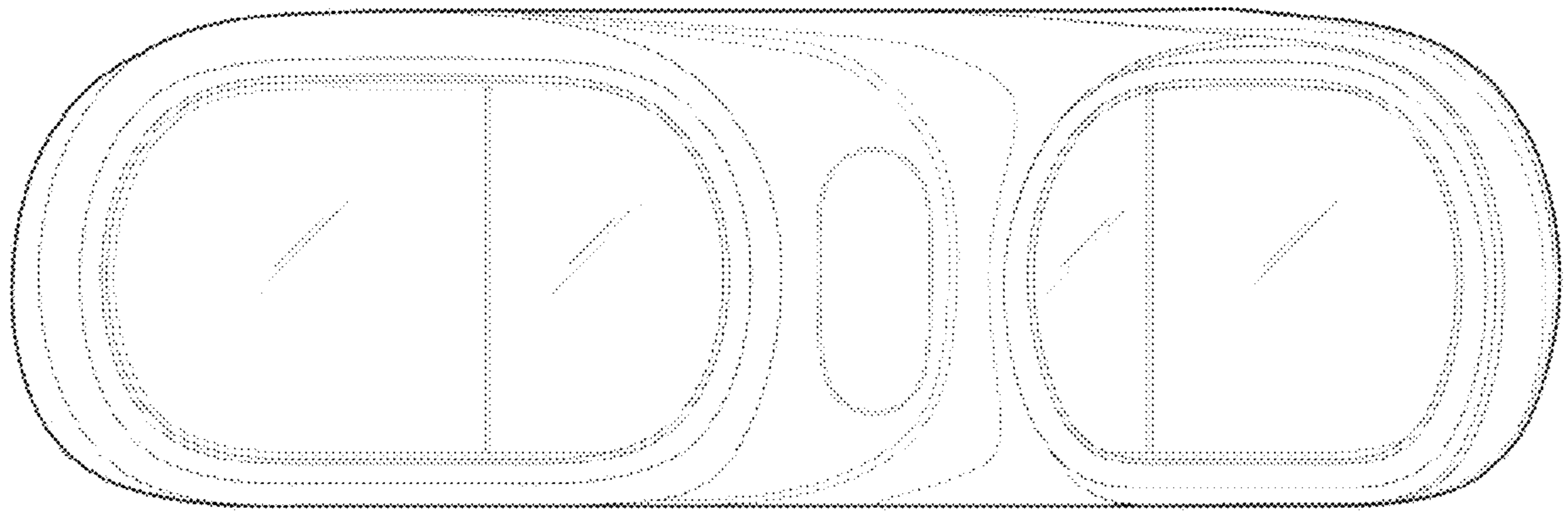

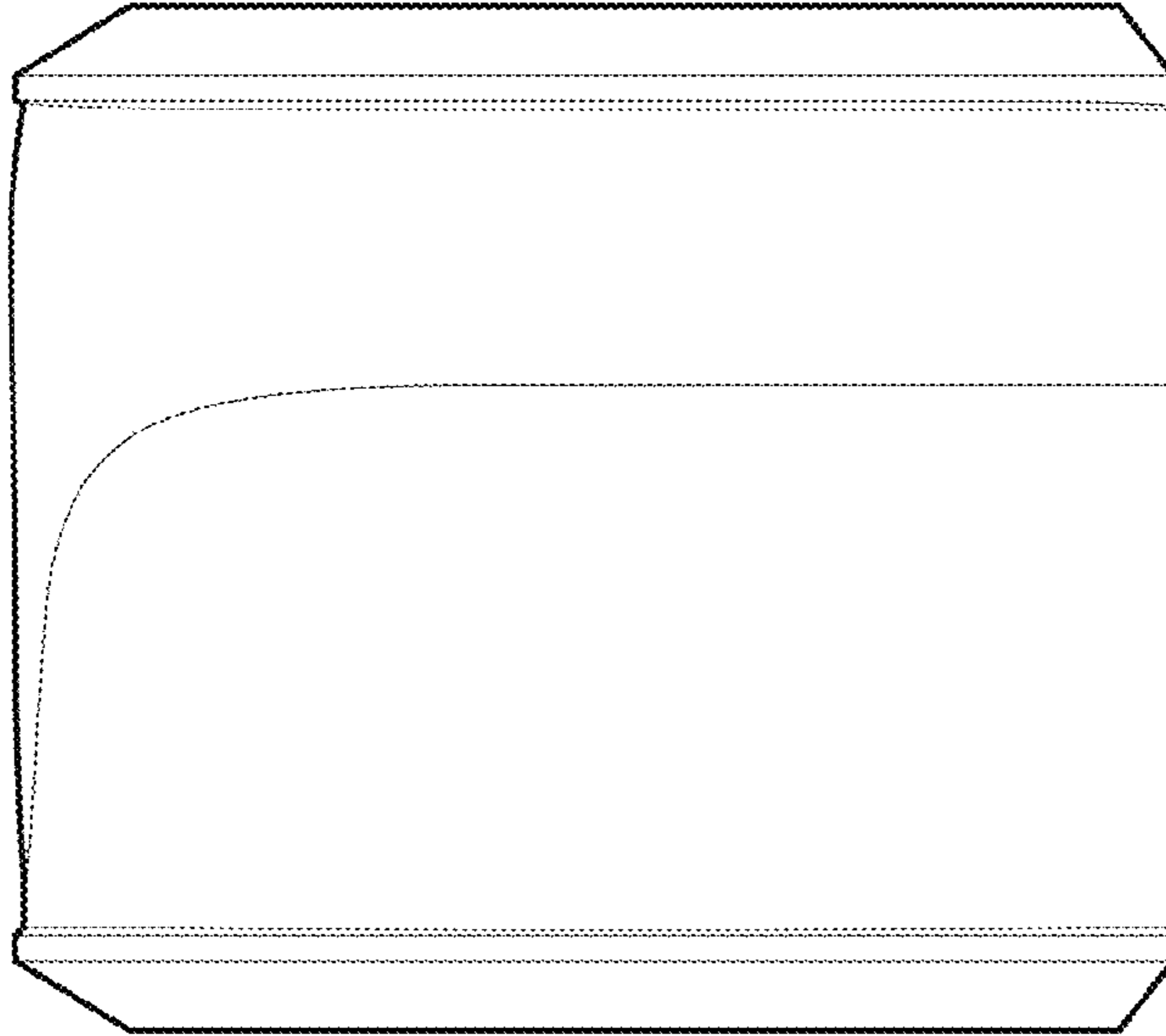

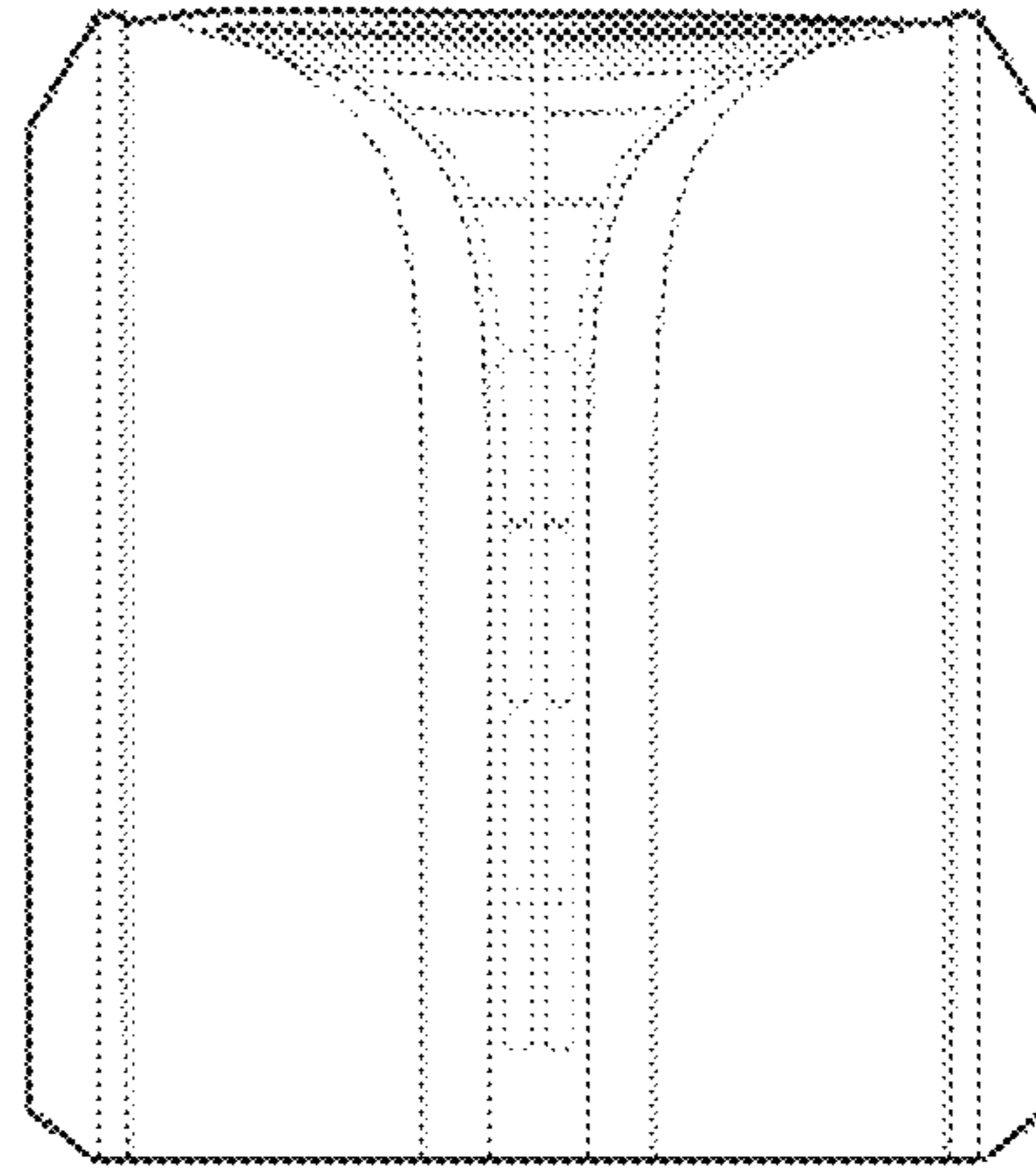
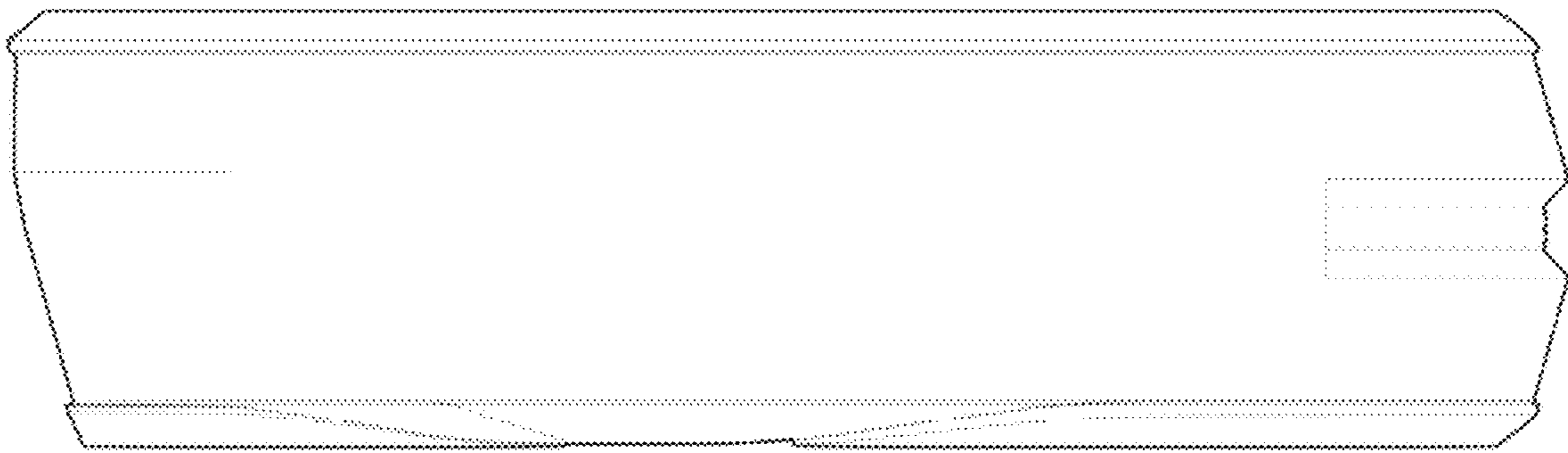
