**DESCRIPTION**

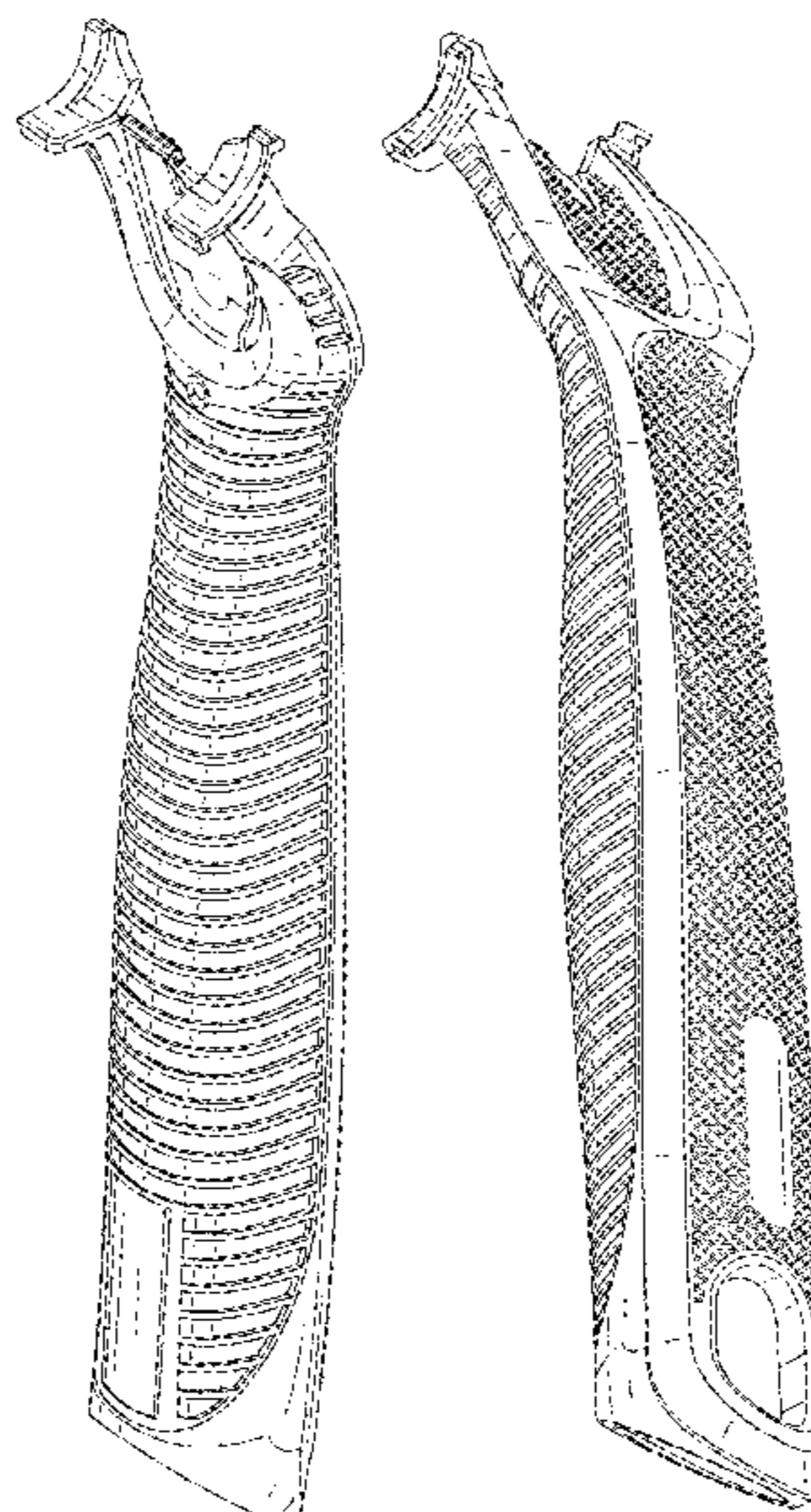
FIG. 1 is a front perspective view of a design of a razor handle of the present invention;

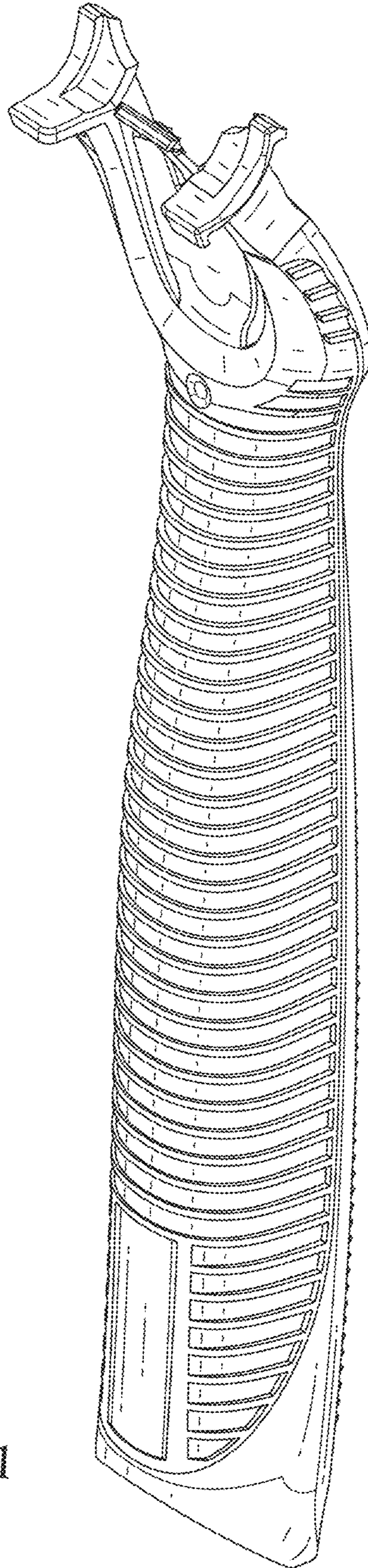

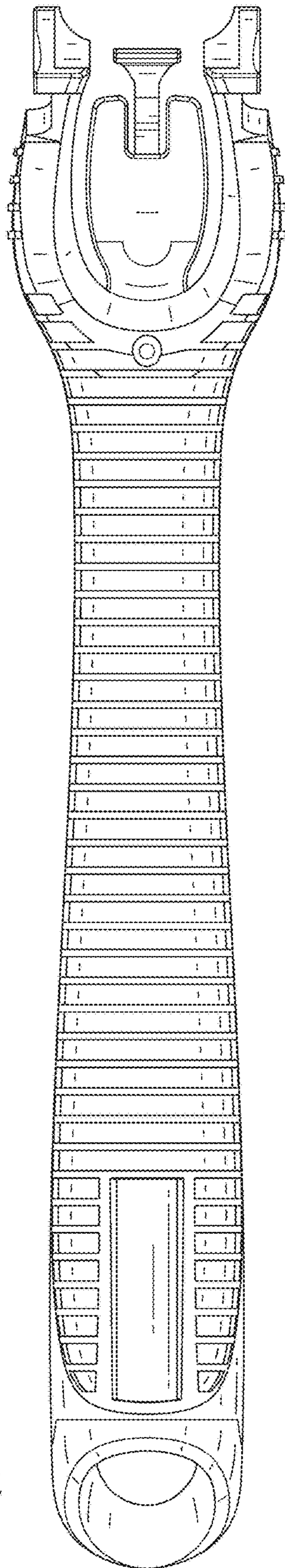

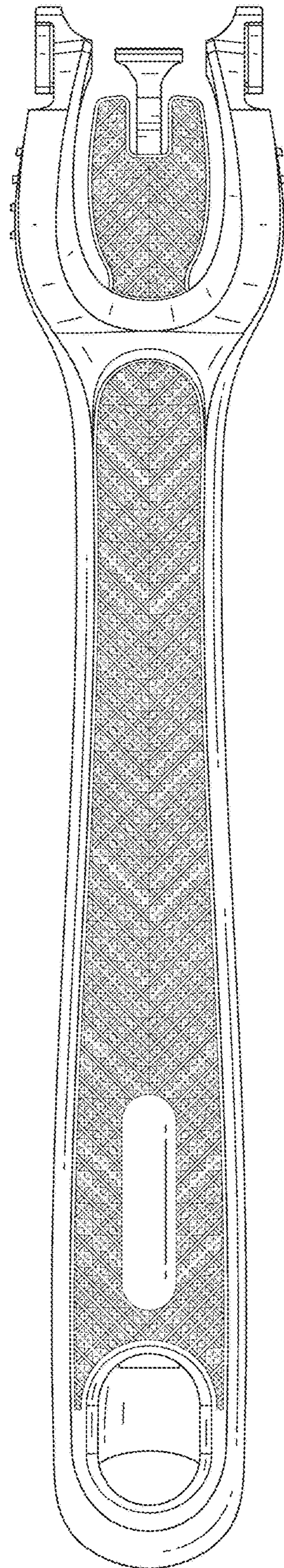

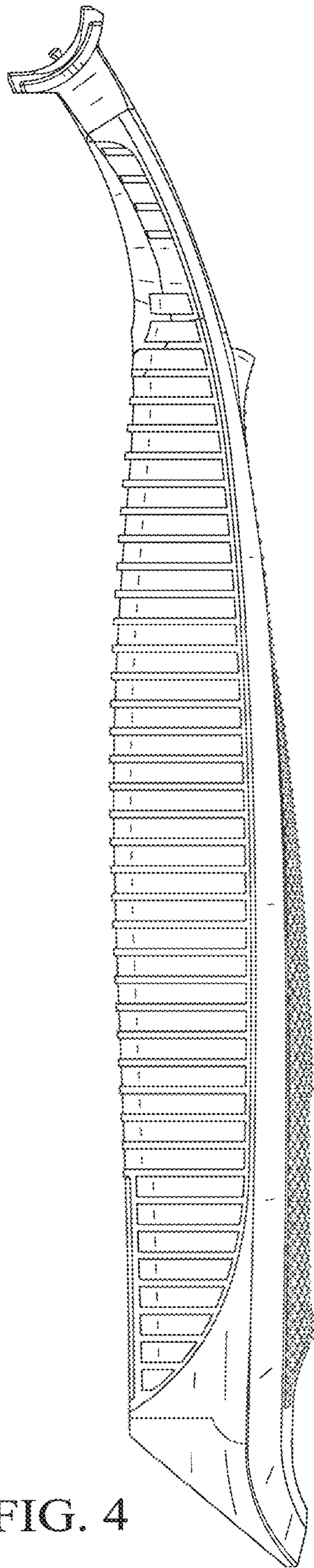

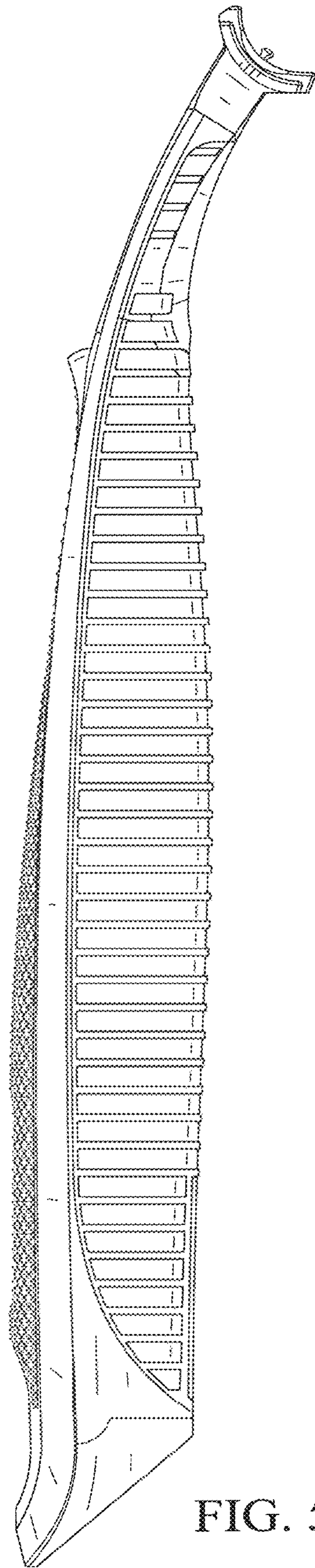

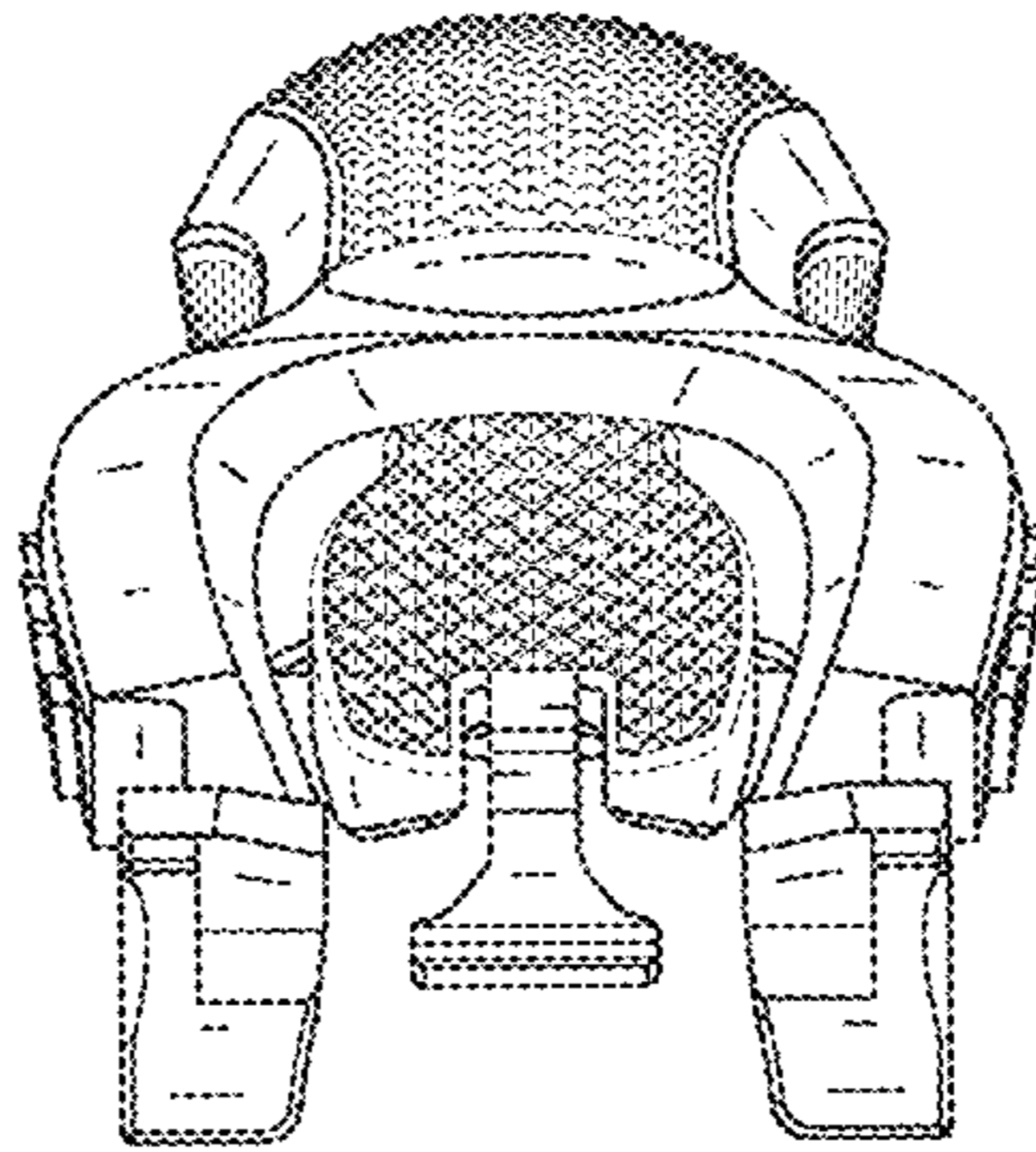

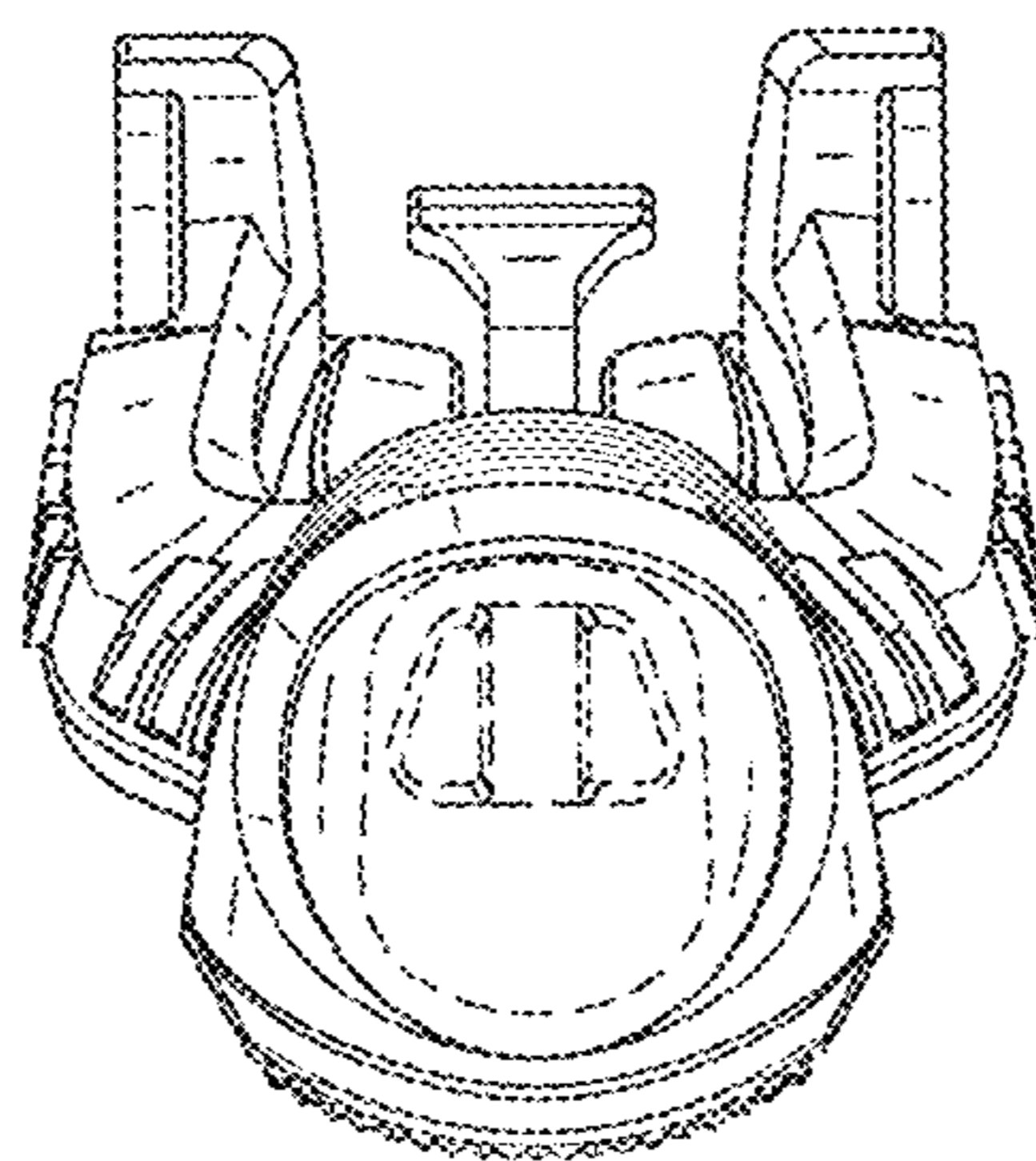

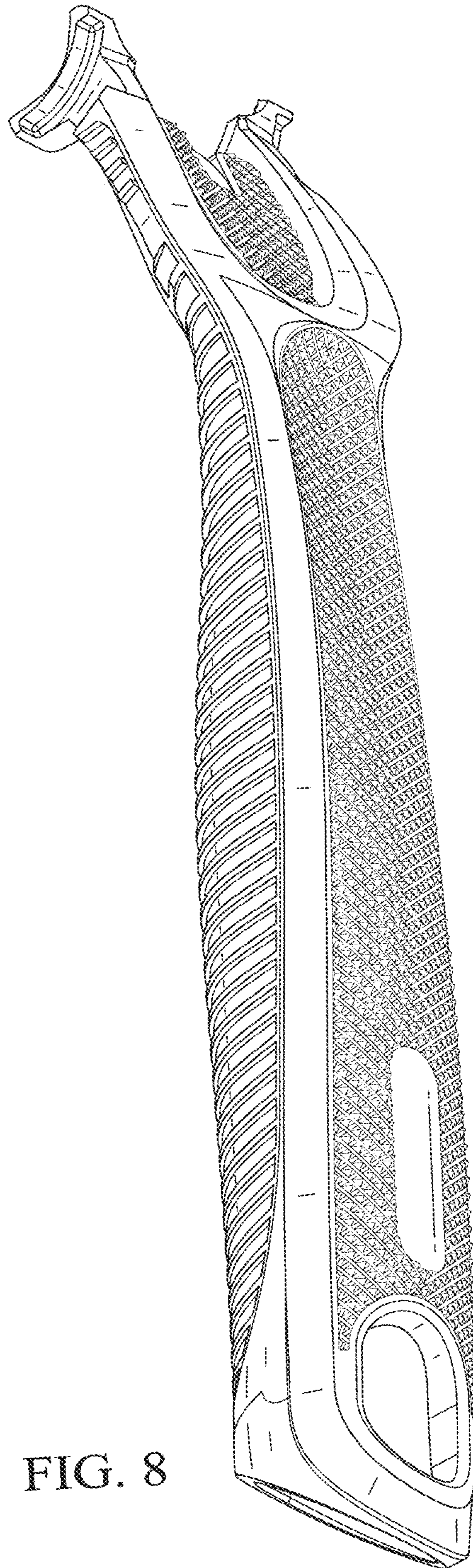

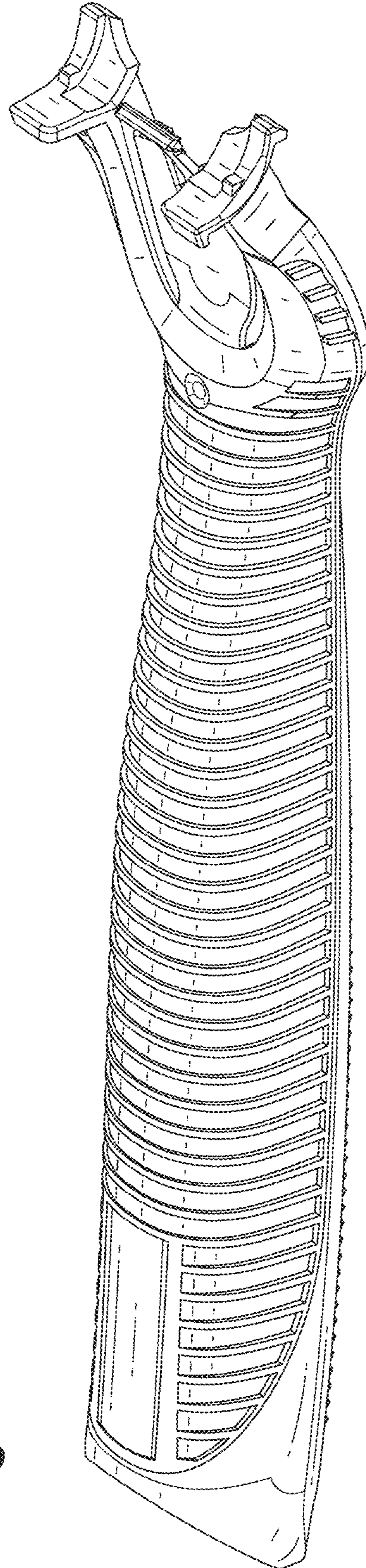

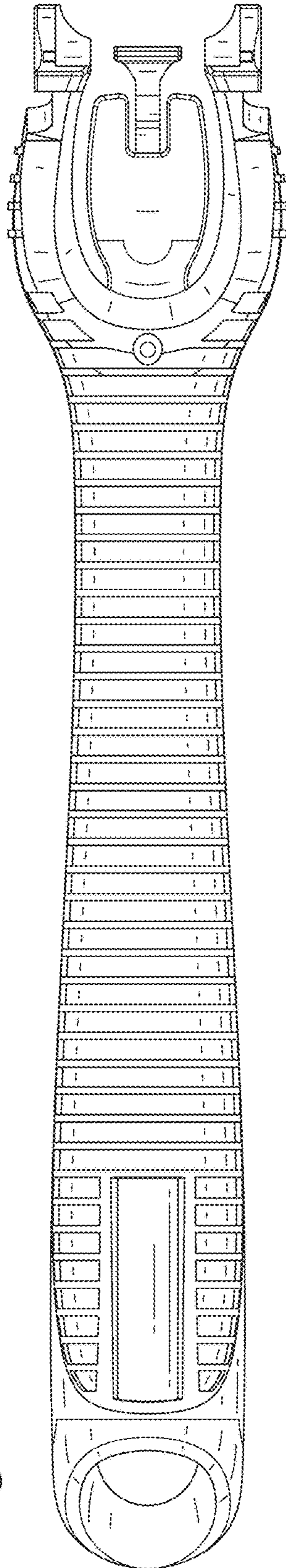

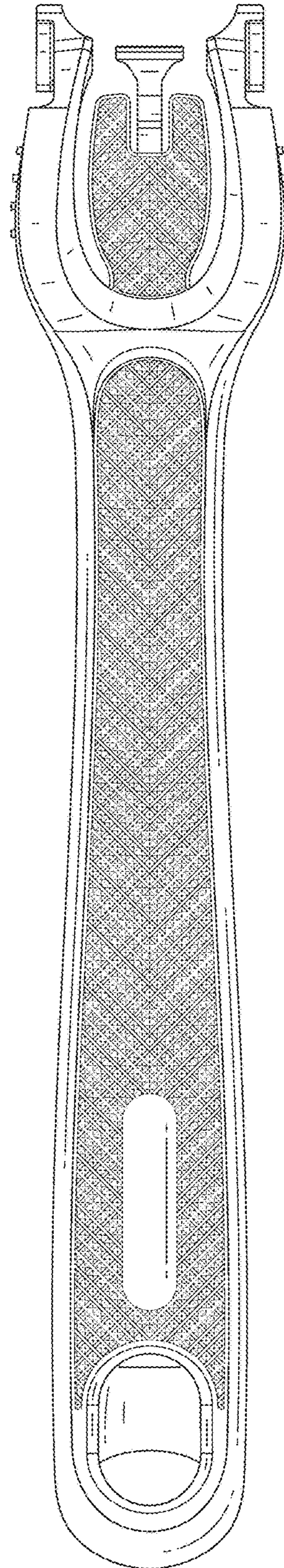

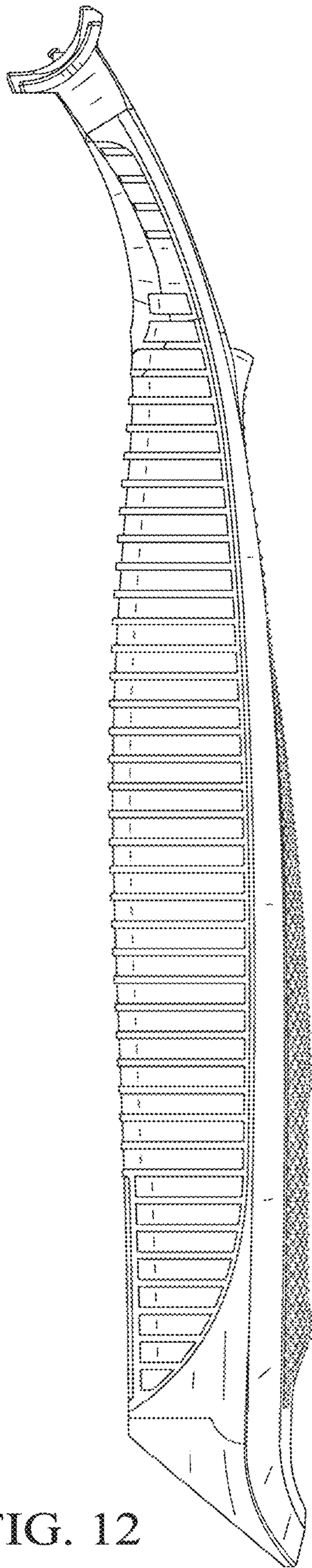

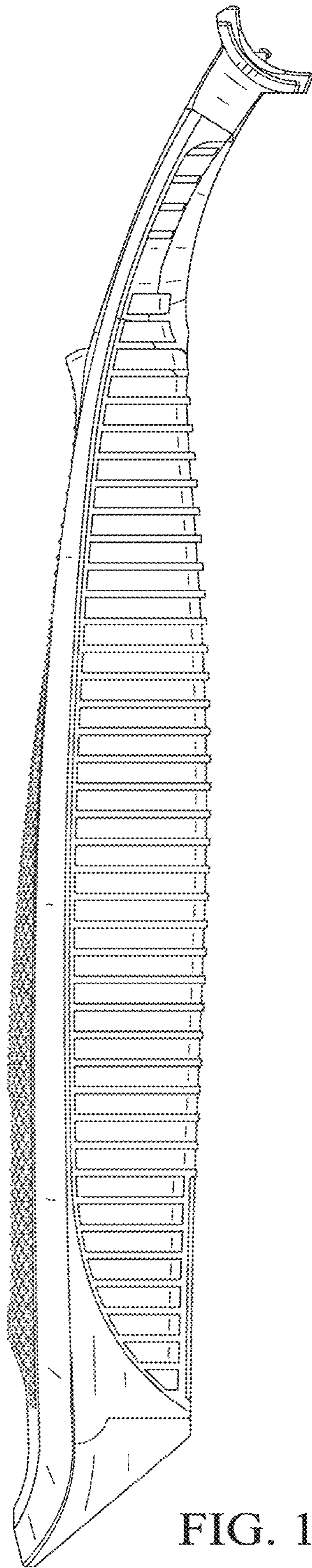

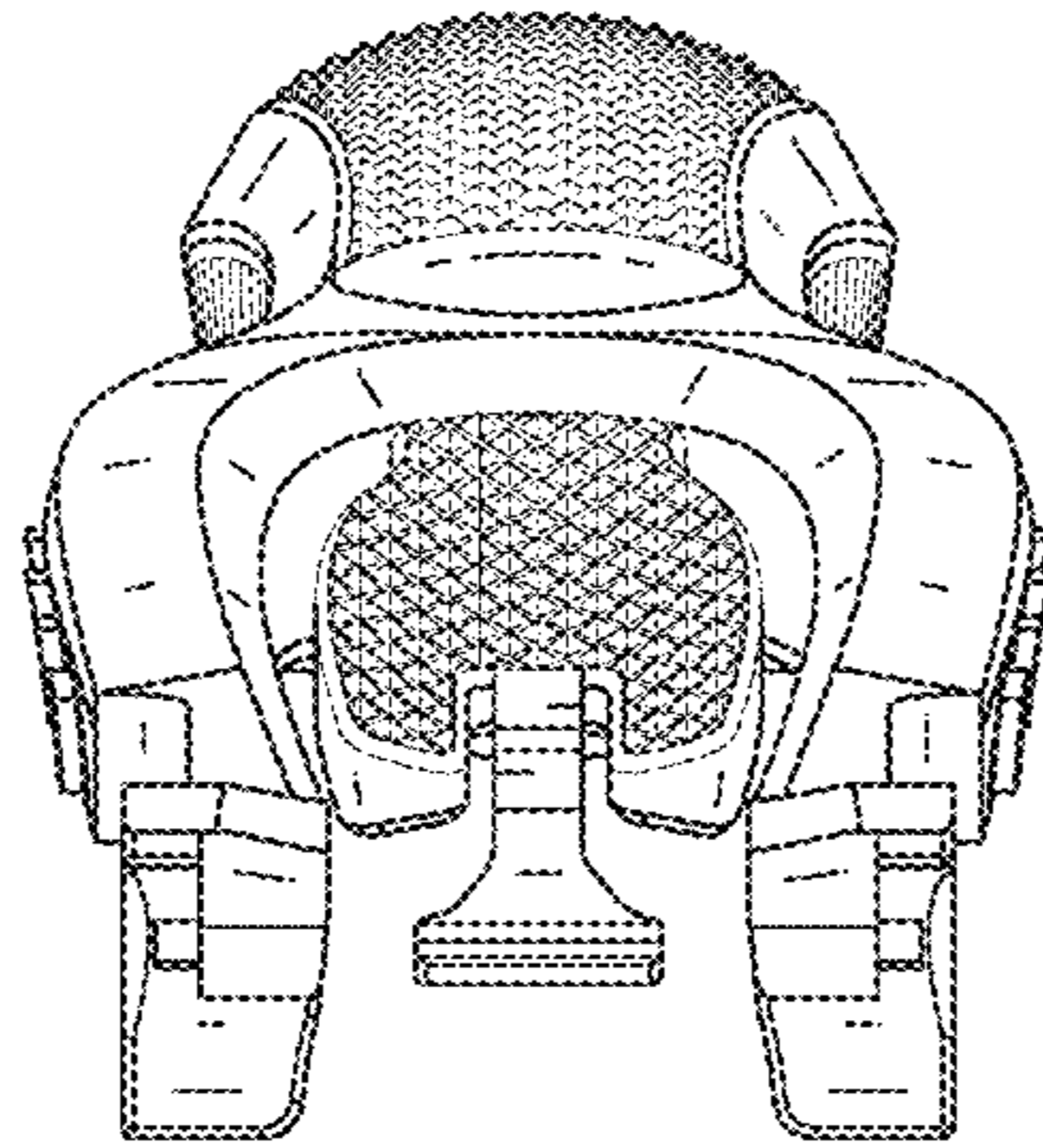

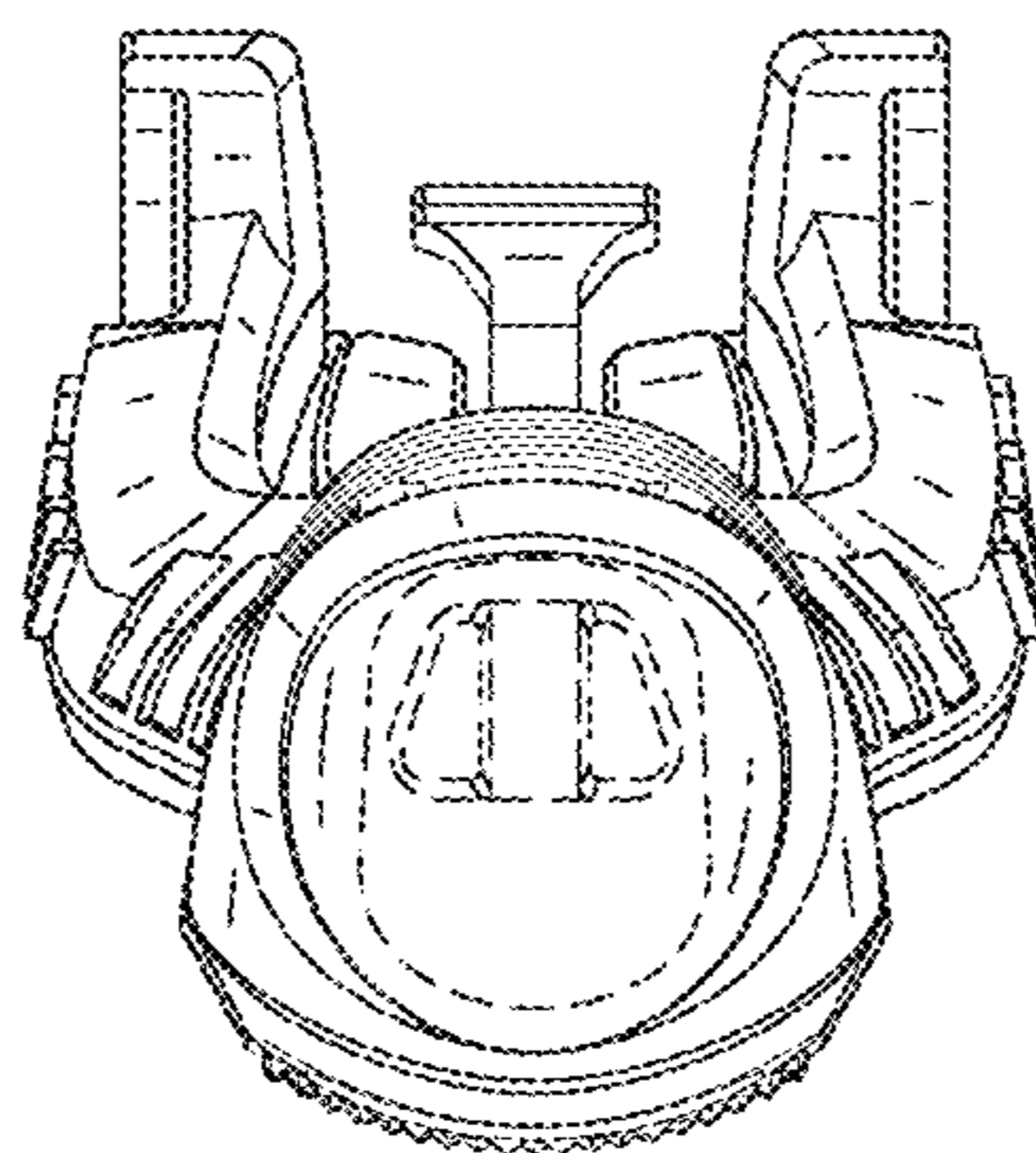

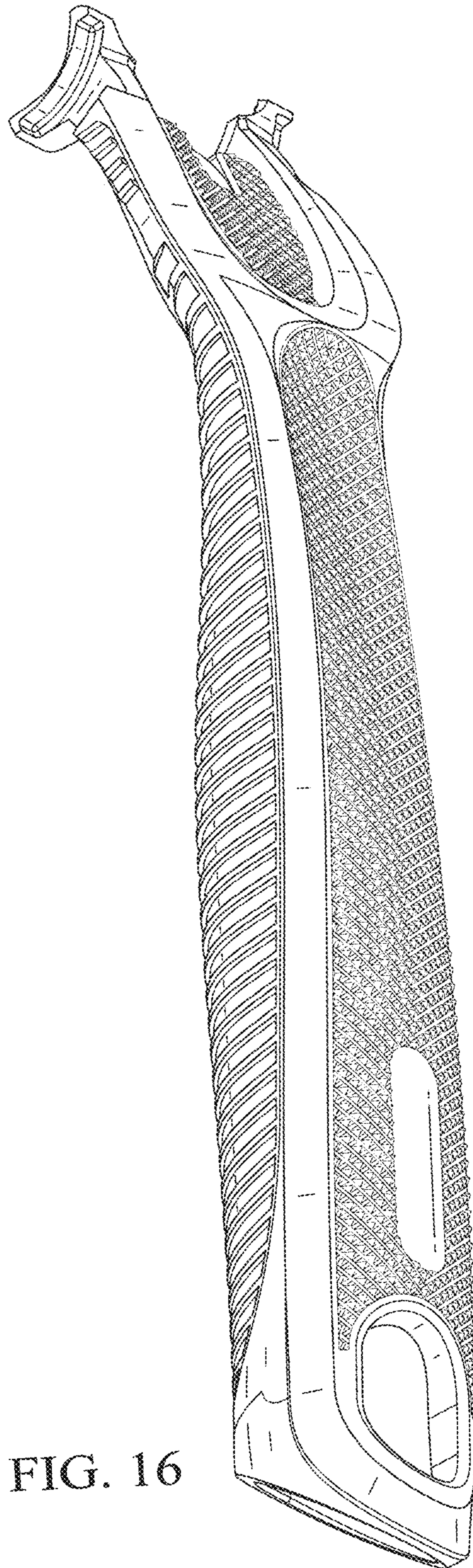
