(57) **CLAIM**

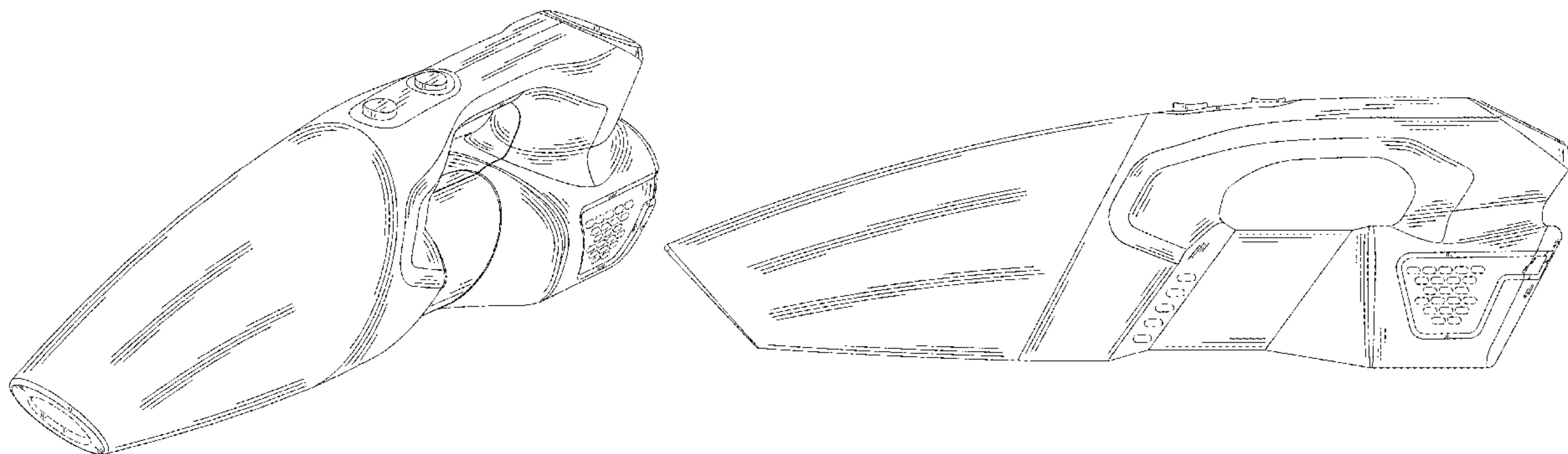
The ornamental design for a car vacuum cleaner, as shown and described.

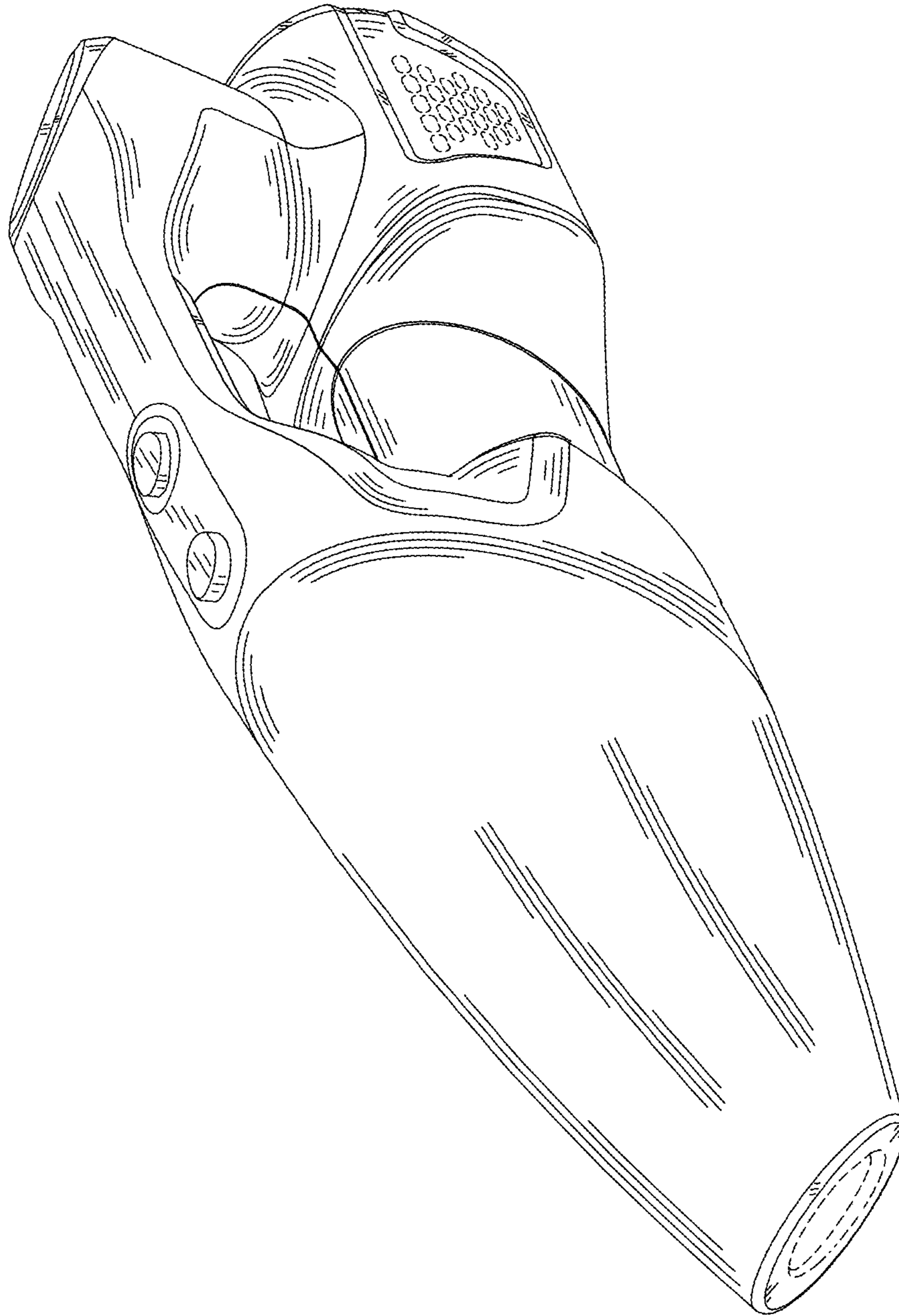

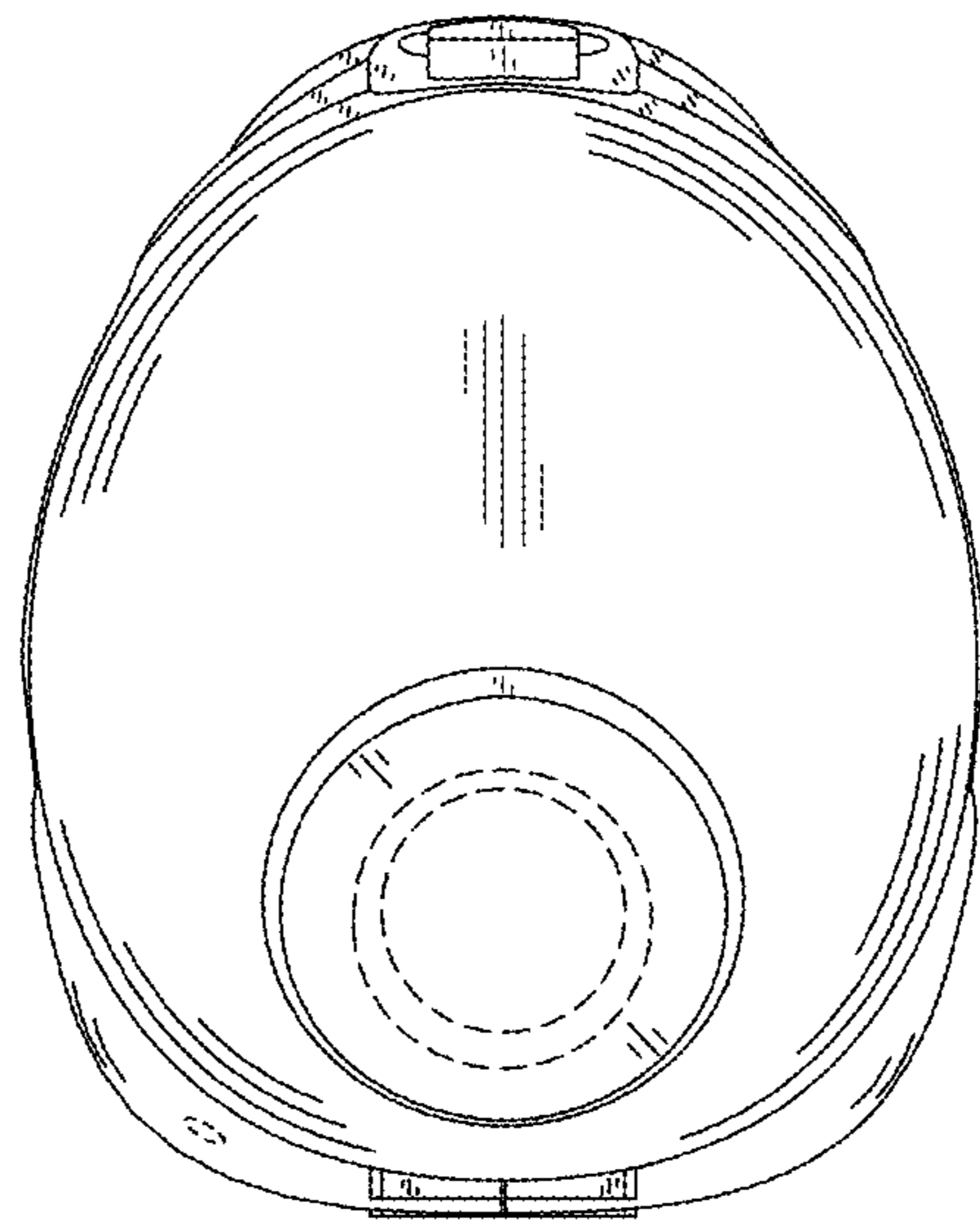

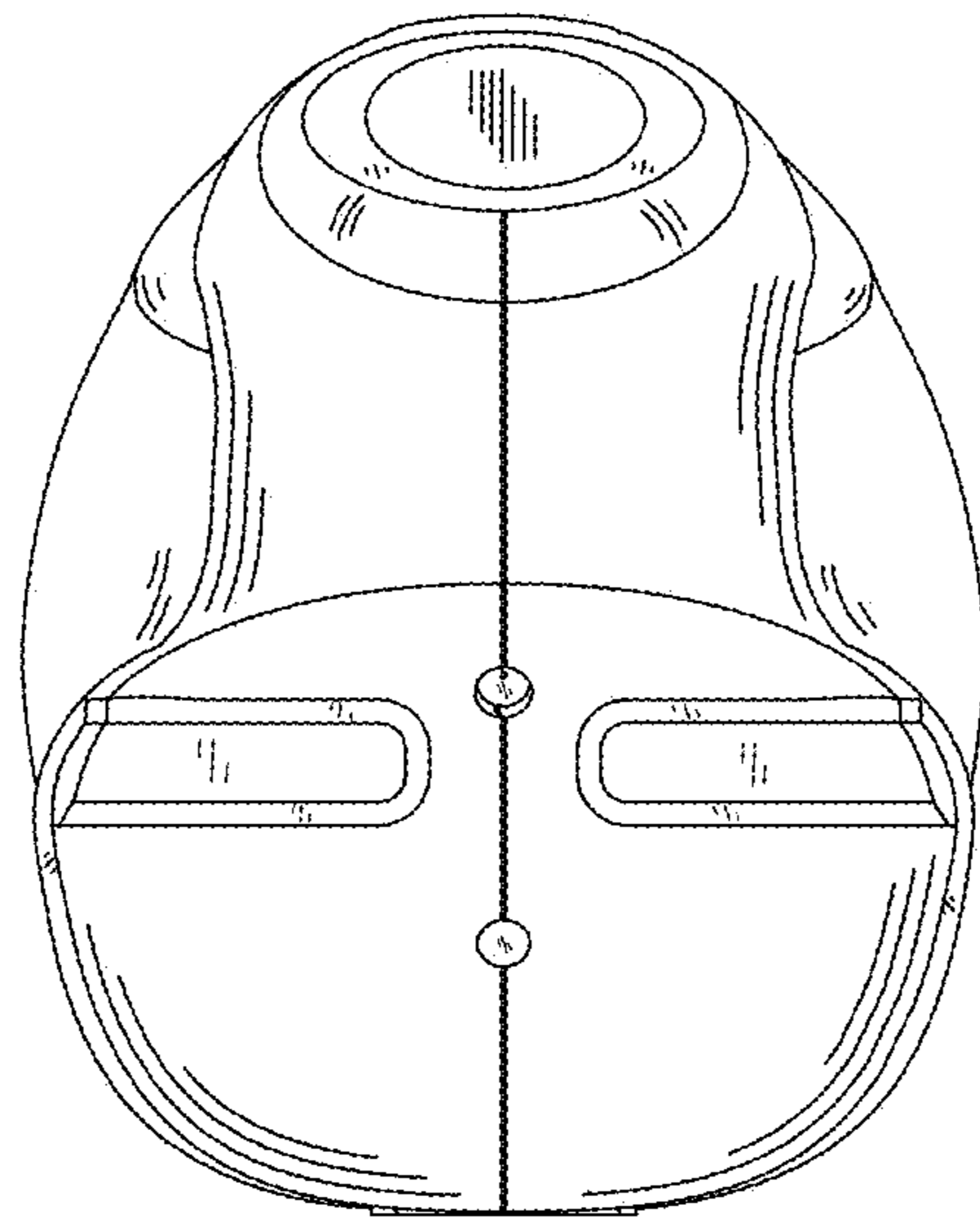

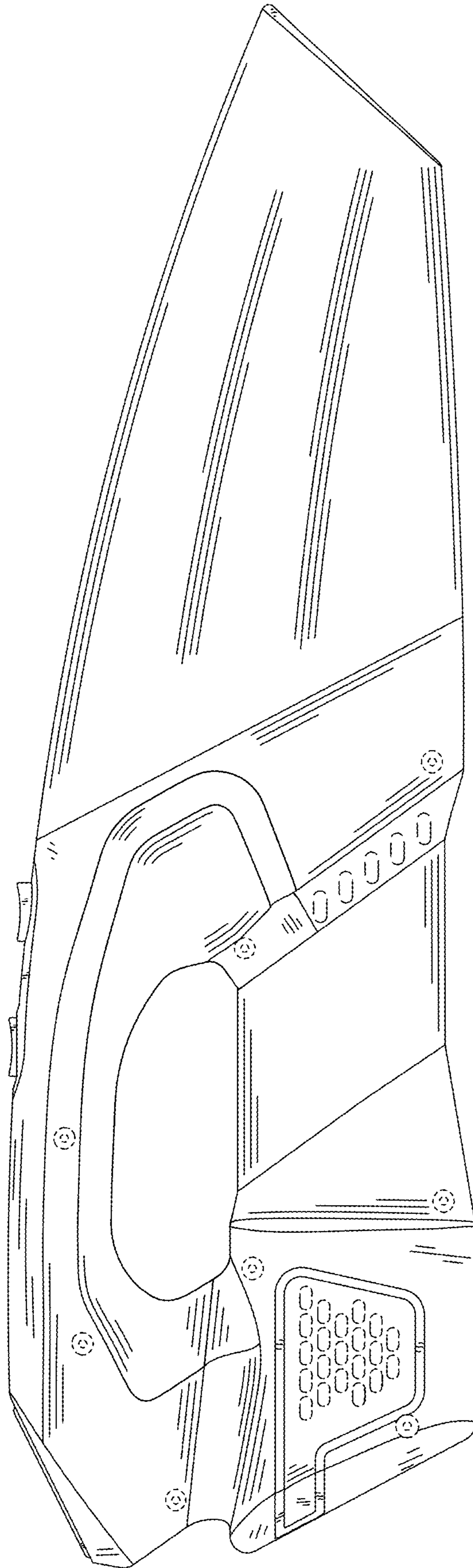

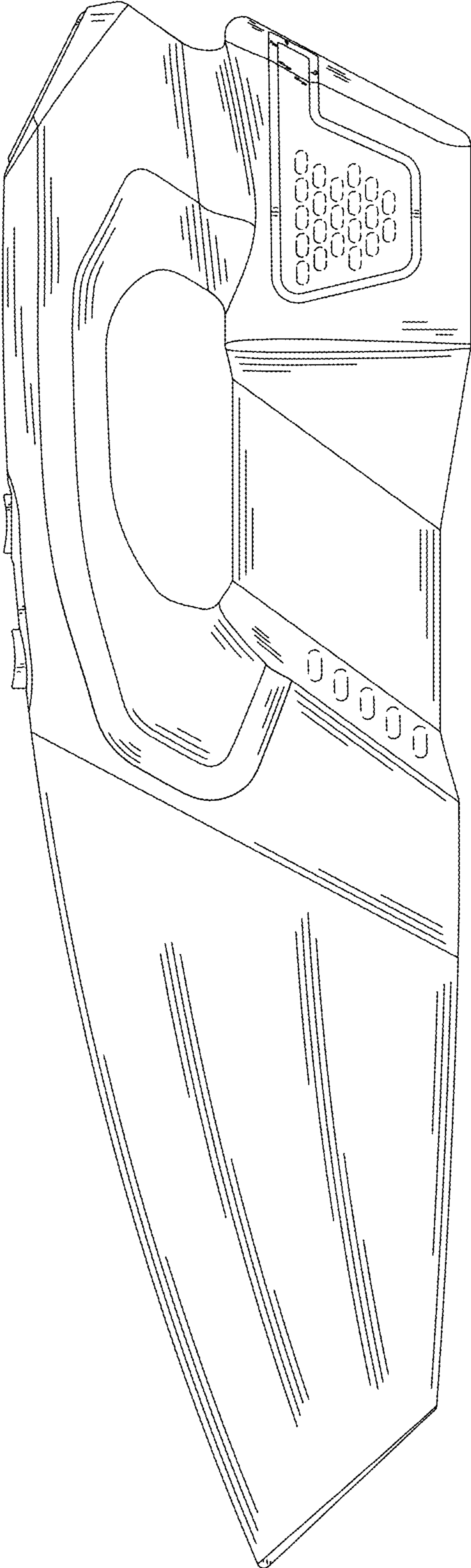

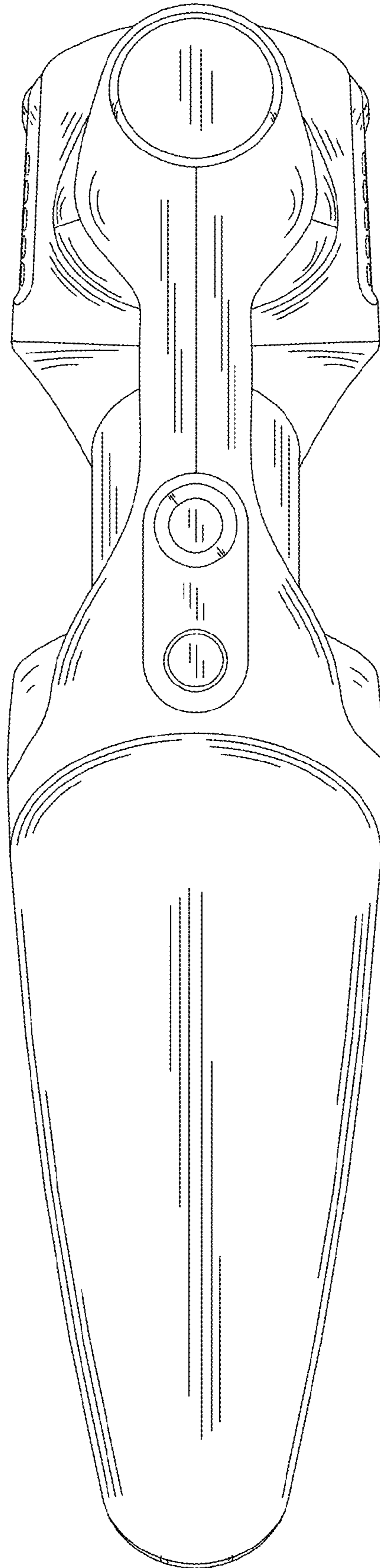

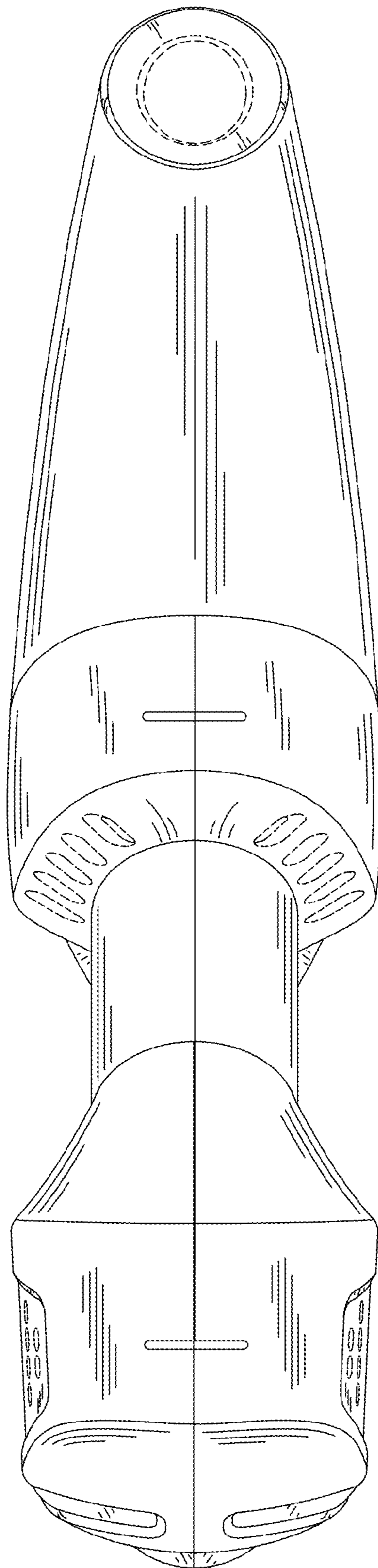
