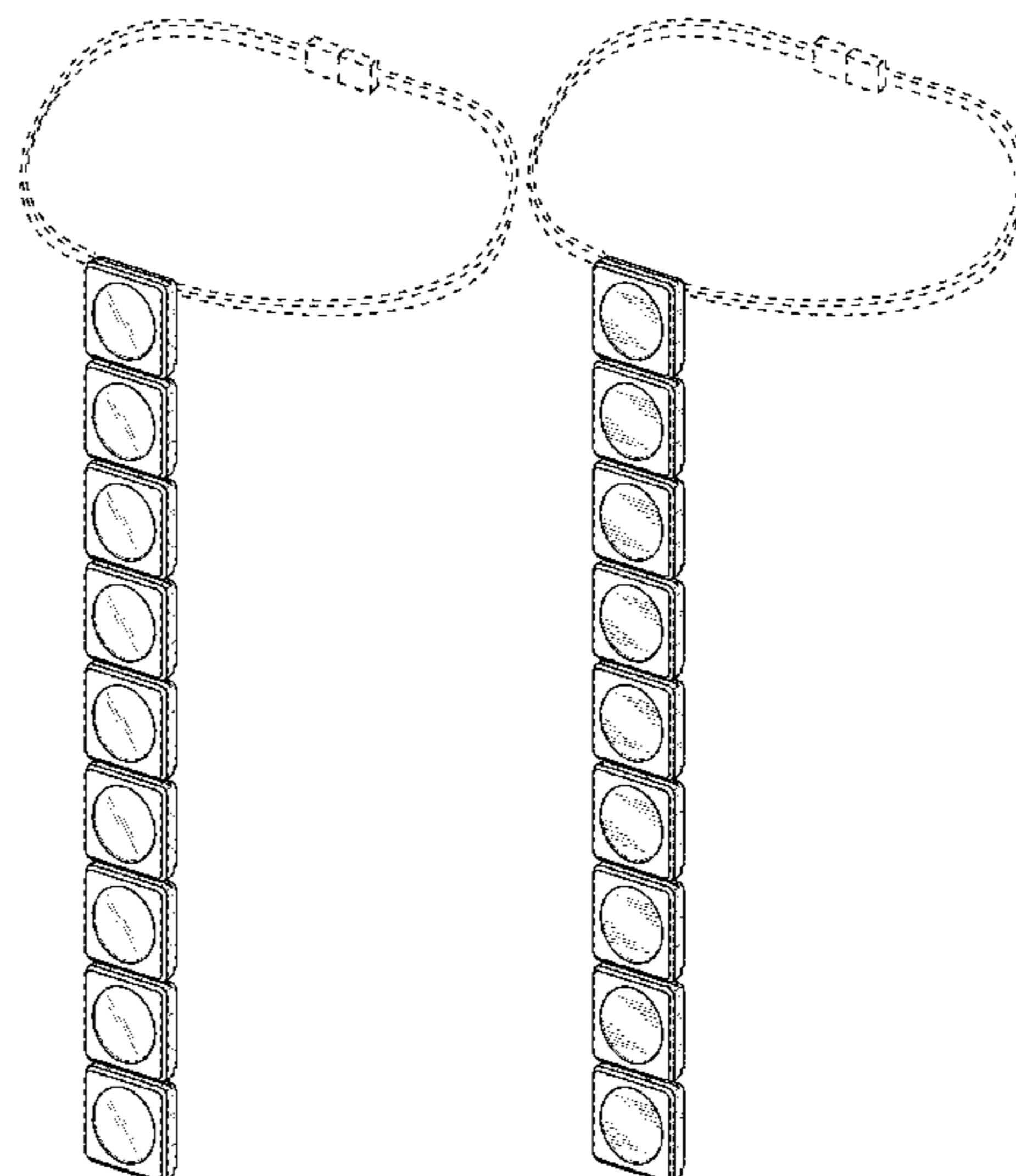
(57) **CLAIM**

The ornamental design for a neckwear for rounds or coins, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a neckwear for rounds or coins showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a front perspective view thereof;
FIG. 8 is a front view of a second embodiment of the neckwear for rounds or coins showing my new design;
FIG. 9 is a rear view thereof;
FIG. 10 is a right side view thereof;
FIG. 11 is a left side view thereof;
FIG. 12 is a top view thereof;
FIG. 13 is a bottom view thereof; and,
FIG. 14 is a front perspective view thereof.
The broken lines along the rear surface of the neckwear portion of the neckwear for rounds or coins that run adjacent to the perimeter edges depict features that form no part of the claimed design. The neckband and link fasteners outlined by broken lines depict portions of the neckwear for rounds or coins that form no part of the claimed design.

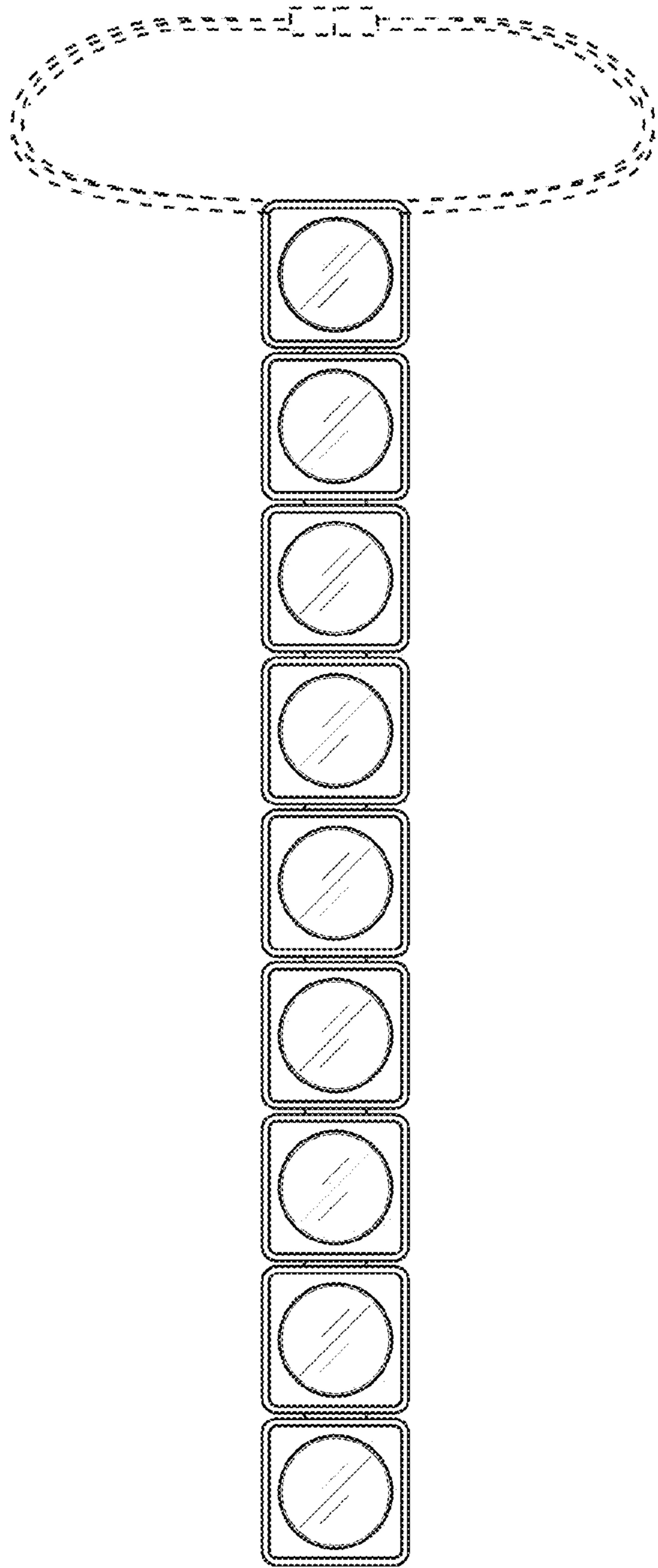

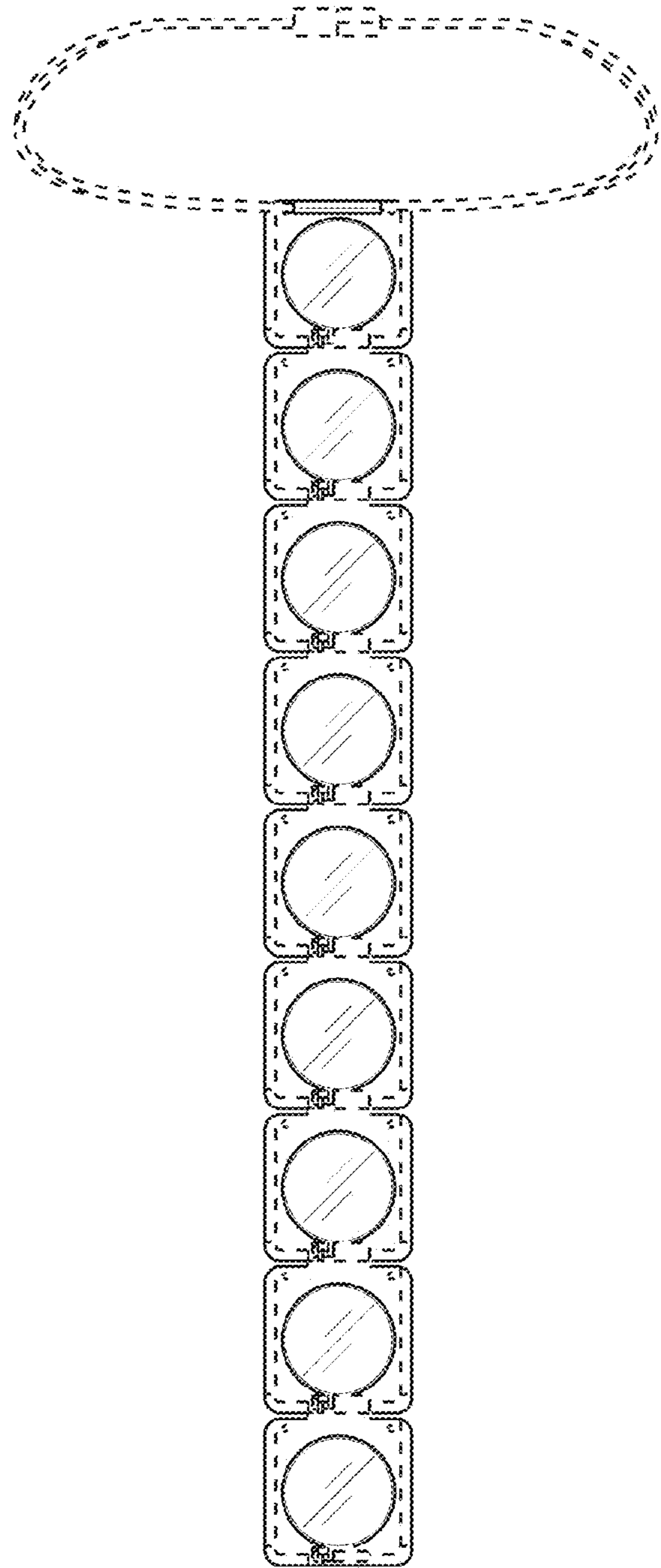

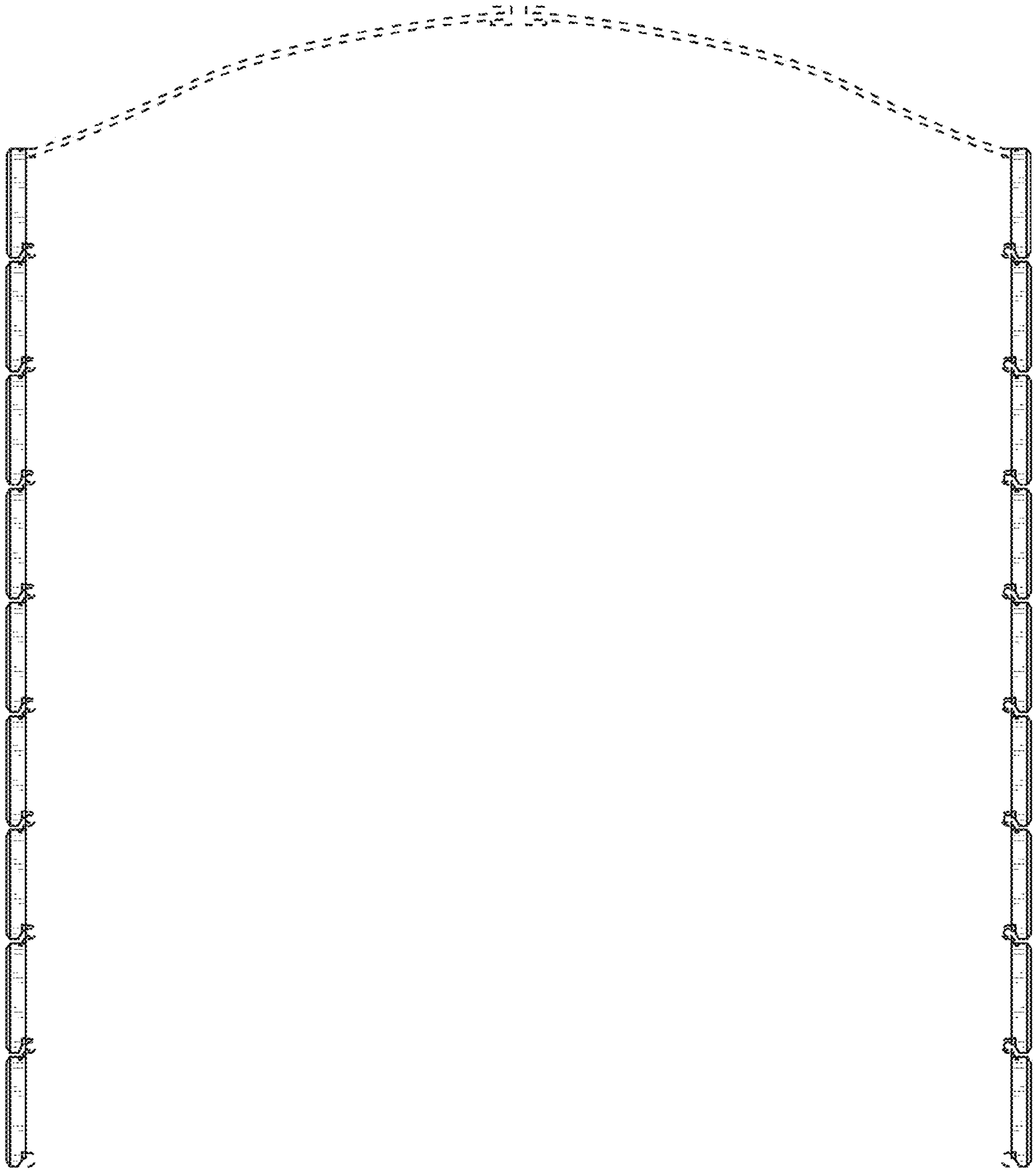

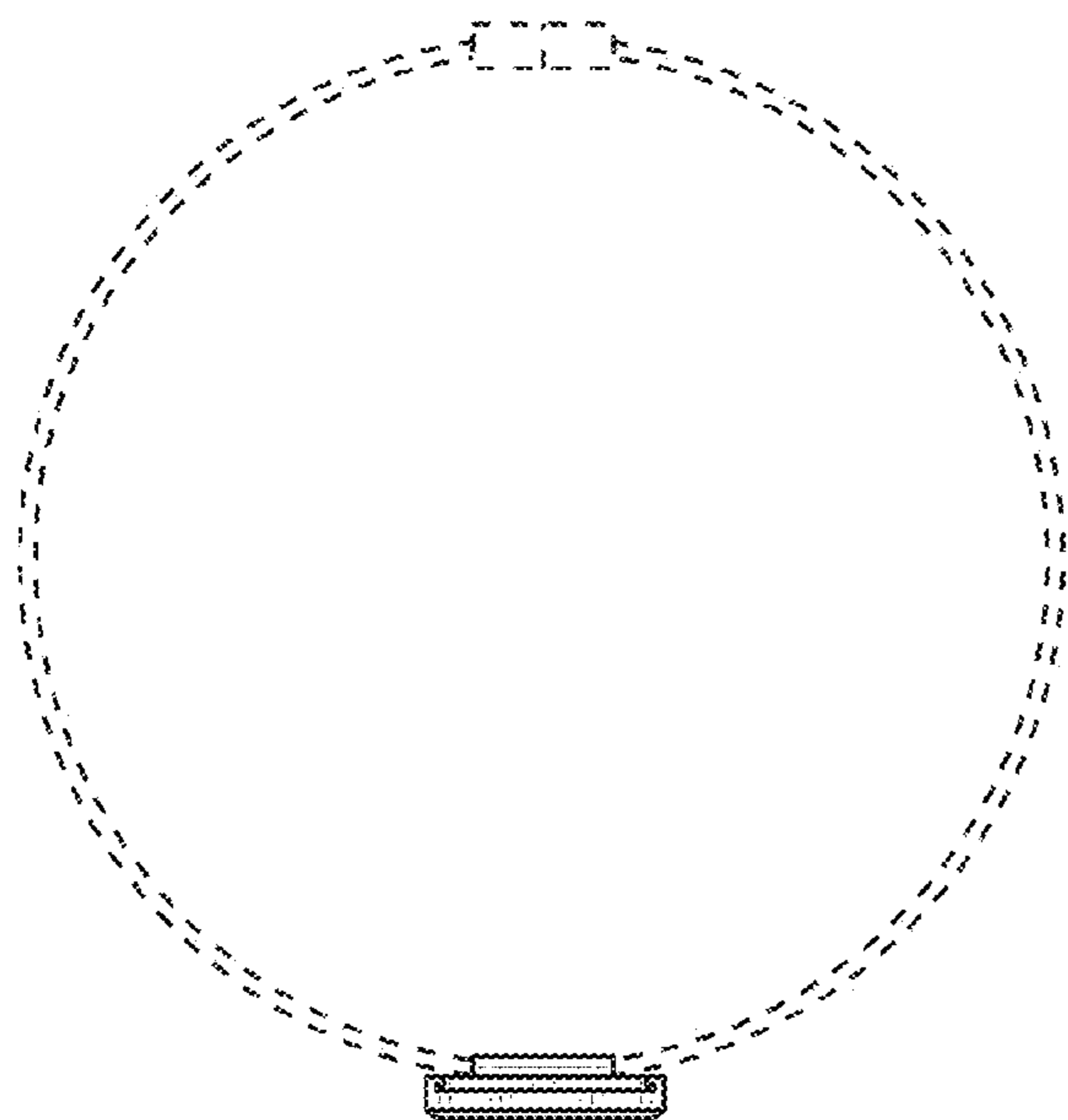

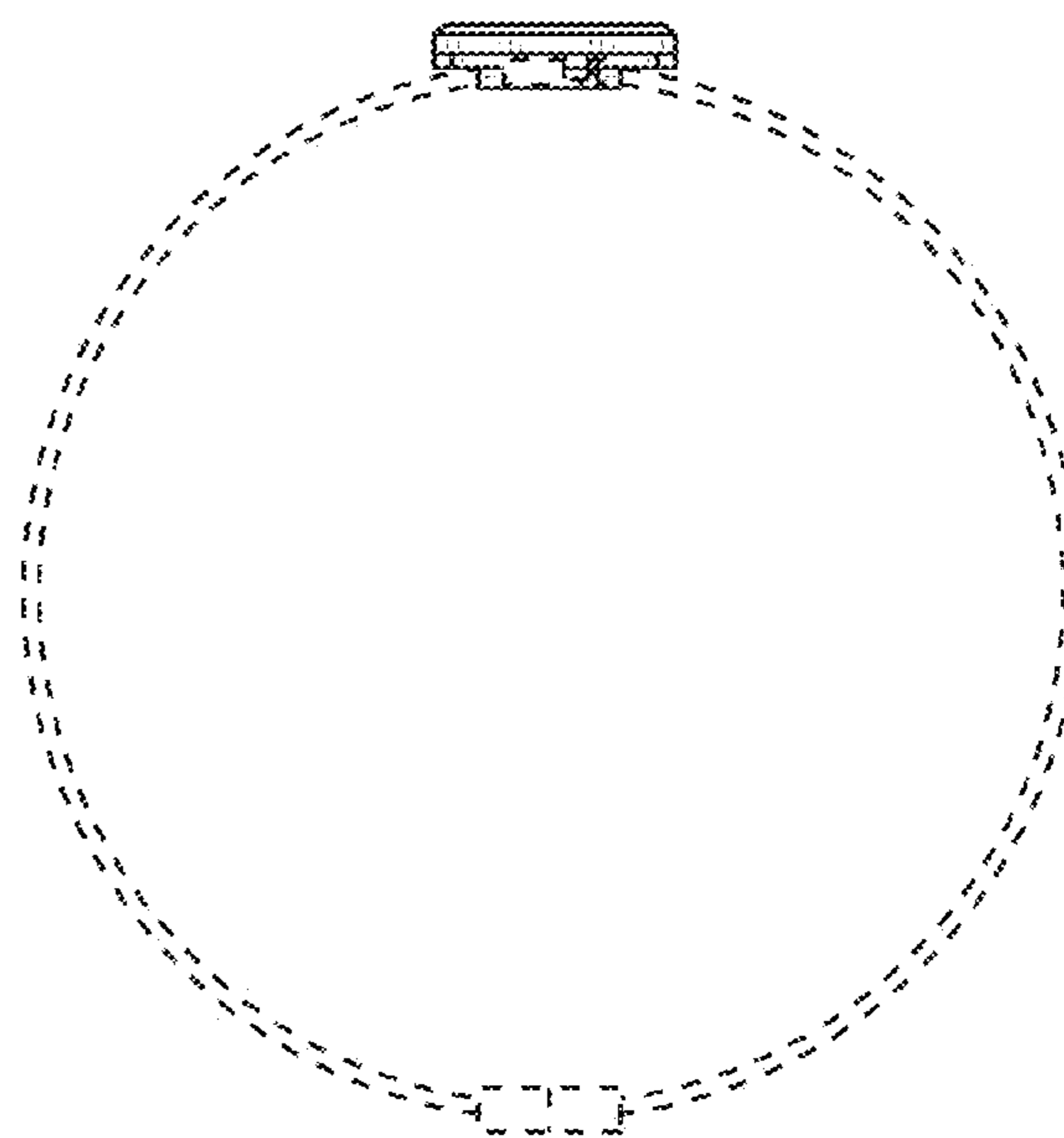

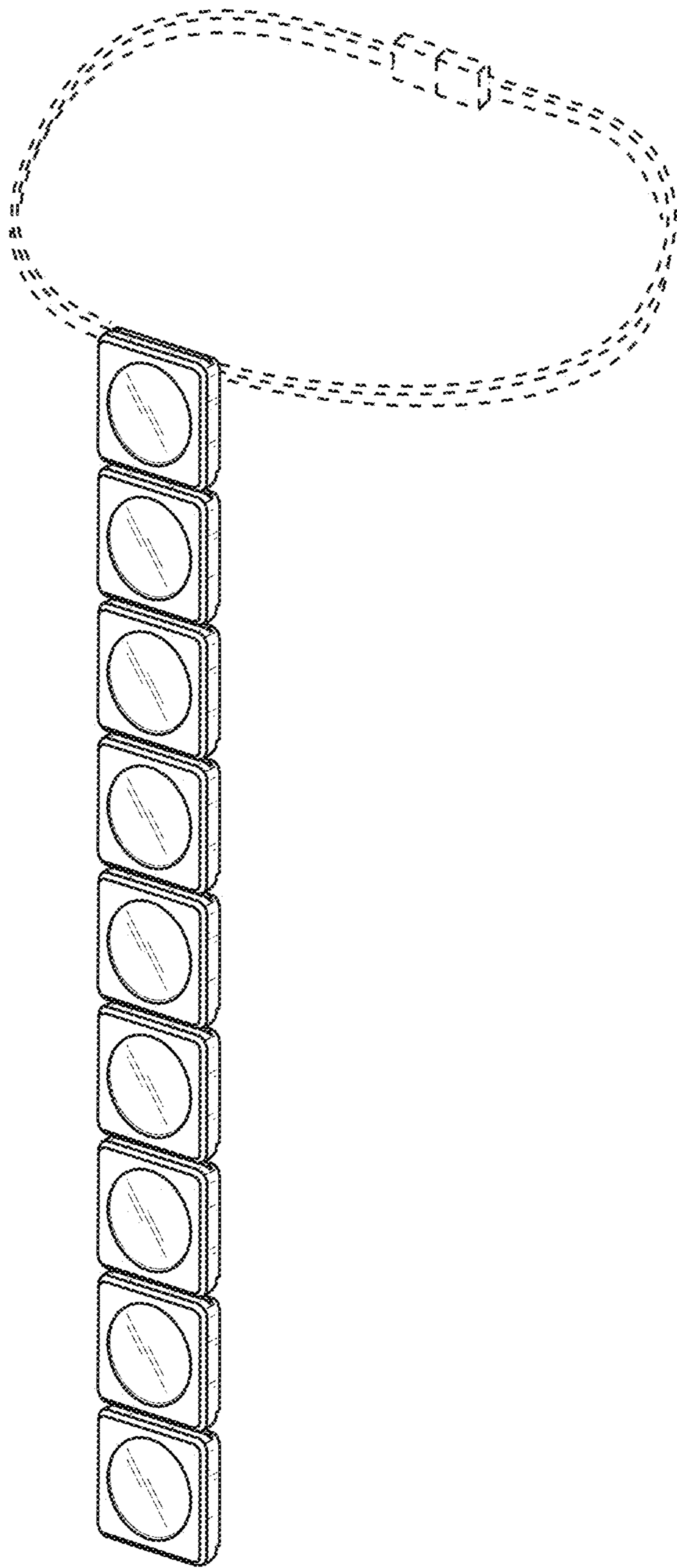

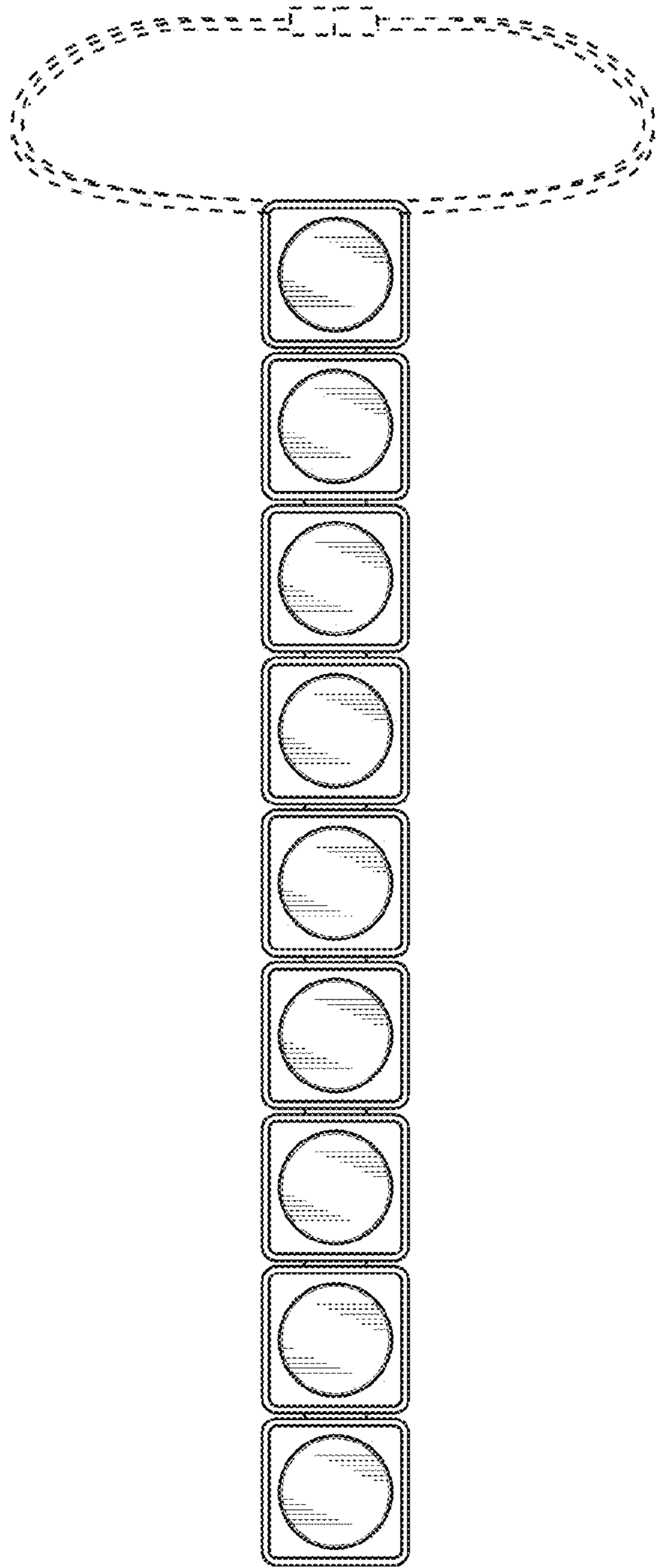

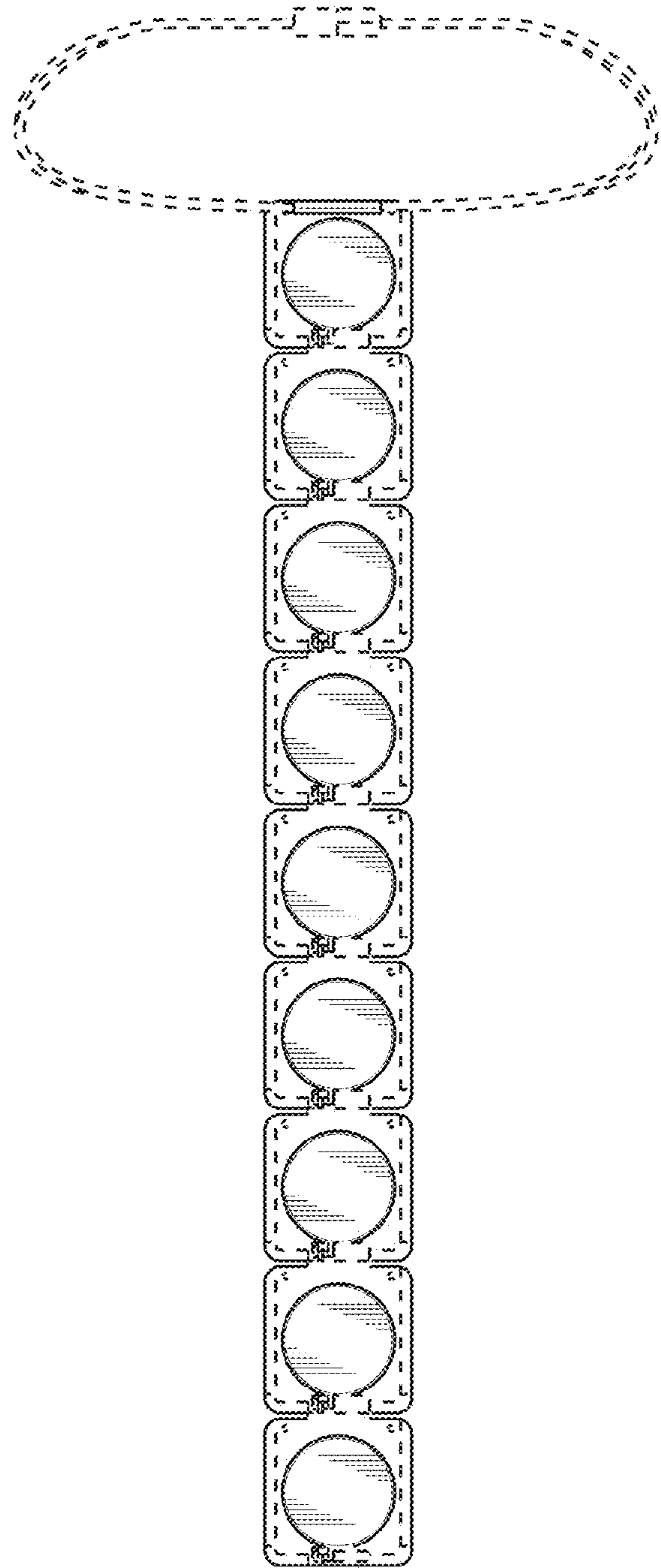

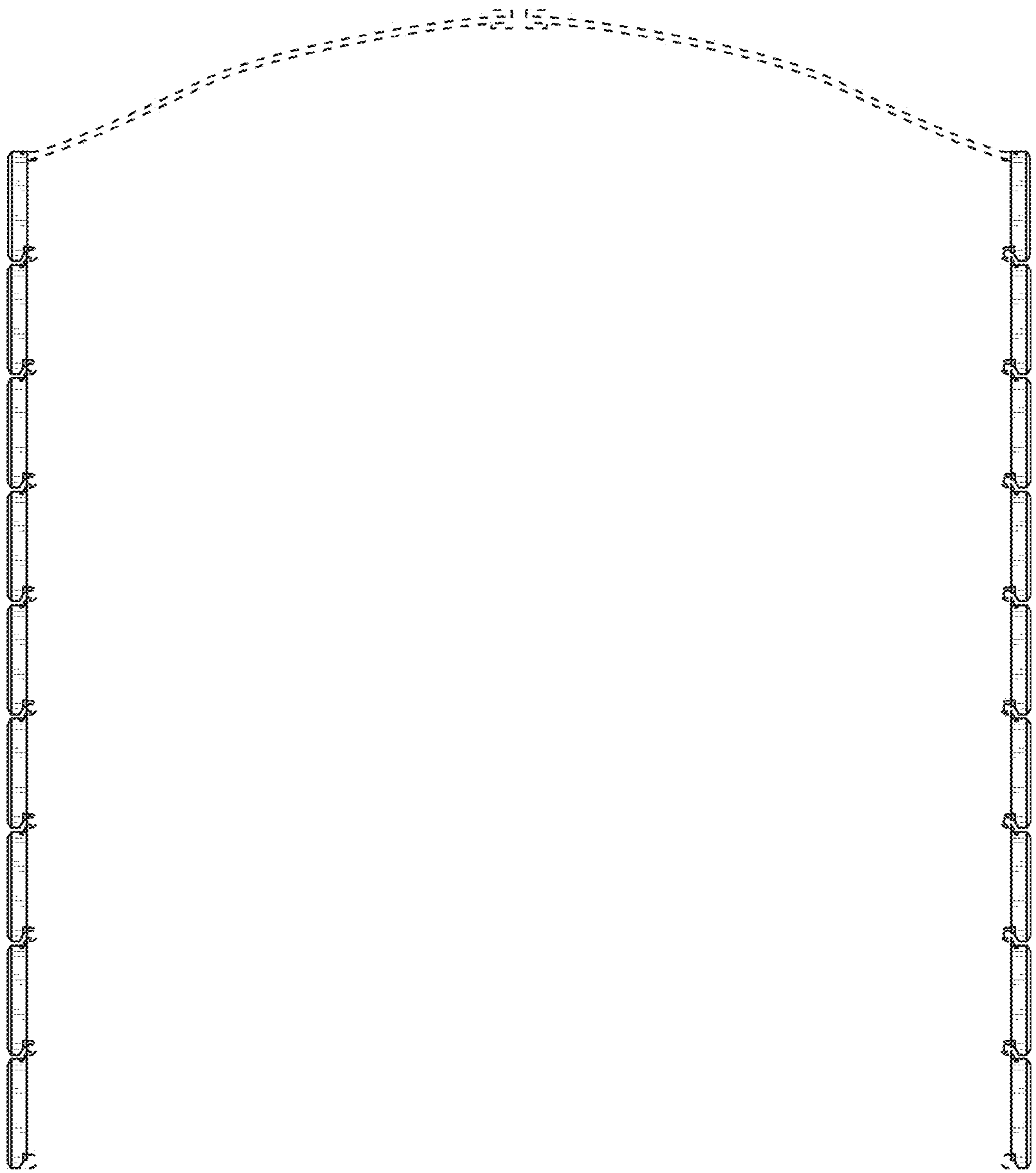

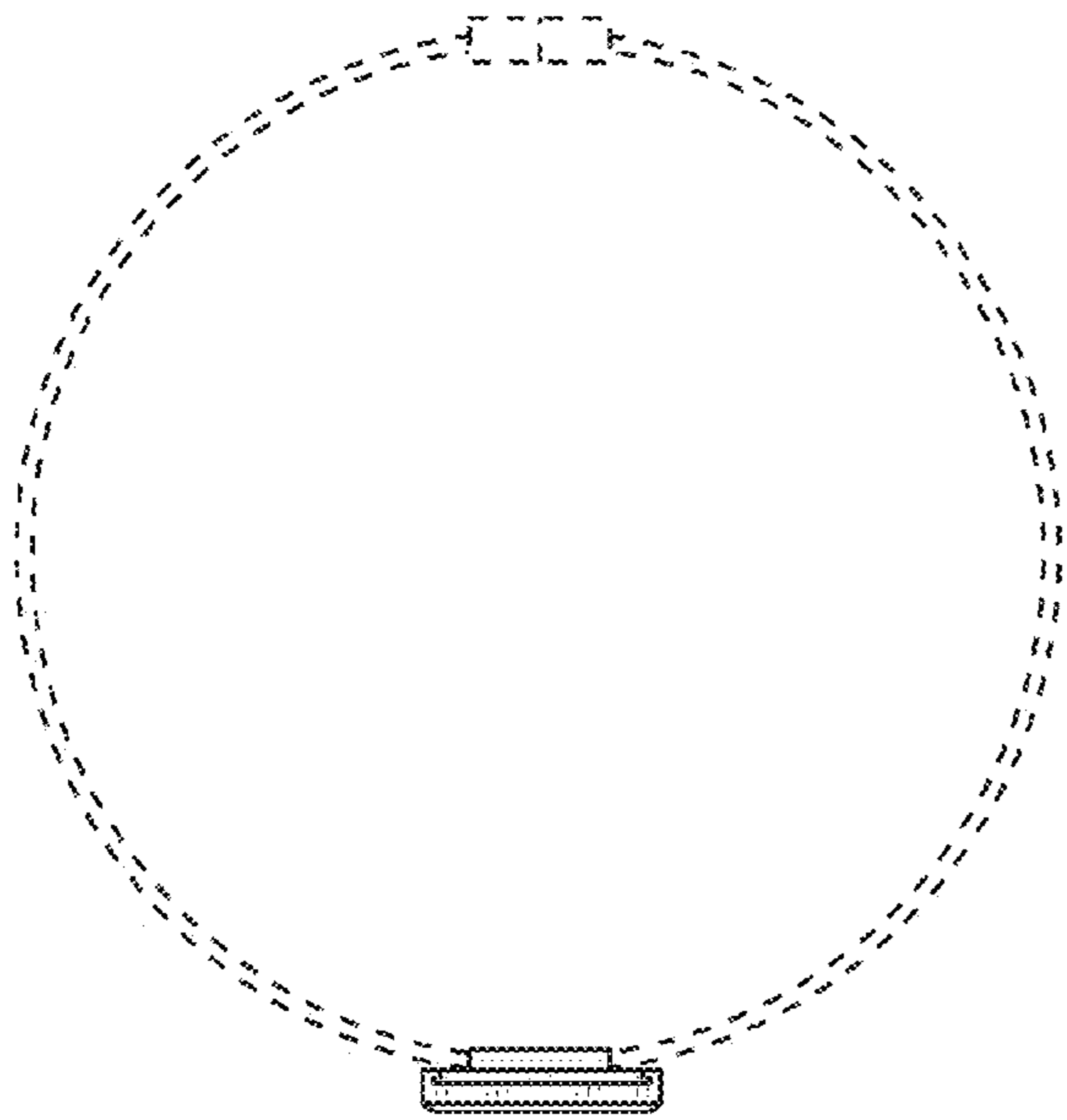

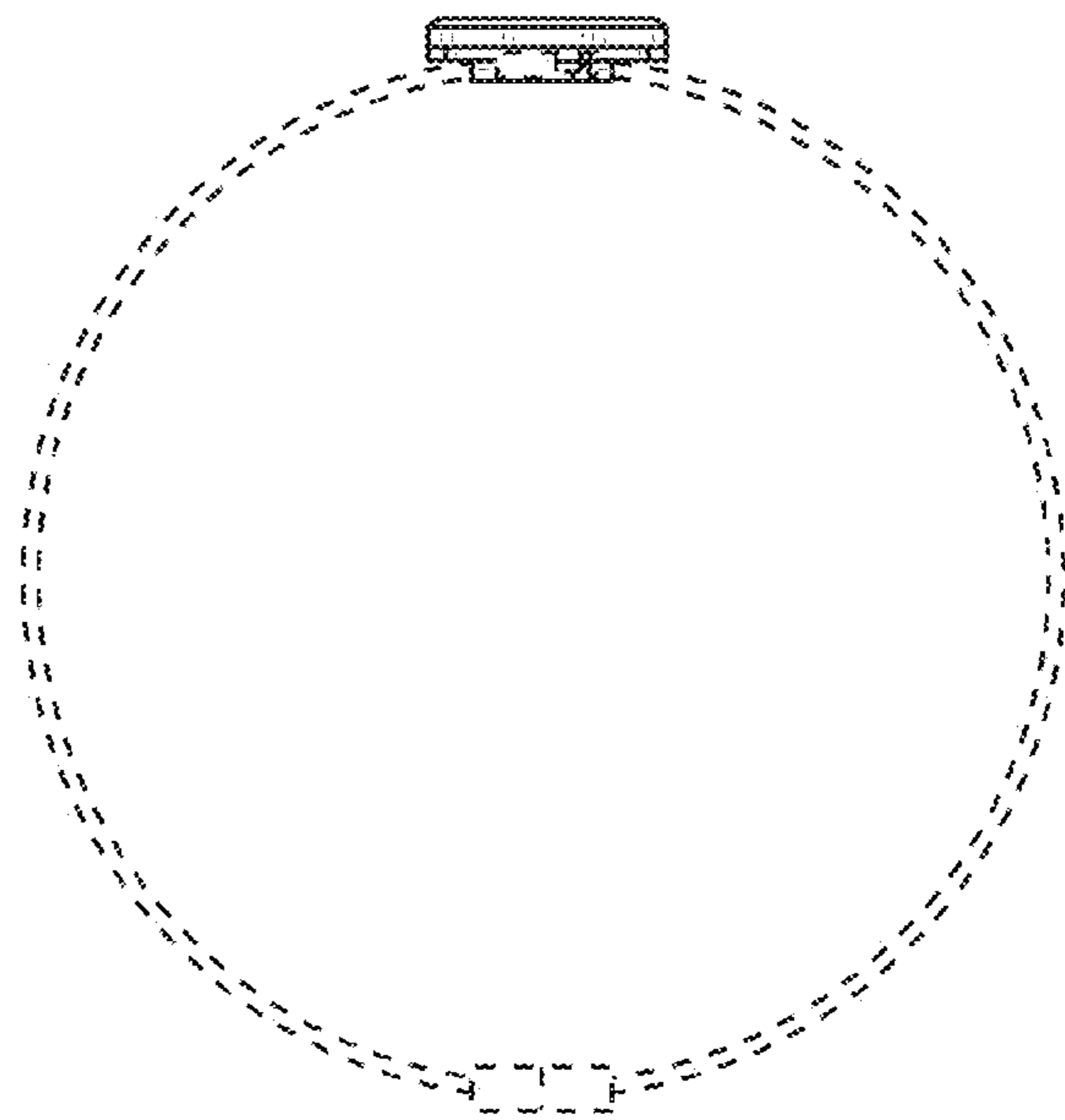

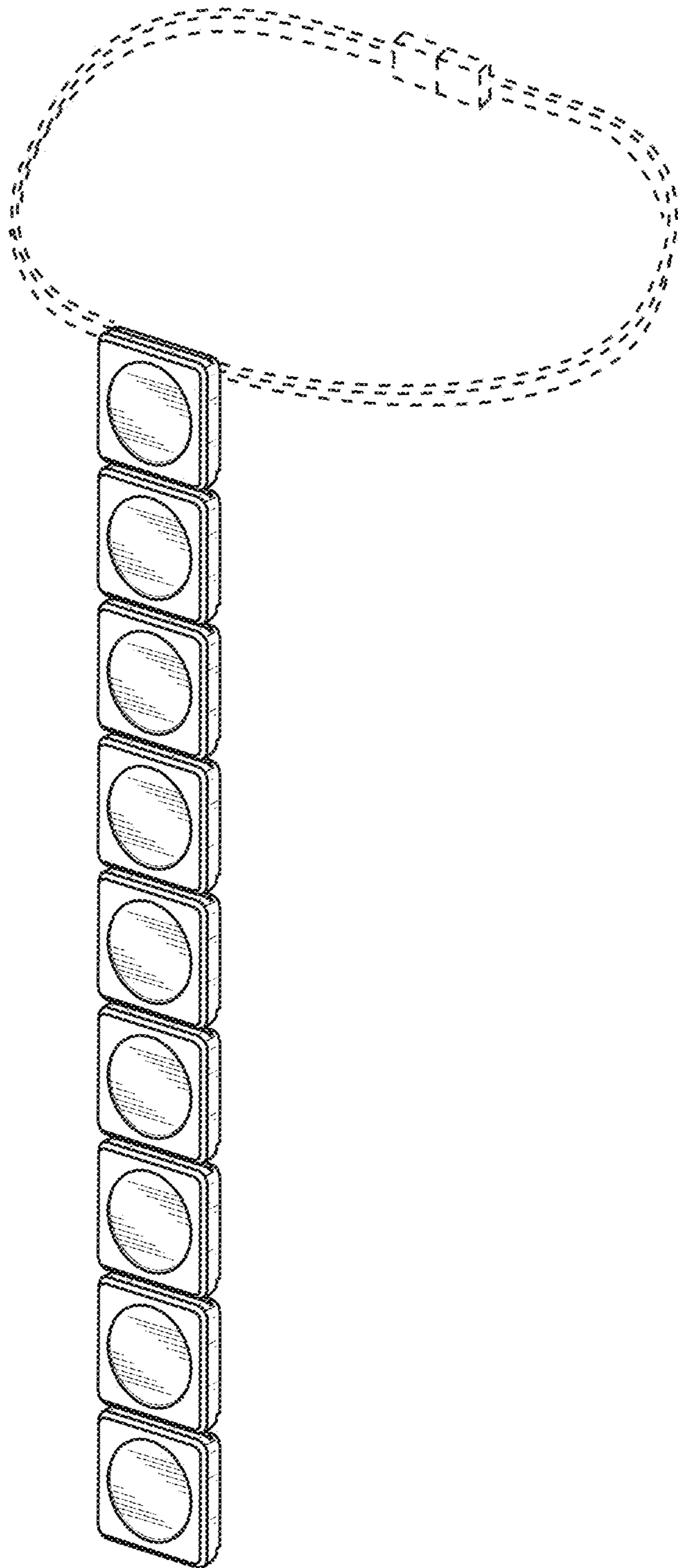
