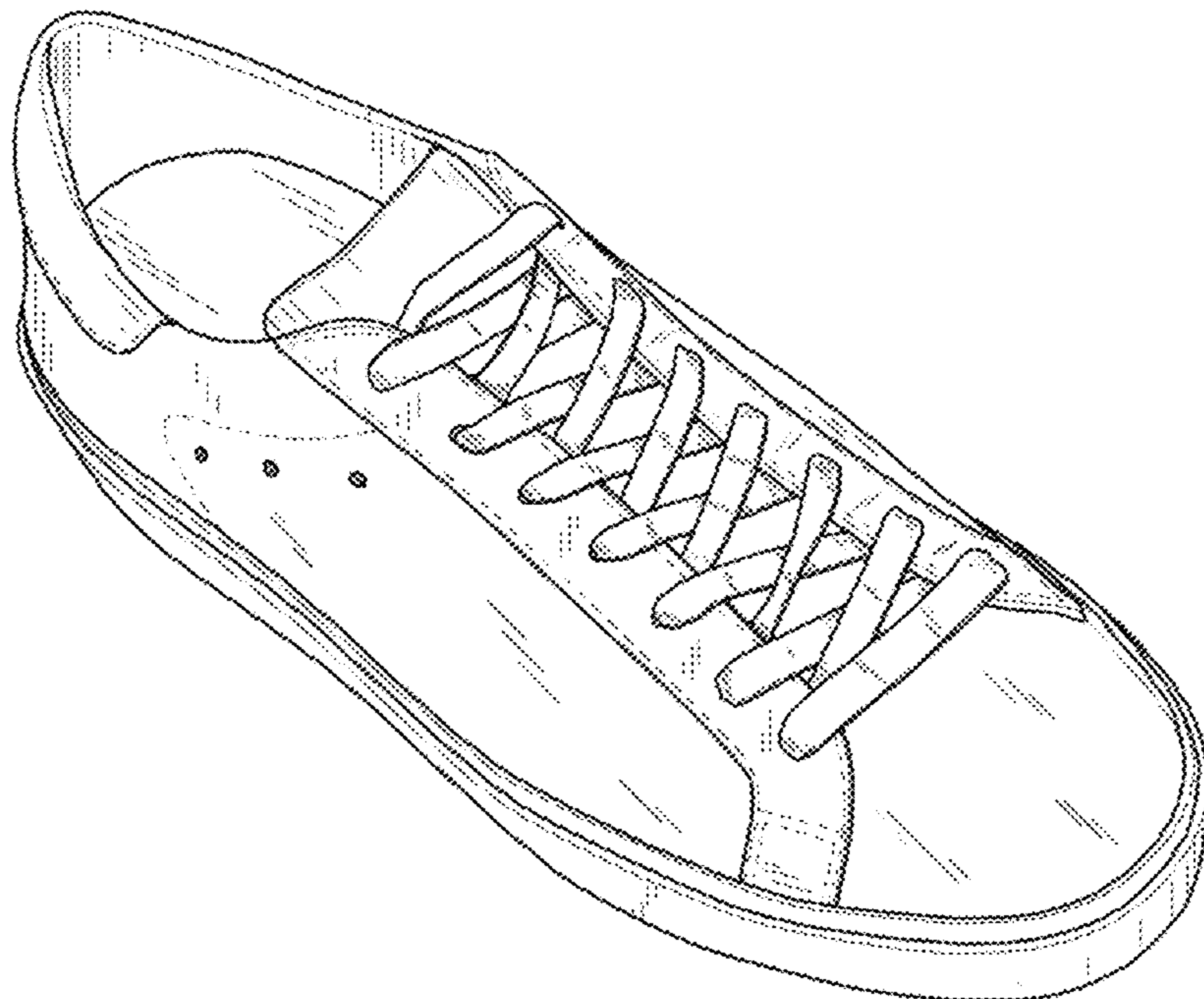
The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

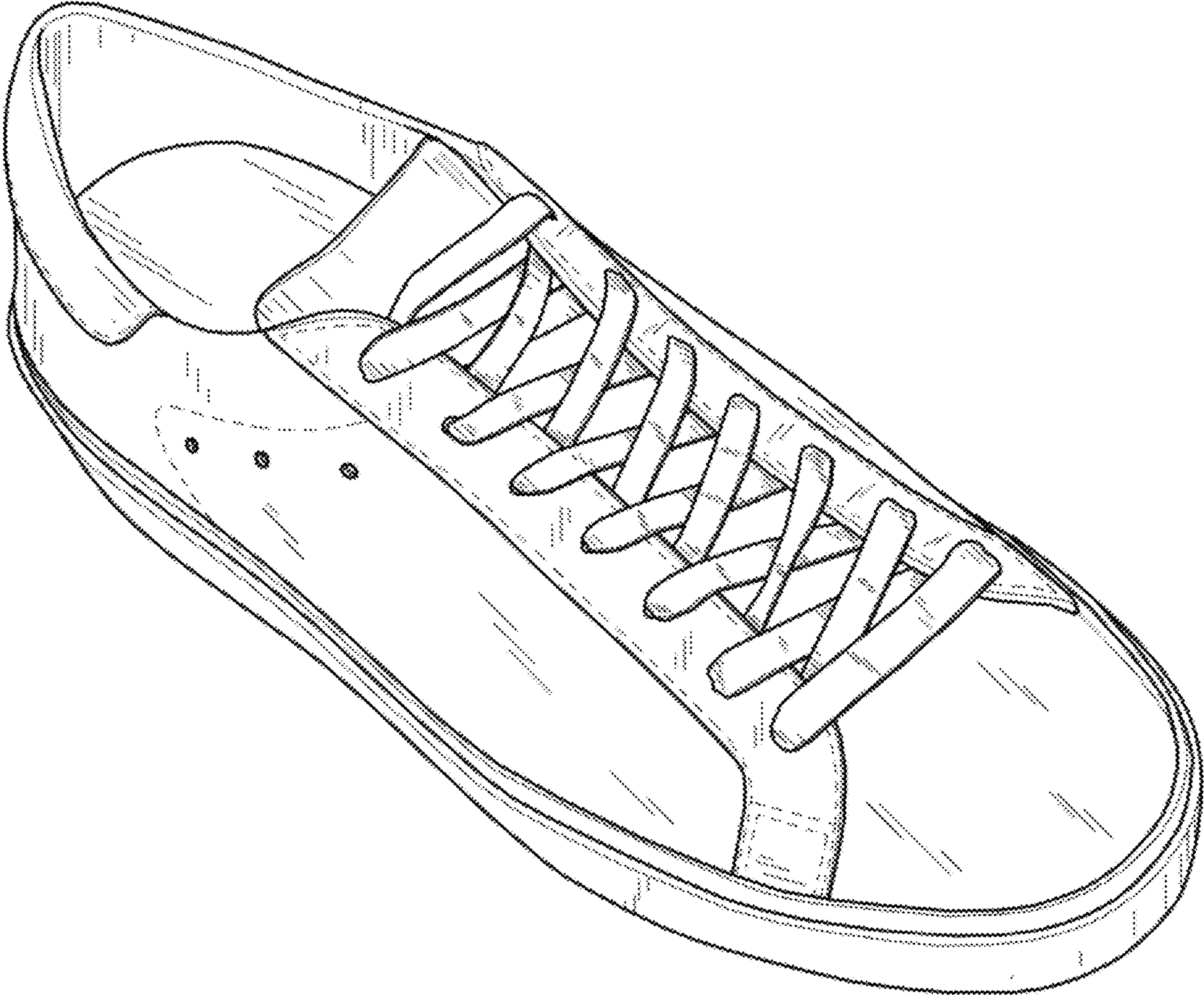
**2.1** is a perspective view of our new design for a shoe;

The broken lines depict claimed stitching.

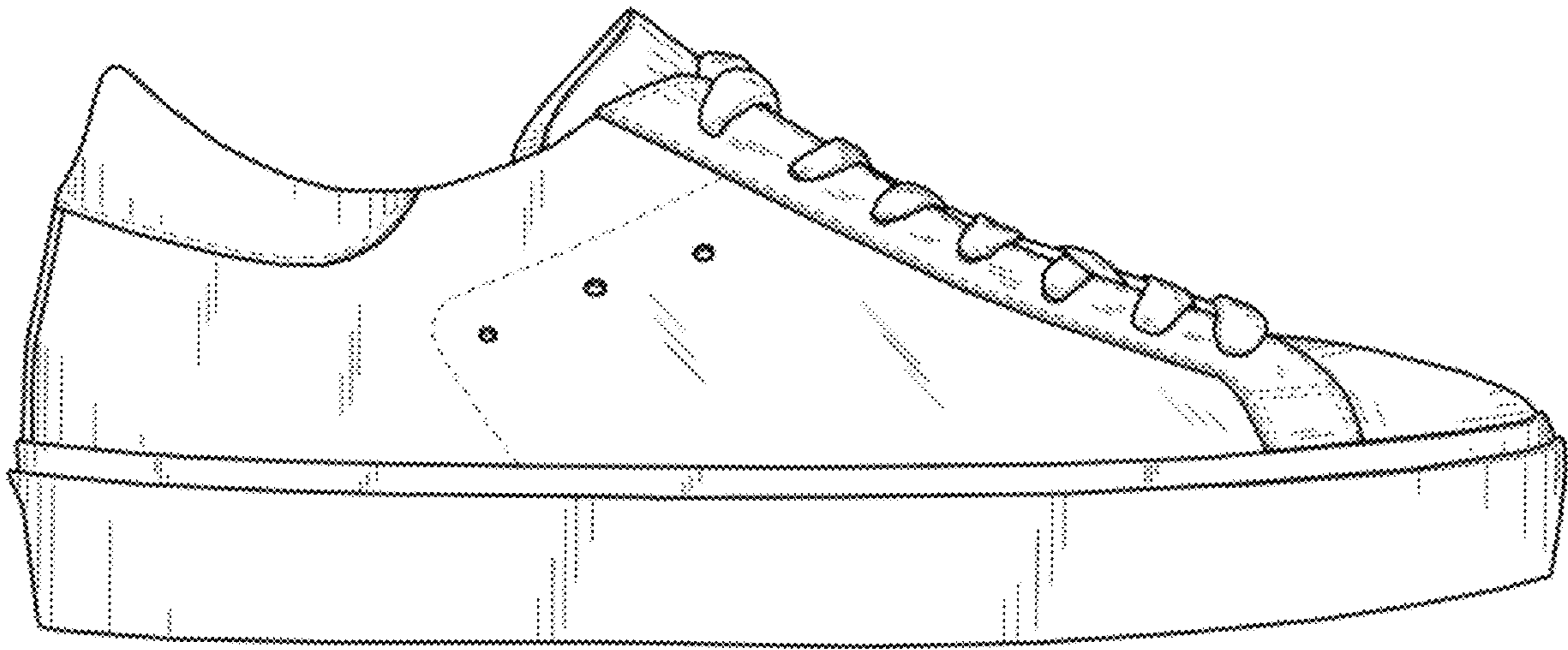

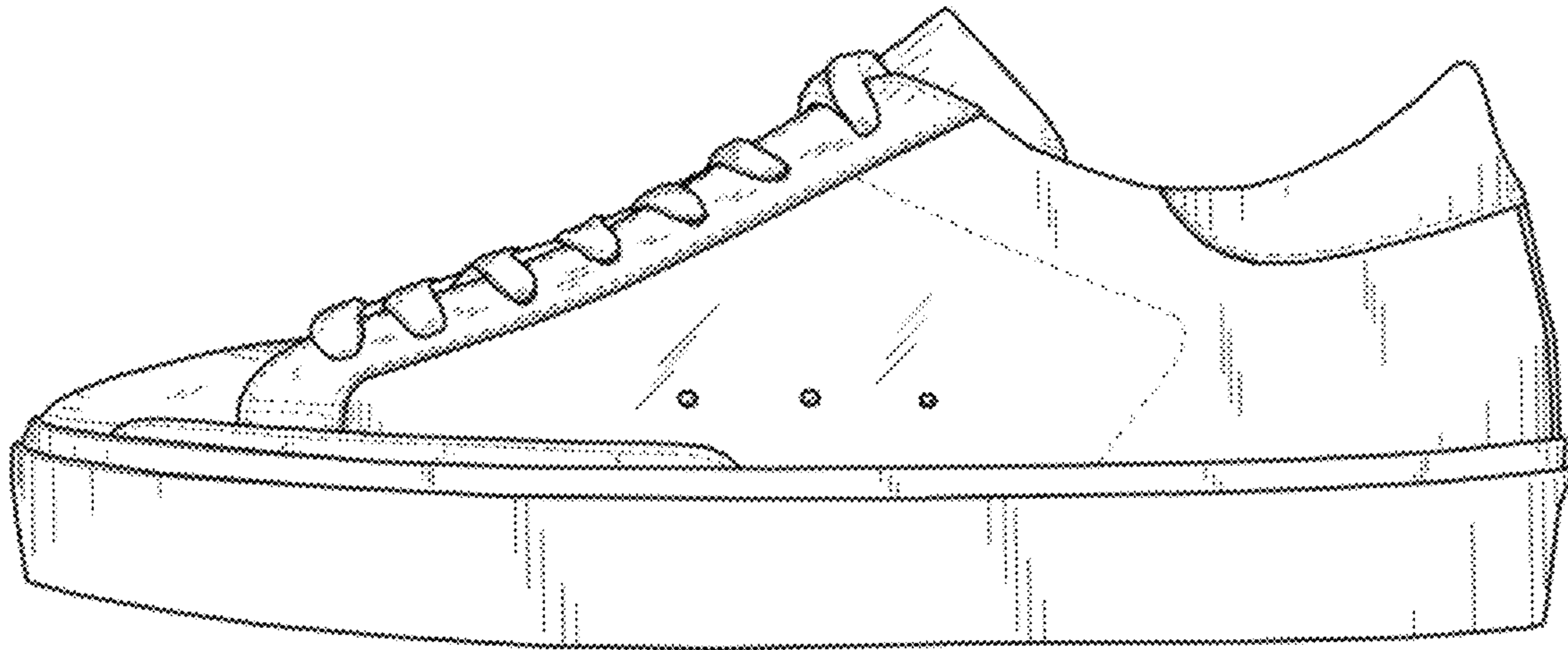

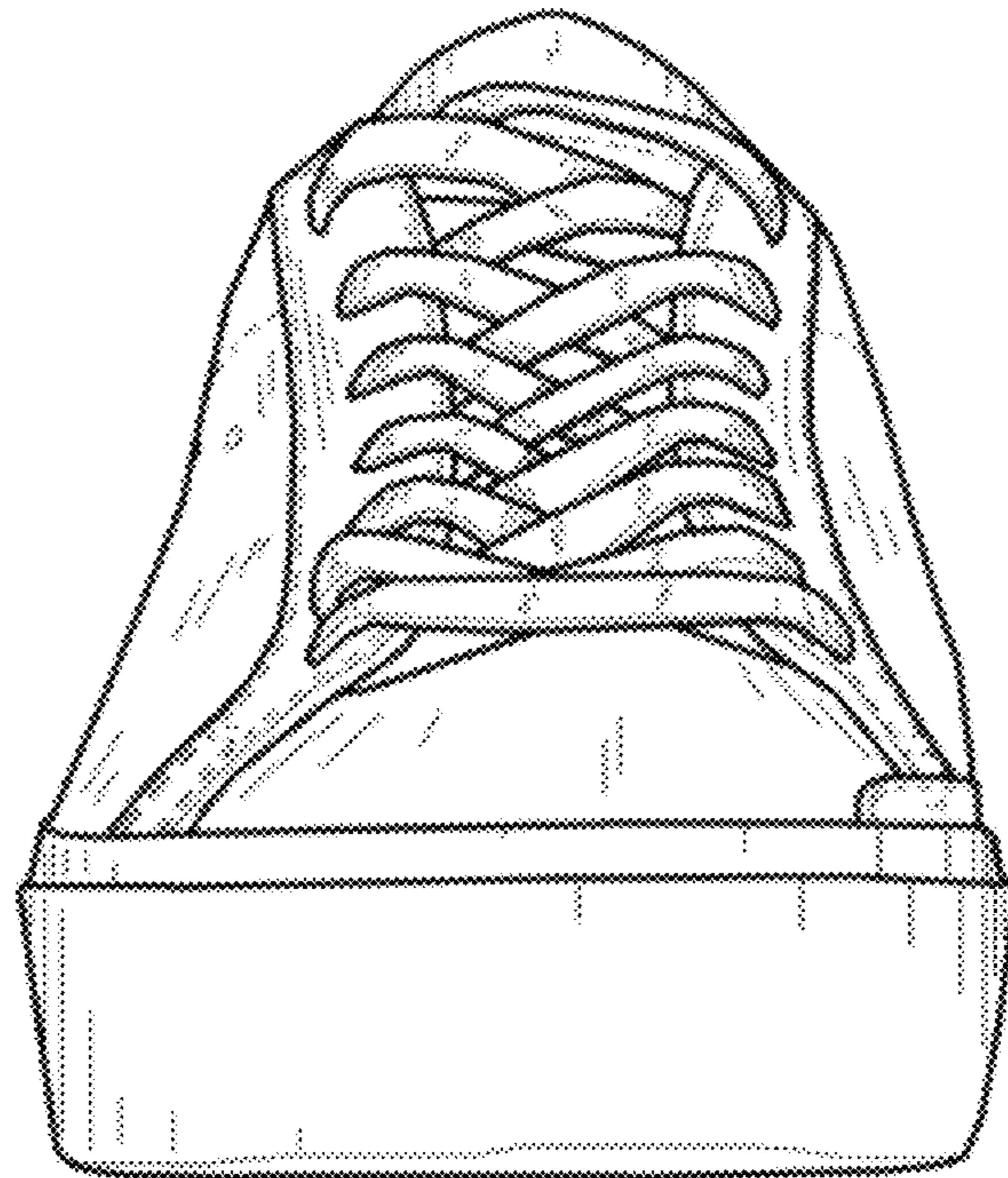

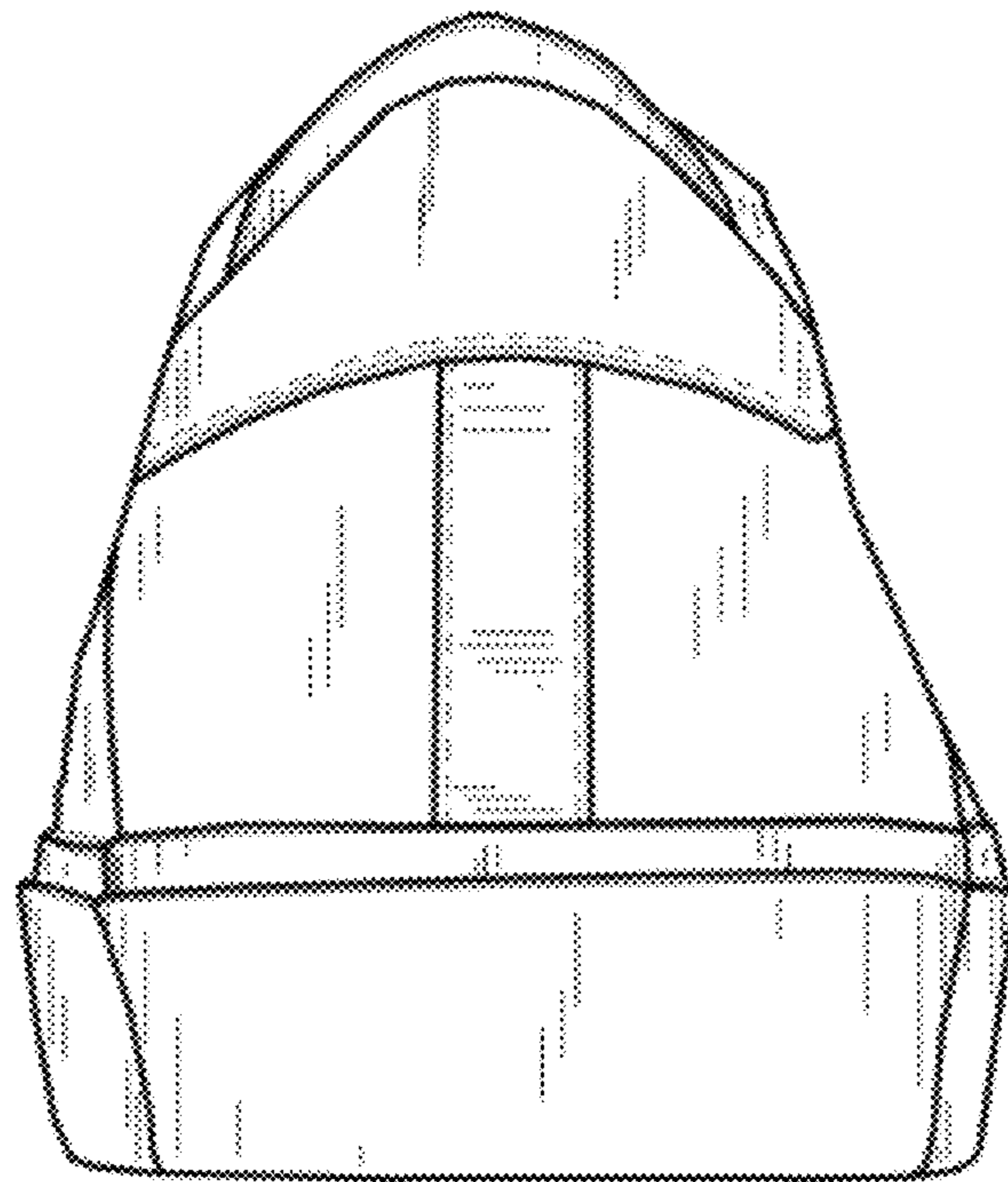
