The ornamental design for a shoe, as shown and described.

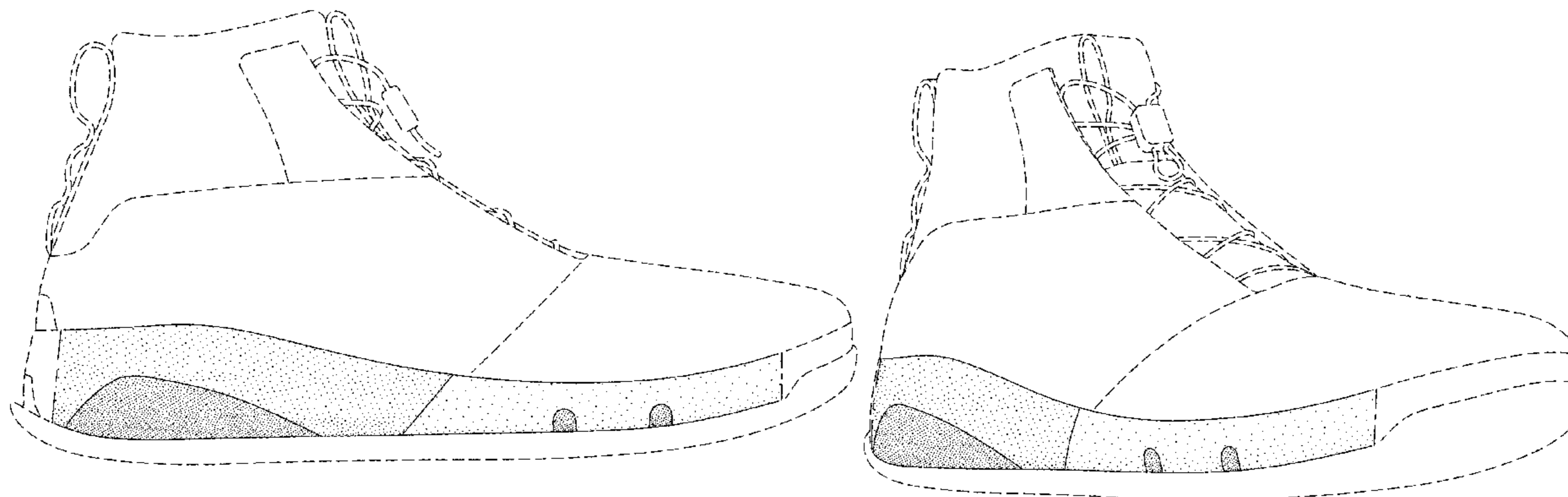
DESCRIPTION

FIG. 1 is a side view of a shoe showing my design; FIG. 2 is a front perspective view thereof; and, FIG. 3 is a rear perspective view thereof.

The even-length broken lines are directed to environment, represent unclaimed subject matter, and form no part of the claimed design. The long and short broken lines form an unclaimed boundary around a portion of the claimed subject matter and form no part of the claim.

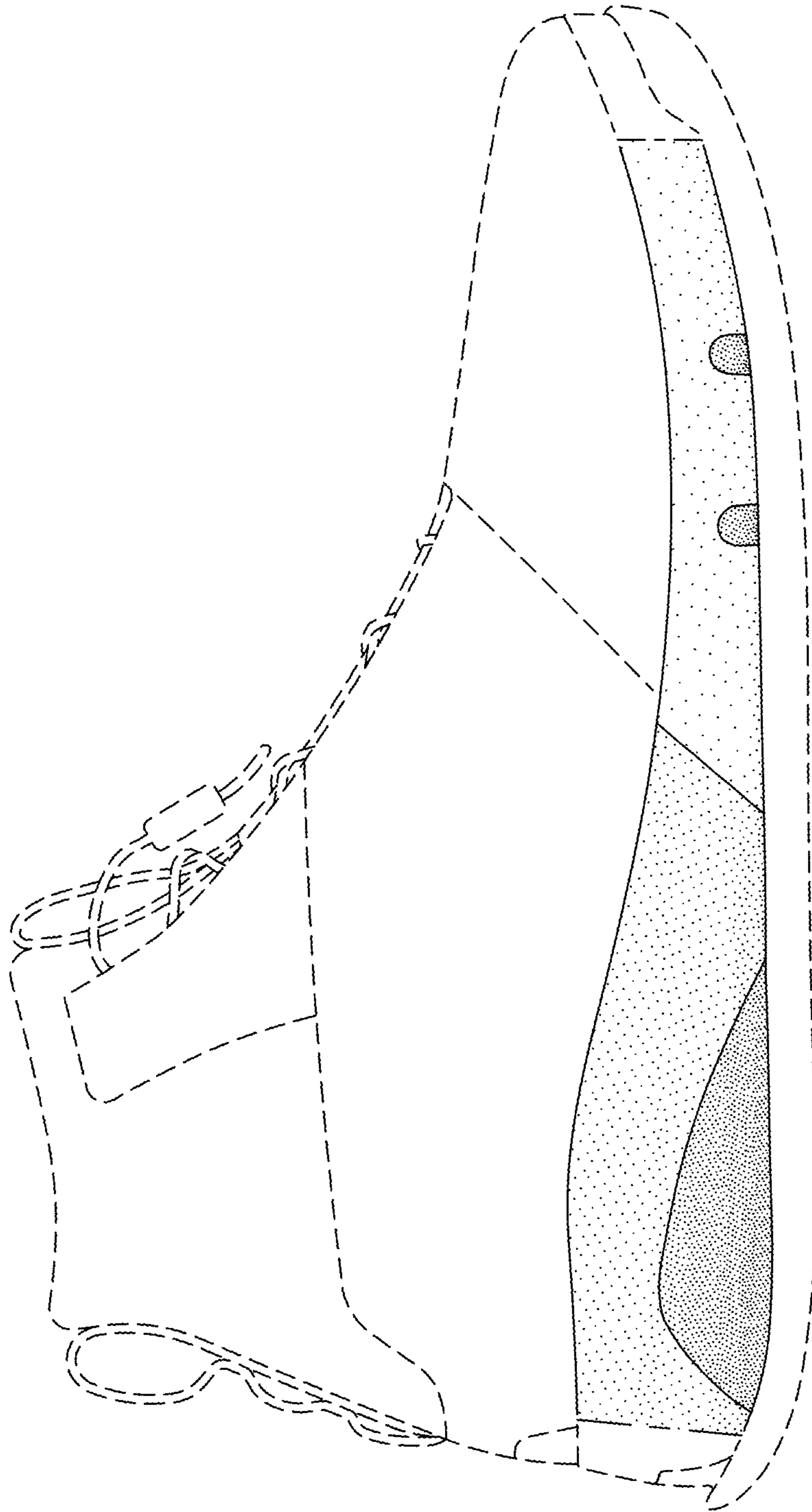

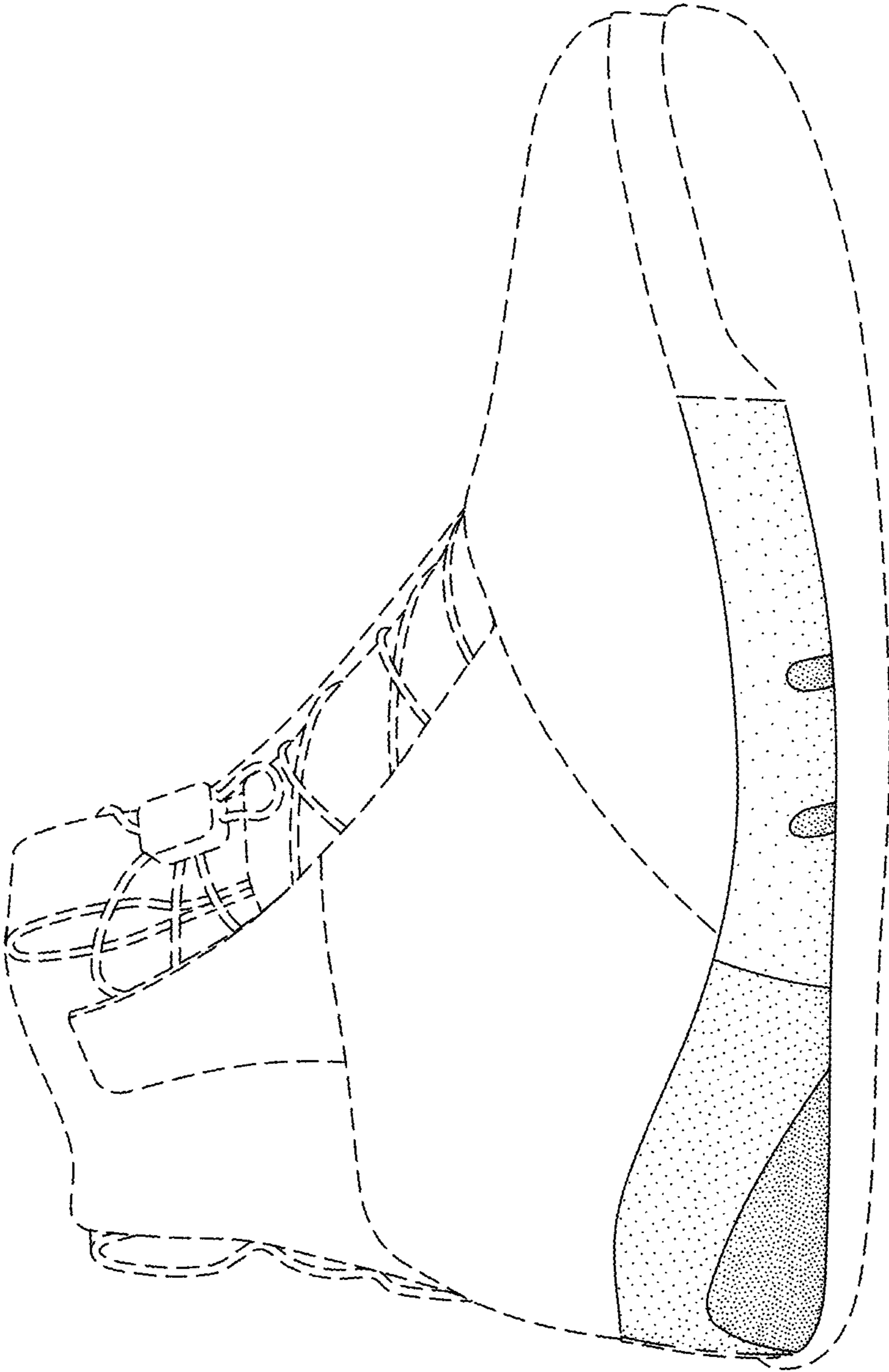

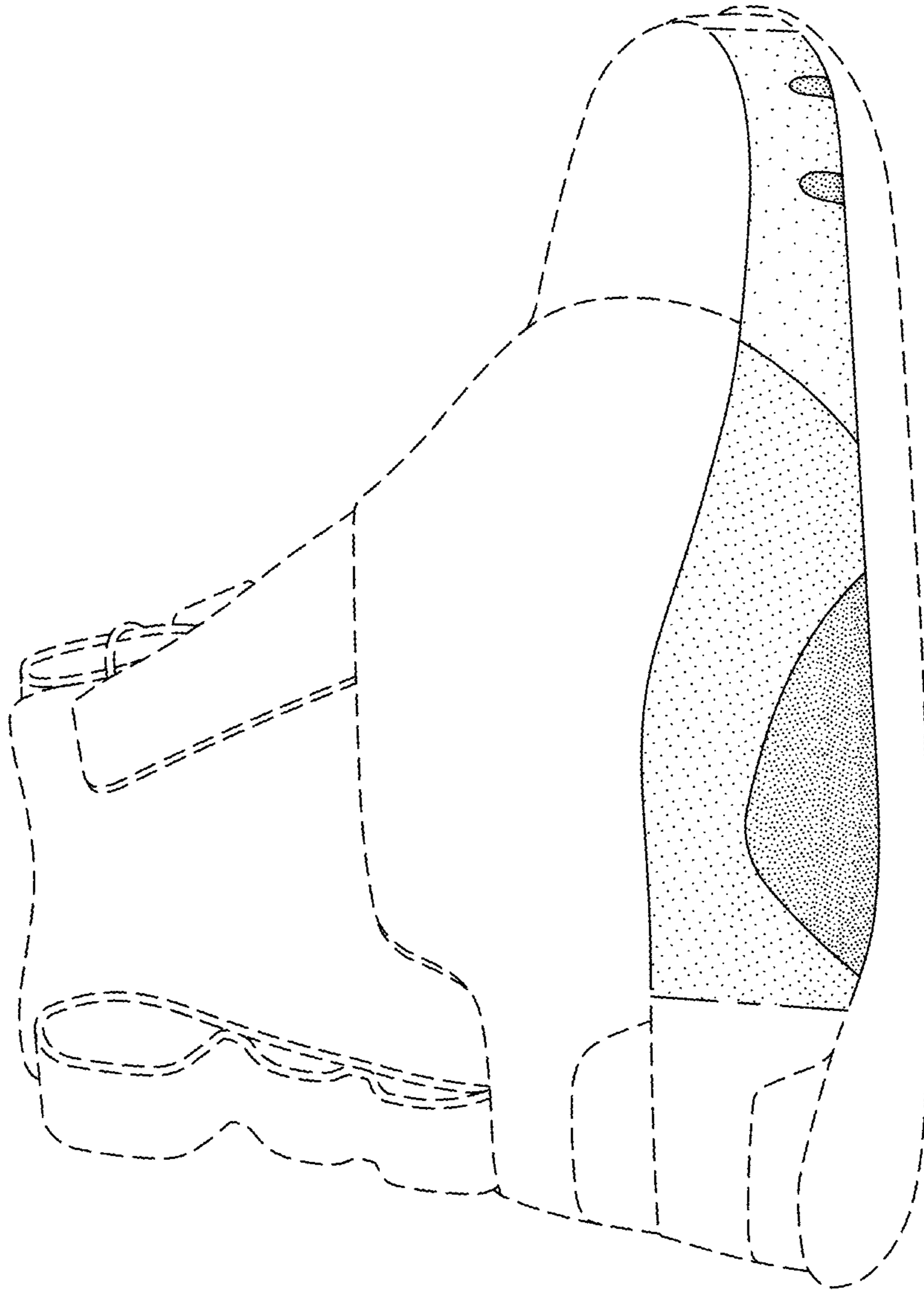
