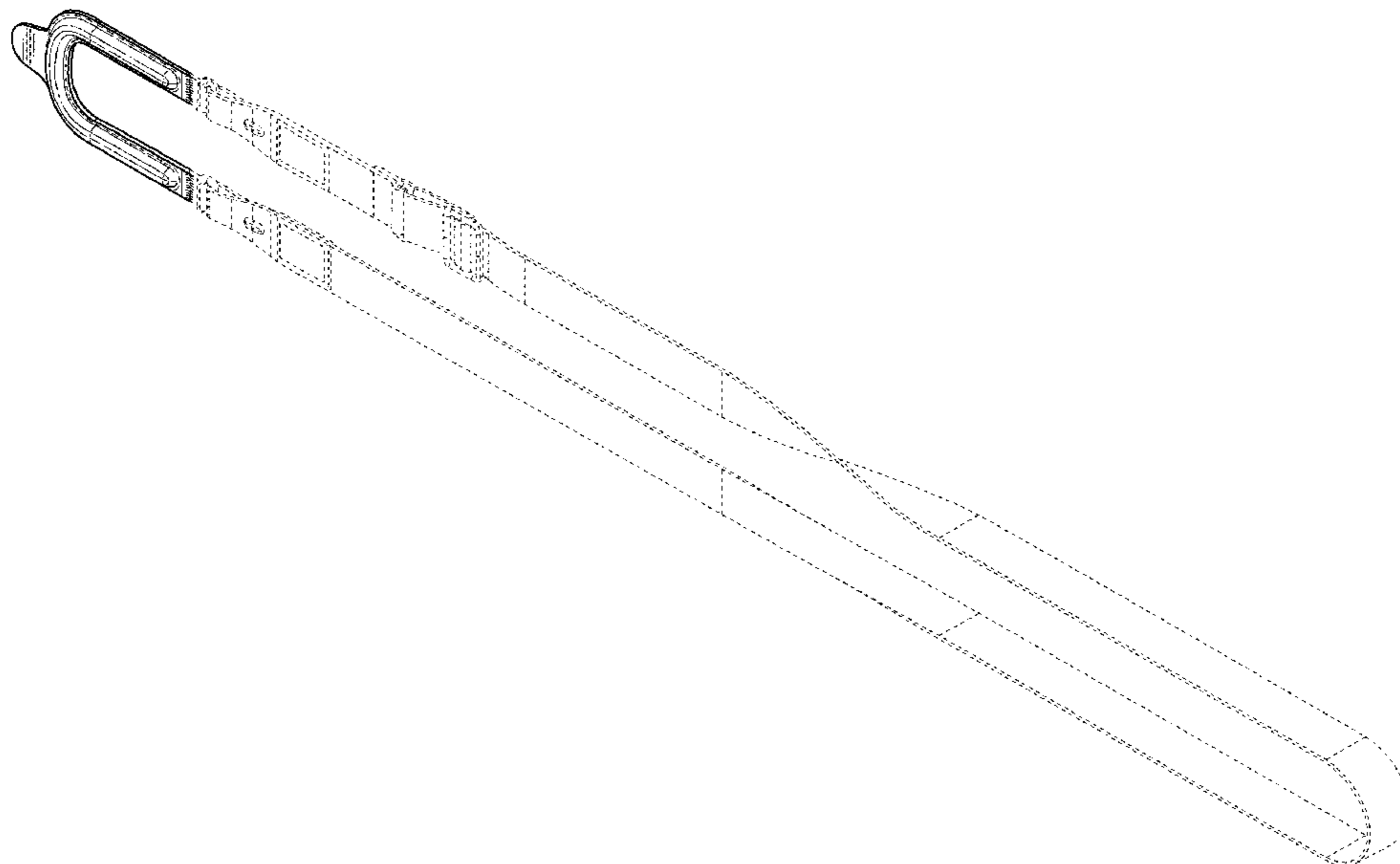
(57) **CLAIM**

We claim the ornamental design for a strap yoke, as shown and described.

DESCRIPTION

FIG. 1 is a left rear perspective view of a strap yoke showing our design;
FIG. 2 is a left view thereof;
FIG. 3 is a right view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines shown in the figures show portions of the strap yoke and a strap that form no part of the claimed design.

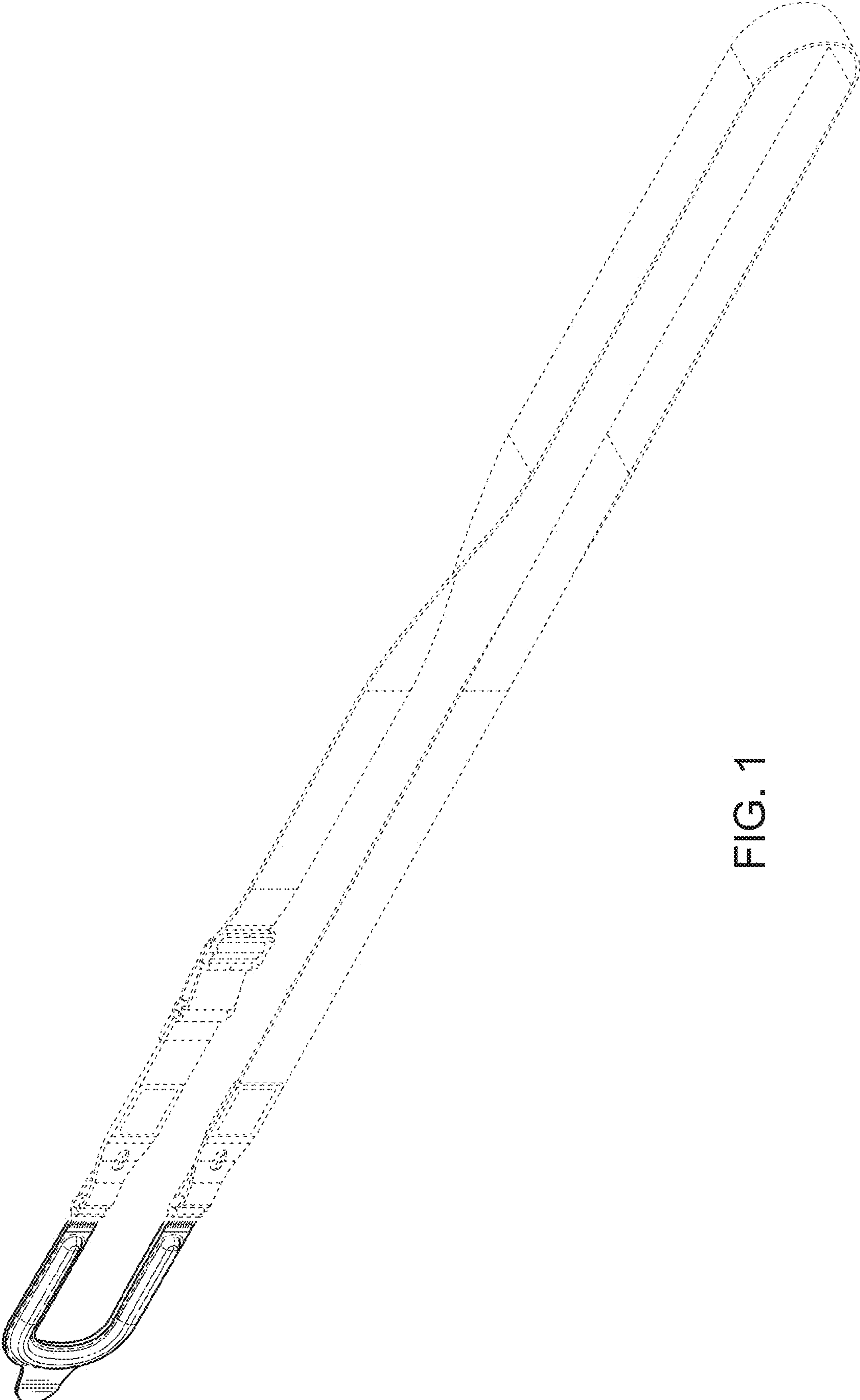

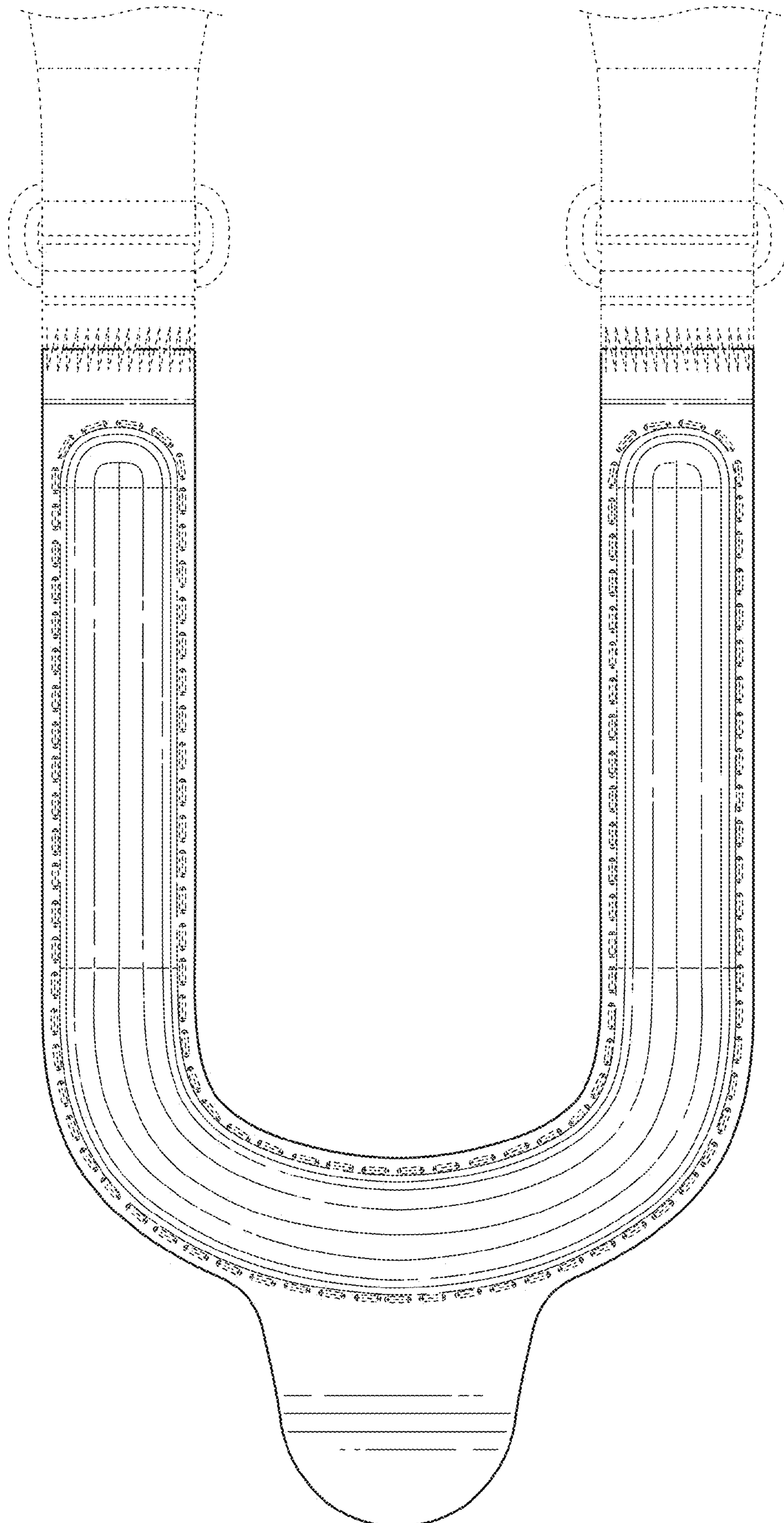

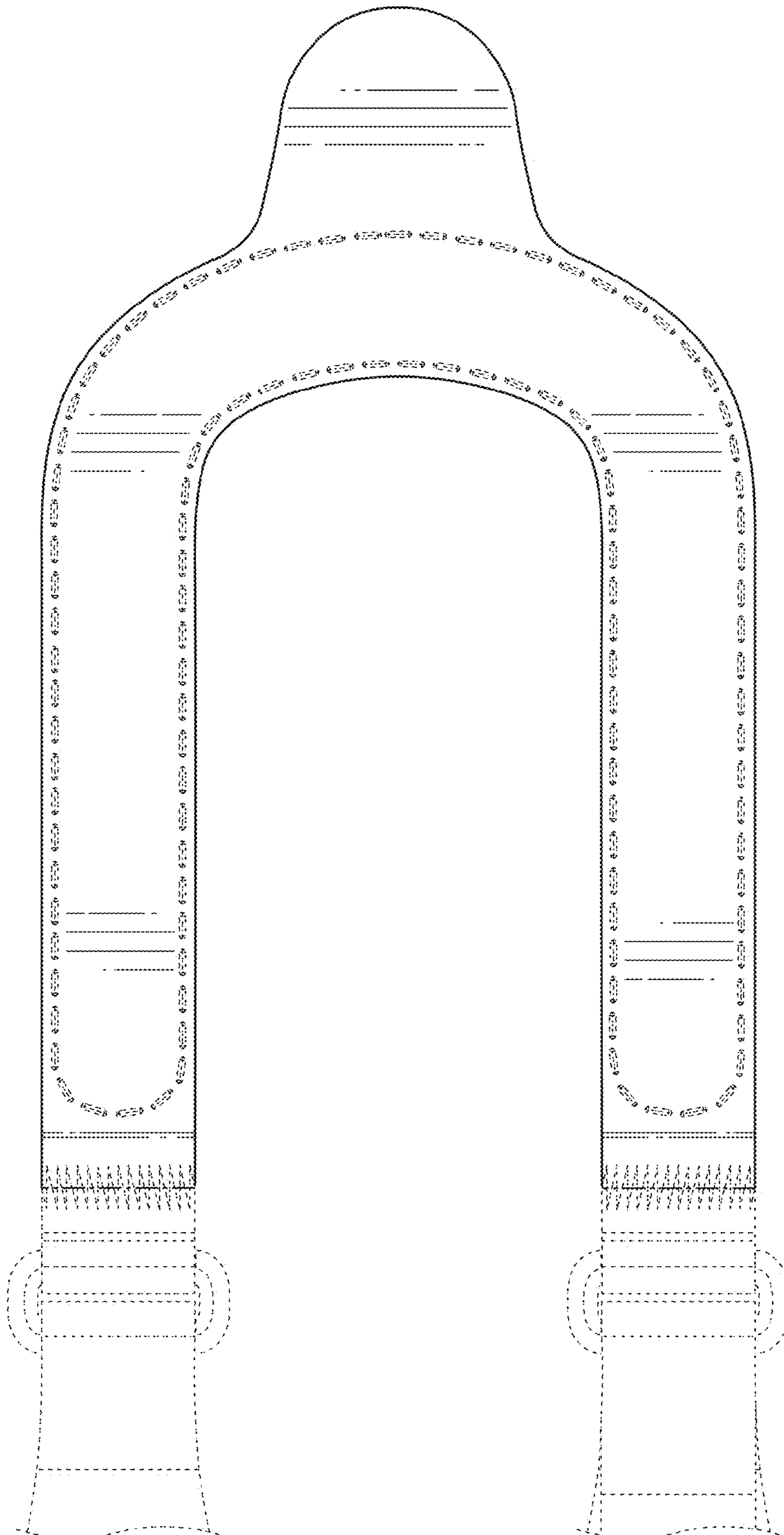

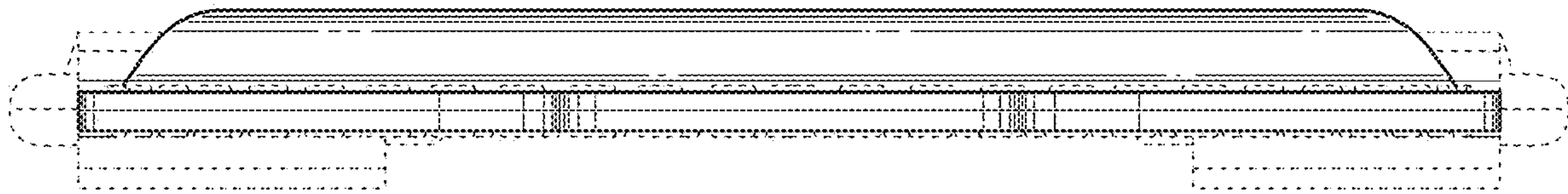

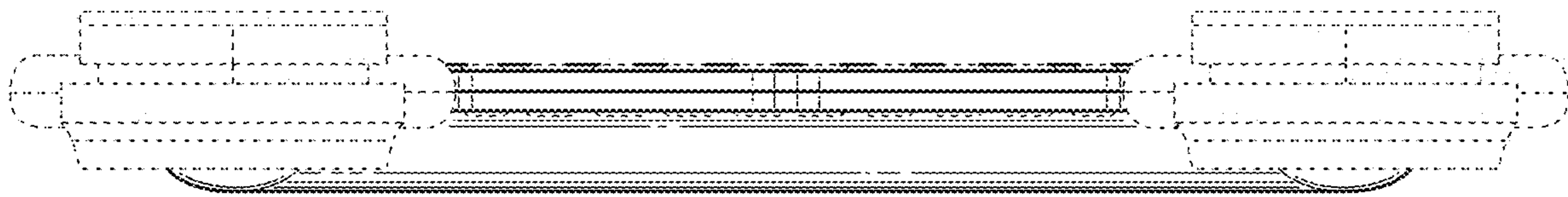

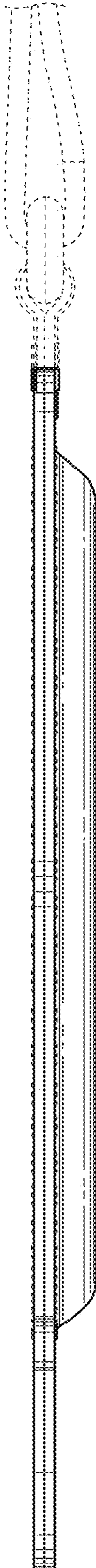

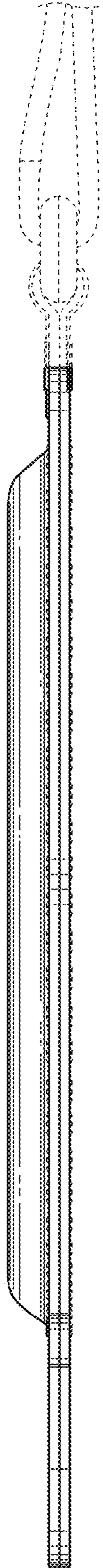
