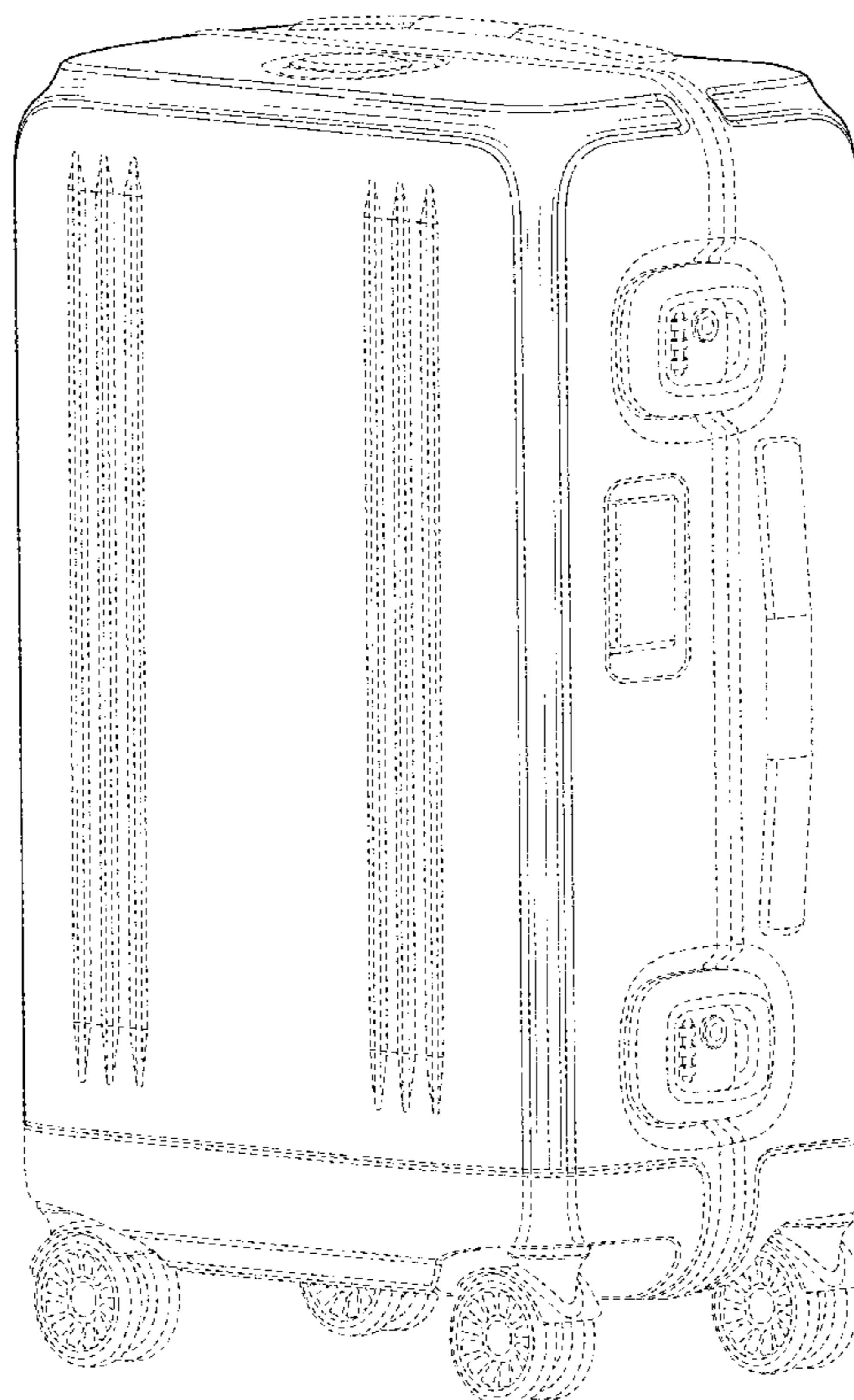
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, right, front perspective view showing the luggage edge;
FIG. 2 is a front view showing the luggage edge;
FIG. 3 is a rear view showing the luggage edge;
FIG. 4 is a left side view showing the luggage edge;

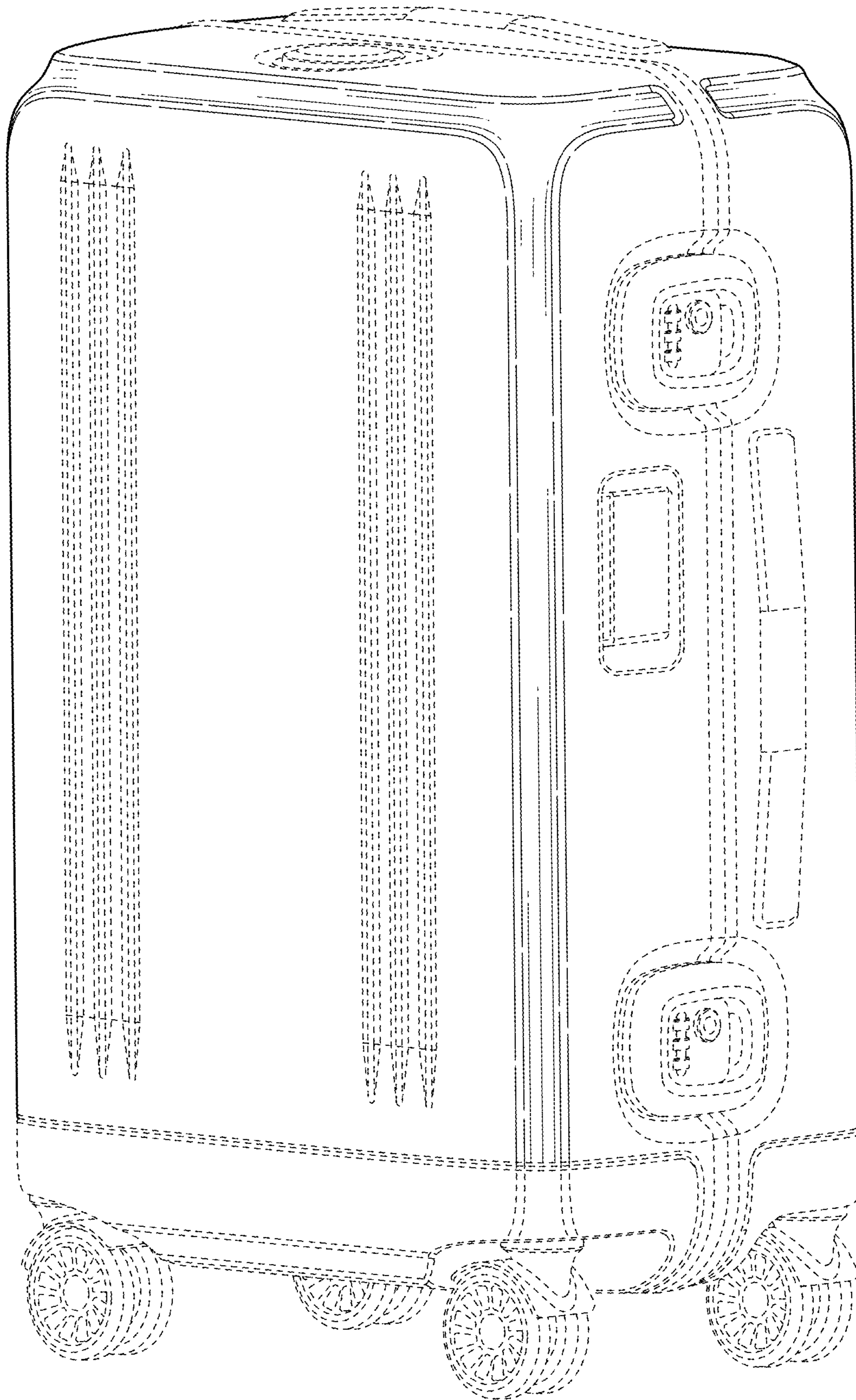

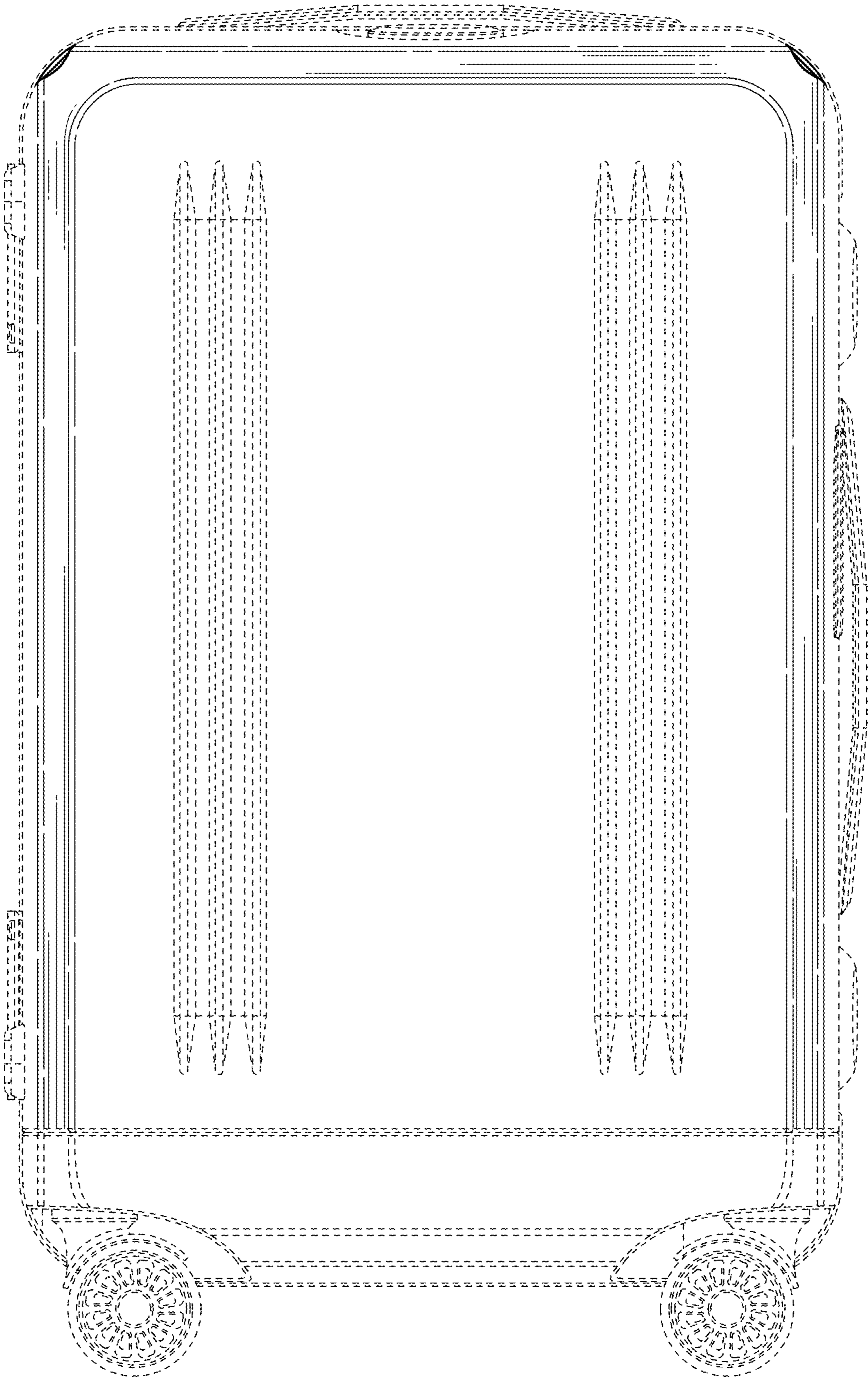

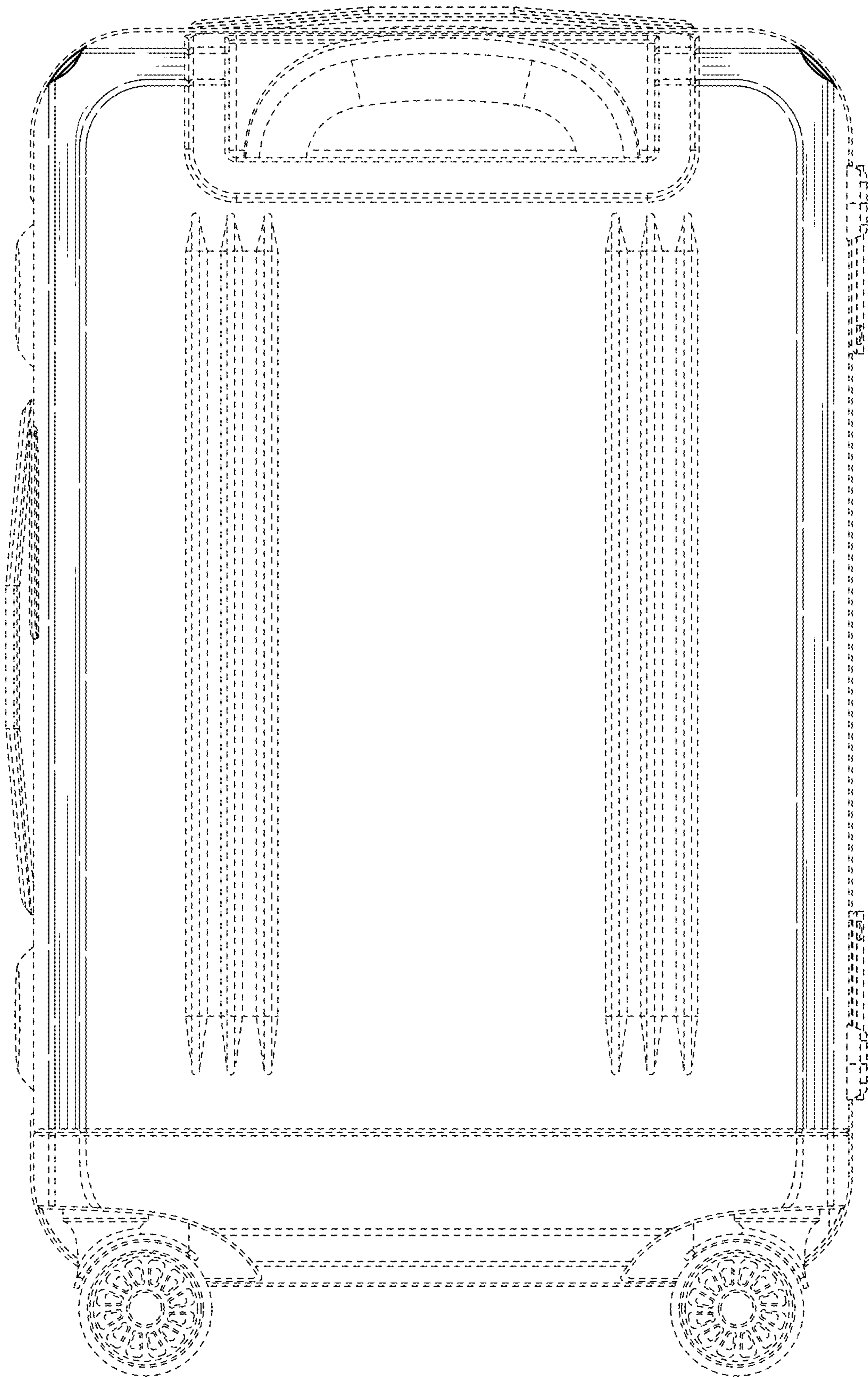

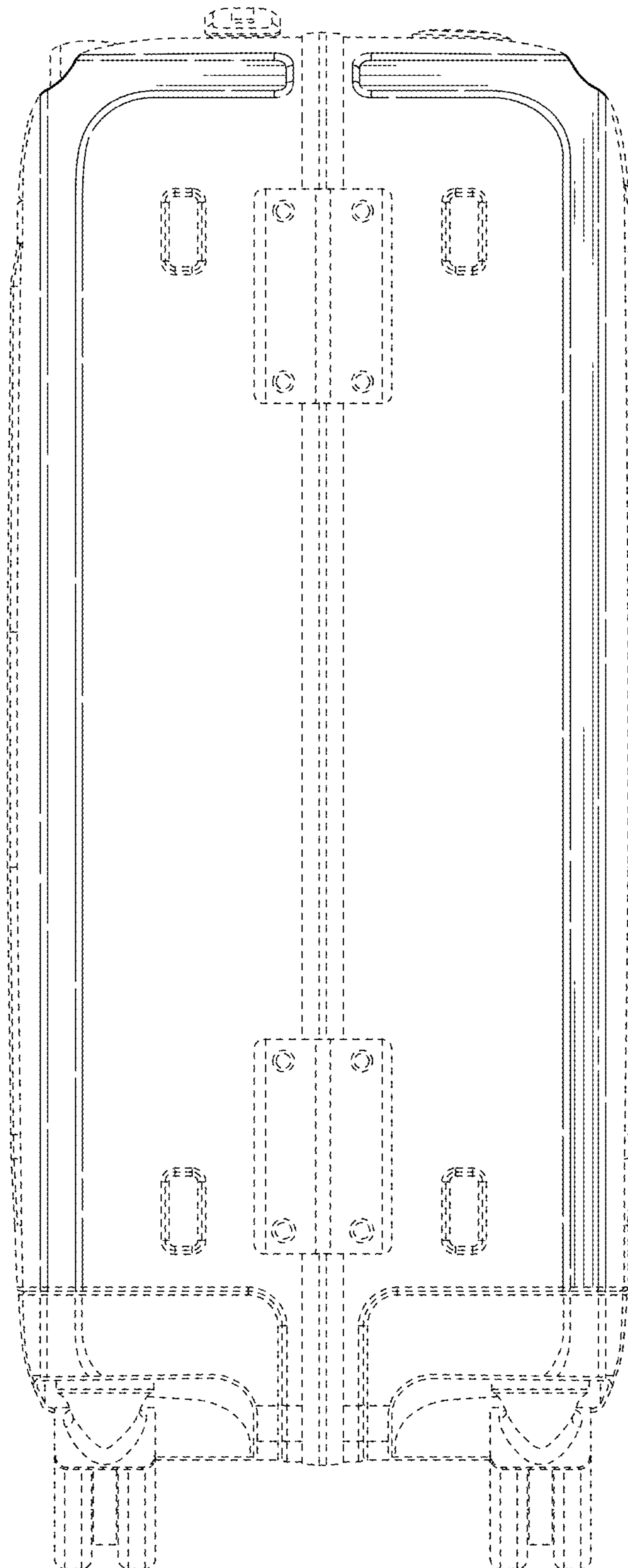

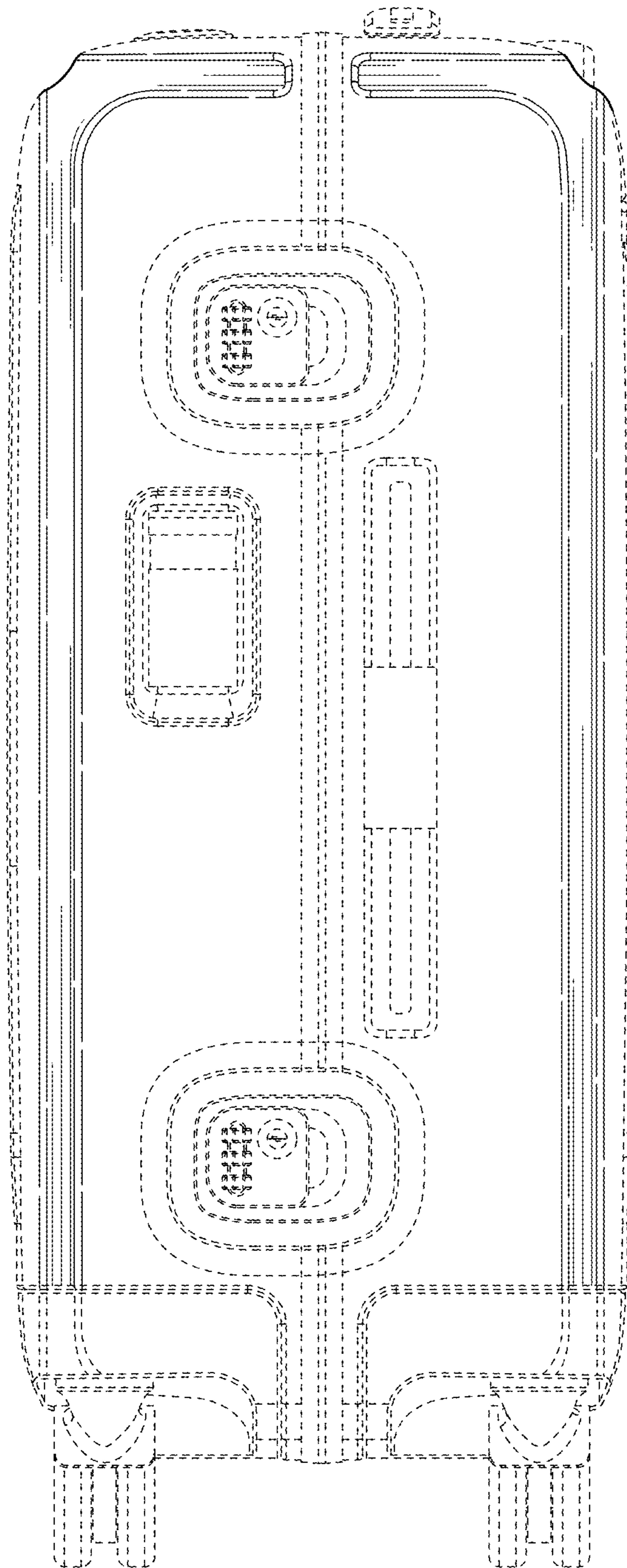

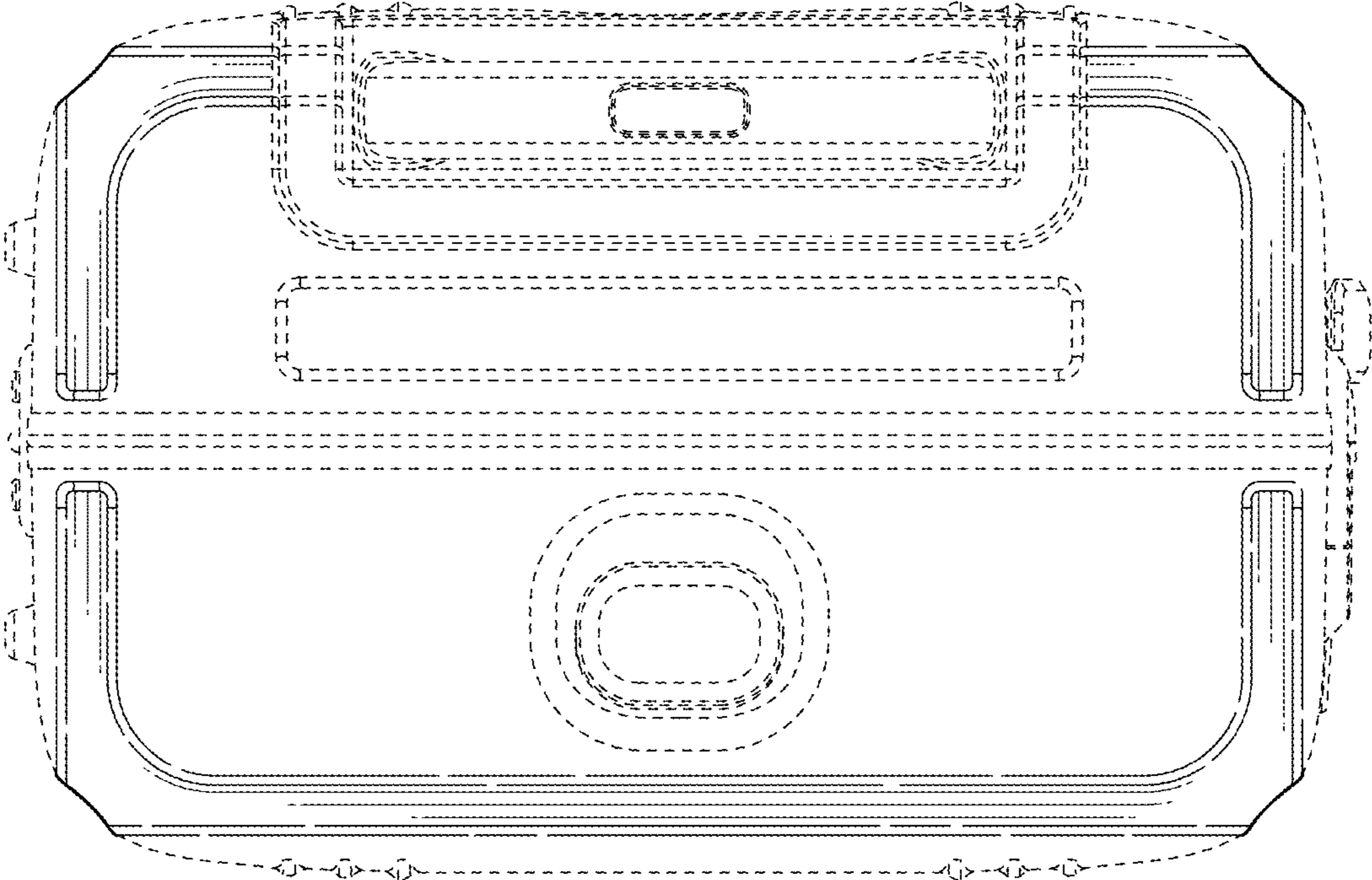

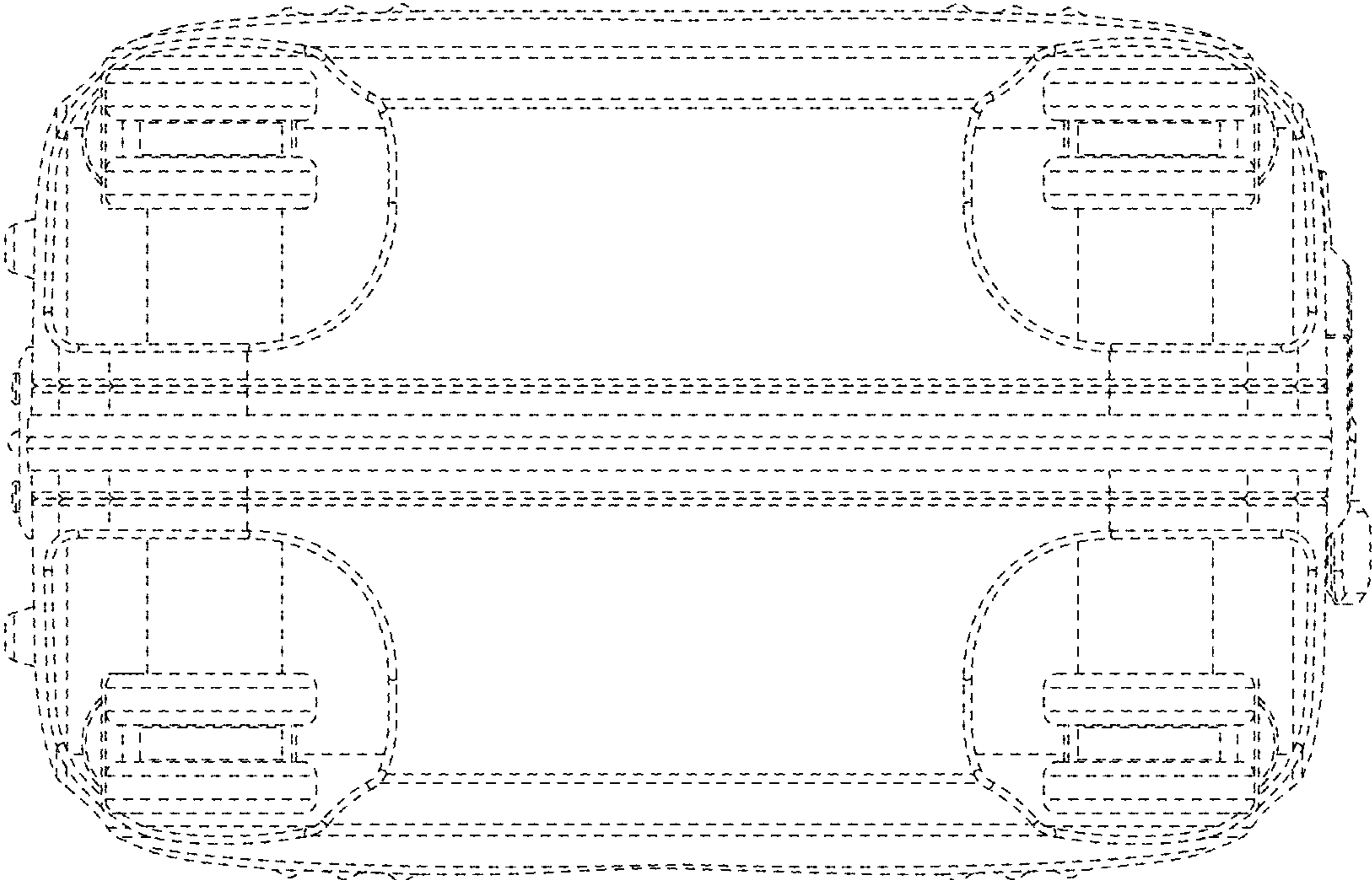
