(57) **CLAIM**

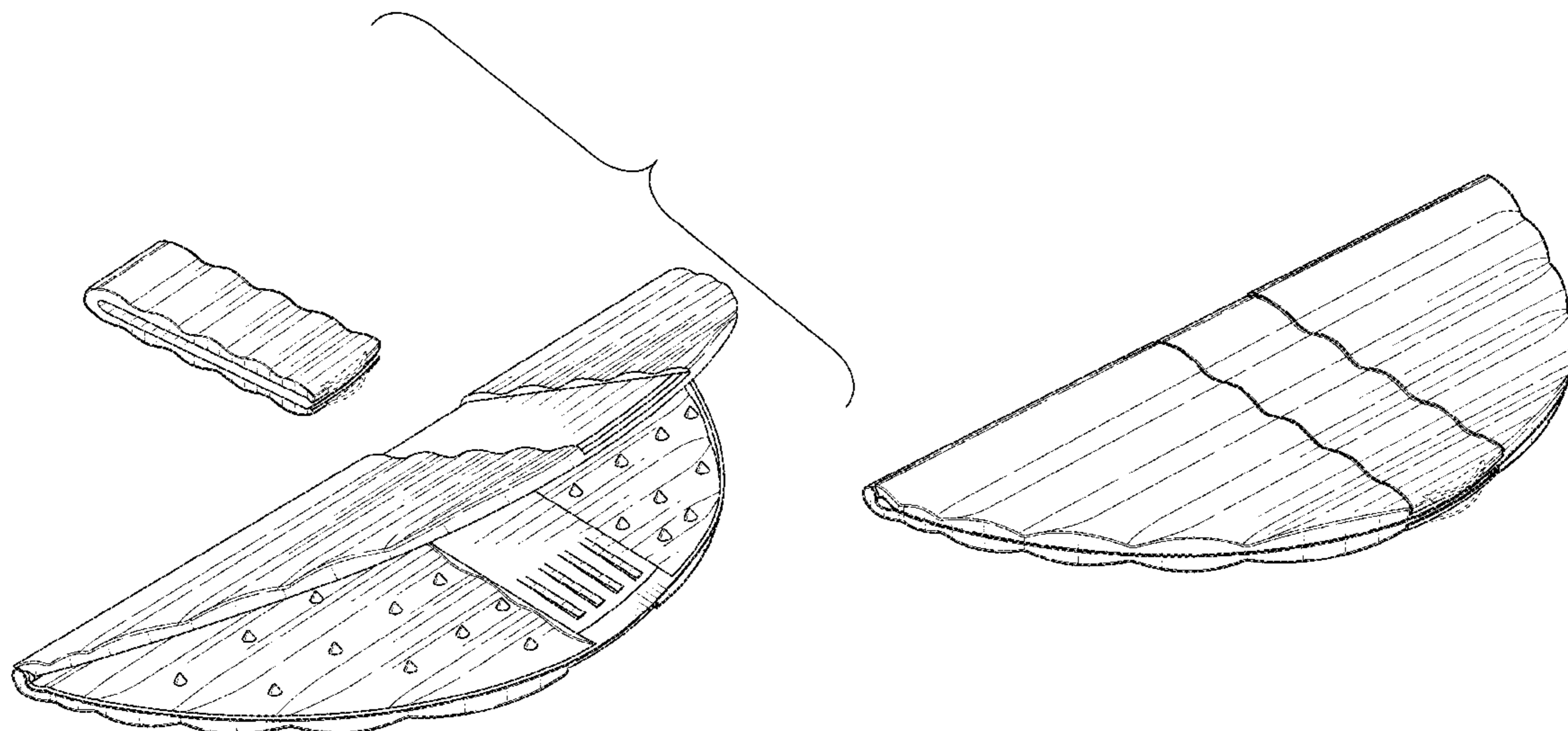
The ornamental design for a curtain clamp assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective exploded view of a first embodiment of a curtain clamp assembly showing my new

design, including a clasp component and two clamp components in a partially open position;  
 FIG. 2 is a front perspective view of the two clamp components in a partially open position;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is a front perspective view of the clasp component;  
 FIG. 10 is a rear elevational view thereof;  
 FIG. 11 is a front elevational view thereof;  
 FIG. 12 is a top plan view thereof, the bottom view being identical;  
 FIG. 13 is a right side elevational view thereof, the right and left side elevational views of the clasp component being mirror images;  
 FIG. 14 is a front perspective view of the curtain clamp assembly, including the clasp component assembled onto the two clamp components in a closed position;  
 FIG. 15 is a front elevational view thereof;  
 FIG. 16 is a rear elevational view thereof;  
 FIG. 17 a right side elevational view thereof;  
 FIG. 18 a left side elevational view thereof;  
 FIG. 19 is a top plan view thereof;  
 FIG. 20 is a bottom plan view thereof;  
 FIG. 21 is a top perspective view of the two clamp components in a fully open position;  
 FIG. 22 is a bottom perspective view thereof;  
 FIG. 23 is a bottom perspective exploded view of the clasp component and the two clamp components in a disassembled state;  
 FIG. 24 is a top perspective exploded view of the clasp component and the two clamp components in a disassembled state; and,  
 FIG. 25 is a front perspective view of a second embodiment of a curtain clamp assembly as in FIG. 2 except for the central gripping ribs illustrated in FIG. 2.  
 The broken lines depict portions of the curtain clamp assembly that form no part of the claimed design.

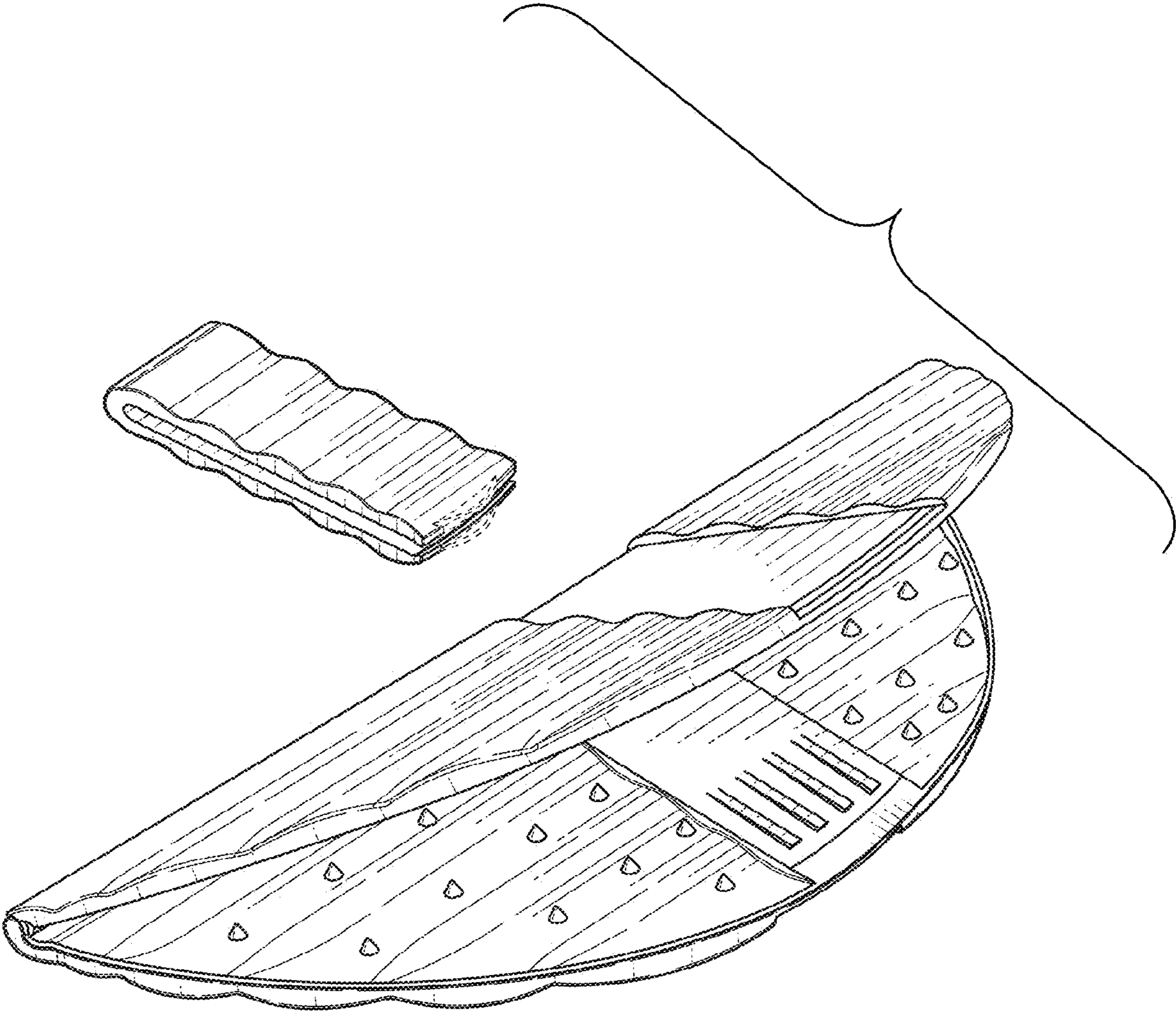

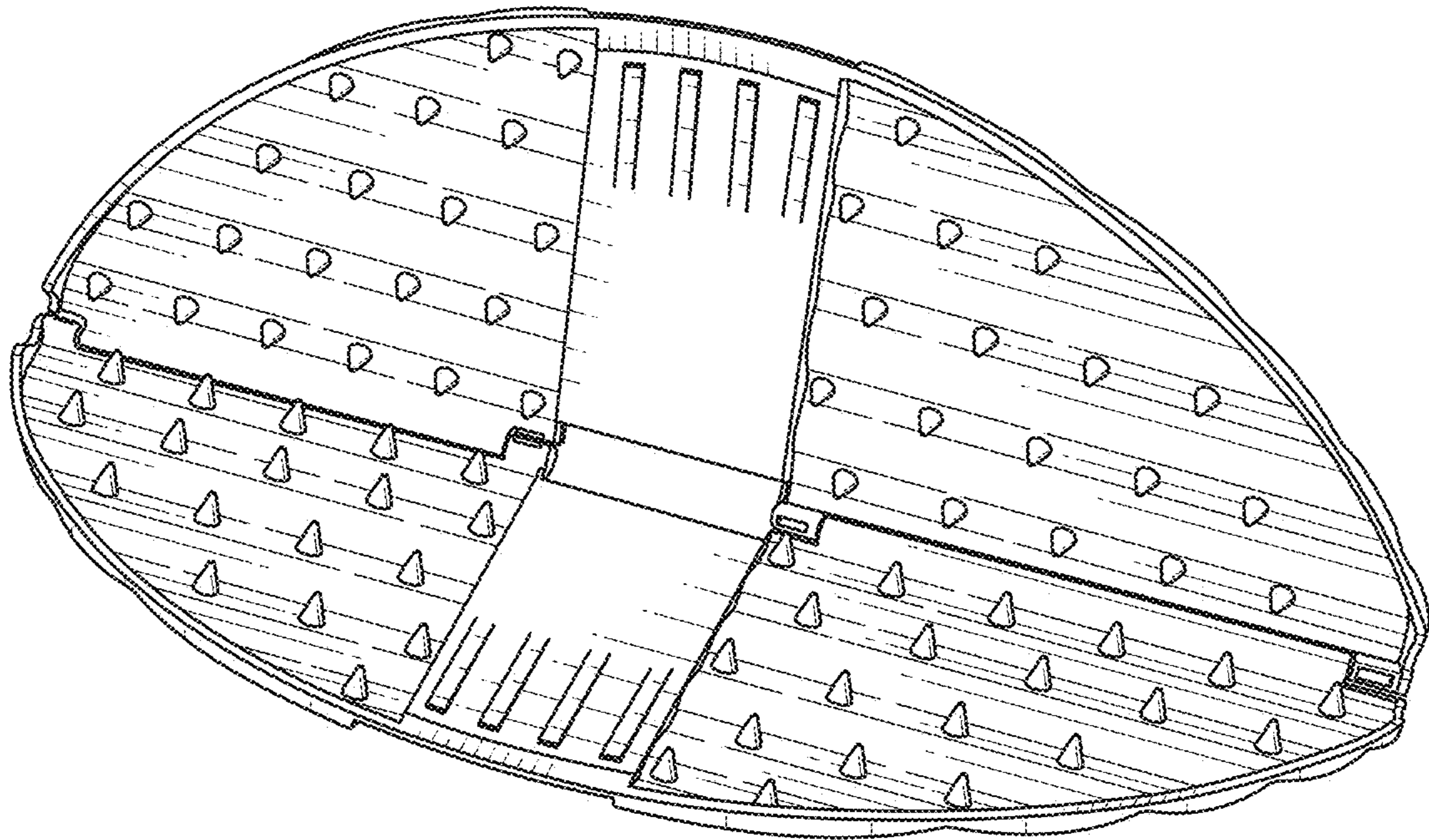

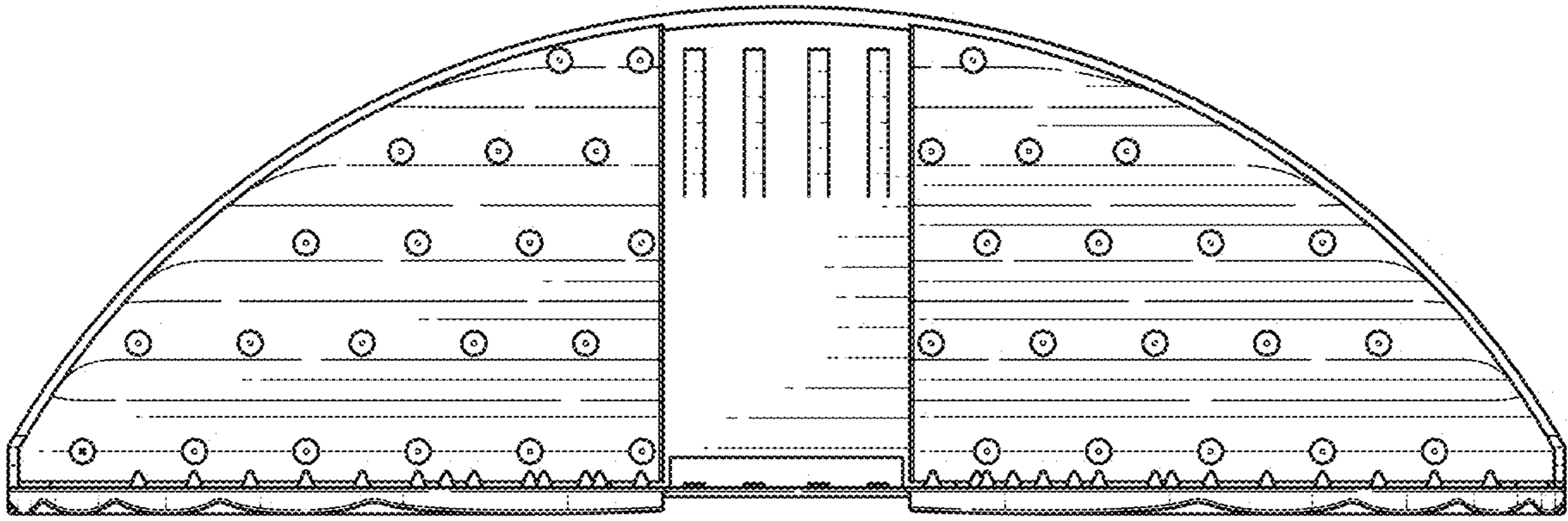

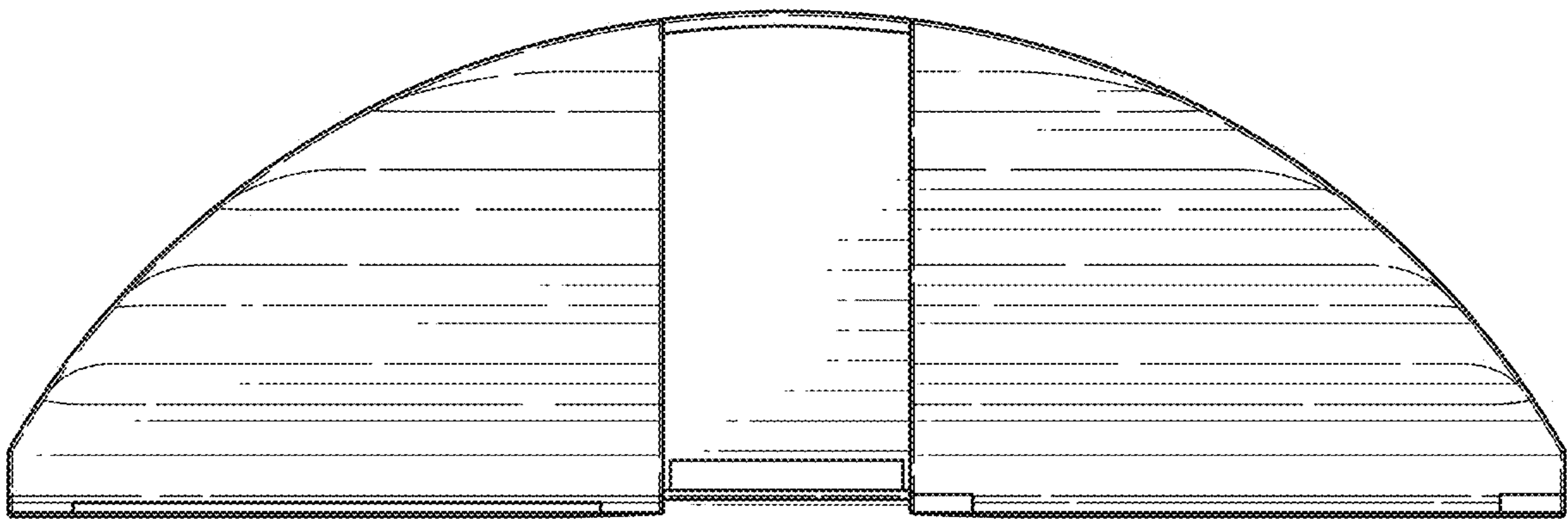

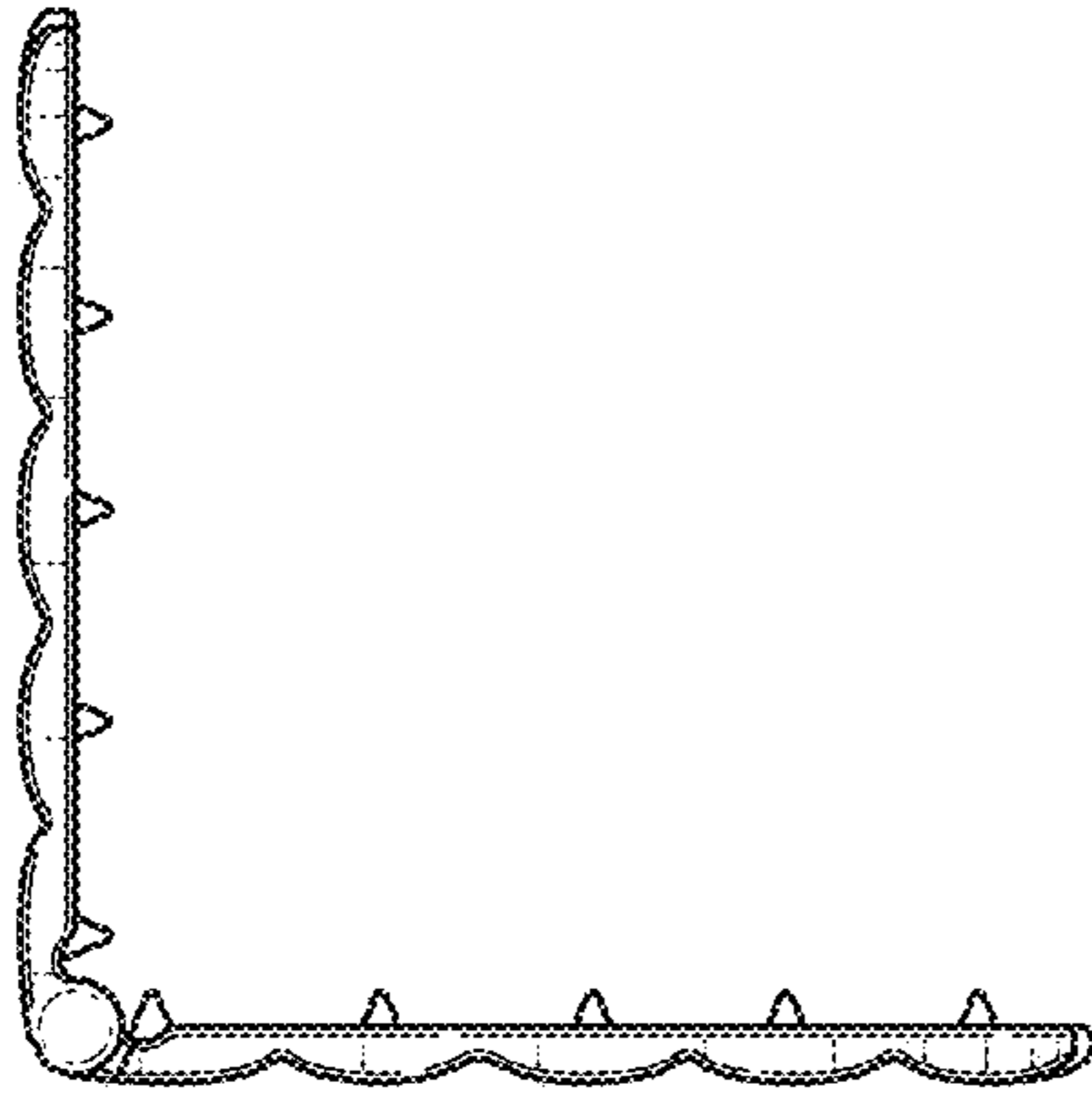

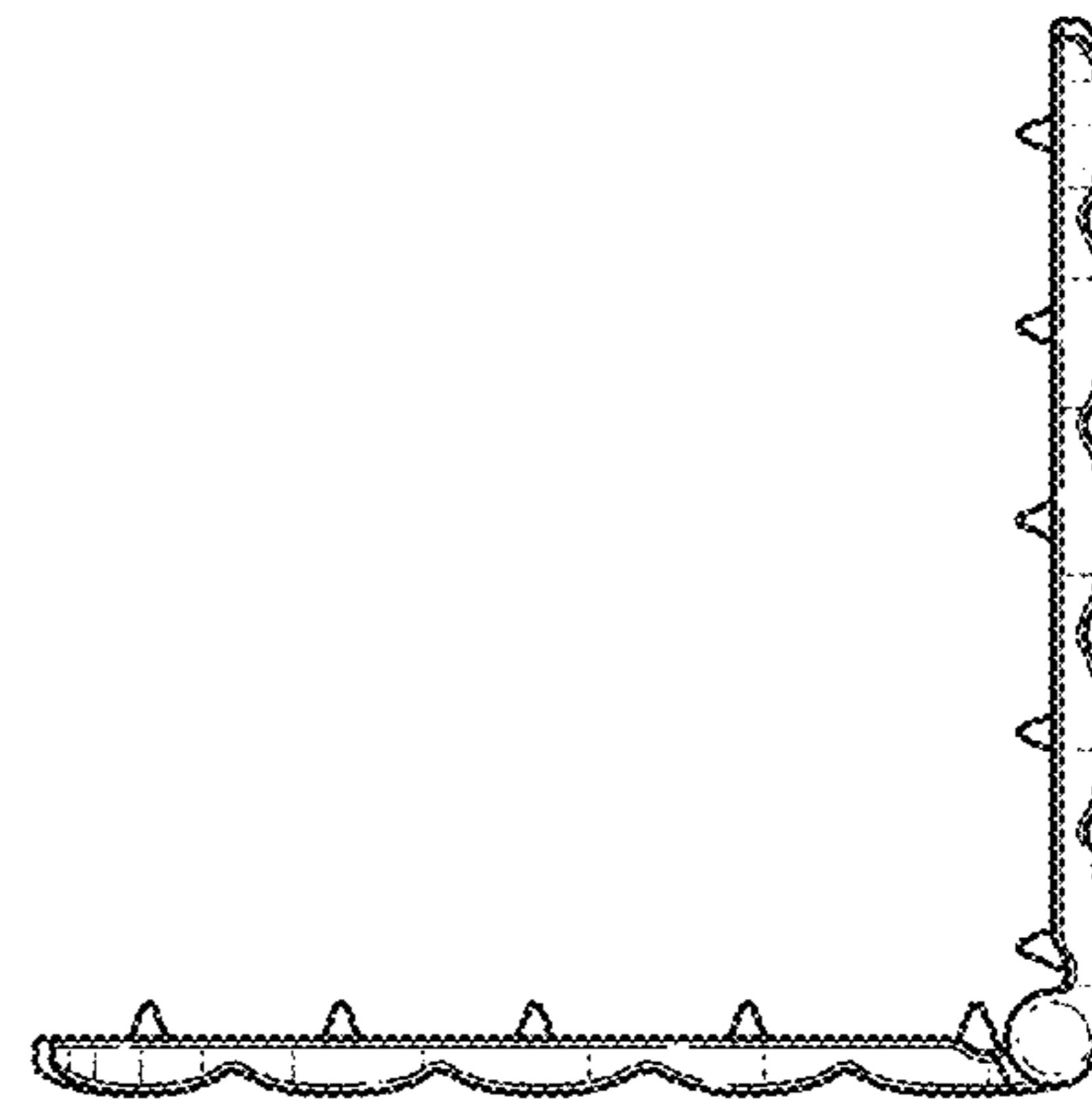

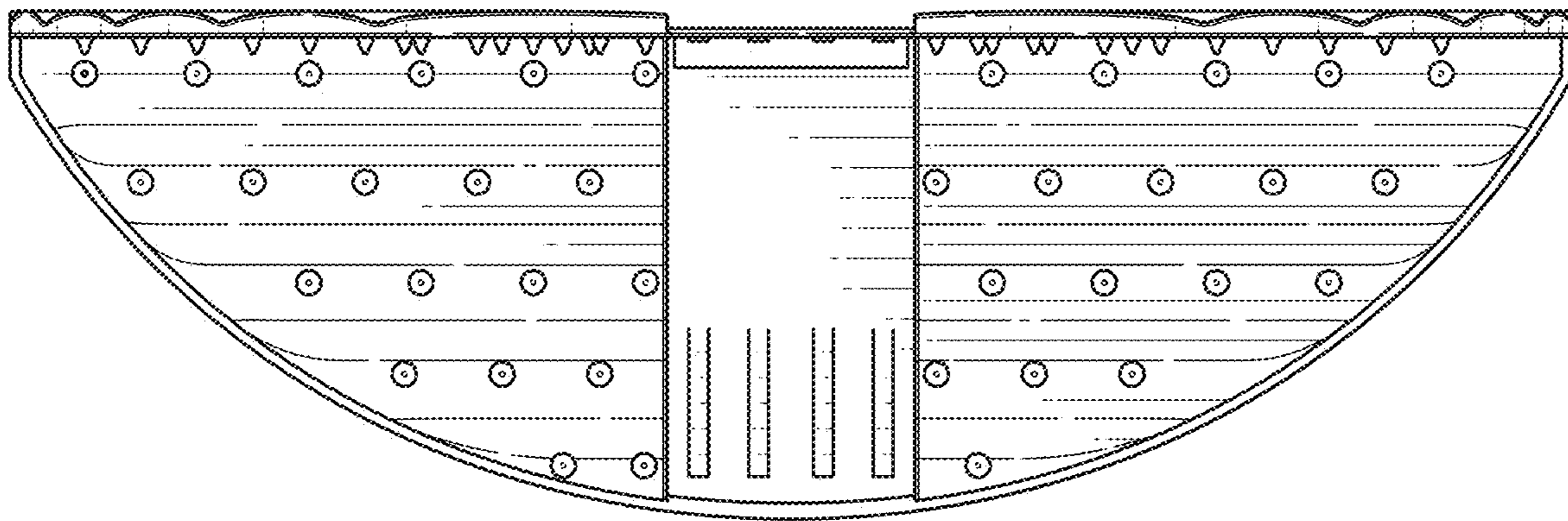

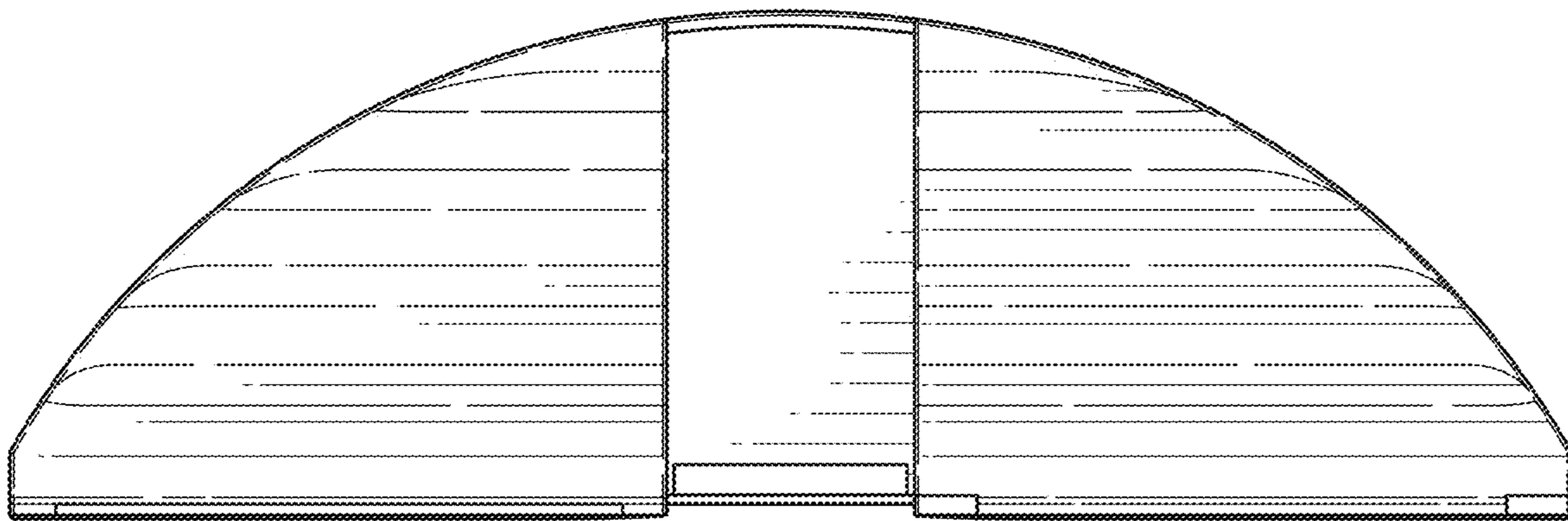

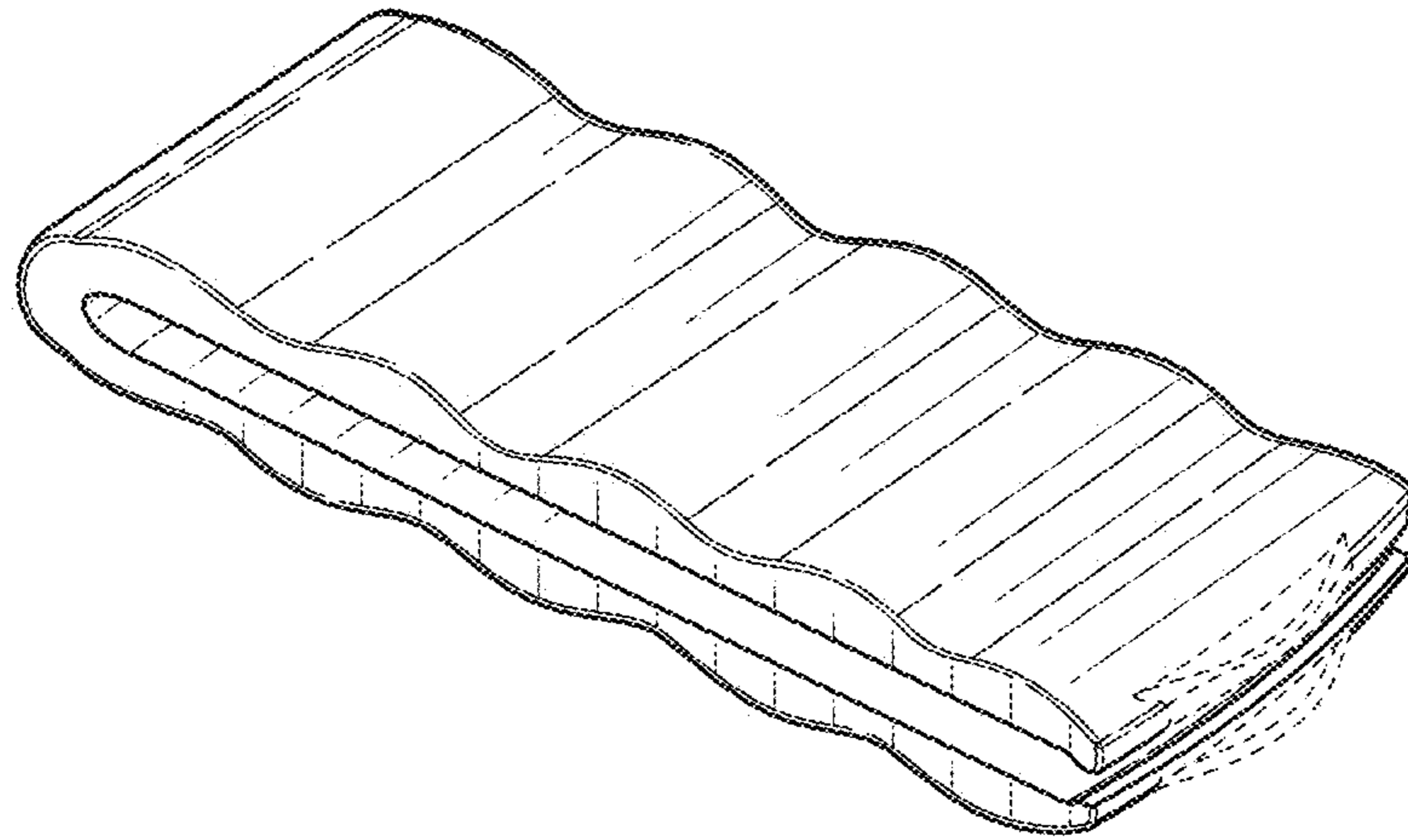

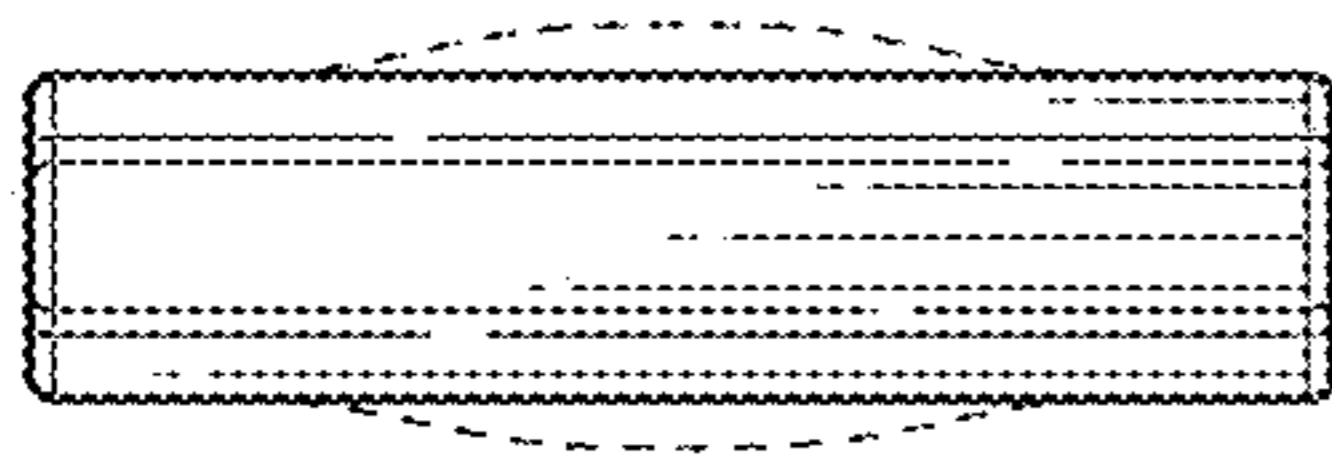

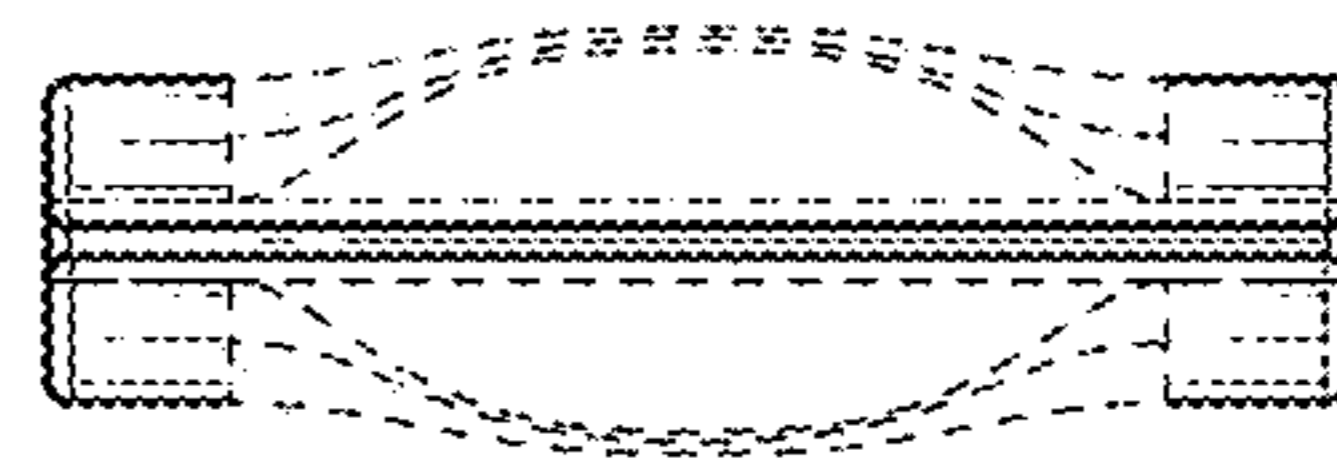

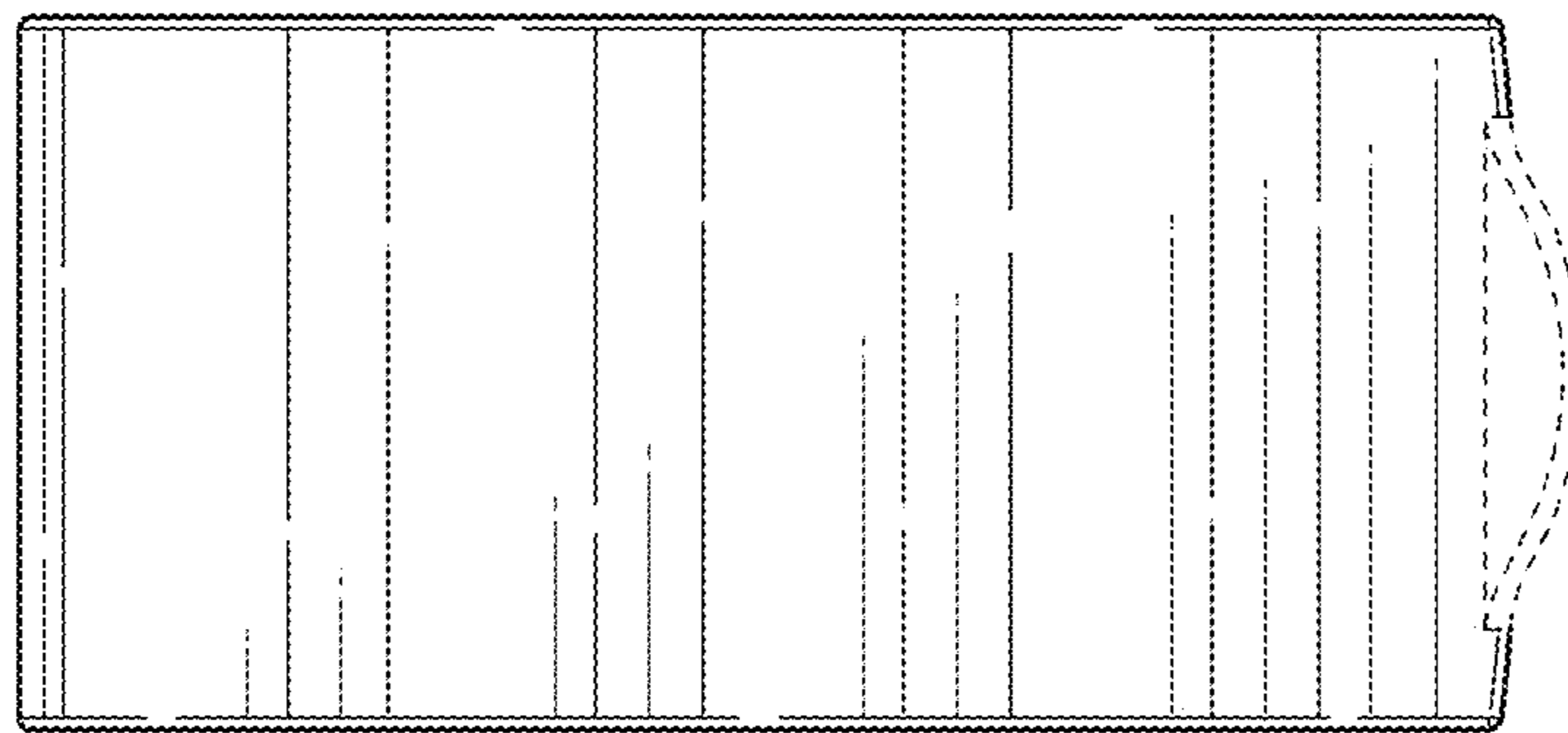

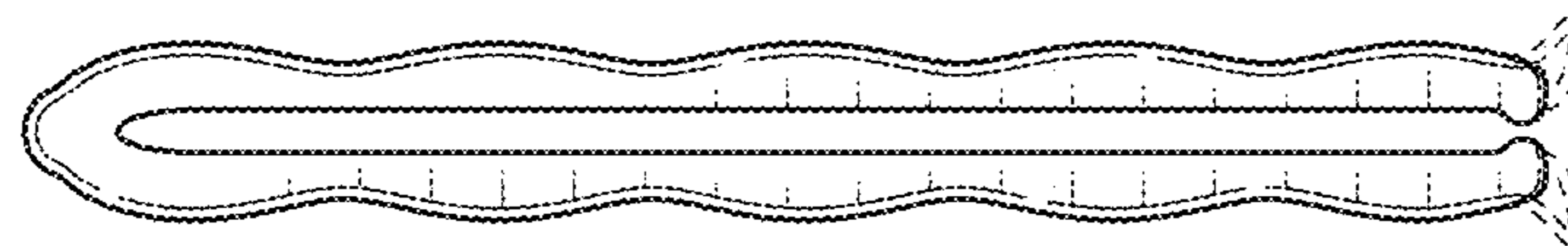

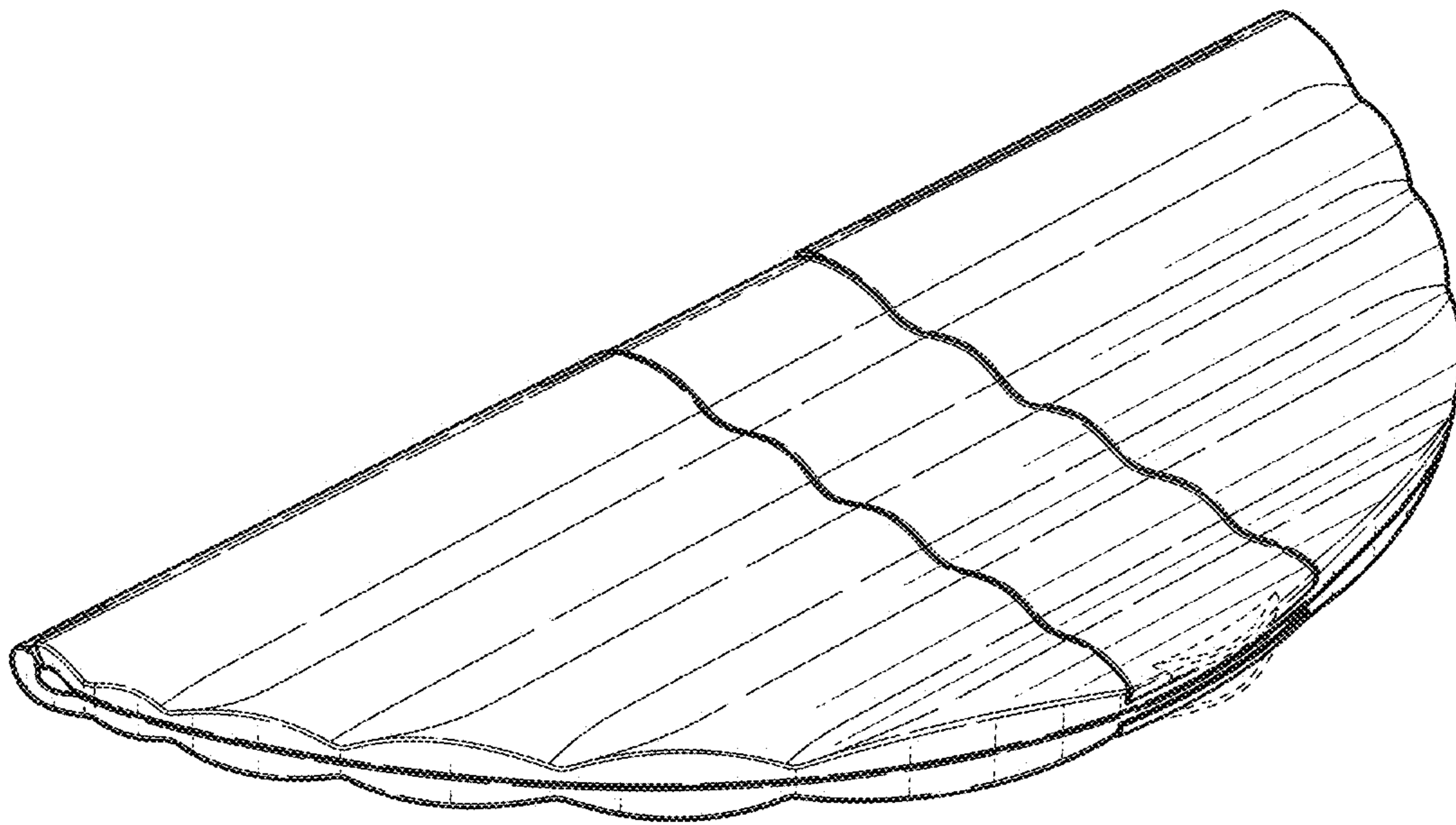

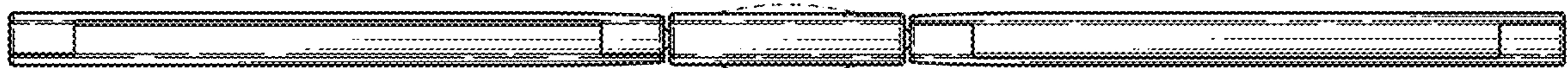

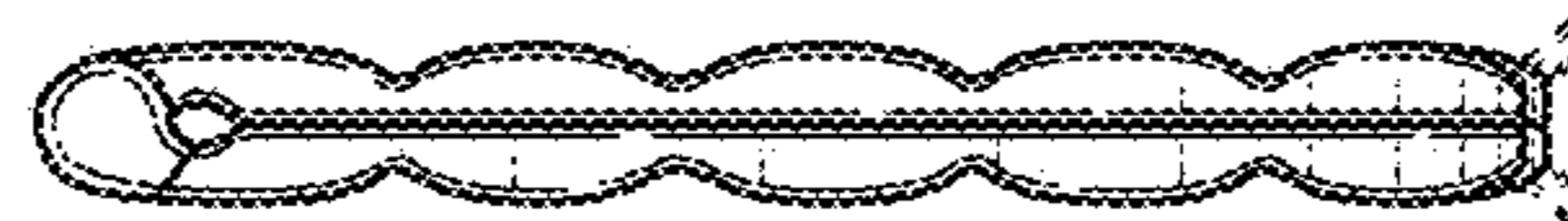

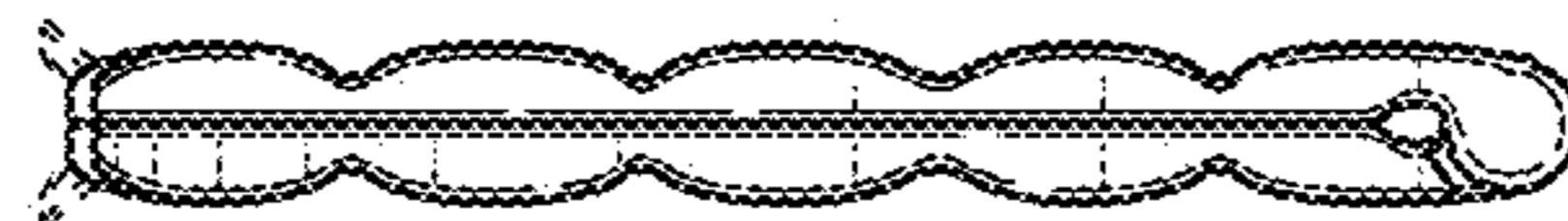

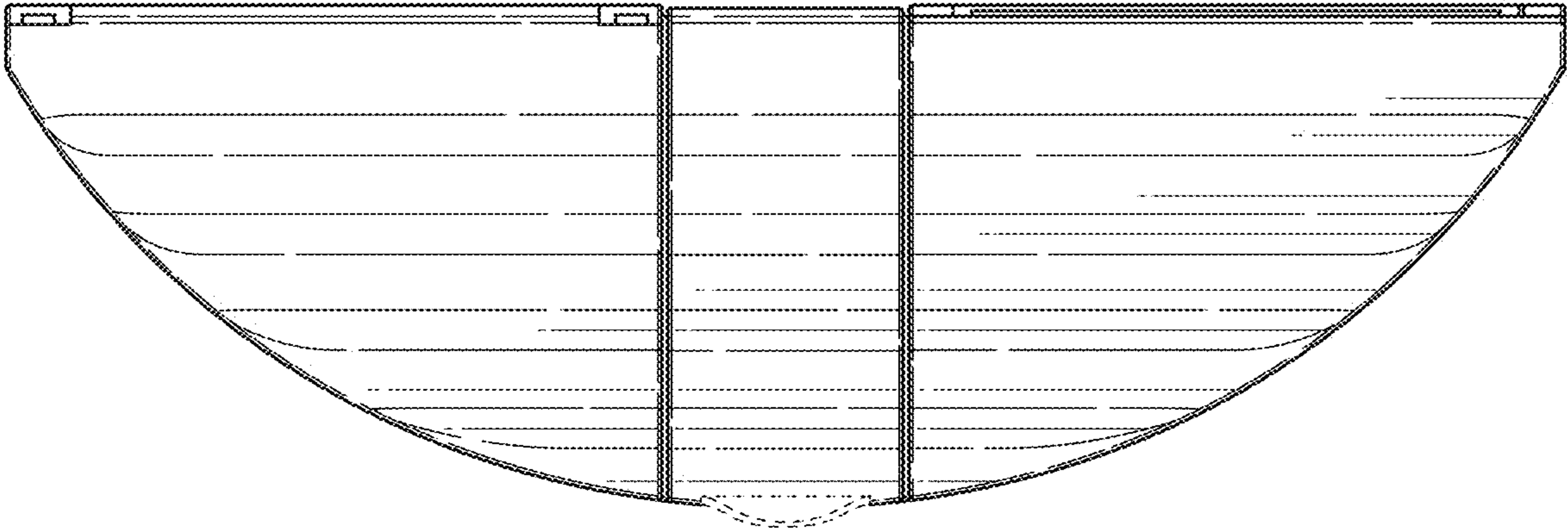

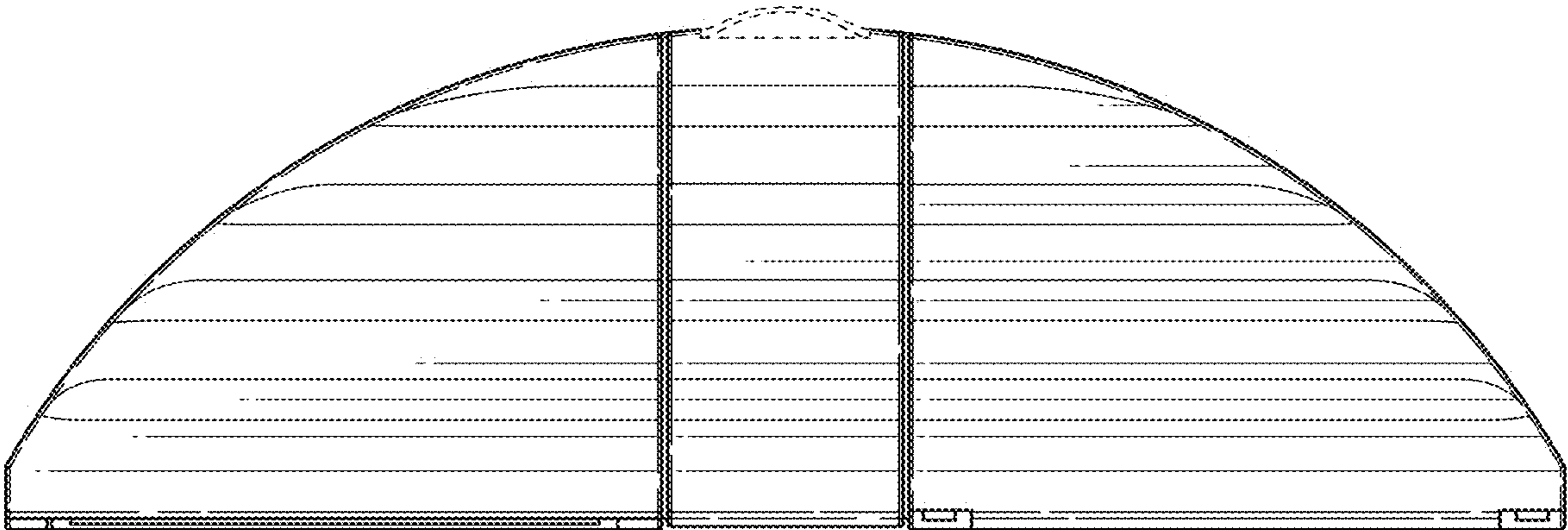

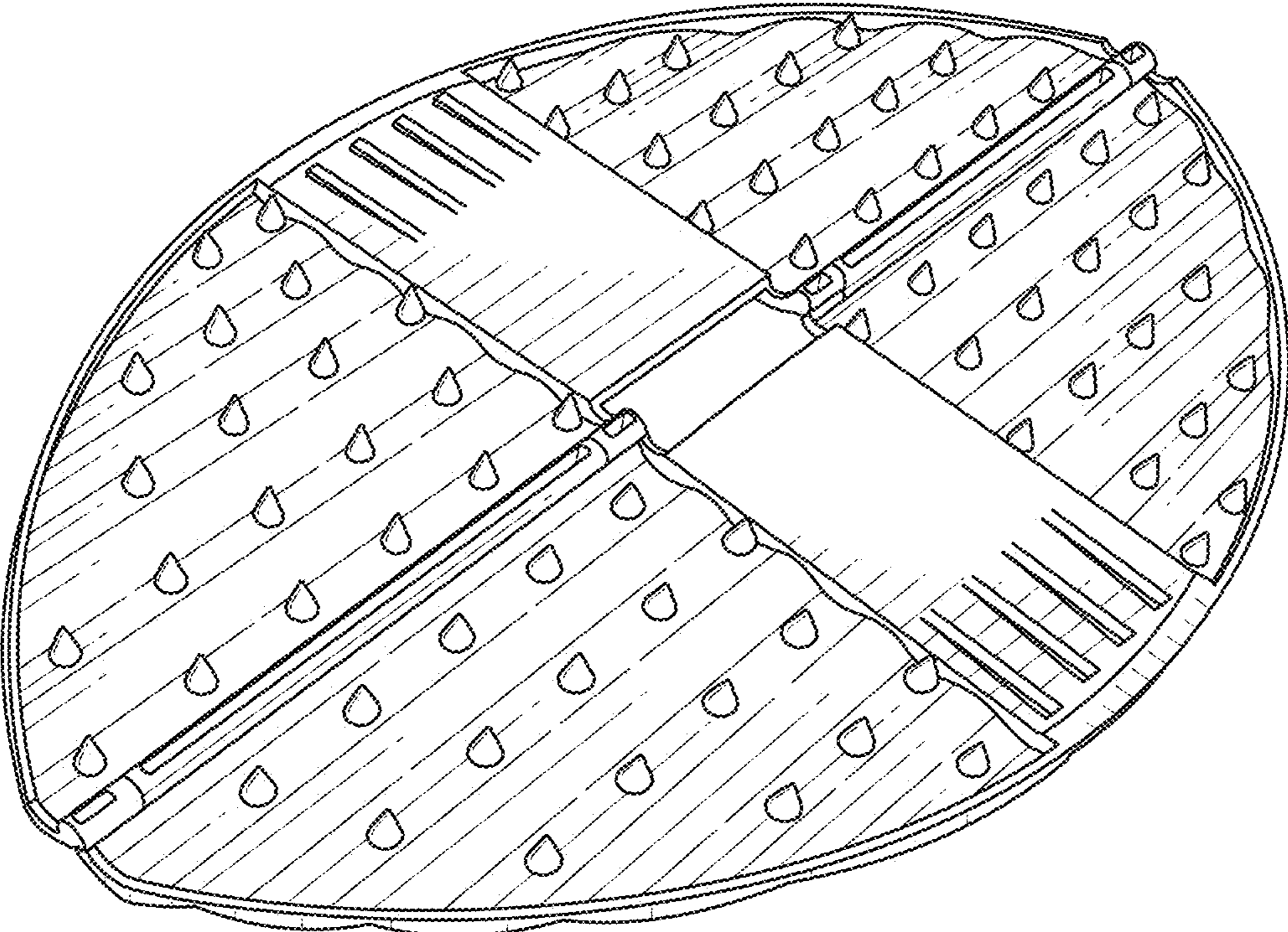

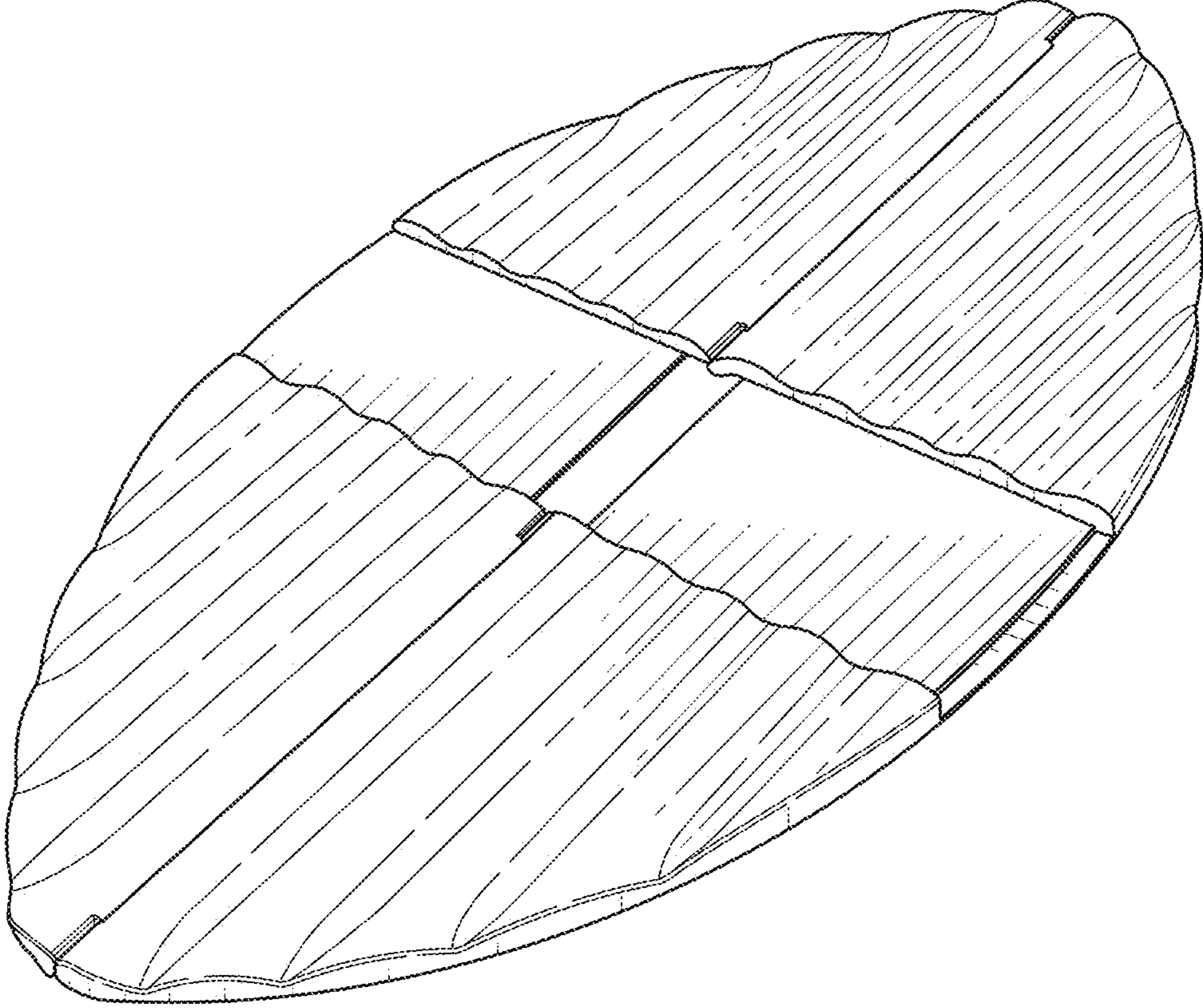

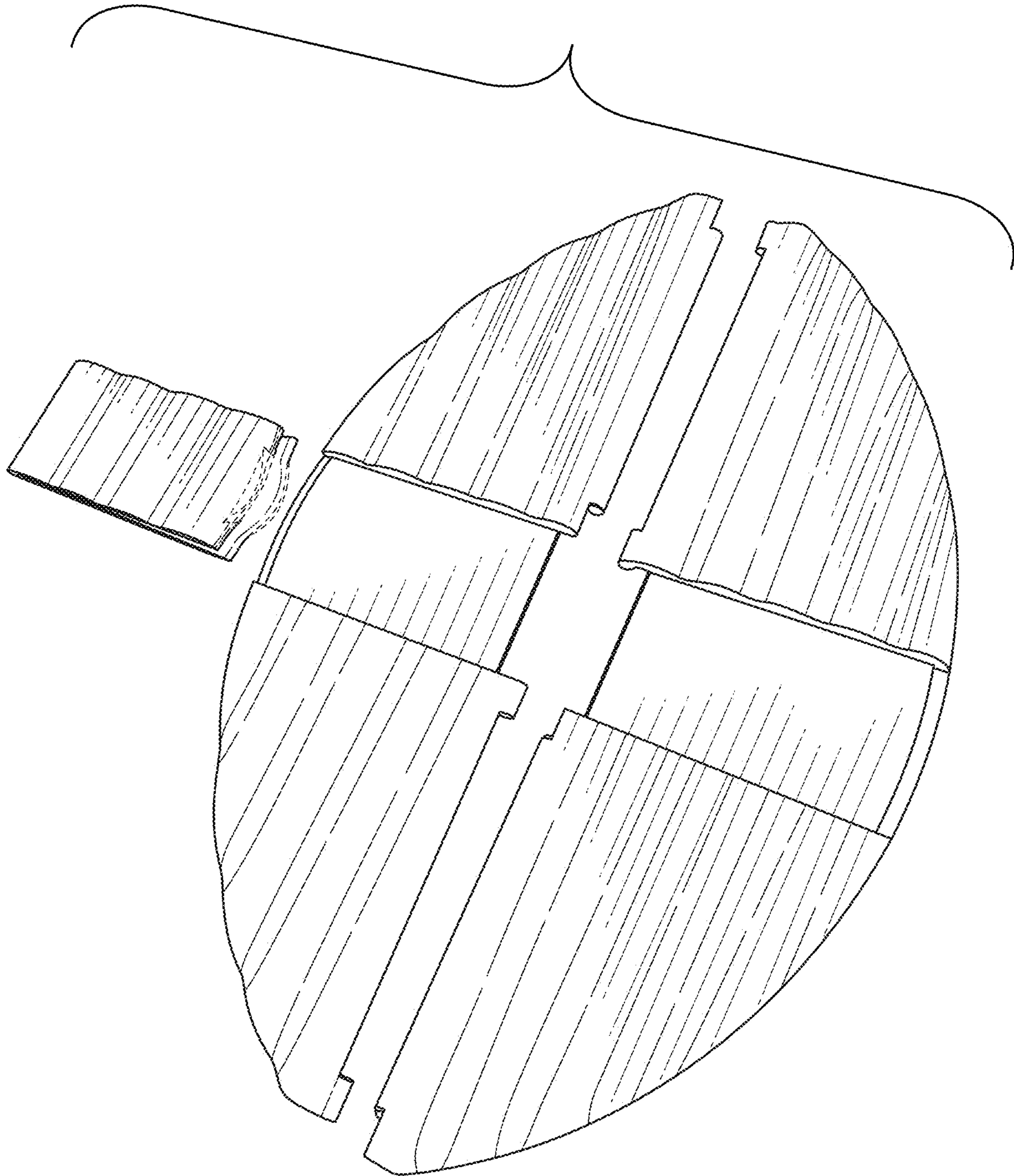

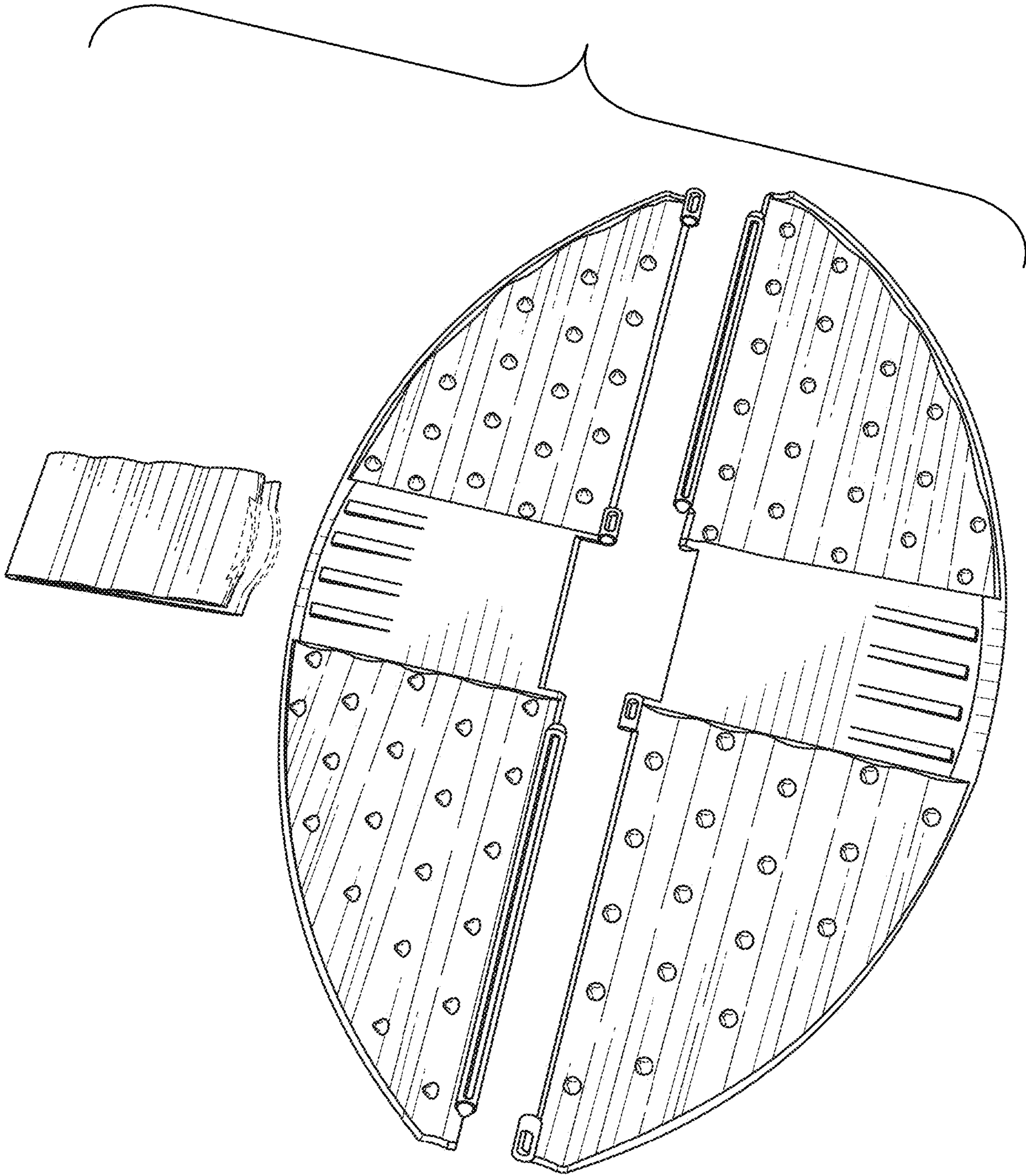

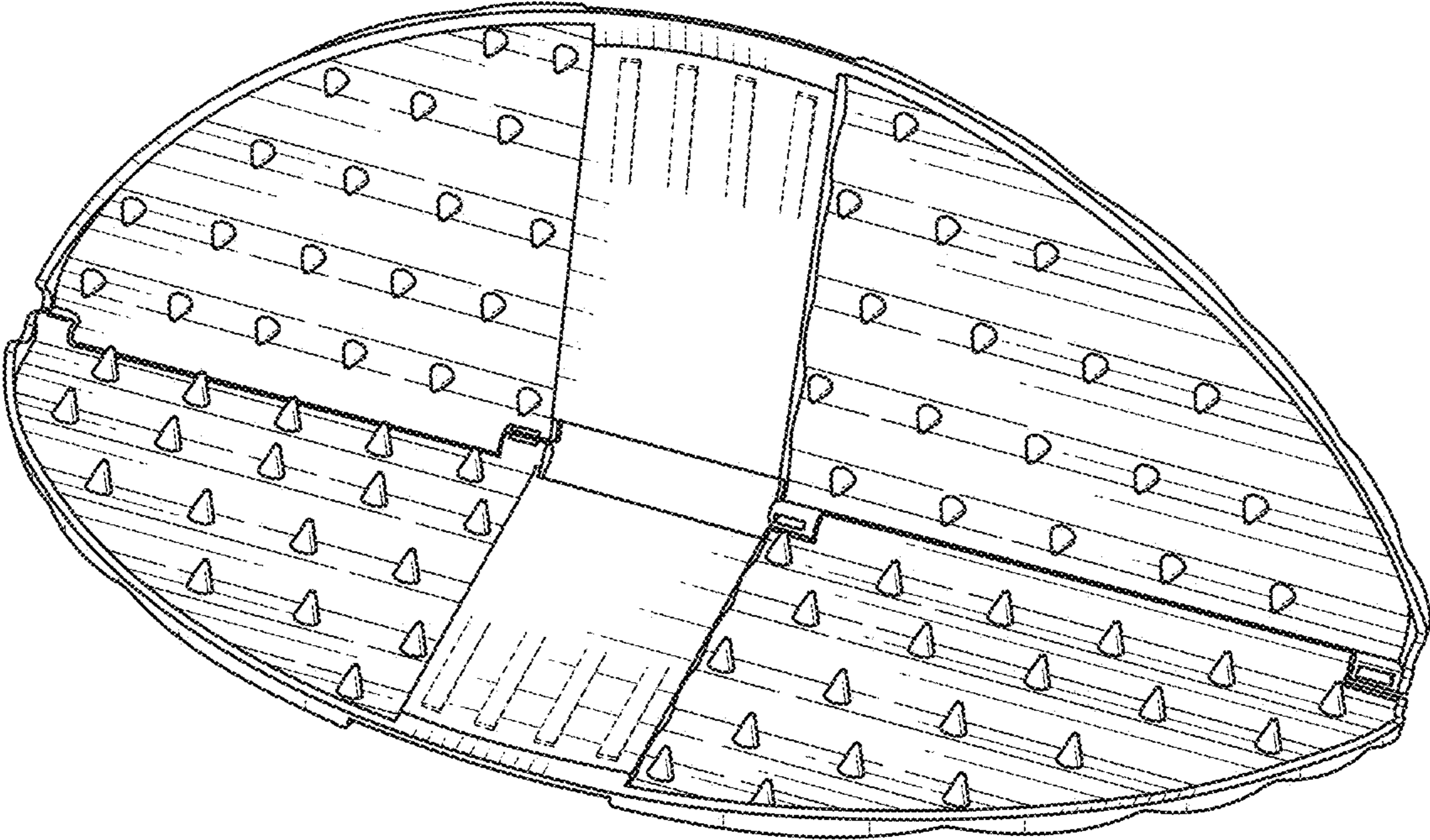
